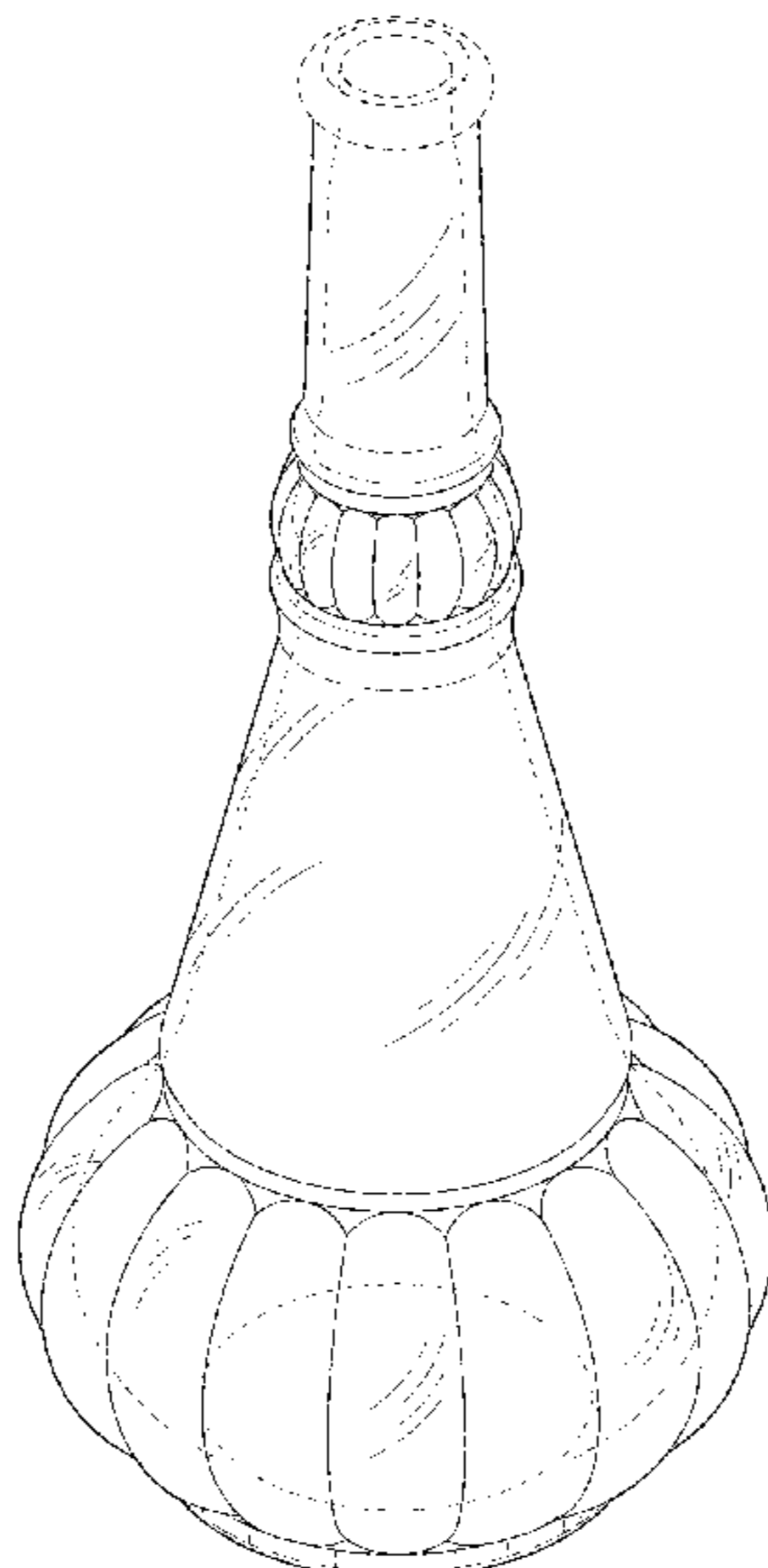

FIG. 1 is a perspective view of a bottle showing my new design;
FIG. 2 is a front side elevation view thereof;
FIG. 3 is a right side elevation view thereof;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.
The rear side of the design is a mirror image of the front side, and the left side of the design is a mirror image of the right side.
The broken lines in the drawings illustrate the portions of the bottle that form no part of the claimed design.

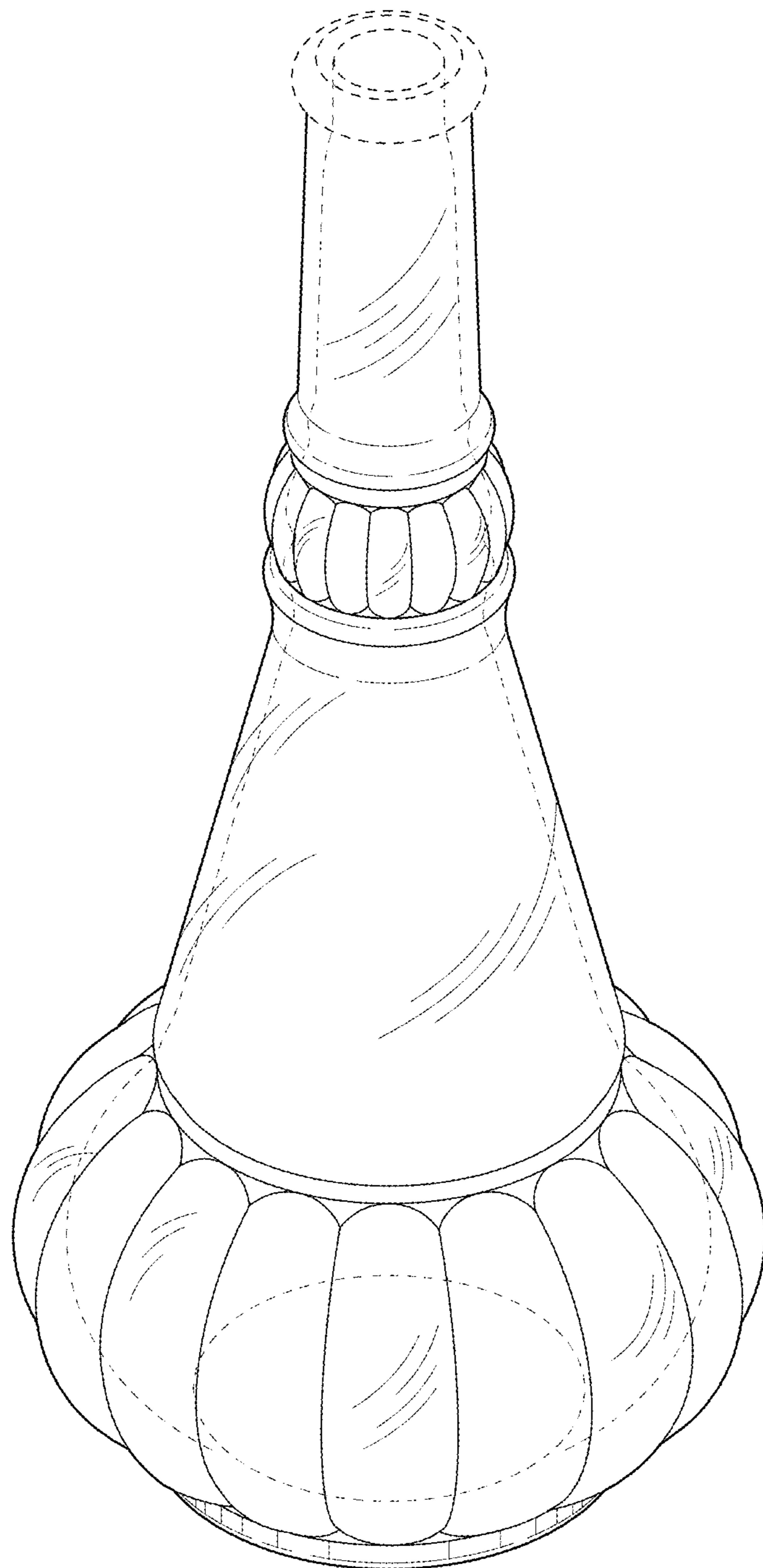

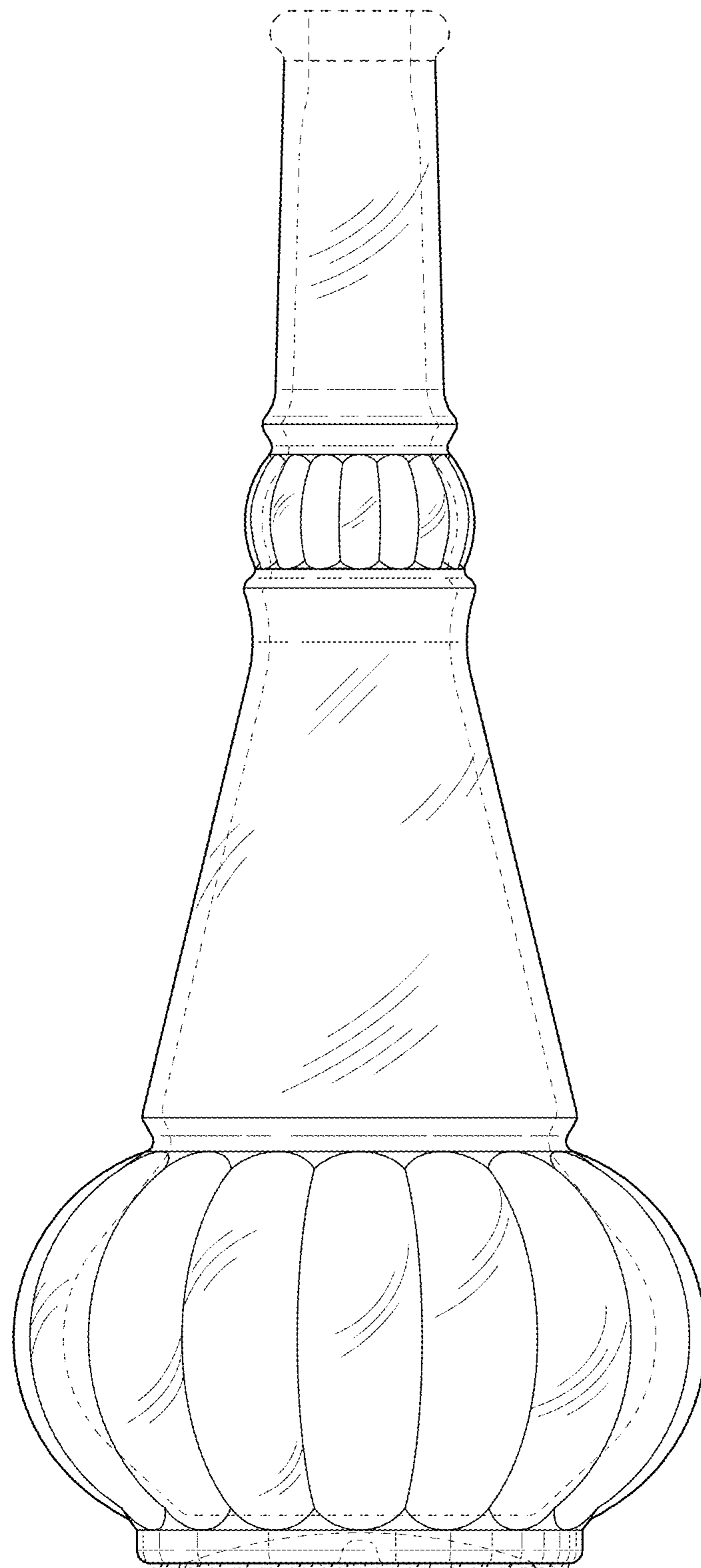

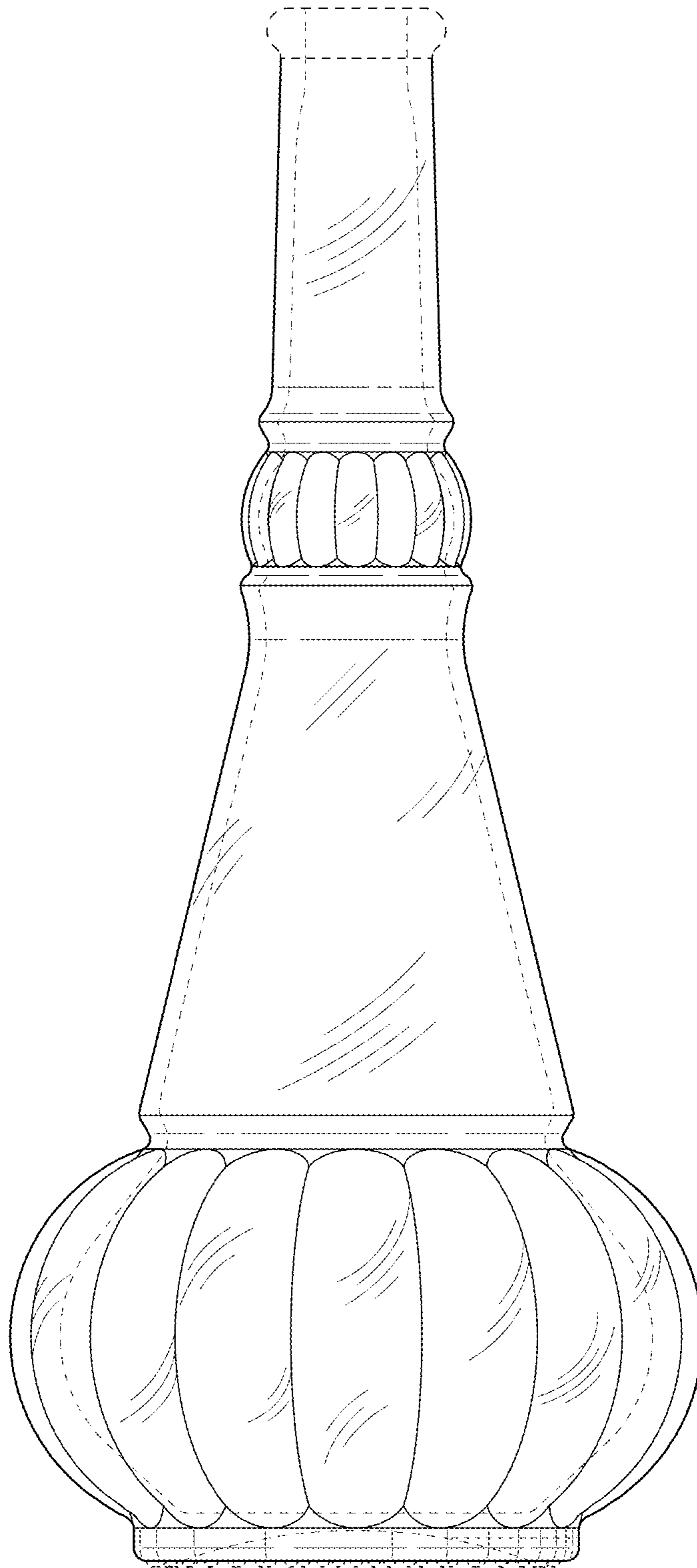

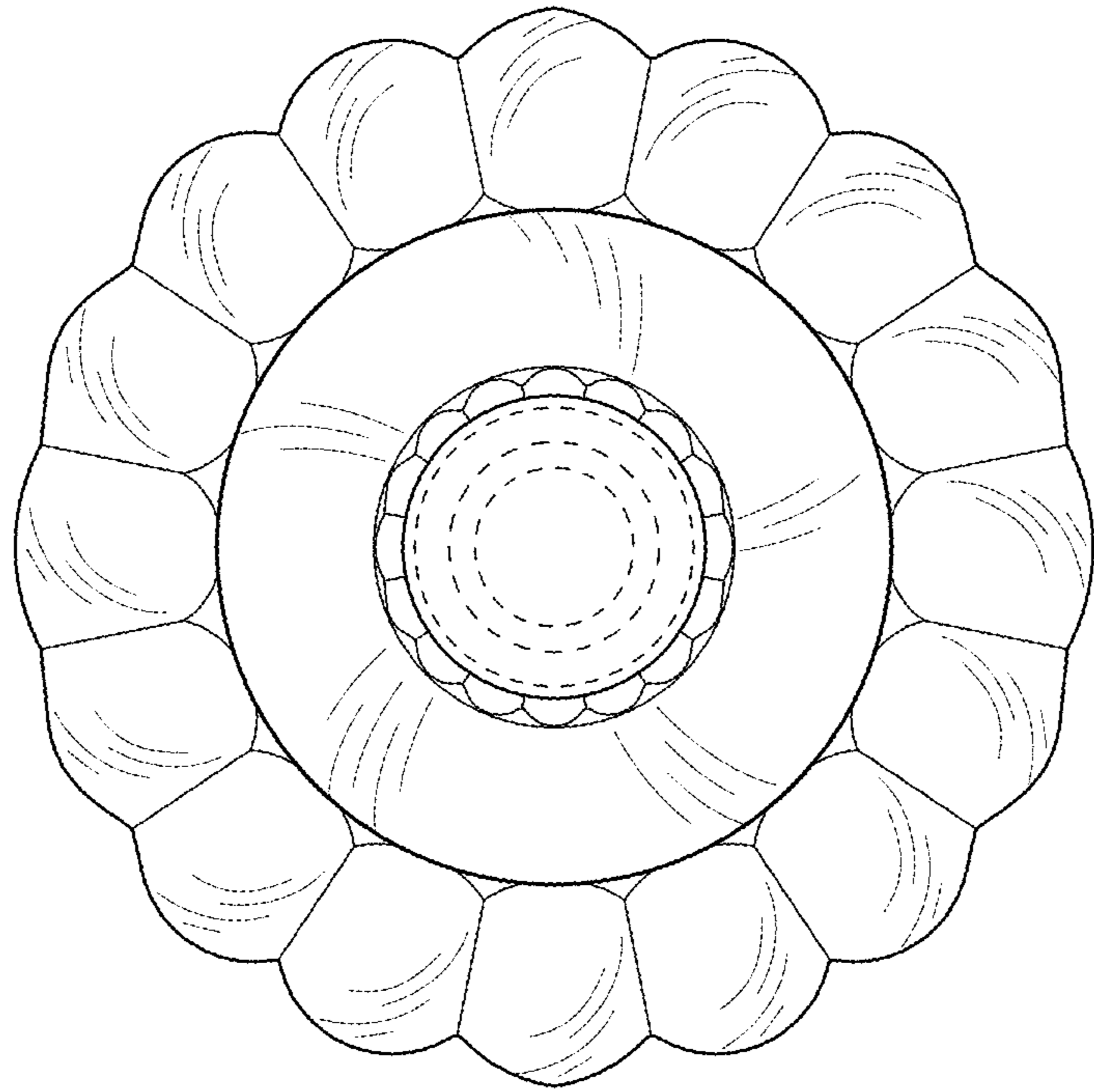

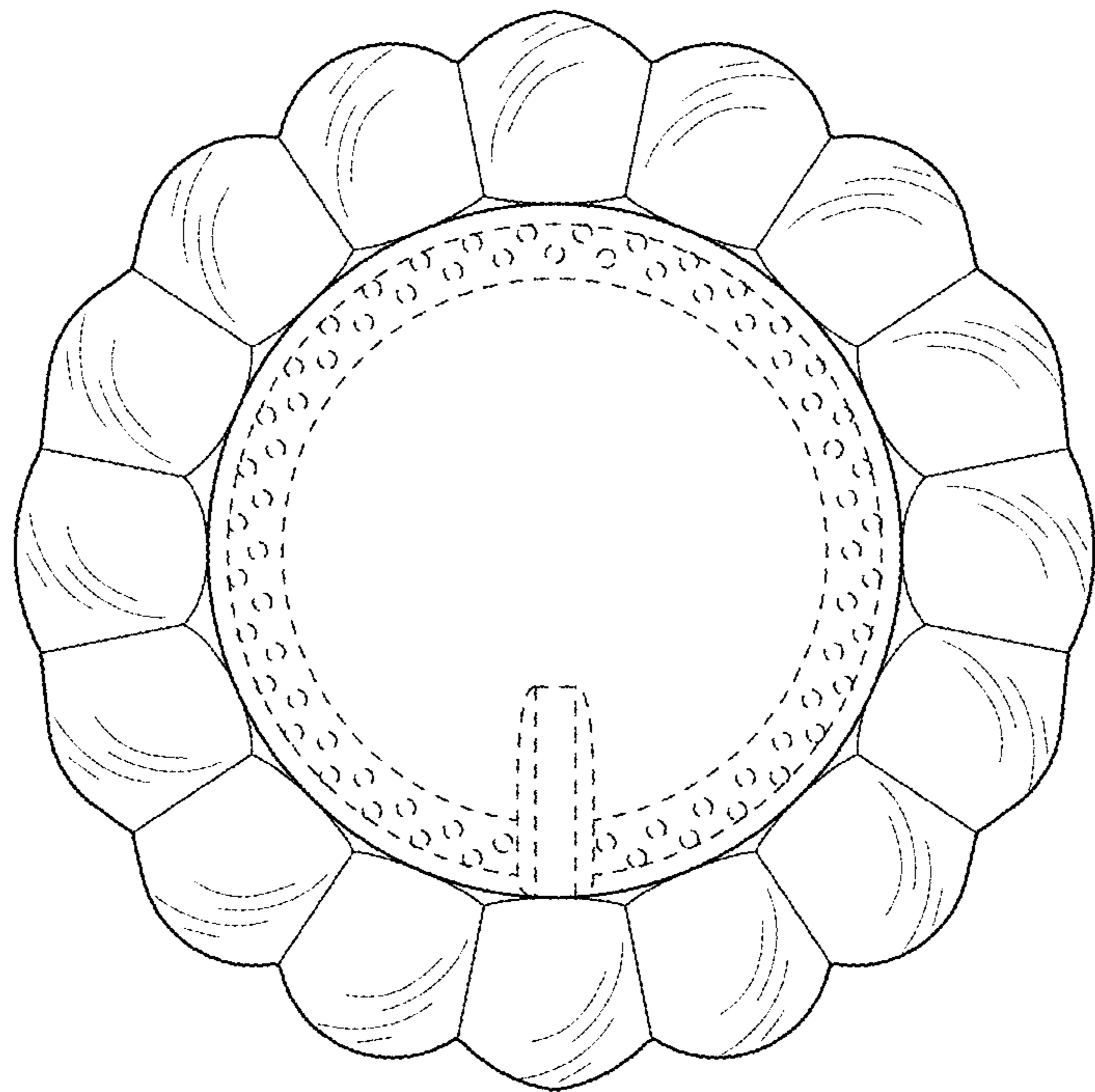
