(57) **CLAIM**

The ornamental design for a flag pole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a flag pole;
FIG. 2 is a top plan view of FIG. 1;
FIG. 3 is a bottom plan view of FIG. 1;
FIG. 4 is a front elevation view of FIG. 1, the rear elevation view being a mirror image thereof;
FIG. 5 is a left side elevation view of FIG. 1;
FIG. 6 is a right side elevation view of FIG. 1; and,
FIG. 7 is a front perspective view of FIG. 1, shown in use.
The broken lines shown in the drawings are included for the purpose of illustrating environmental structure and form no part of the claimed design.

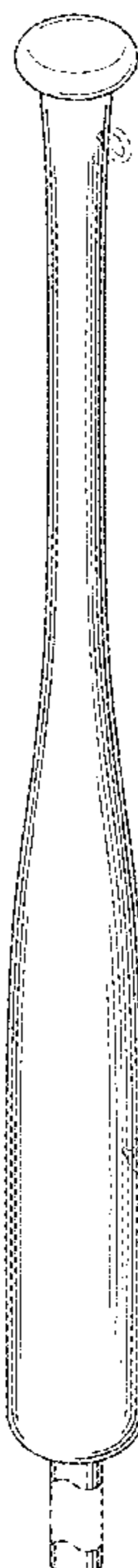

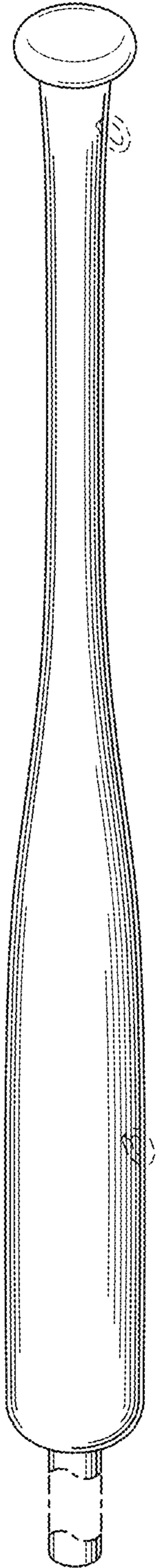

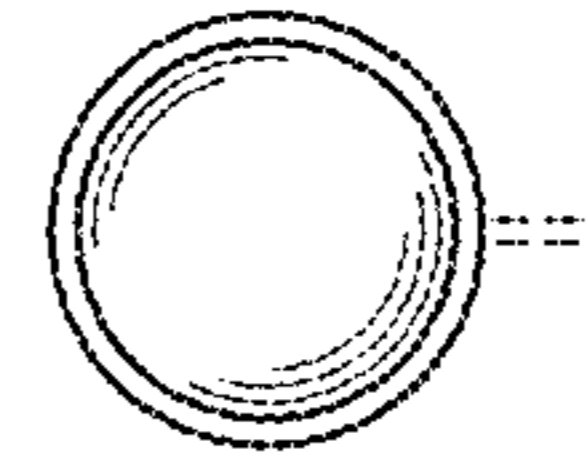
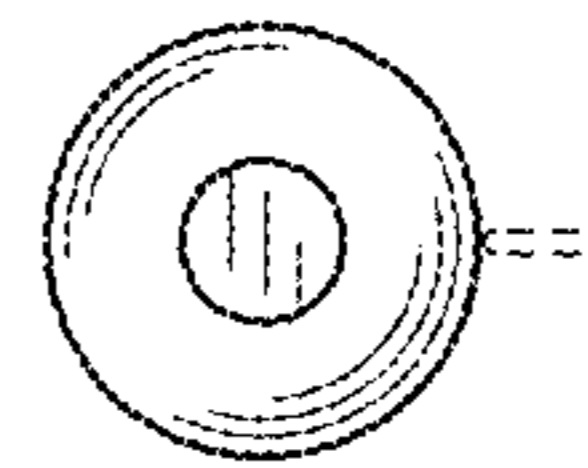

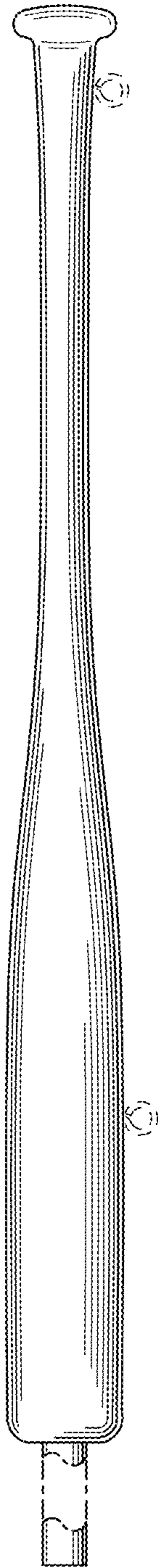

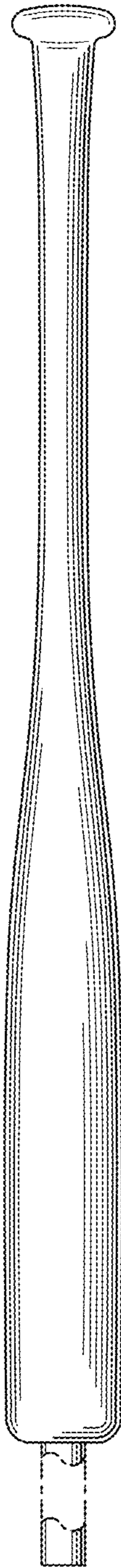

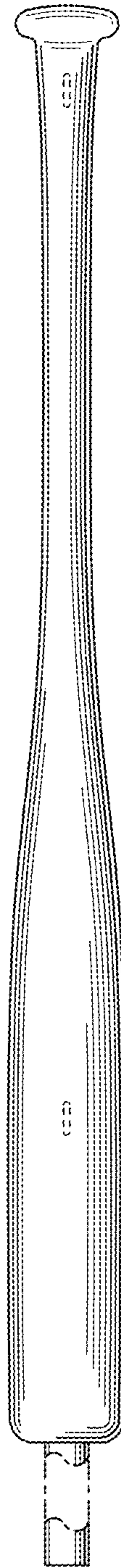

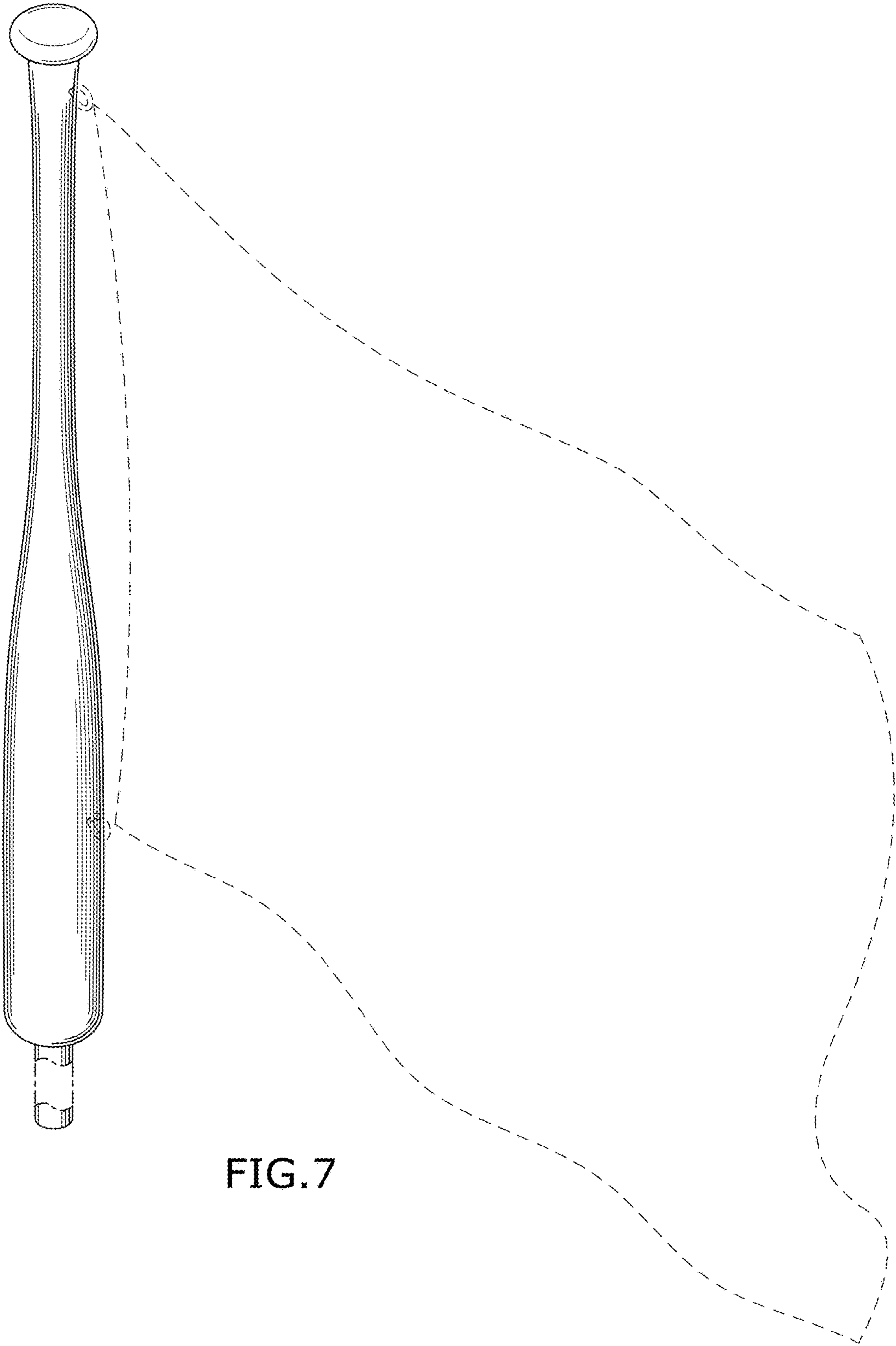
