(57) **CLAIM**

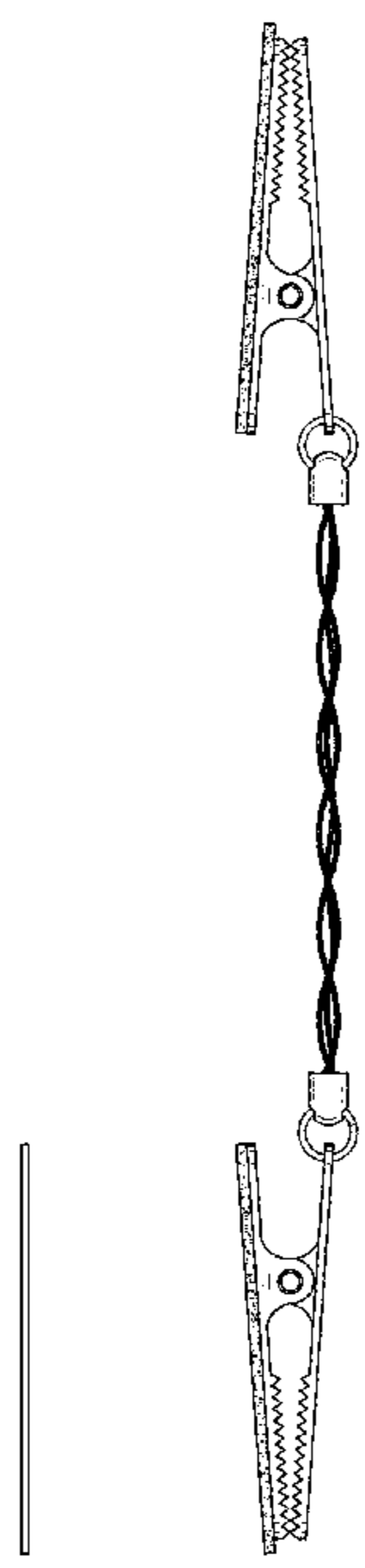
The ornamental design for a alligator clip fastener kit, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevation view of a alligator clip fastener kit showing my new design with an attachment base and an alligator clip fastener separated for clarity, the opposite side being a mirror image of the shown; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; and, FIG. 4 is a top plan view thereof, the opposite side being a mirror image of the shown. The broken lines in FIG. 5 of the drawings depict a sweater and decorative accessories as environmental subject matter only and form no part of the claimed design.

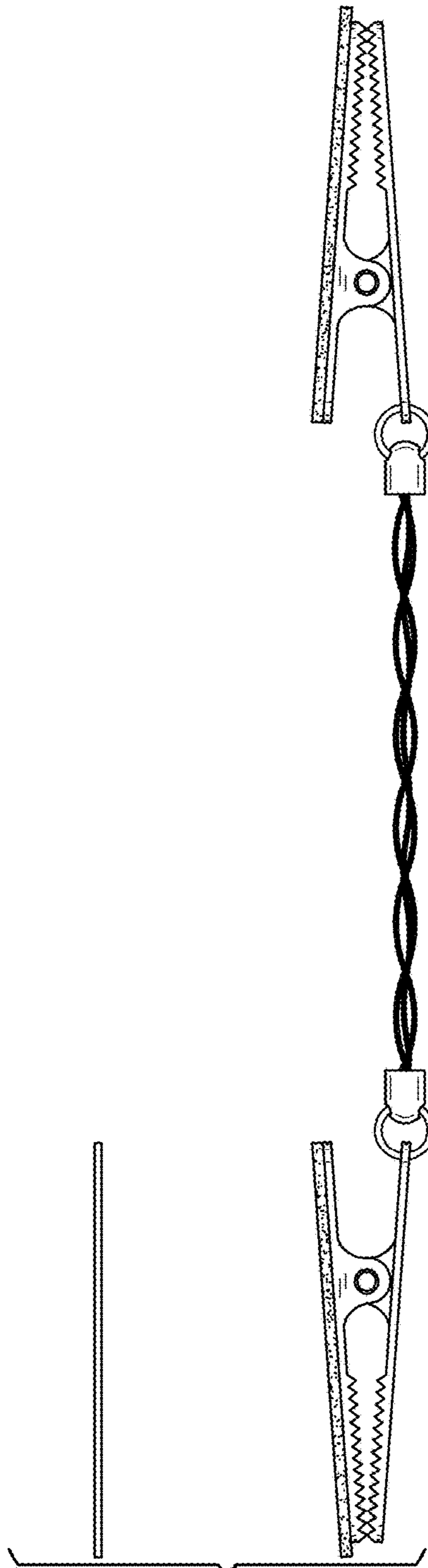

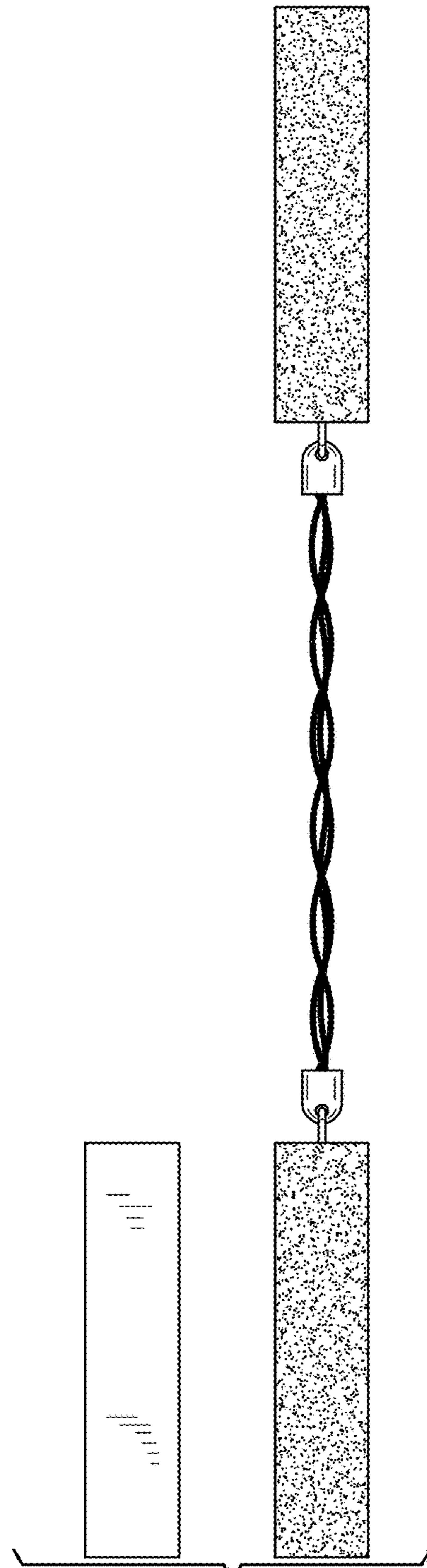

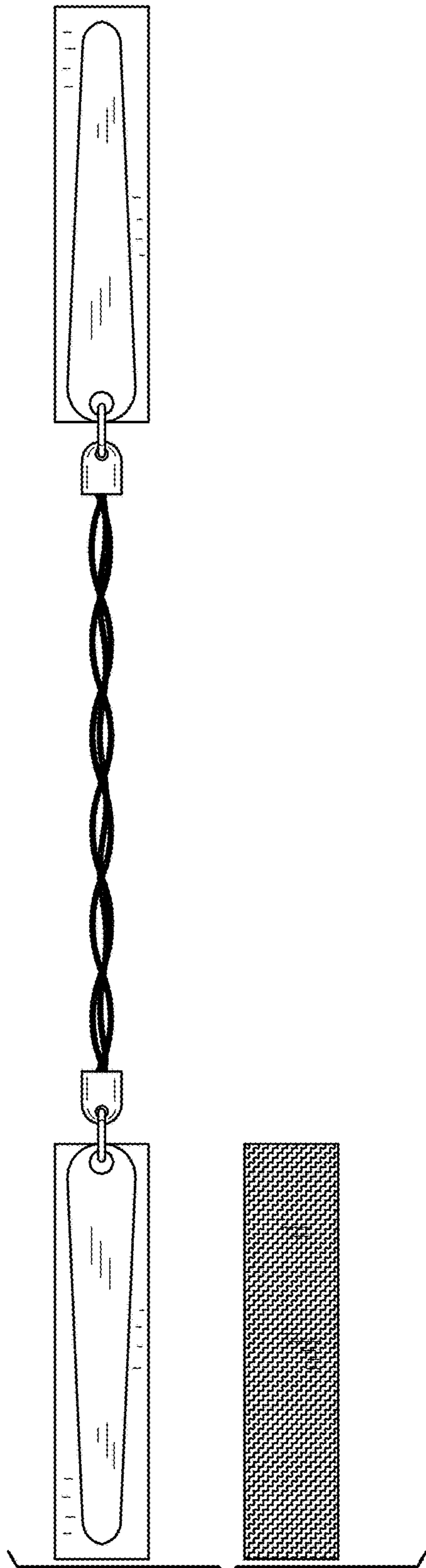
