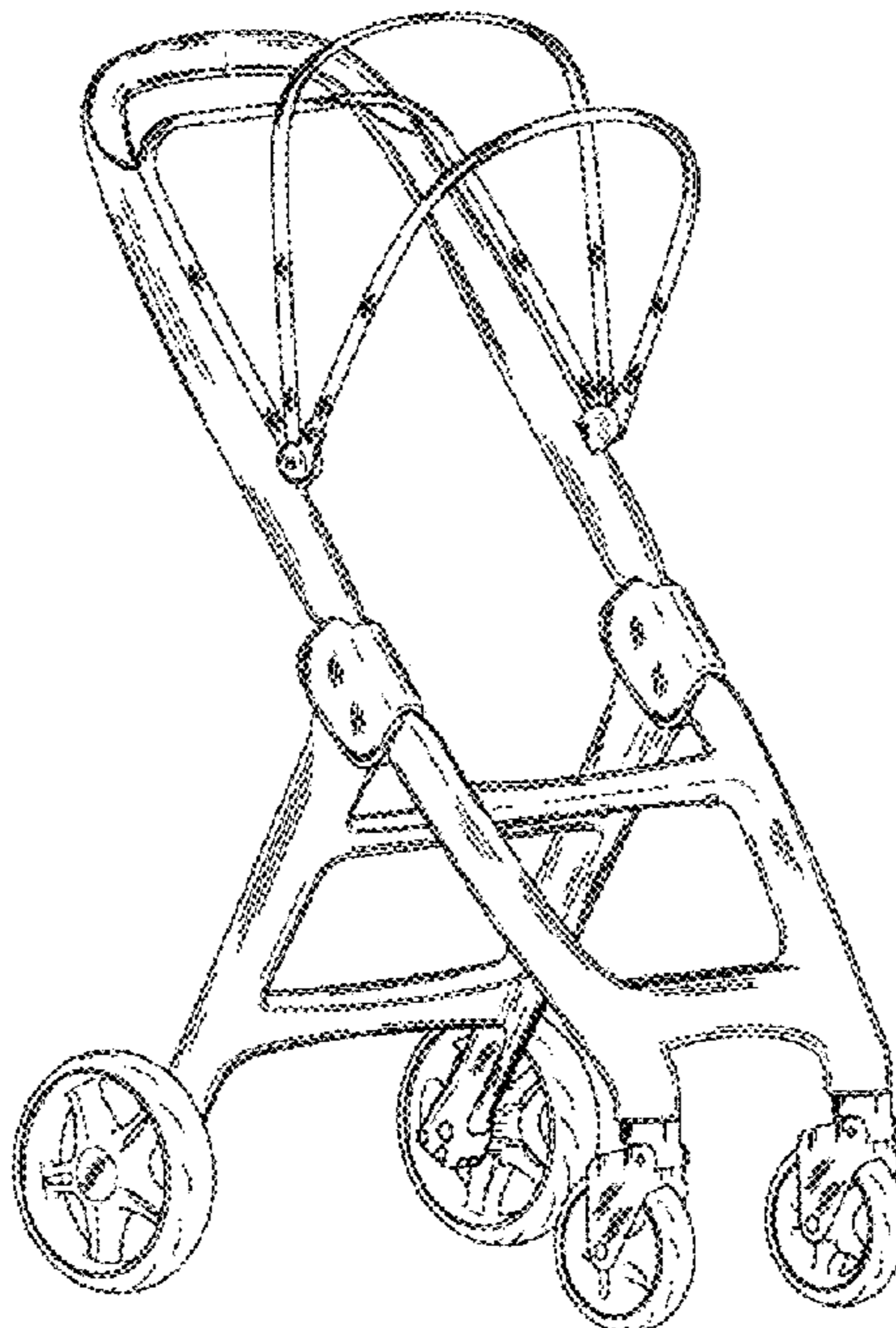
(57) **CLAIM**

The ornamental design for a collapsible stroller frame, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the collapsible stroller frame showing our design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;

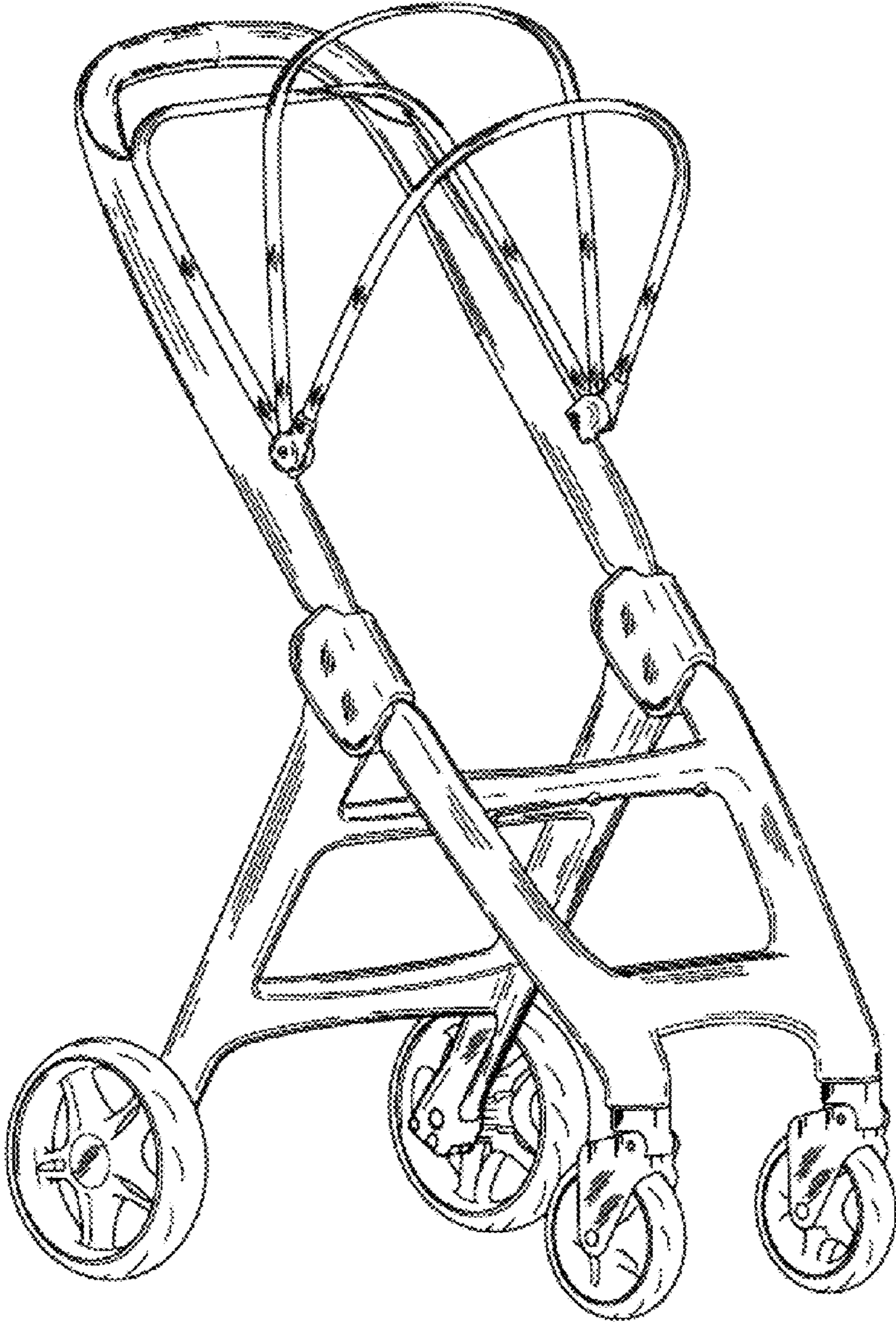

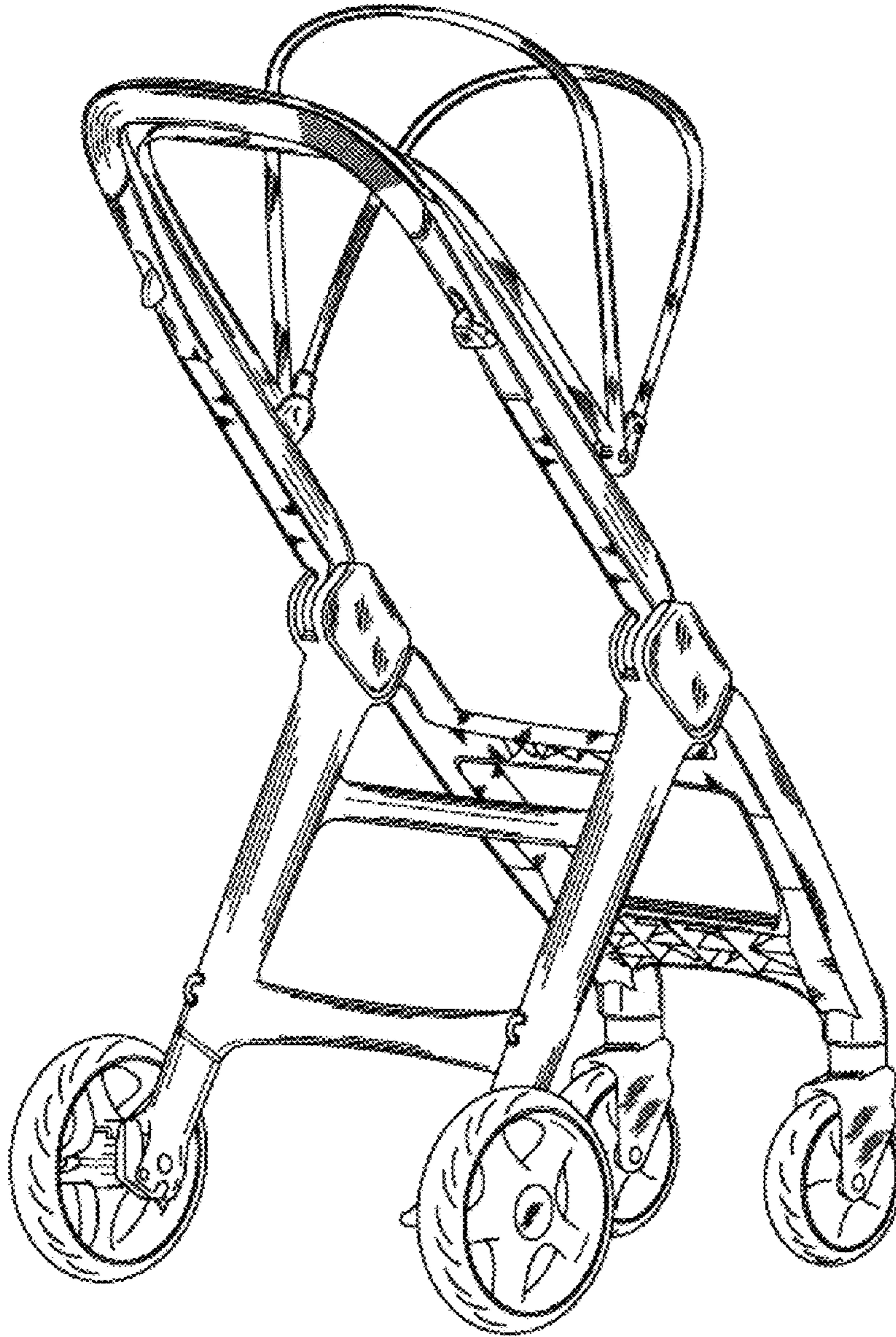

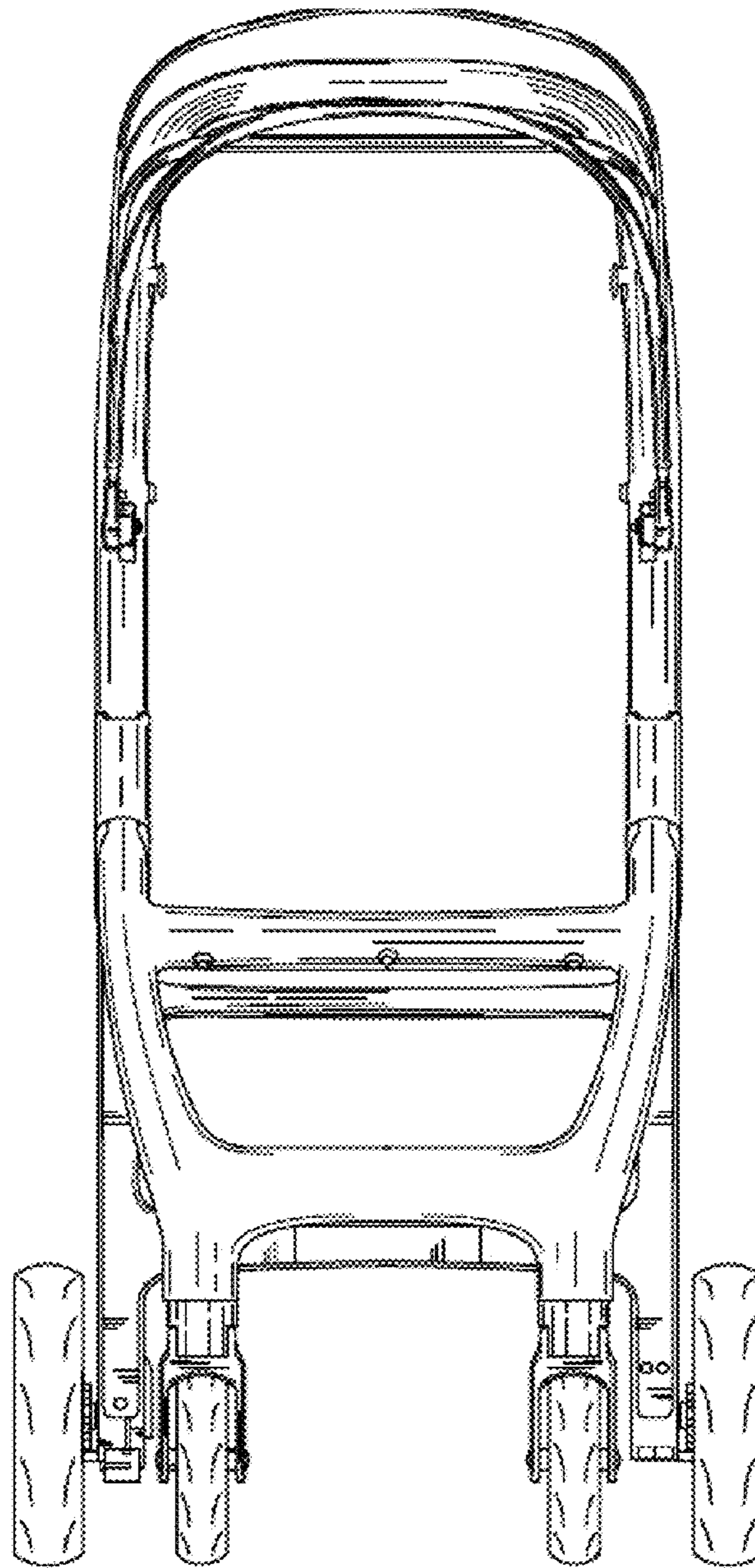

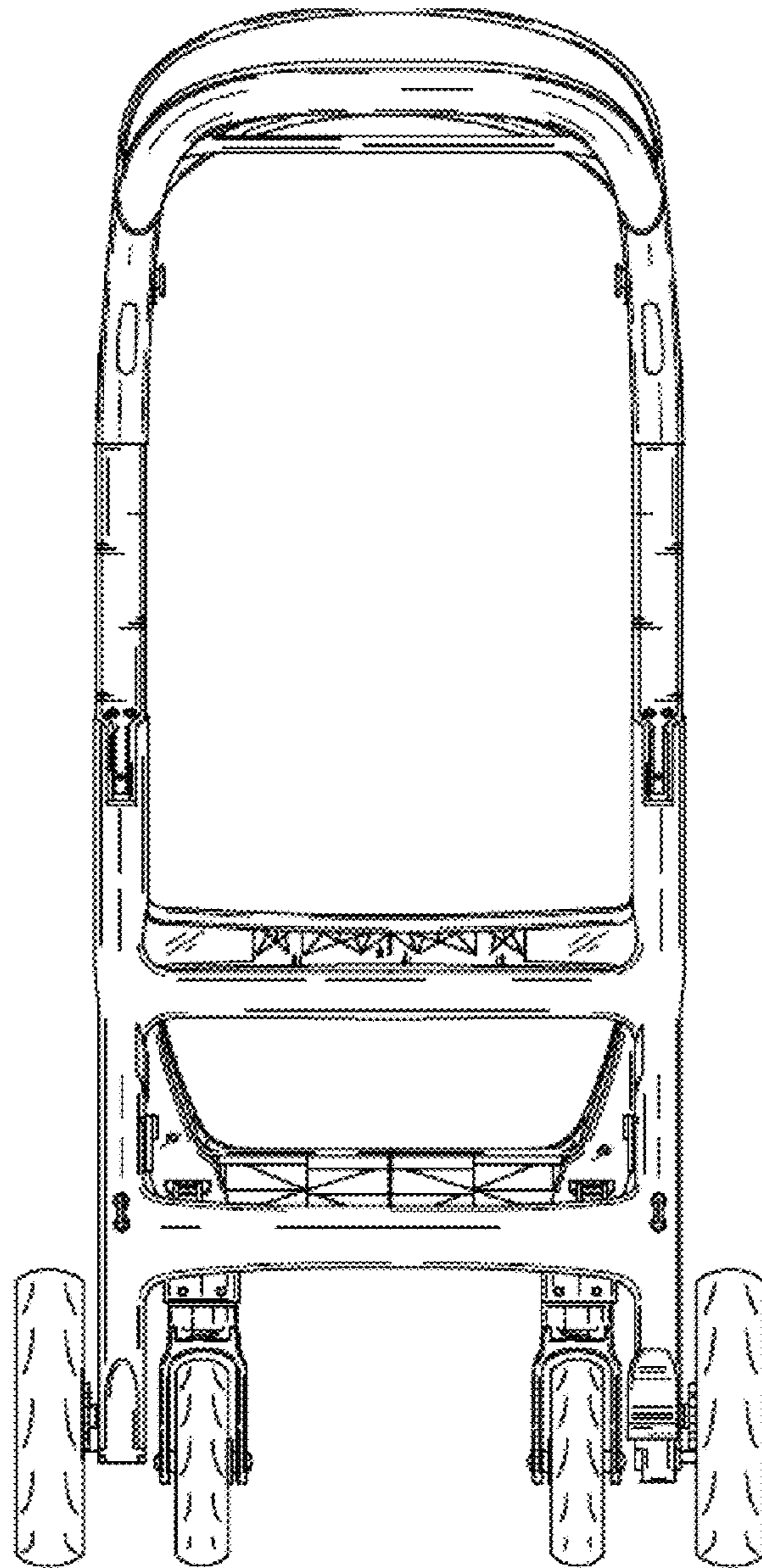

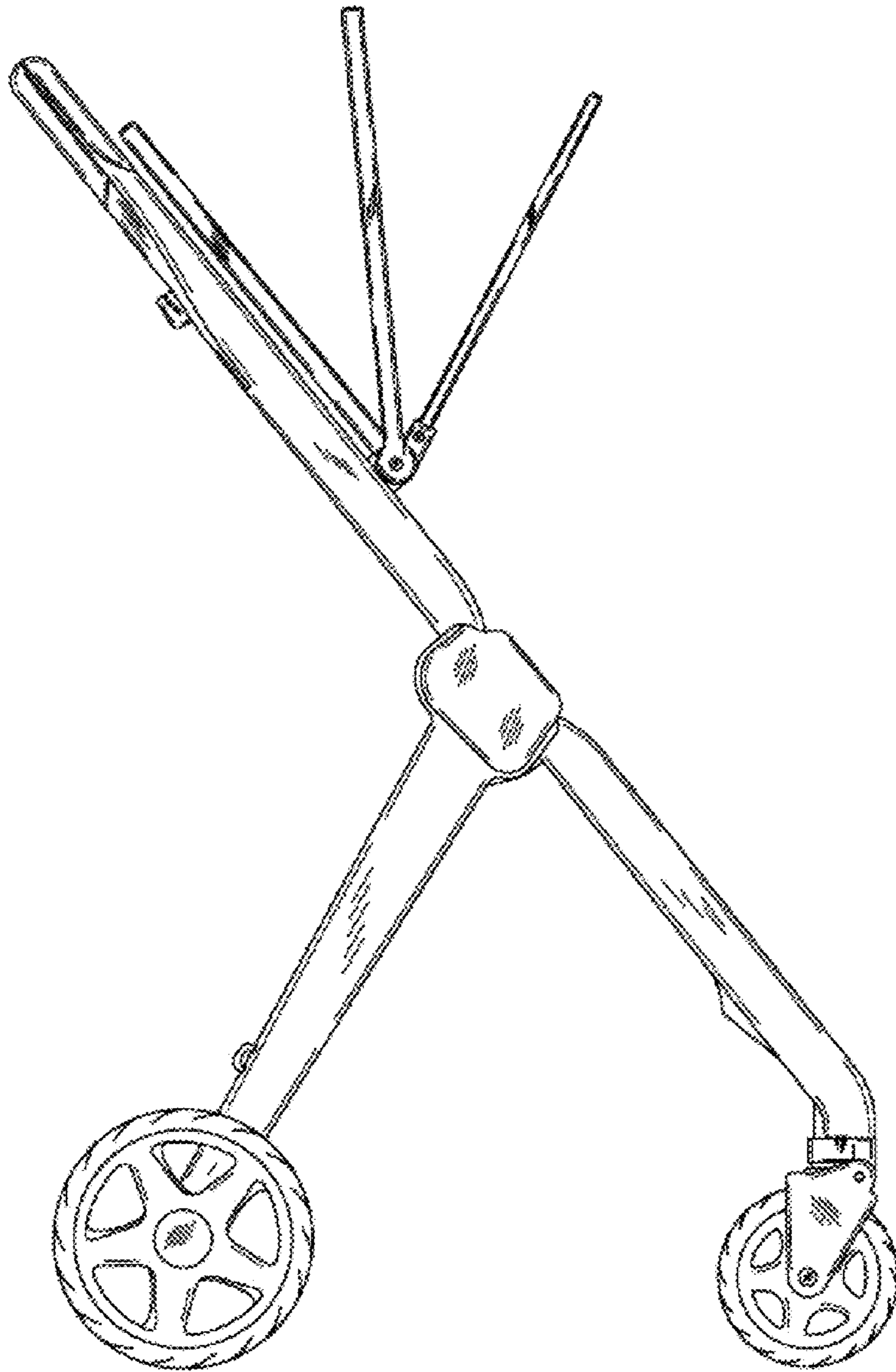

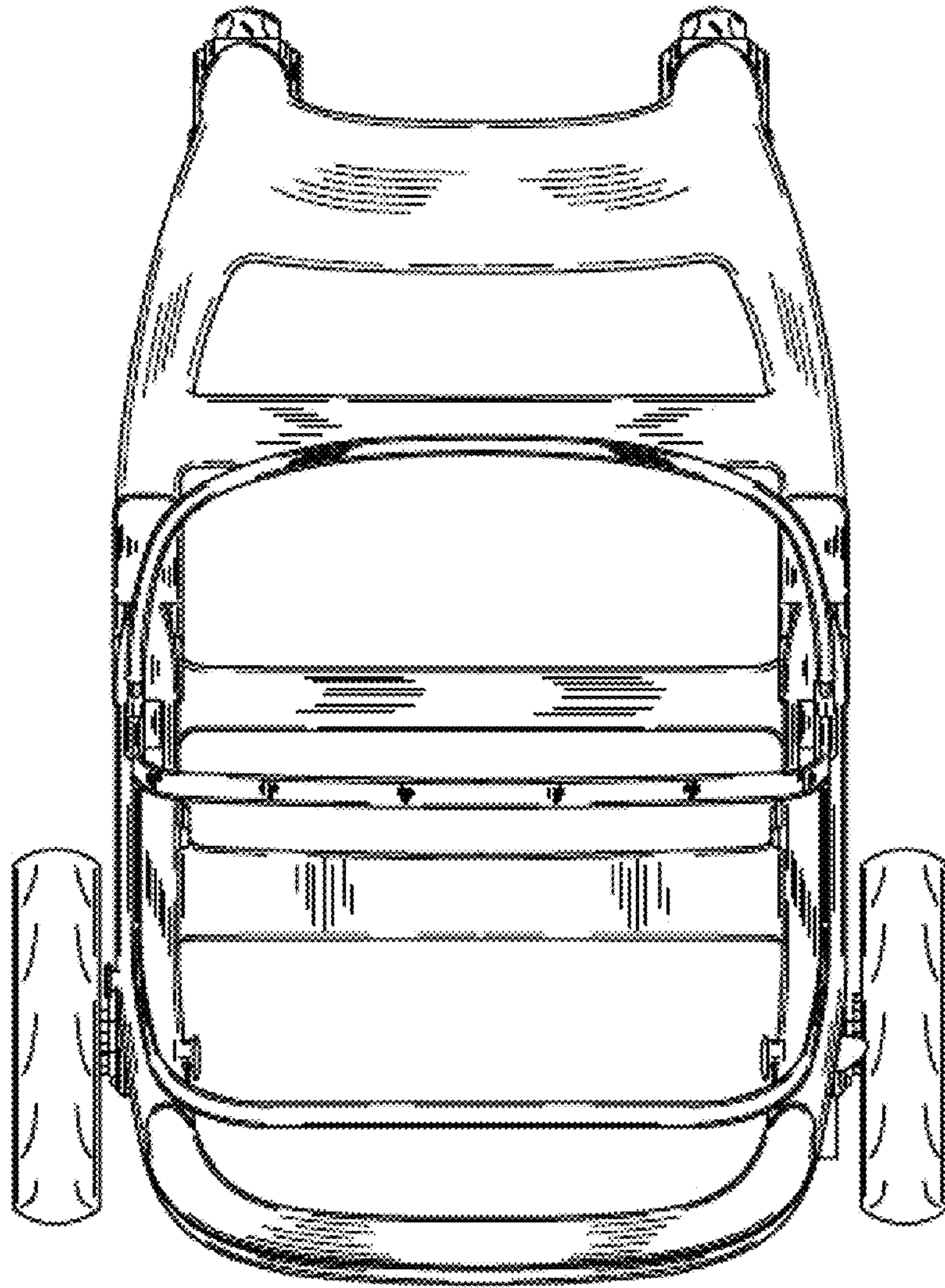

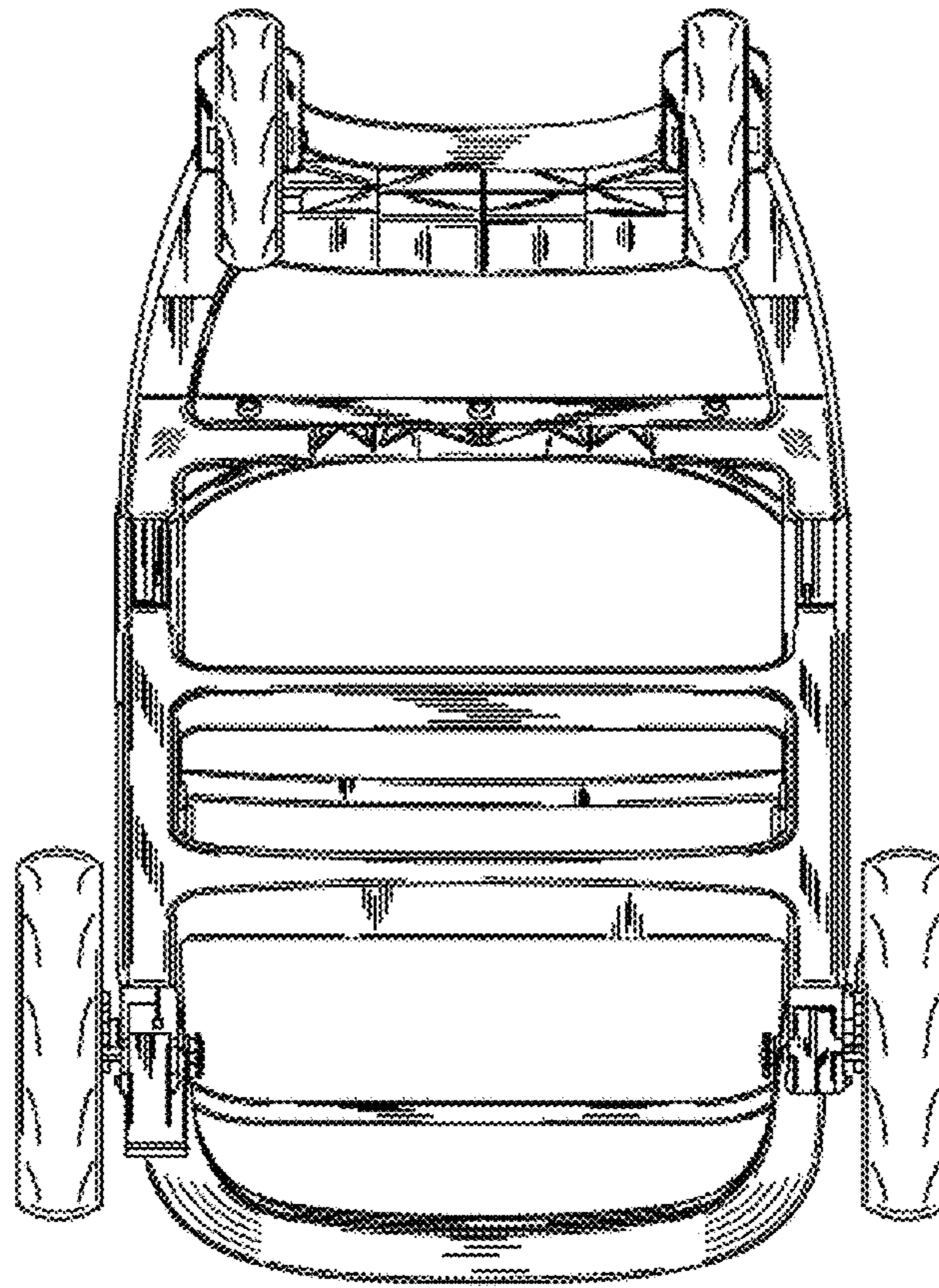
