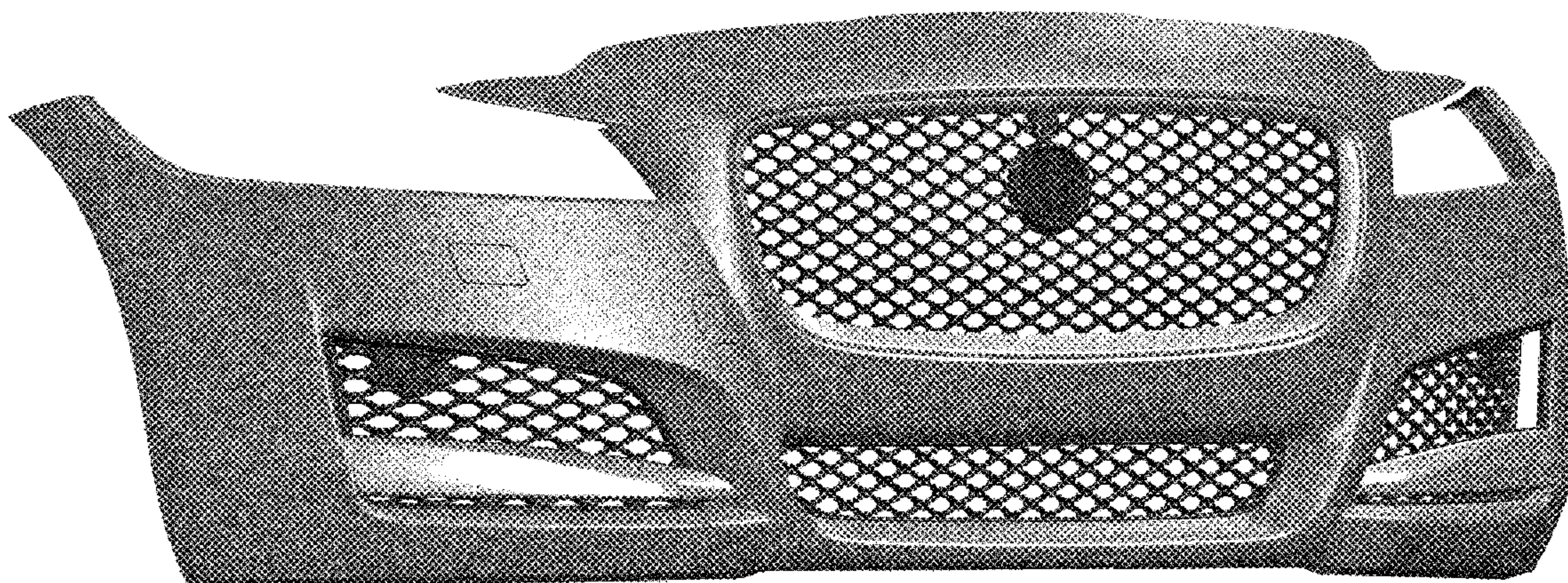
The ornamental design for a front bumper, as shown and

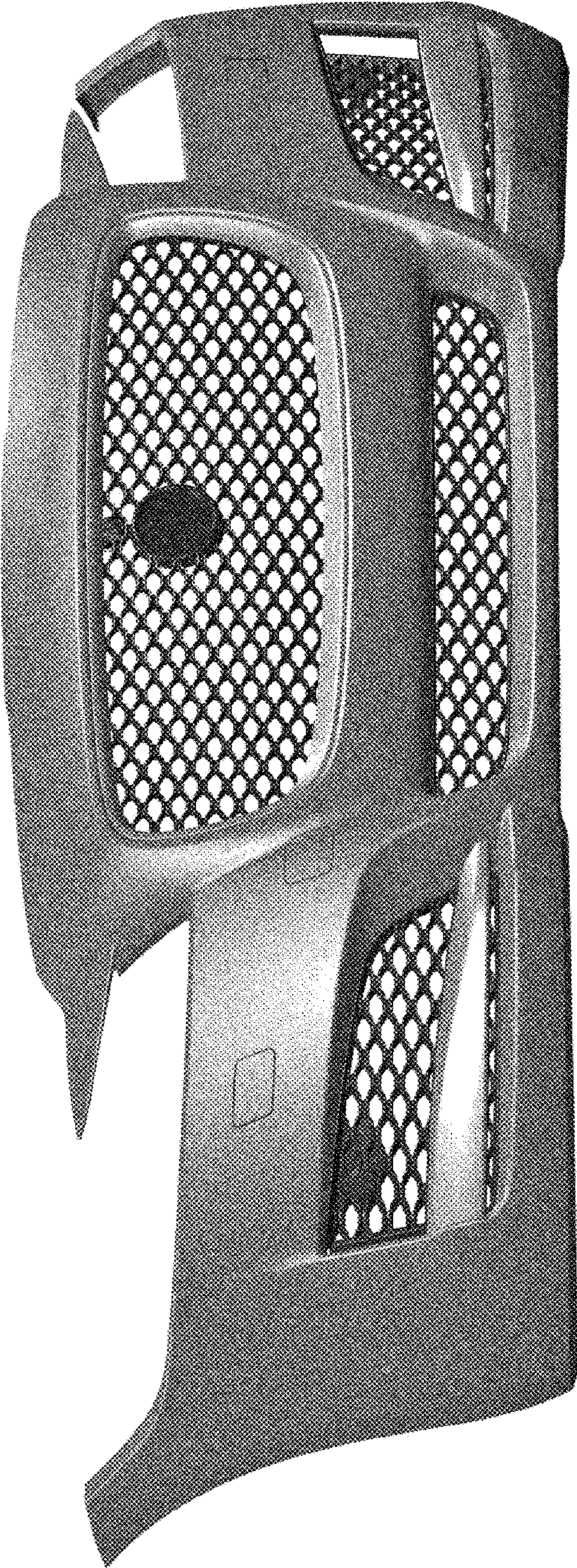

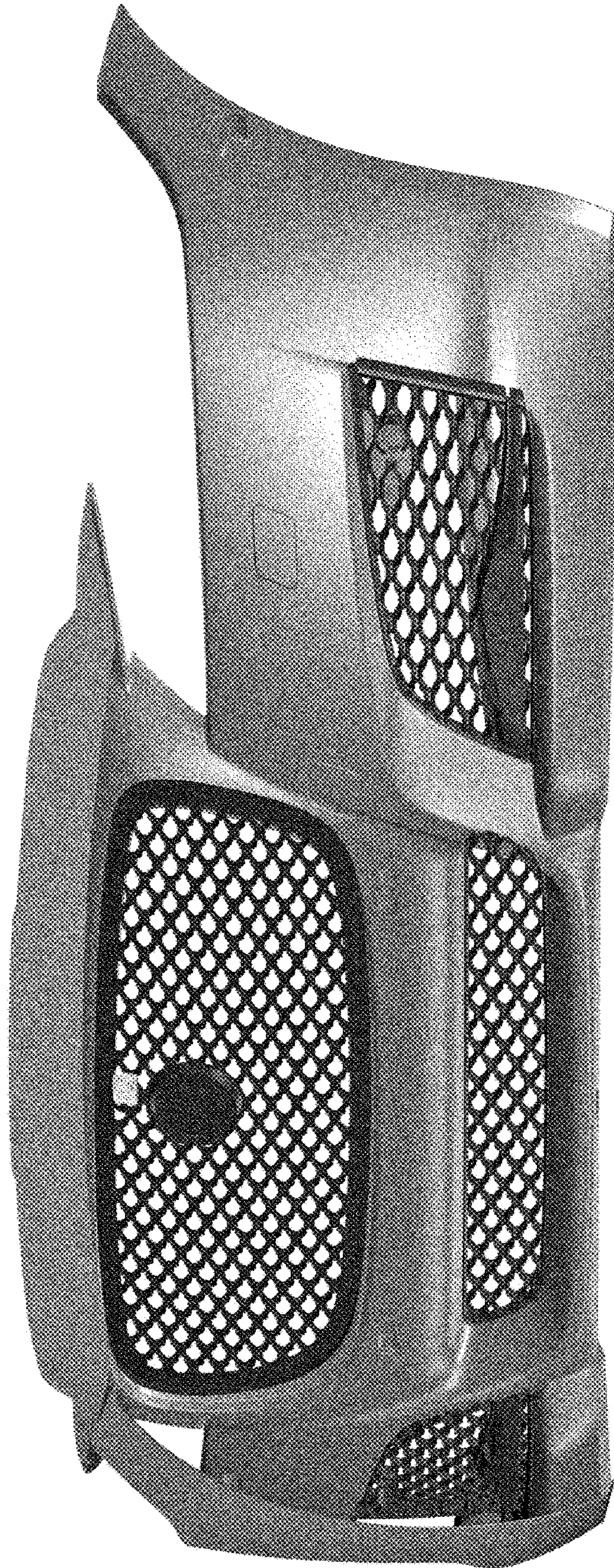

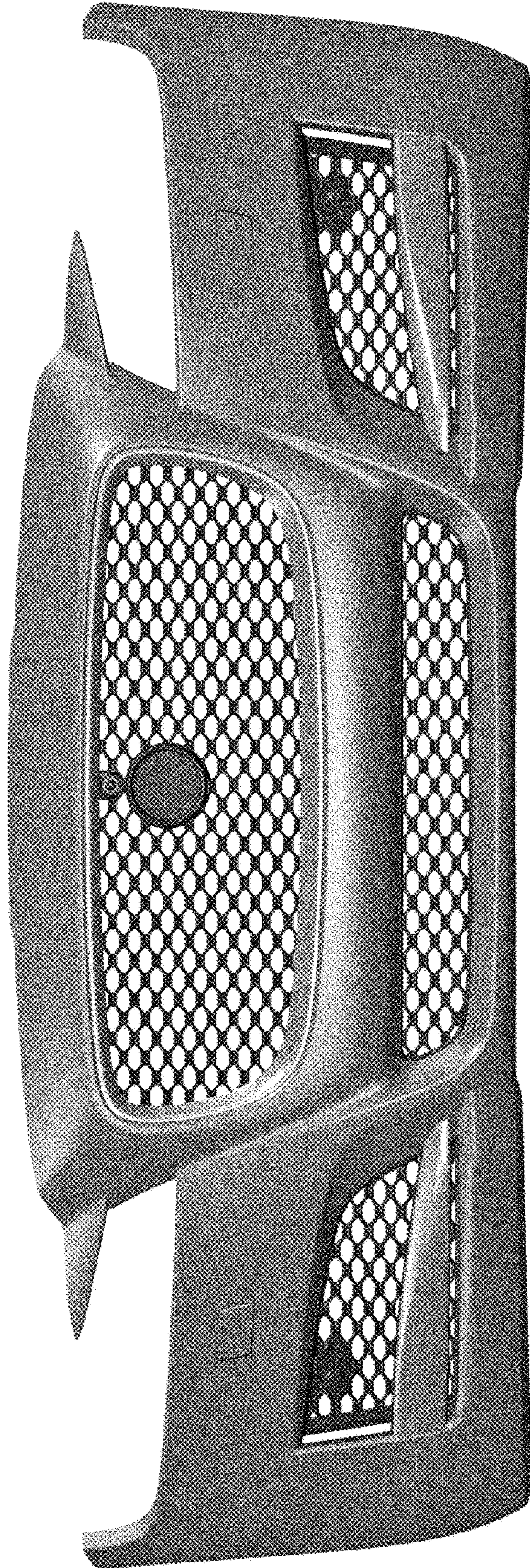

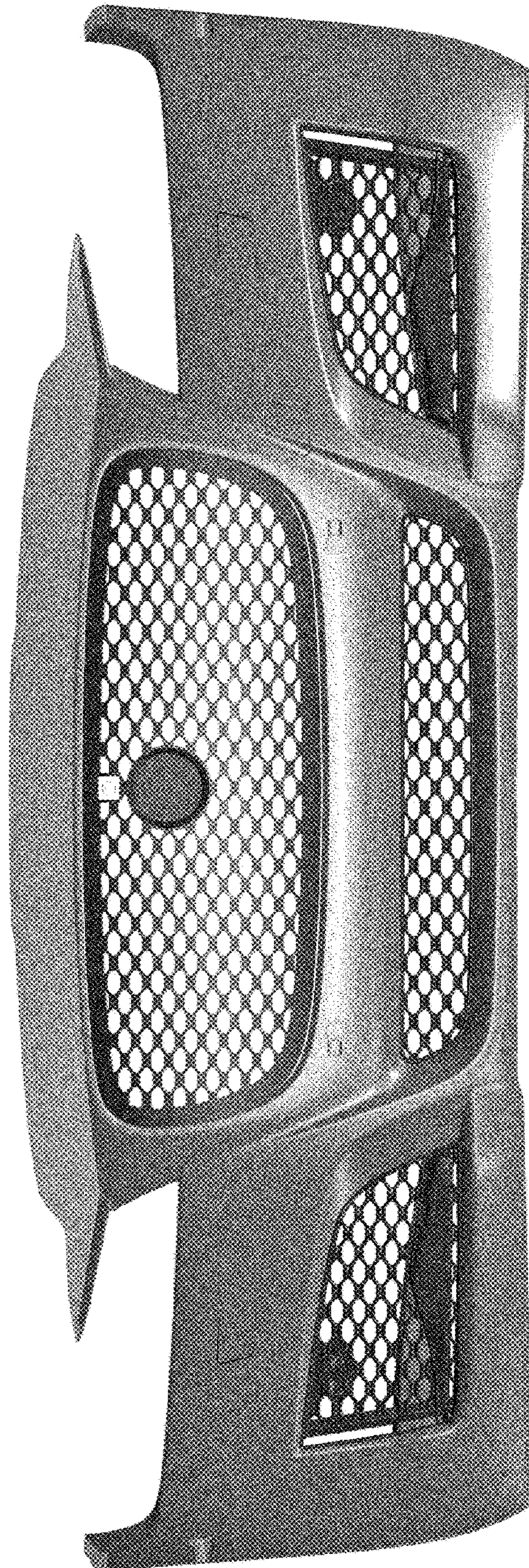

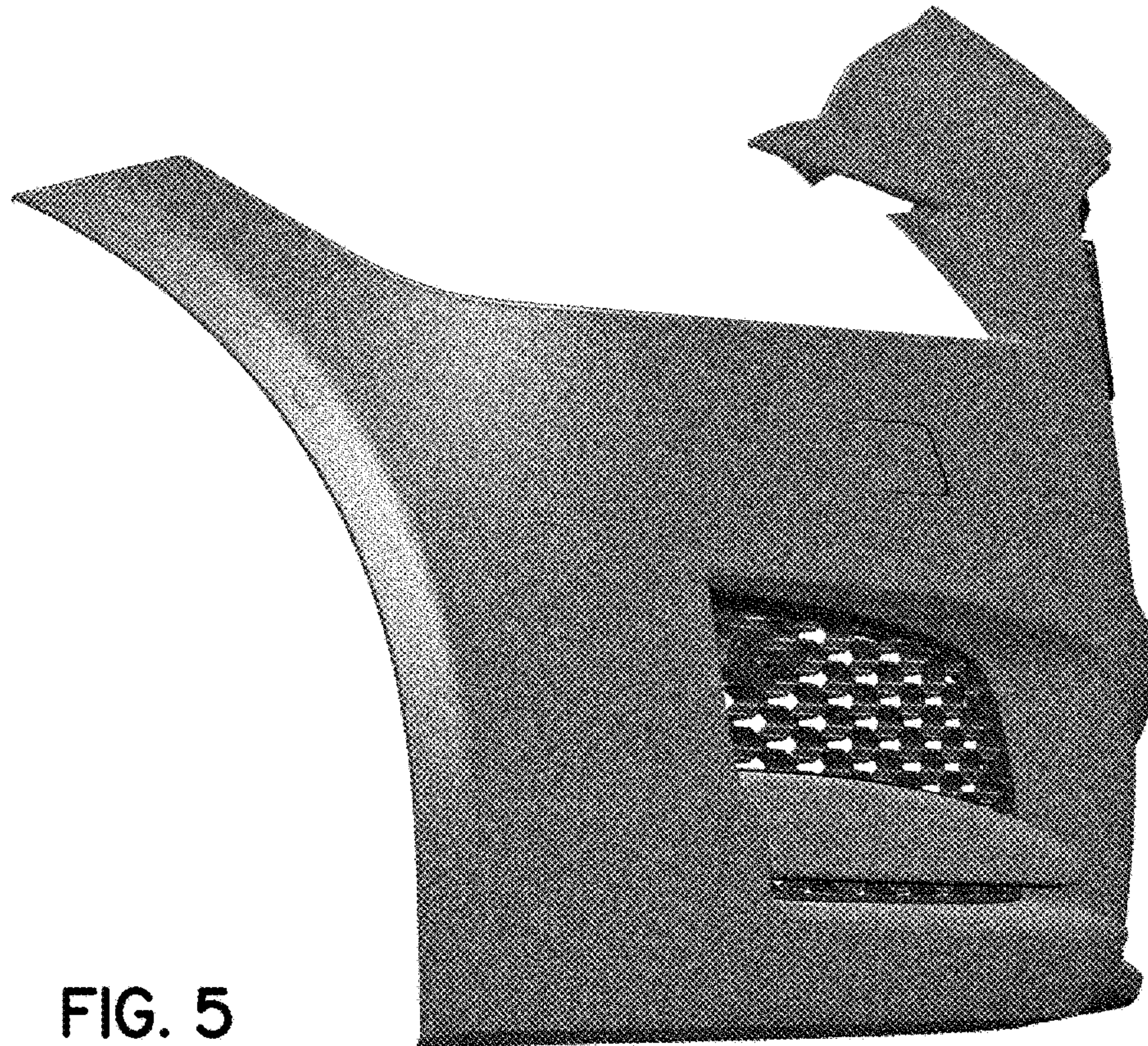

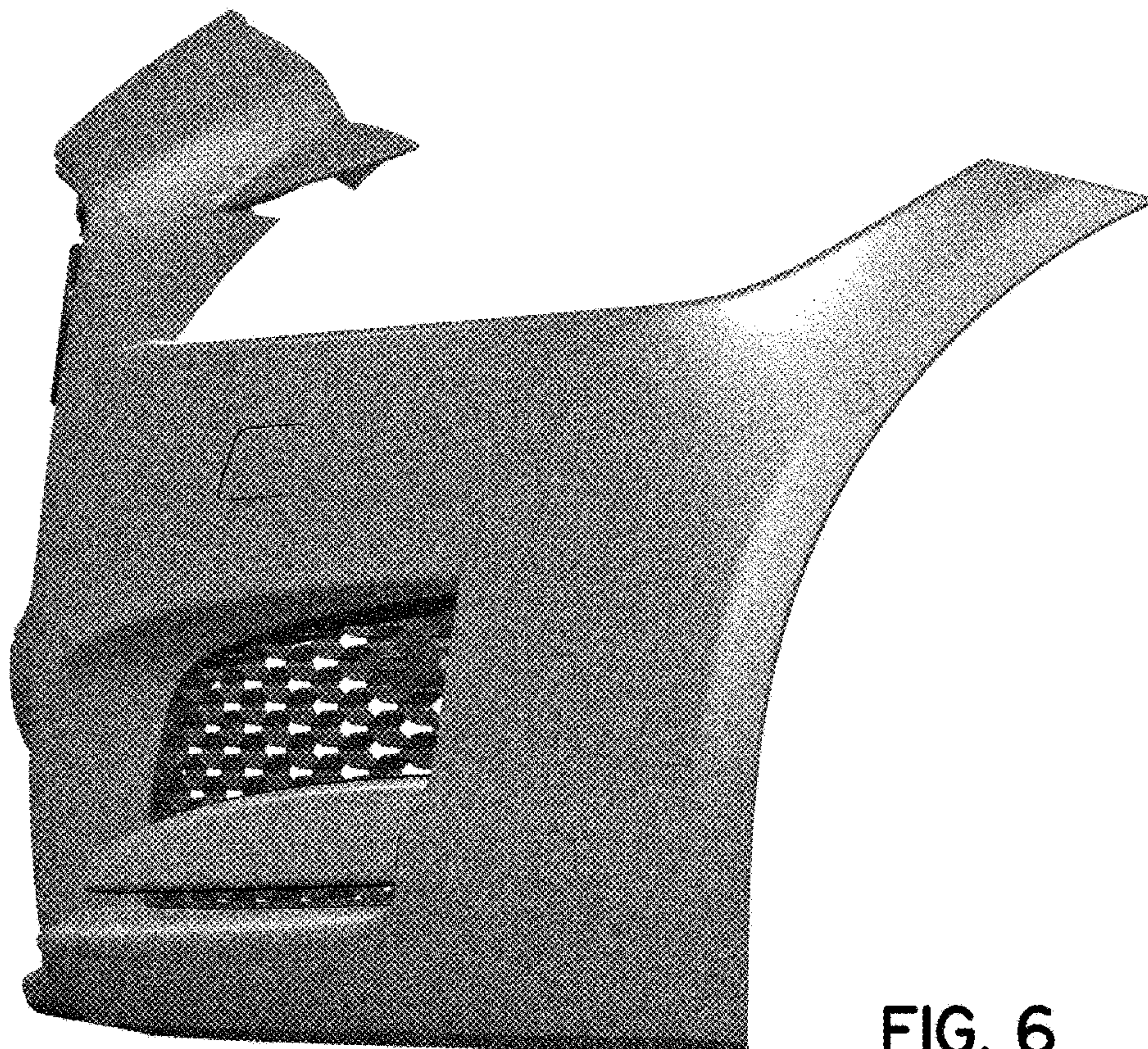

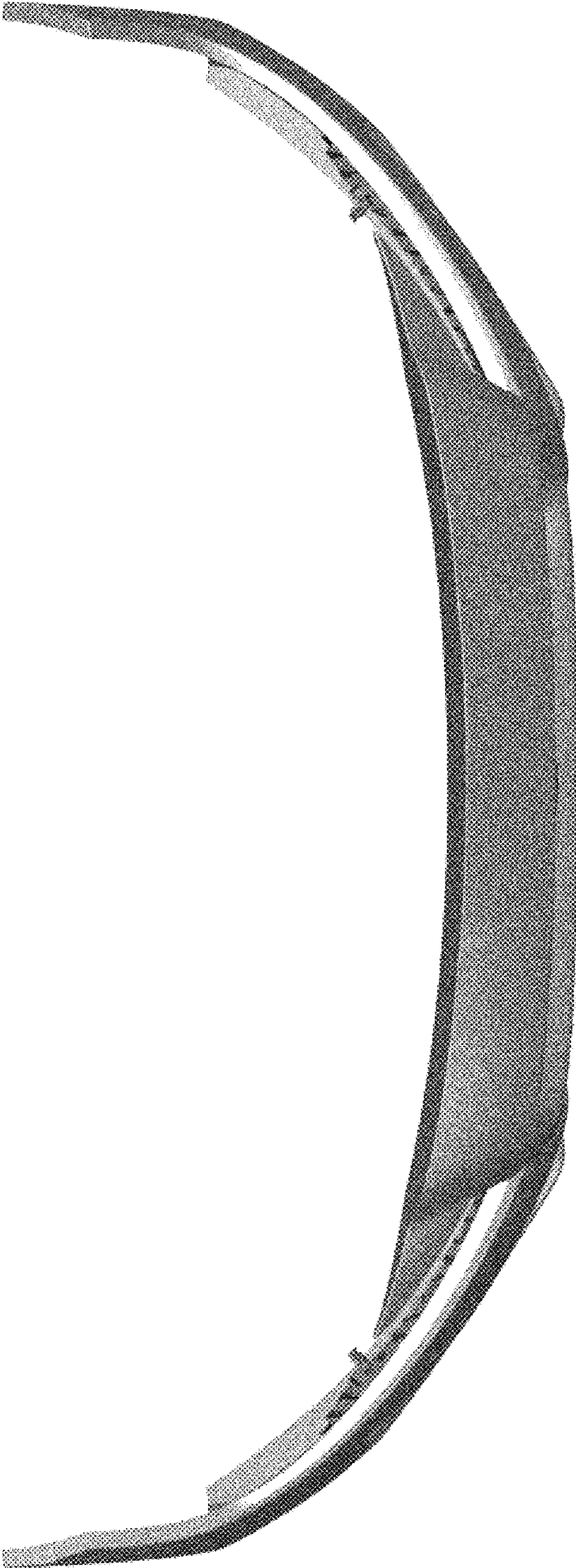
