(57) **CLAIM**

The ornamental design for a rear tailgate, as shown and described.

DESCRIPTION

FIG. 1 is a right rear perspective view of the rear tailgate, showing my invention;

FIG. 5 is a right side view thereof.

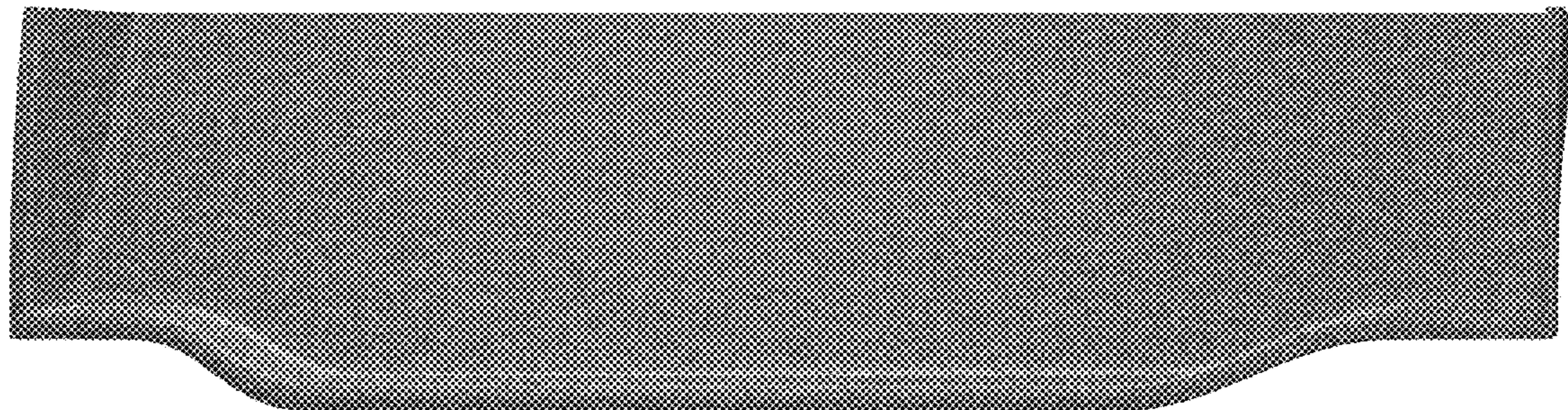
FIG. 6 is a left side view thereof.

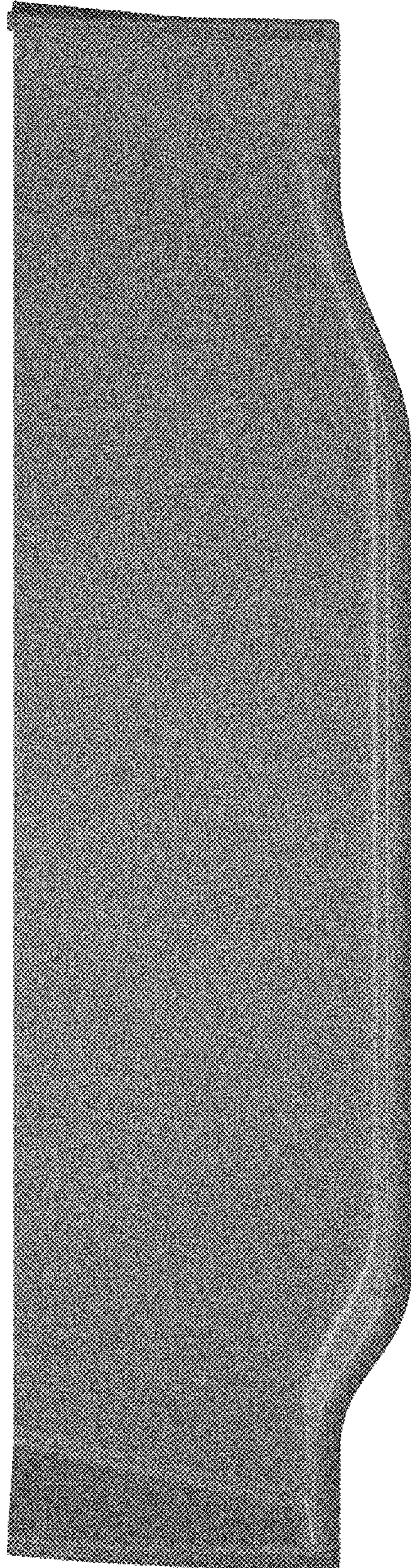

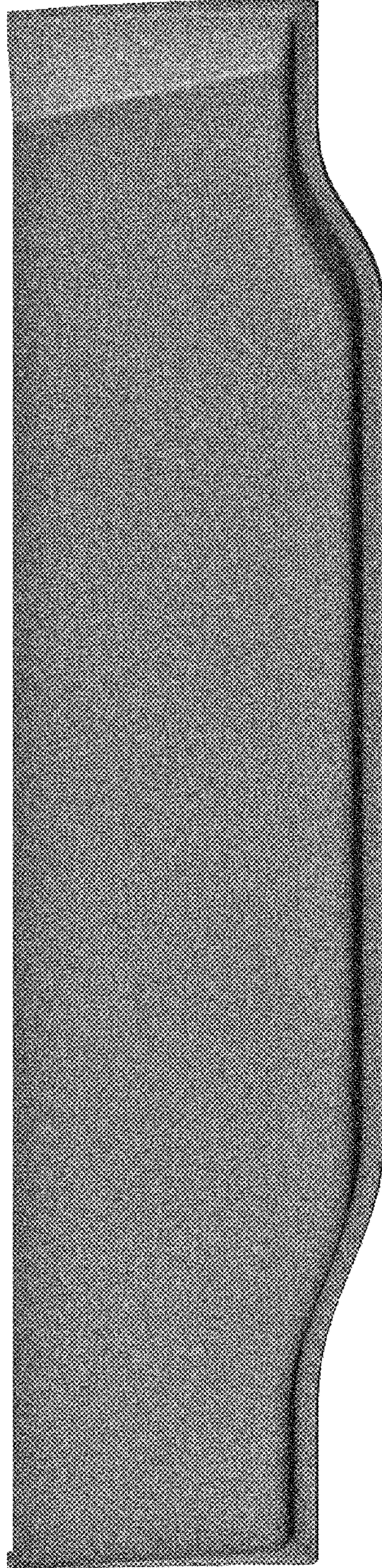

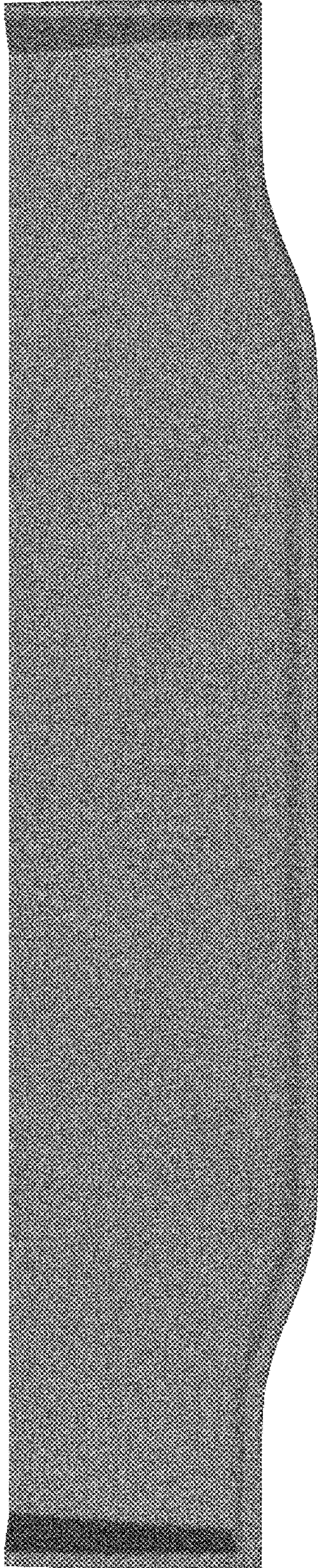

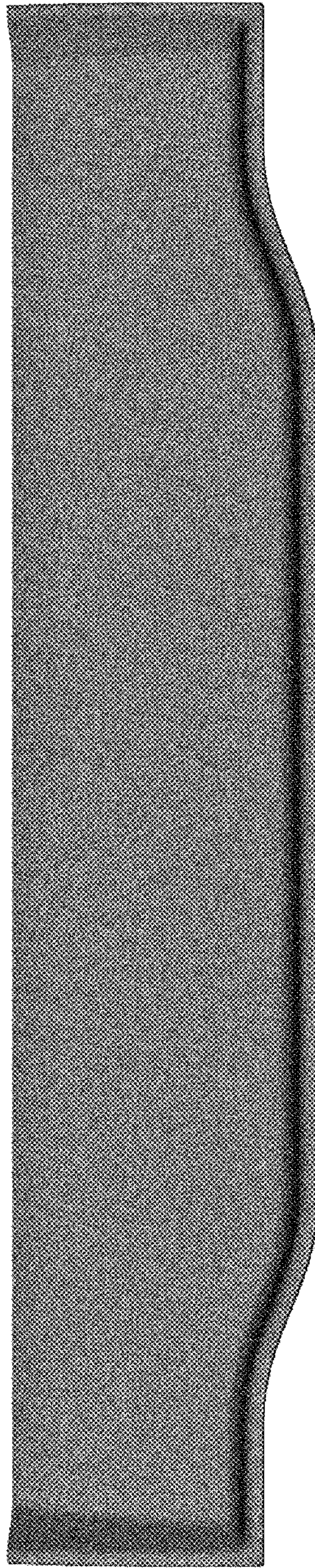

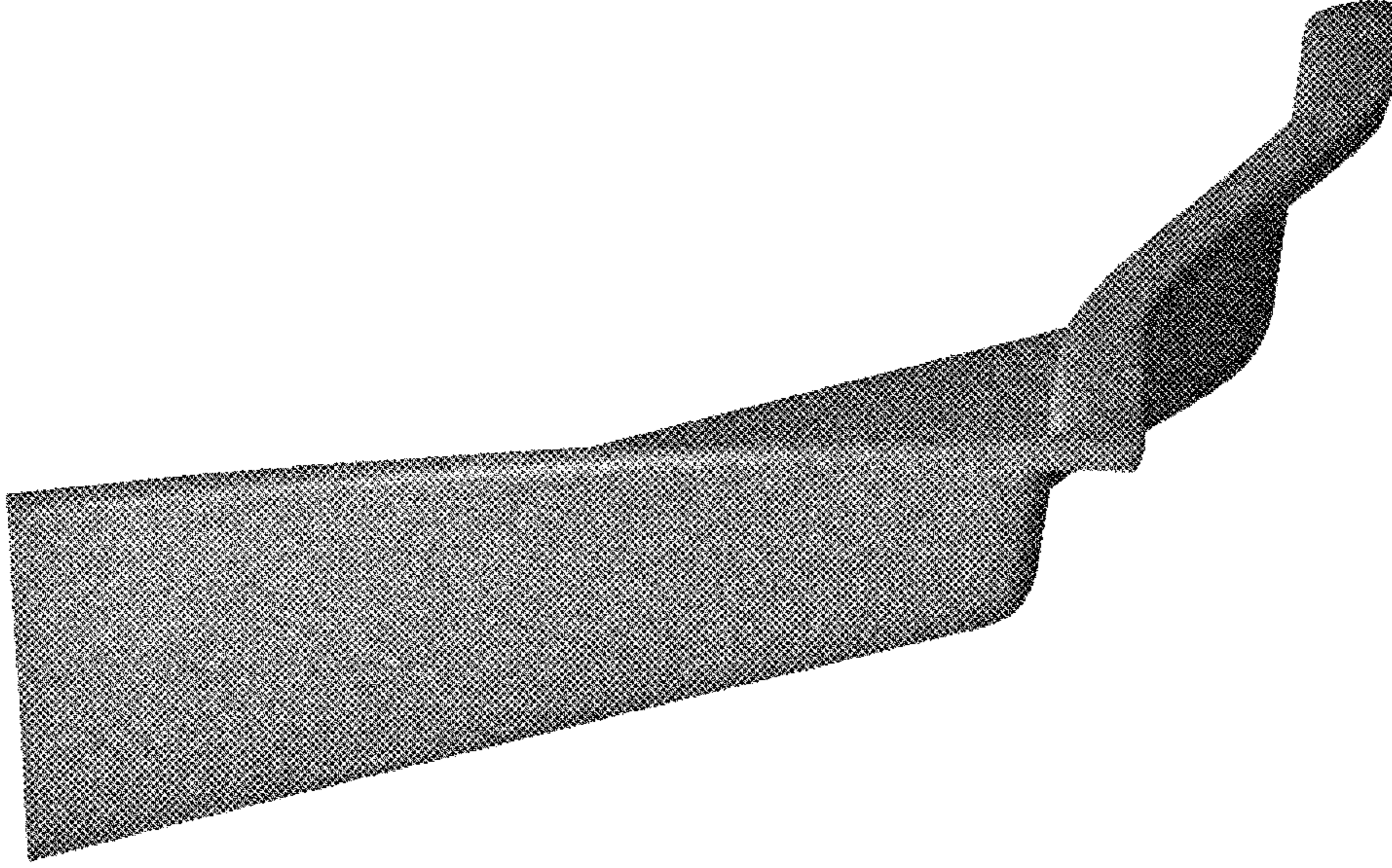

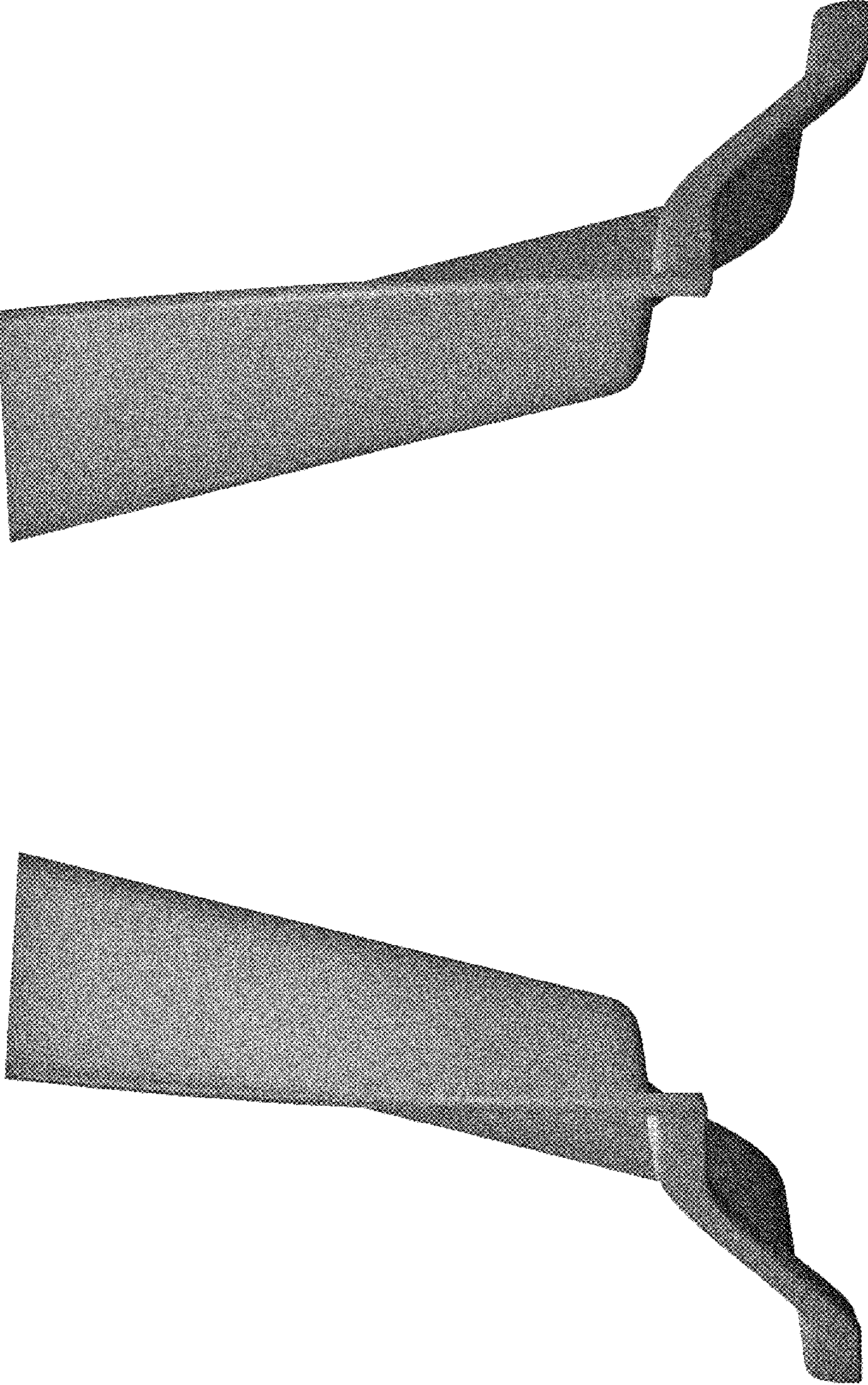

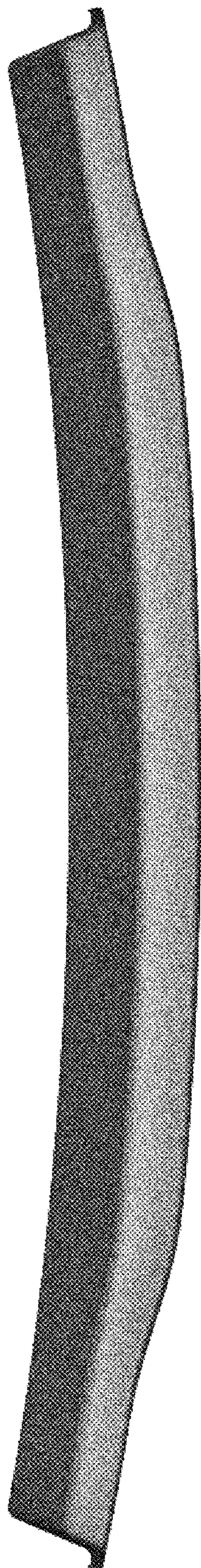

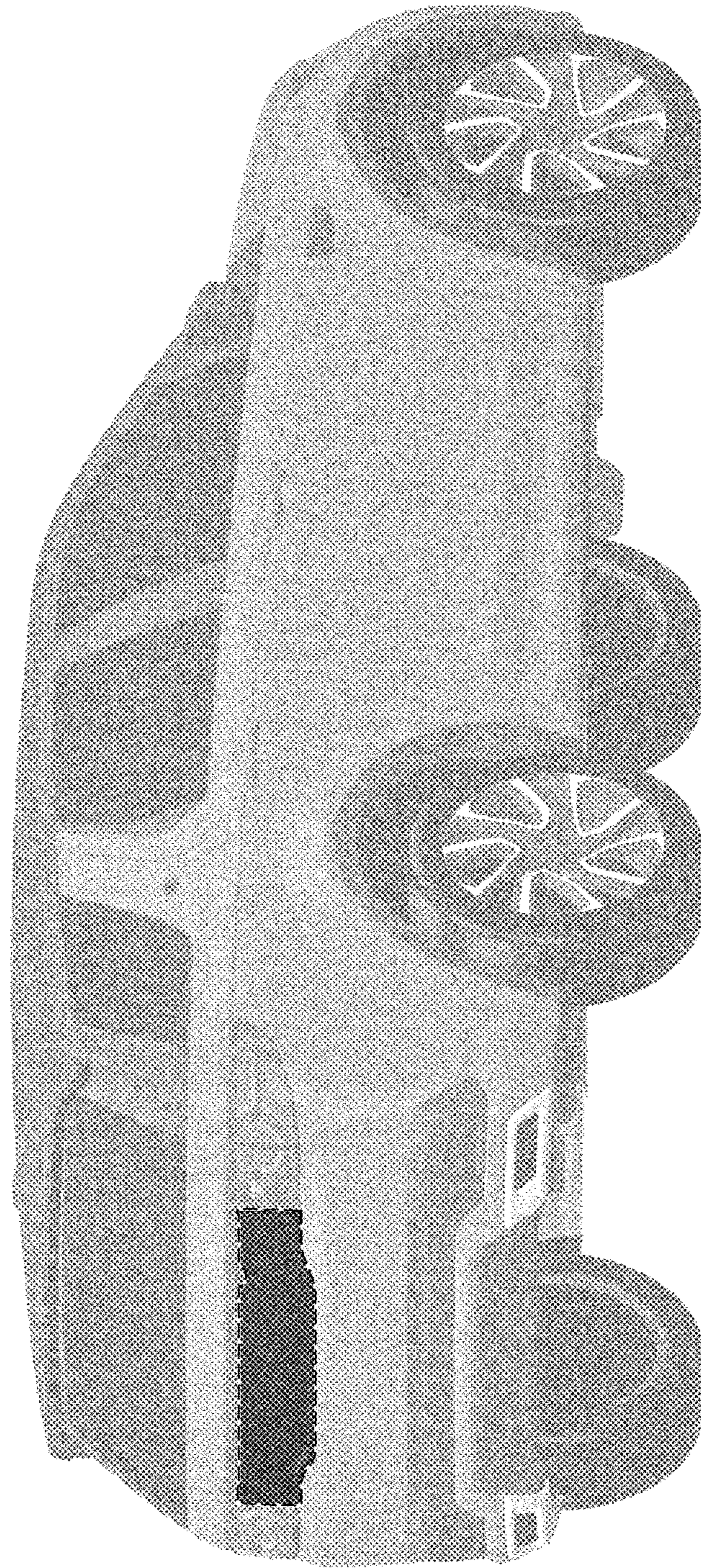
