(57) **CLAIM**

The ornamental design for an automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an automobile tire showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a top view thereof.

FIG. 7 is a bottom view thereof.

FIG. 8 is a partially enlarged view of a portion defined by lines 8-8 shown in FIG. 1;

FIG. 9 is a partially enlarged view of a portion defined by lines 9-9 shown in FIG. 2; and,

FIG. 10 is a cross-sectional view taken in the direction of line 10-10 of FIG. 9.

The evenly-spaced broken line showing portions of a tire depicts environment and forms no part of the claim; the dash-dot-dash lines represent boundaries of the claimed design and form no part thereof.

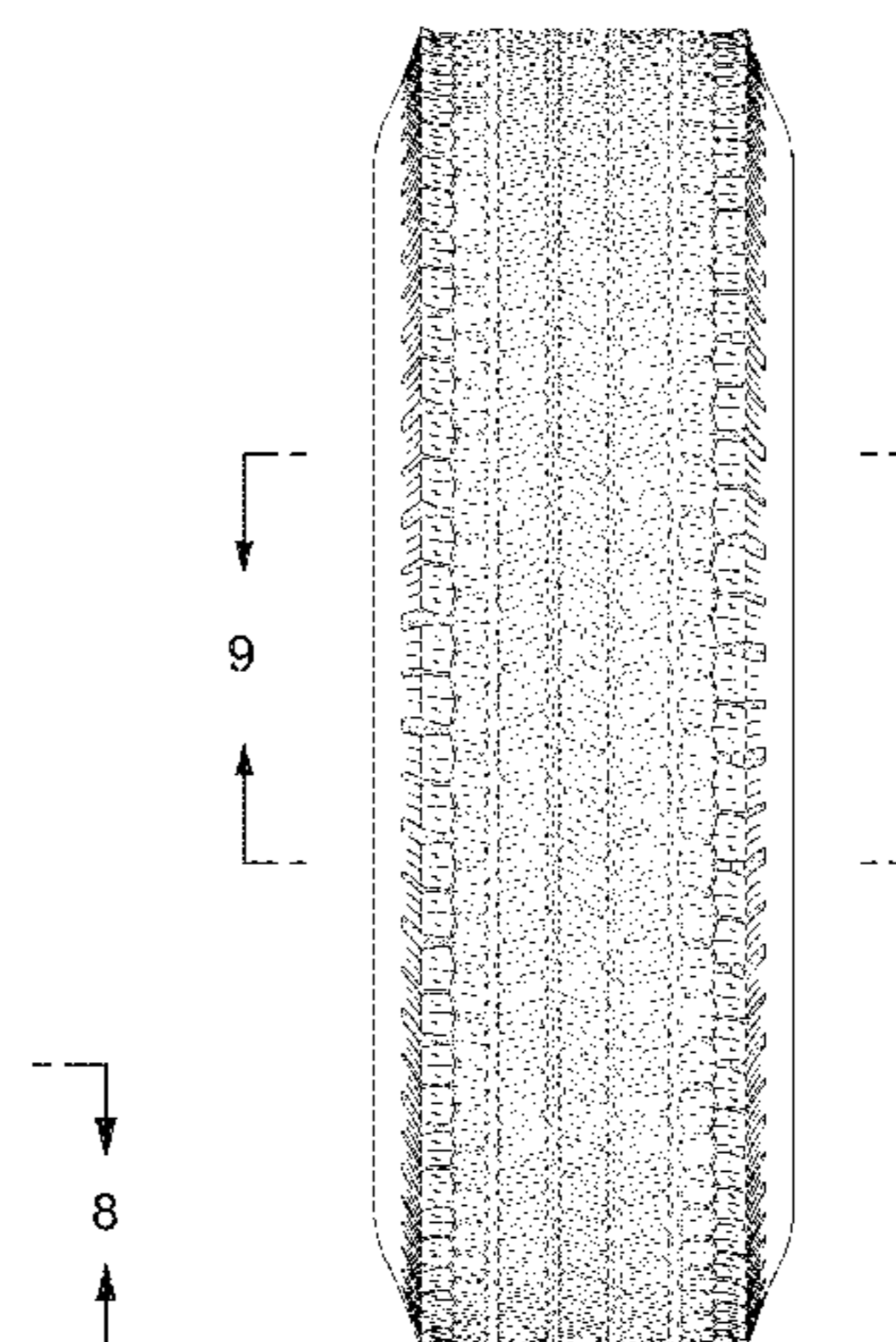
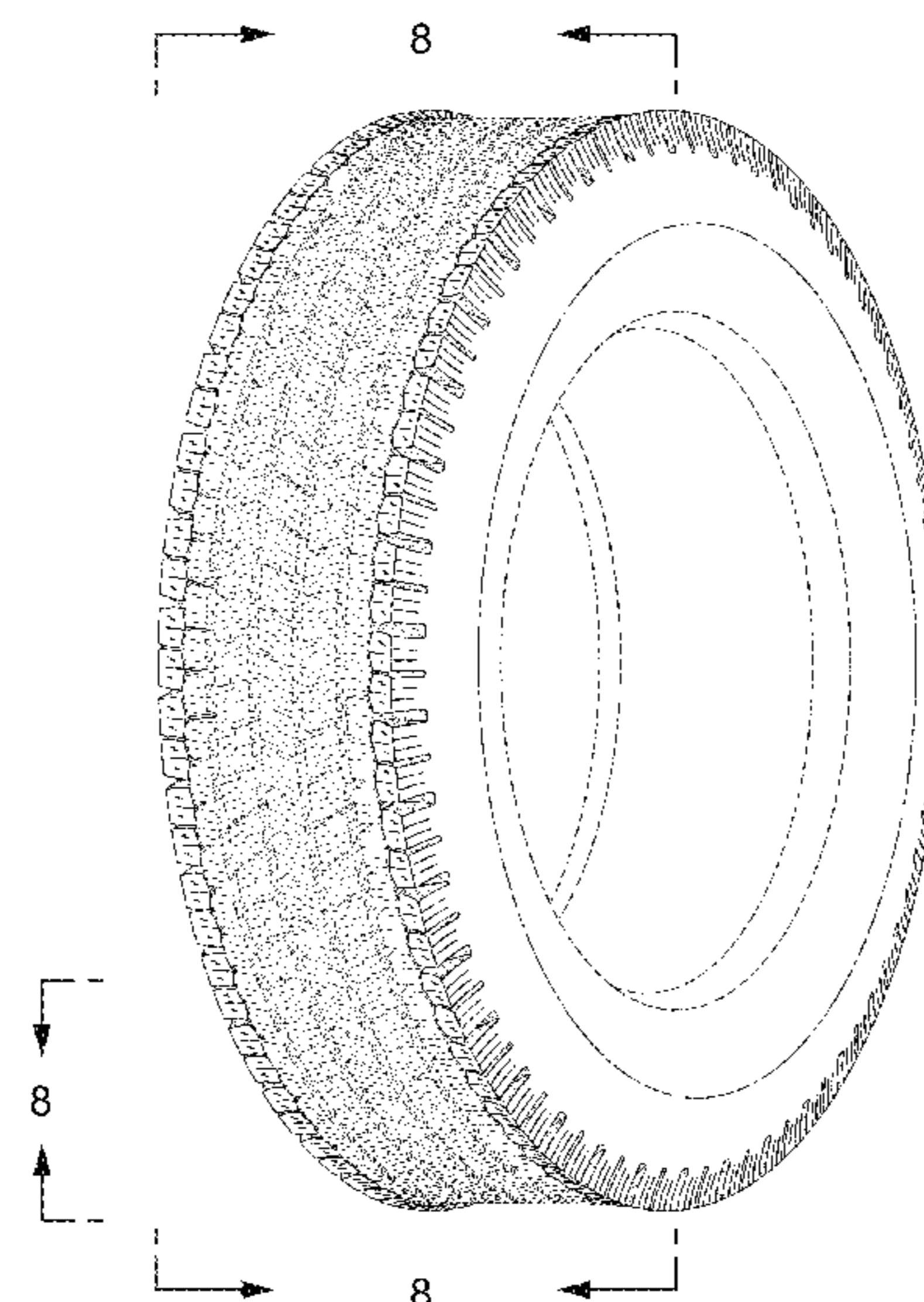

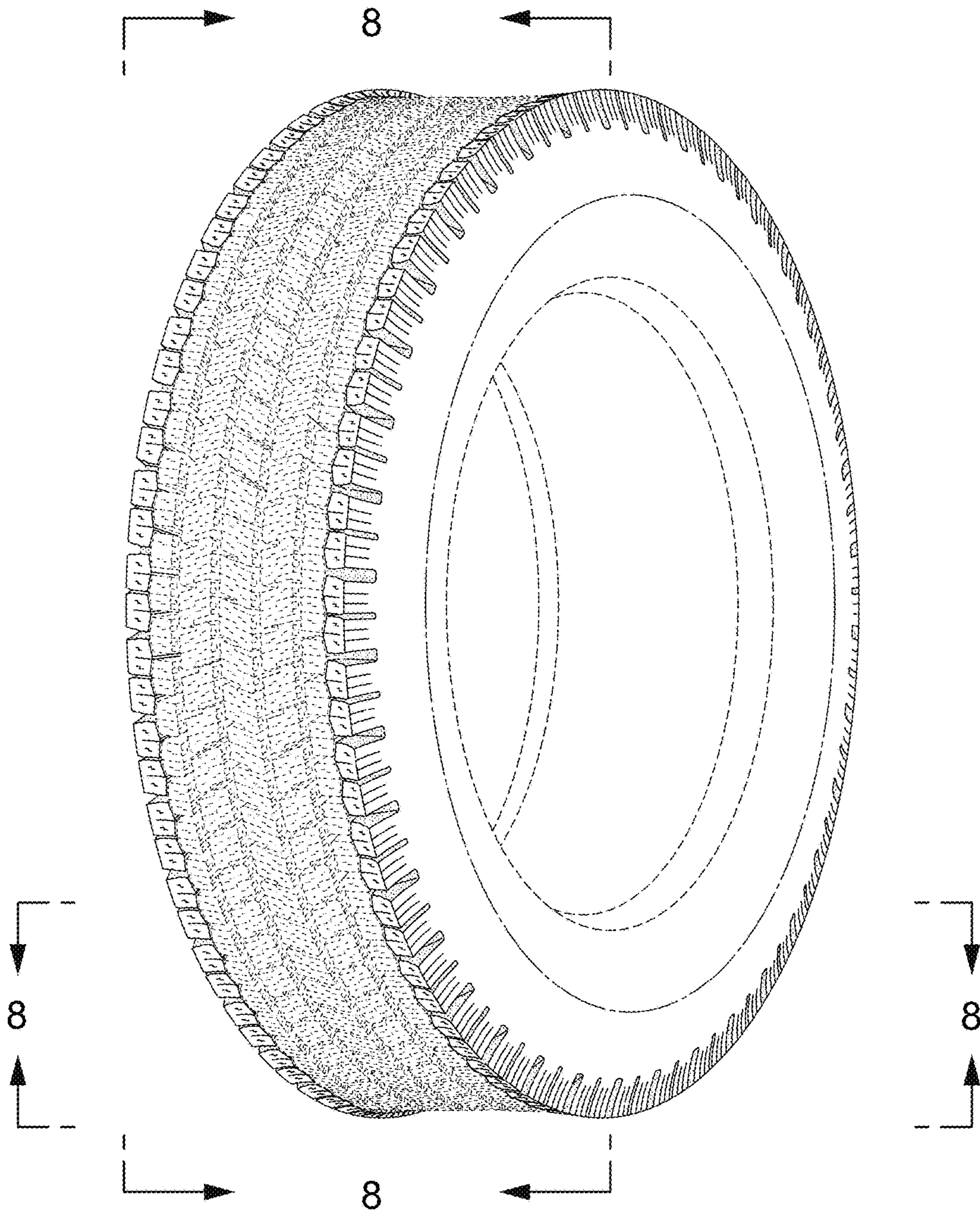

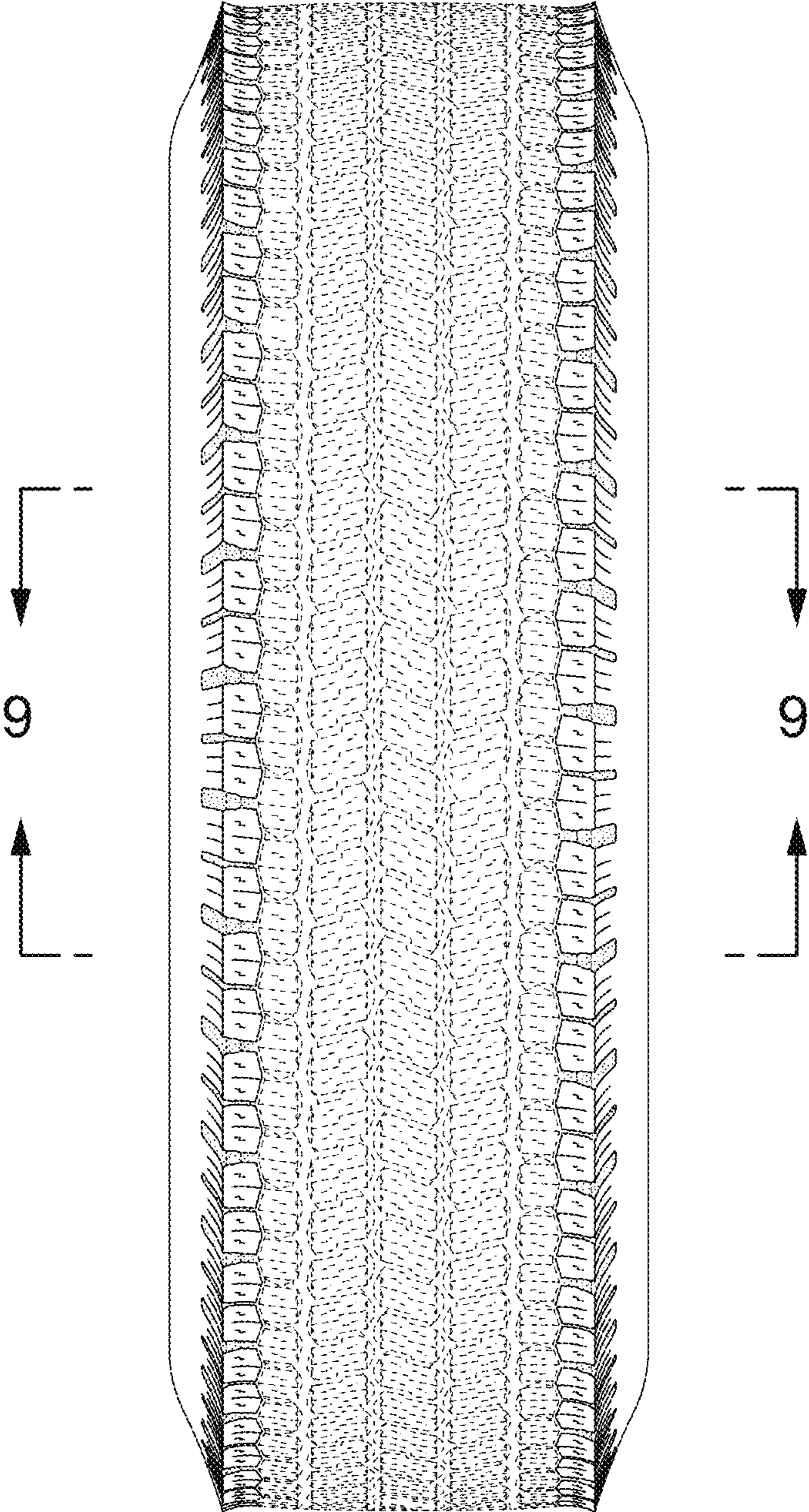

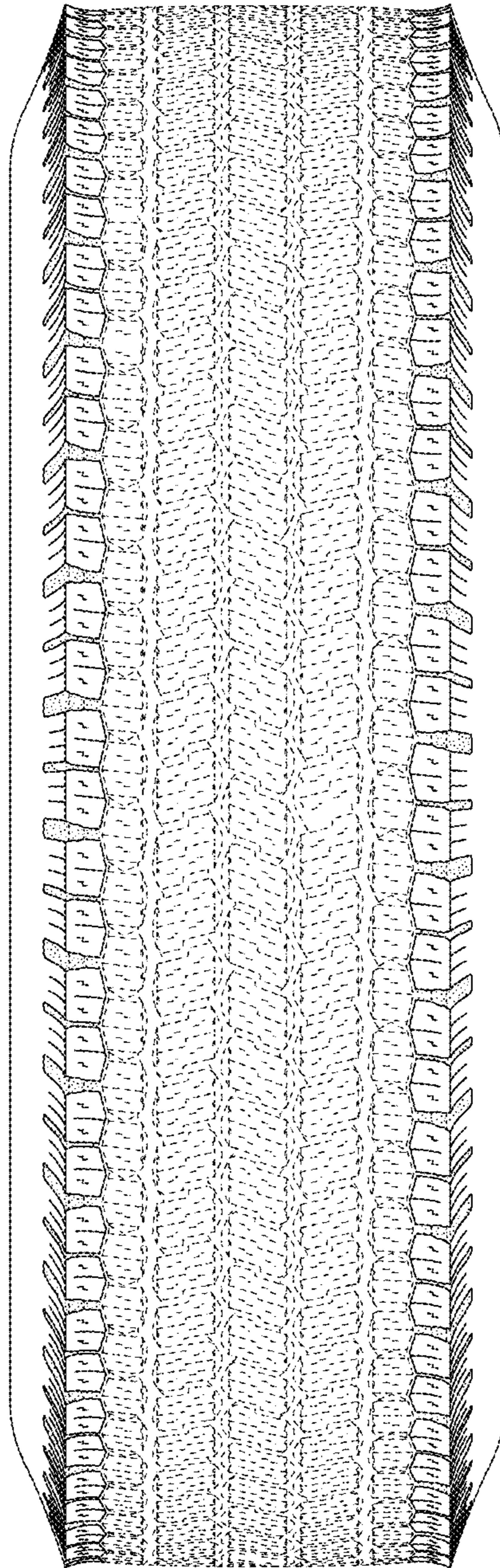

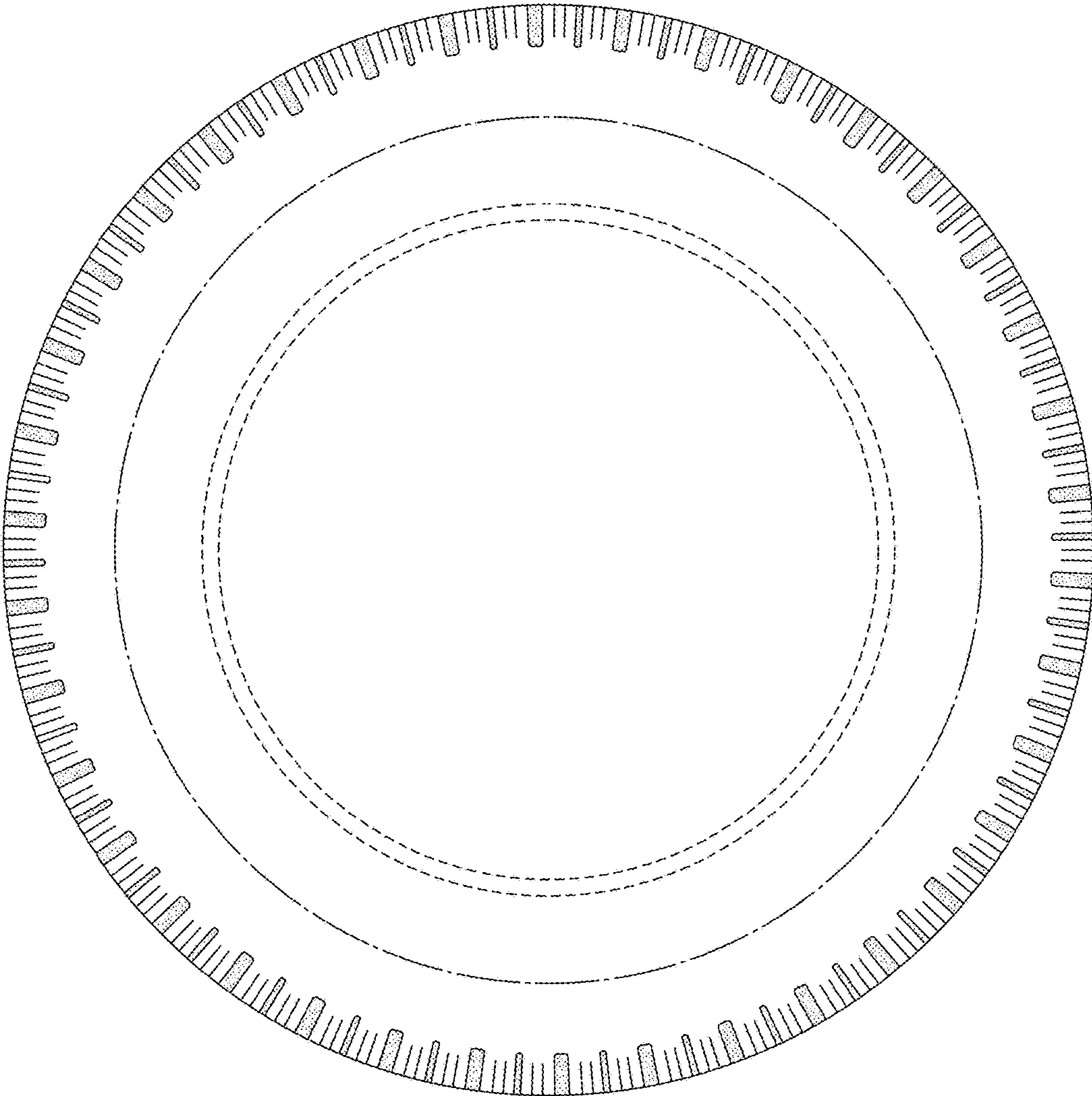

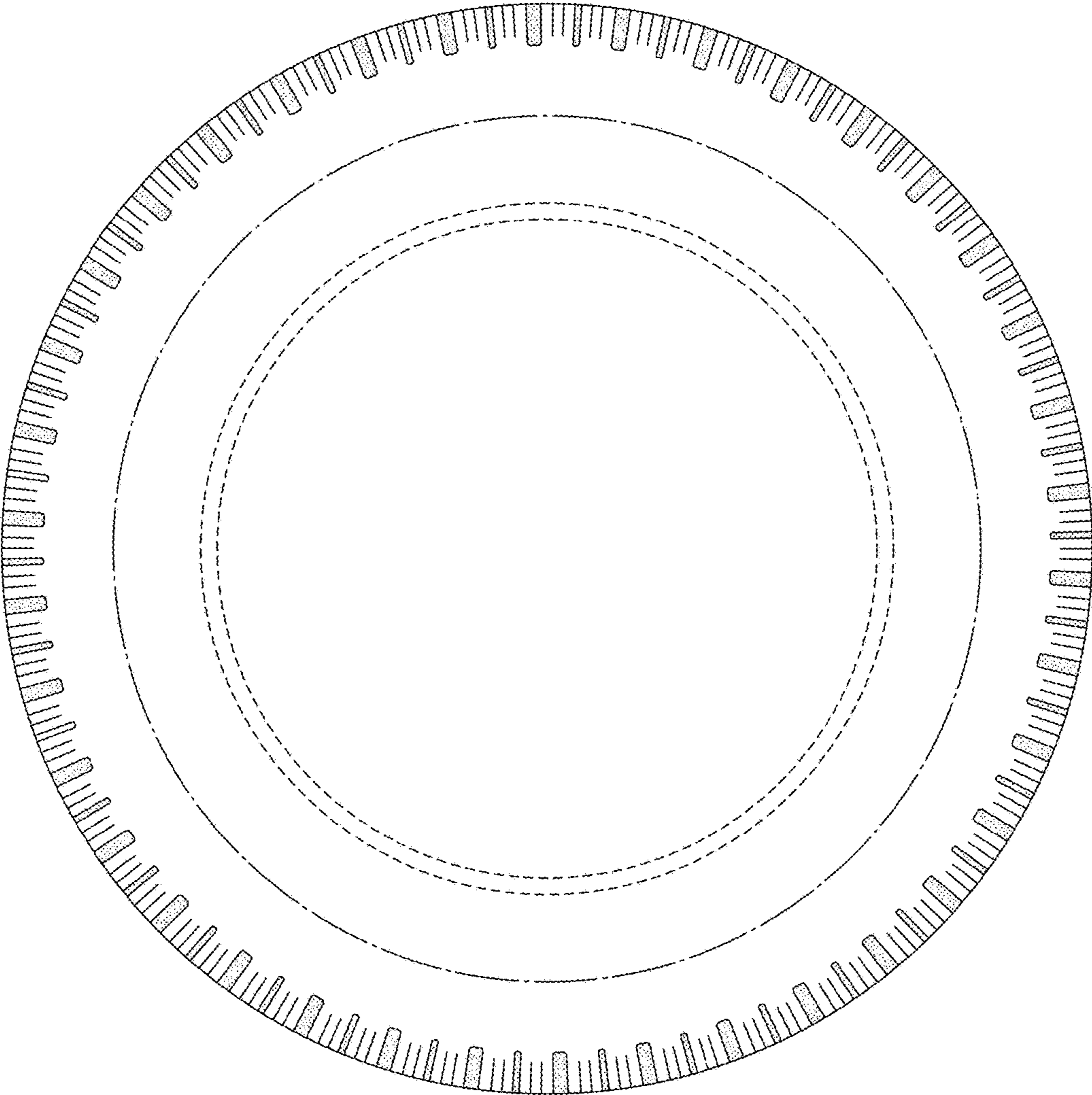

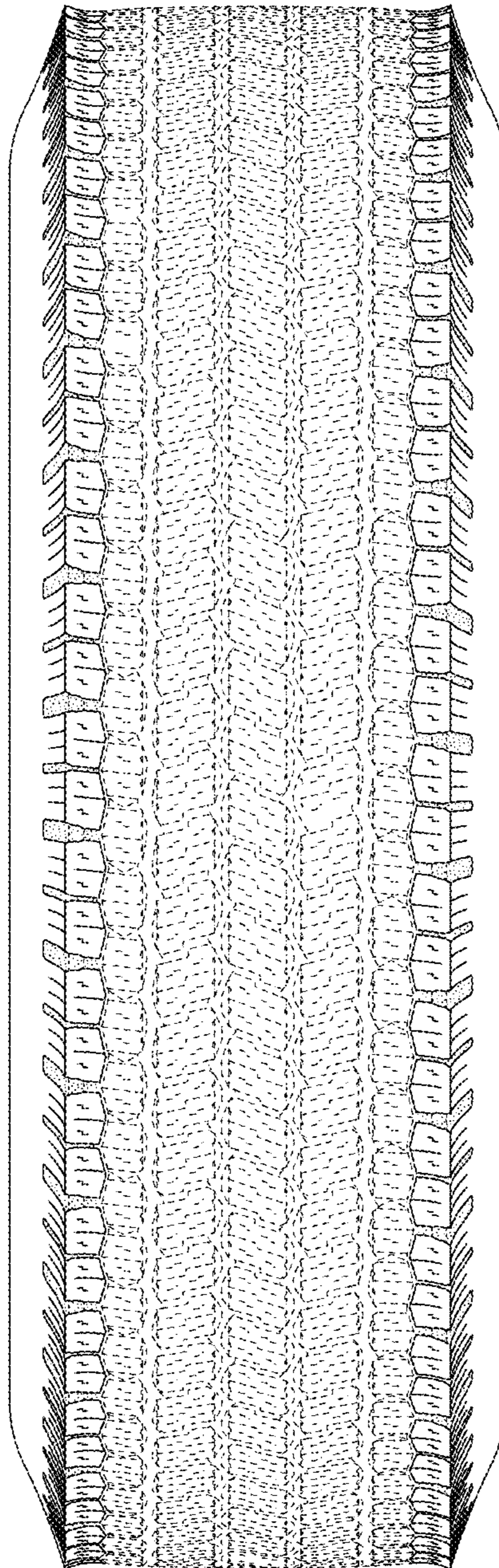

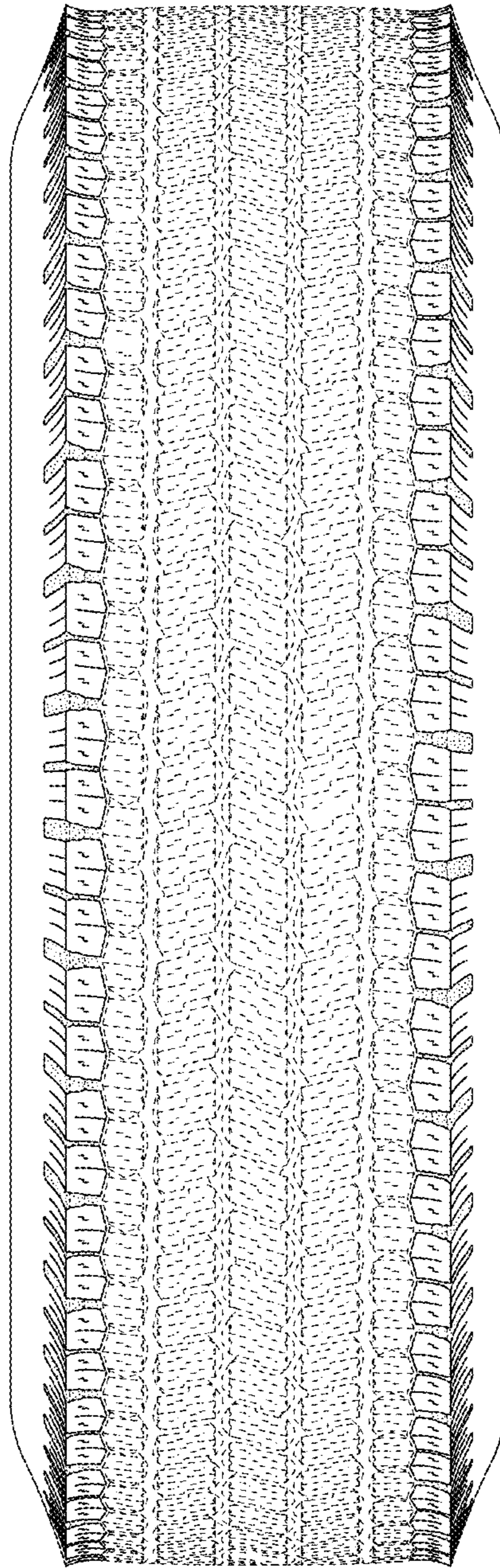

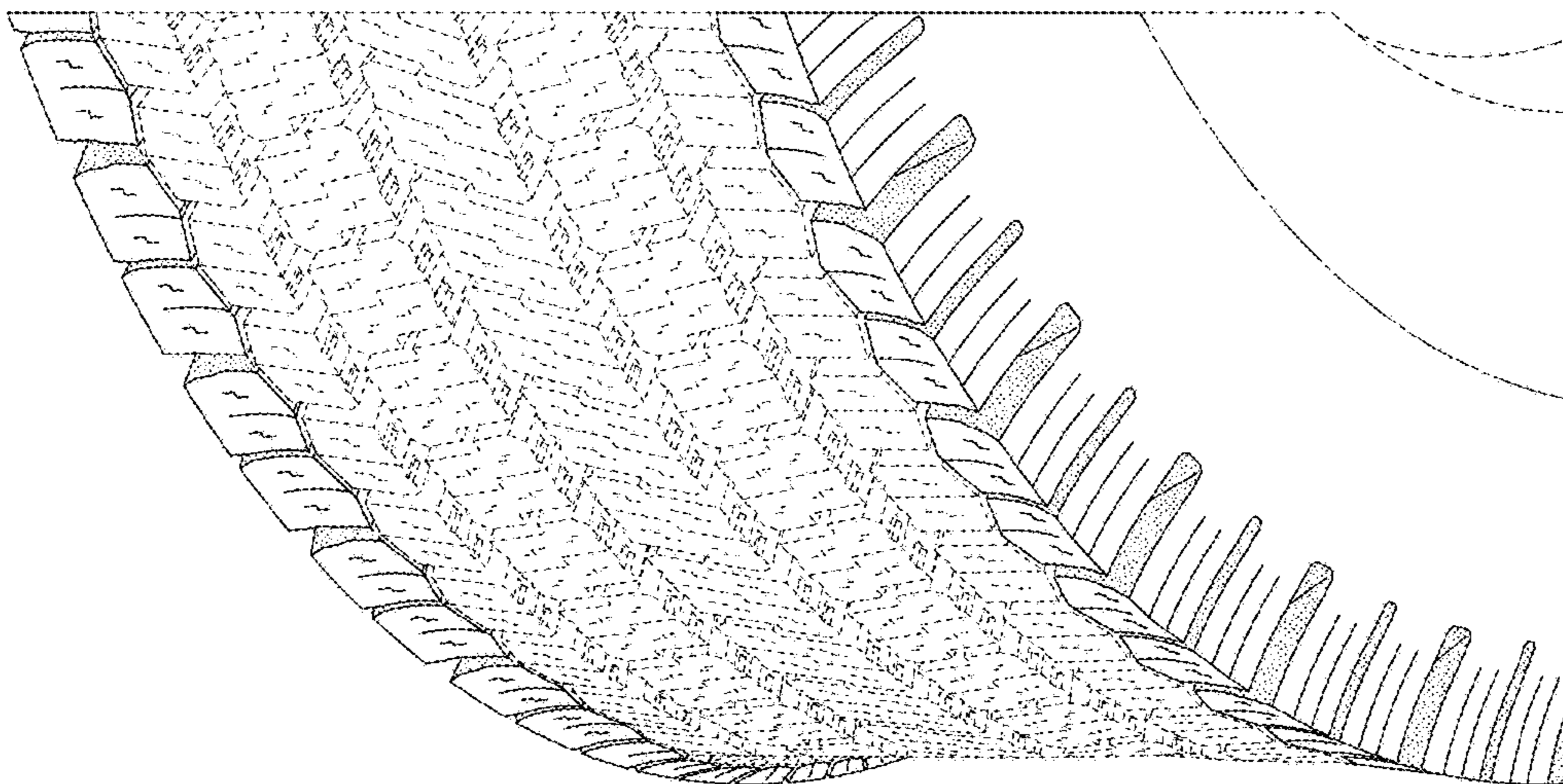

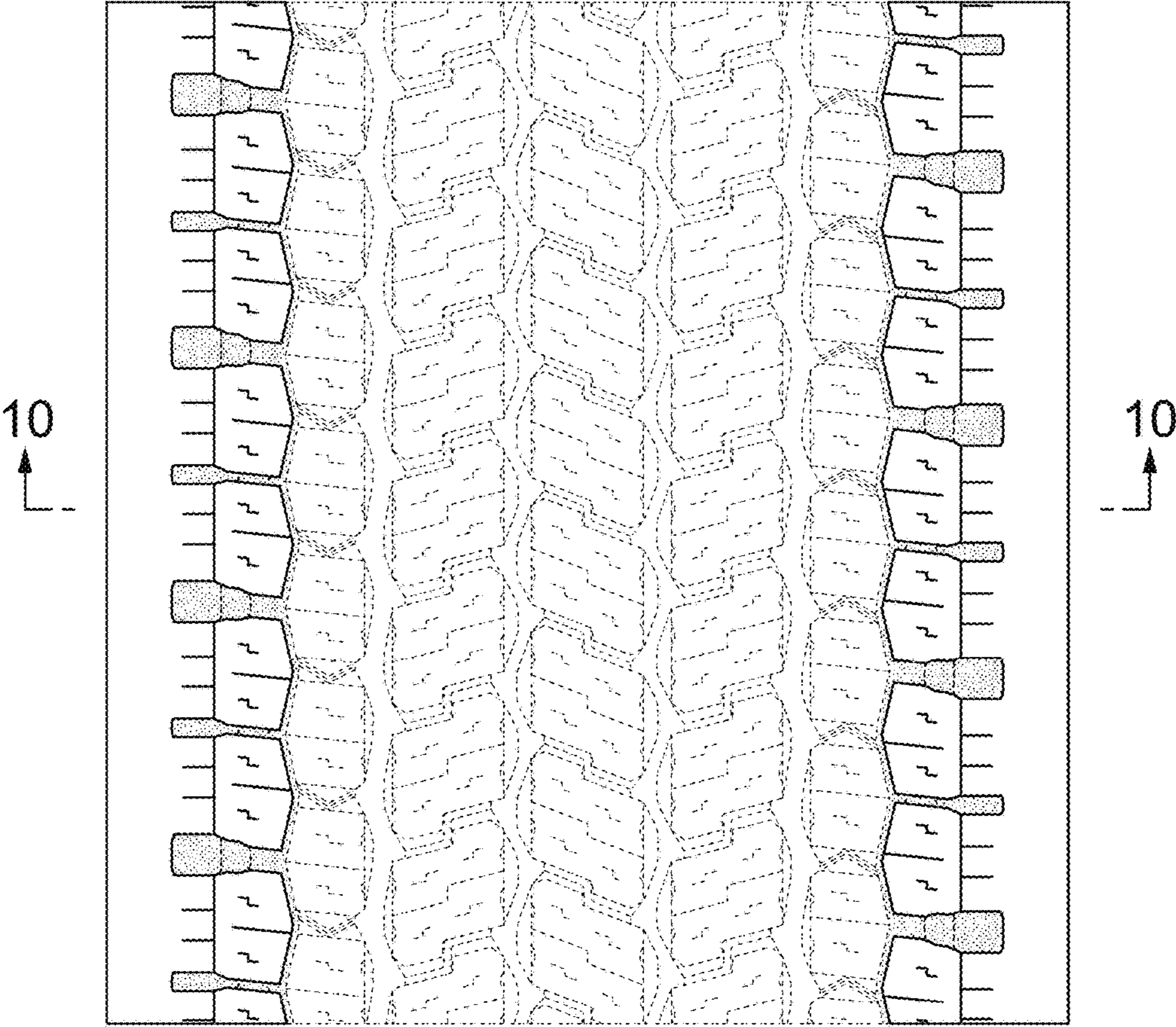
