(57) **CLAIM**

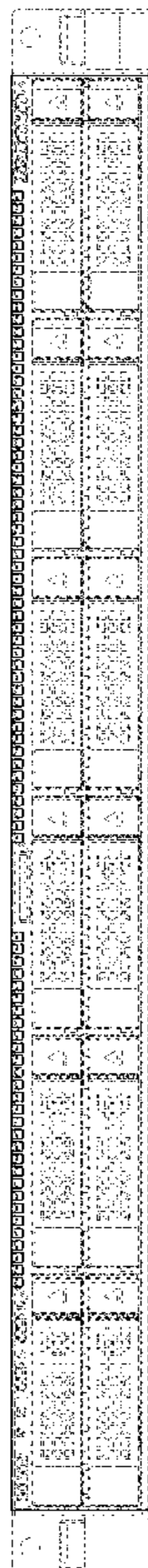
The ornamental design for a server, as shown and described.

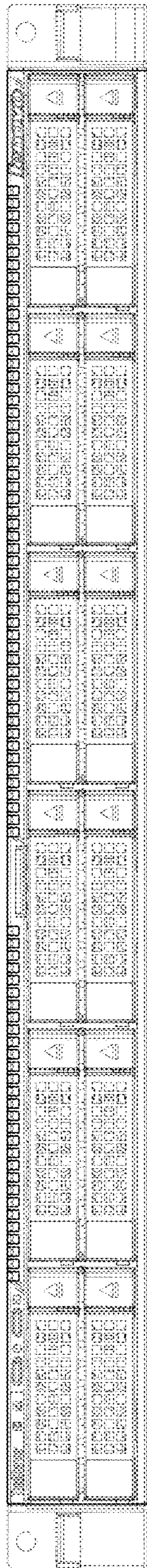

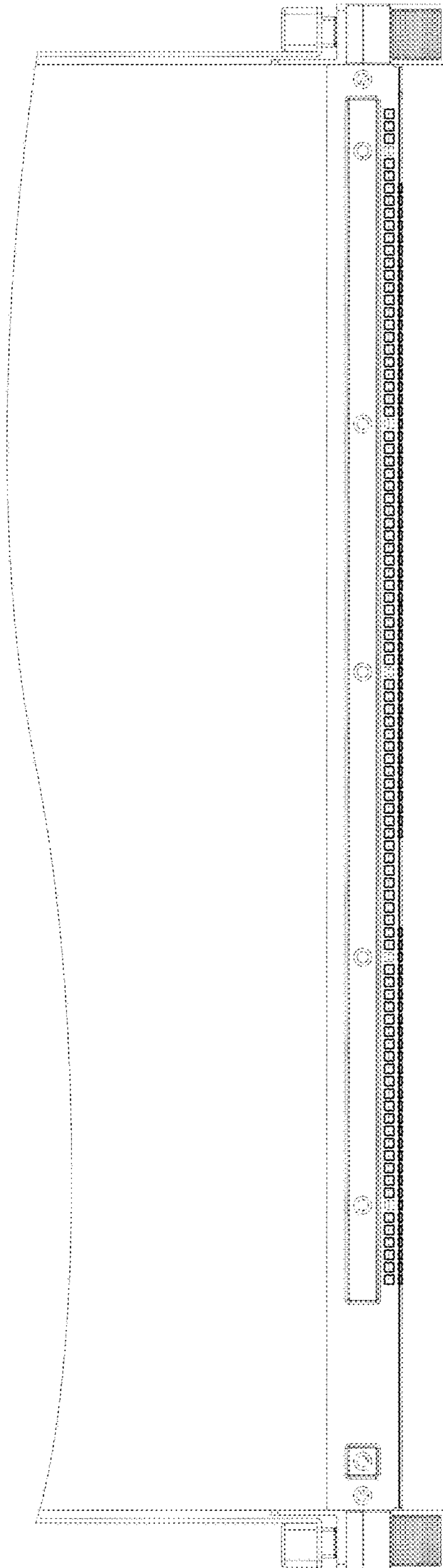
