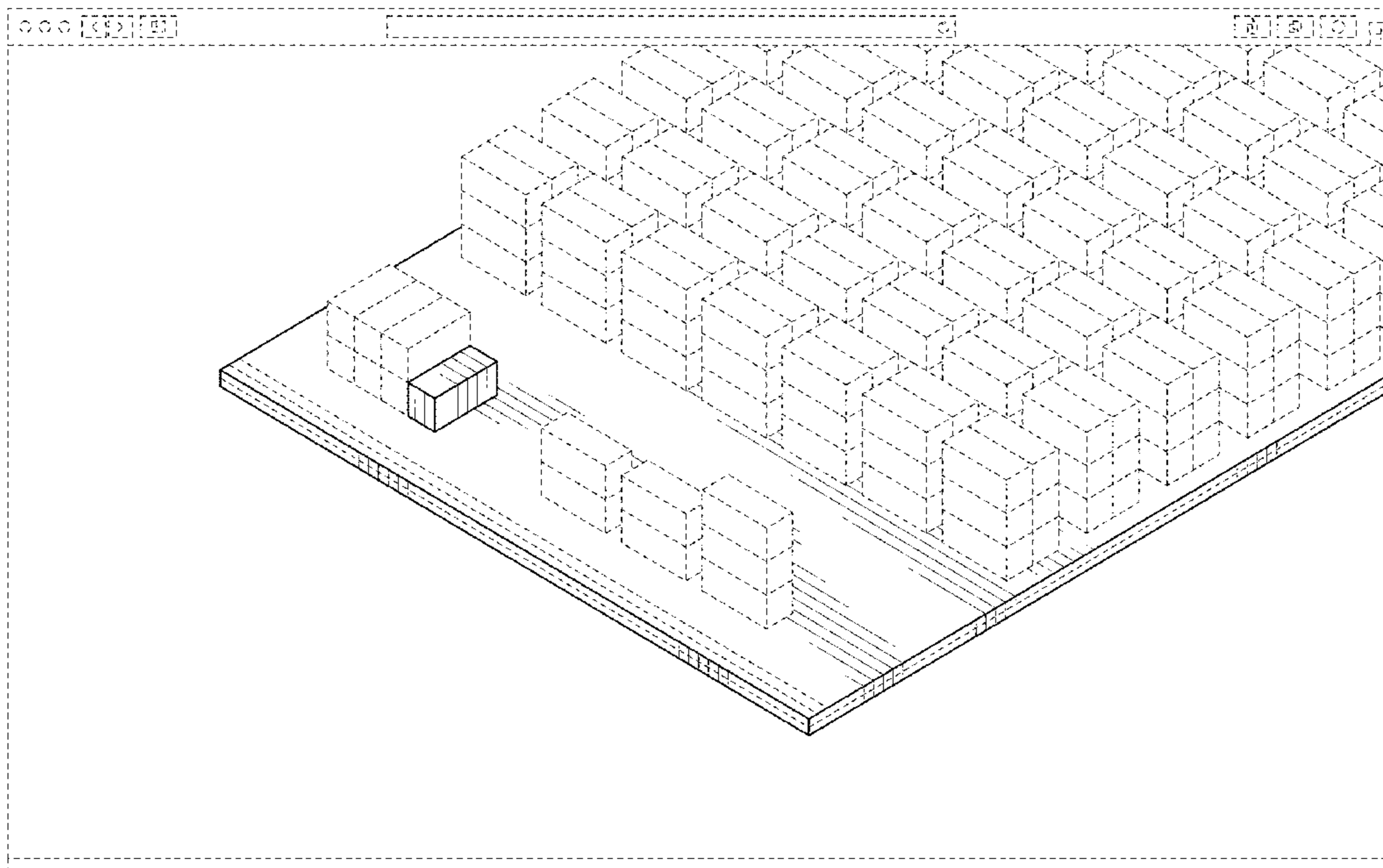
(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a display screen with graphical user interface showing my new design; FIG. 2 is a front view of a second embodiment thereof; FIG. 3 is a front view of a third embodiment thereof; FIG. 4 is a front view of a fourth embodiment thereof; FIG. 5 is a front view of a fifth embodiment thereof; and, FIG. 6 is a front view of a sixth embodiment thereof. The outermost broken line rectangle illustrates the display screen. The remaining broken lines illustrate portions of the graphical user interface. None of the broken lines form part of the claimed design.

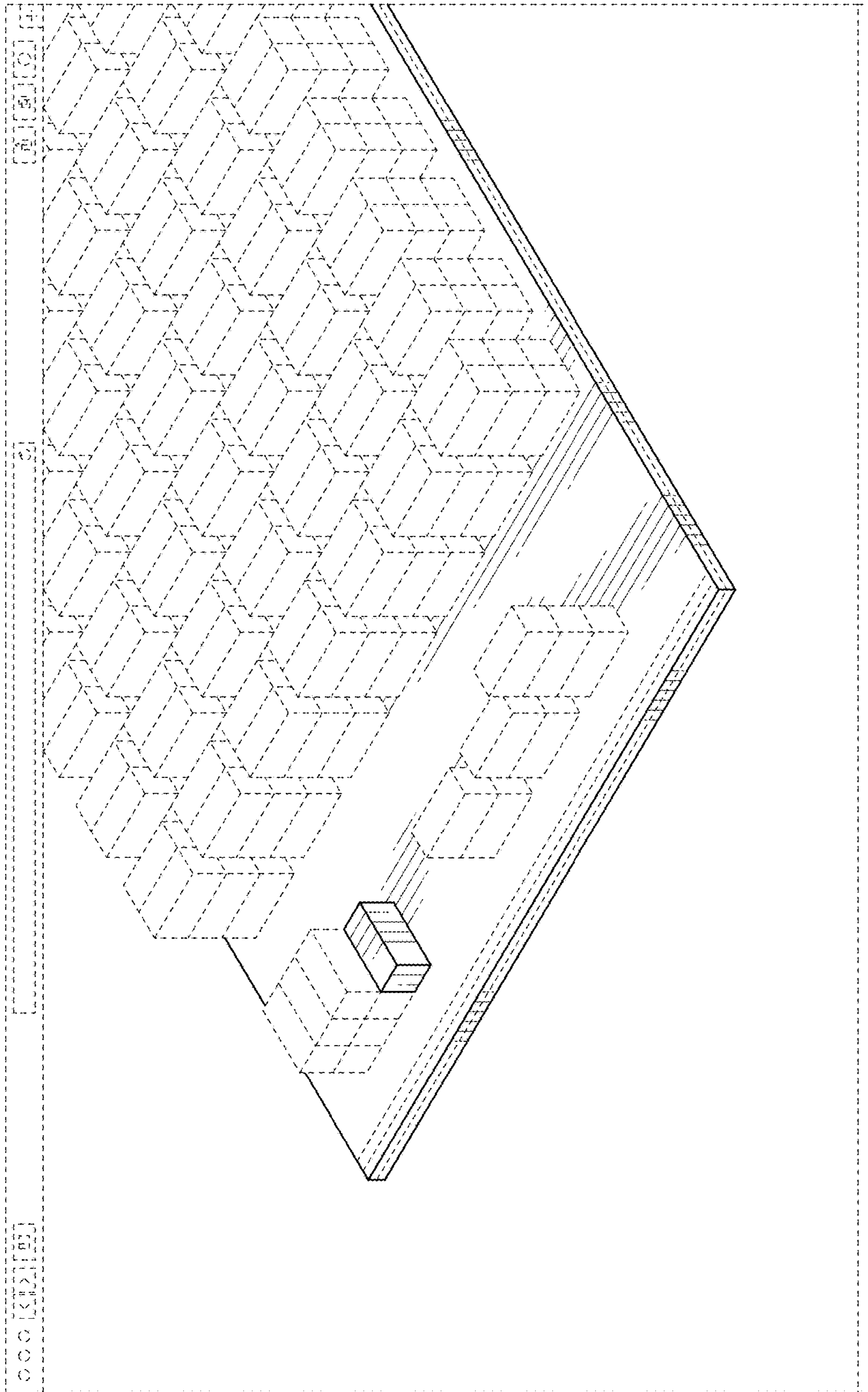

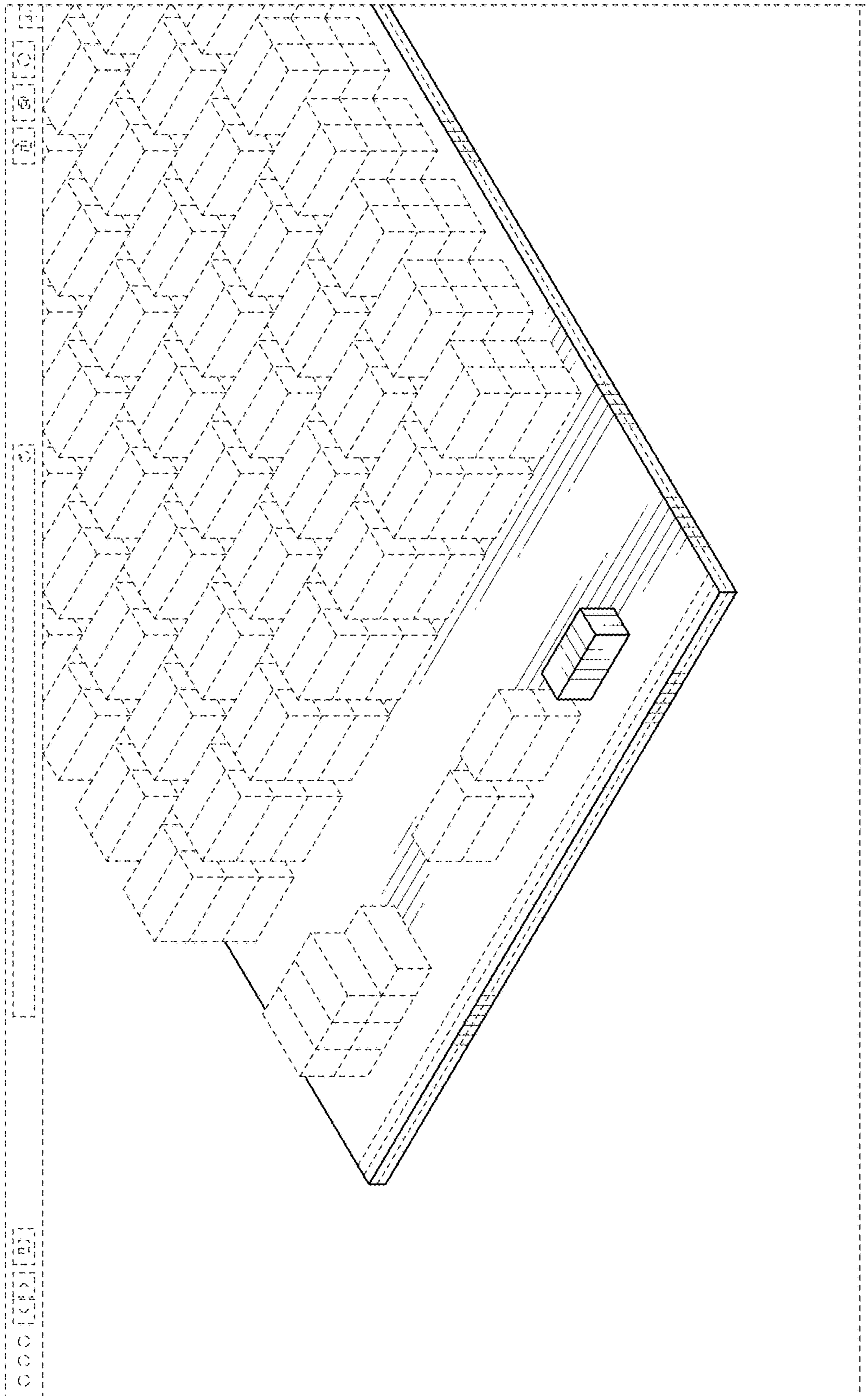

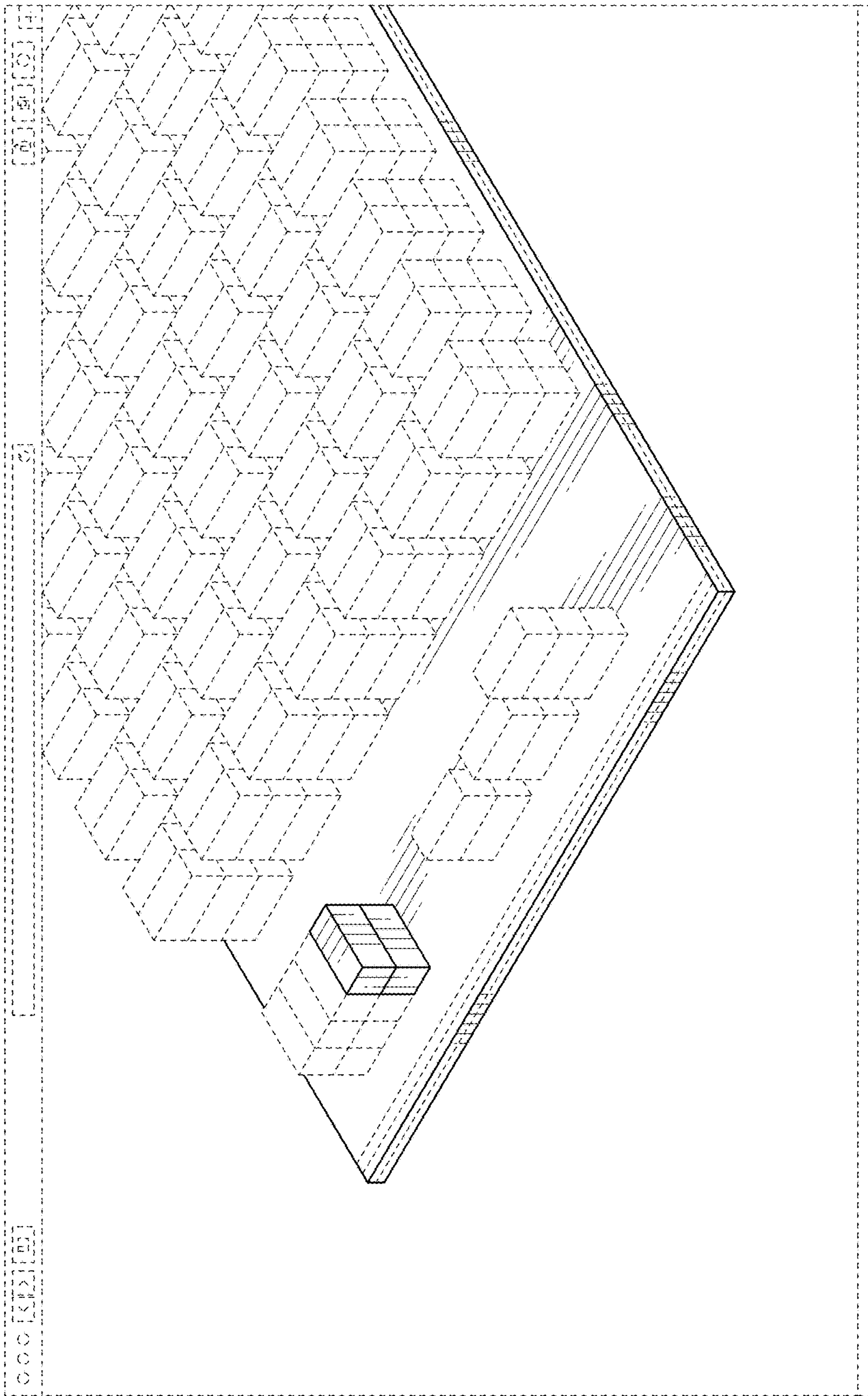

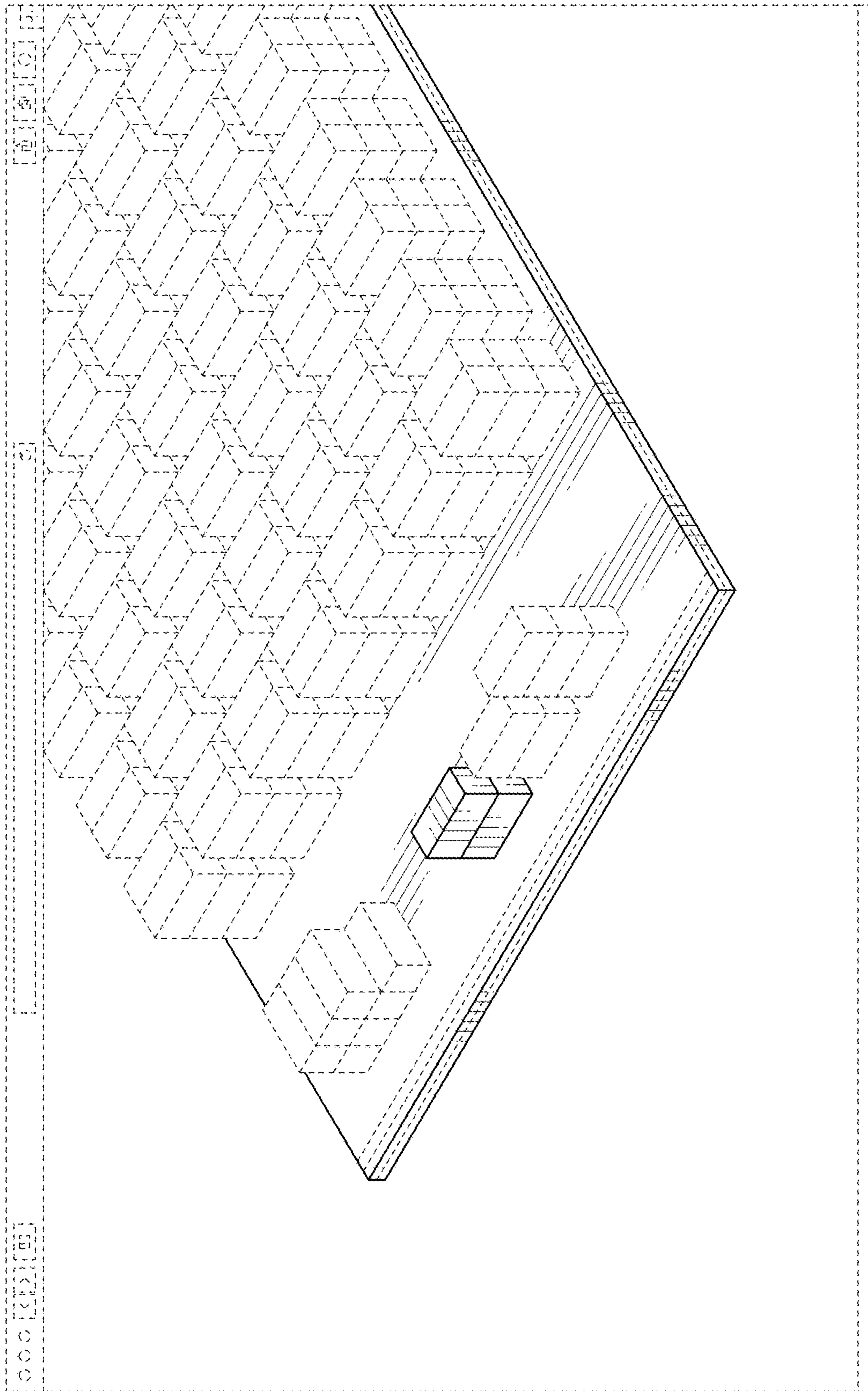

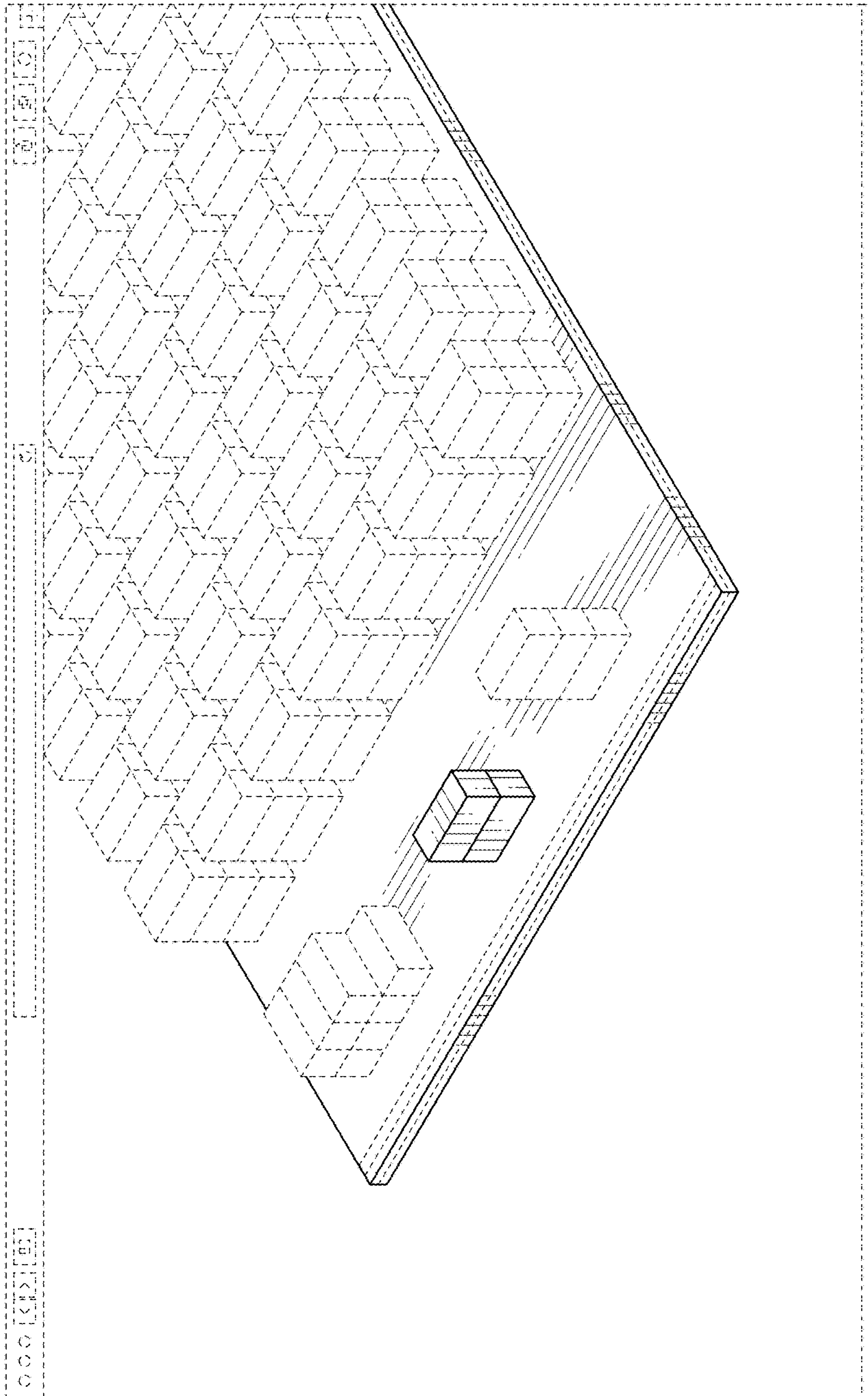

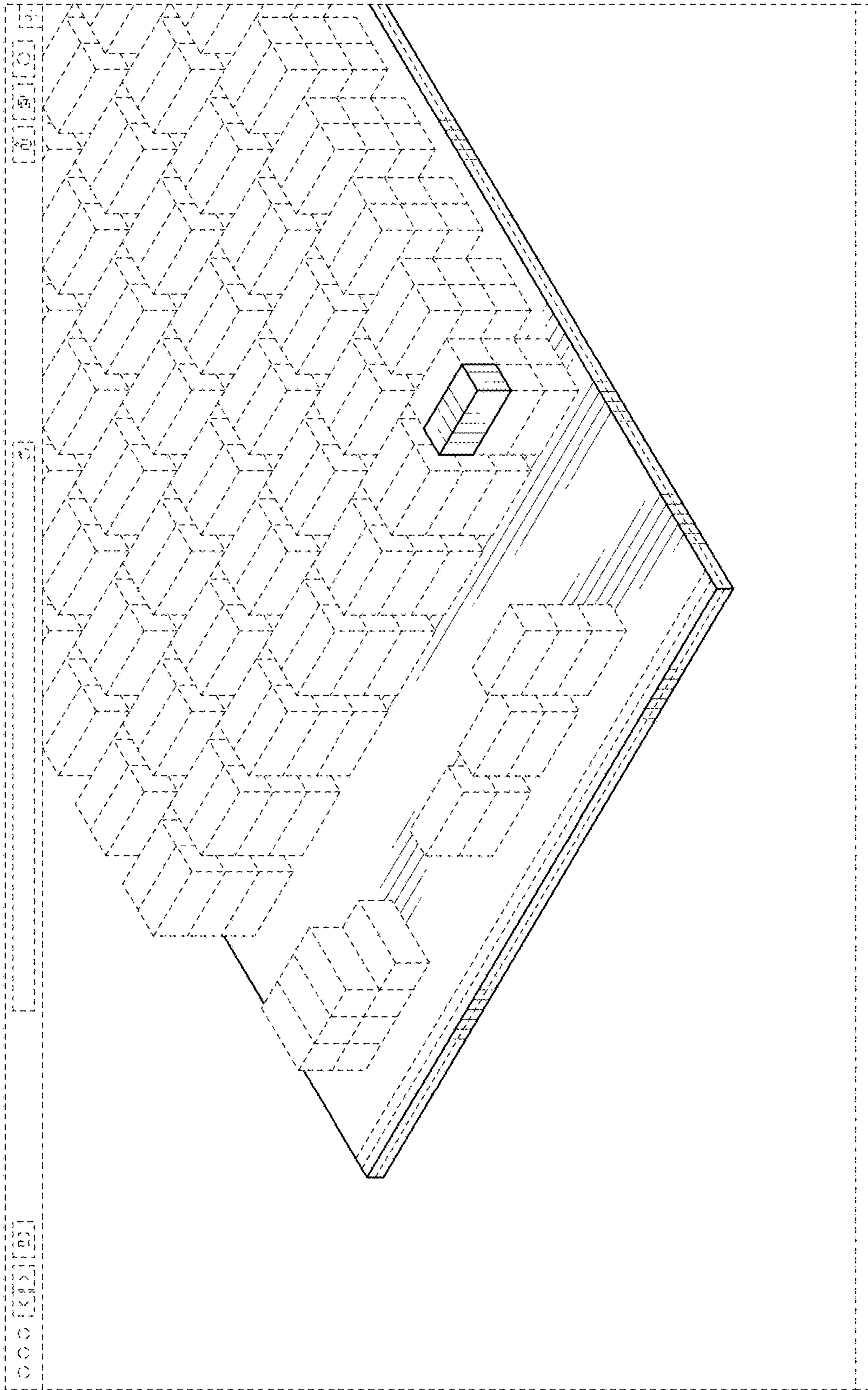
