FIG. 11 is a right side view of the blower housing of FIG. 8;

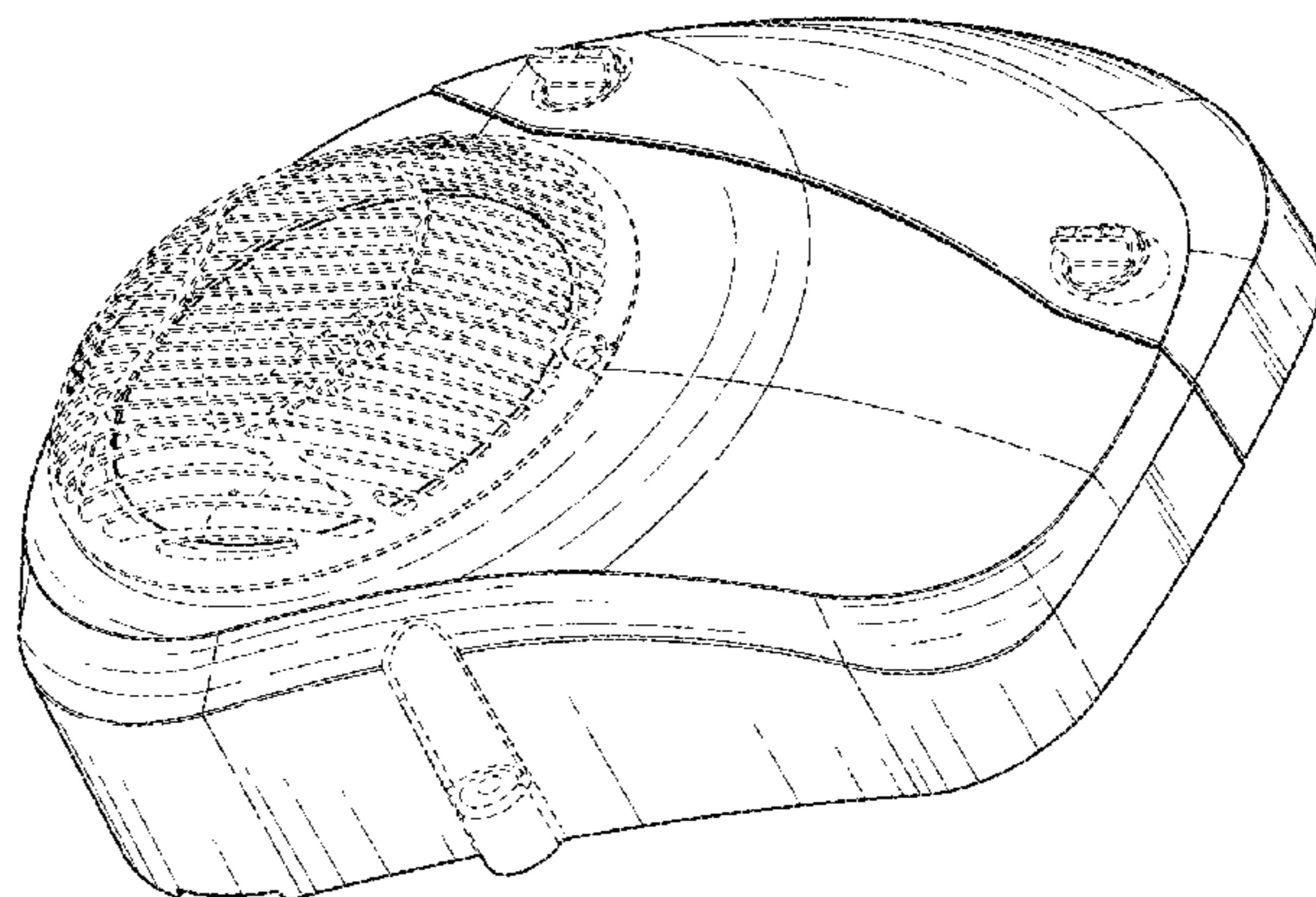
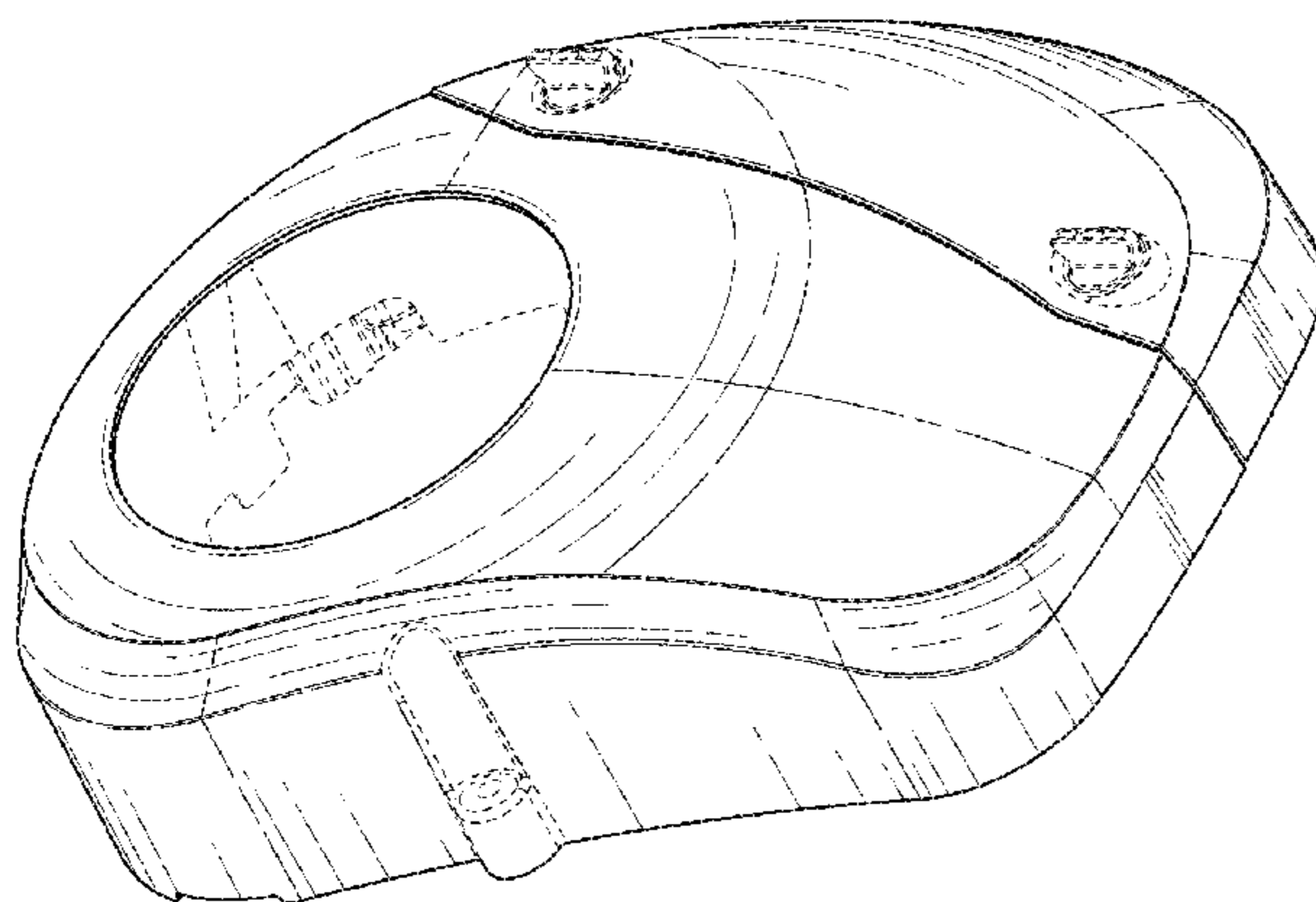
FIG. 12 is a left side view of the blower housing of FIG. 8;

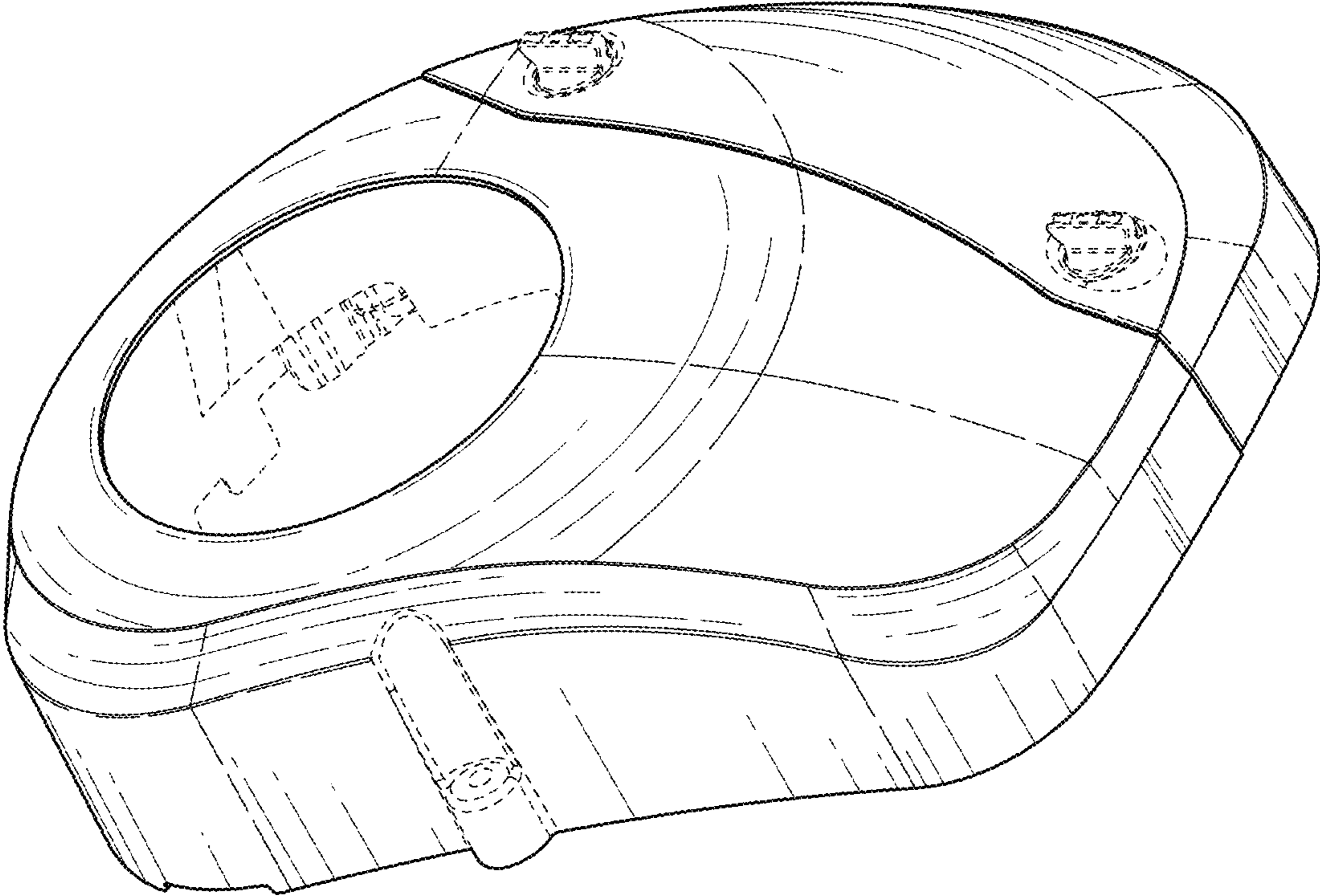

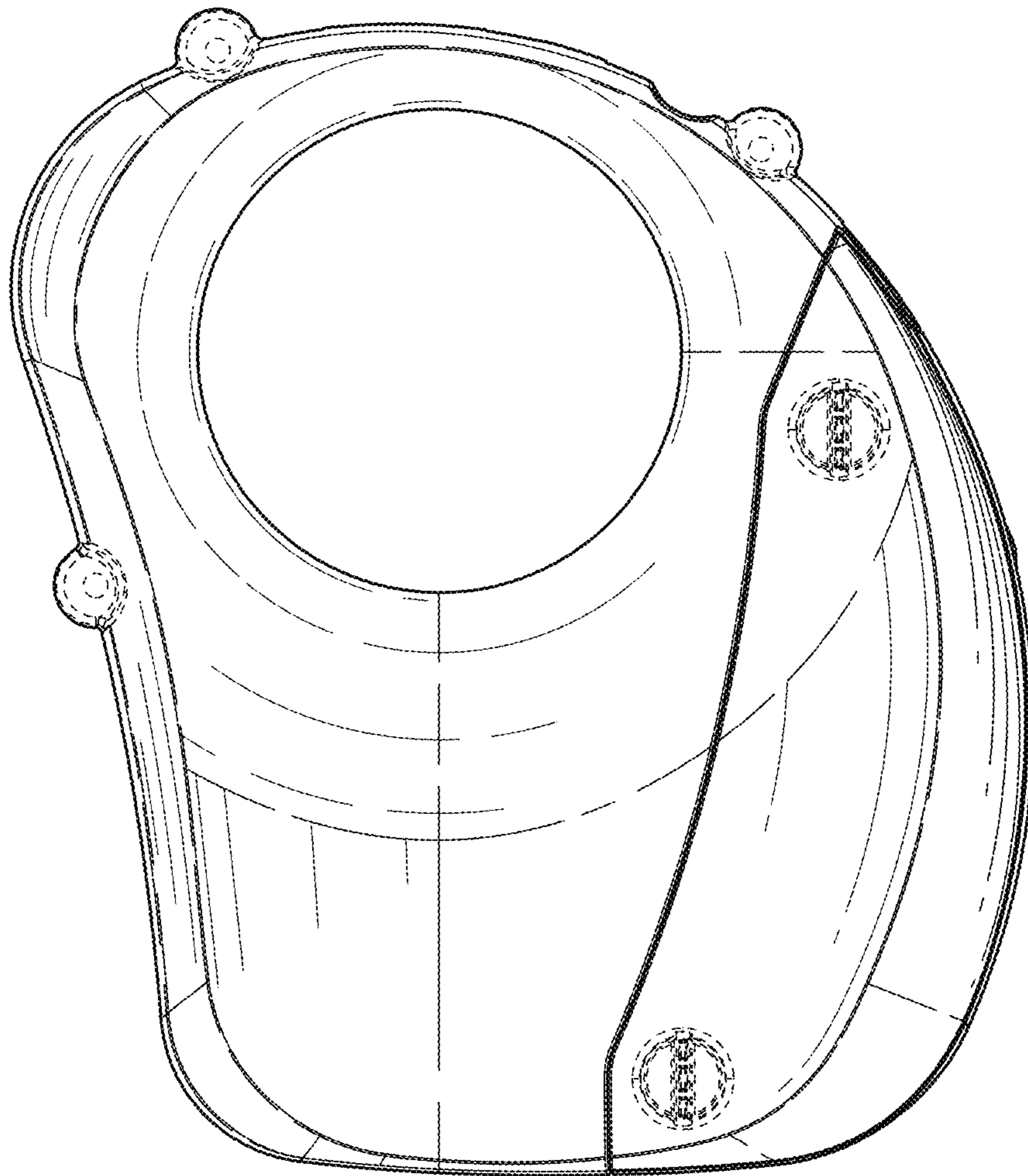

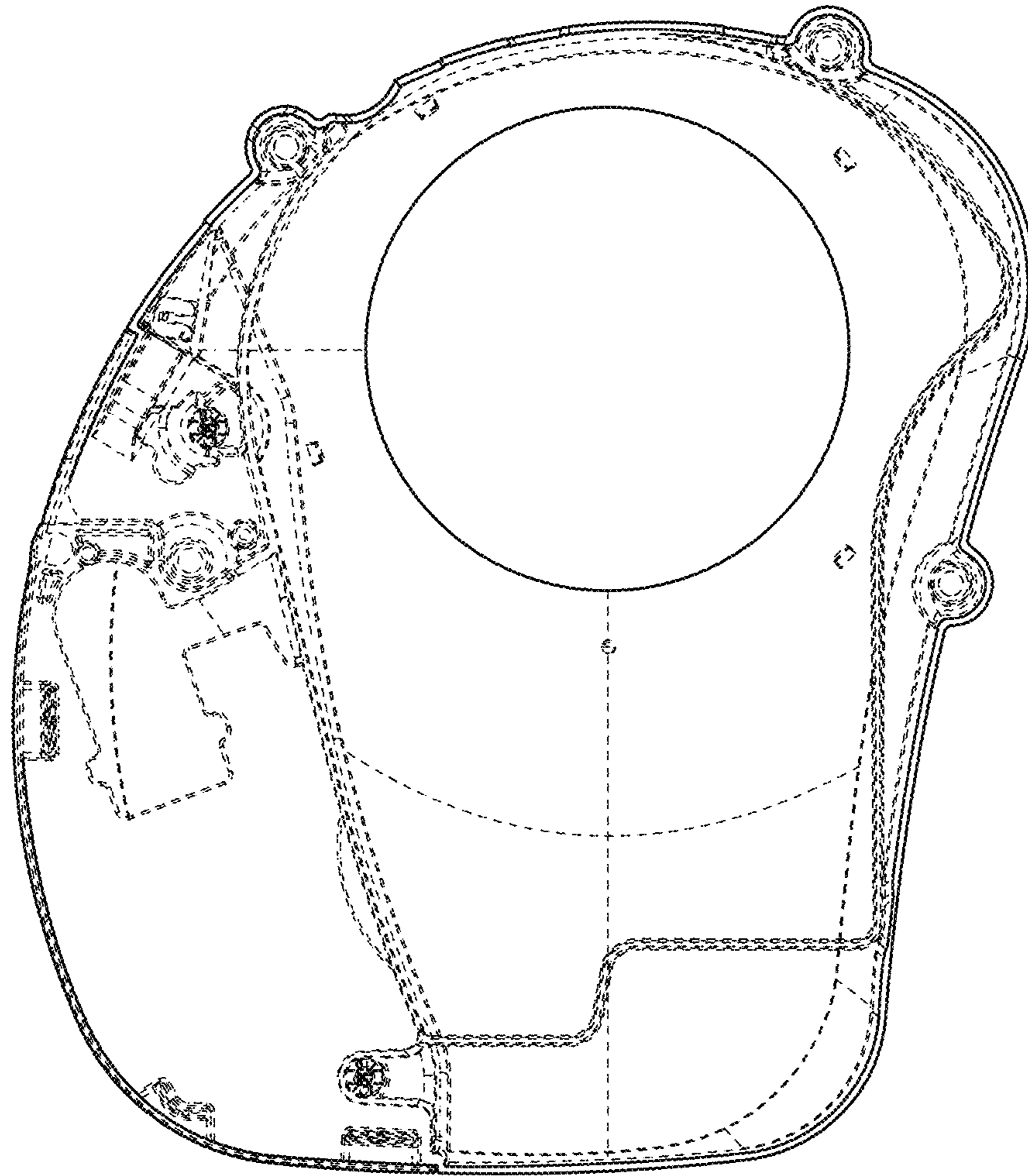

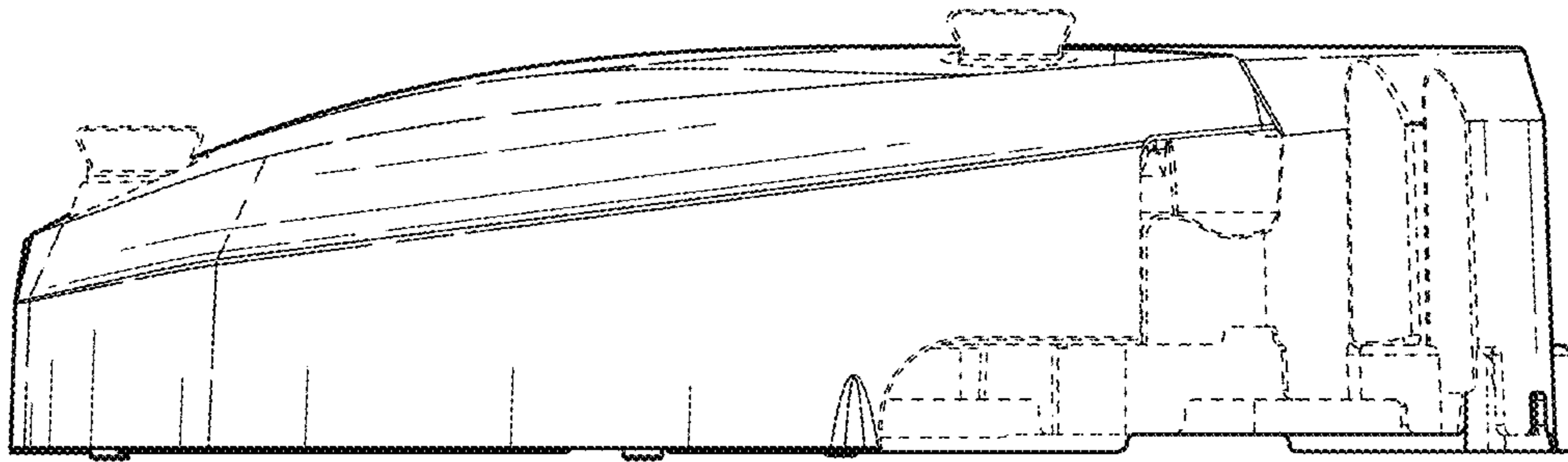

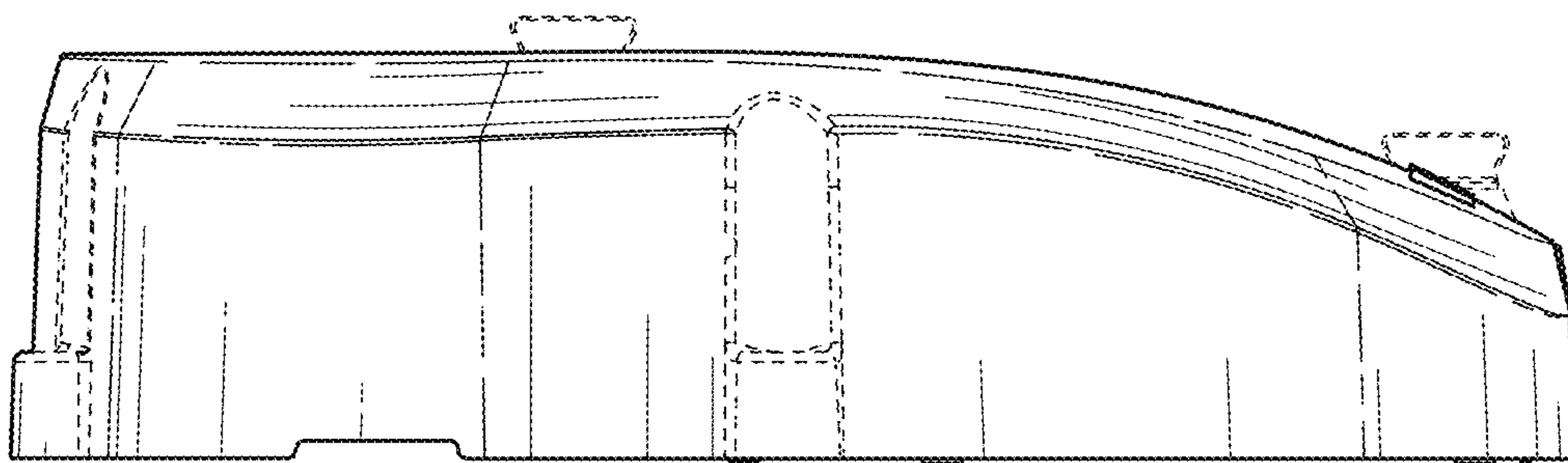

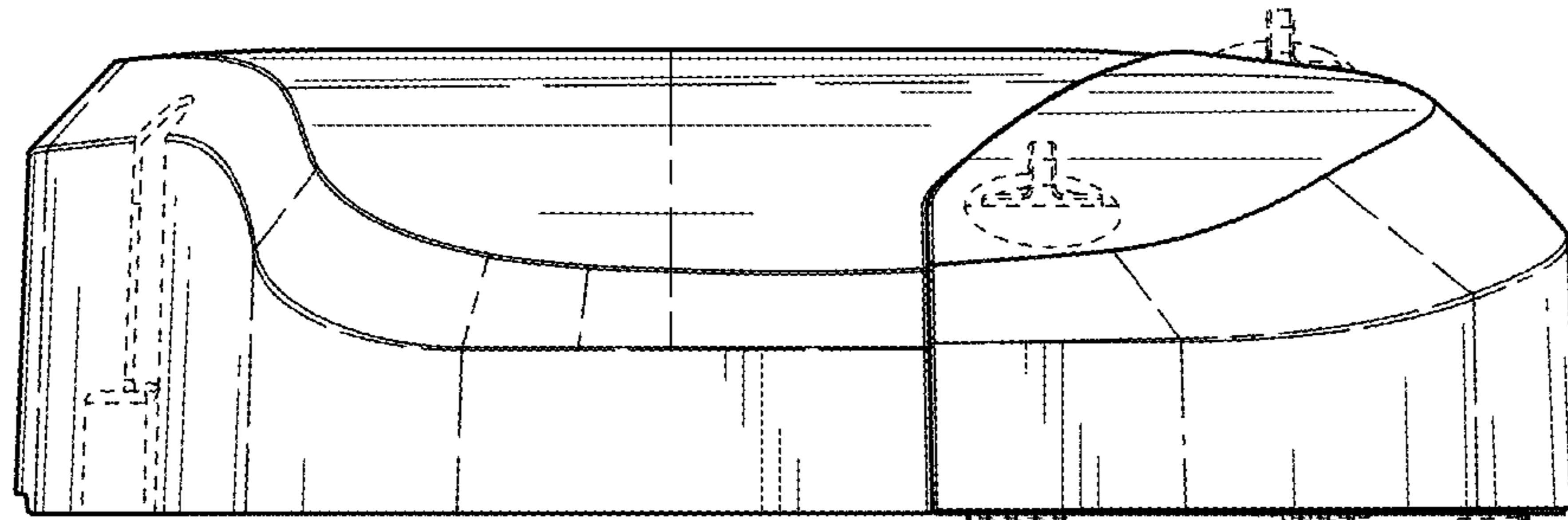

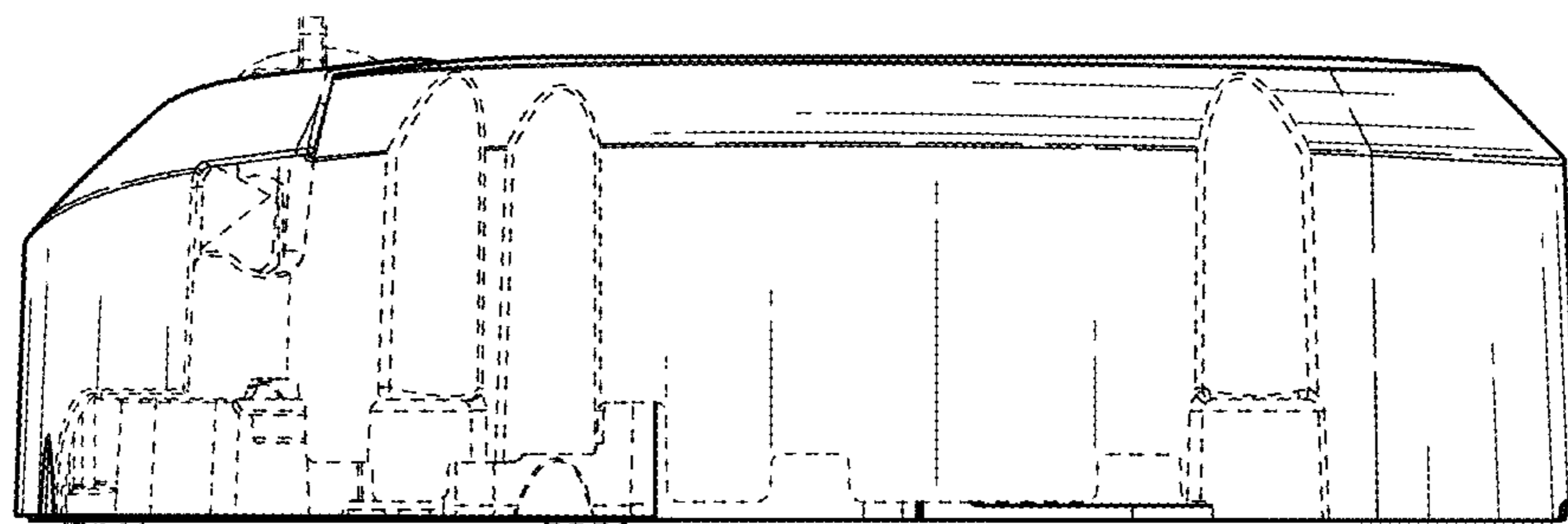

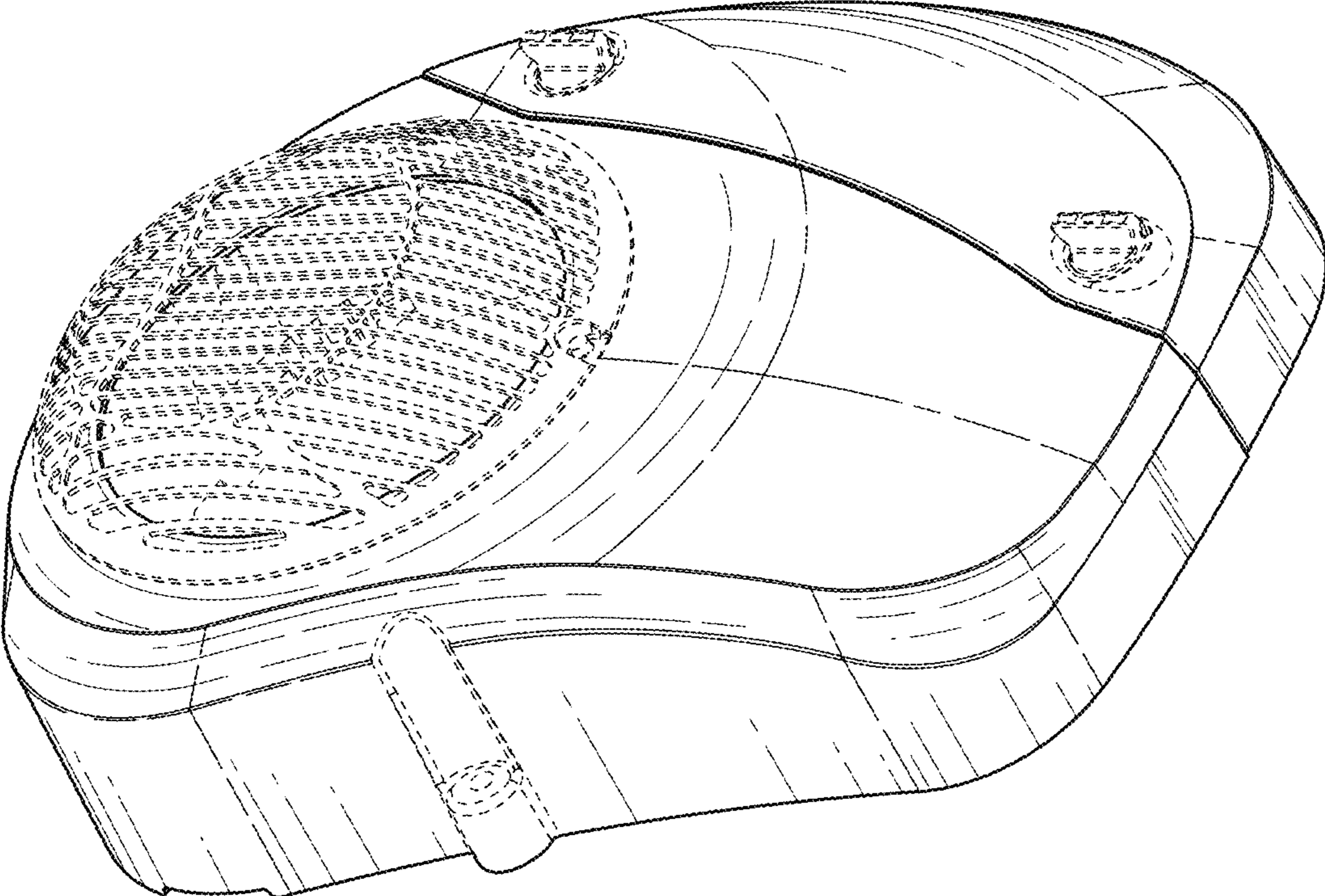

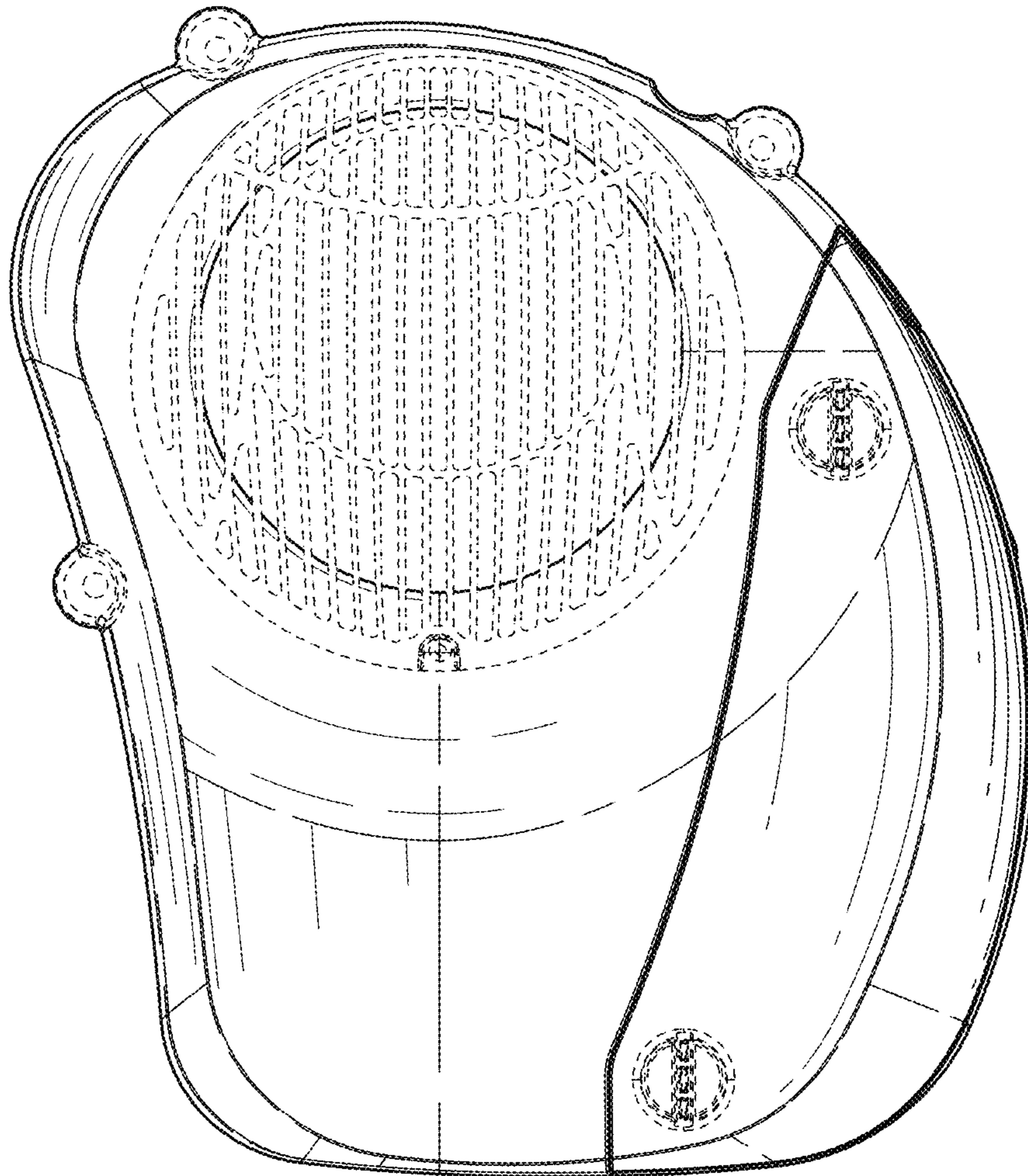

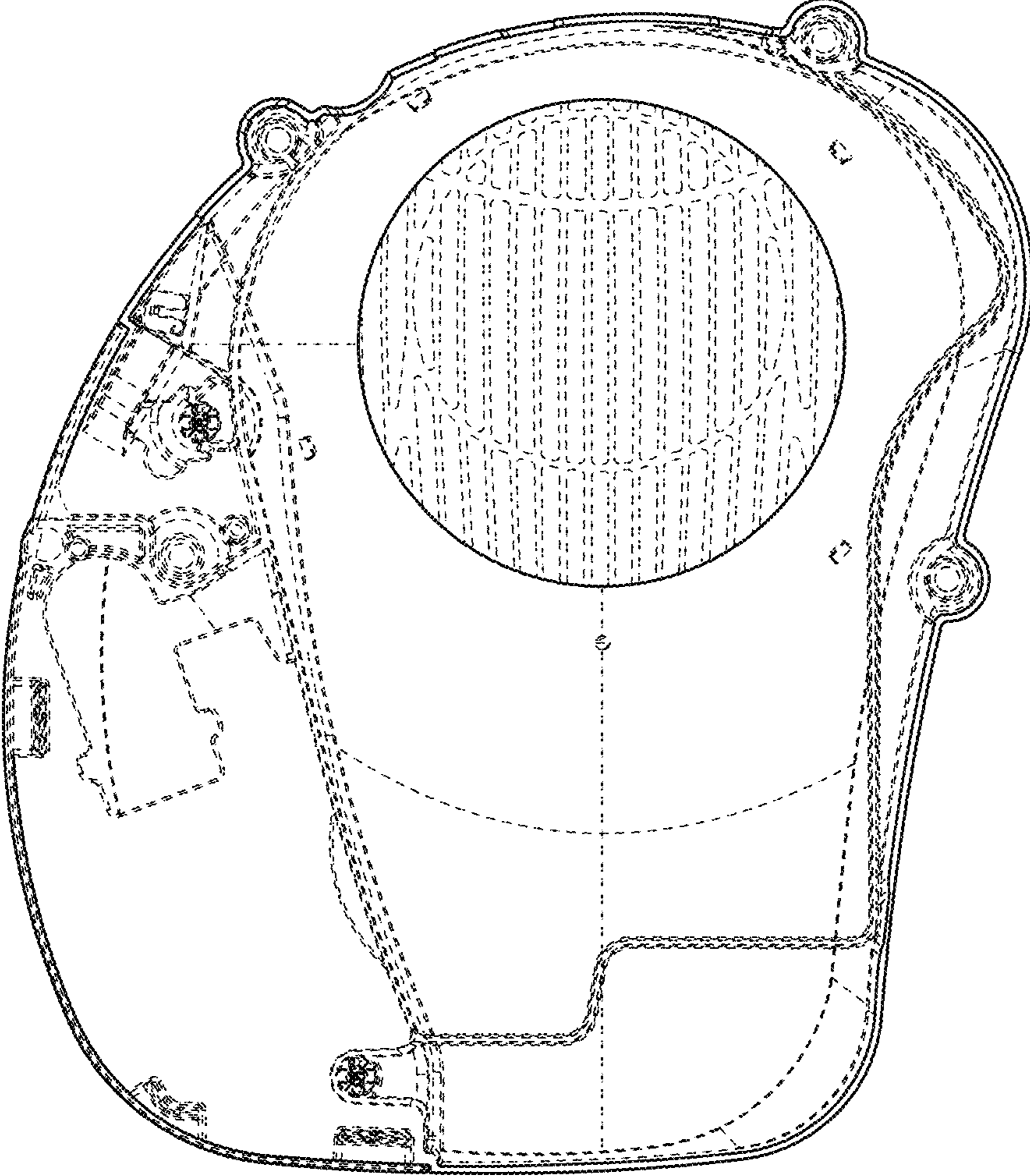

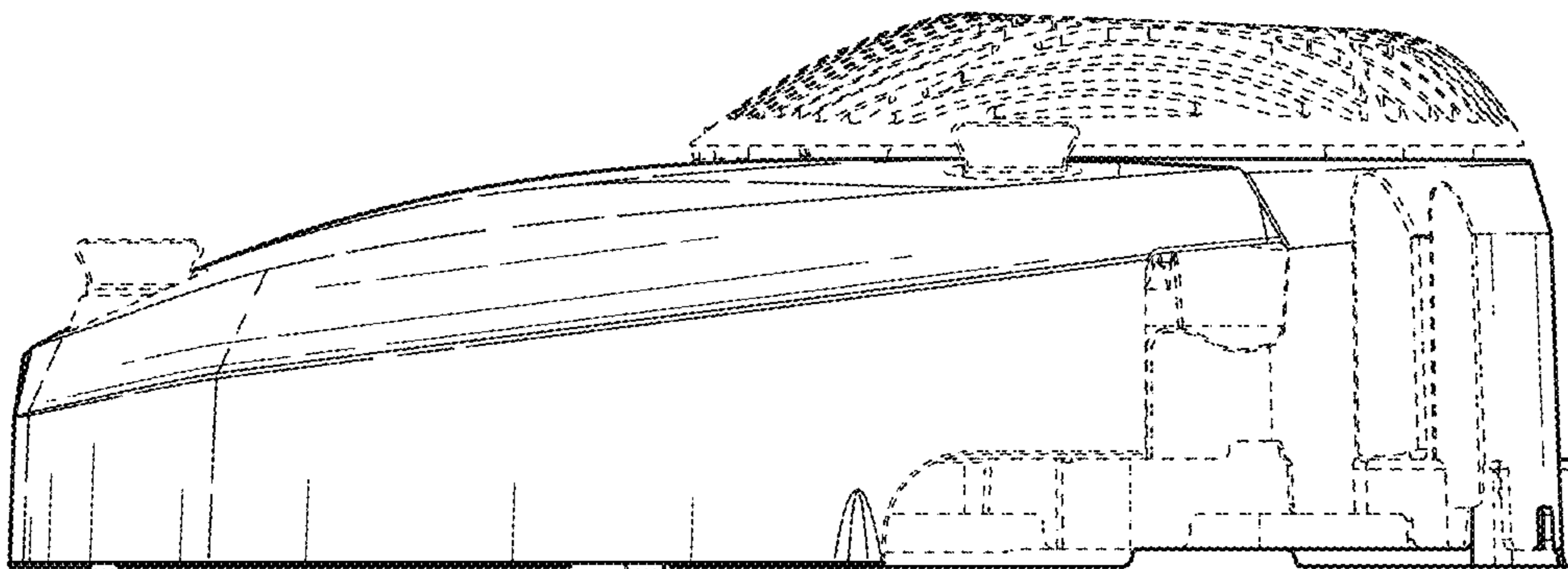

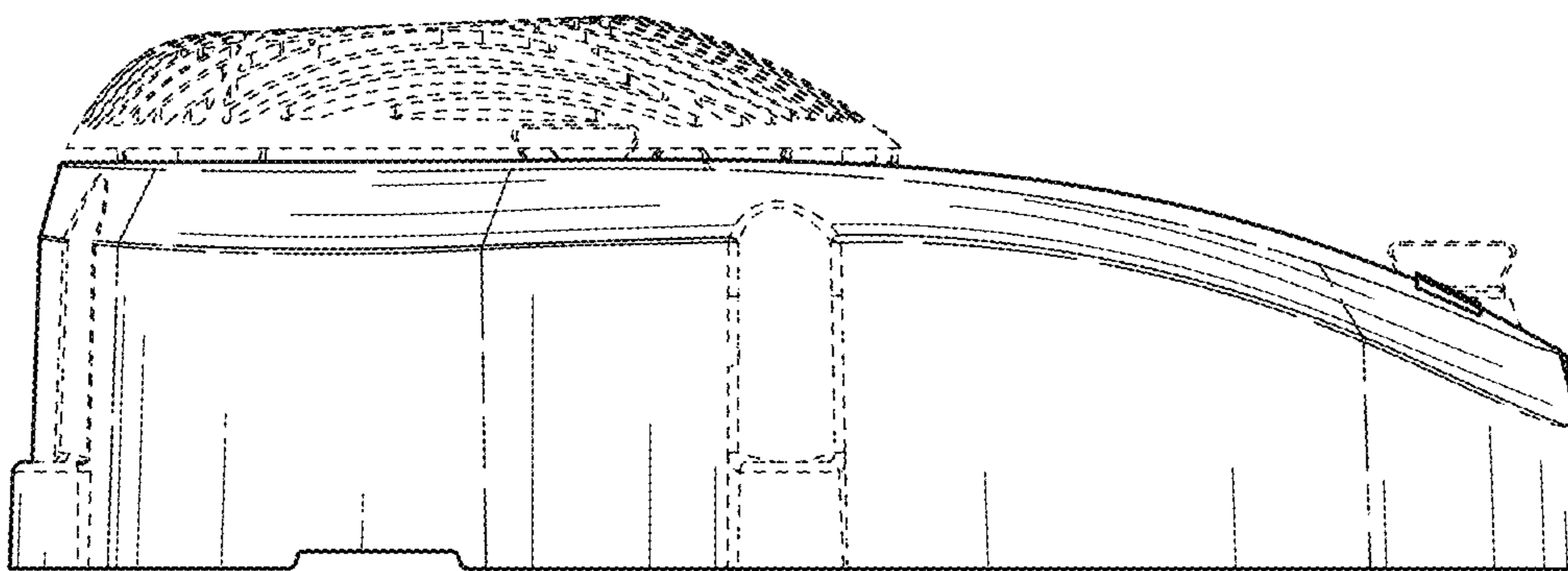

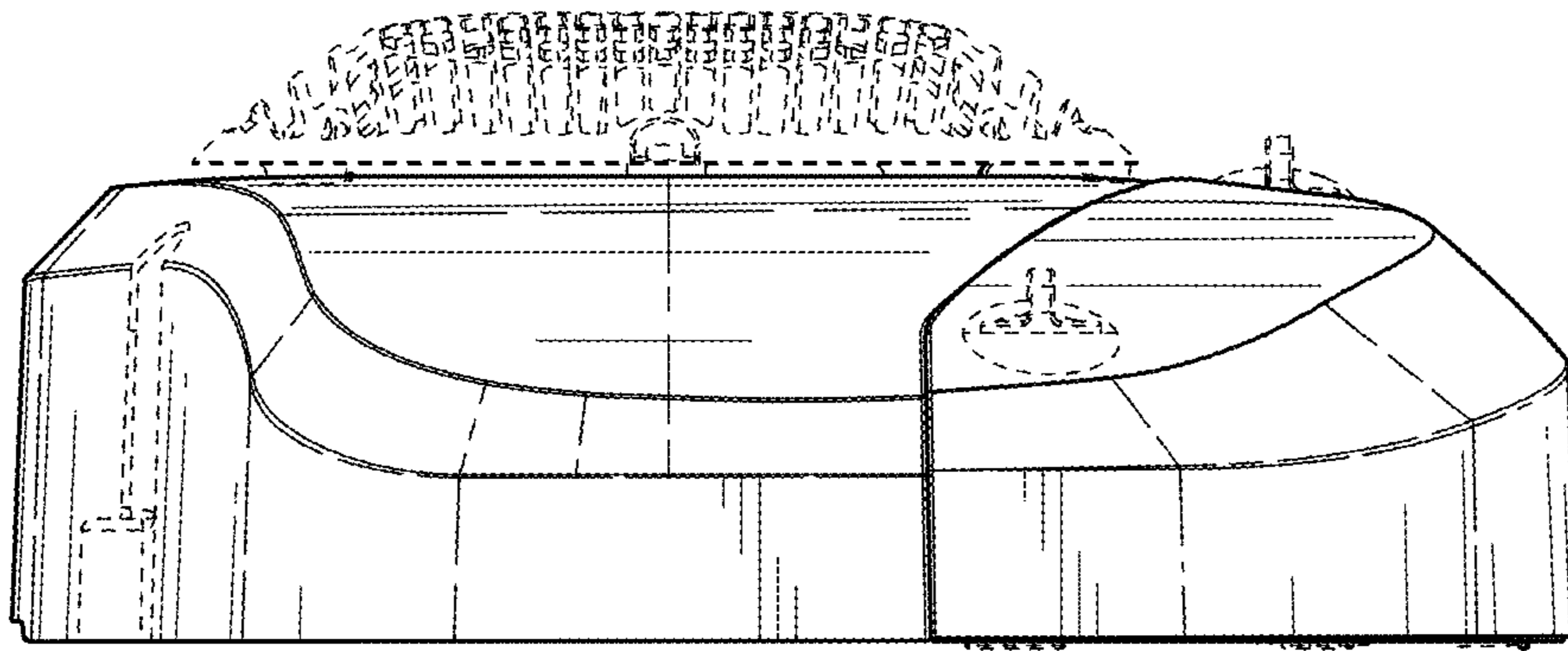

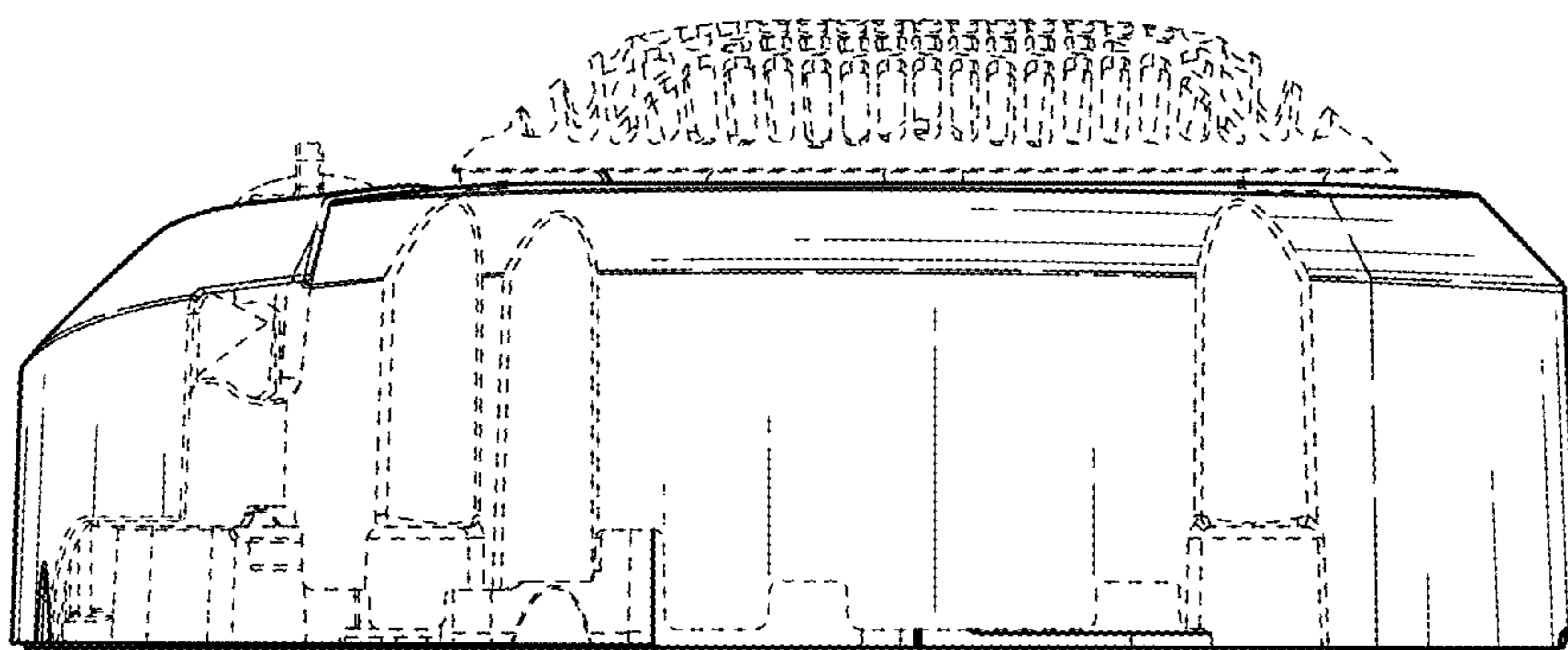
