FIG. 3 is a front elevational view of FIG. 1.

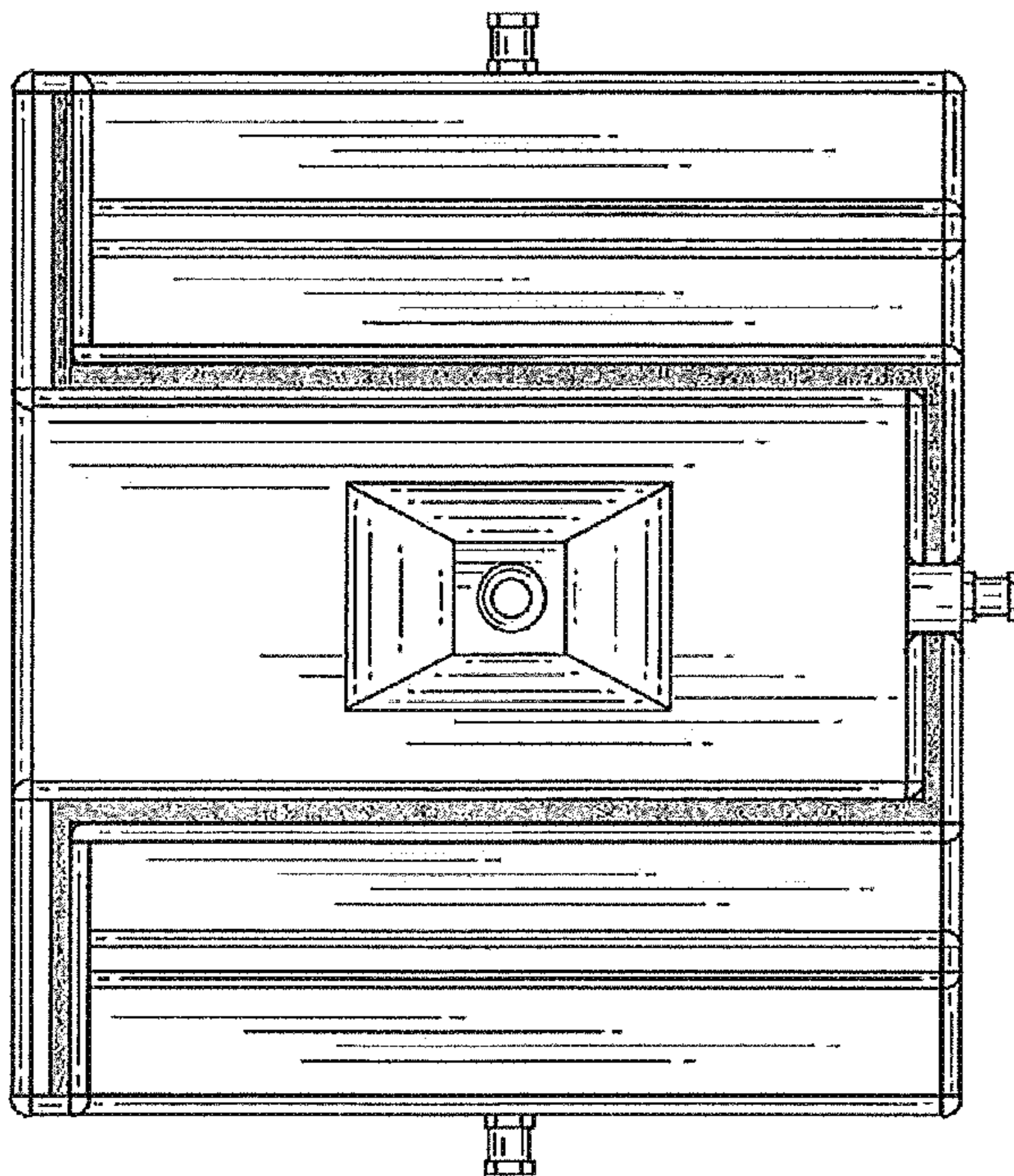
FIG. 4 is a rear elevational view of FIG. 1.

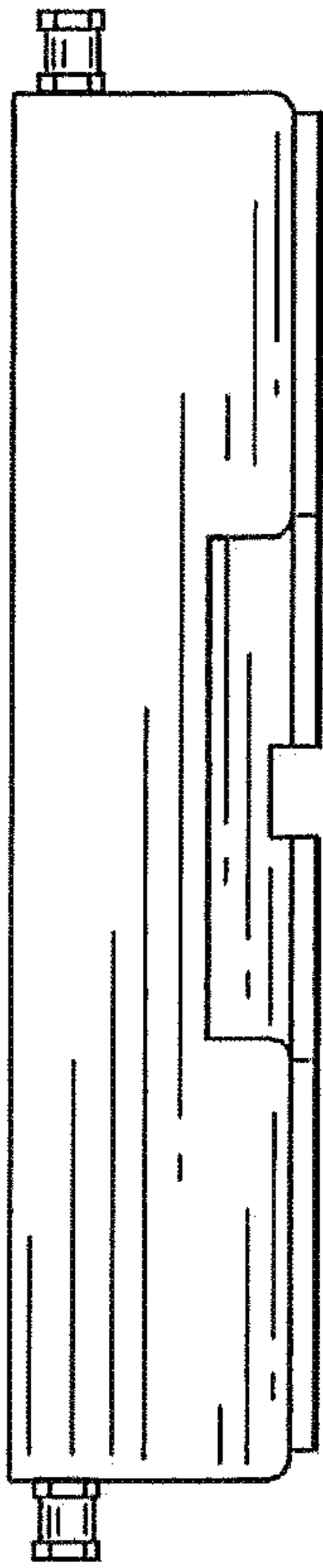

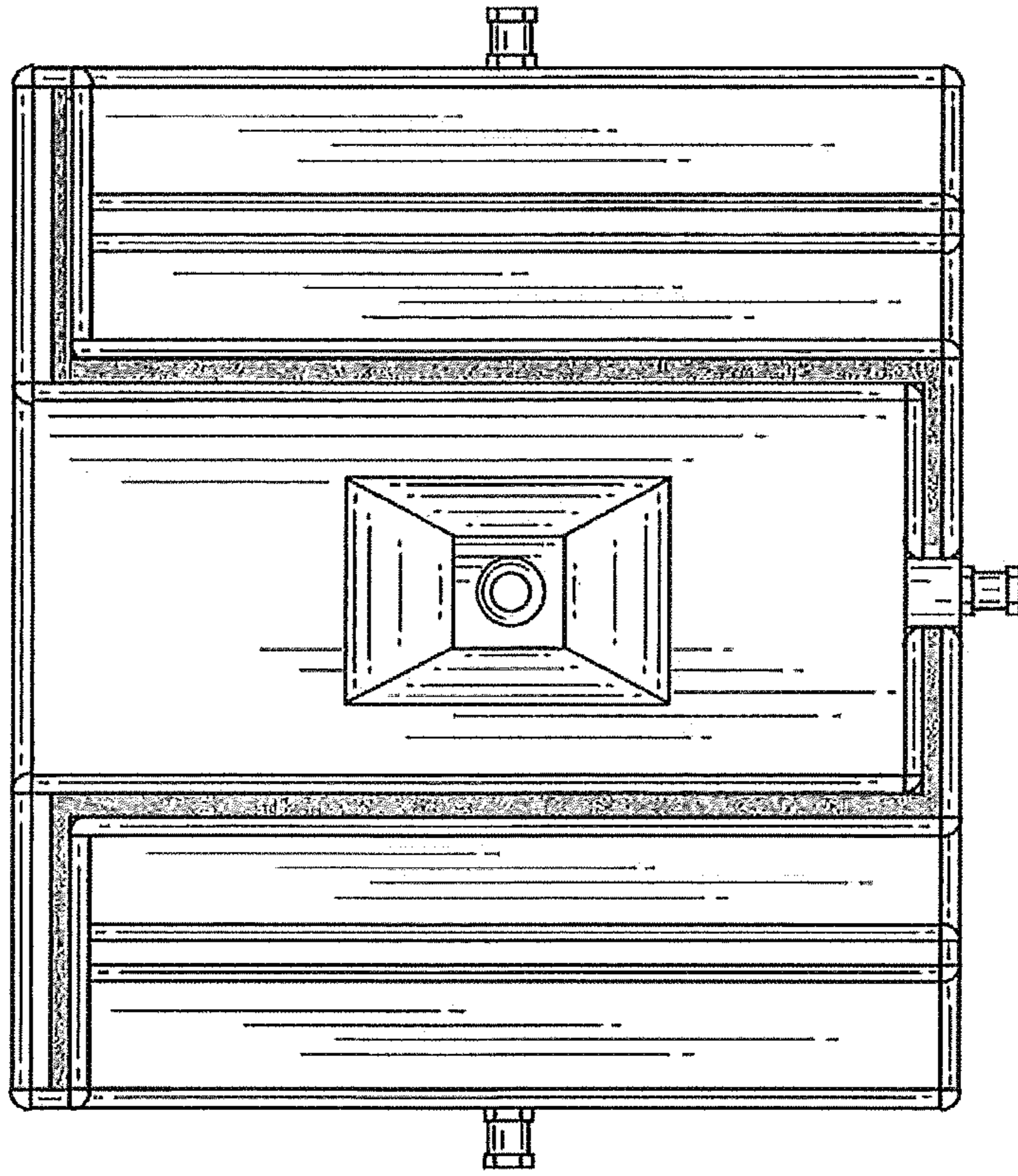

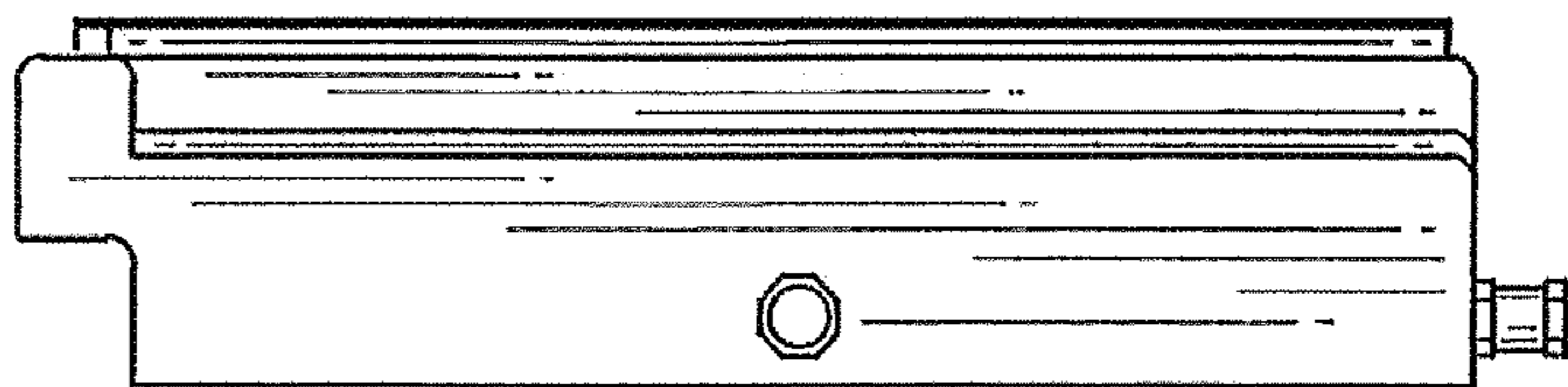

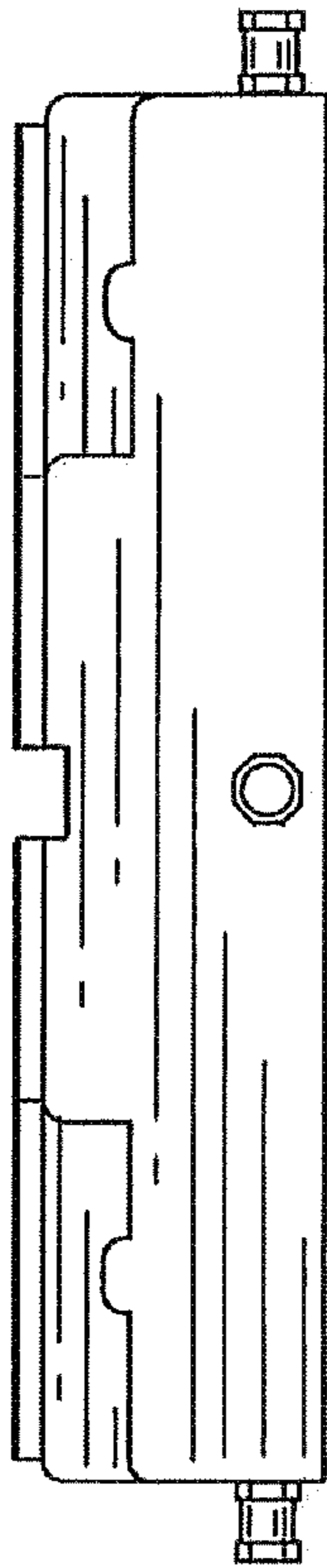

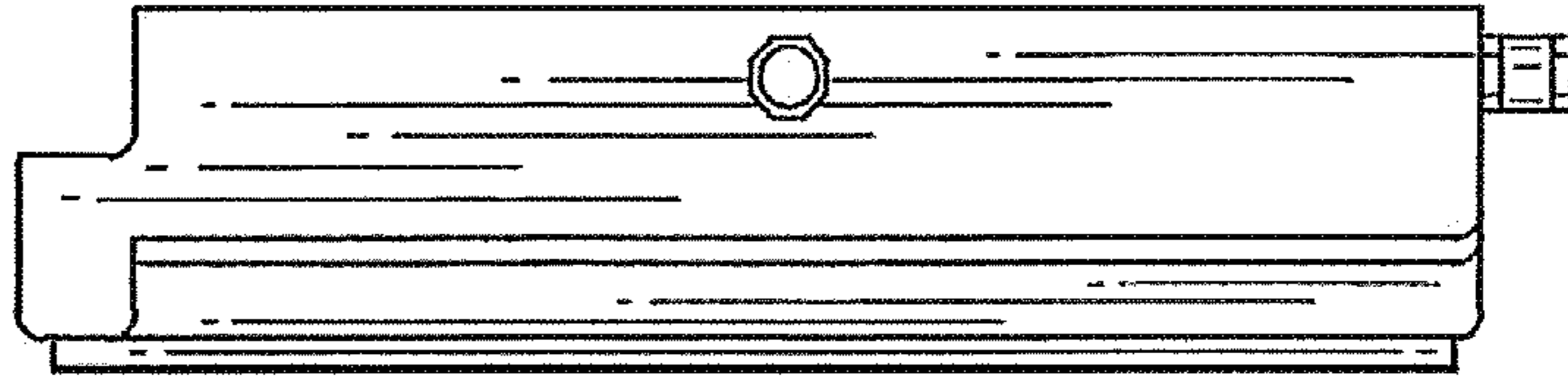

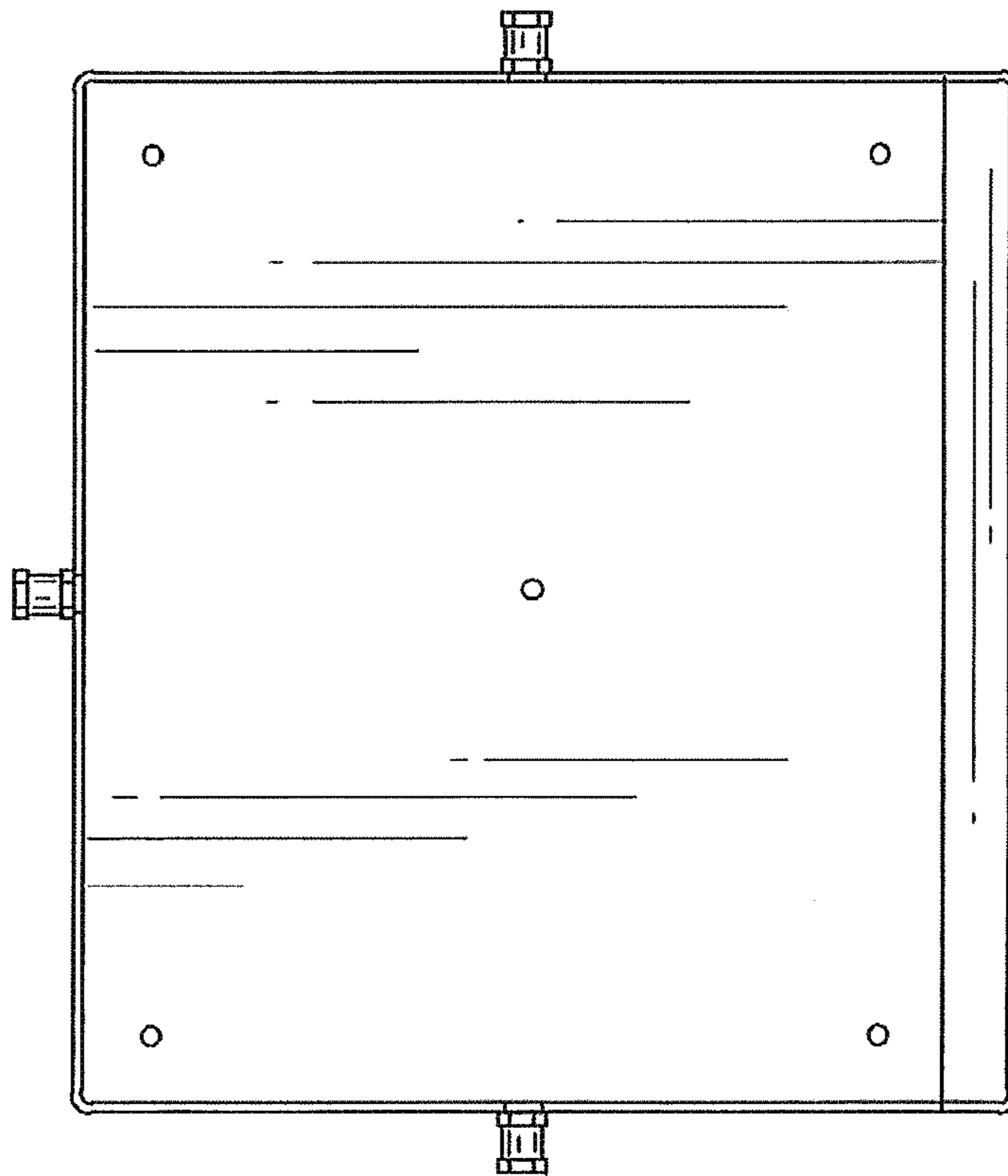
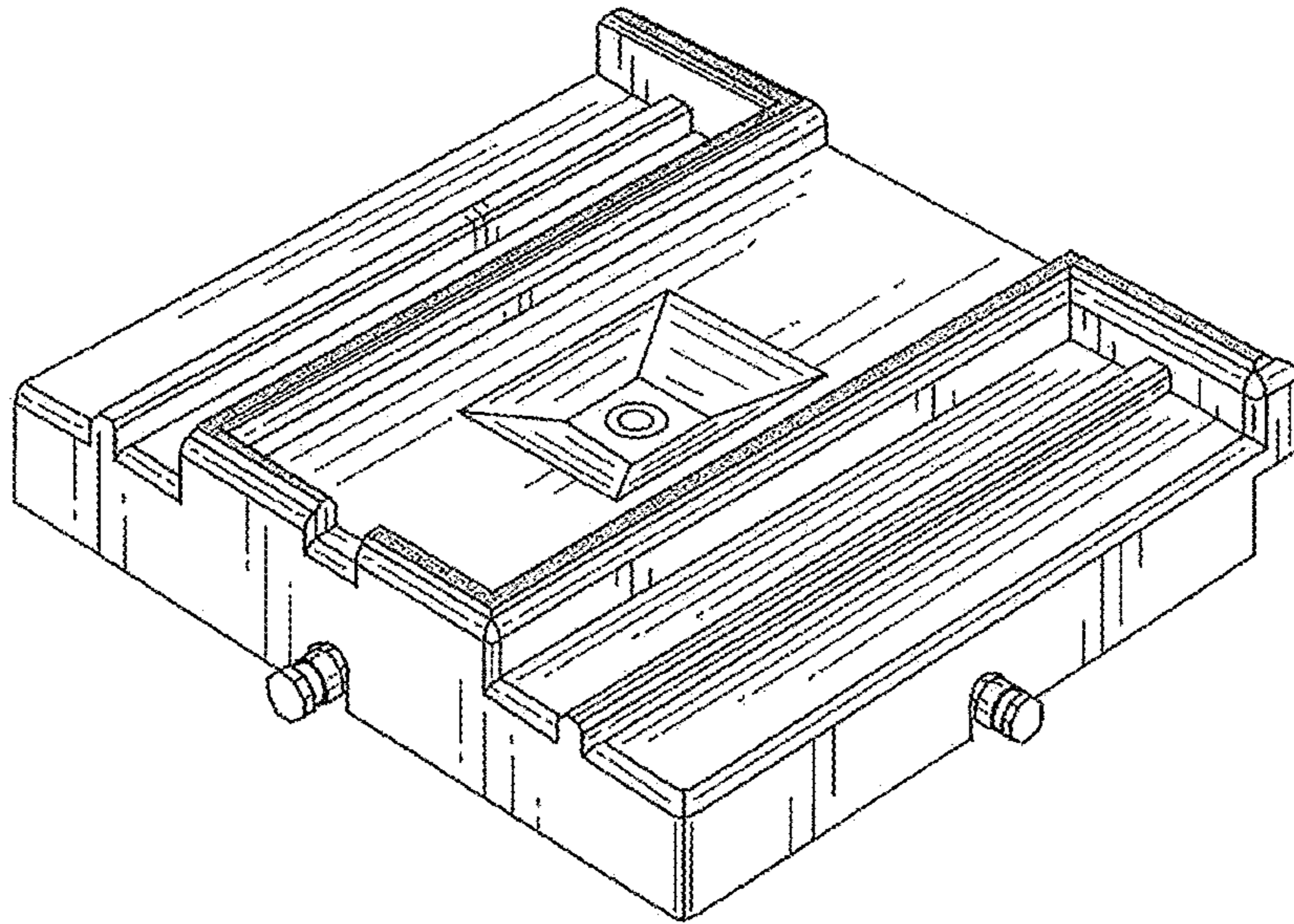
