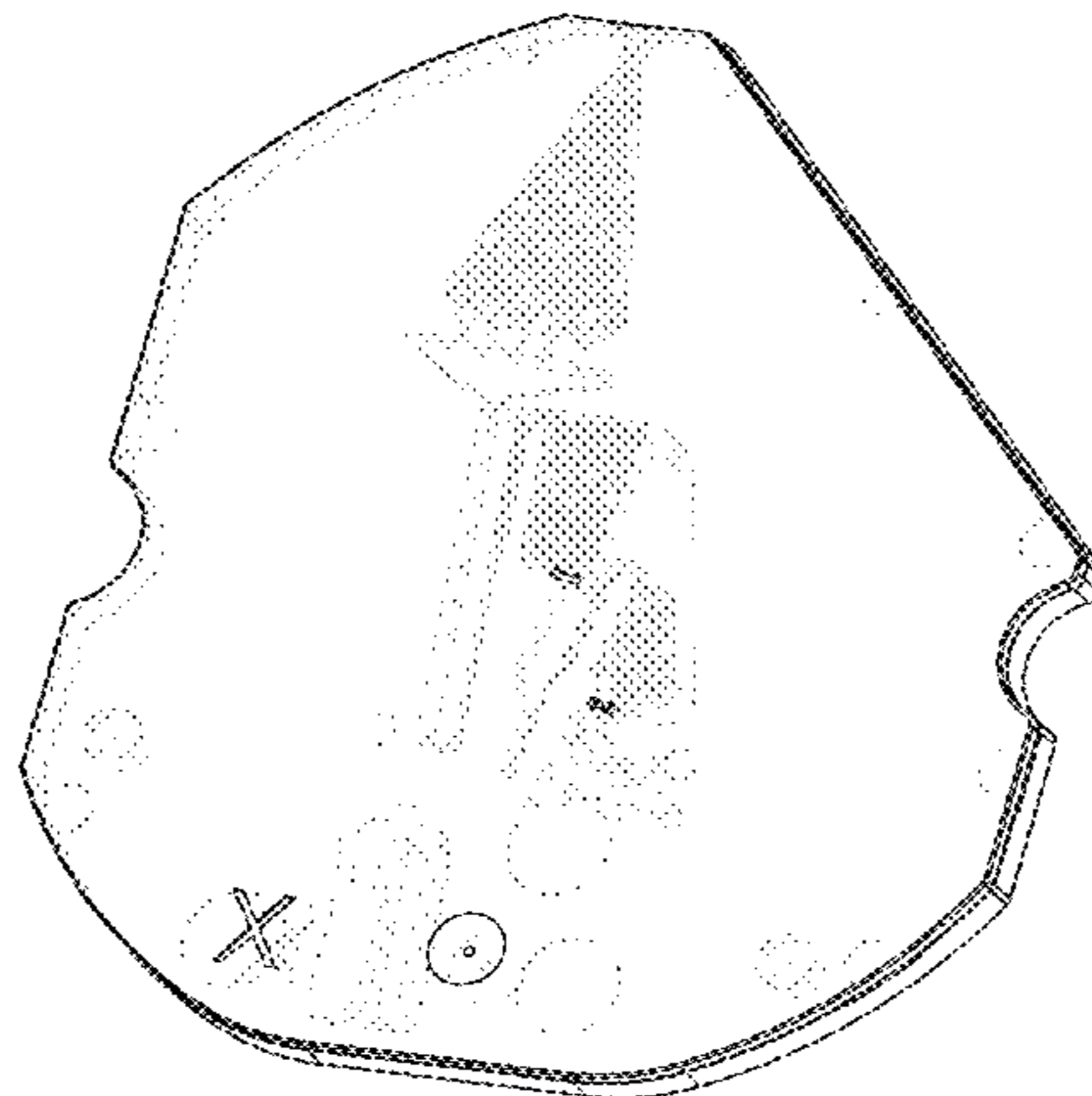
The ornamental design for a sampling device, as shown and described.

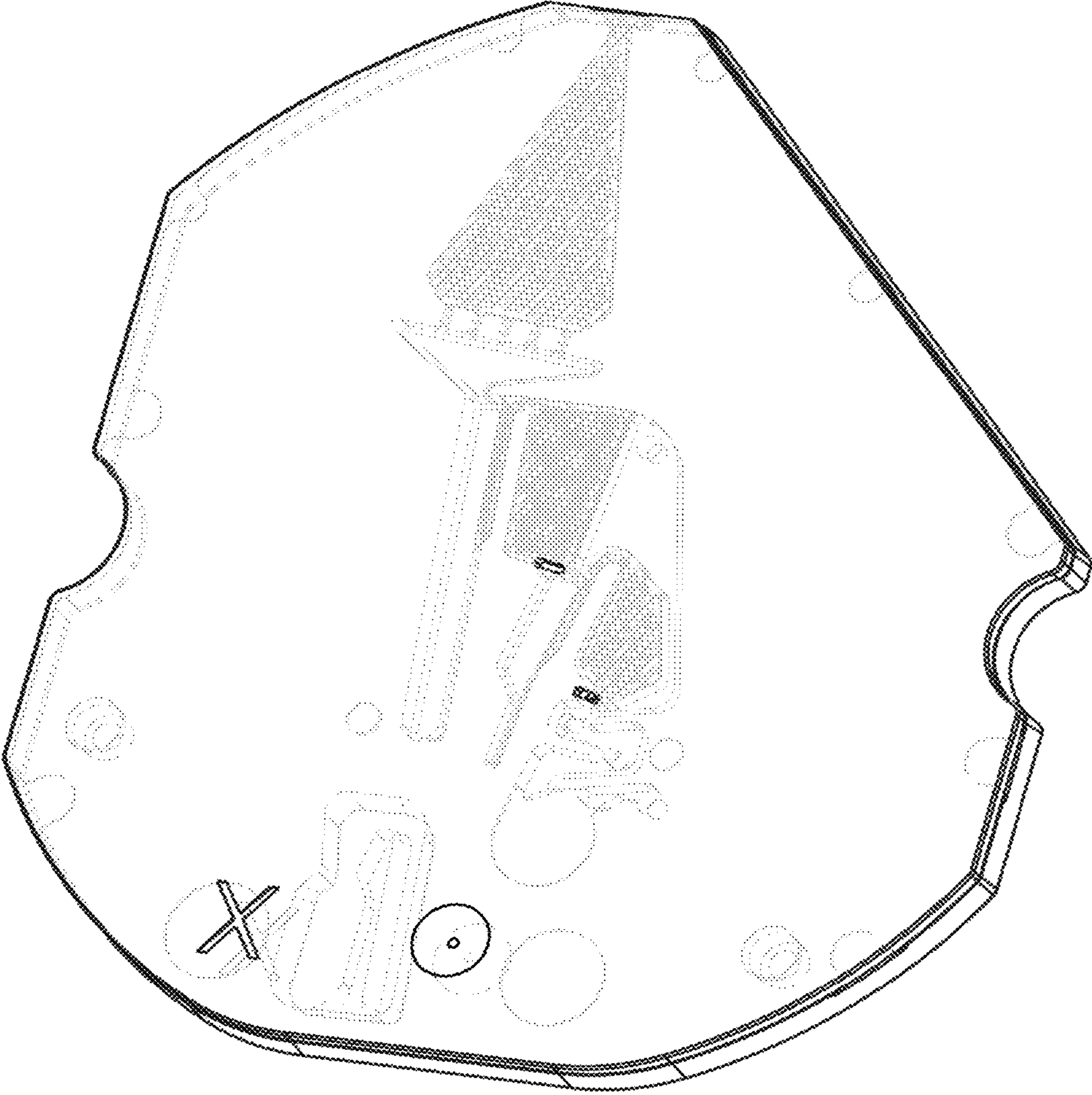

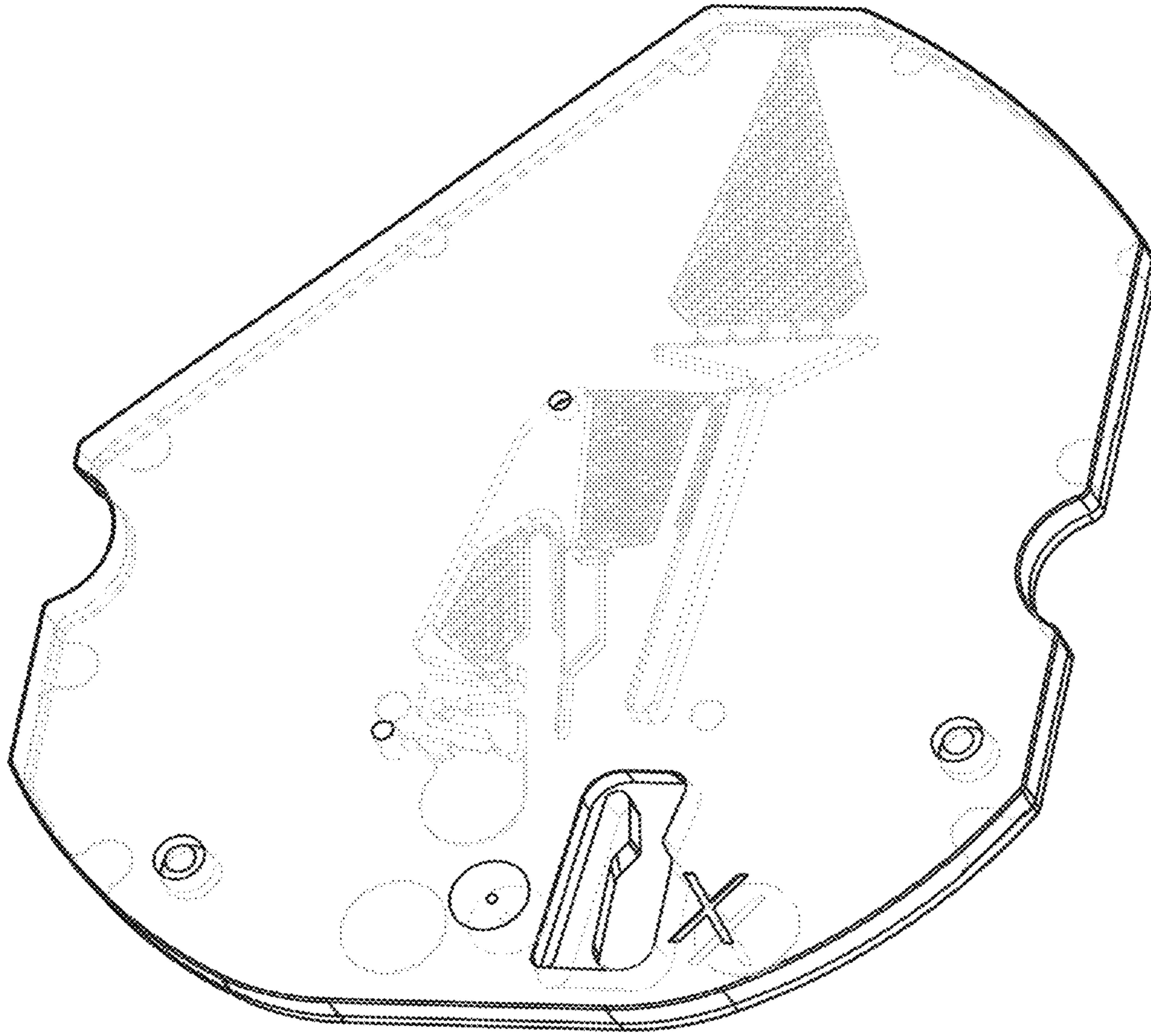

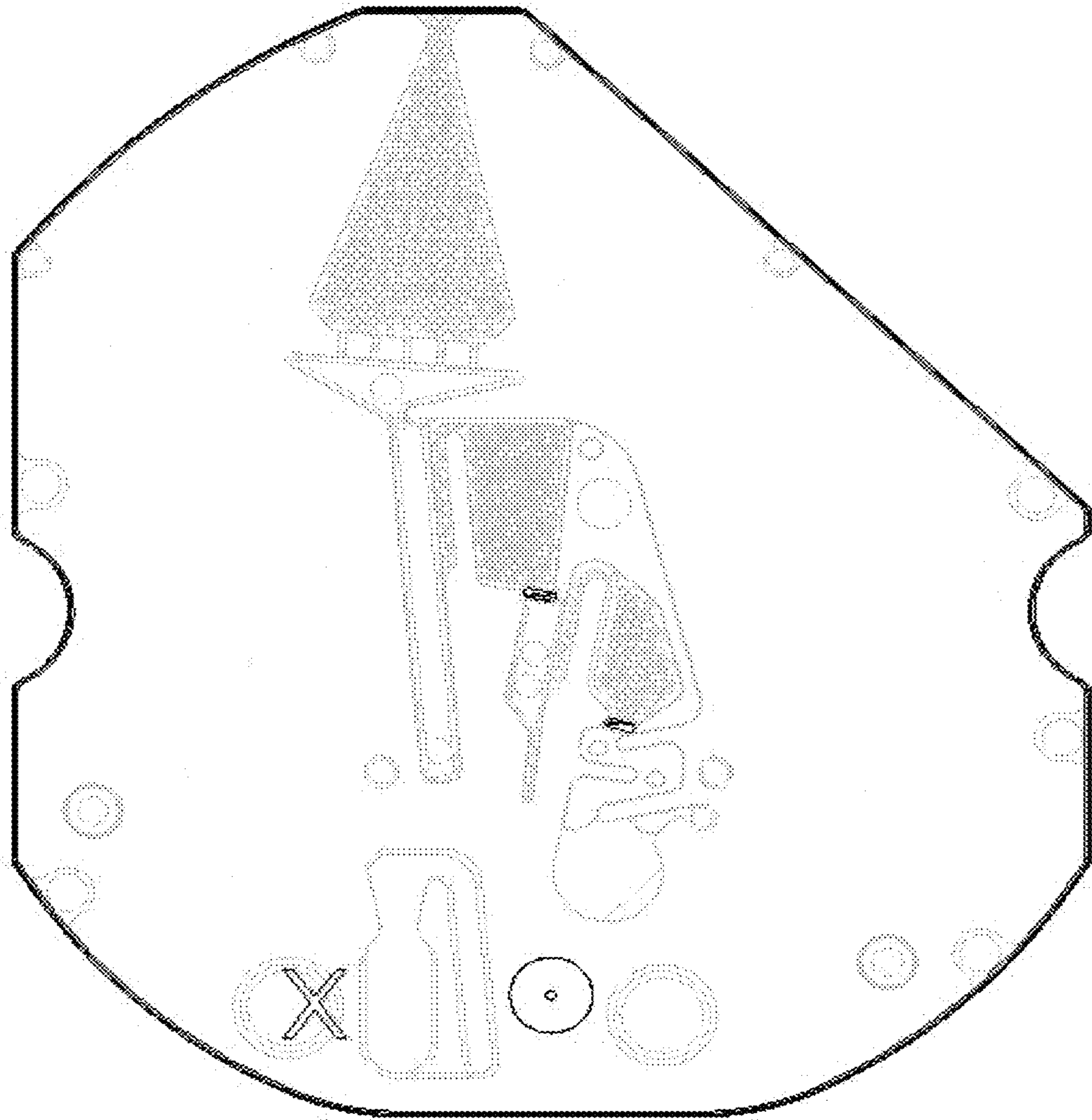

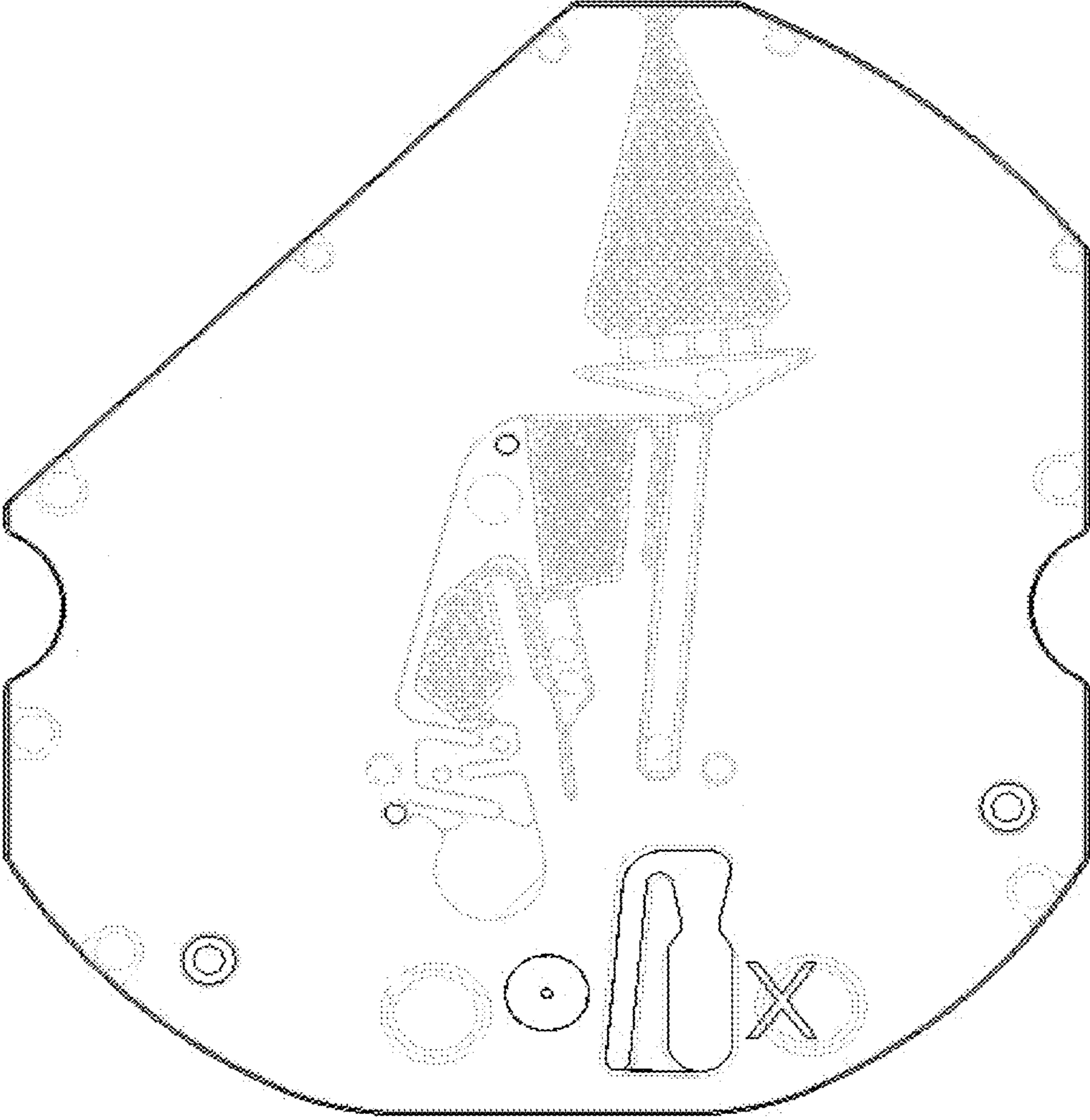

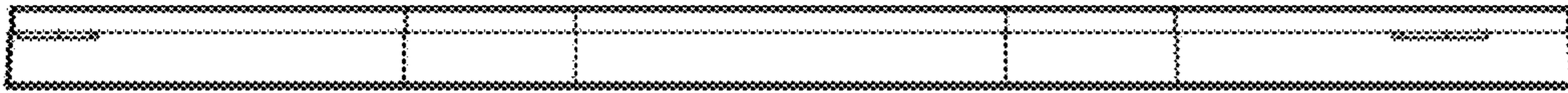

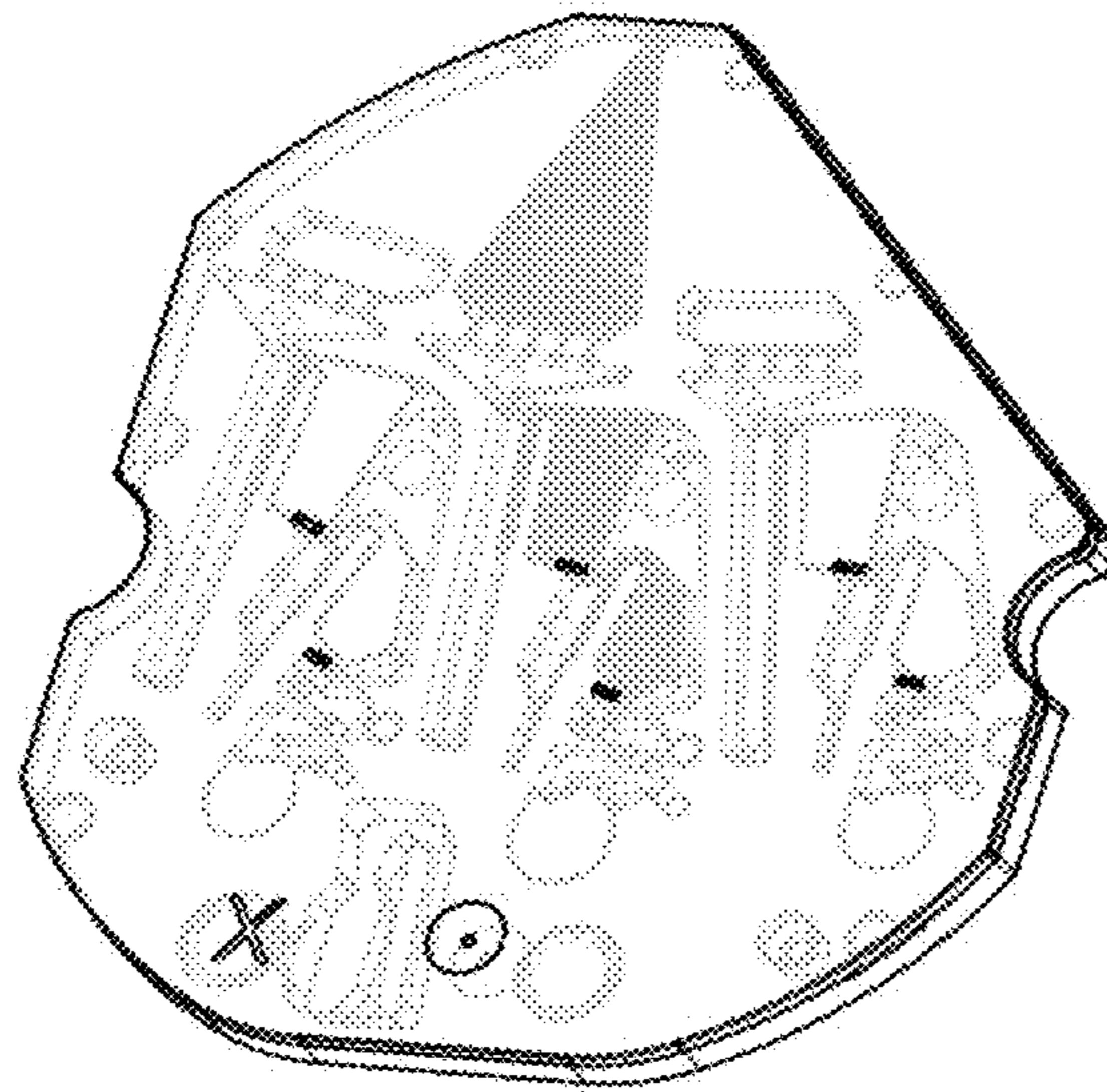

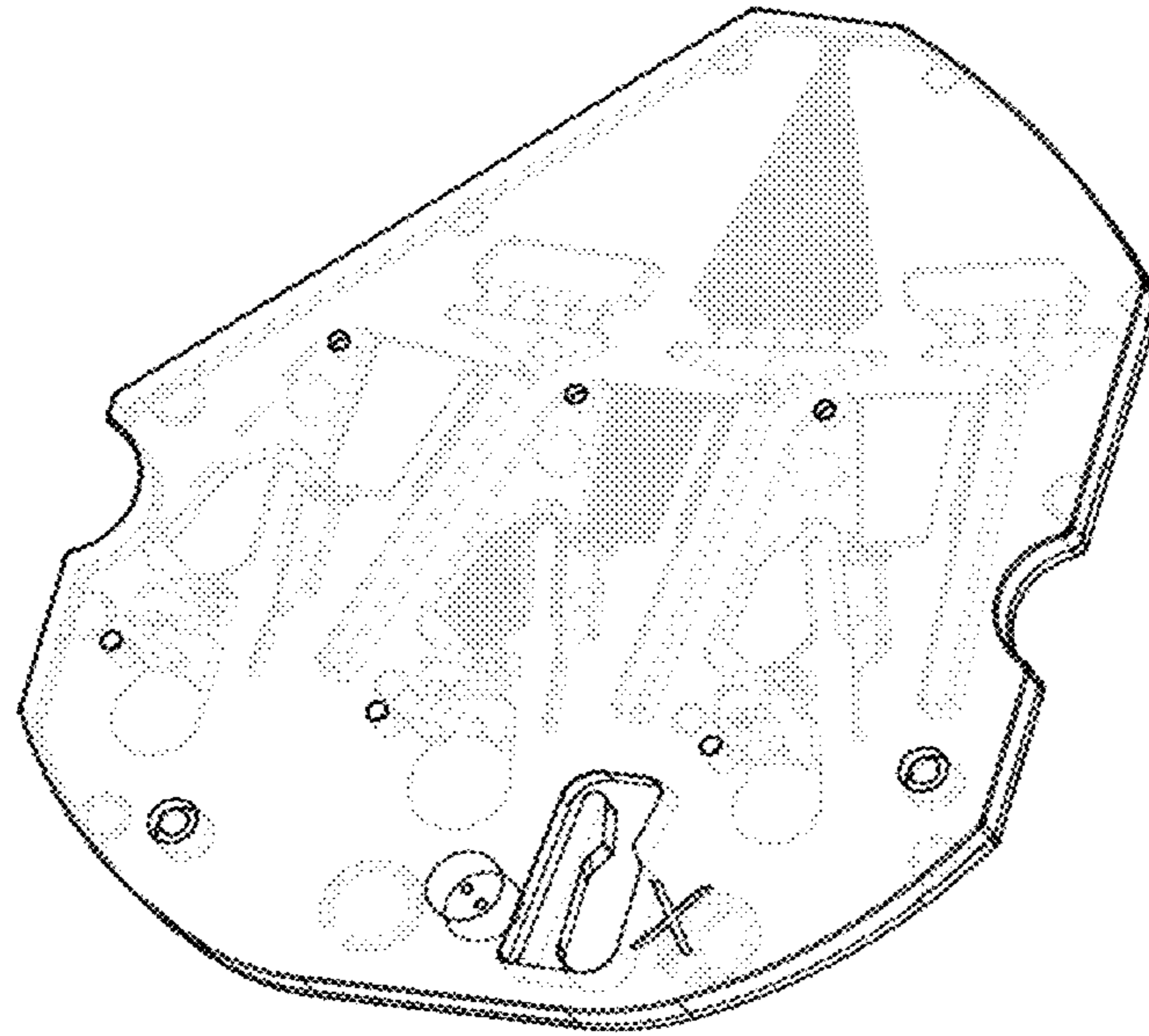

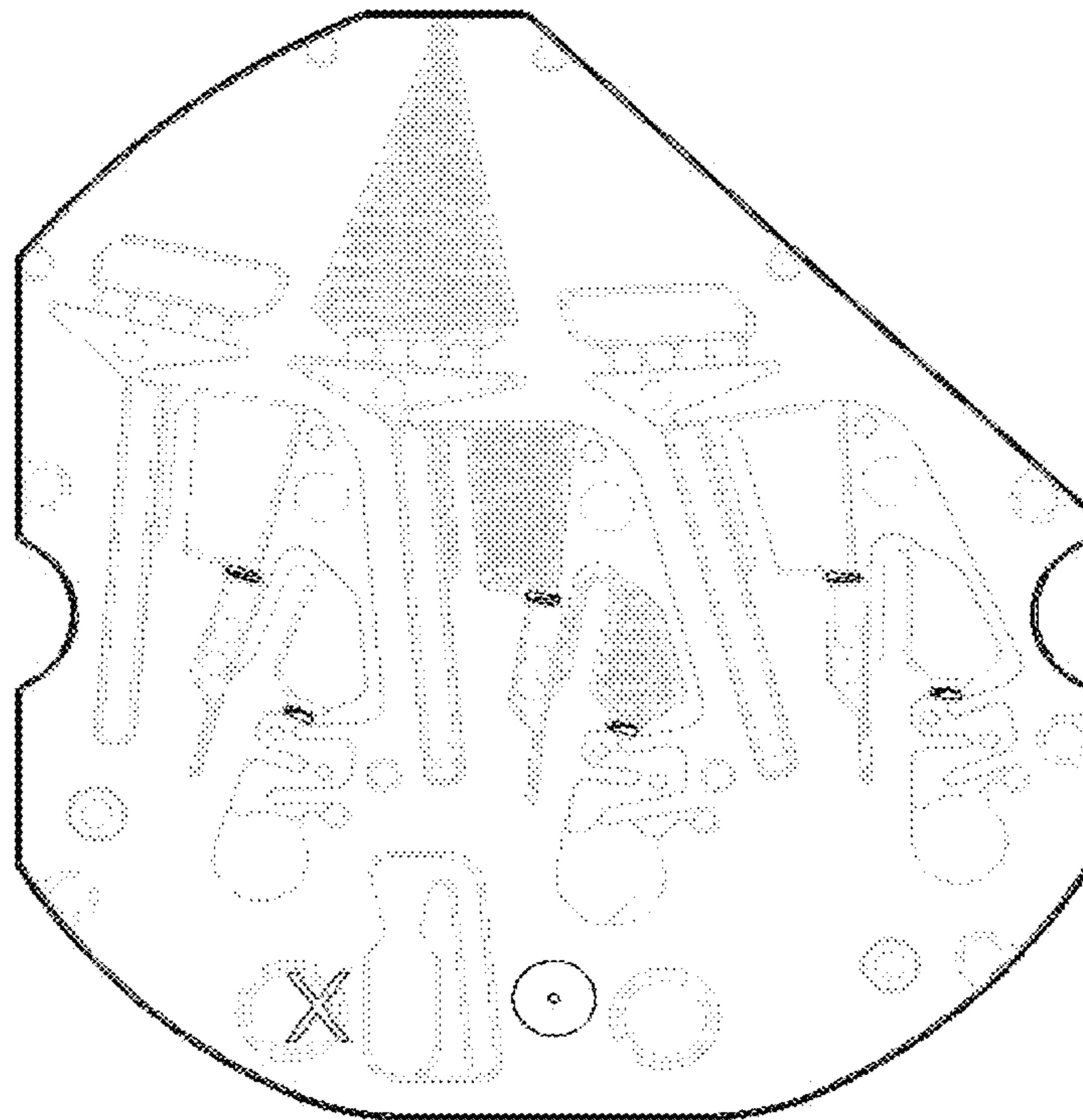

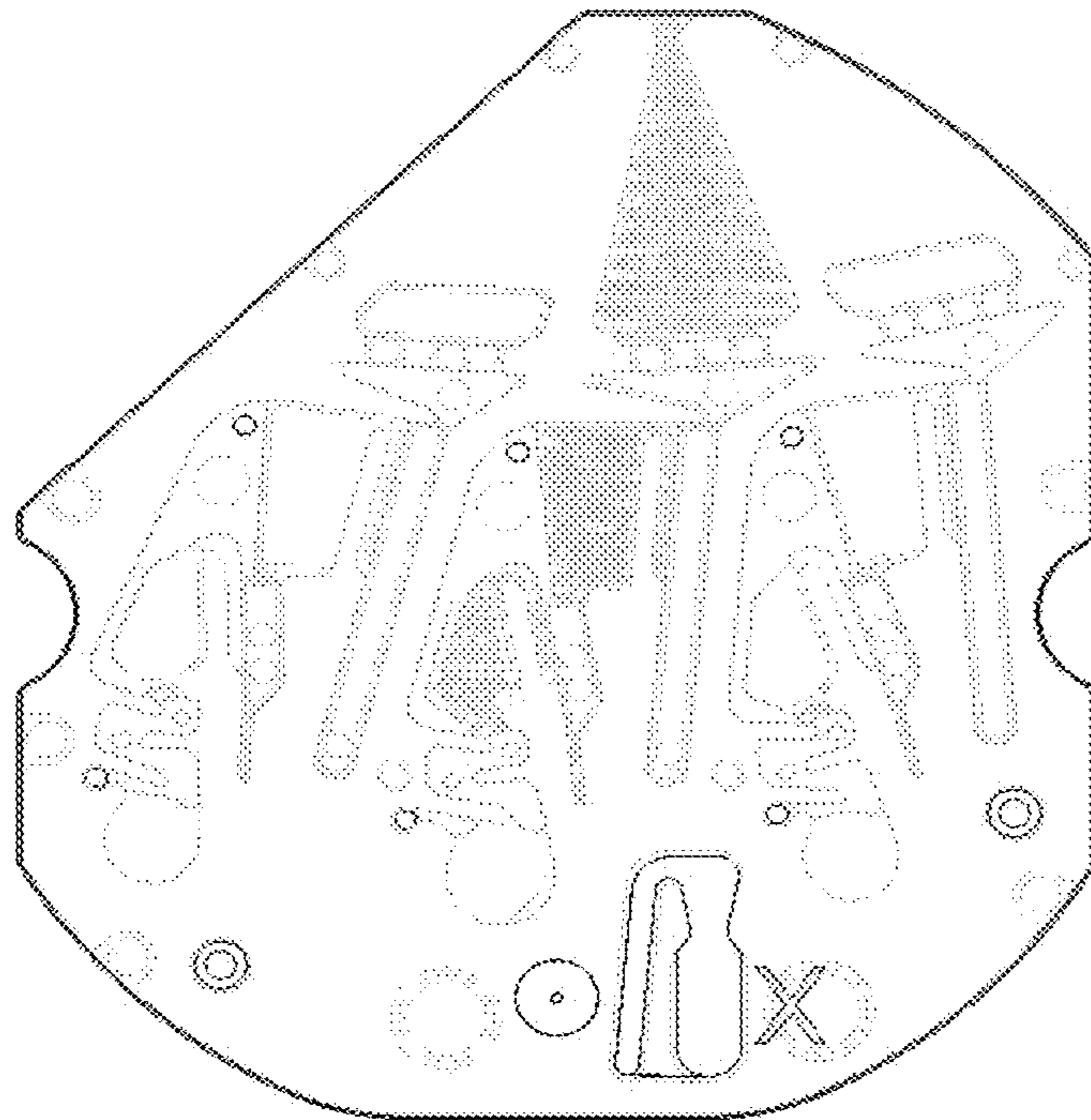

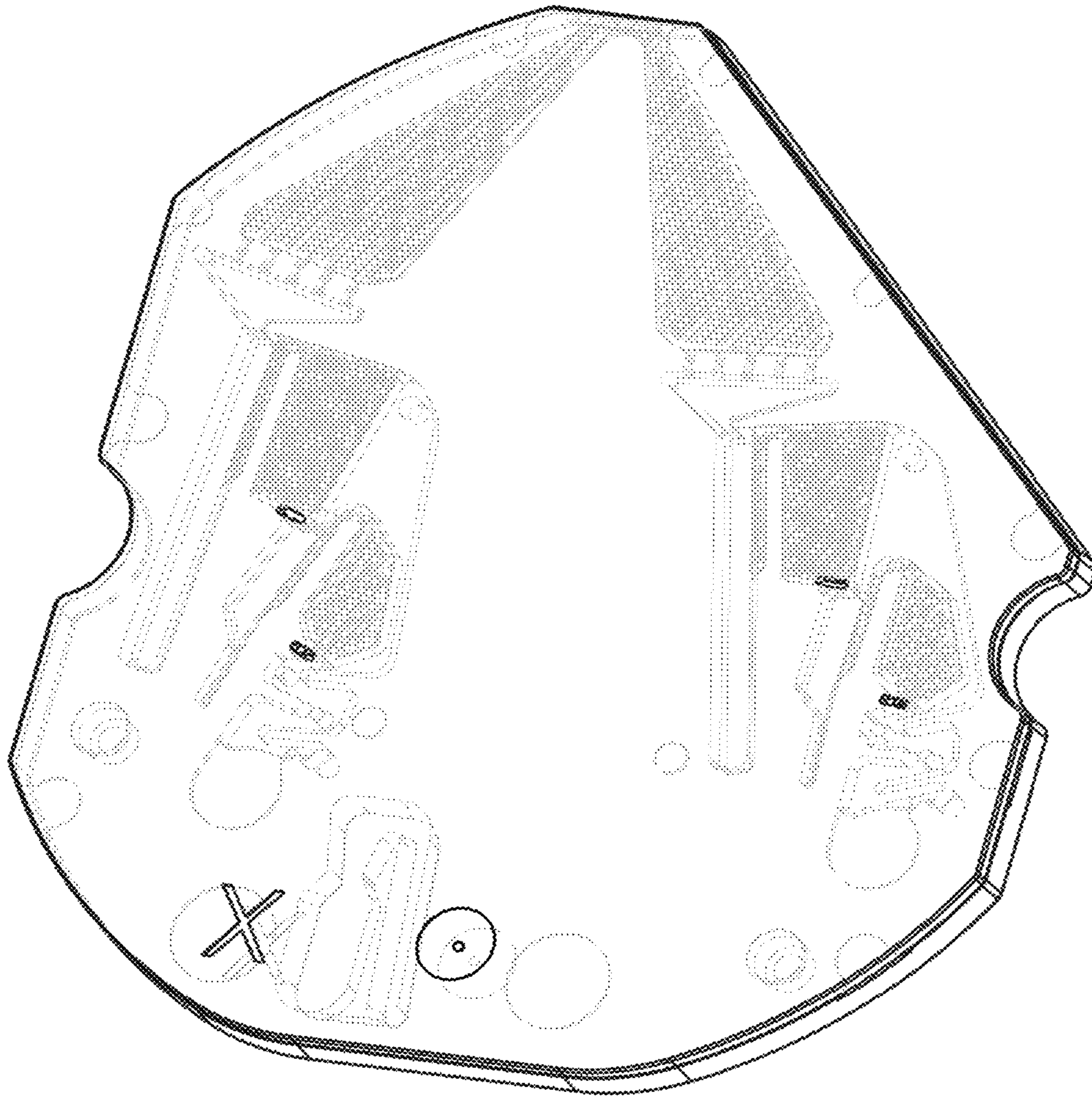

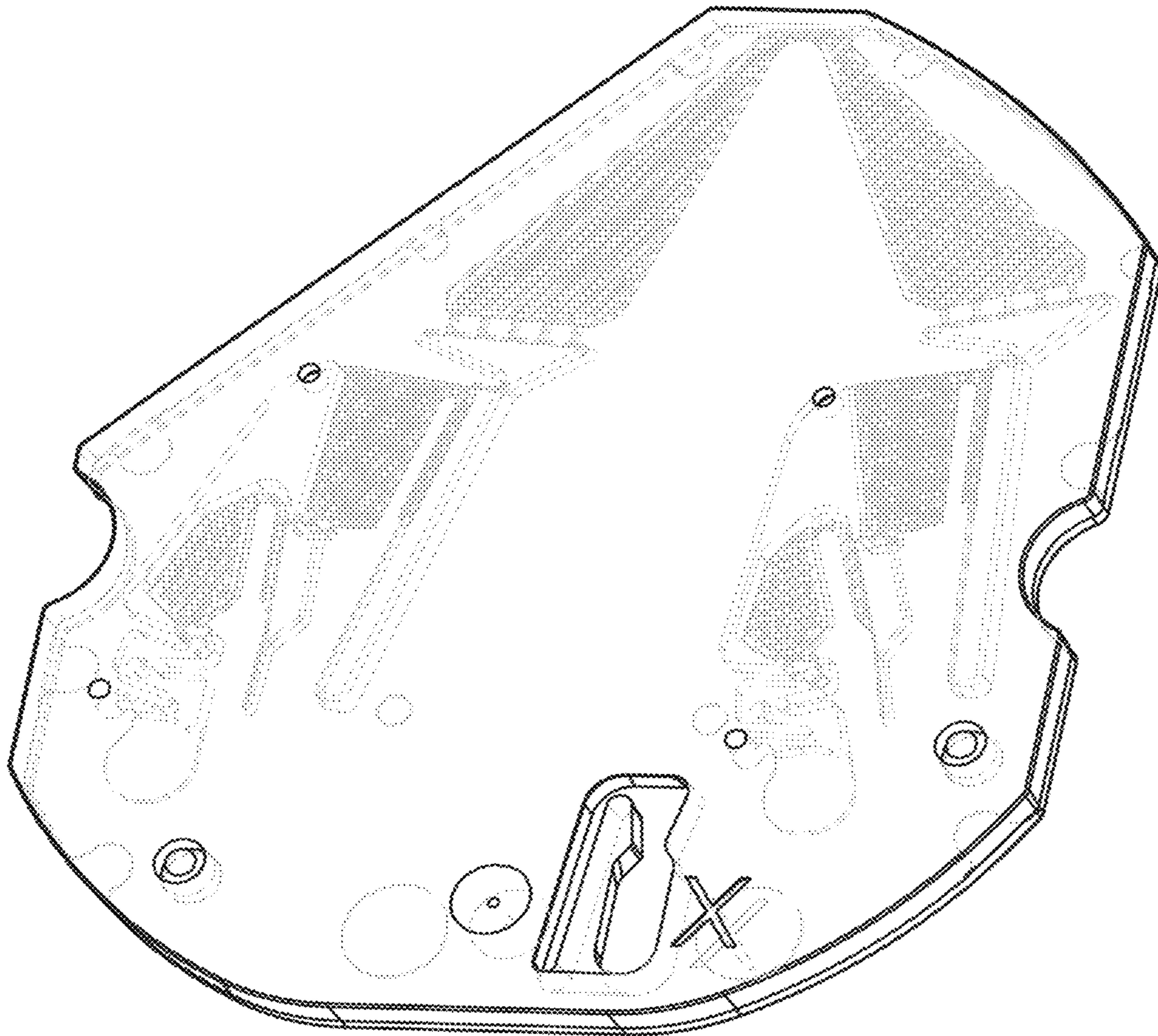

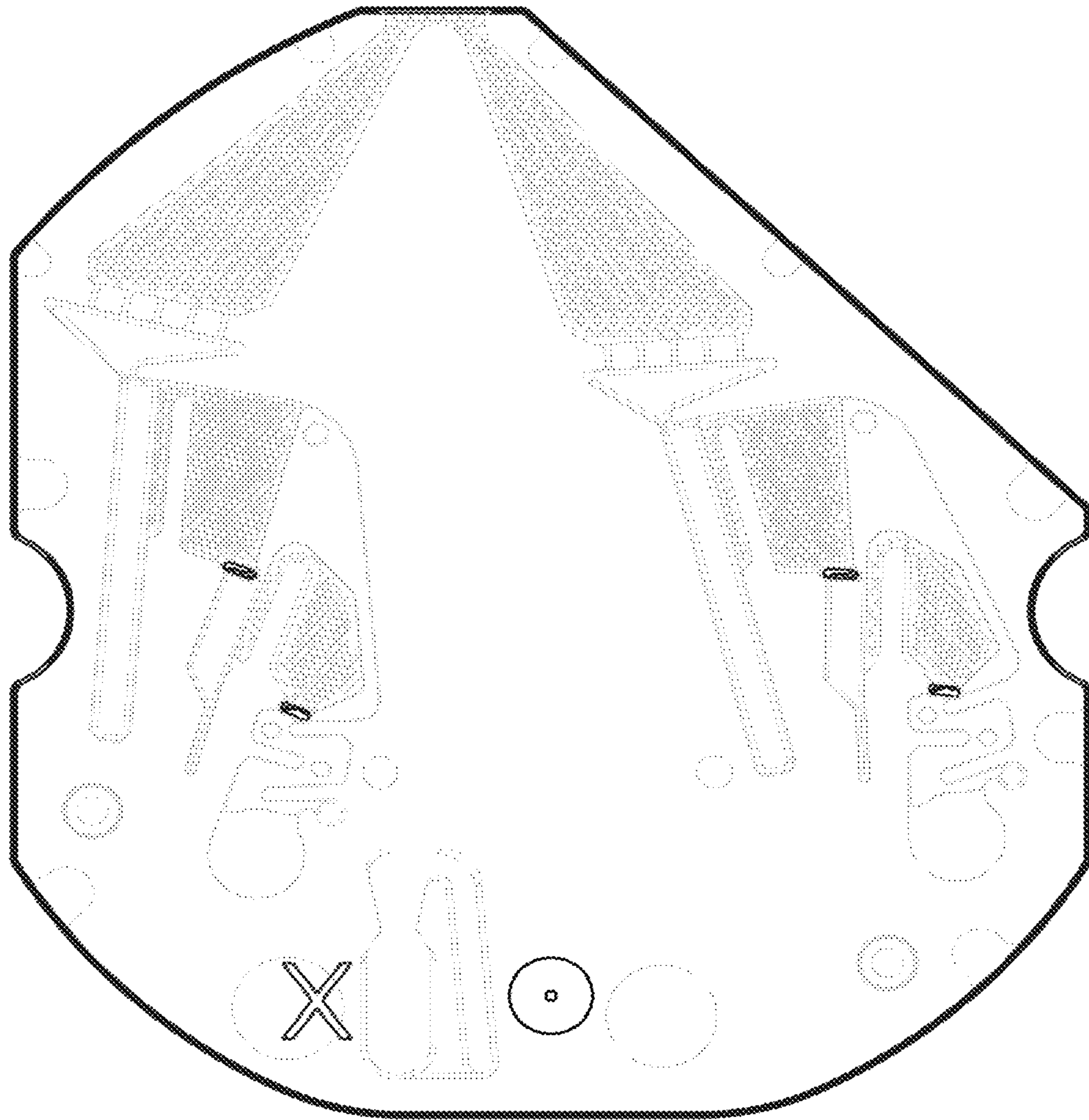

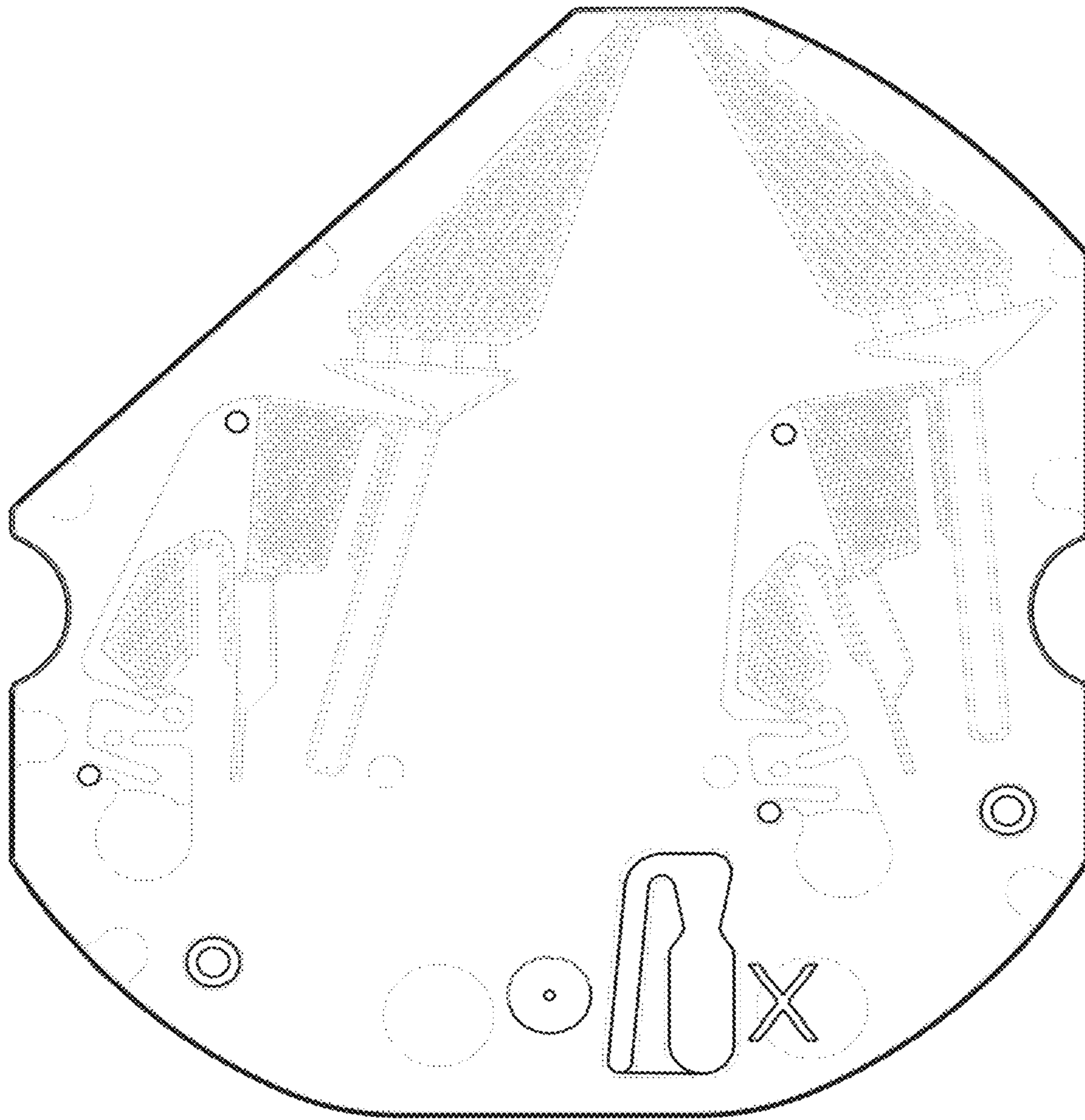

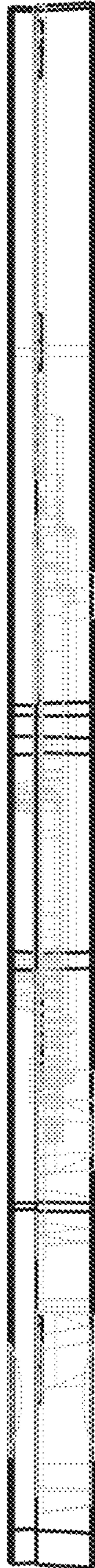

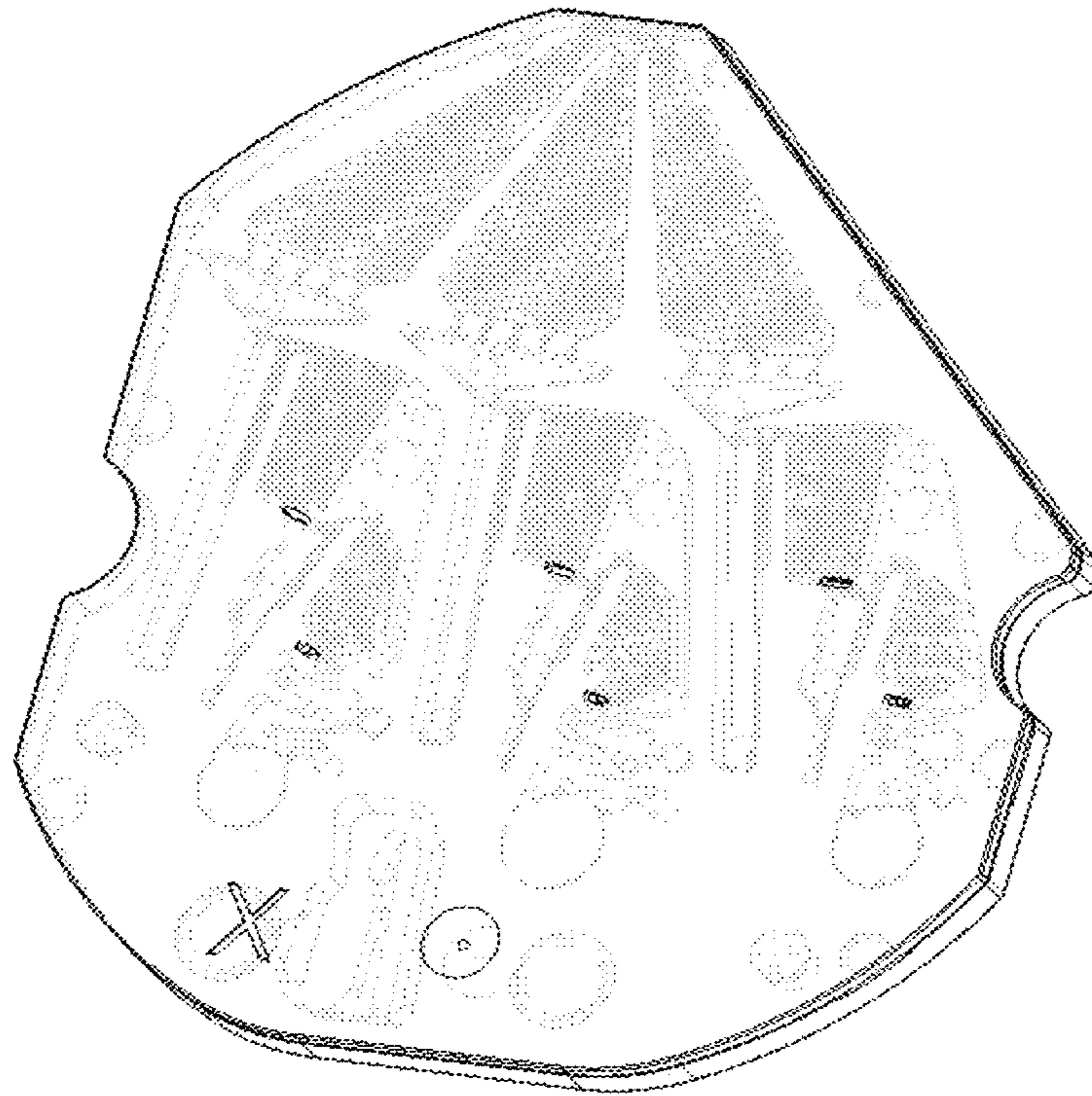

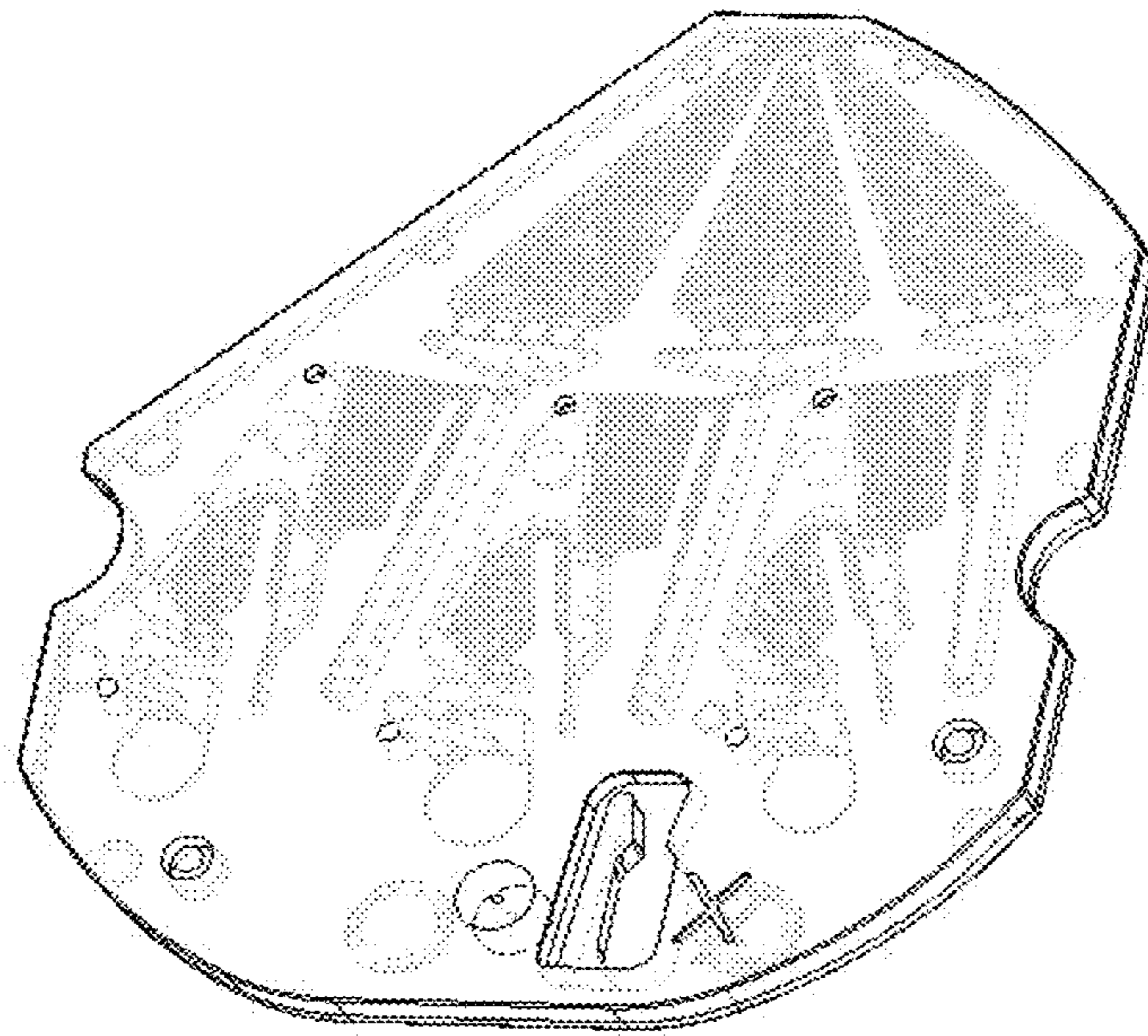

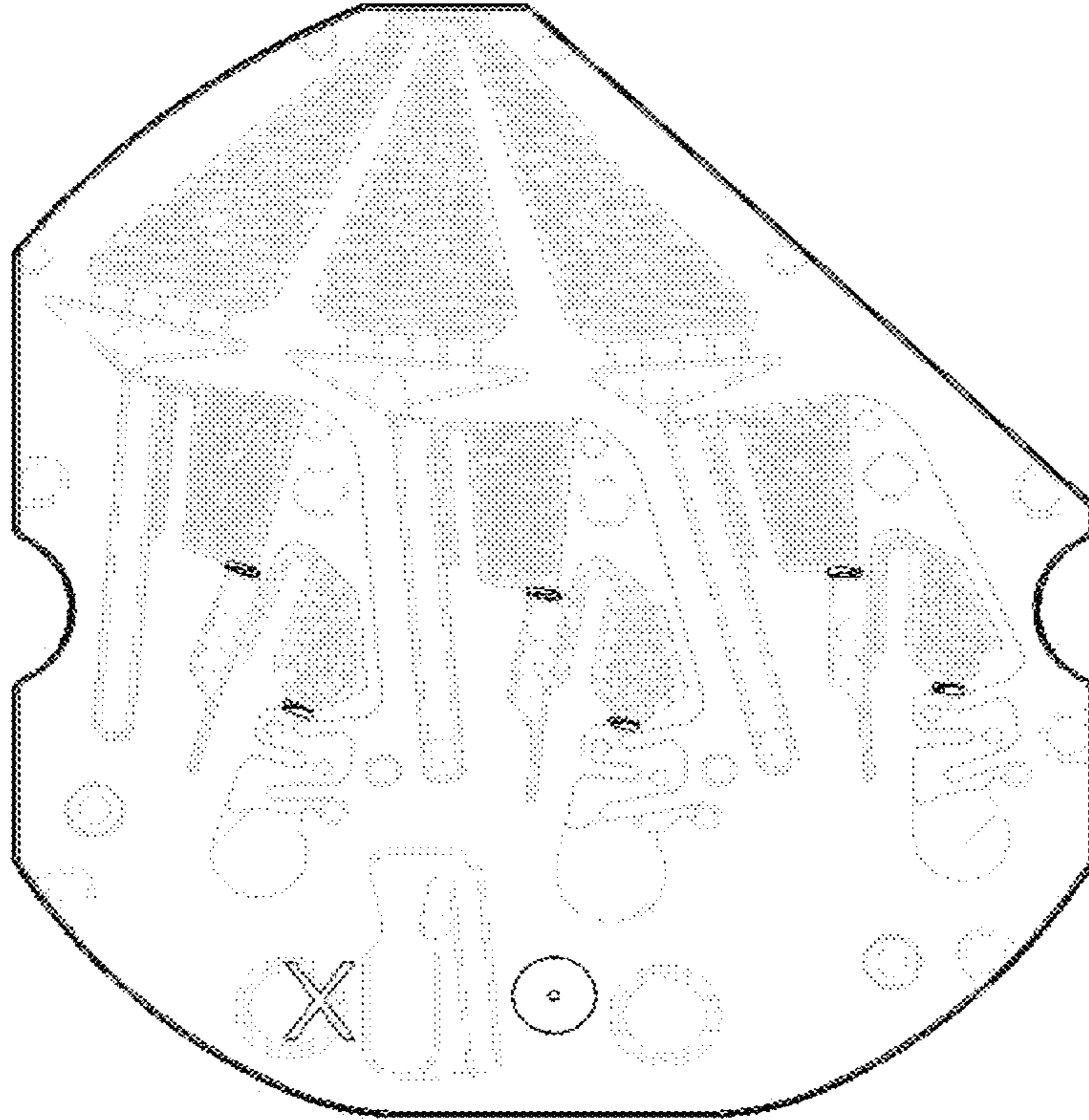

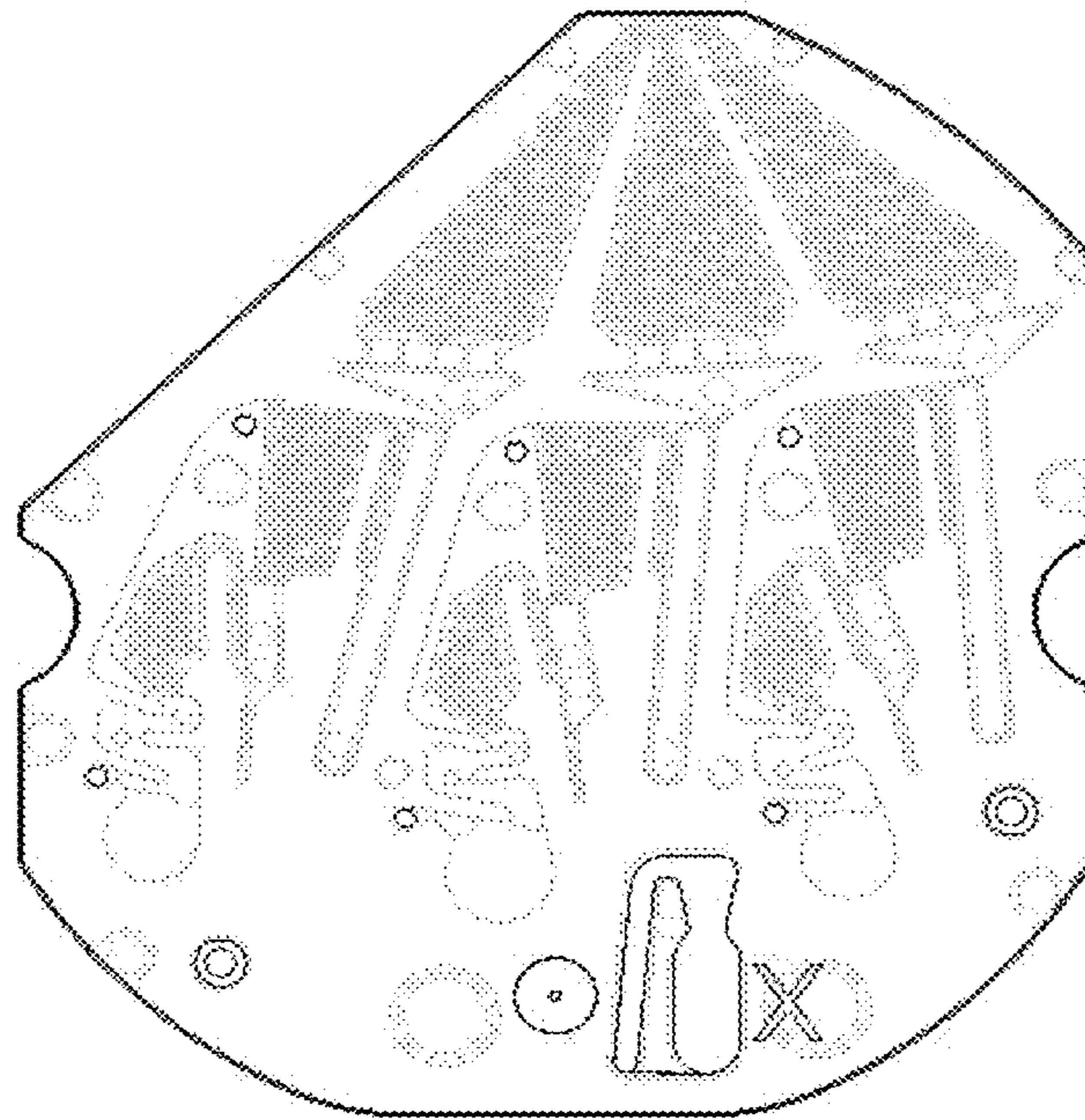

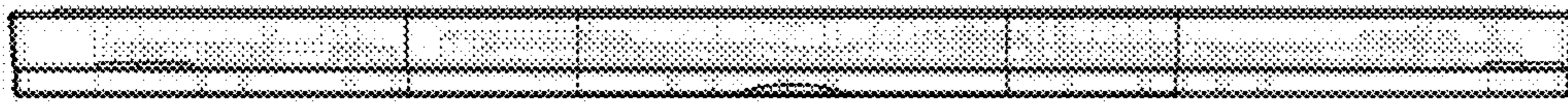

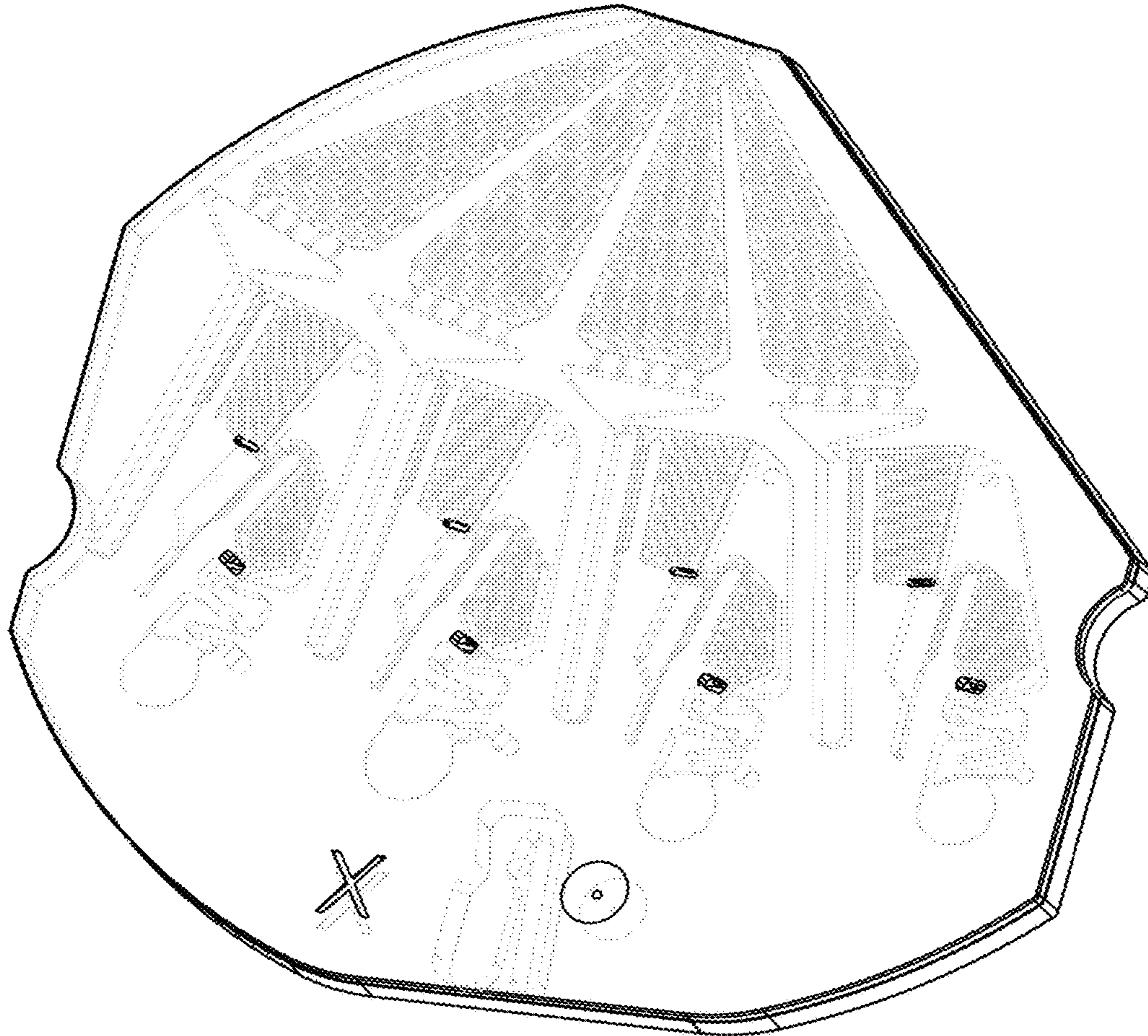

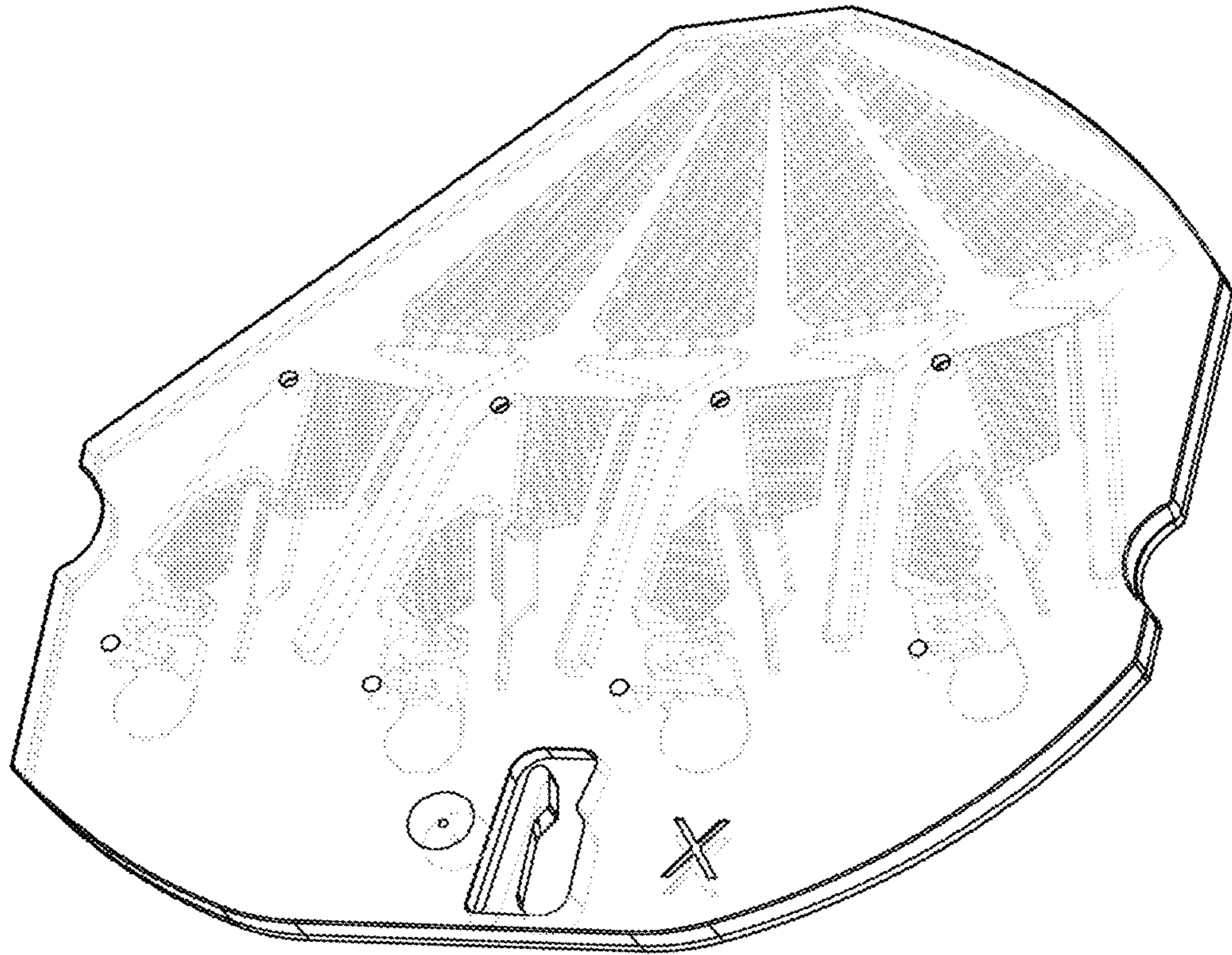

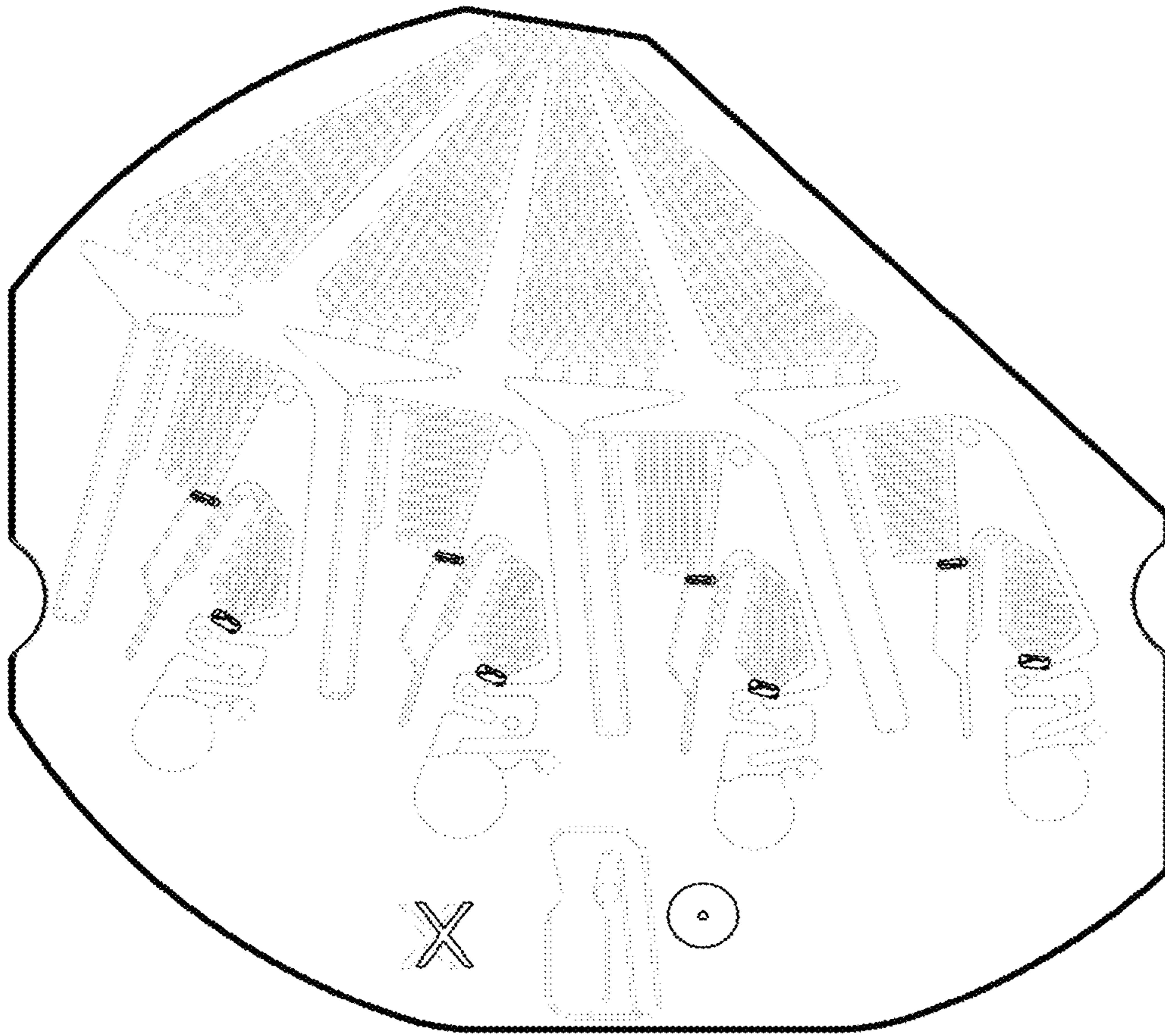

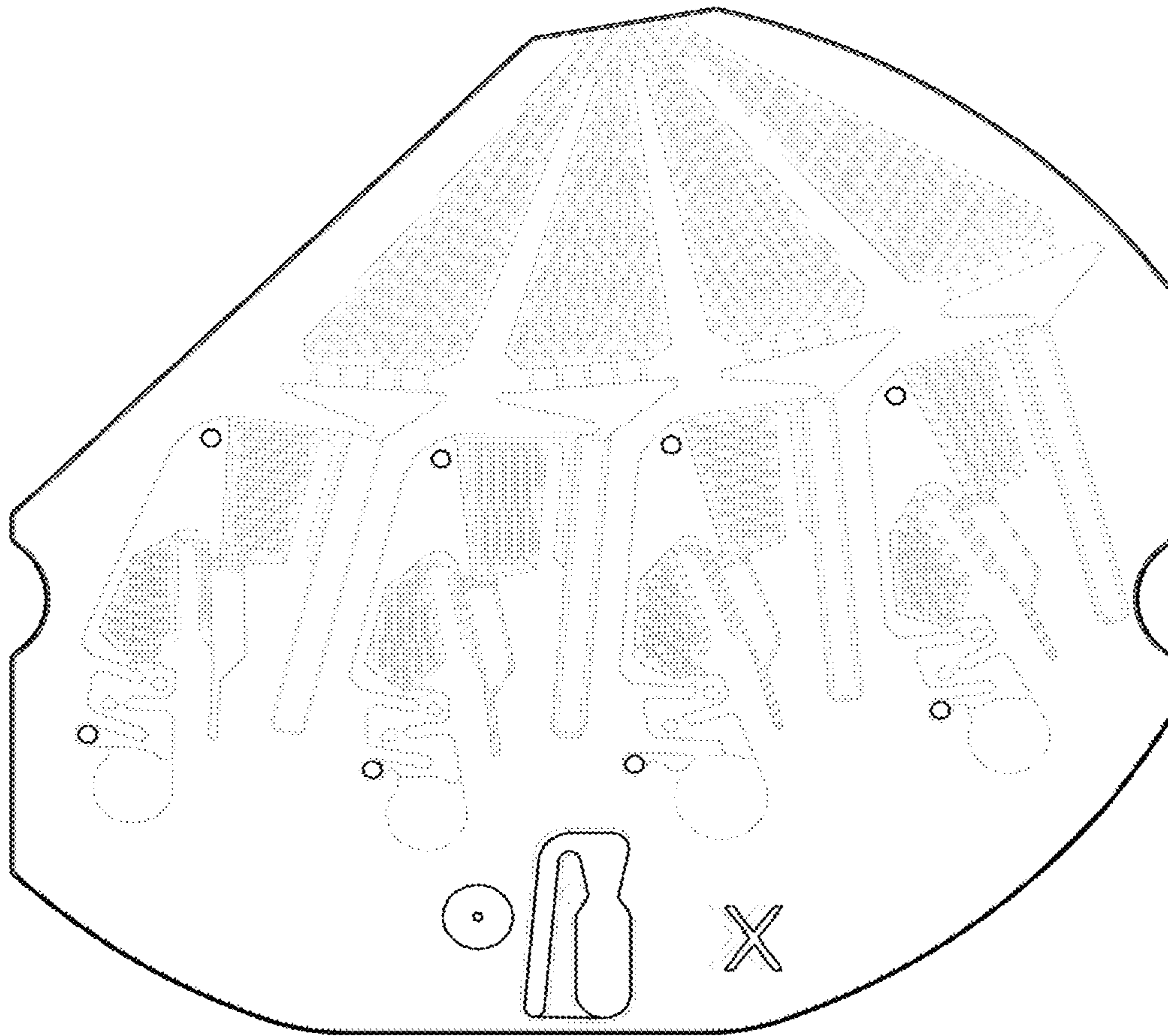

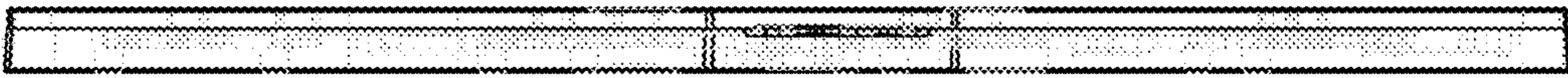

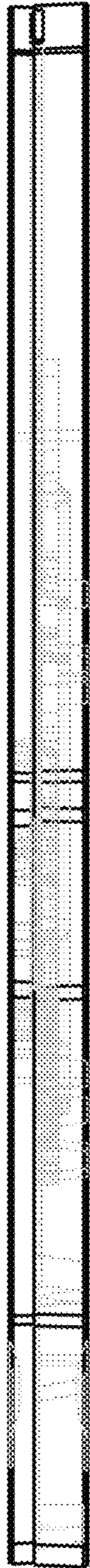
