The ornamental design for oral tobacco, as shown and described.

DESCRIPTION

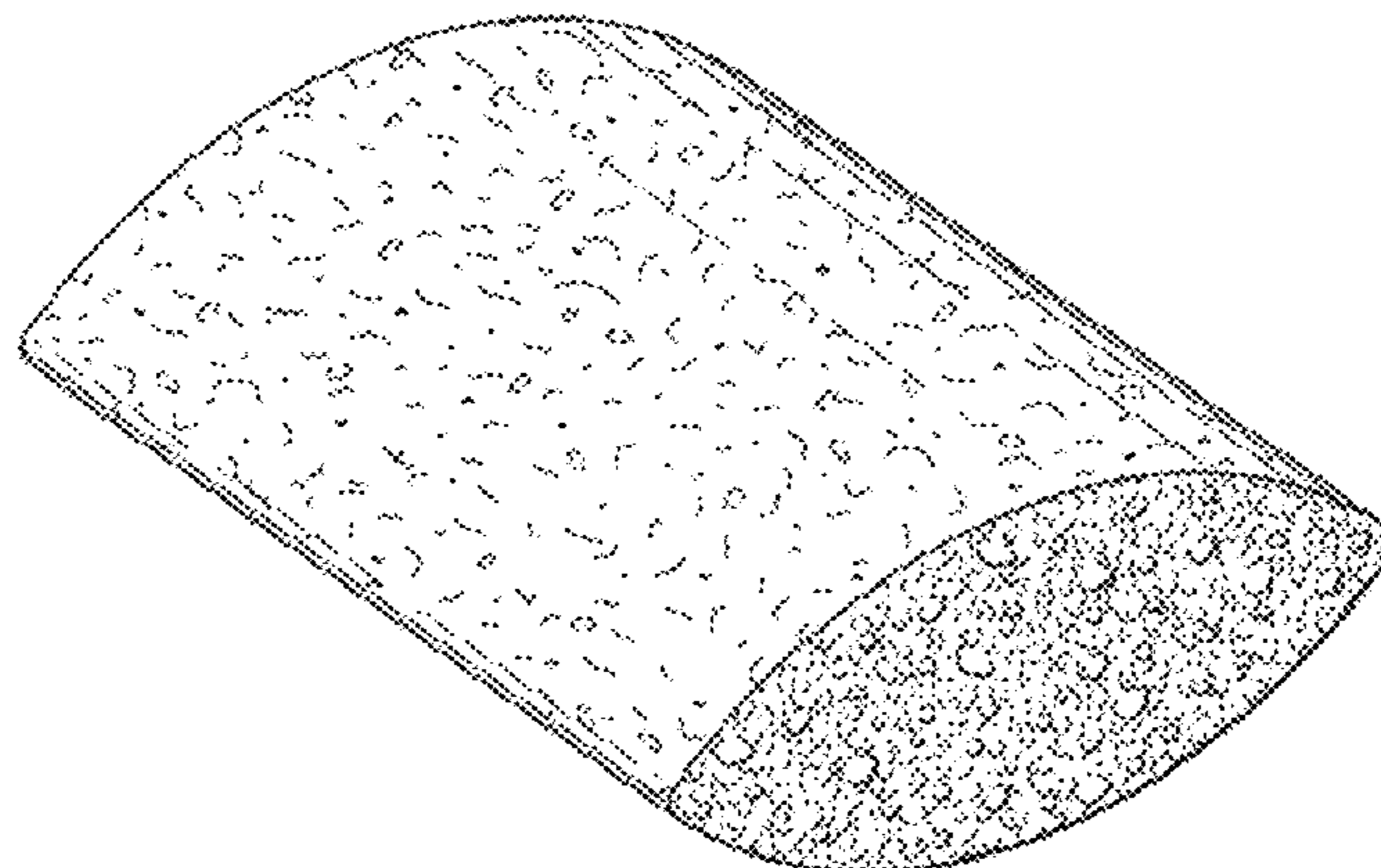


FIG. 12 is a top view thereof, the bottom view being a mirror image thereof;

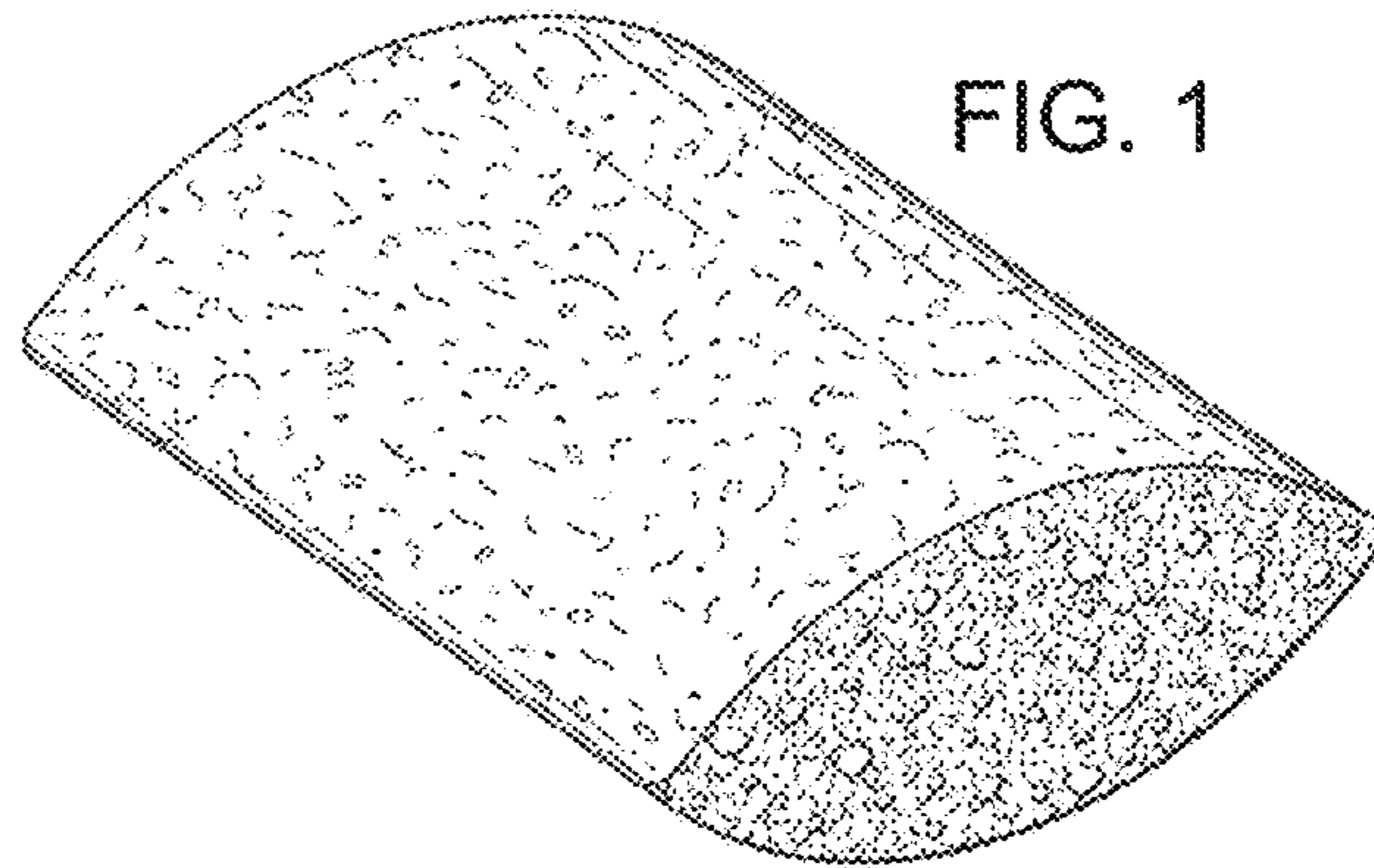

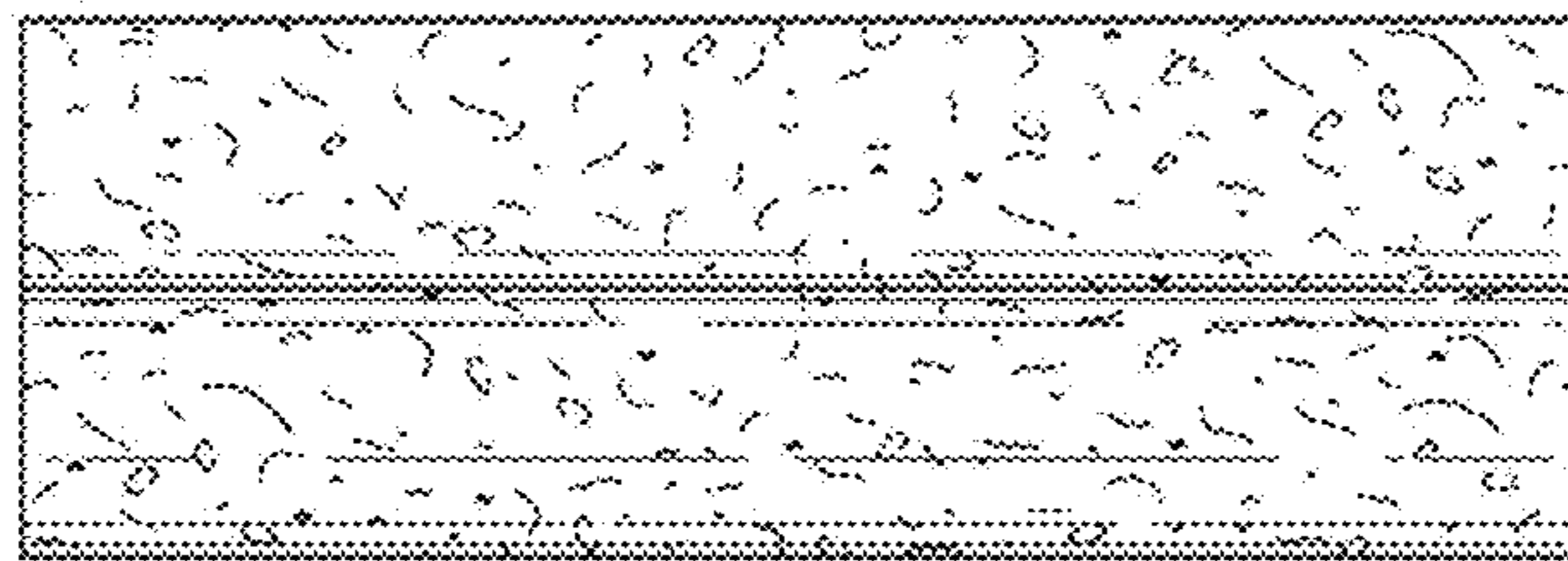

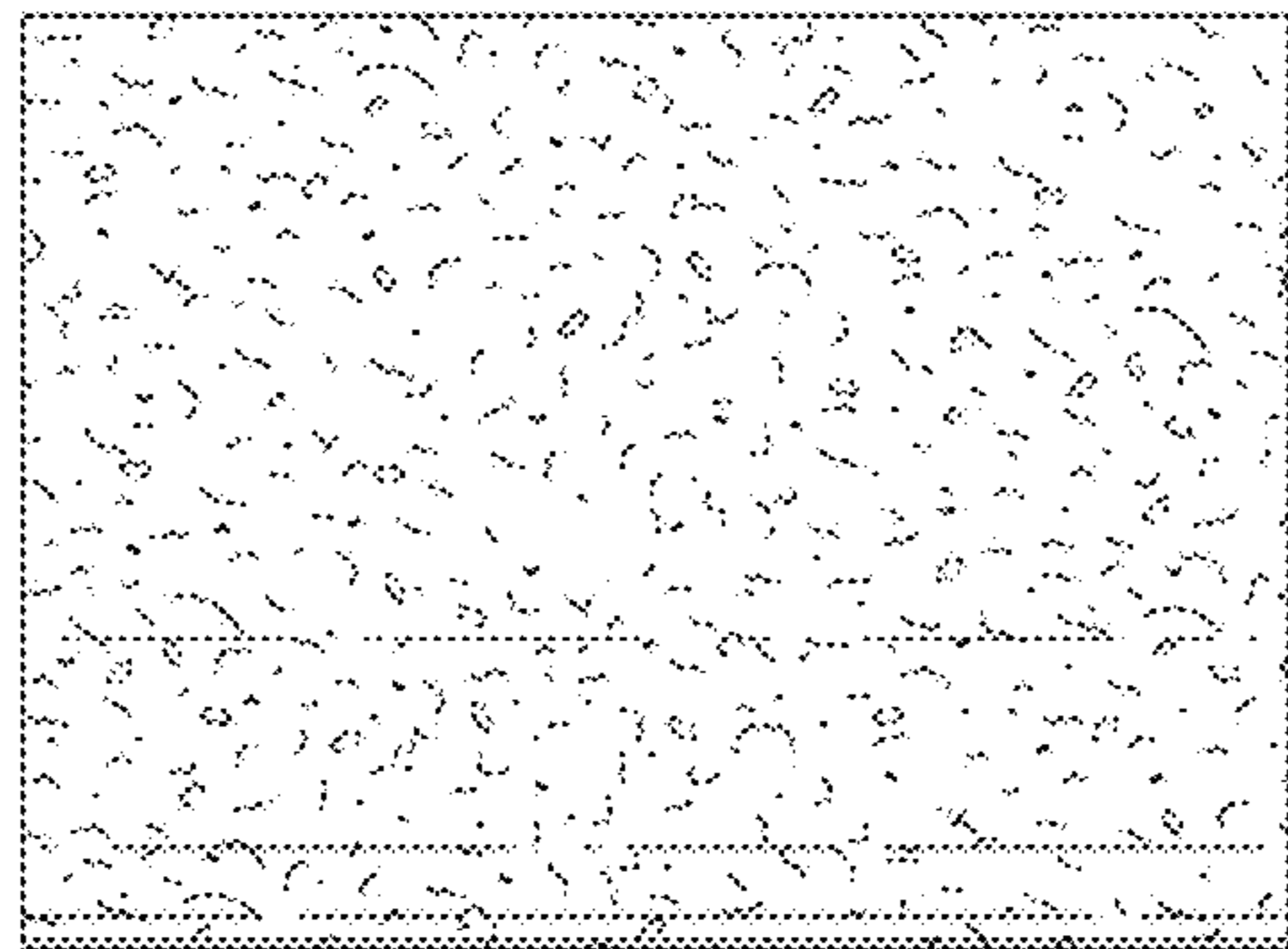
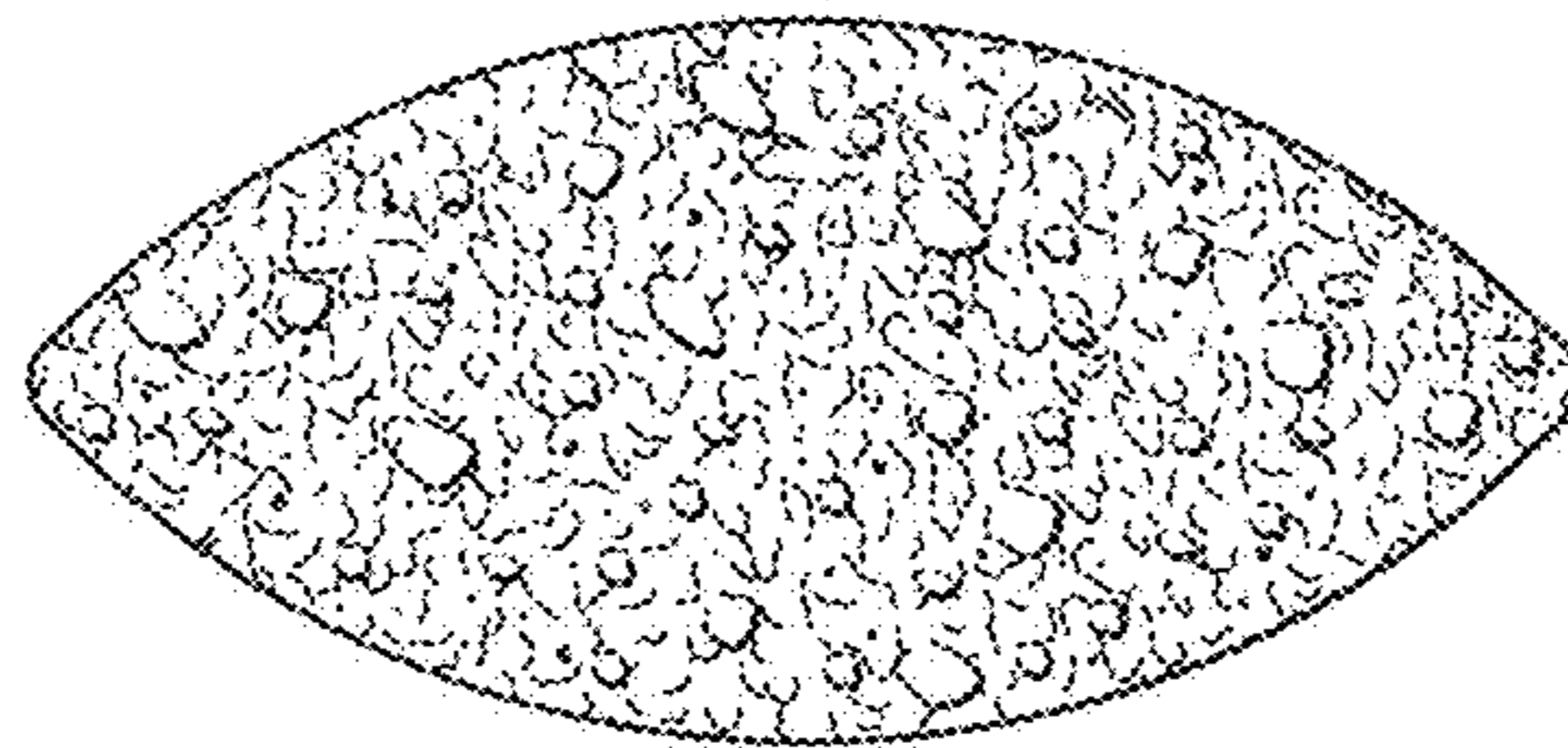

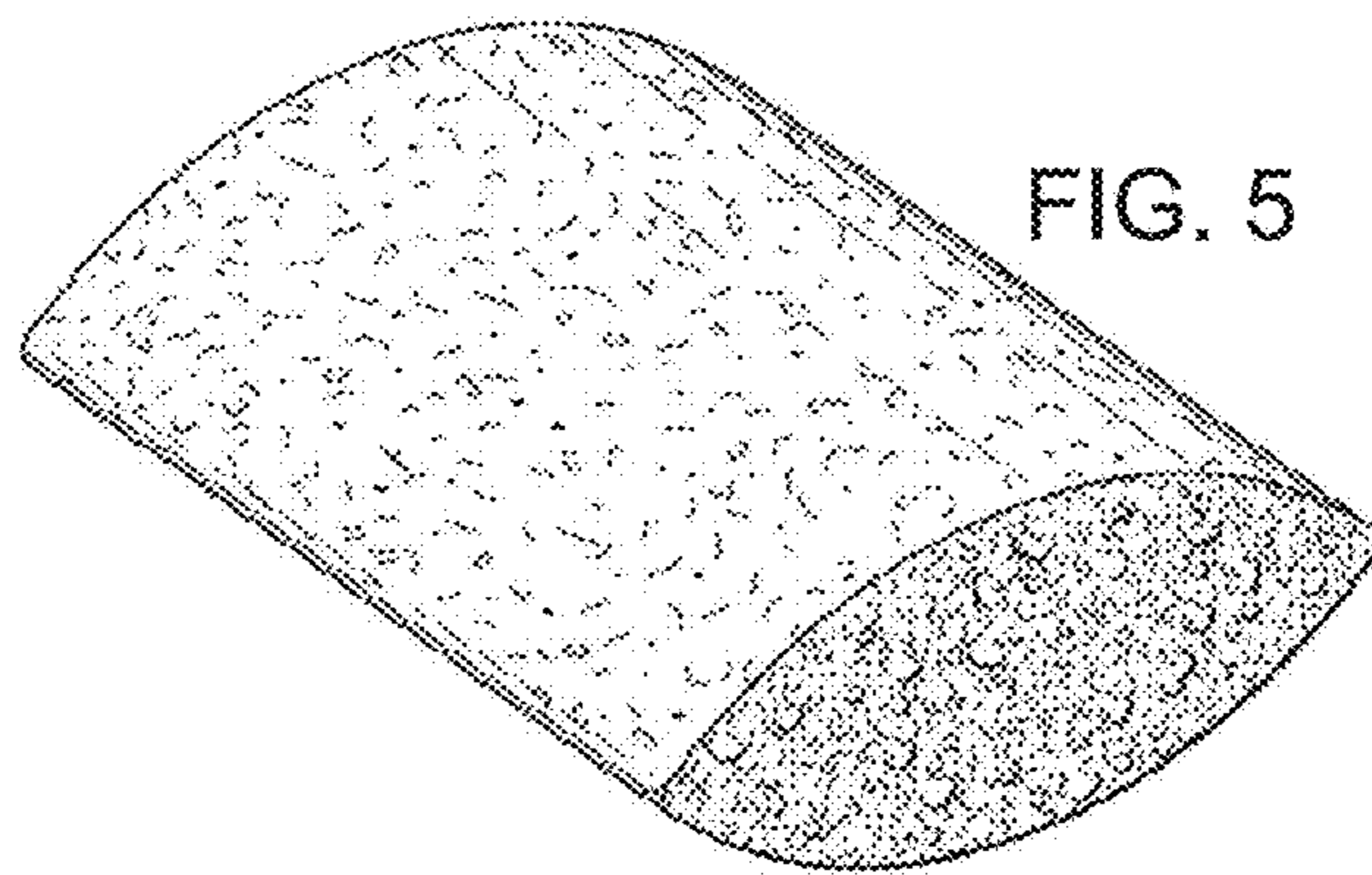

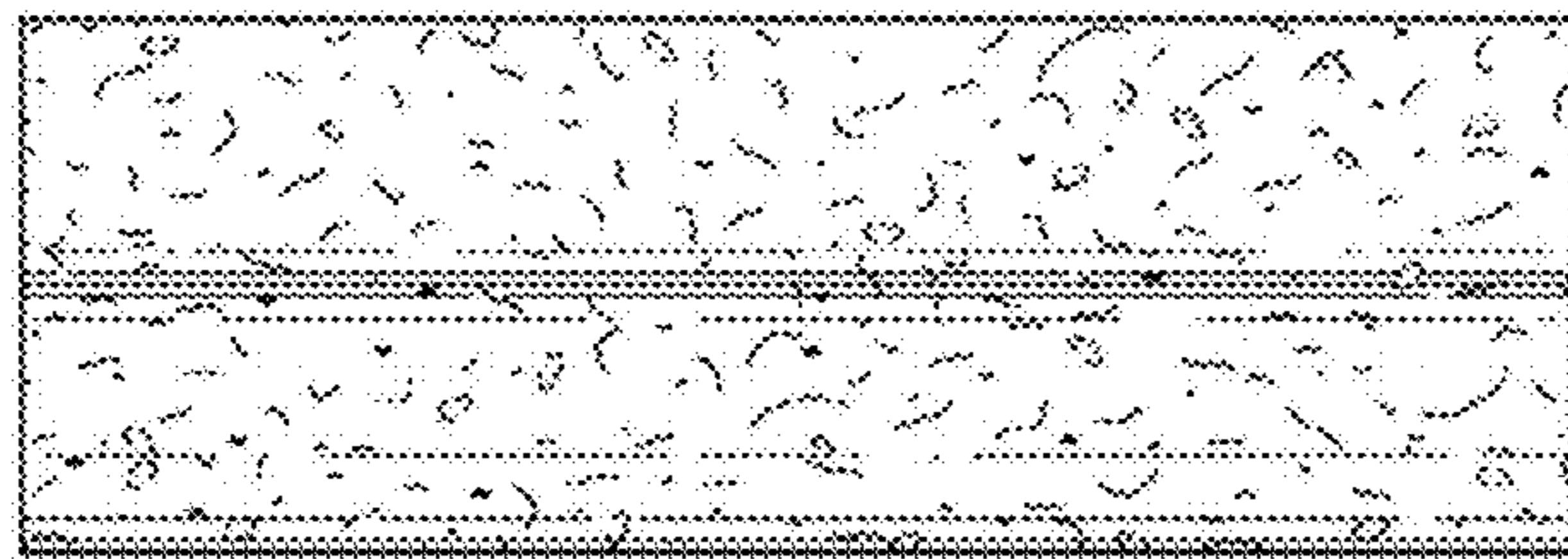

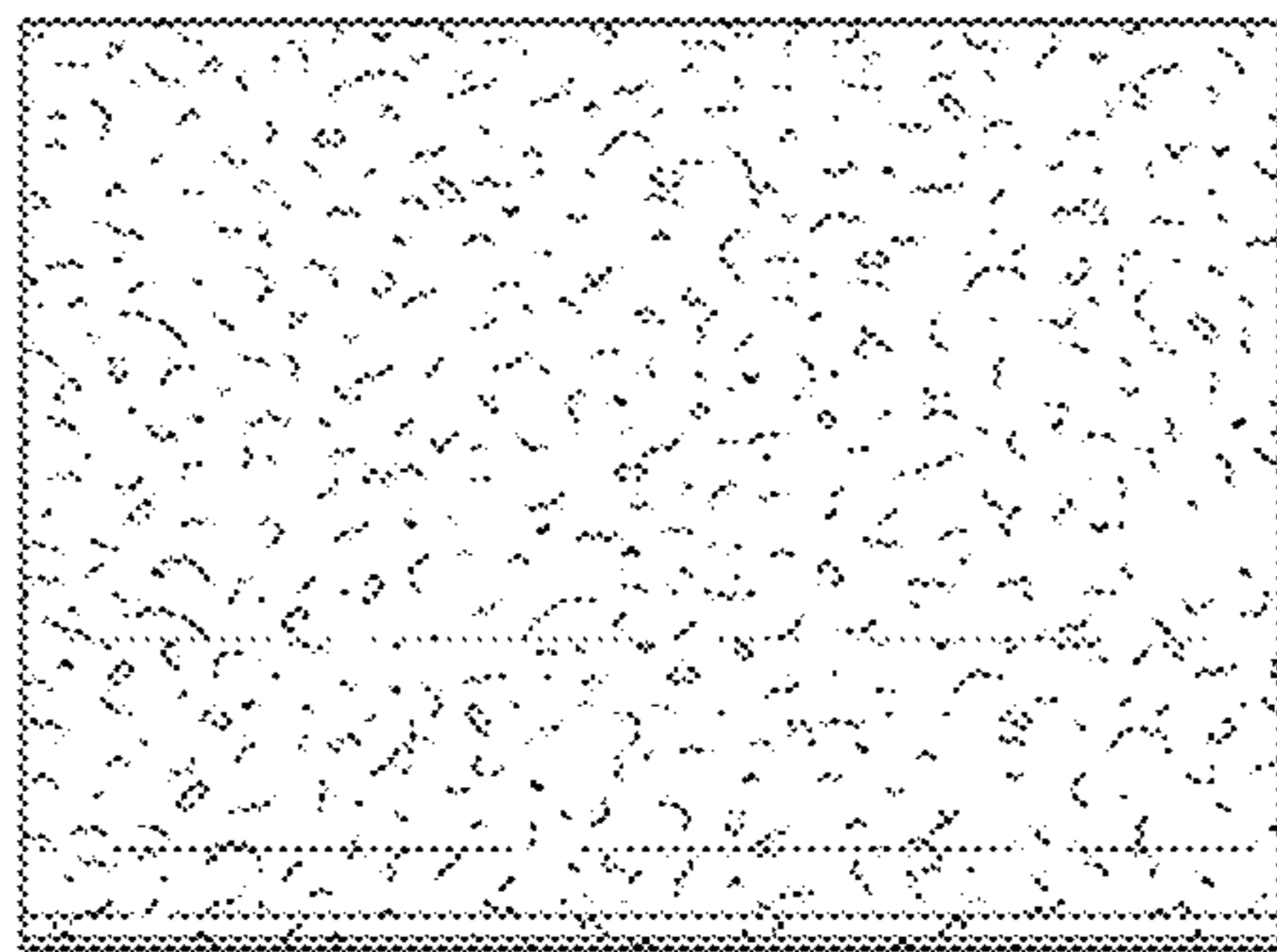
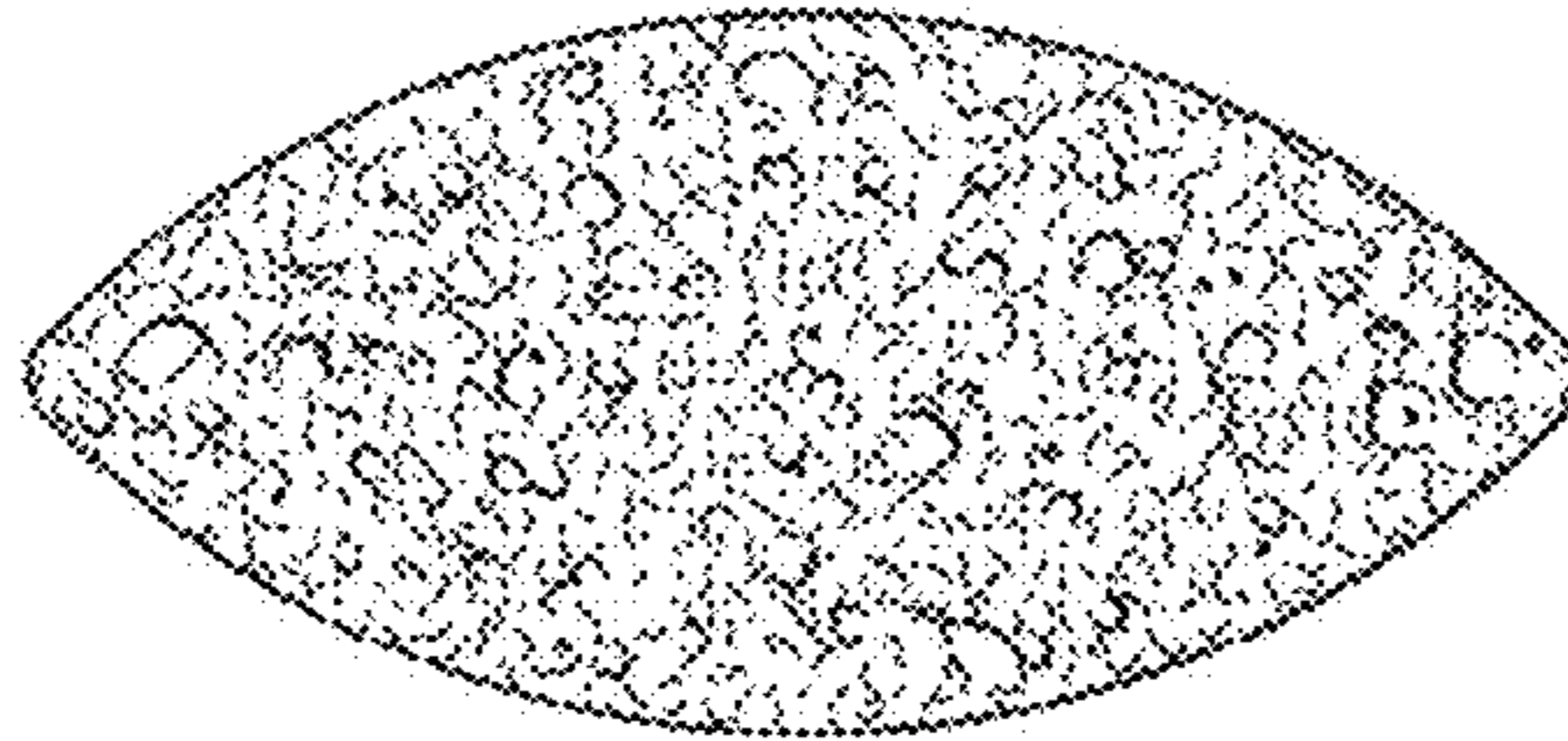

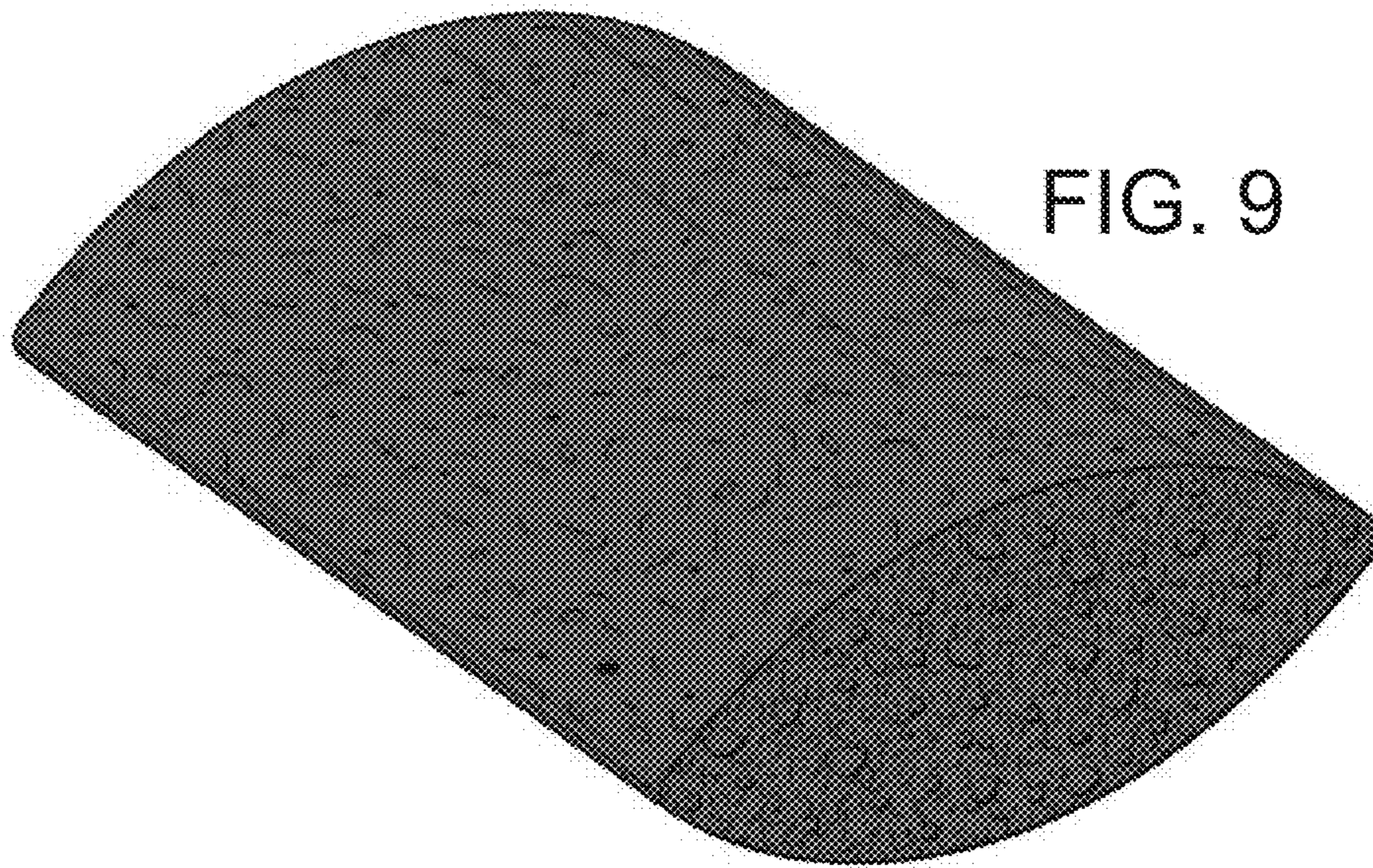

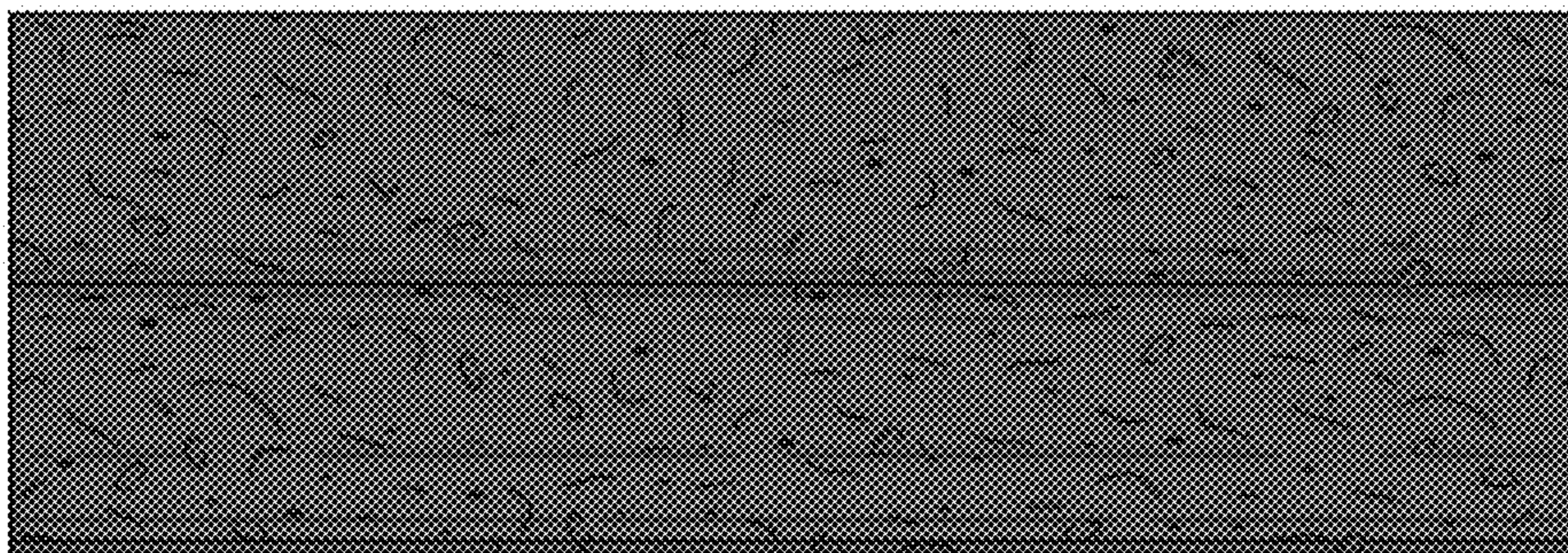

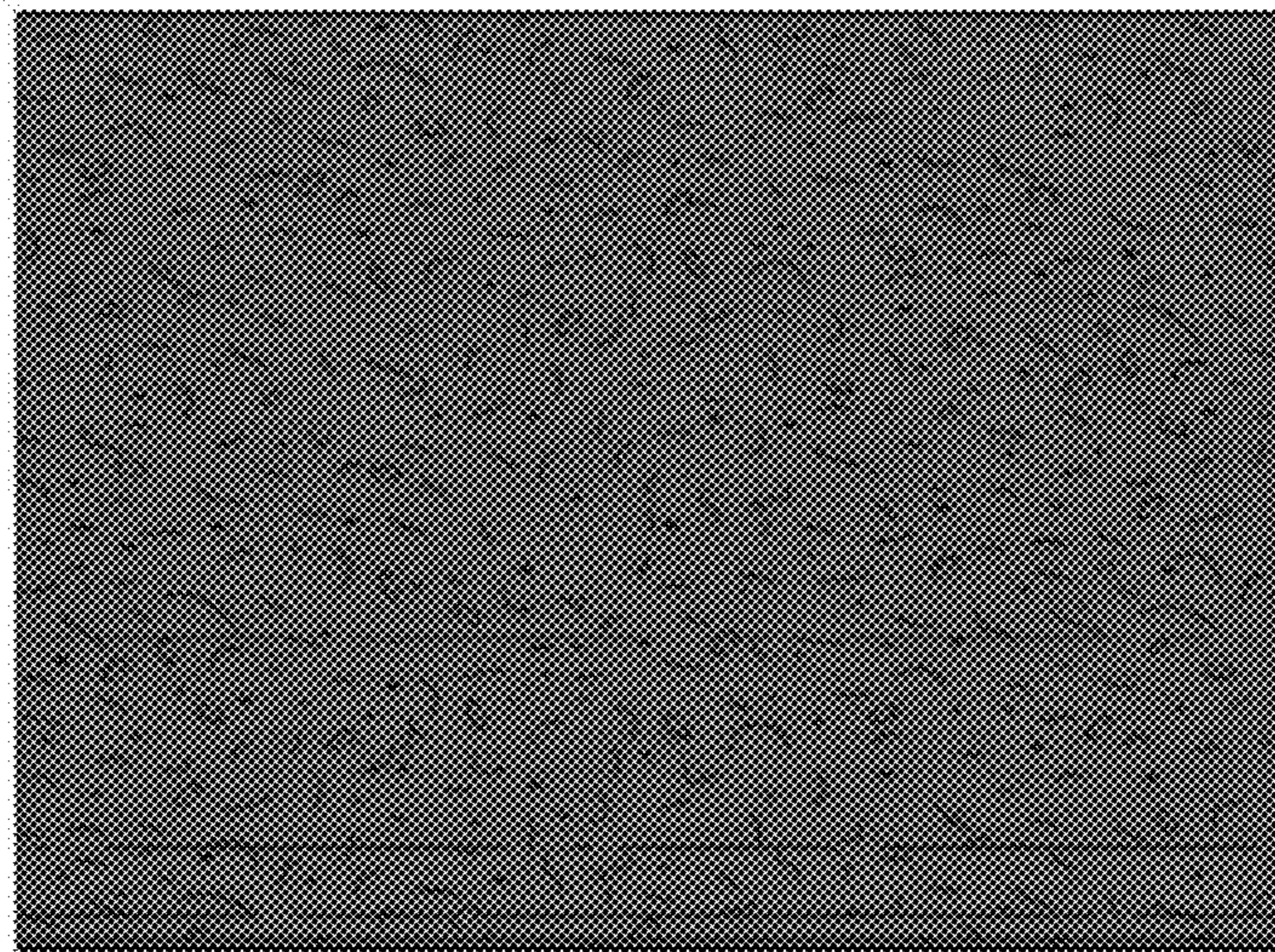
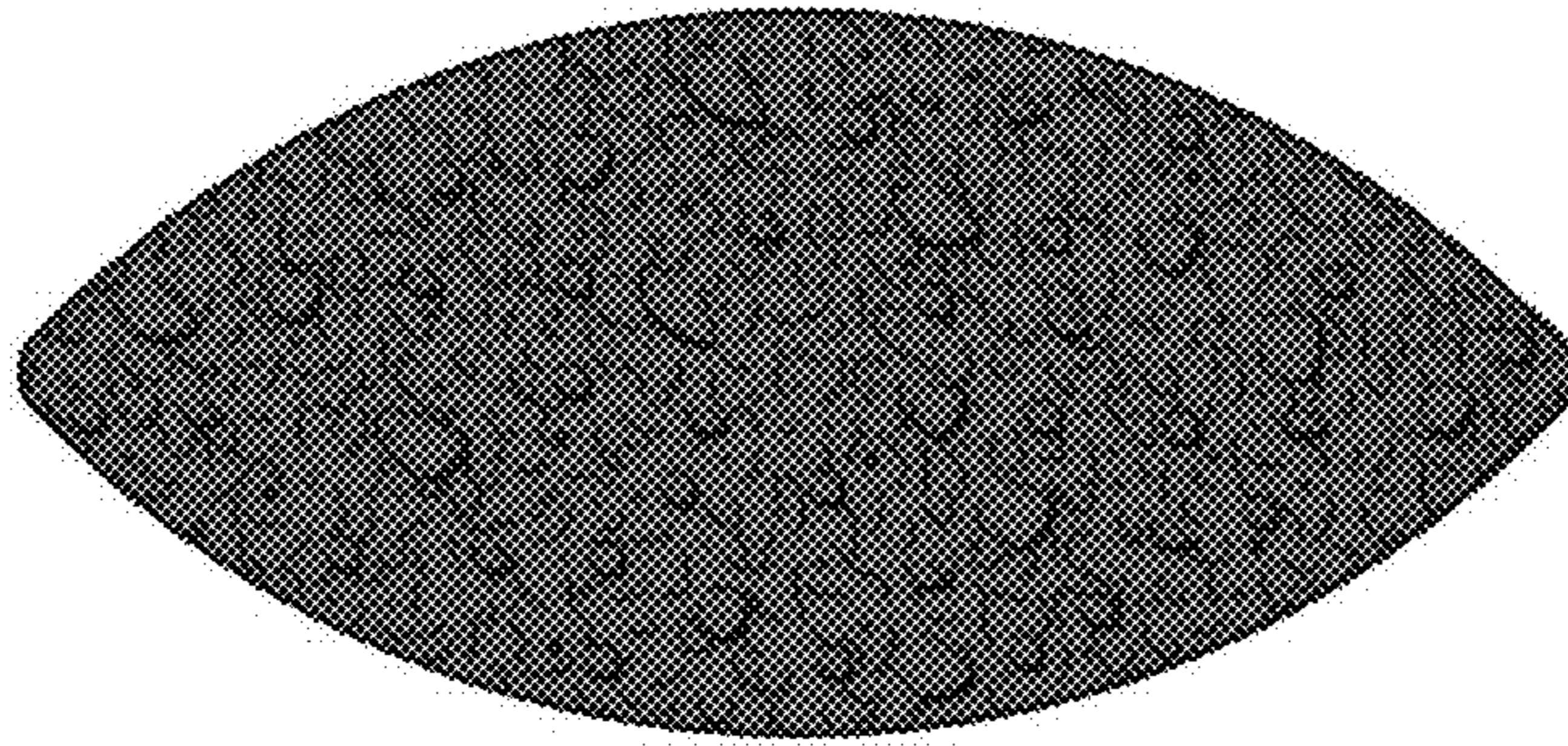

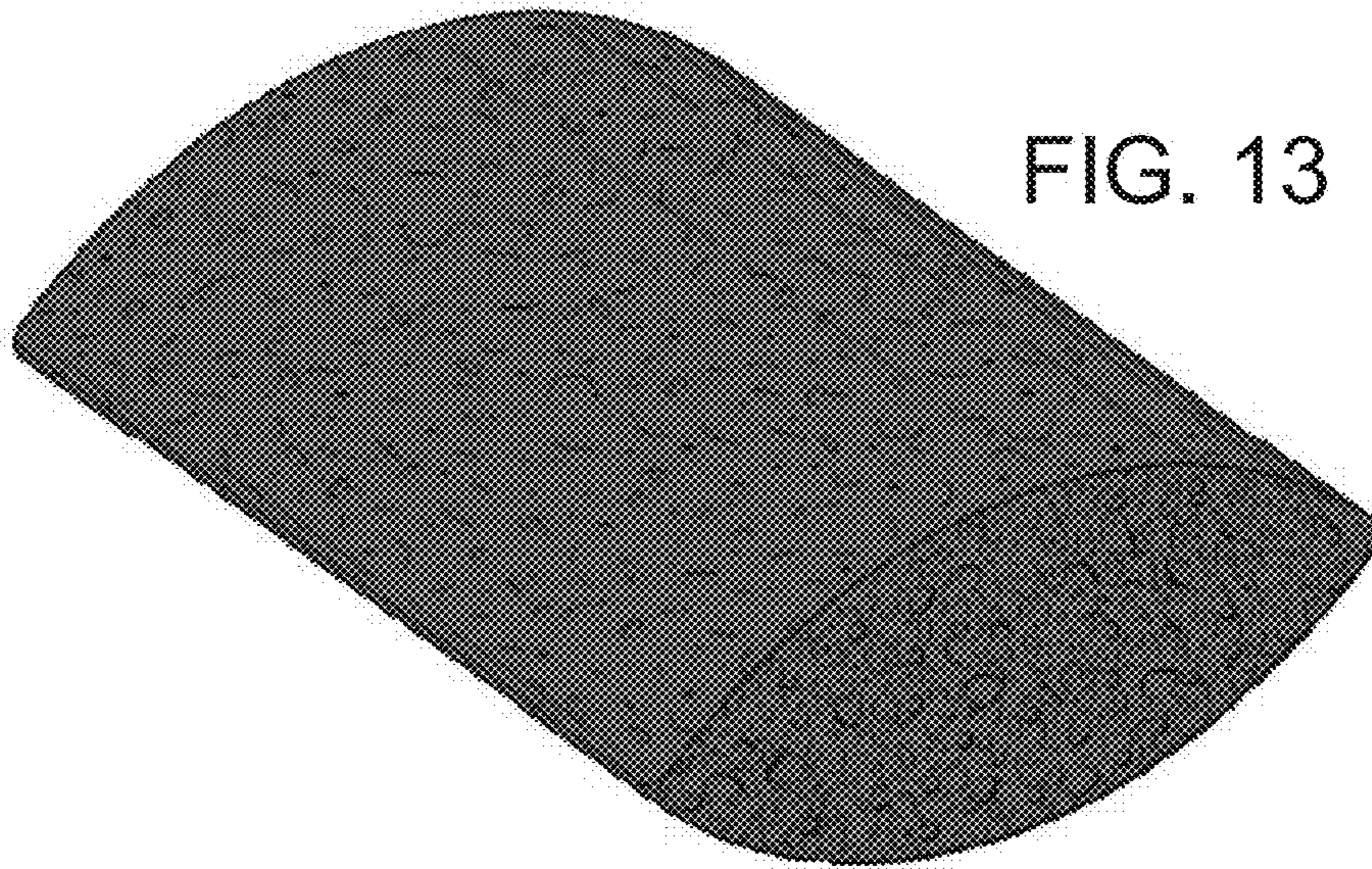

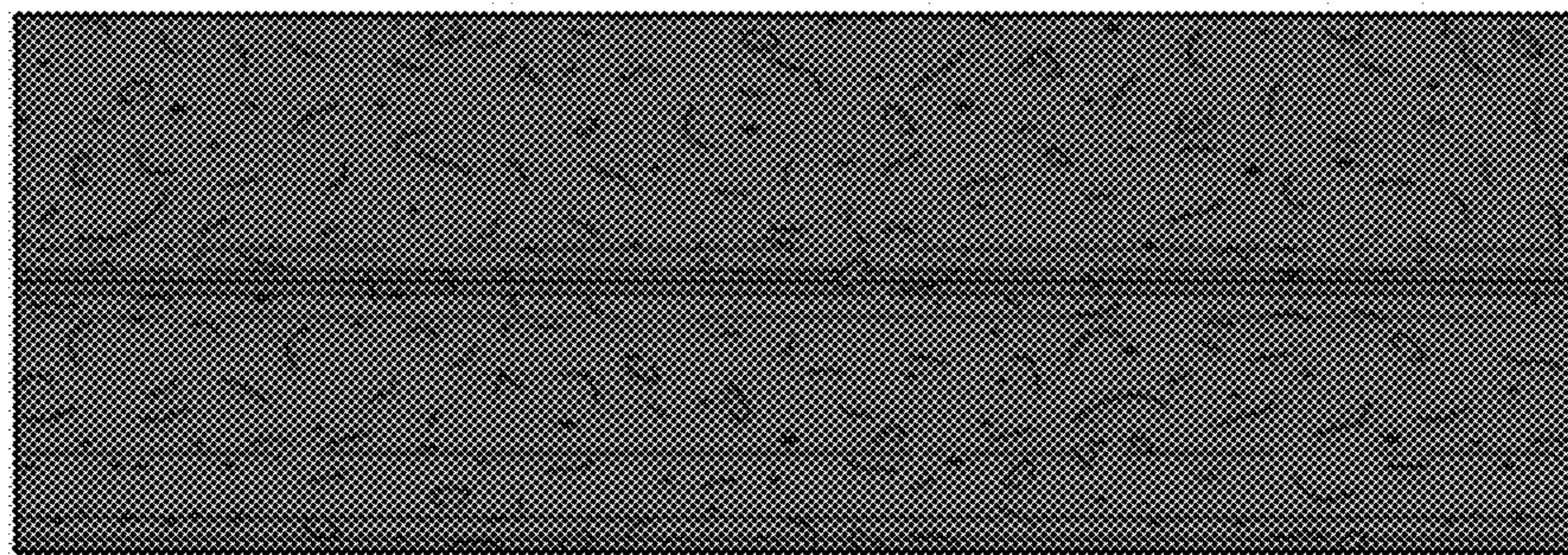

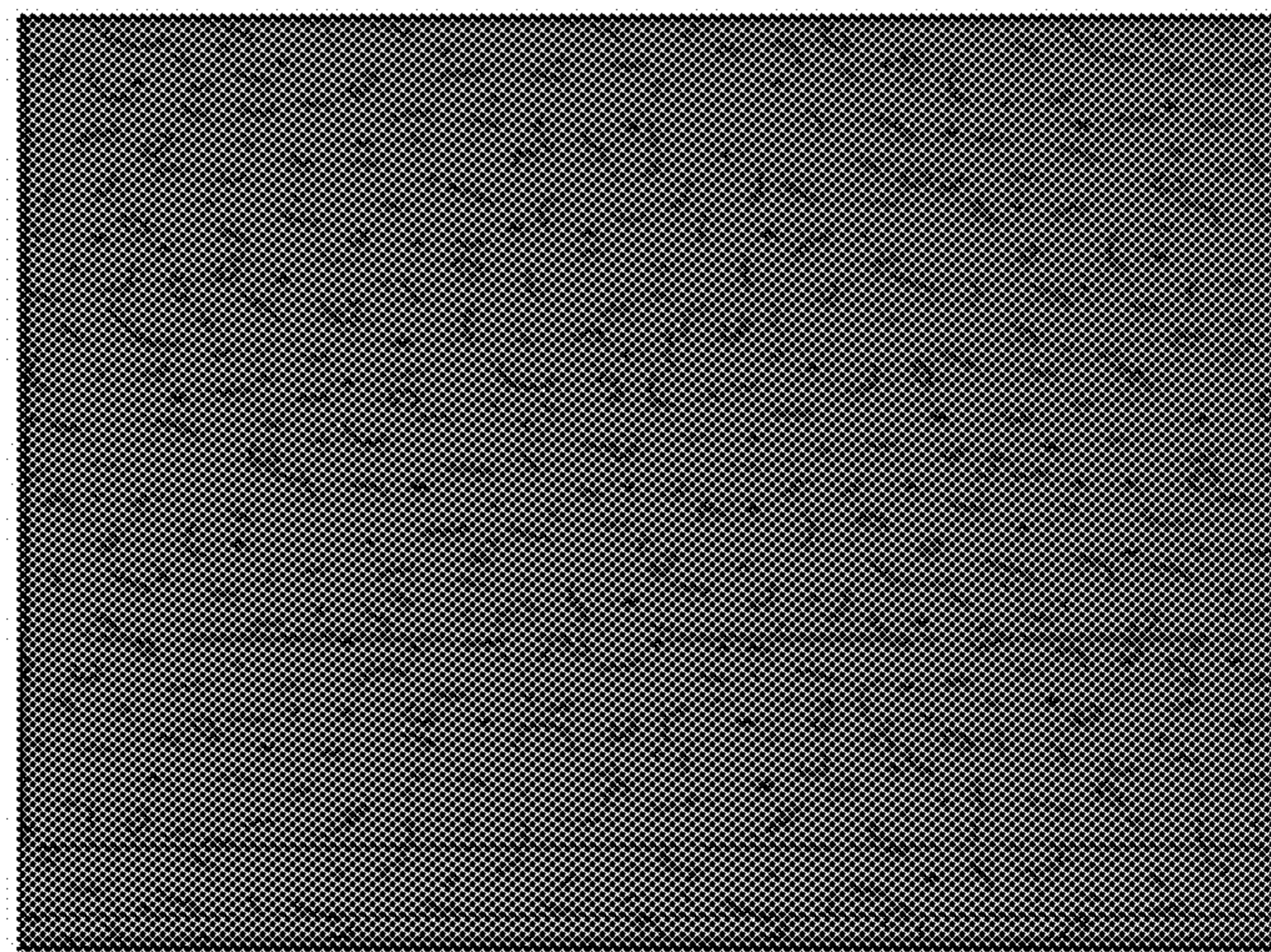
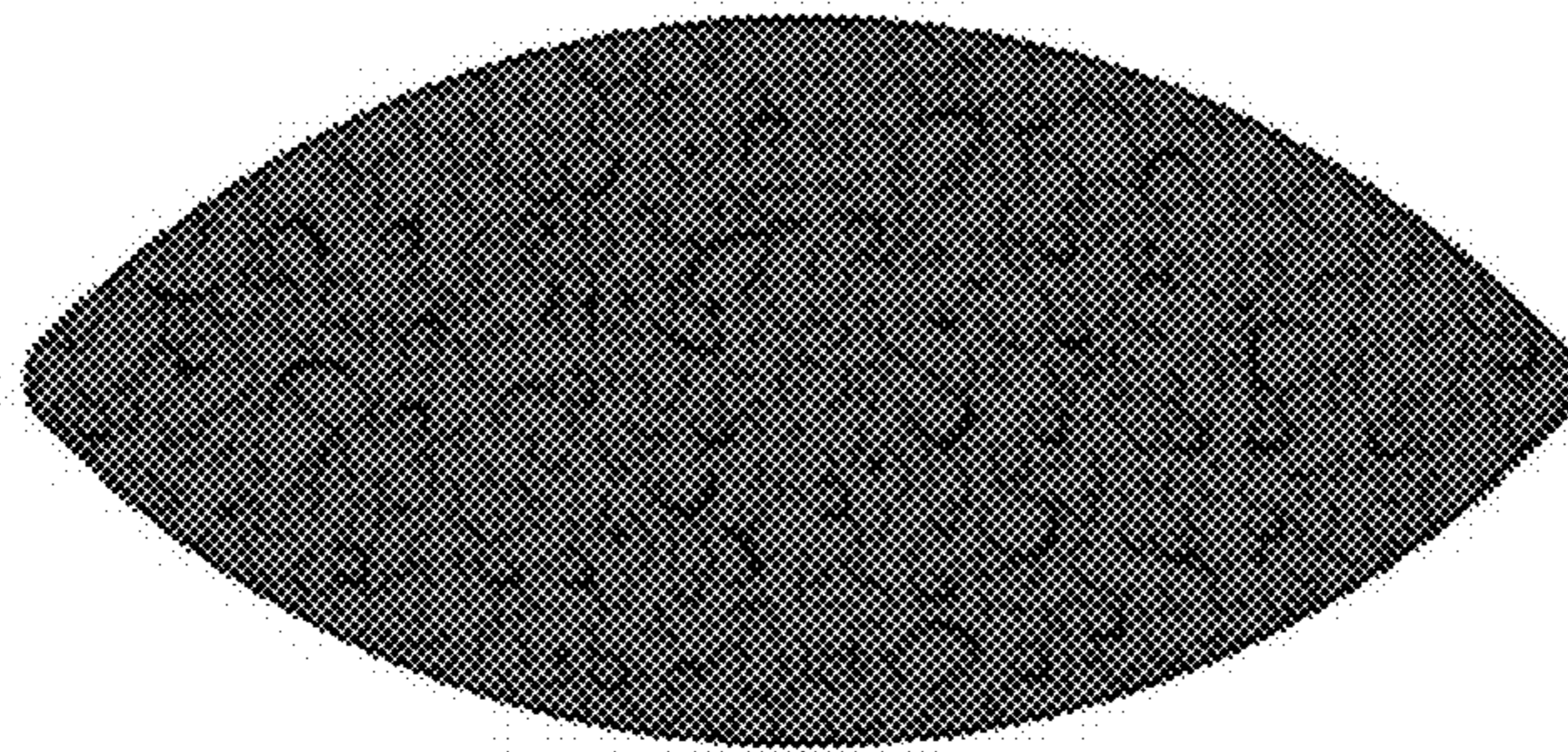
