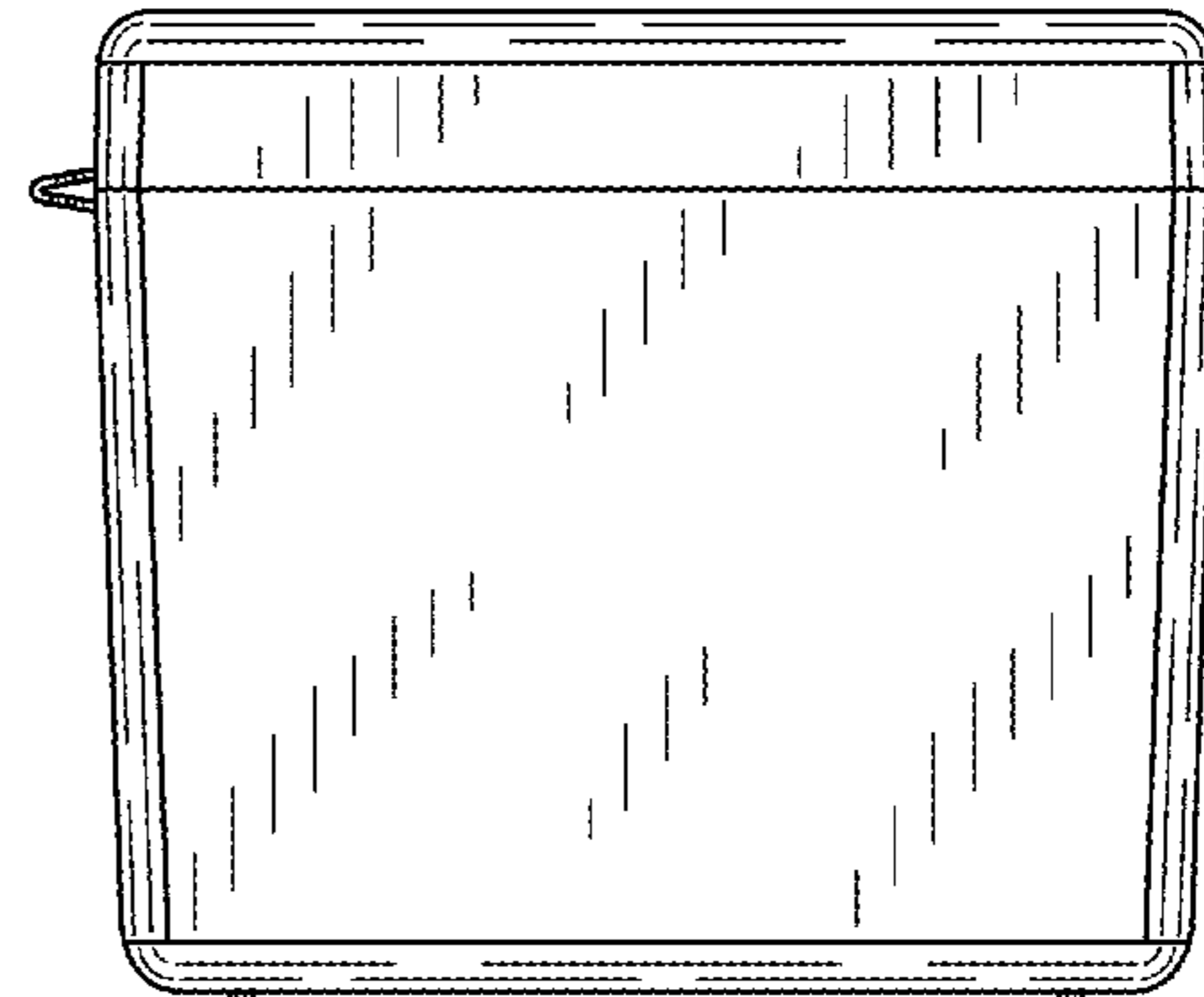
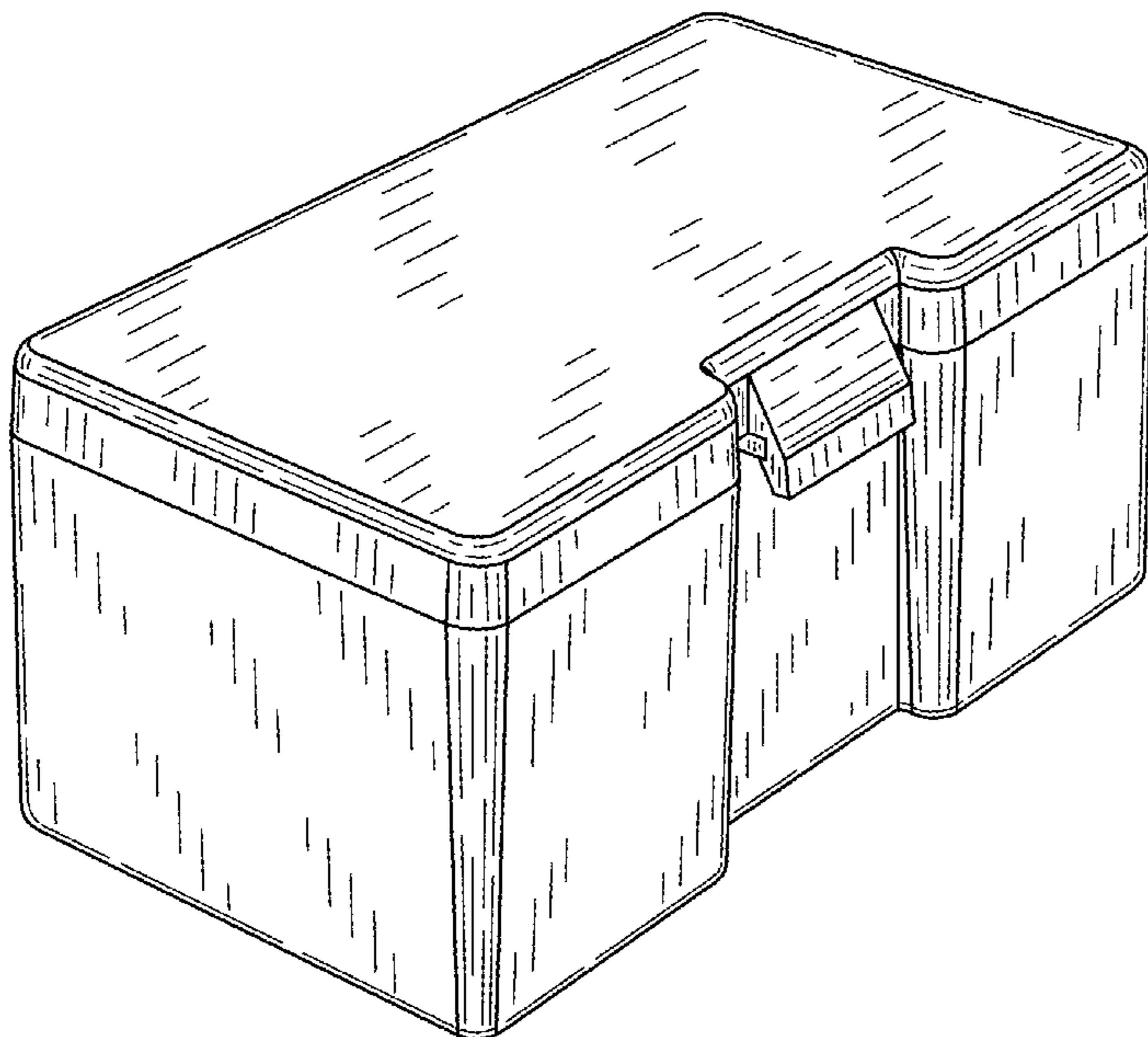
(57) **CLAIM**

The ornamental design for an algae scrubber, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an algae scrubber in accordance with the present design.
FIG. 2 is a right side view of the algae scrubber shown in FIG. 1.
FIG. 3 is a left side view of the algae scrubber shown in FIG. 1.

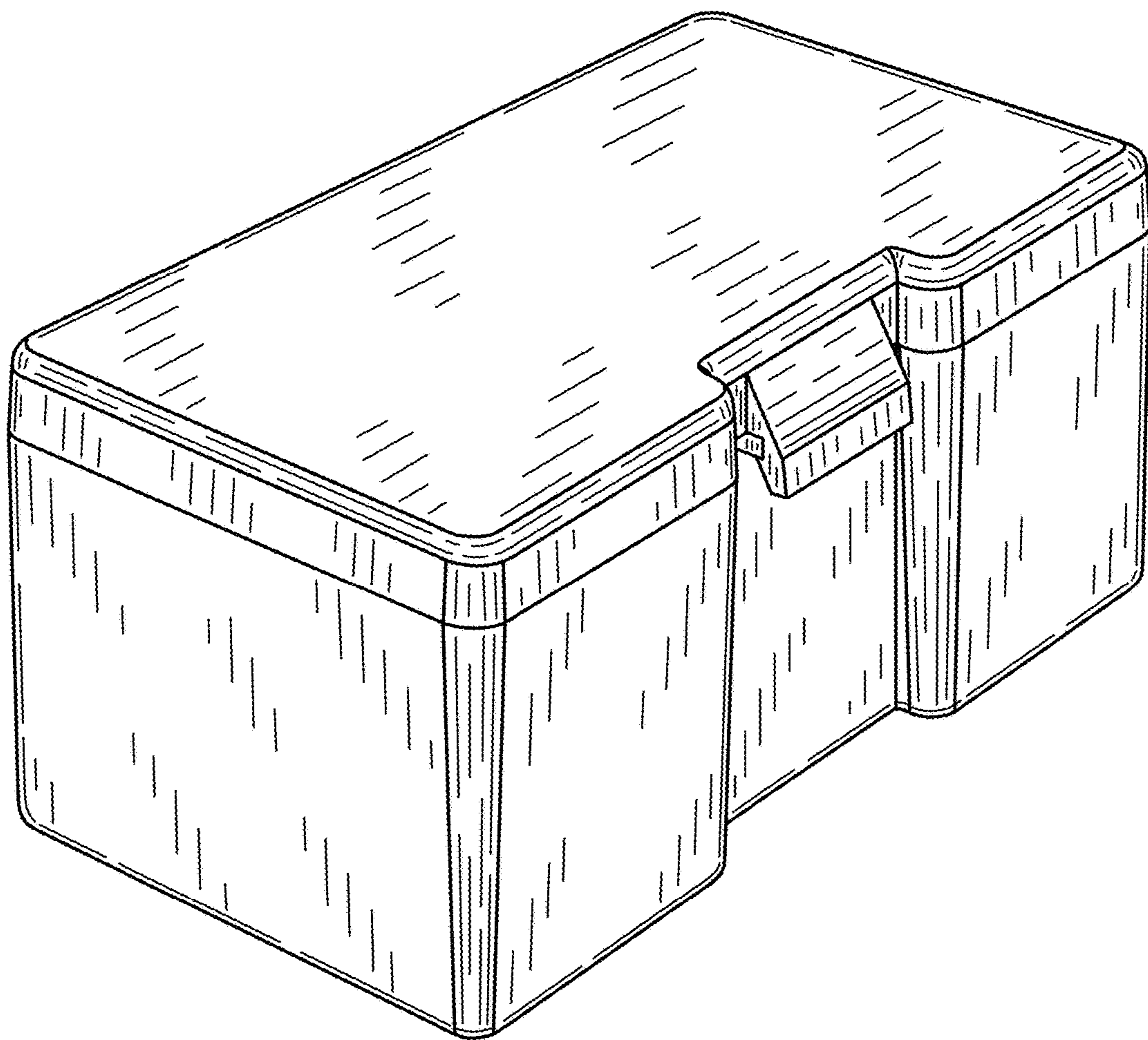

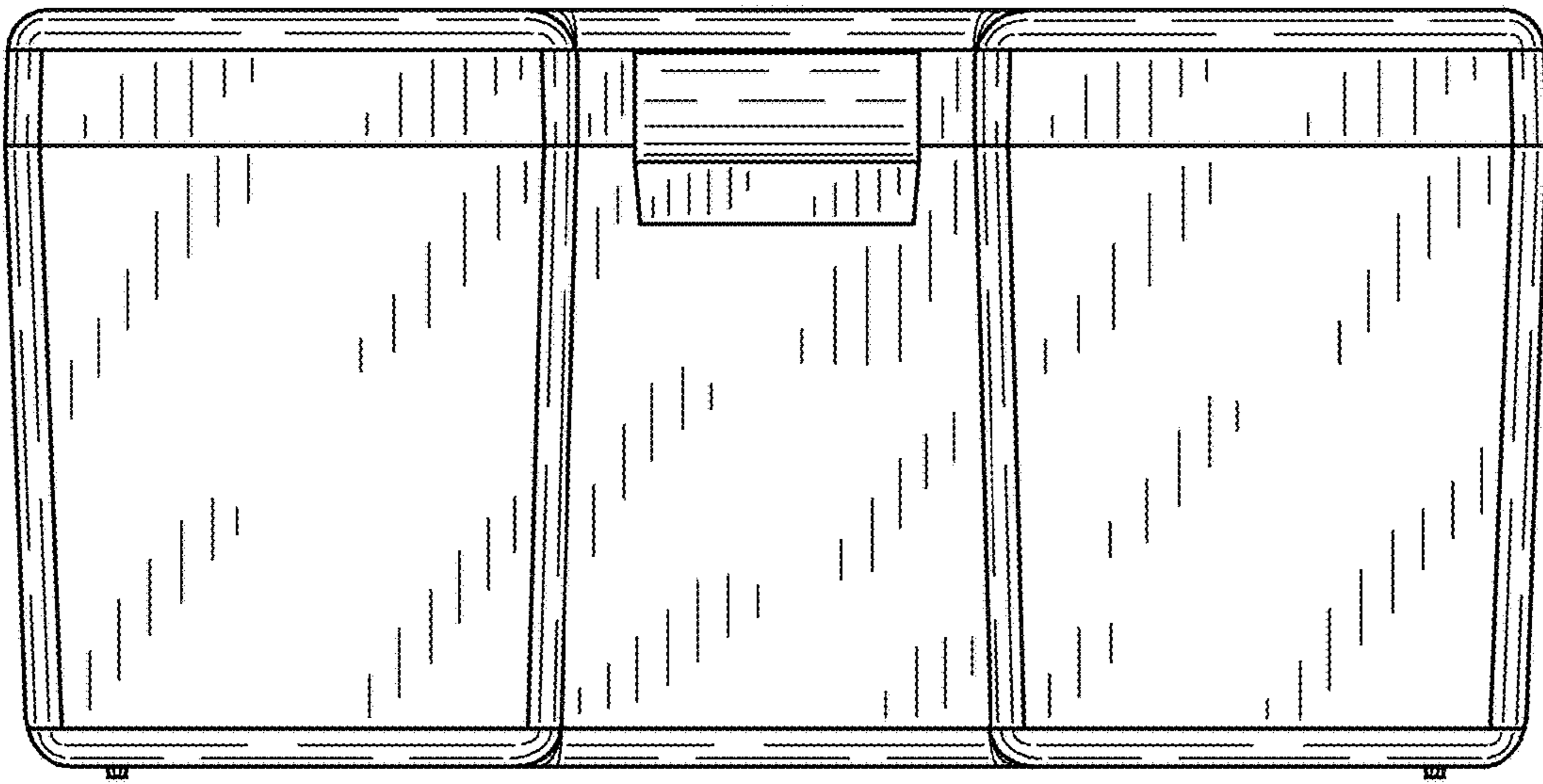

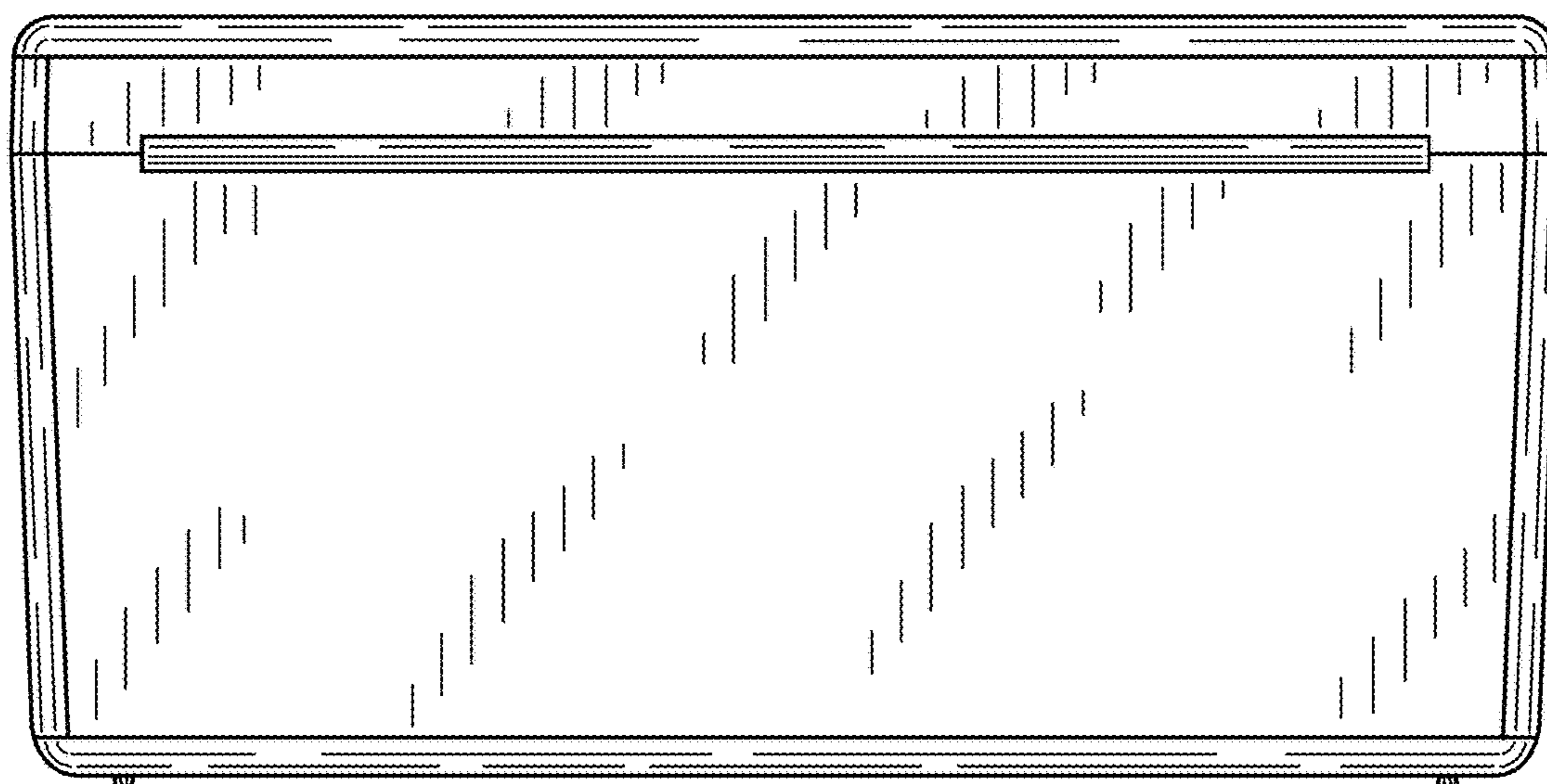

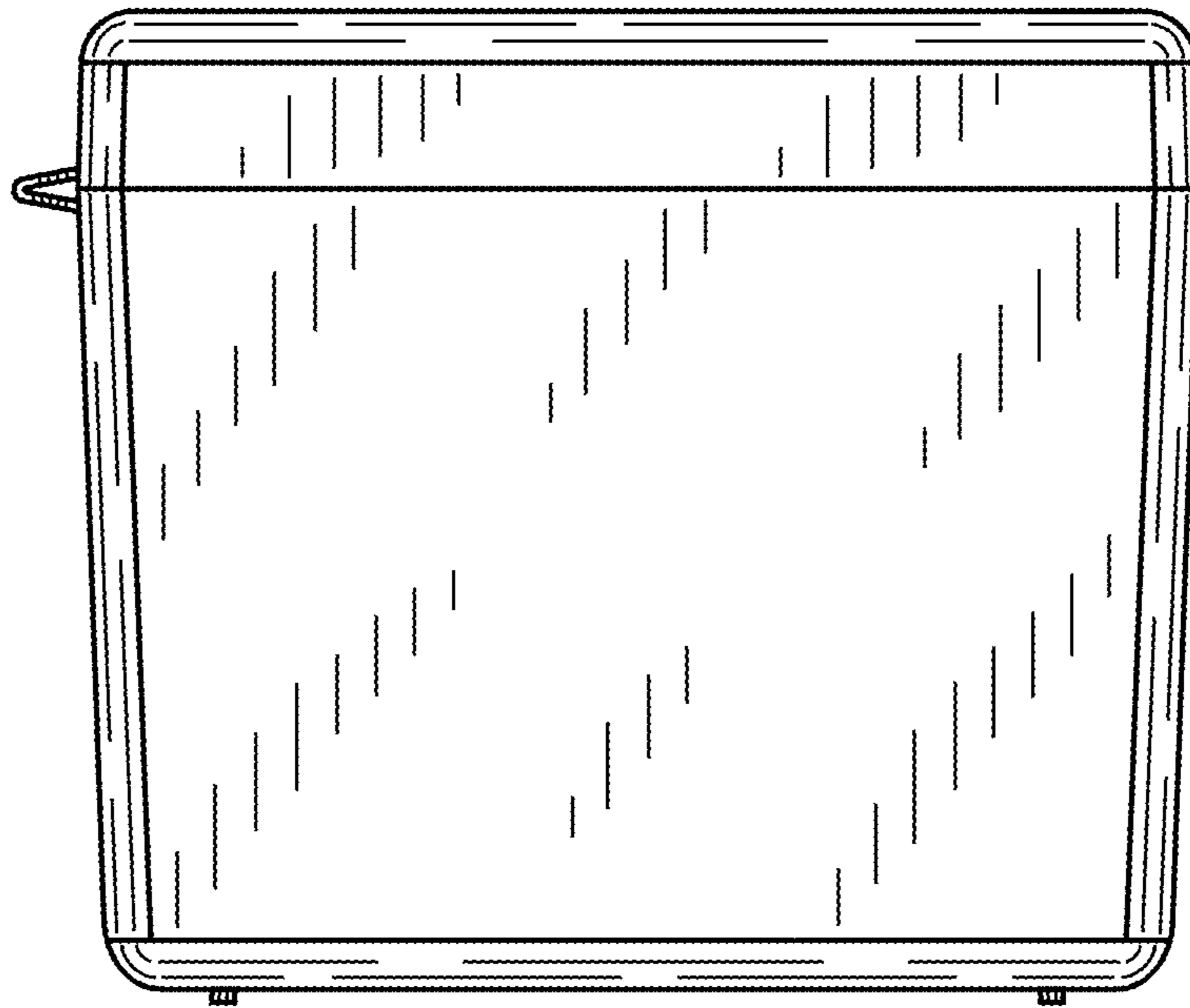

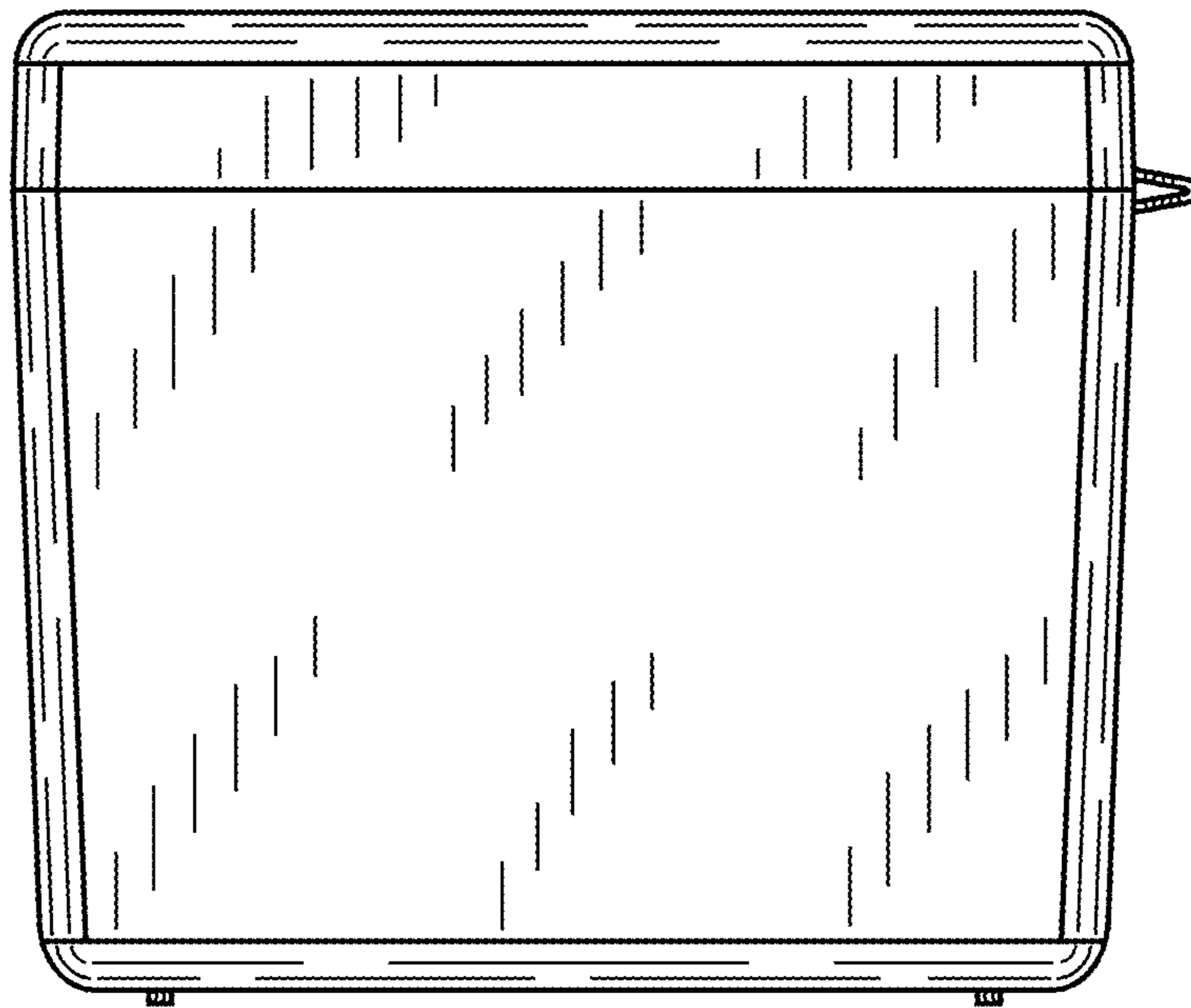

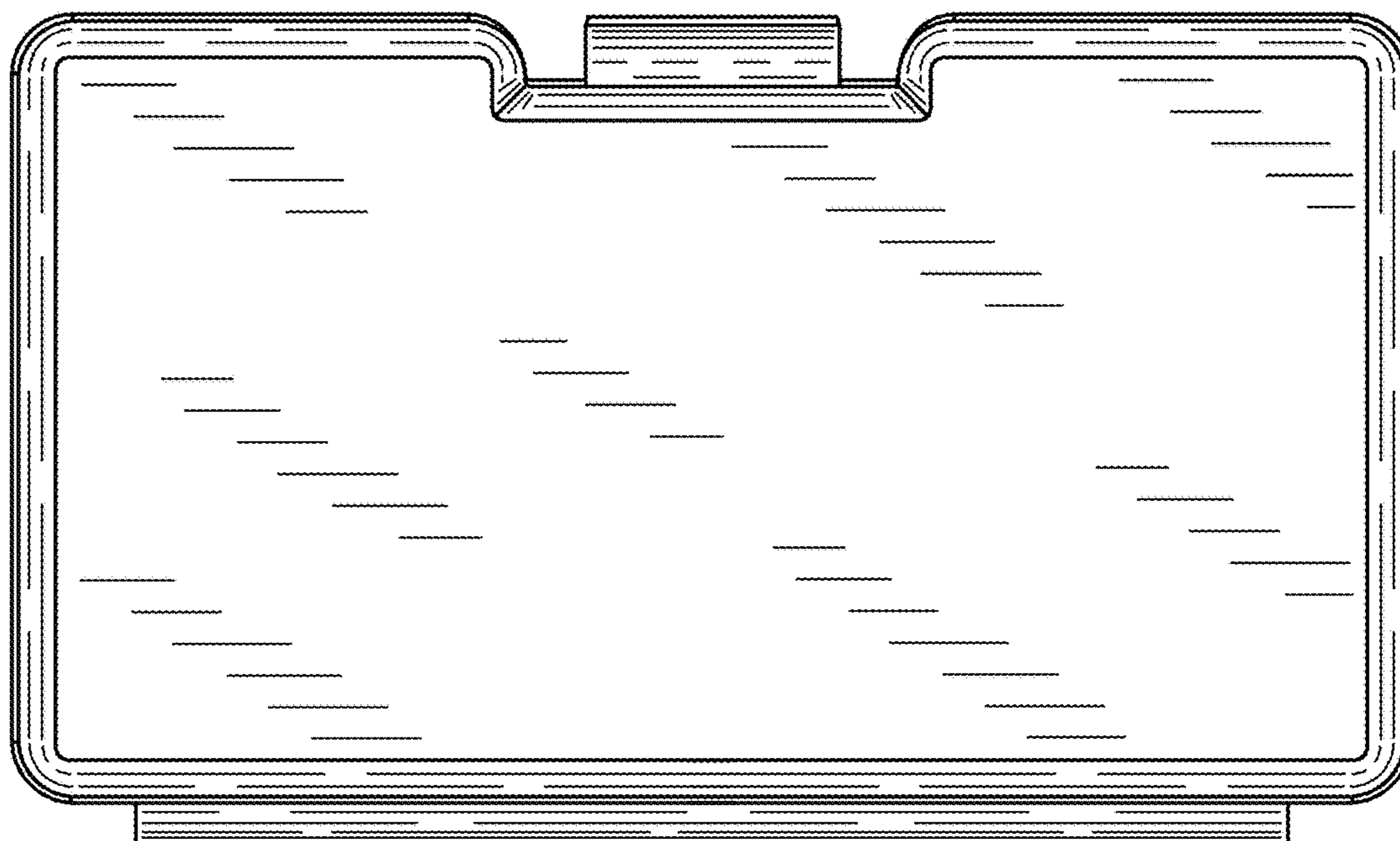

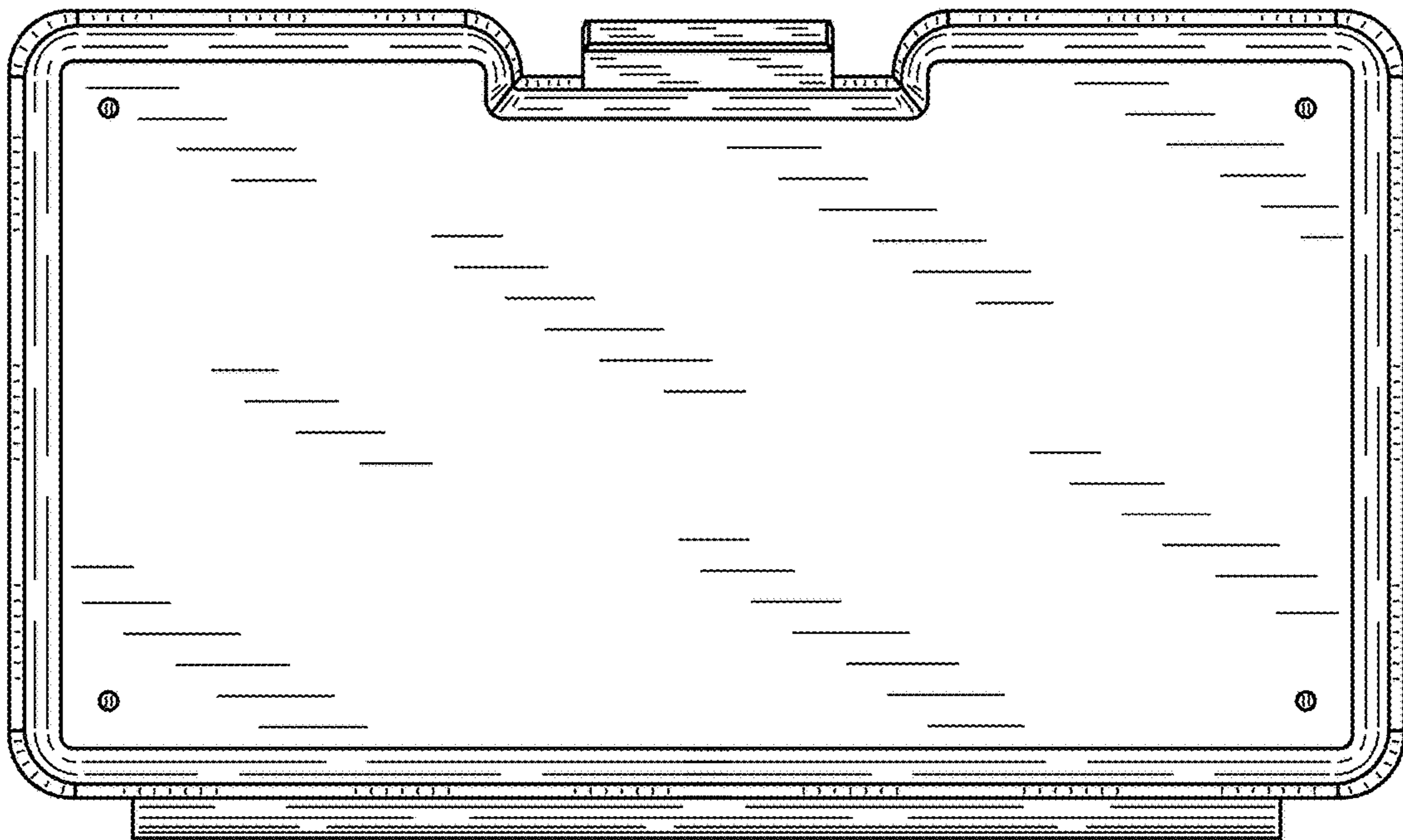
