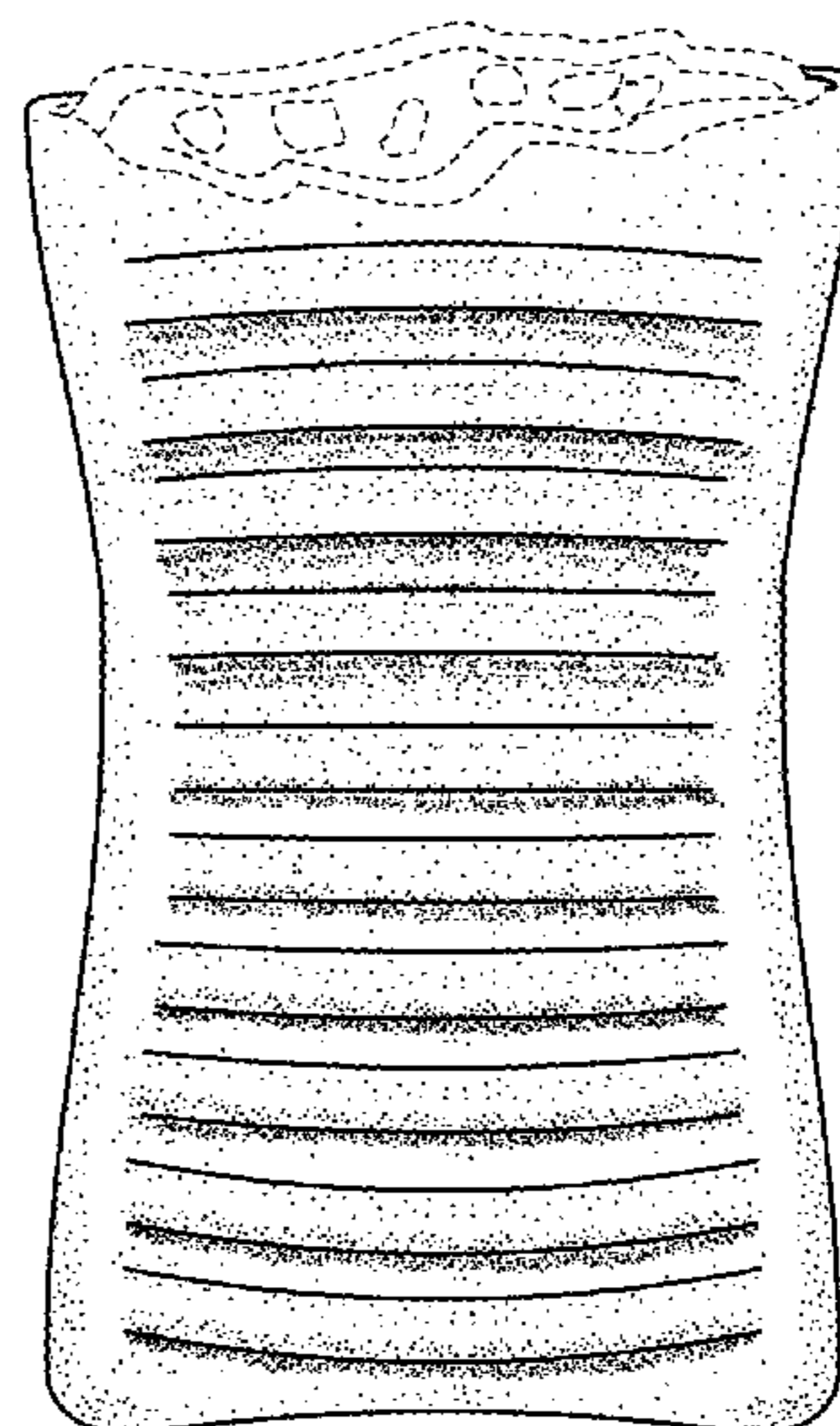
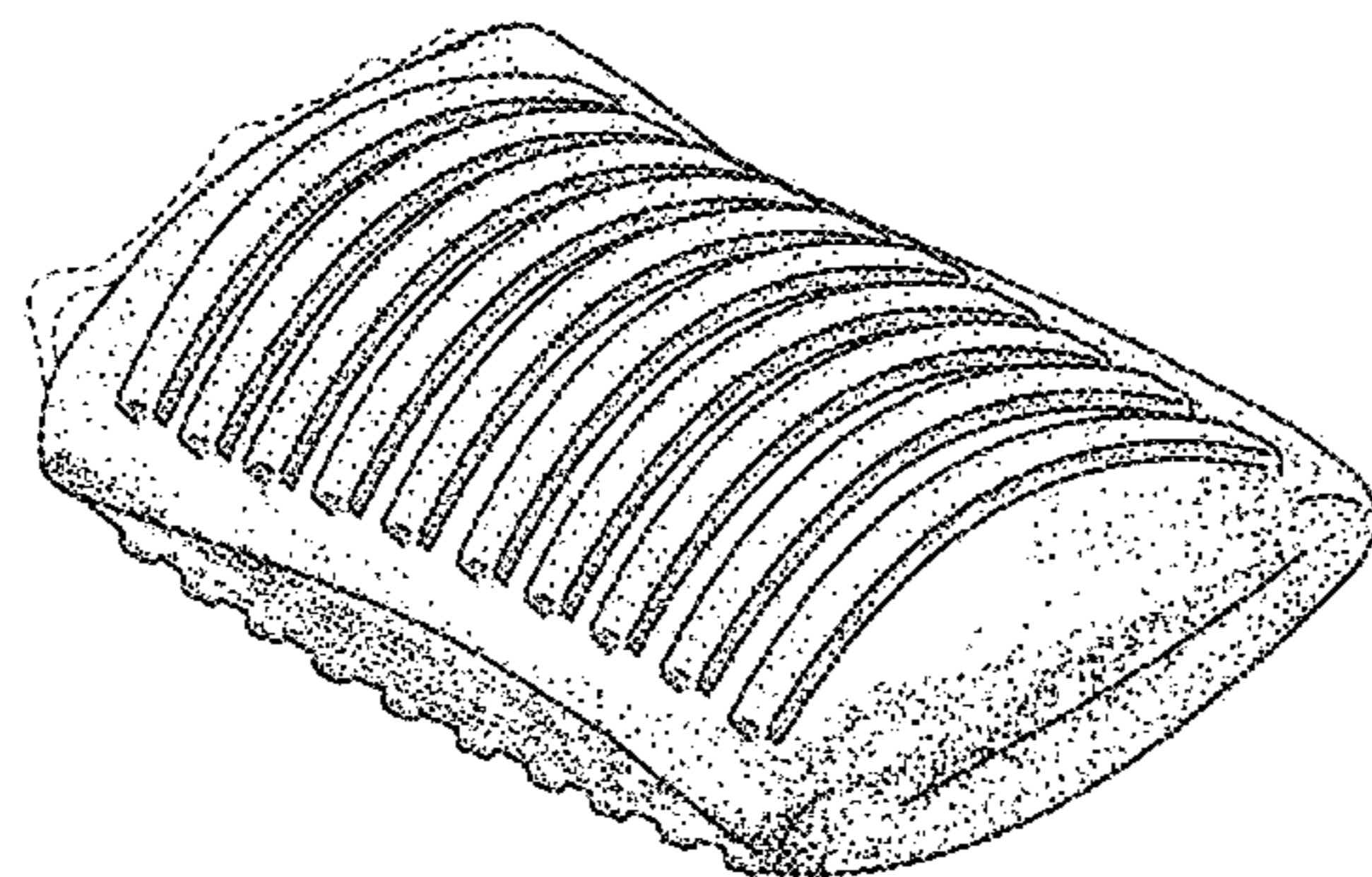
(57) **CLAIM**

The ornamental design for a pizza product, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a pizza product; FIG. 2 is a bottom view of the pizza product of FIG. 1; FIG. 3 is a top view of the pizza product of FIG. 1; FIG. 4 is a left side view of the pizza product of FIG. 1; FIG. 5 is a right side view of the pizza product of FIG. 1; FIG. 6 is a back end perspective view of the pizza product of FIG. 1; and, FIG. 7 is a front end perspective view of the pizza product of FIG. 1. The broken lines in FIGS. 1-6 illustrate portions of the pizza product that form no part of the claimed design.

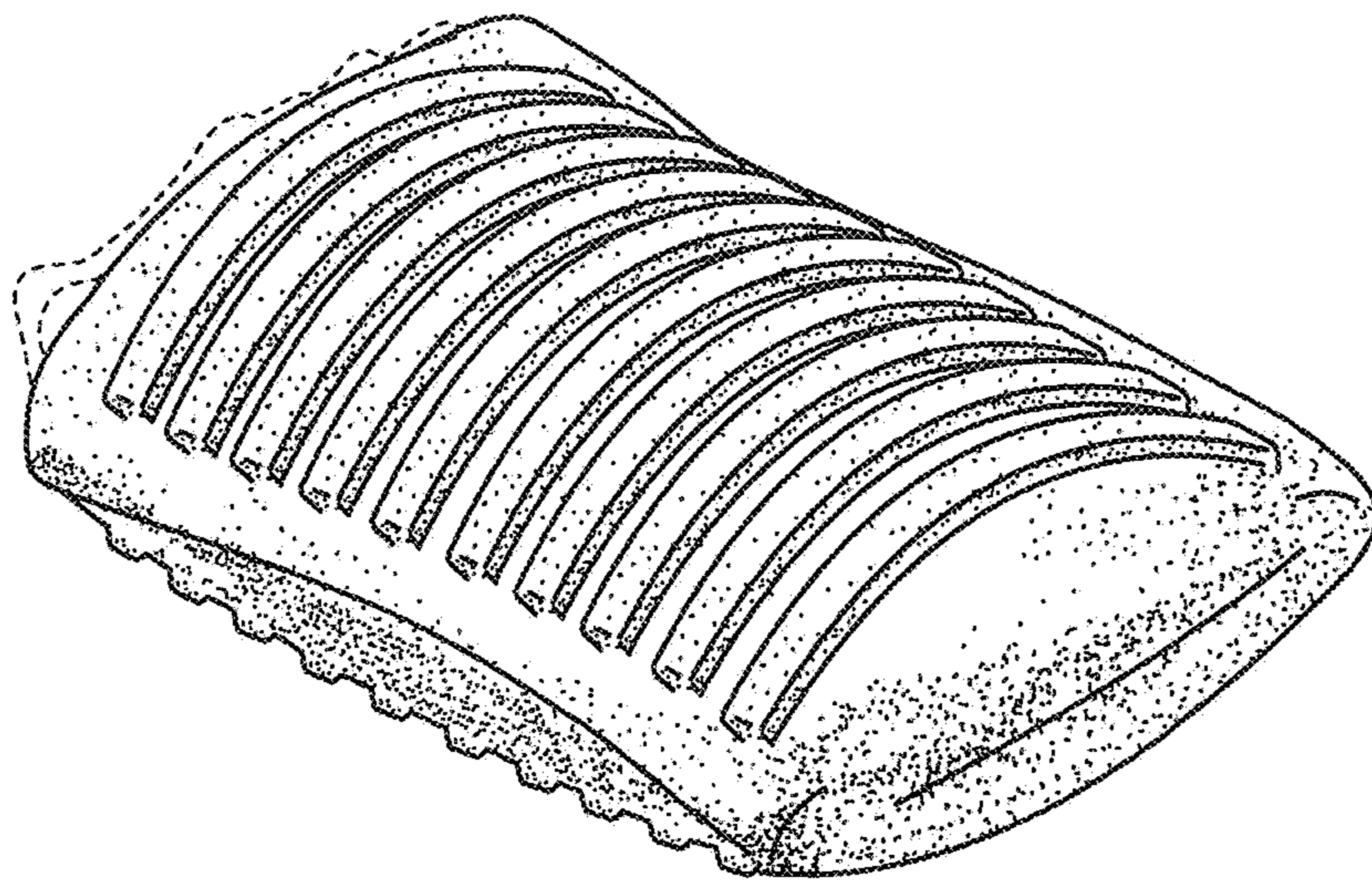

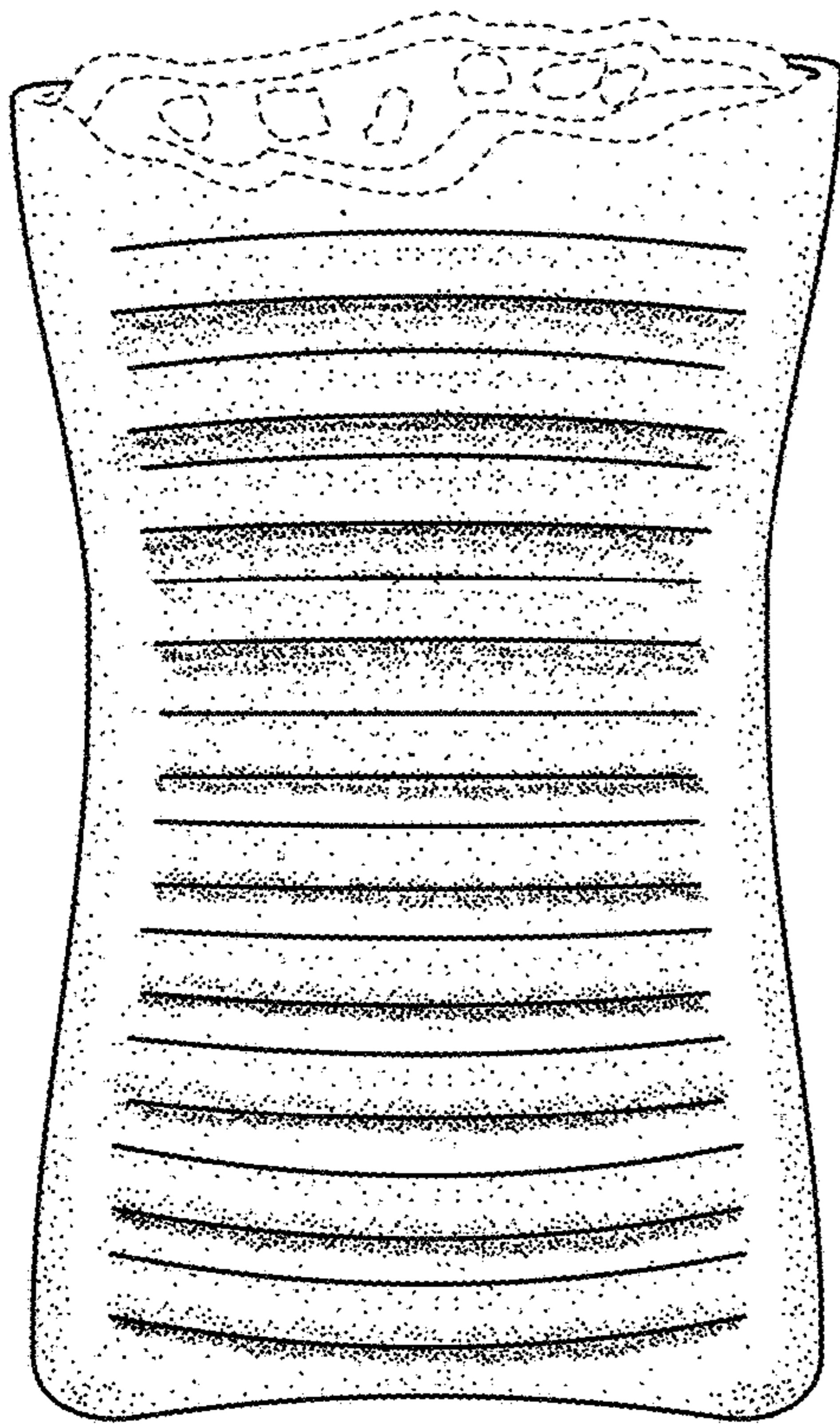

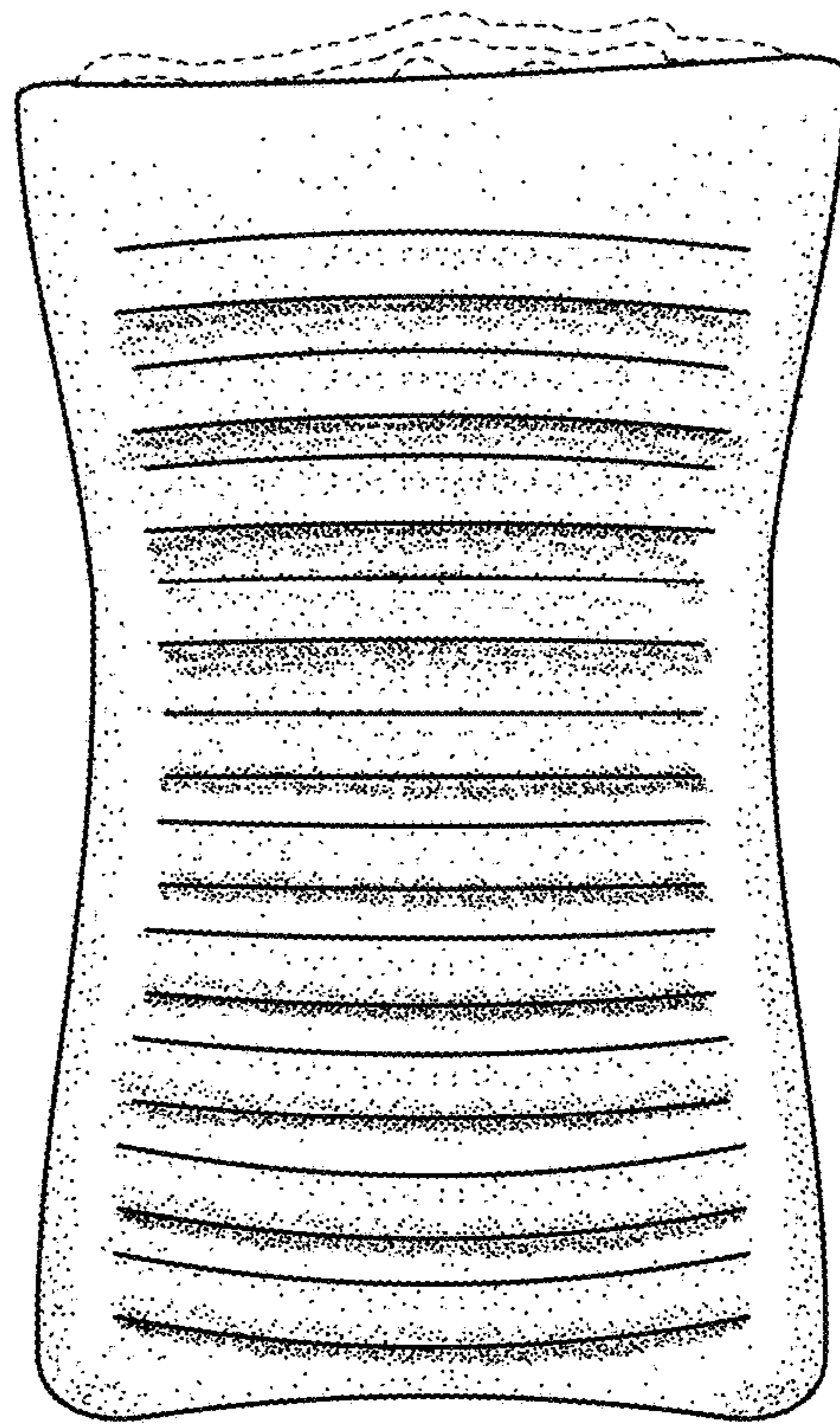
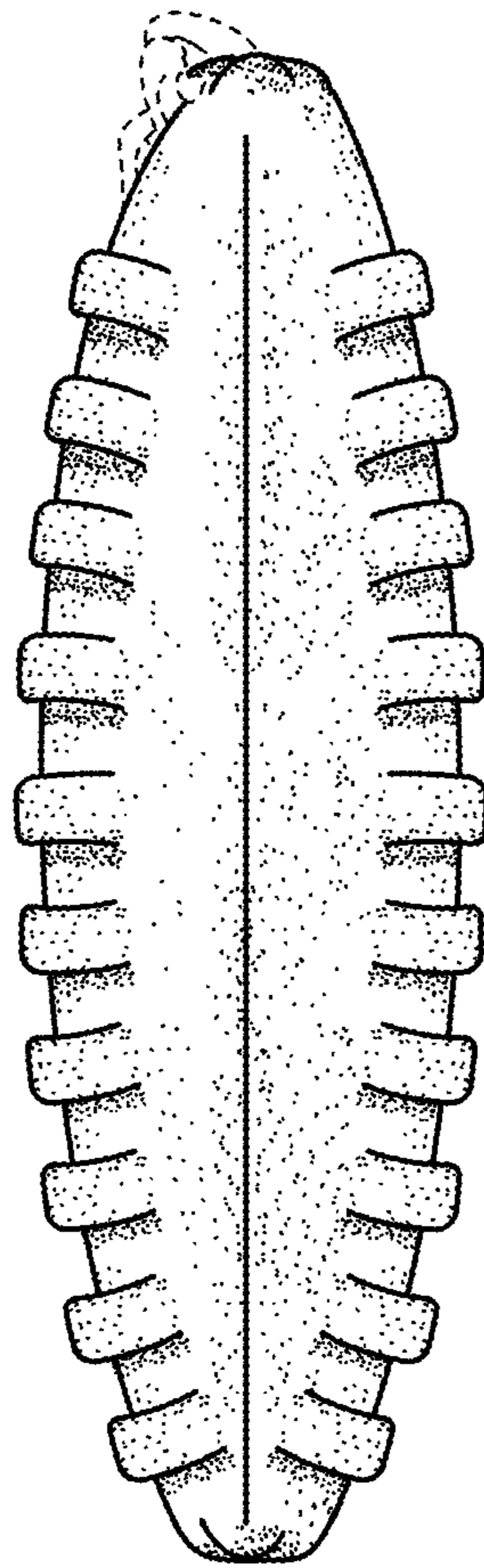
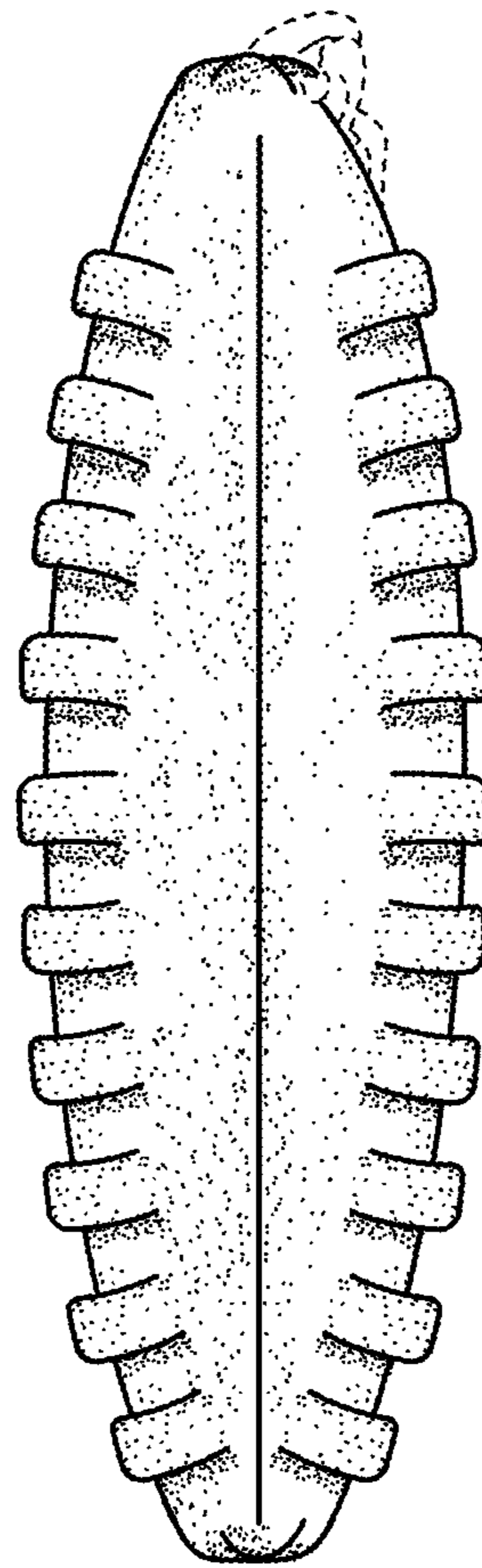


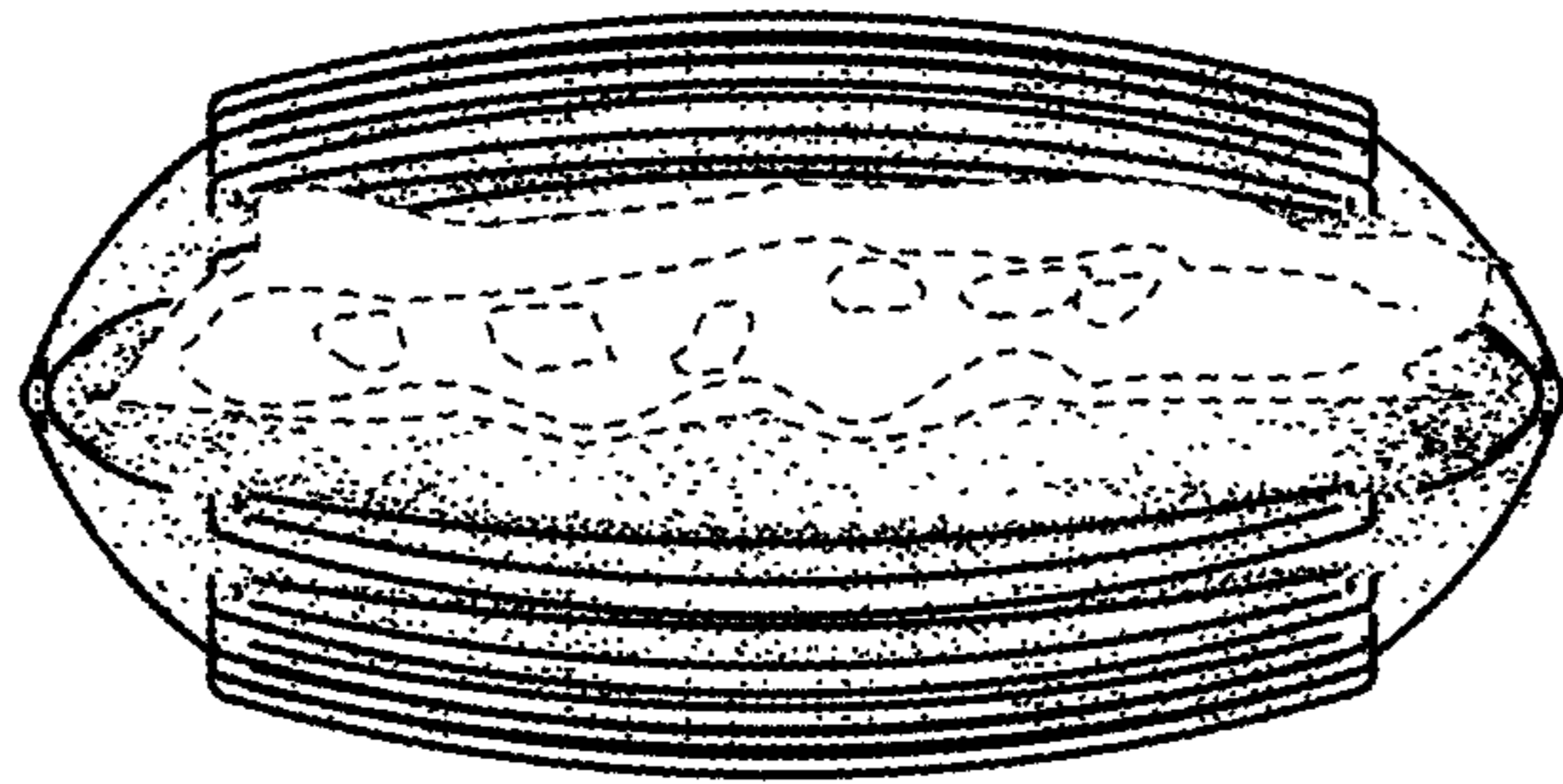

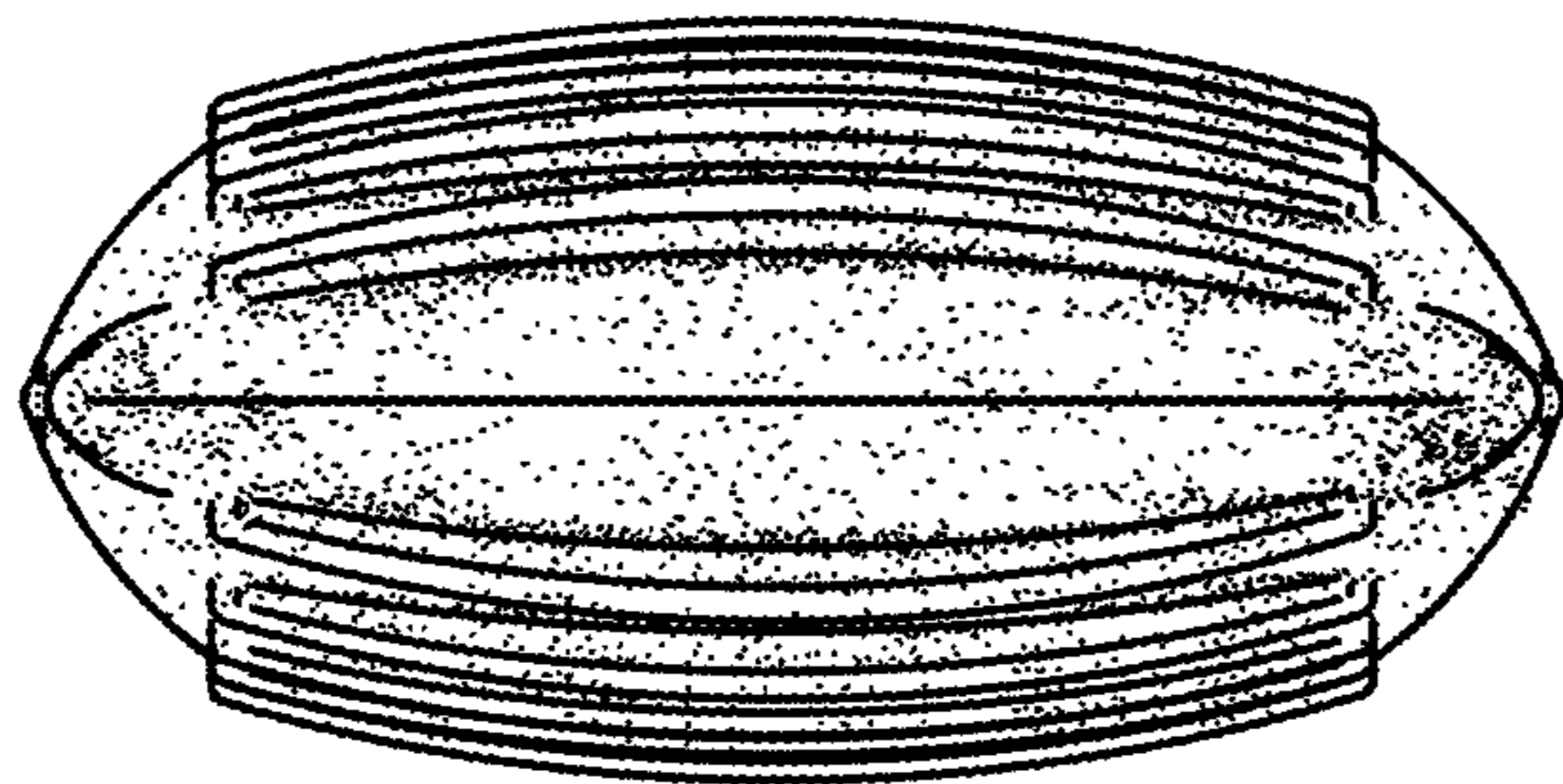
