FIG. 1 is a front view of a decorative bra attachment showing my new design, a rear view being identical;

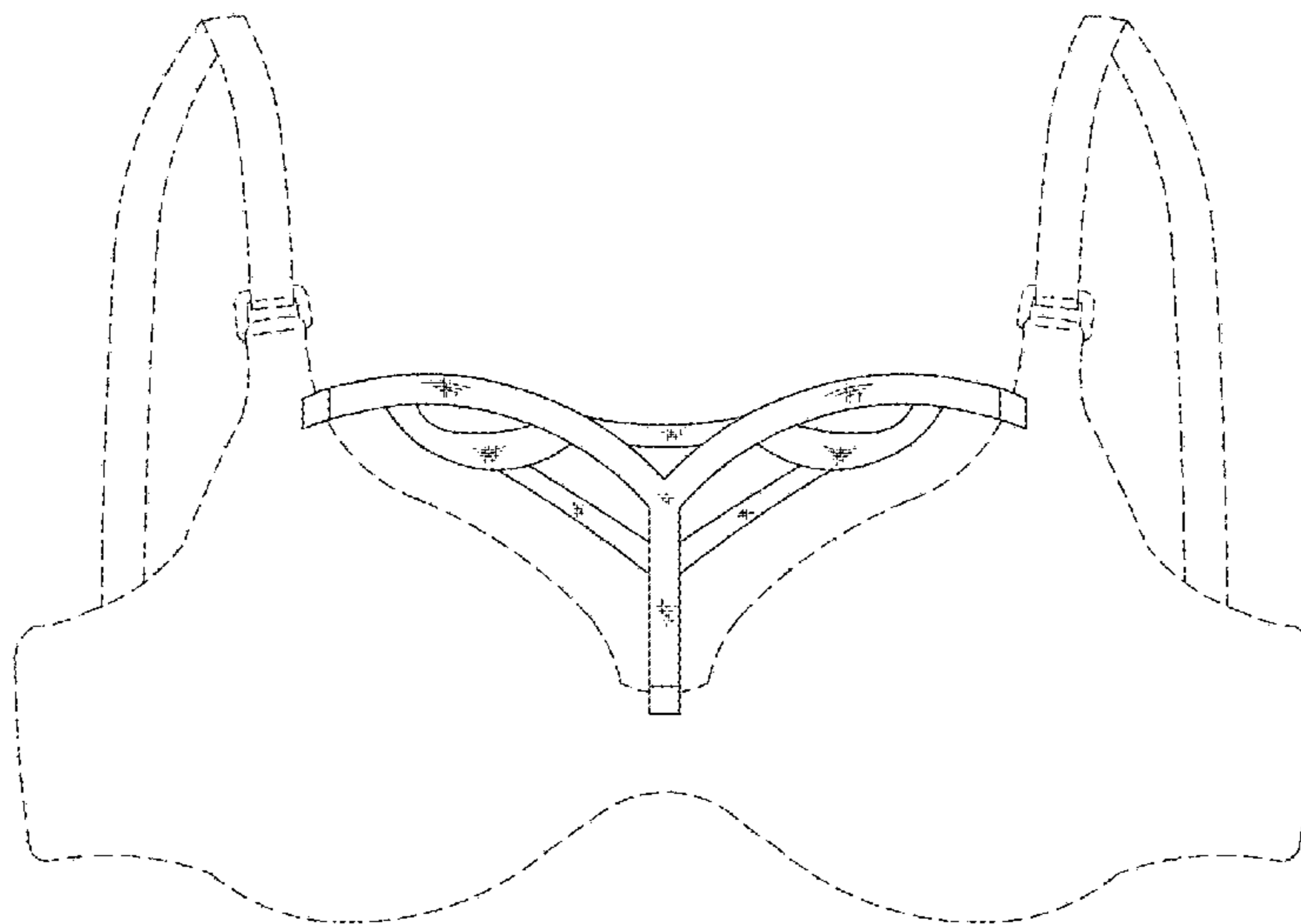
FIG. 2 is a left side view of the decorative bra attachment, a right side view being identical;

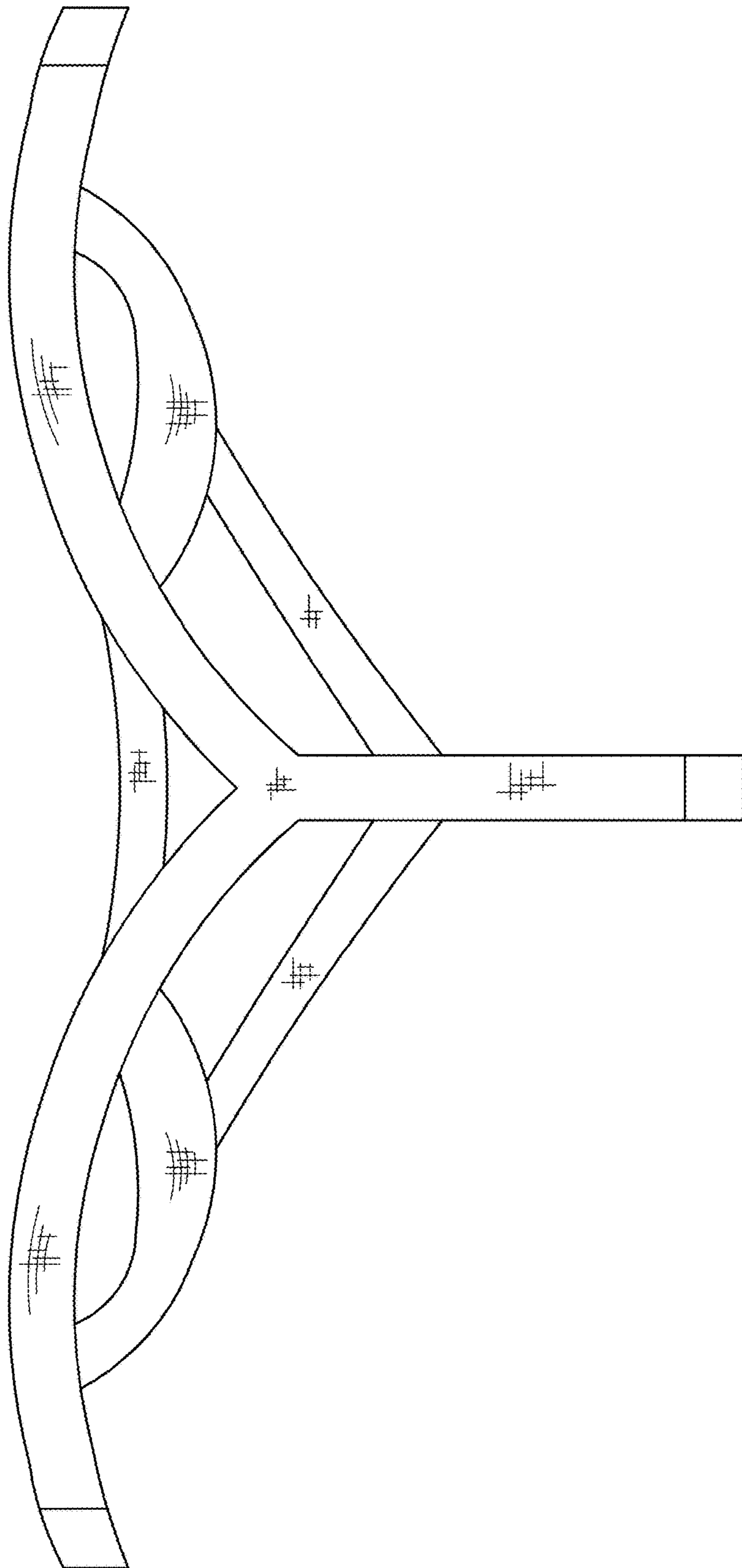

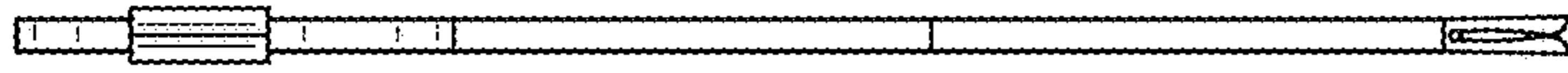

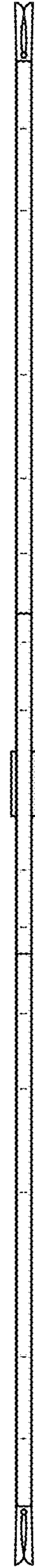
