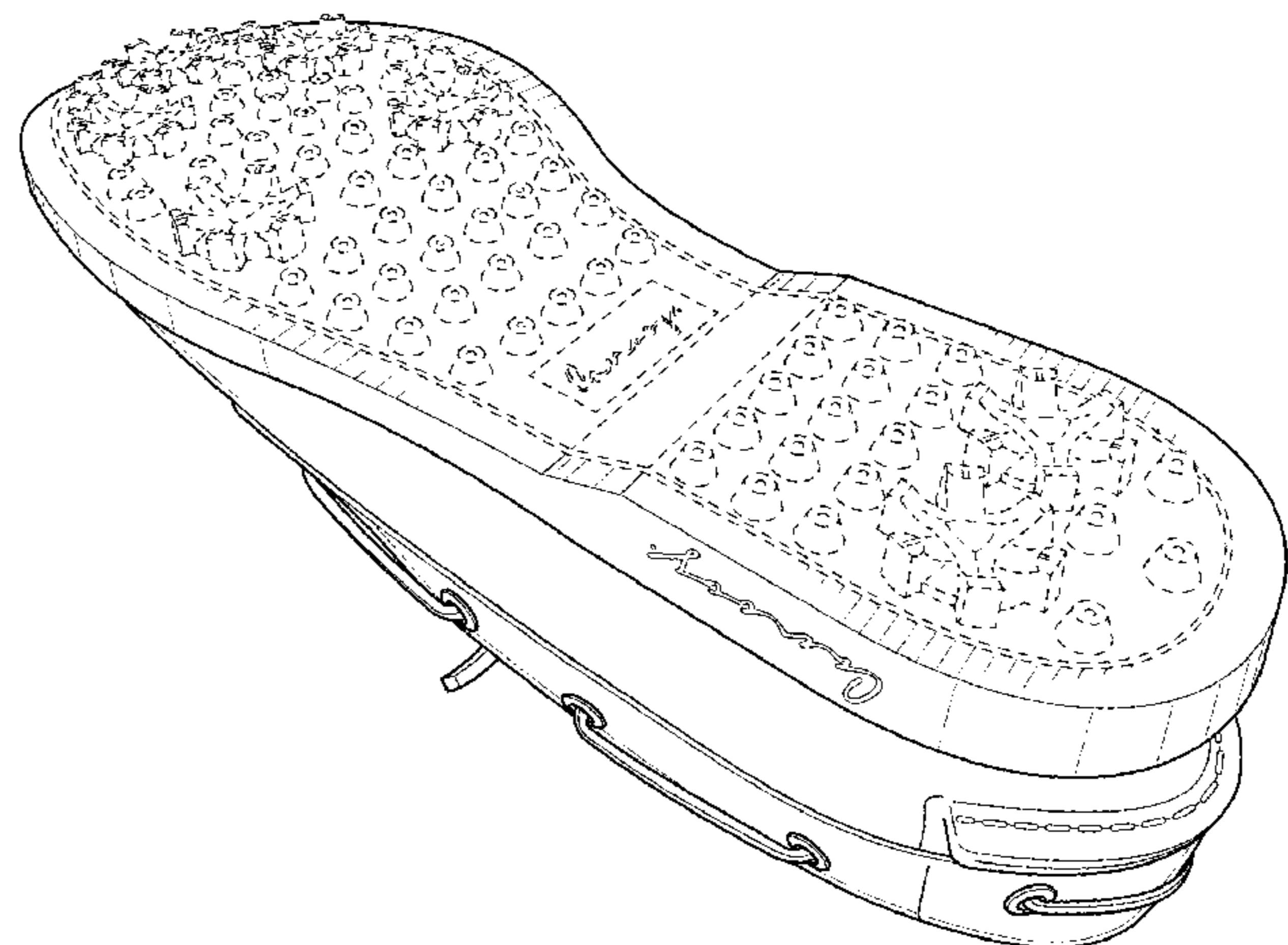
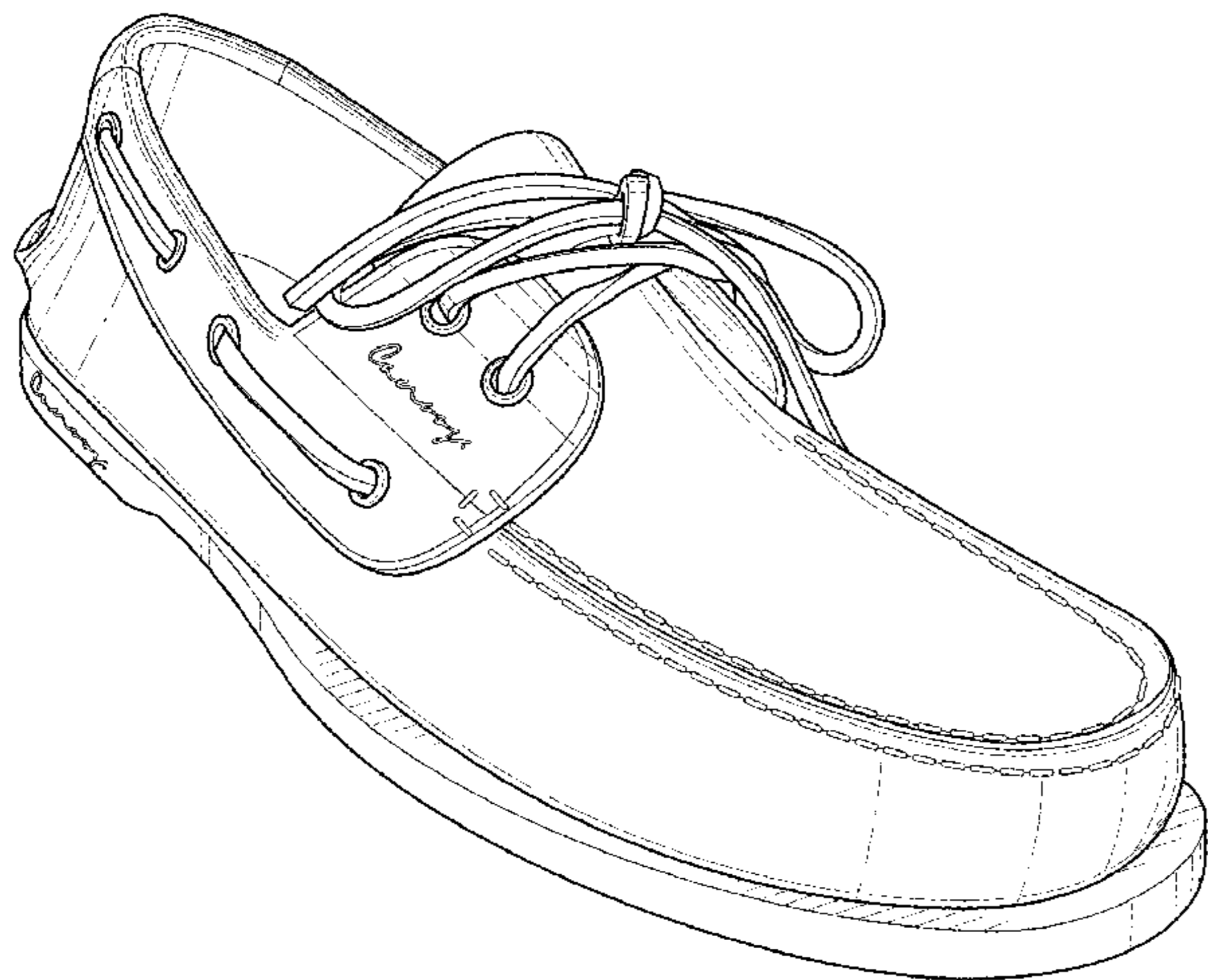
(57) **CLAIM**

The ornamental design for a golf shoe, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a top, left, front perspective view of a golf shoe showing our new design;  
FIG. 2 is a bottom, right, back perspective view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a left side elevational view thereof;  
FIG. 7 is a front elevational view thereof; and,  
FIG. 8 is a rear elevational view thereof.  
FIGS. 1-8 illustrate a right golf shoe, with the left golf shoe being a mirror image thereof. The broken lines shown in the drawings represent portions of the golf shoe that form no part of the claimed design.

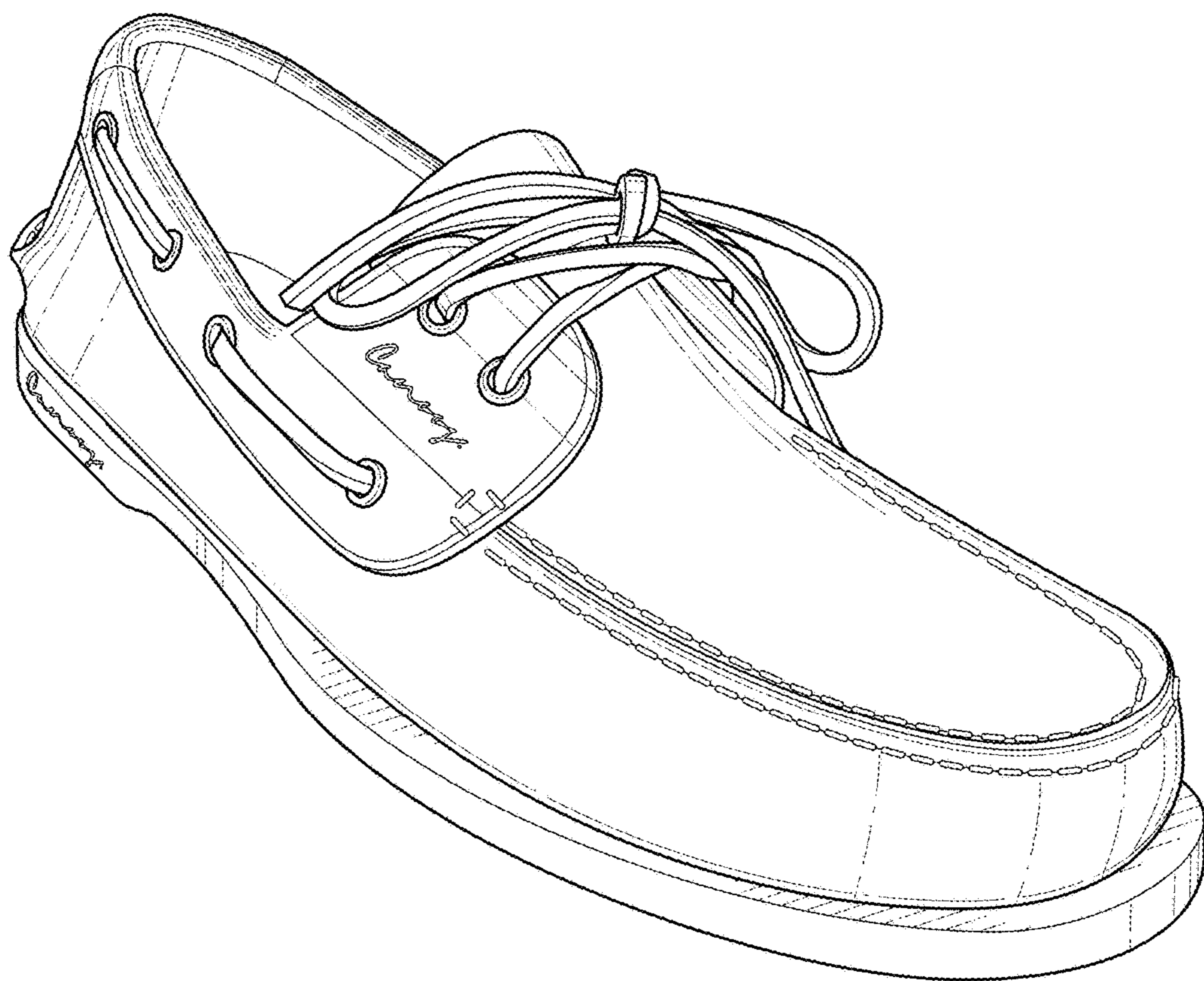

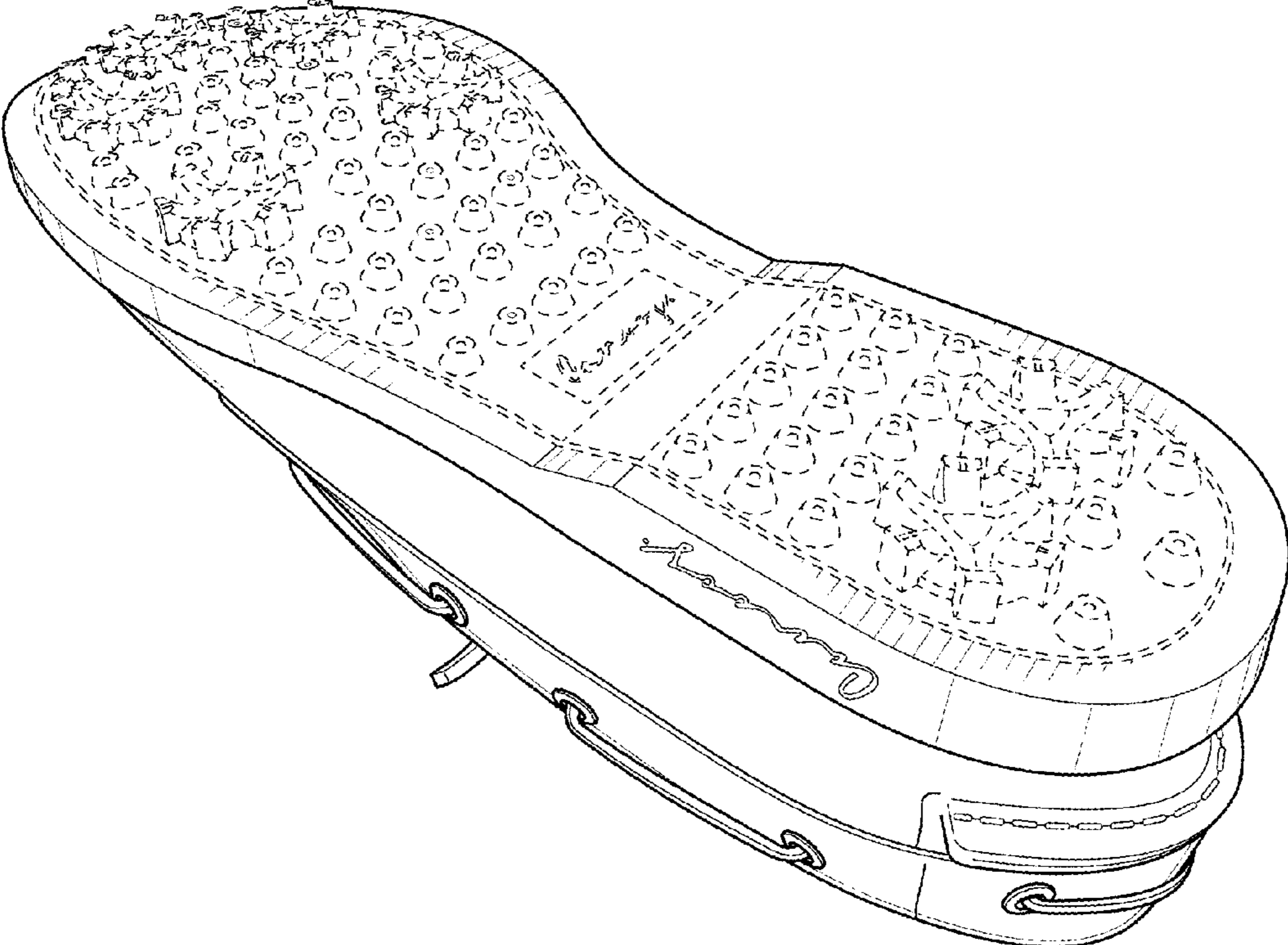

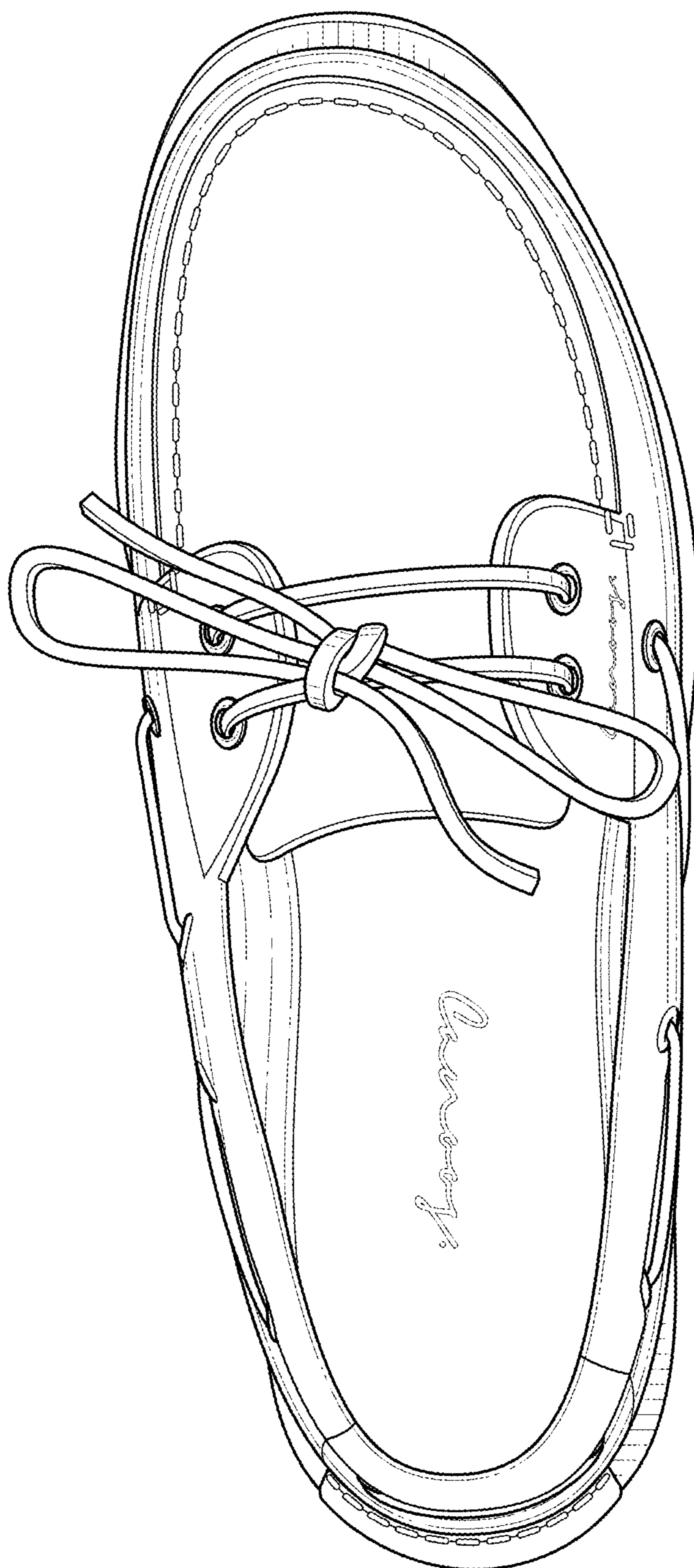

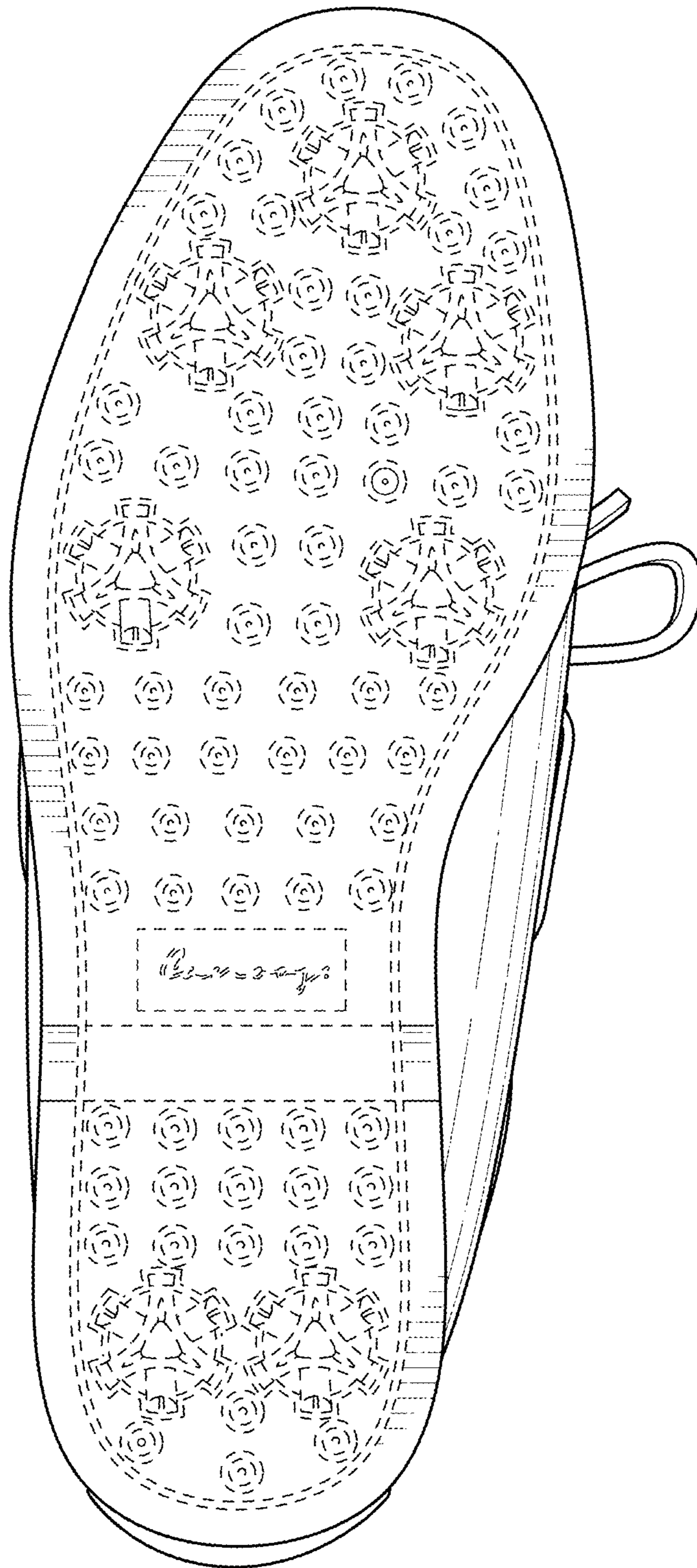
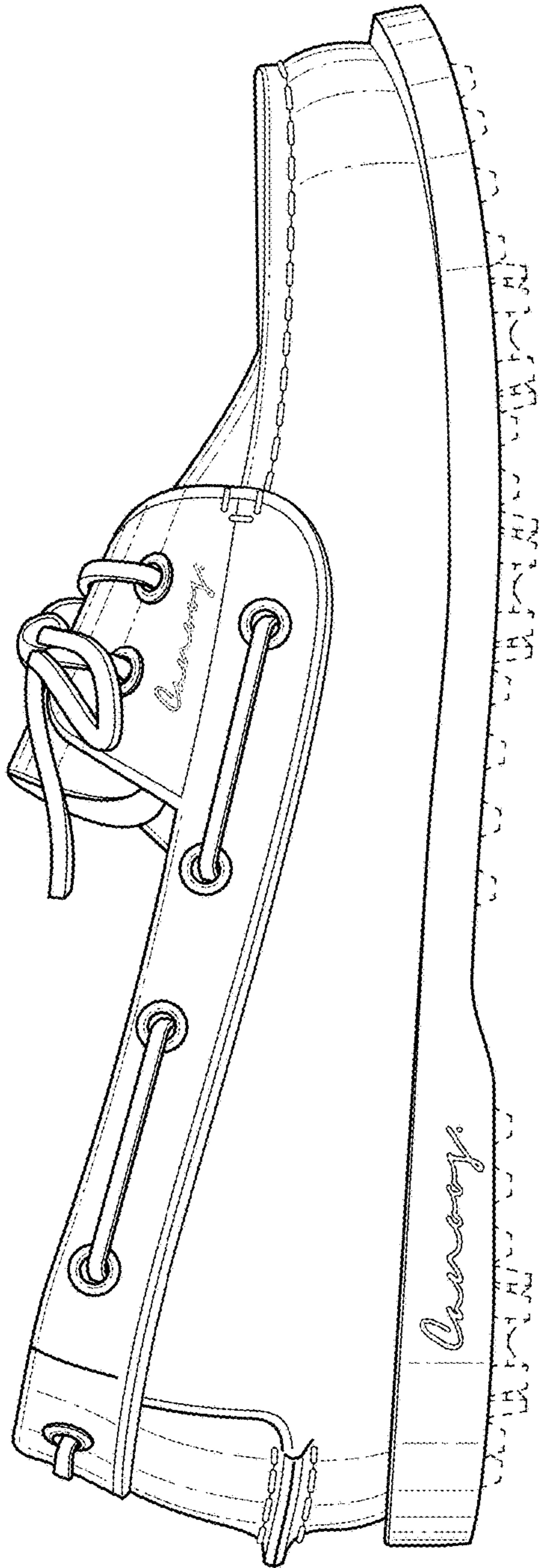
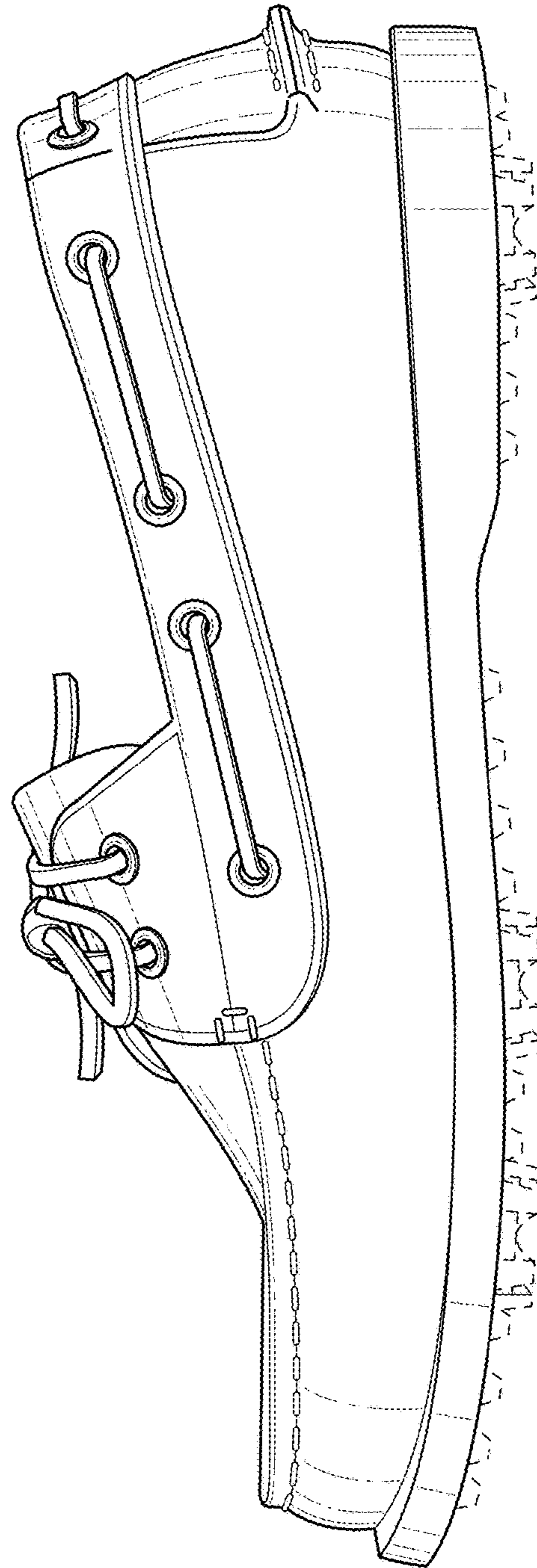

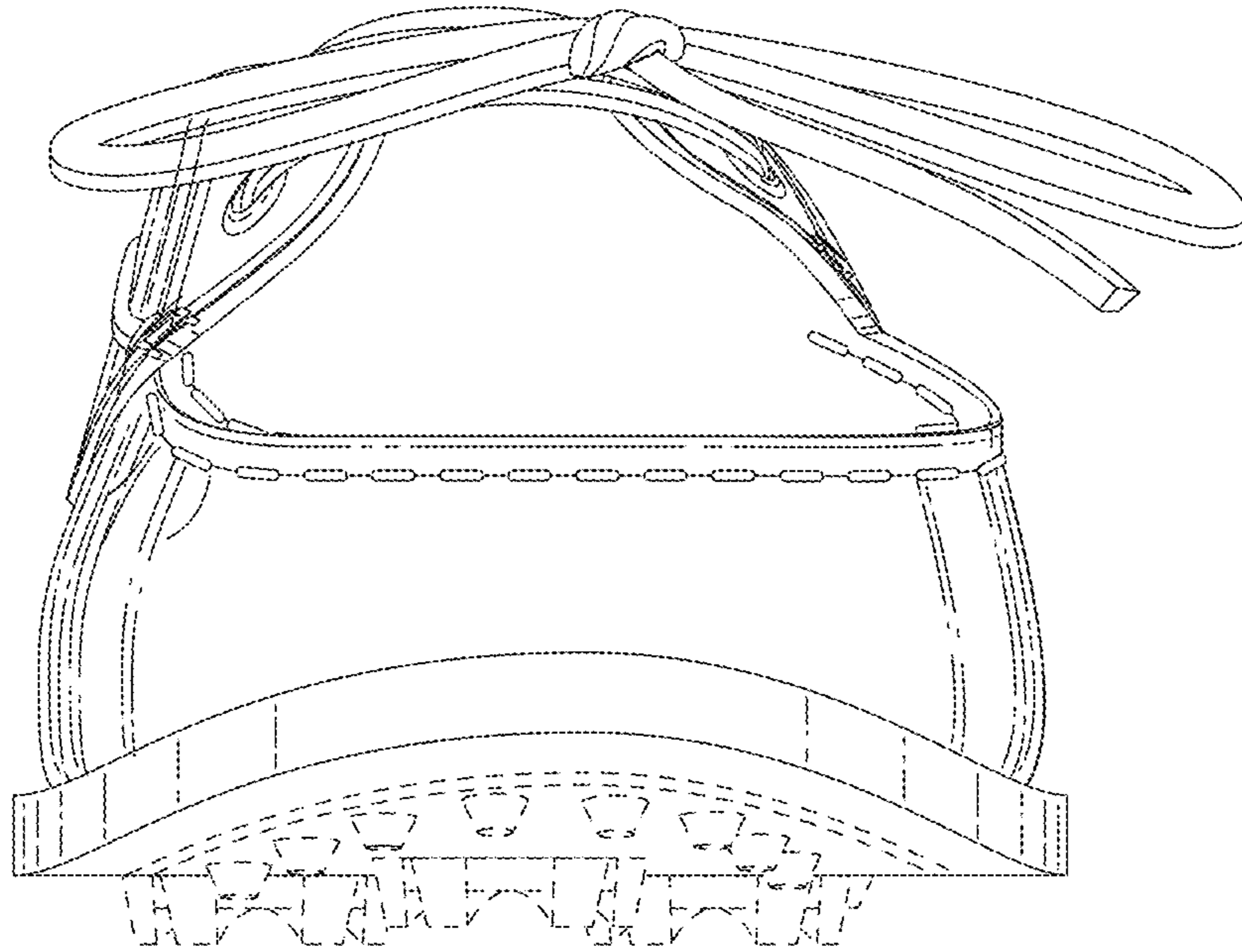

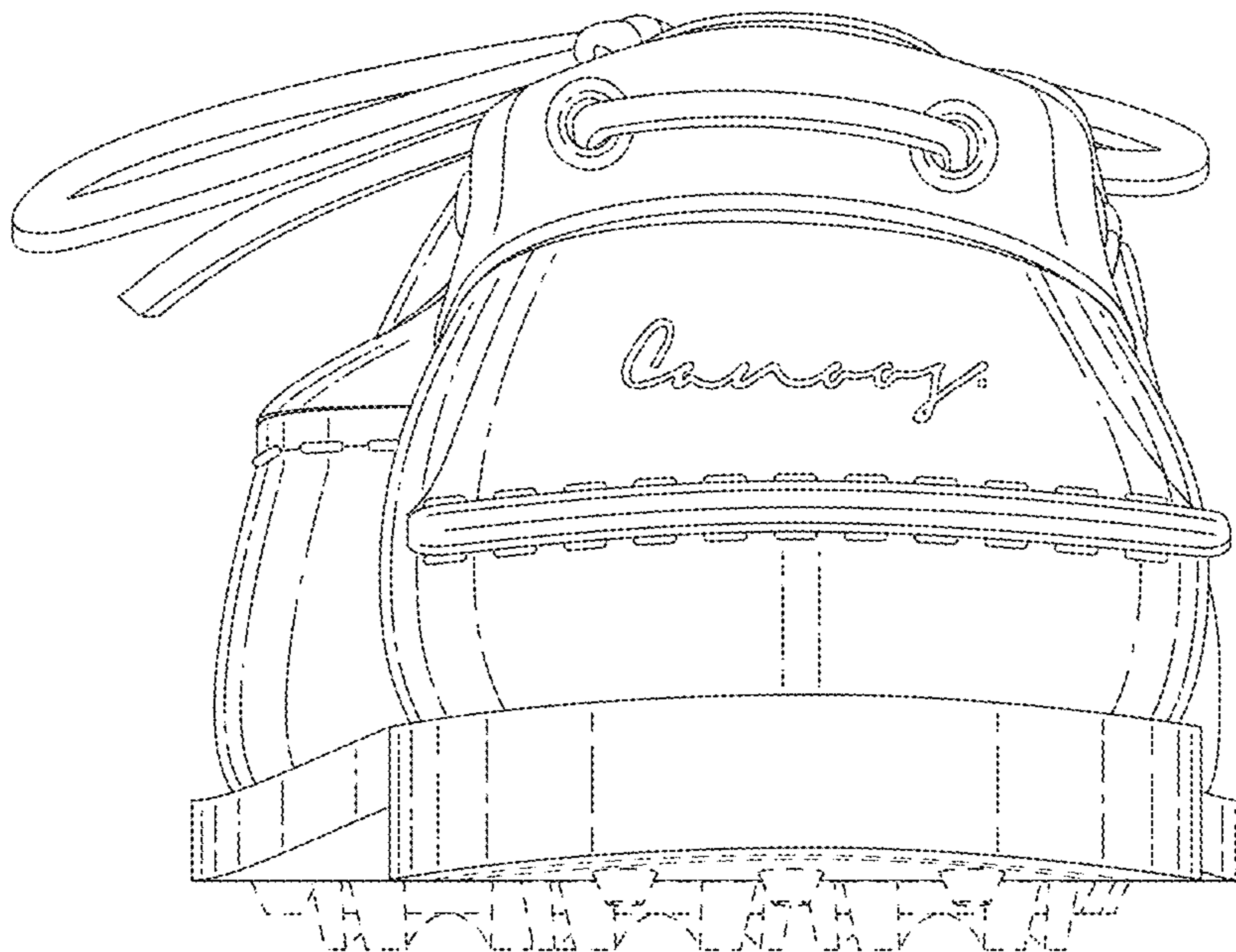
