FIG. 2 is a bottom view thereof;

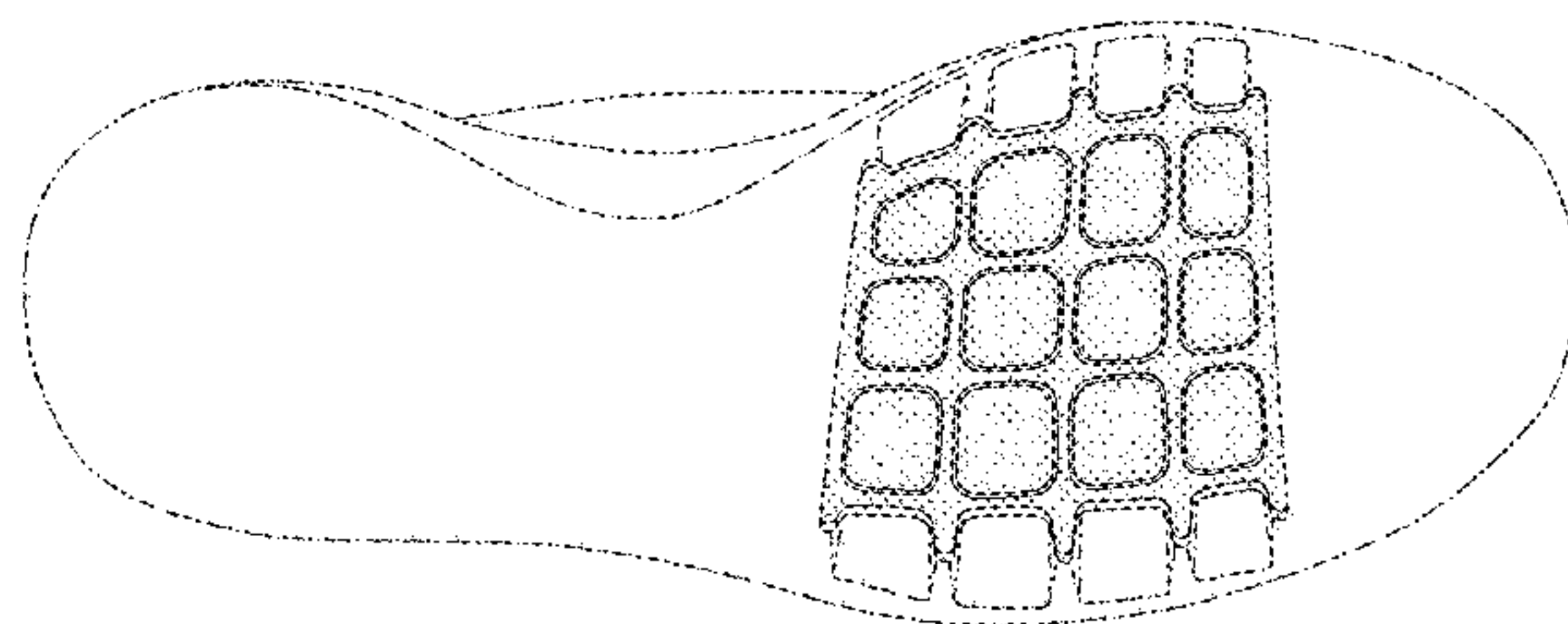
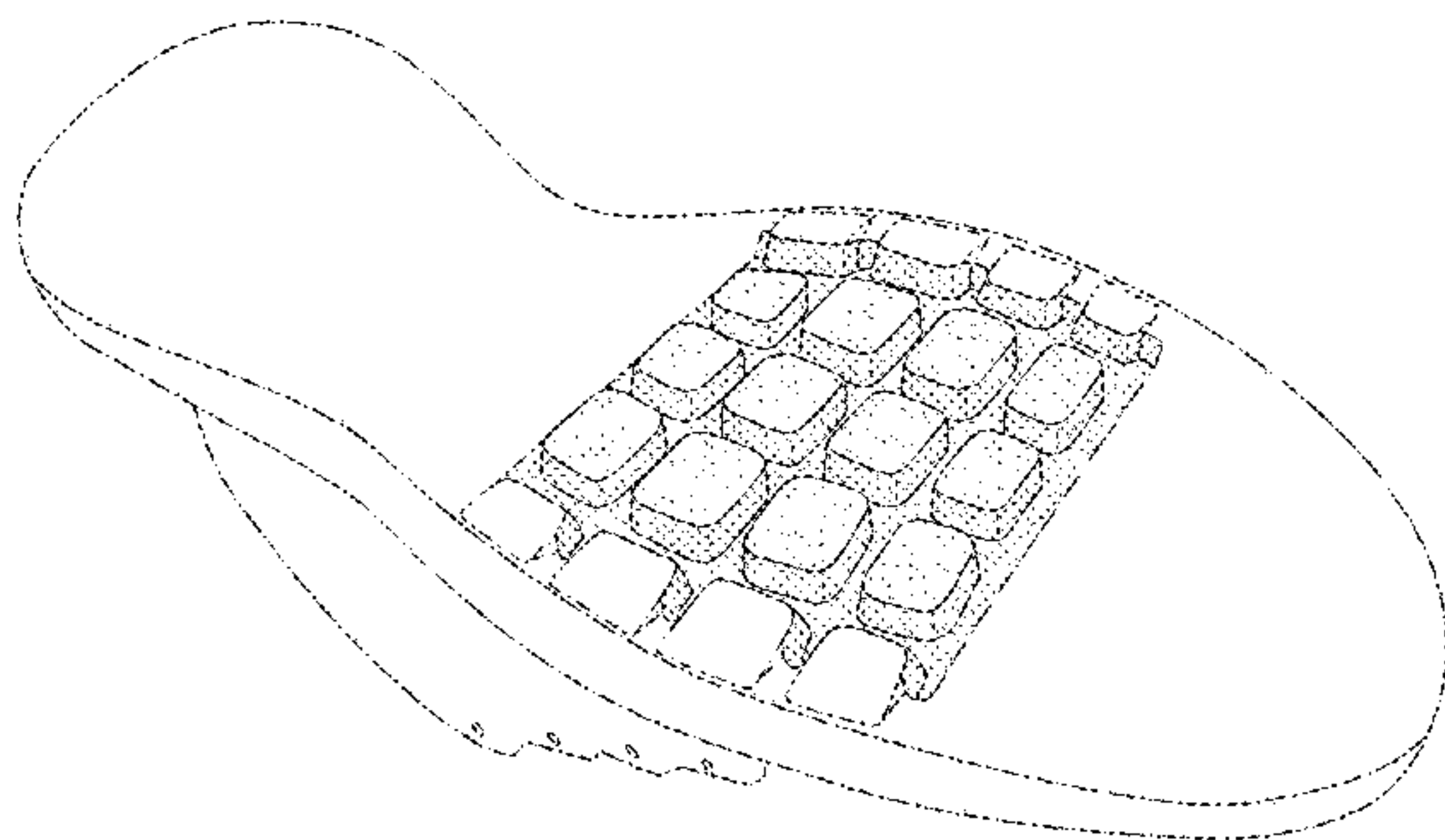
FIG. 3 is a rear perspective view thereof;

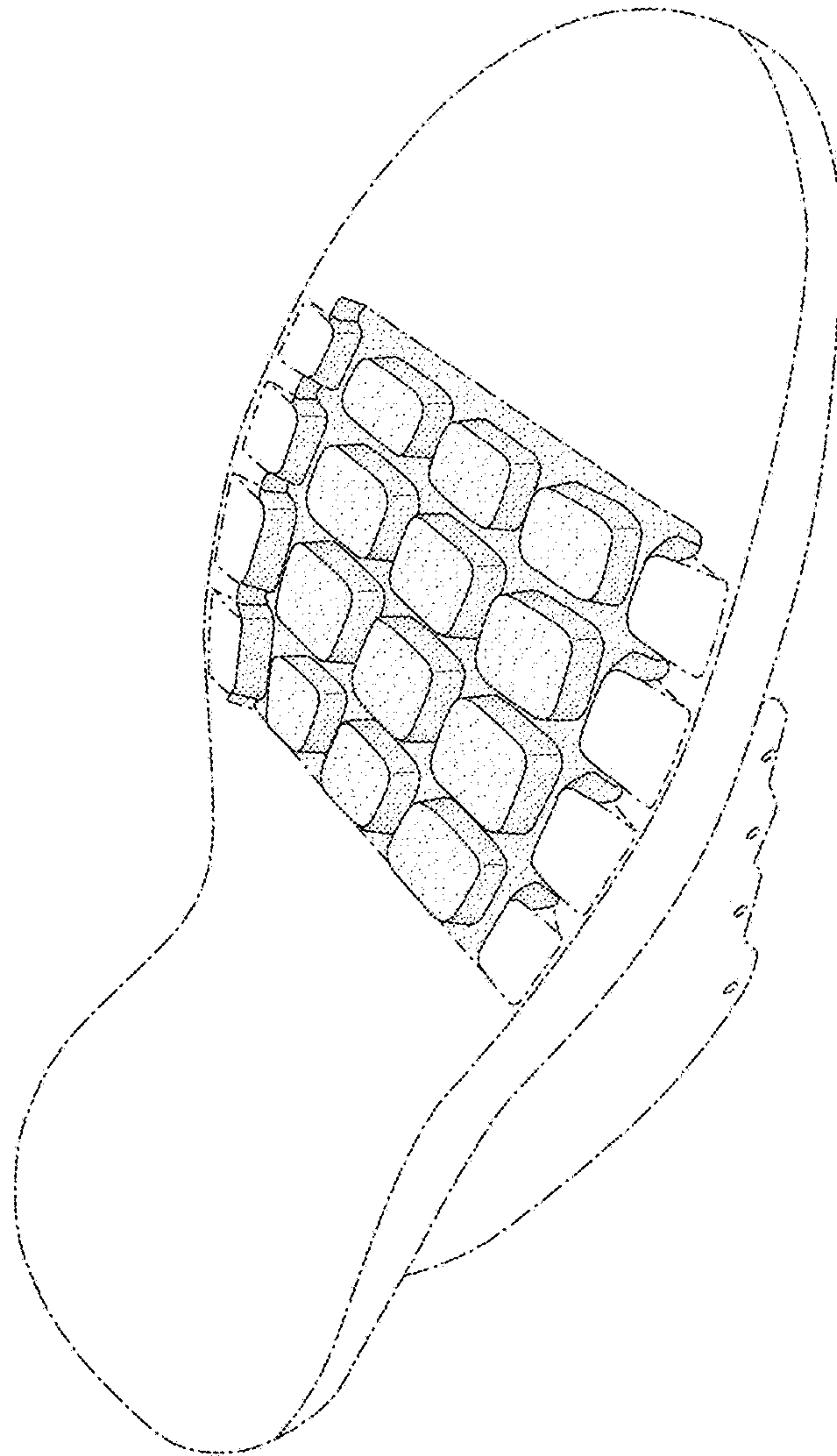

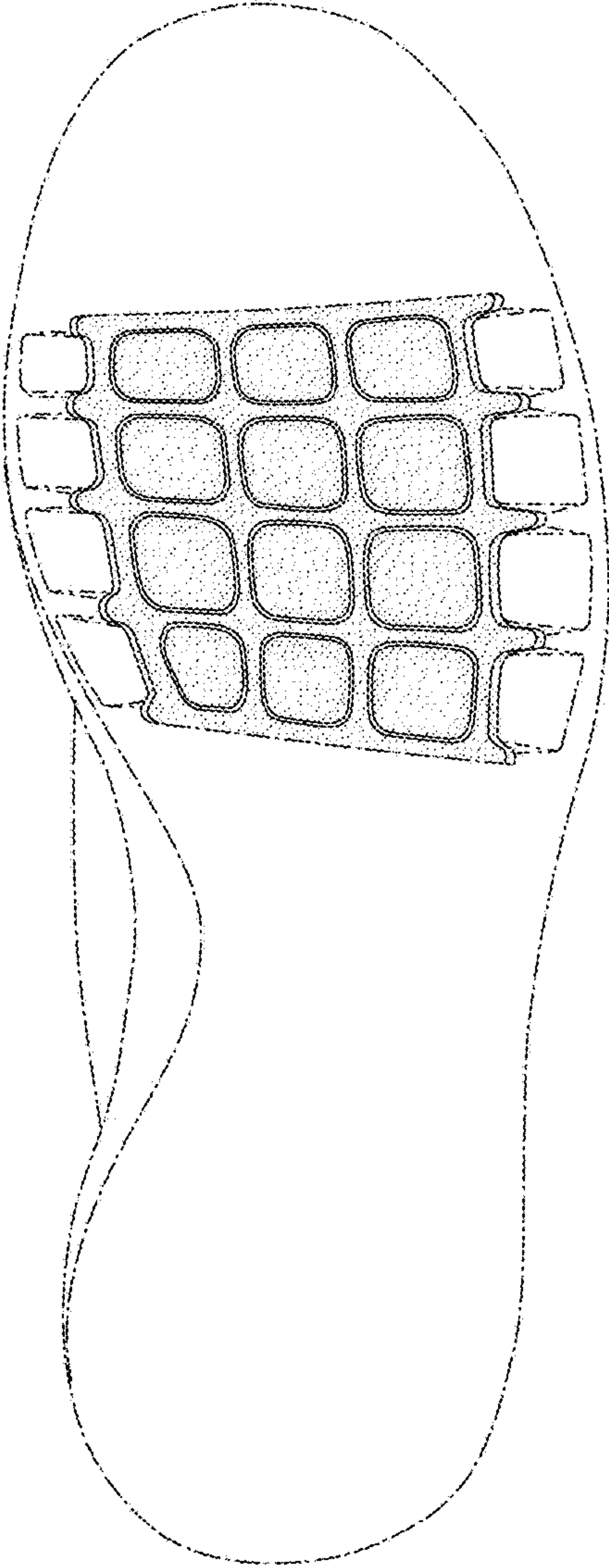

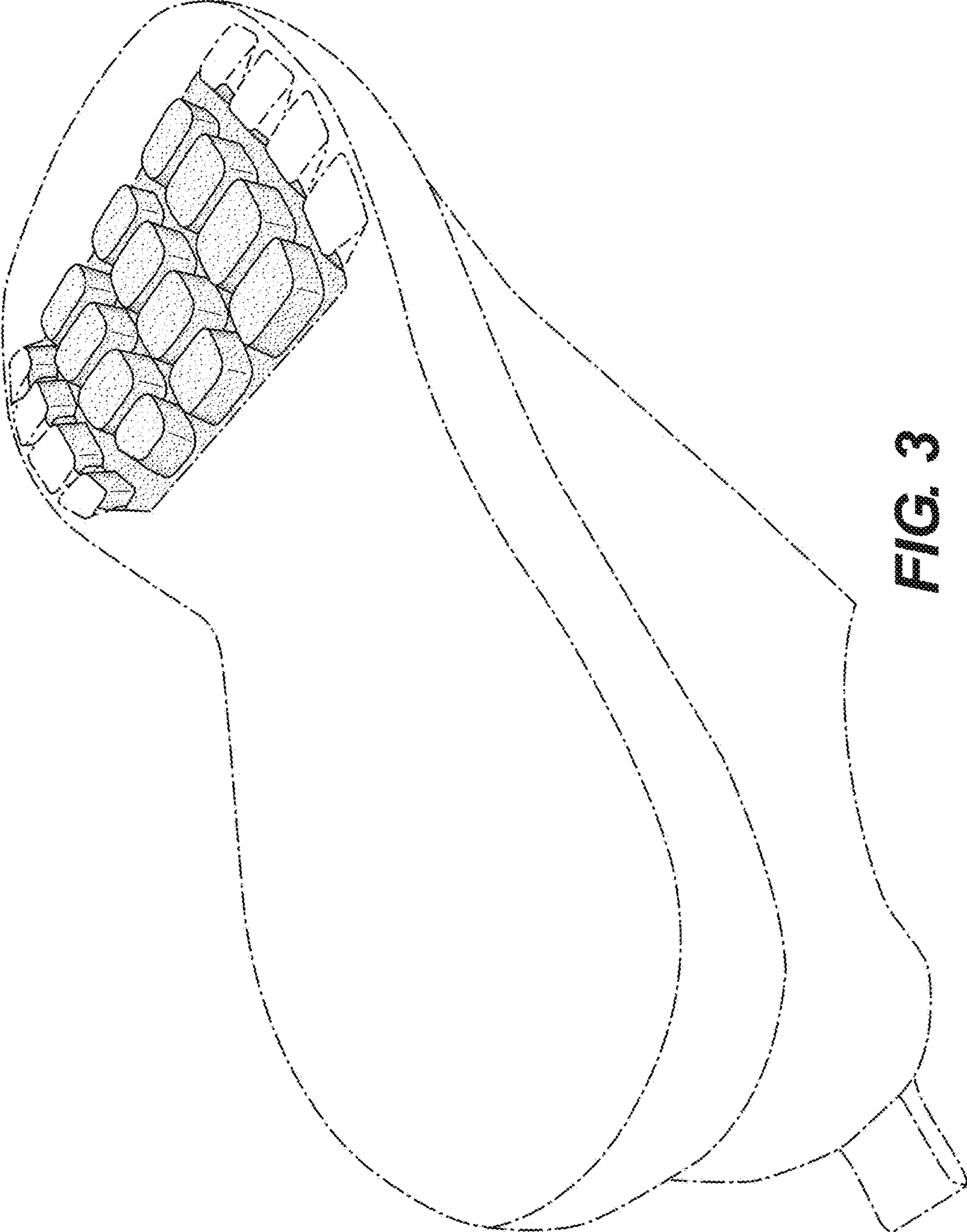

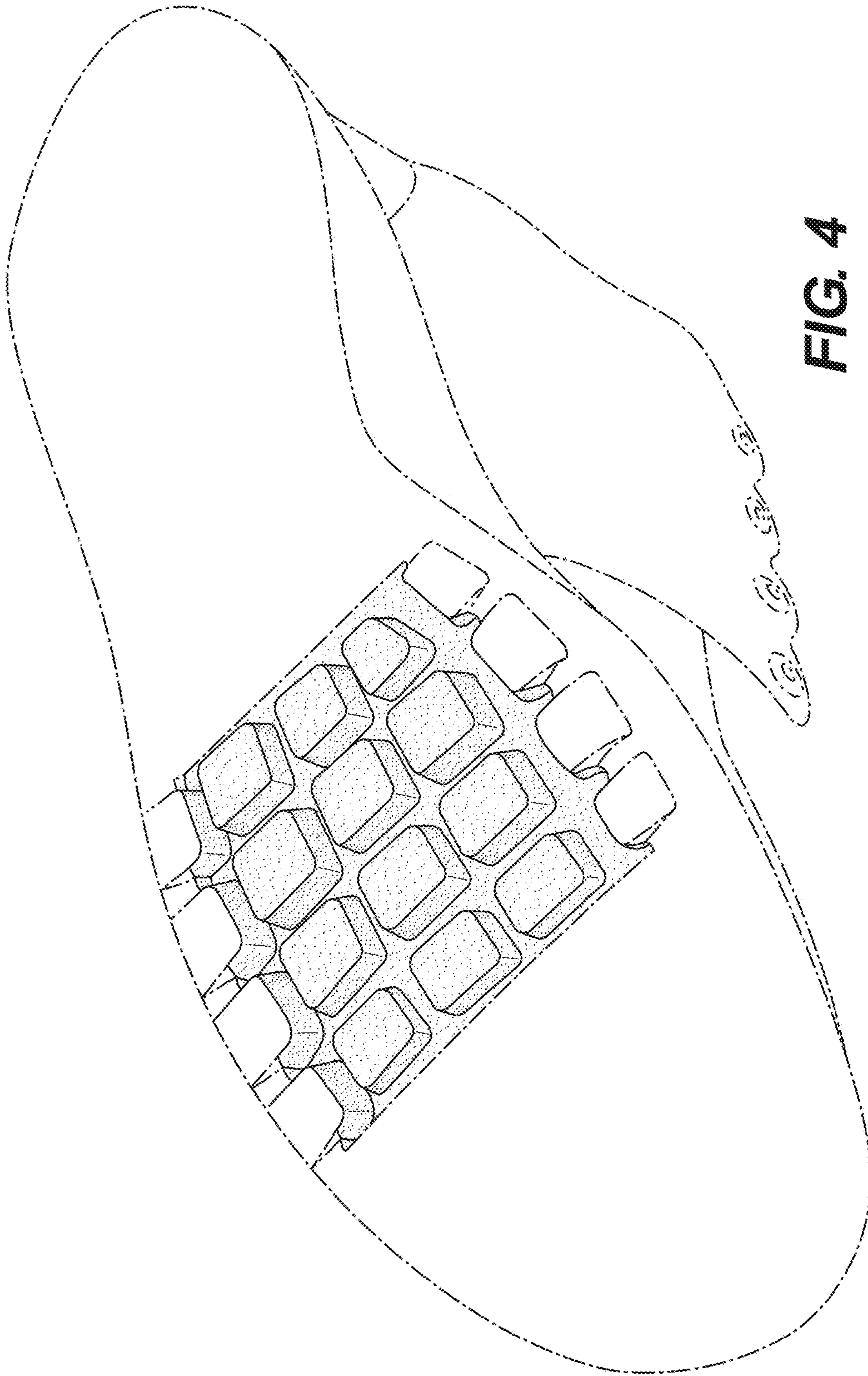

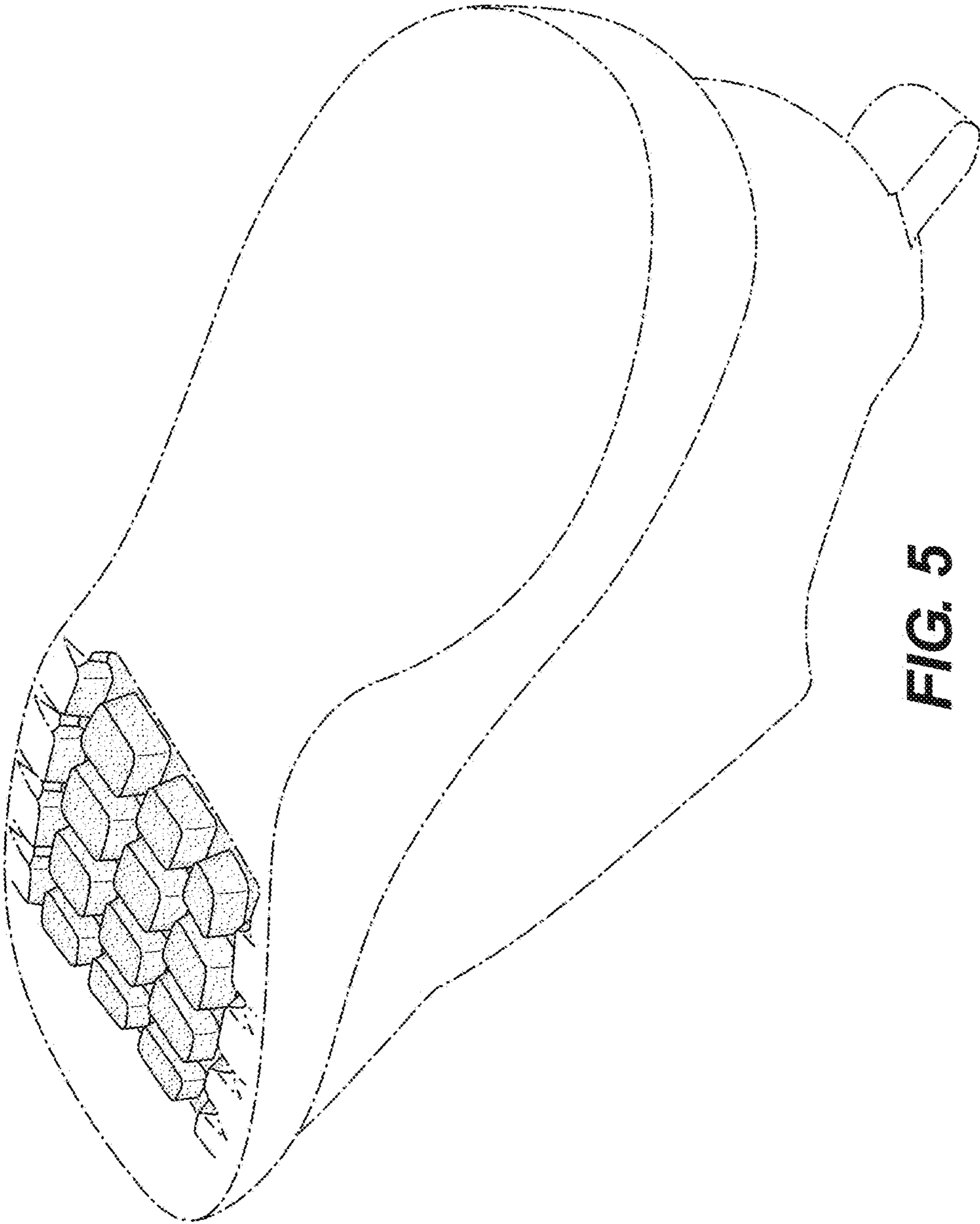
