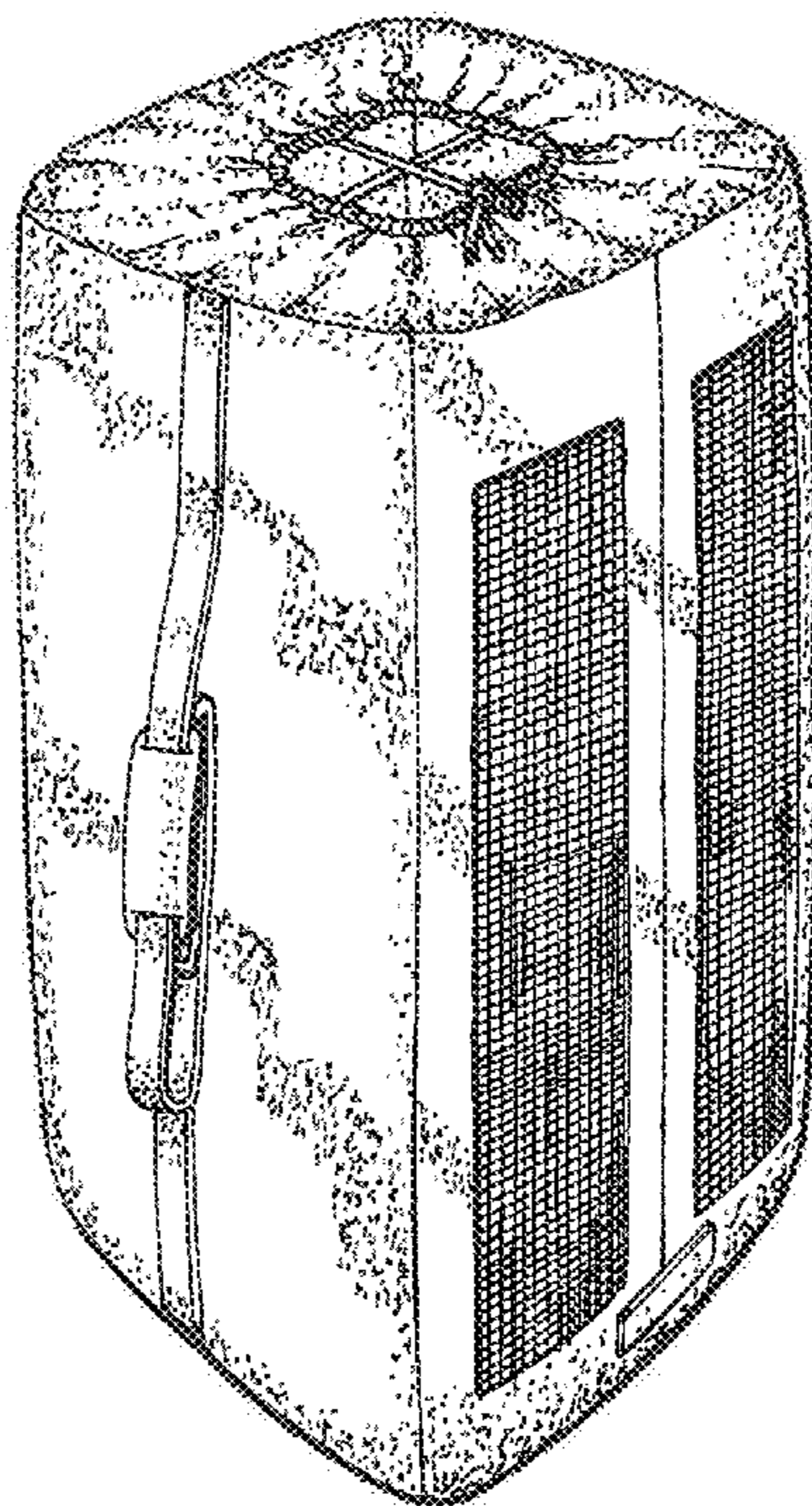
The ornamental design for a sports ball bag, as shown.

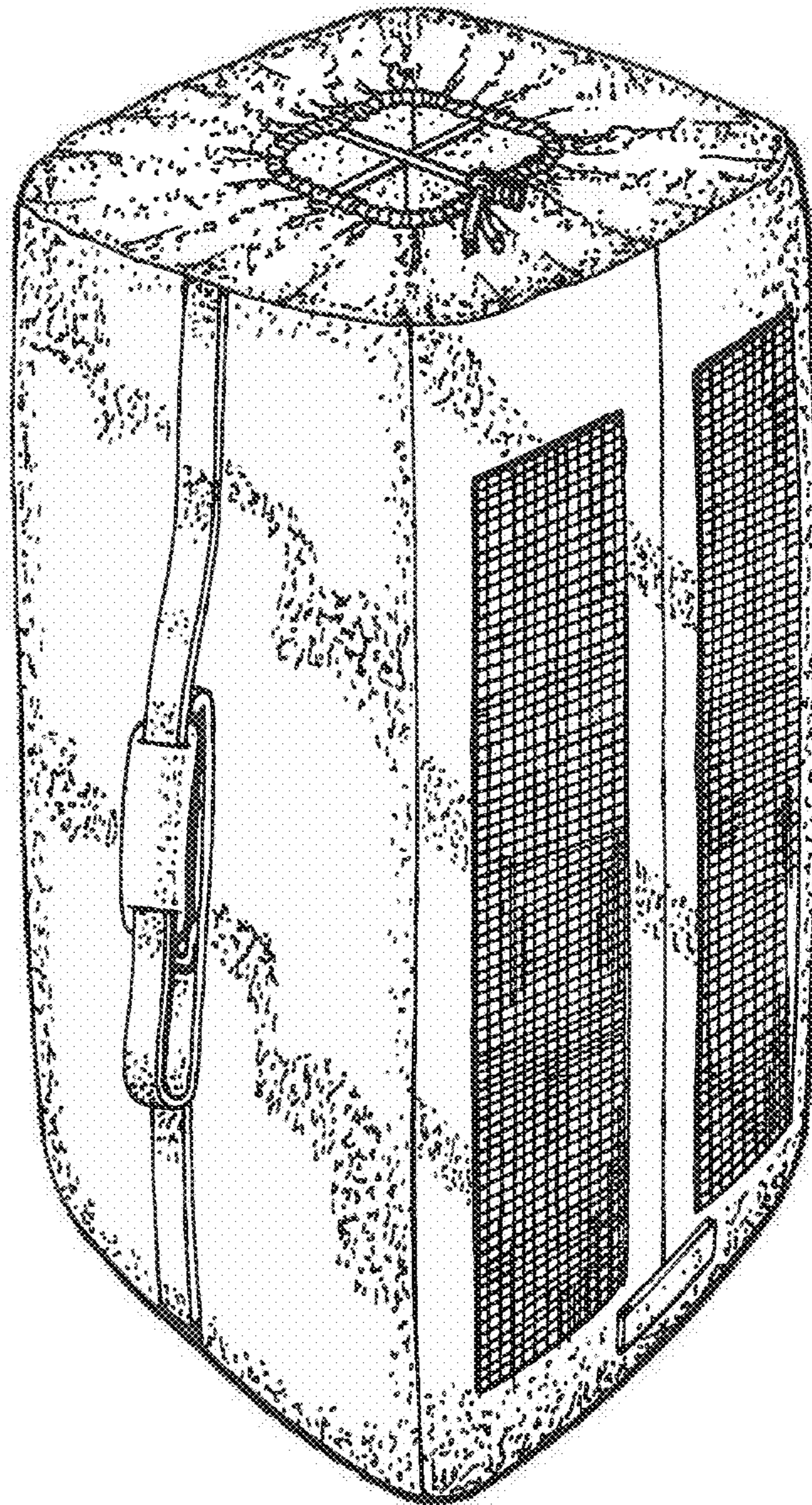

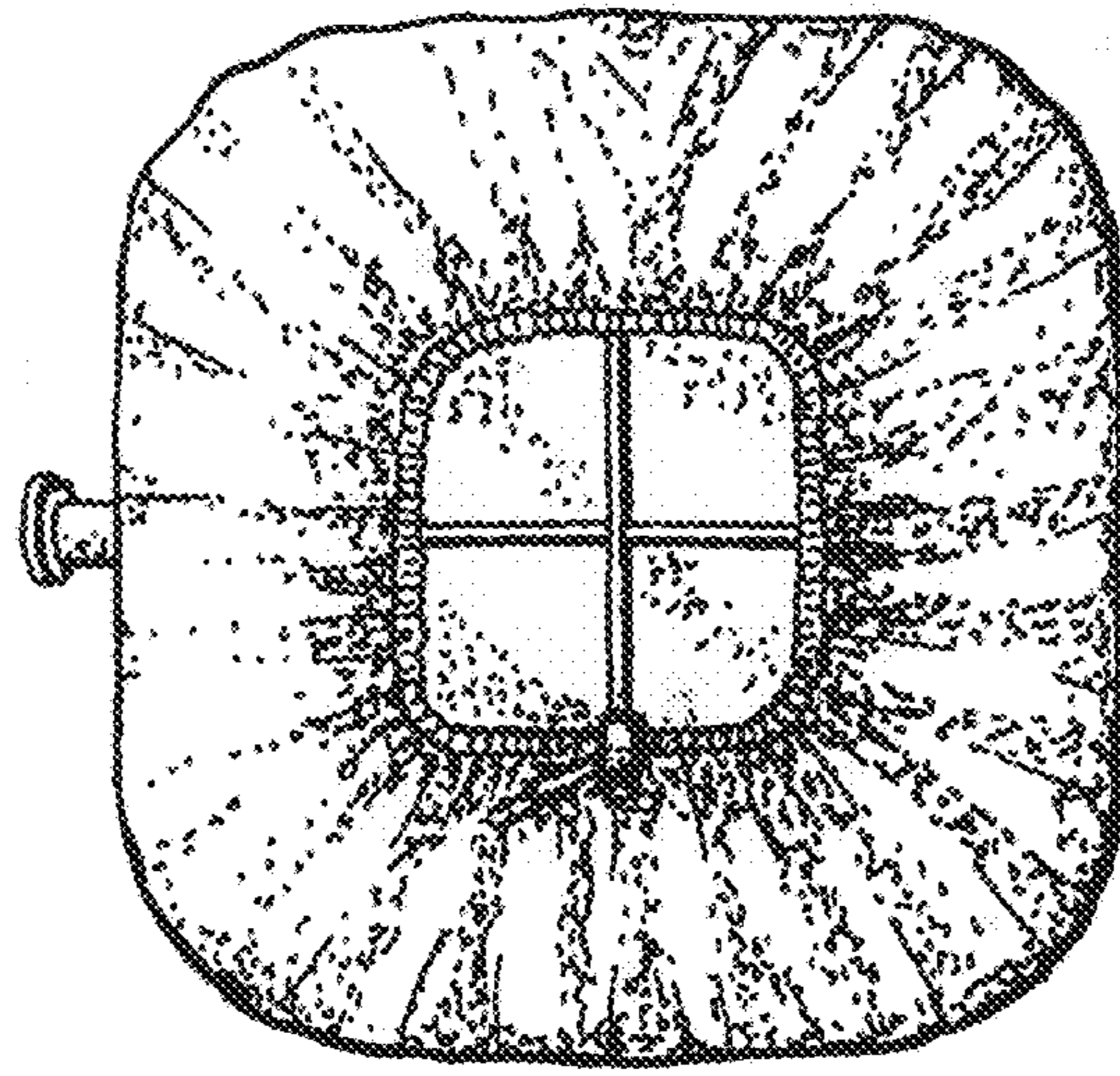

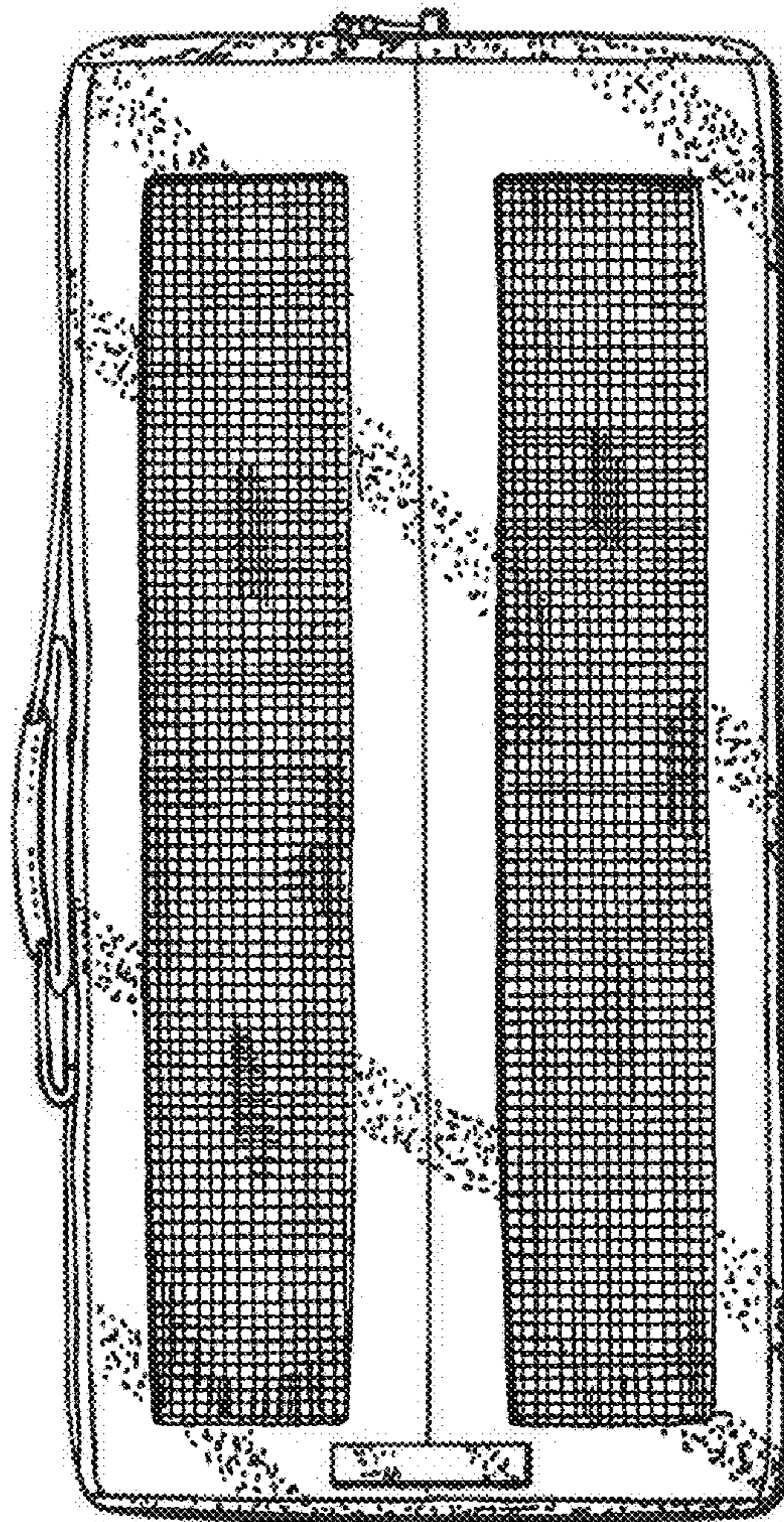

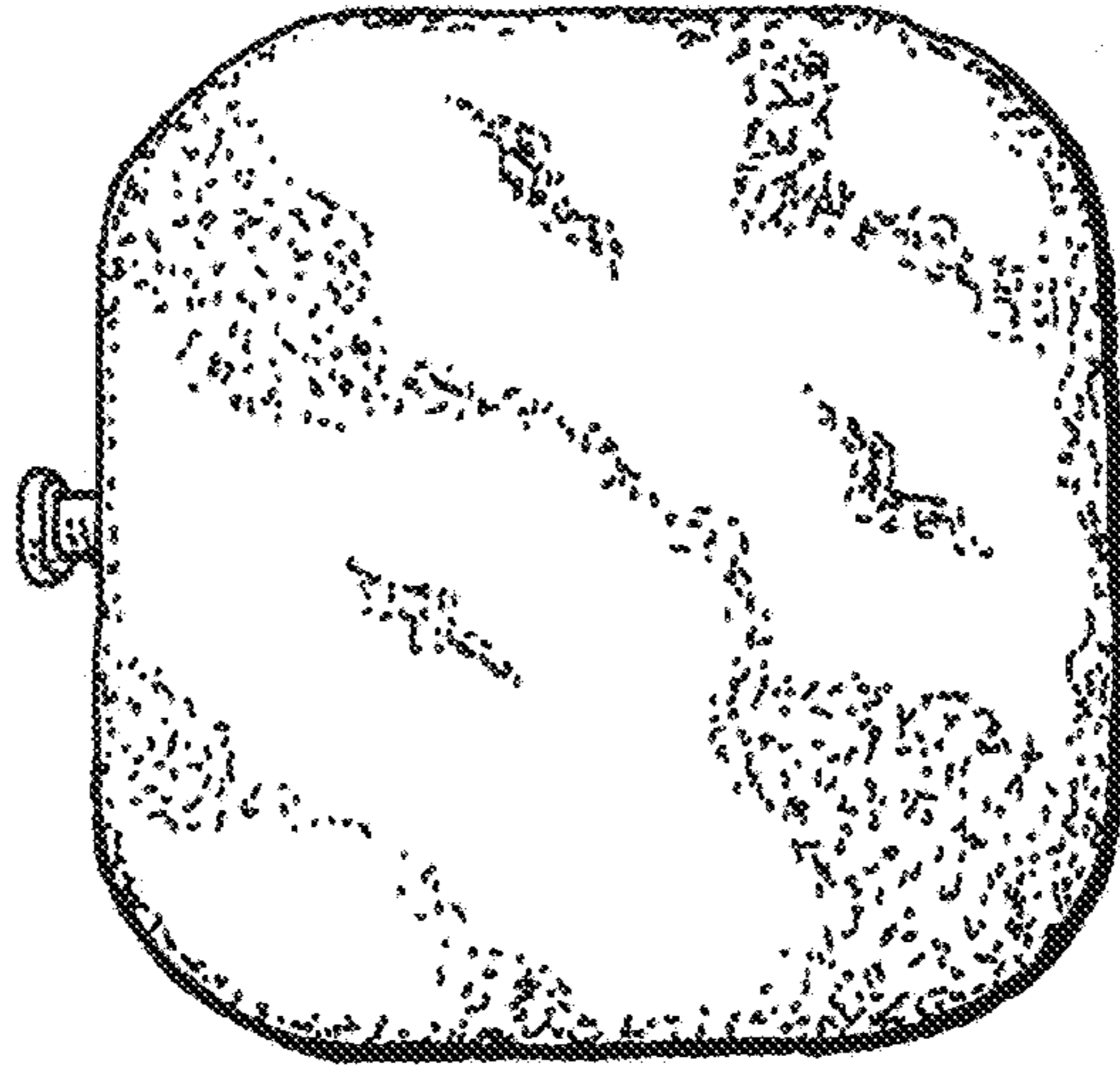

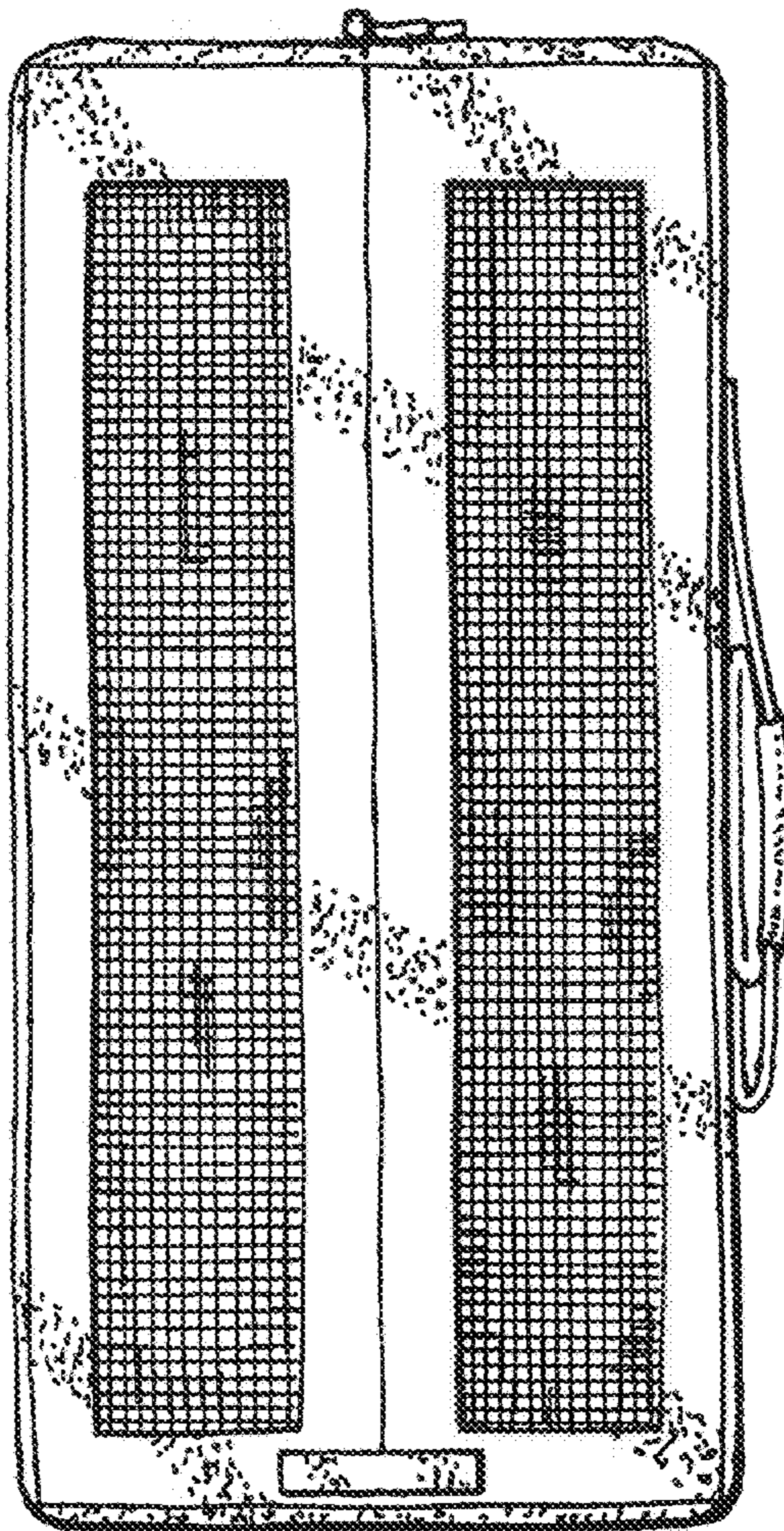

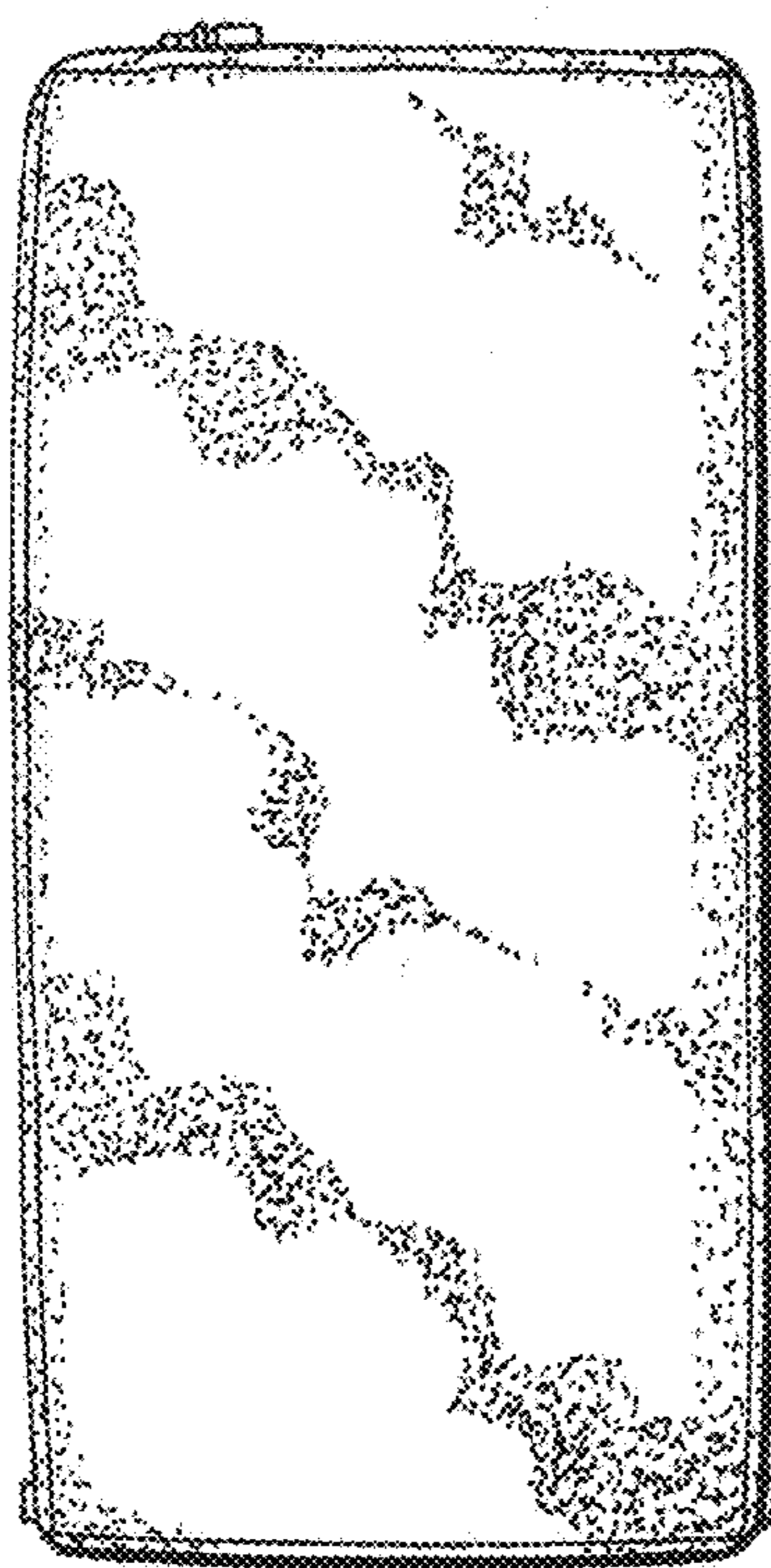

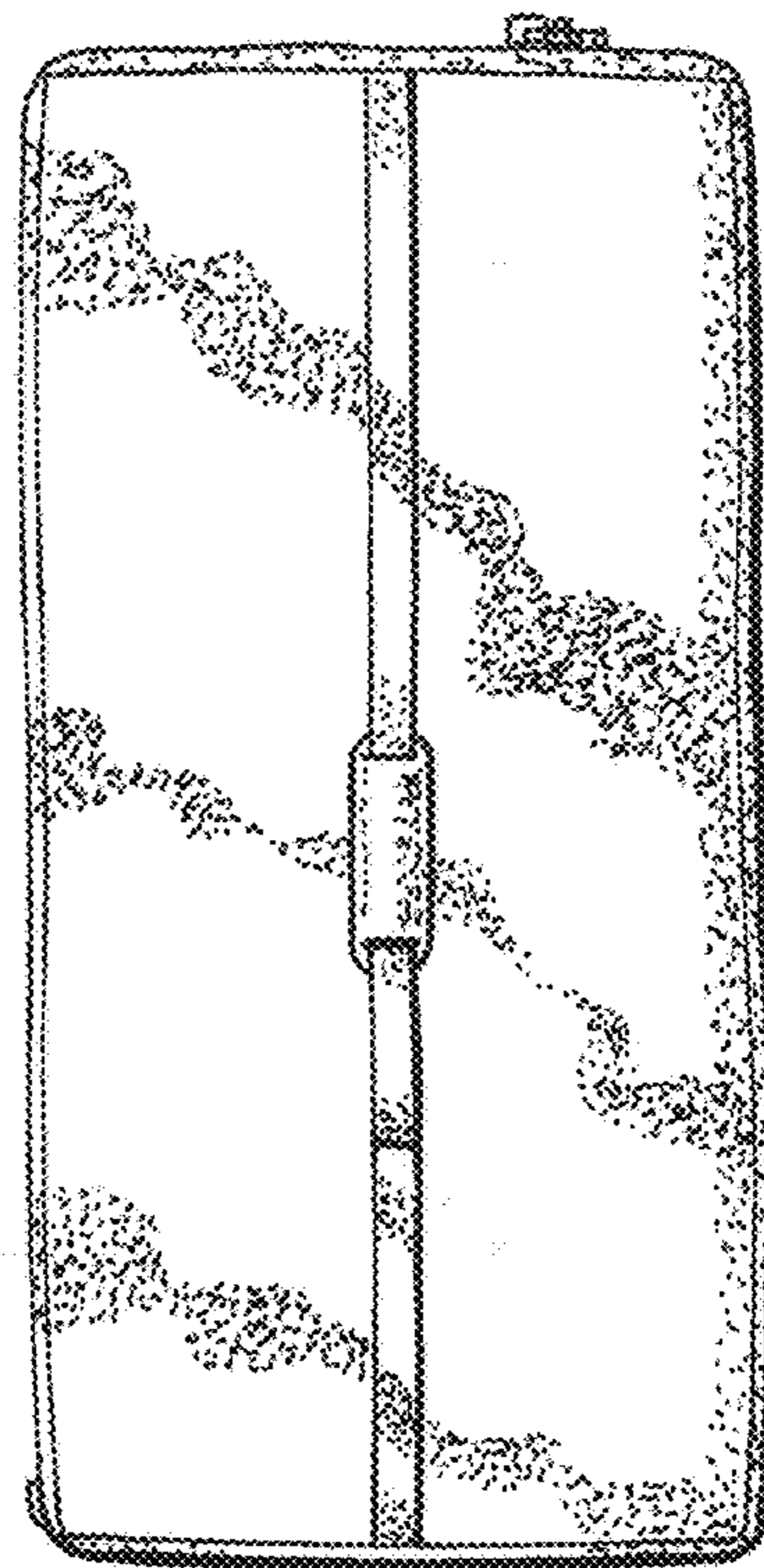
