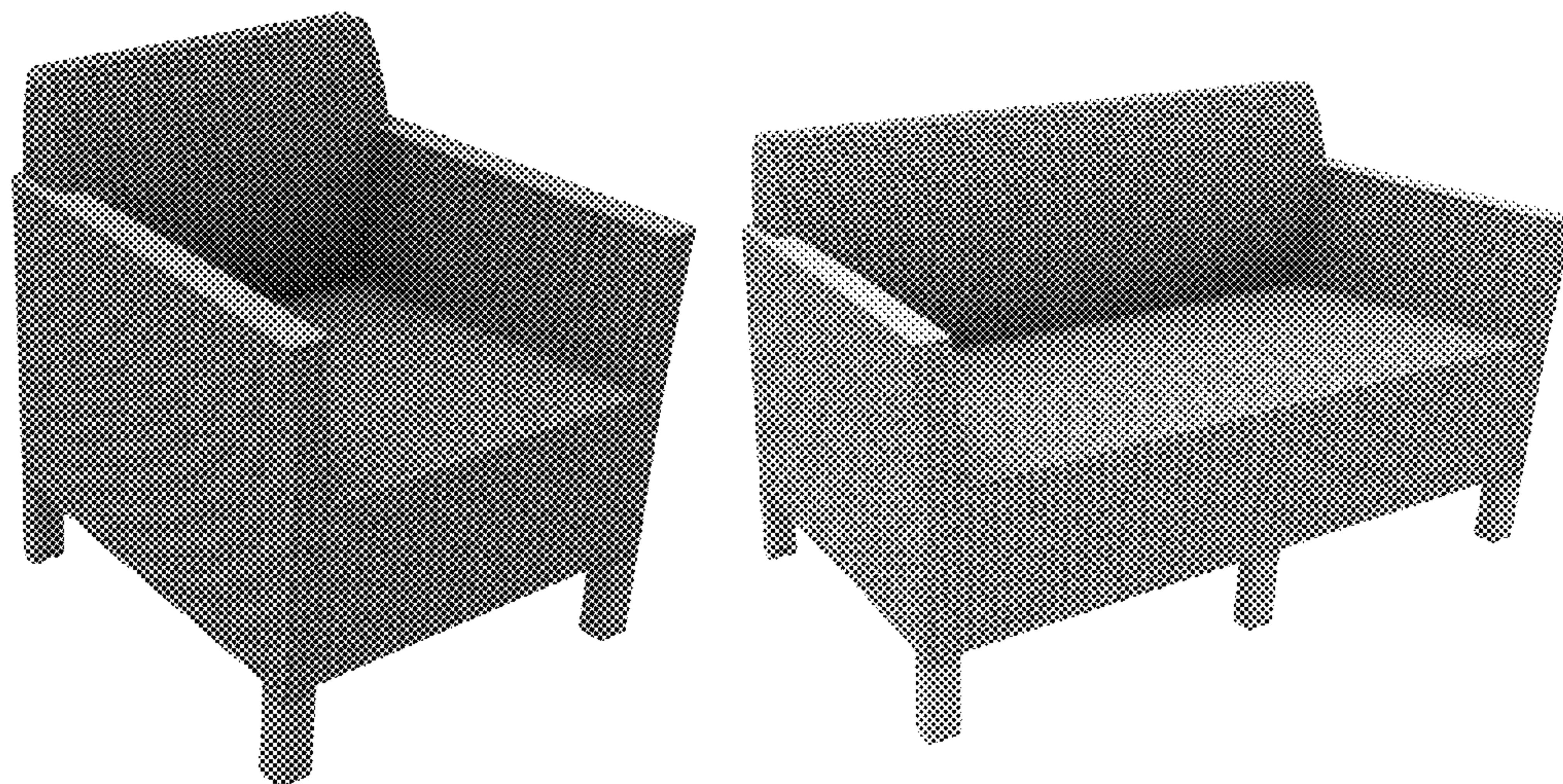
(57) **CLAIM**

The ornamental designs for furniture, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of furniture in the form of a chair;
 FIG. 2 is a rear perspective view of the chair shown in FIG. 1;
 FIG. 3 is a front elevational view of the chair shown in FIG. 1;
 FIG. 4 is a rear elevational view of the chair shown in FIG. 1;
 FIG. 5 is a side elevational view of the chair shown in FIG. 1; the other side elevational view being a mirror image;
 FIG. 6 is a top plan view of the chair shown in FIG. 1;
 FIG. 7 is a front perspective view of a second embodiment of furniture in the form of a sofa;
 FIG. 8 is a rear perspective view of the sofa shown in FIG. 7;
 FIG. 9 is a front elevational view of the sofa shown in FIG. 7;
 FIG. 10 is a rear elevational view of the sofa shown in FIG. 7;
 FIG. 11 is a side elevational view of the sofa shown in FIG. 7; the other side elevational view being a mirror image;
 FIG. 12 is a top plan view of the sofa shown in FIG. 7;
 FIG. 13 is a front perspective view of a third embodiment of furniture in the form of a sofa;
 FIG. 14 is a rear perspective view of the sofa shown in FIG. 13;
 FIG. 15 is a front elevational view of the sofa shown in FIG. 13;
 FIG. 16 is a rear elevational view of the sofa shown in FIG. 13;
 FIG. 17 is a side elevational view of the sofa shown in FIG. 13; the other side elevational view being a mirror image; and,
 FIG. 18 is a top plan view of the sofa shown in FIG. 13.

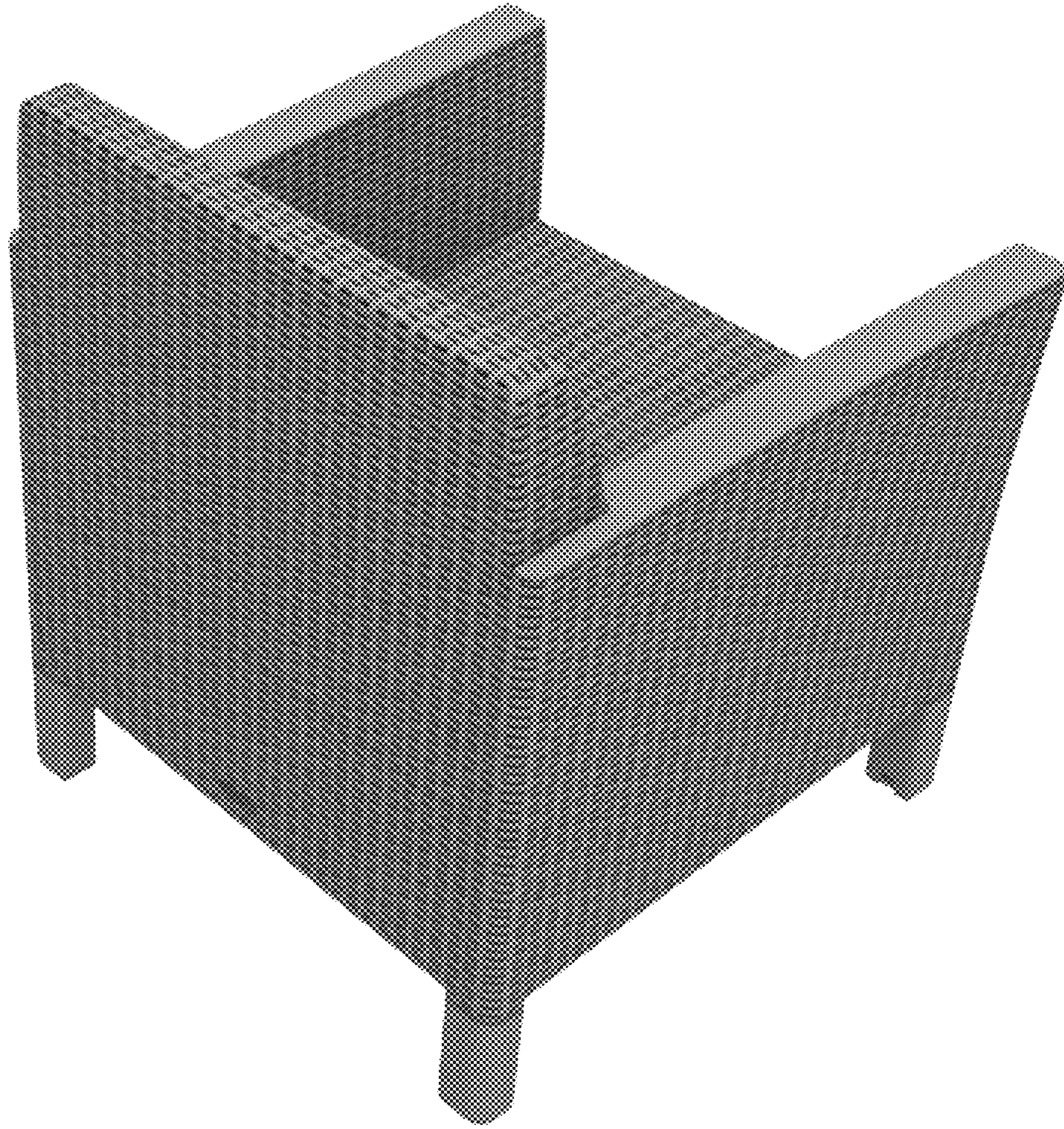

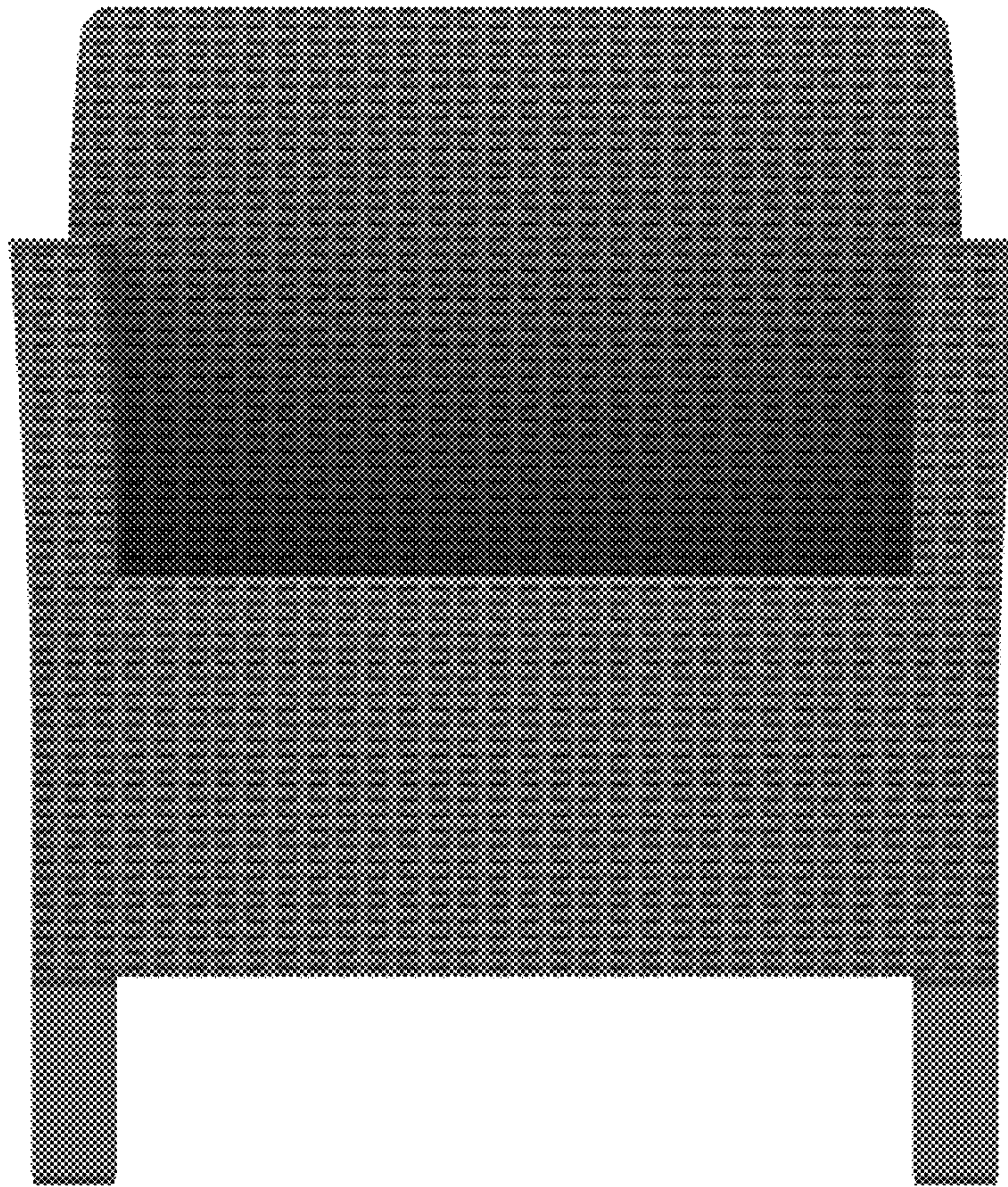

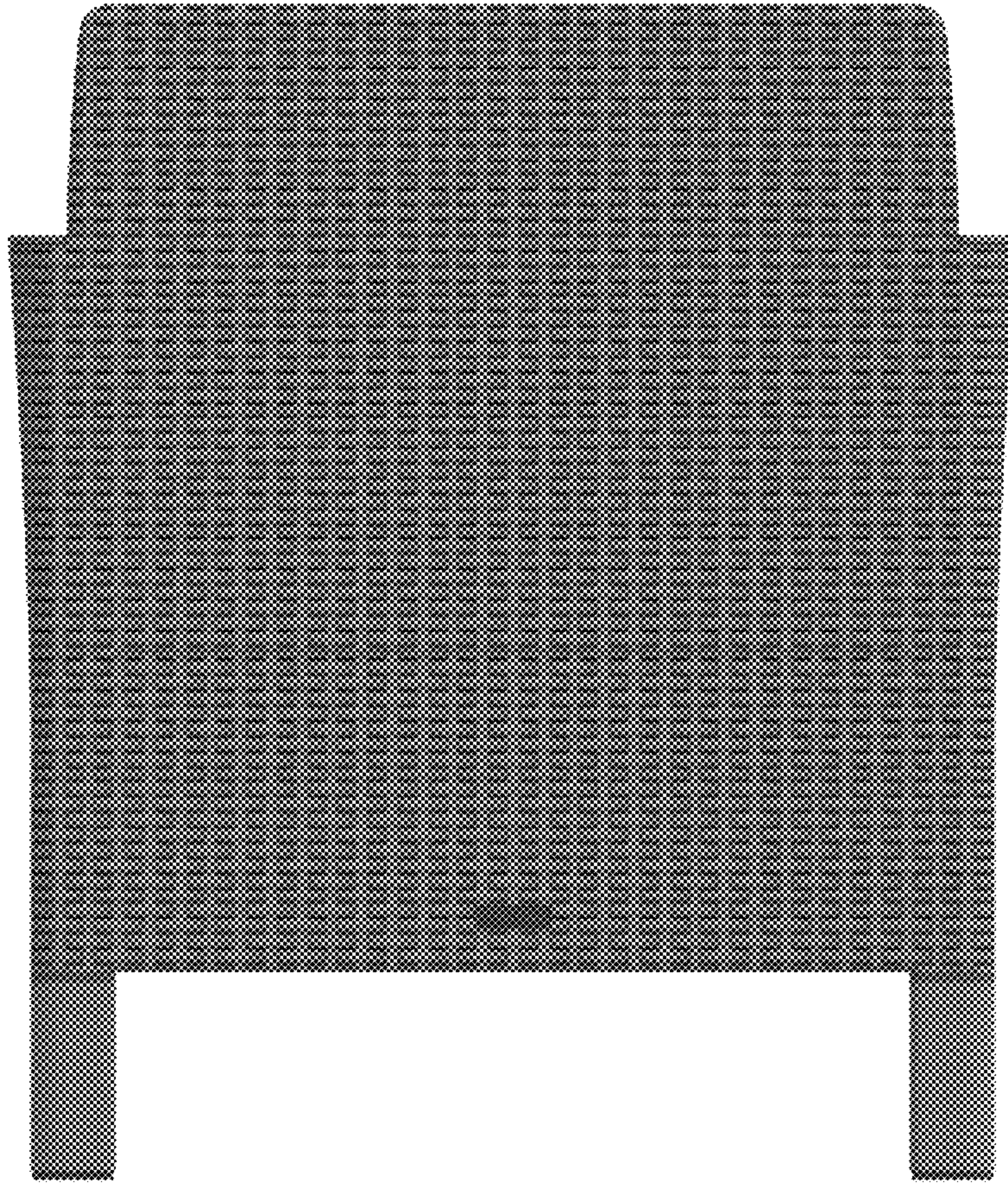

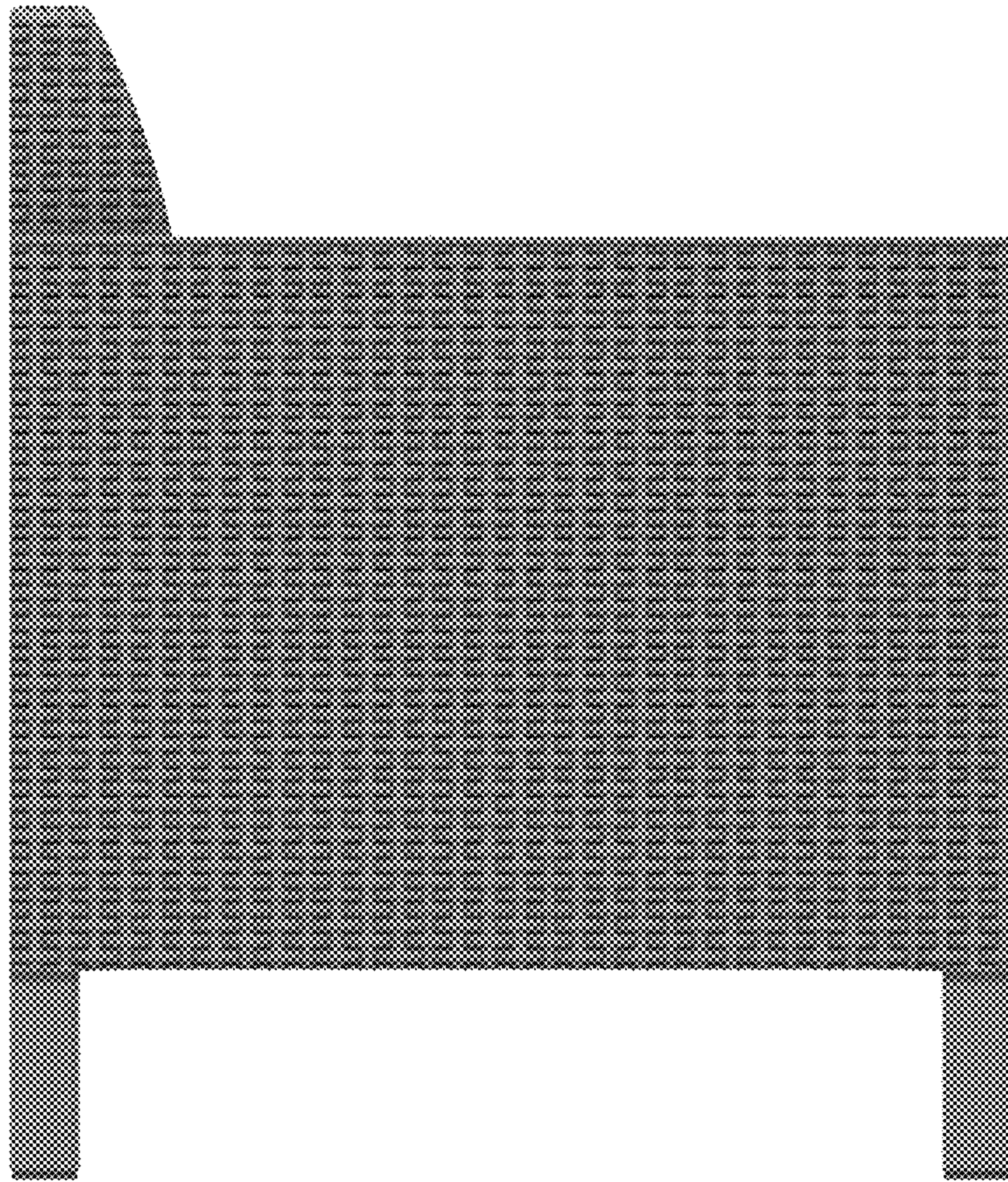

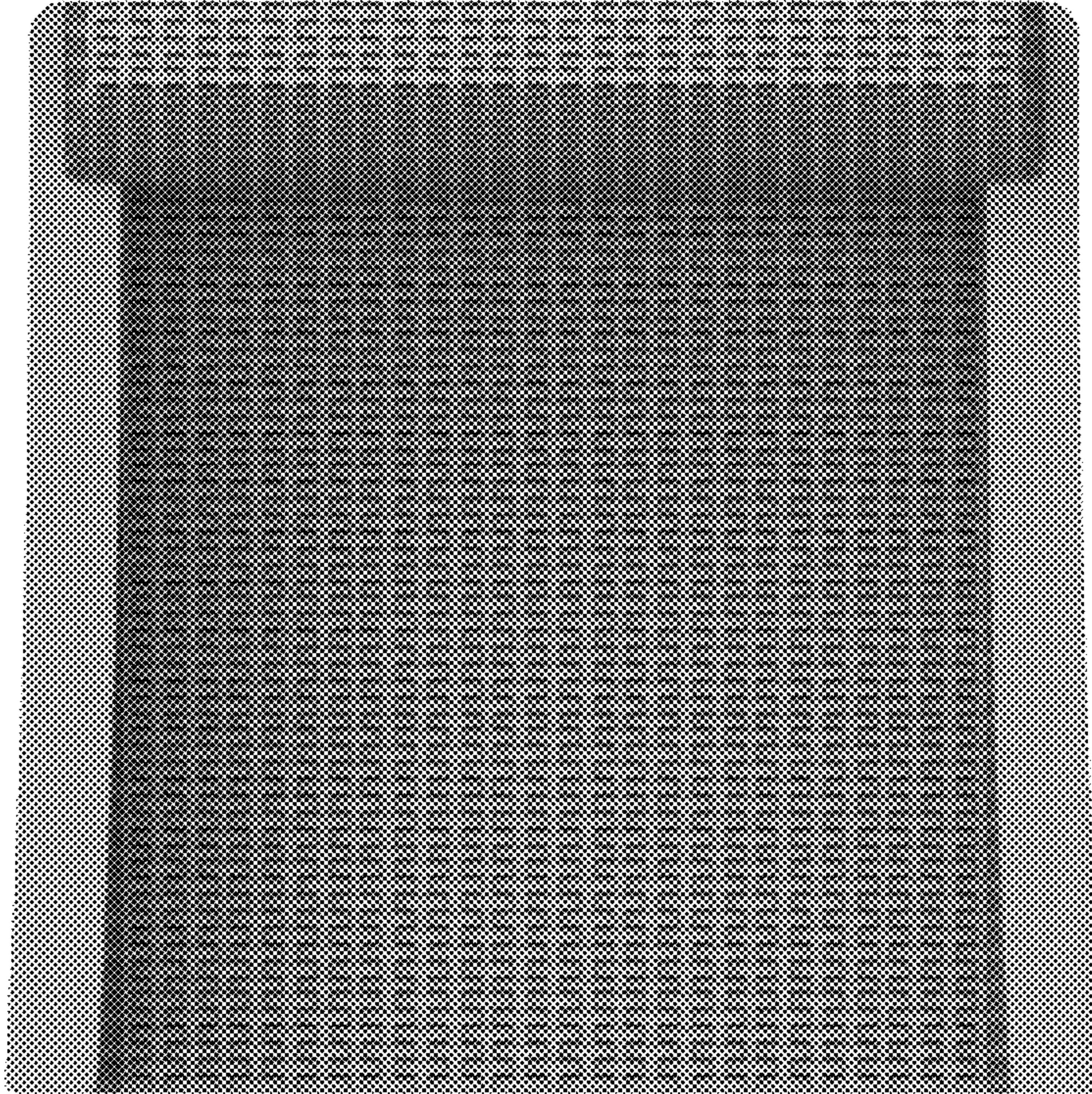

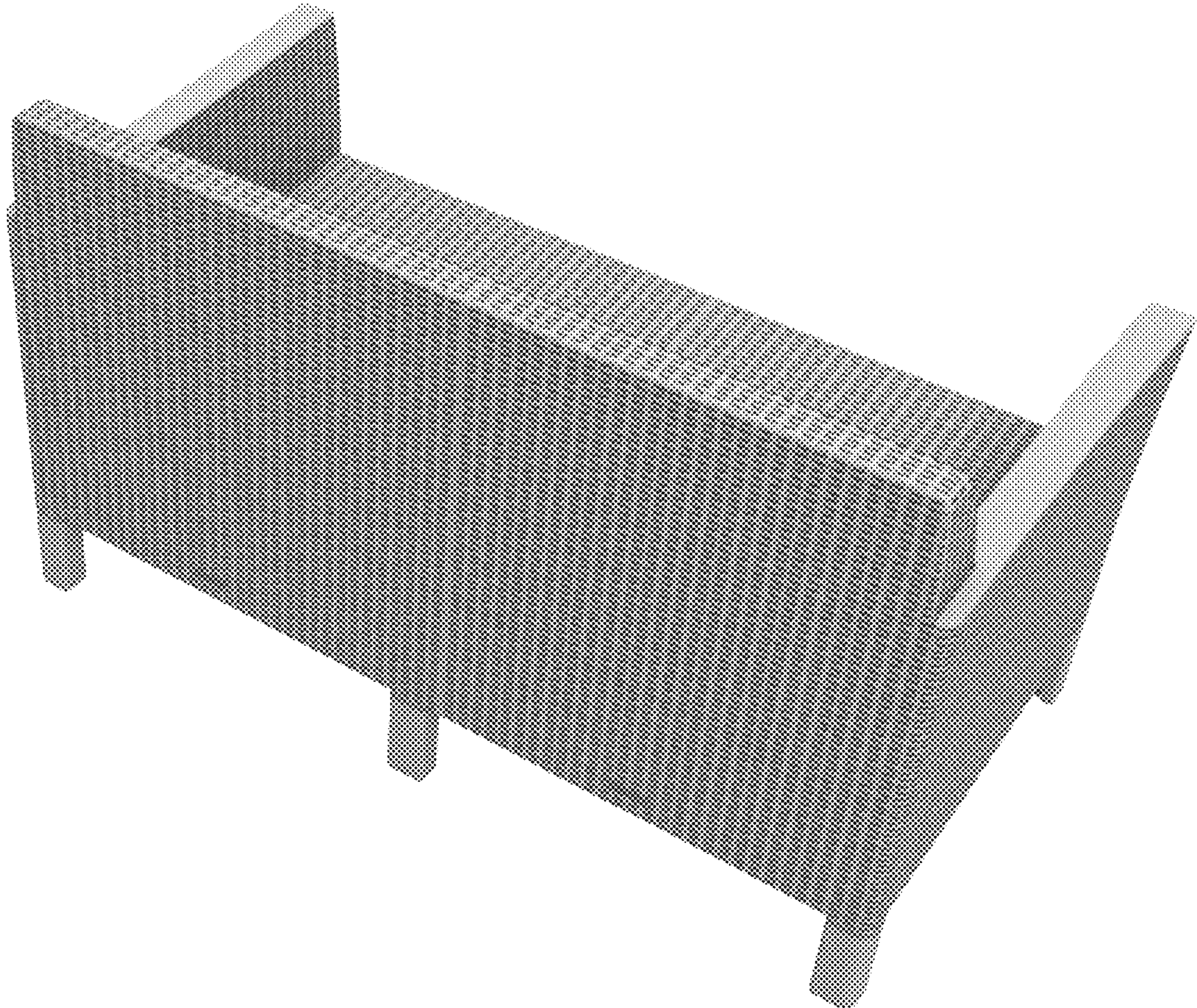

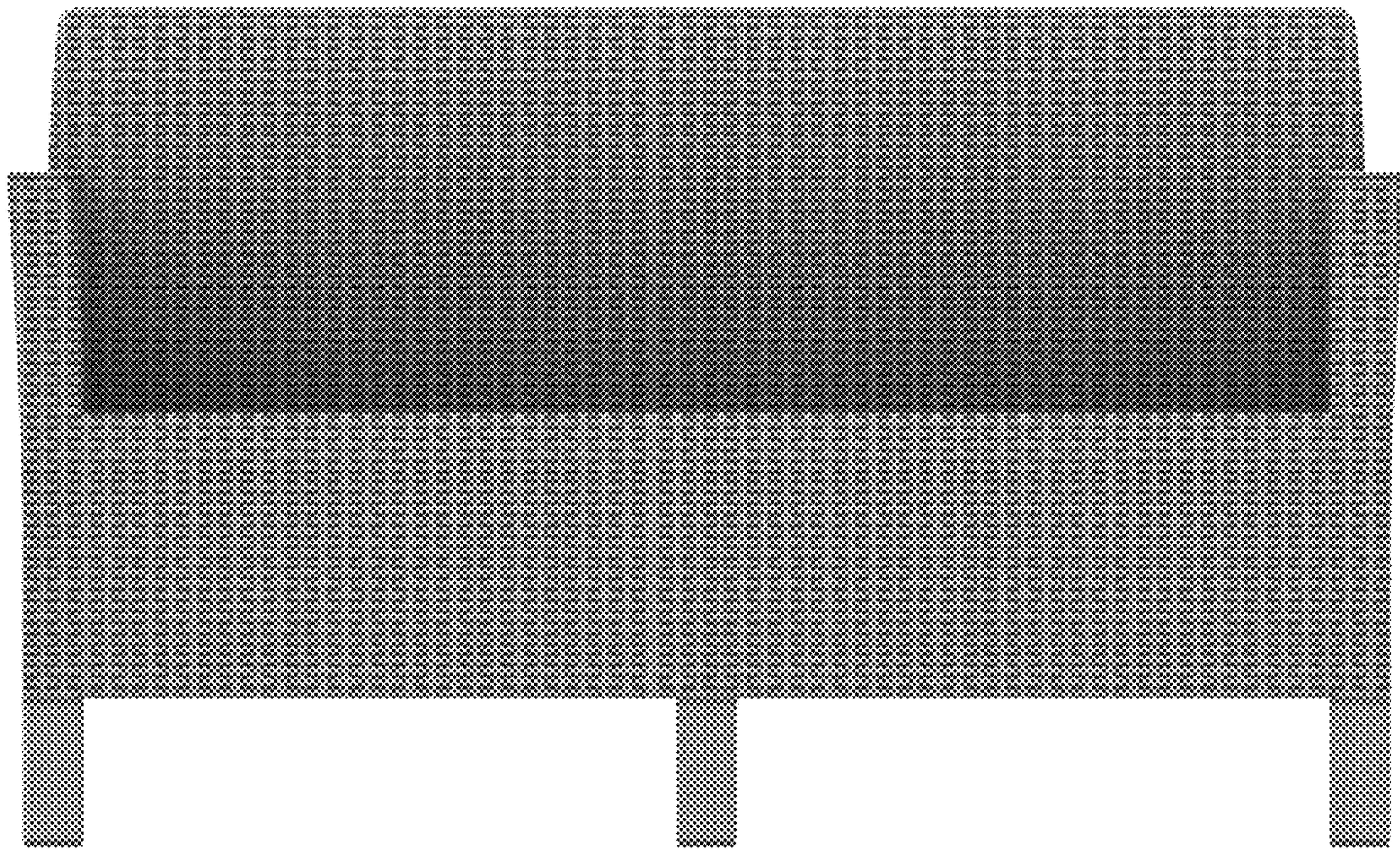

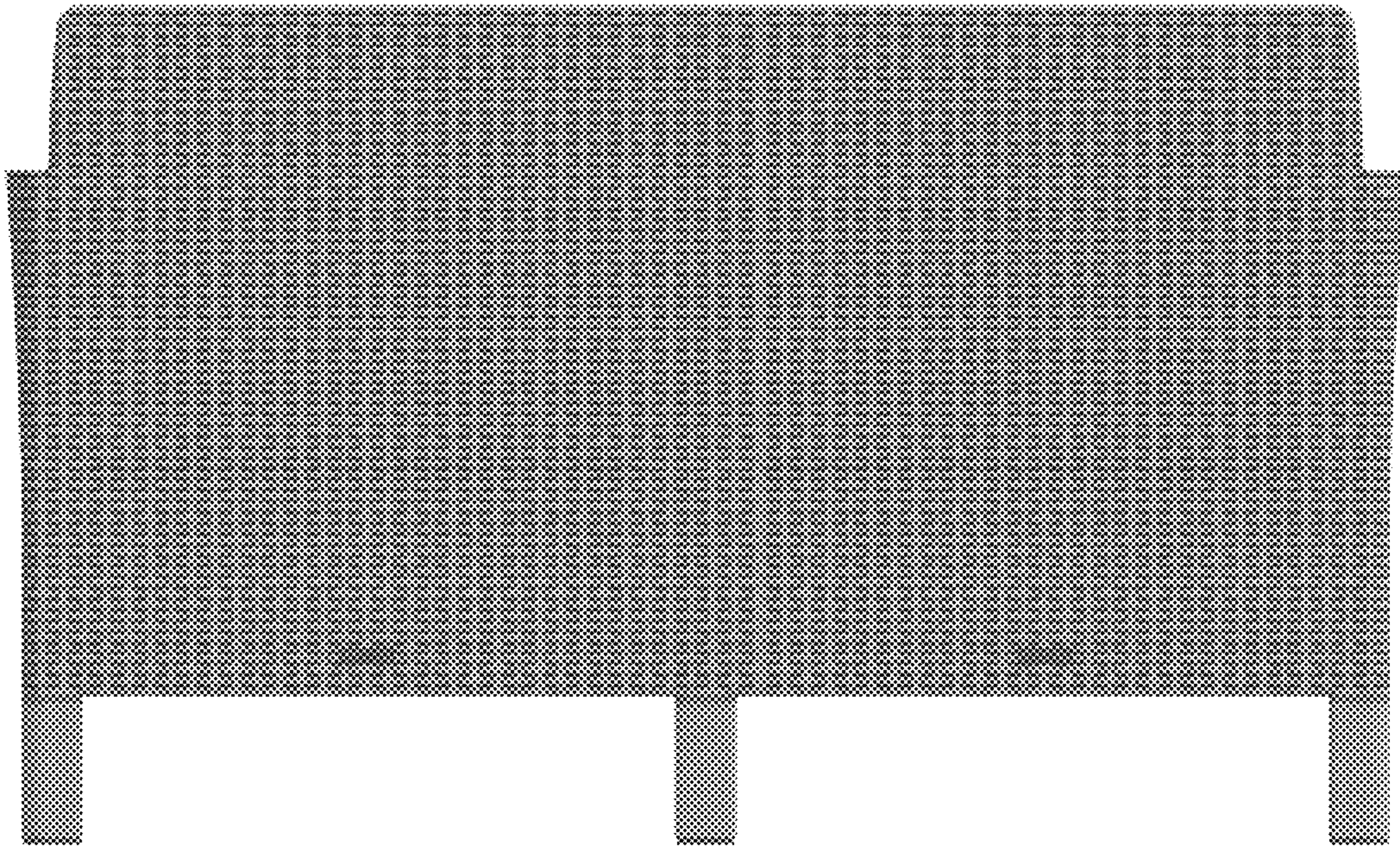

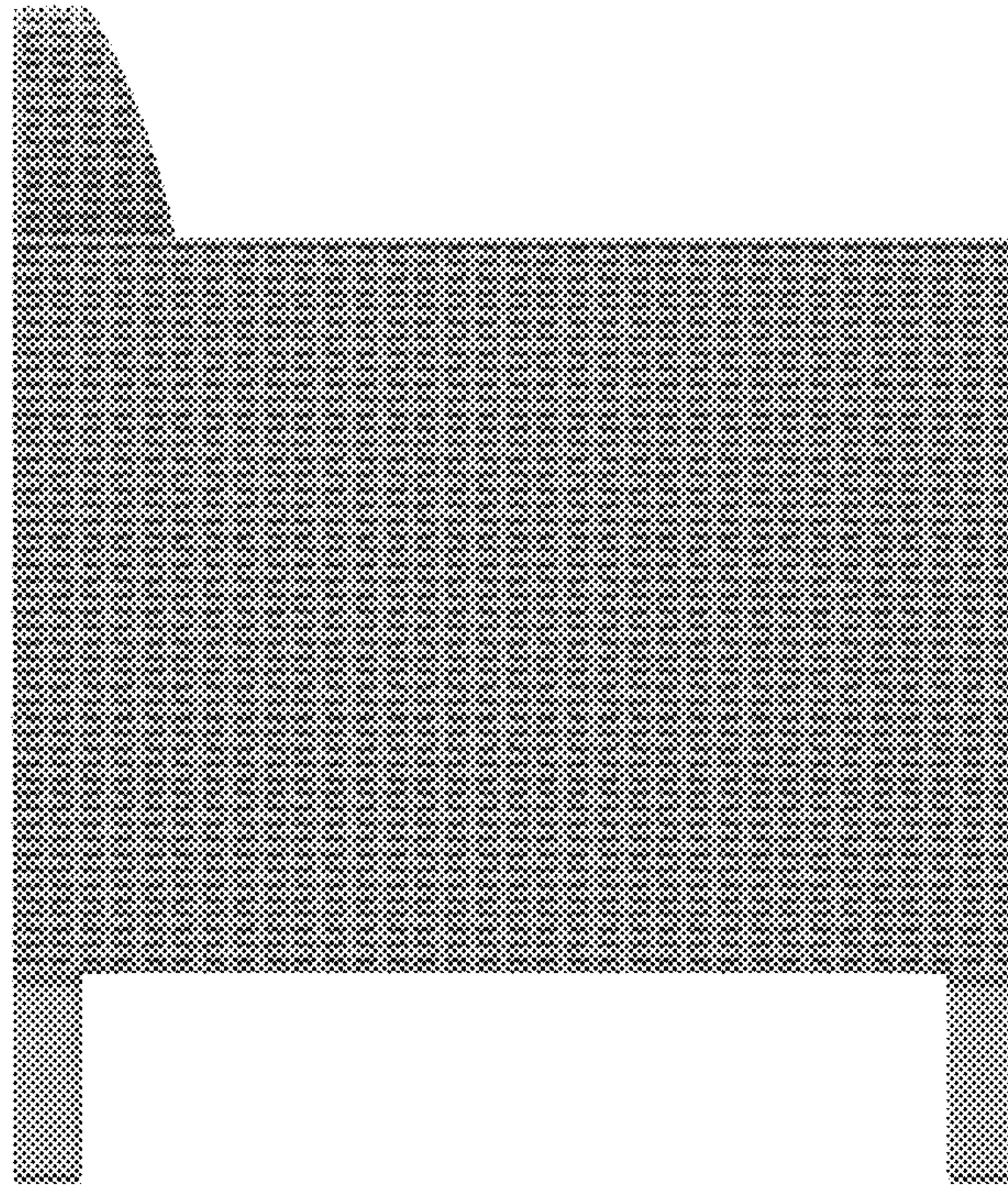

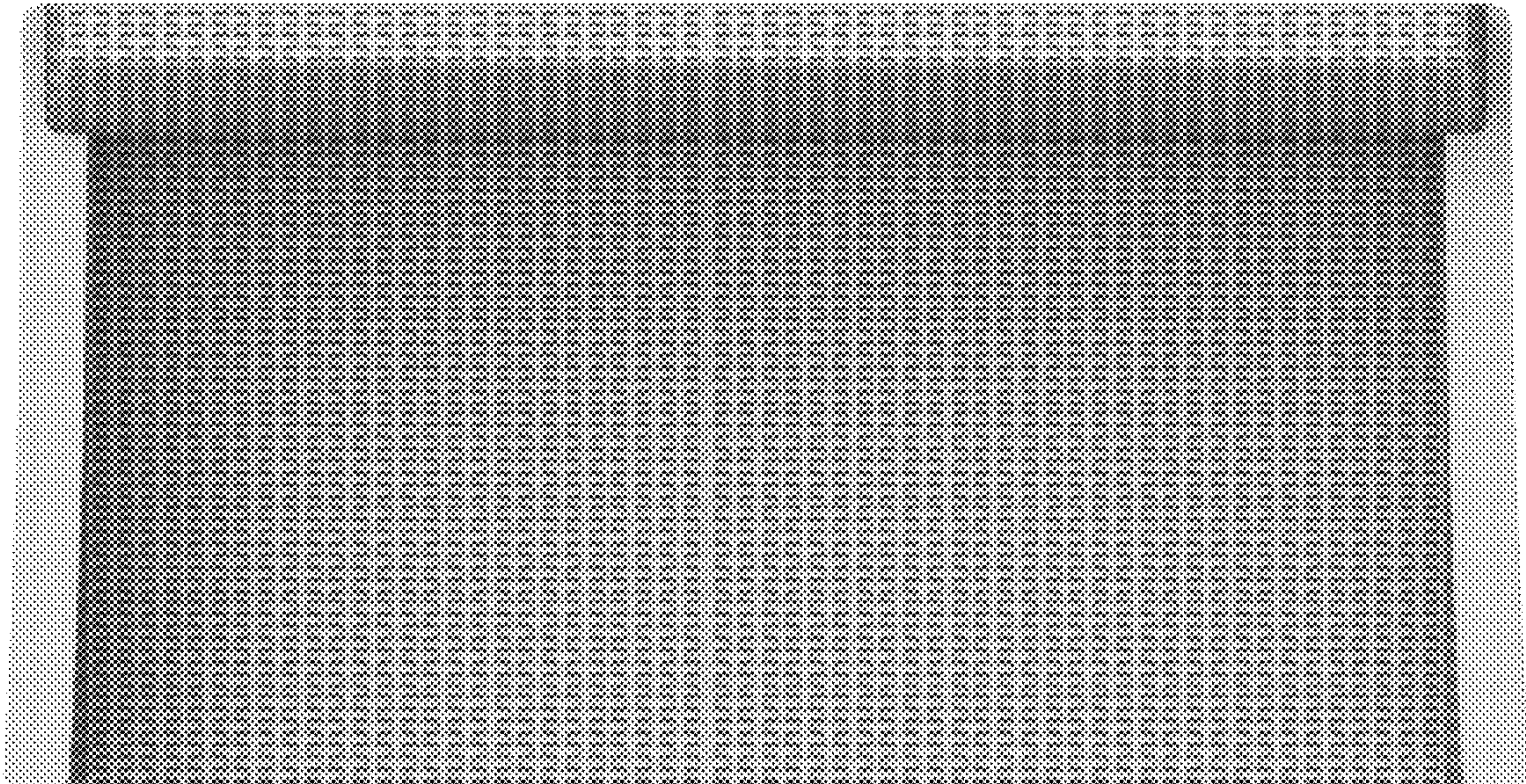

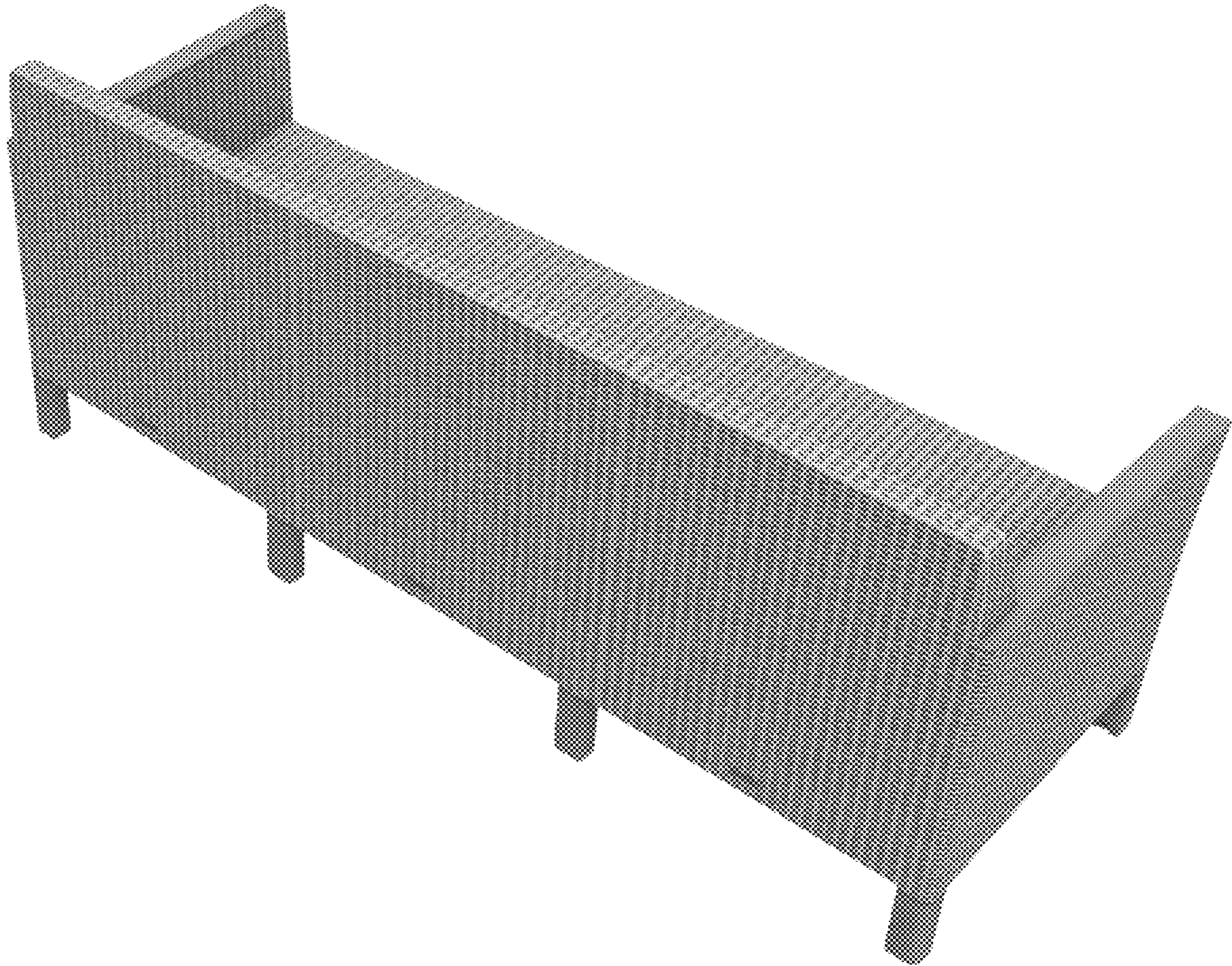

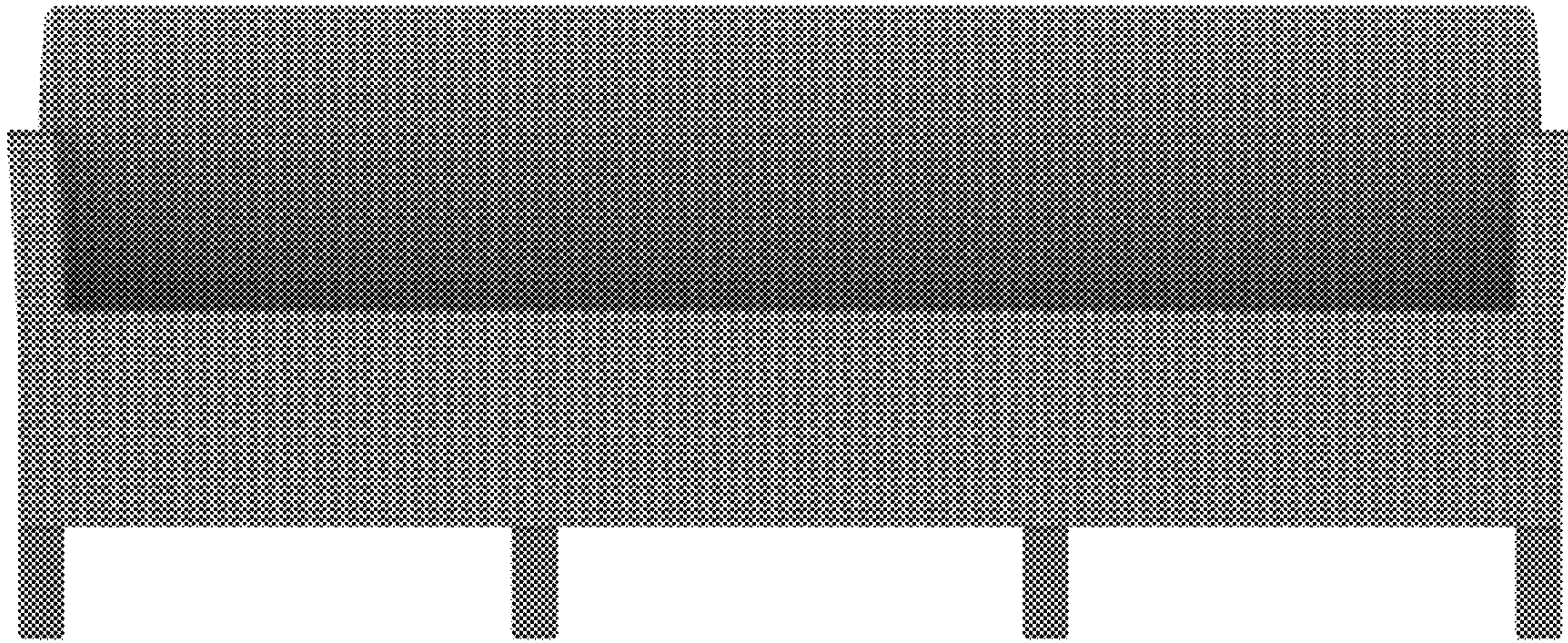

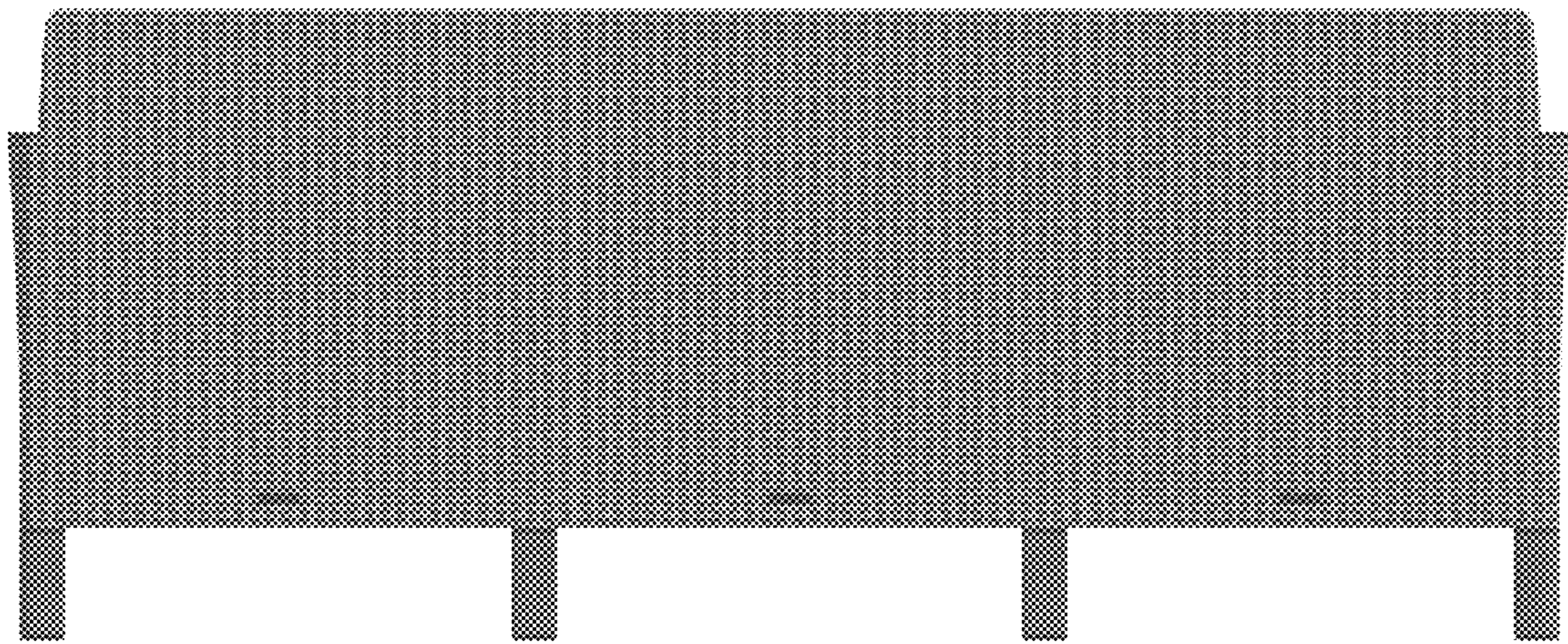

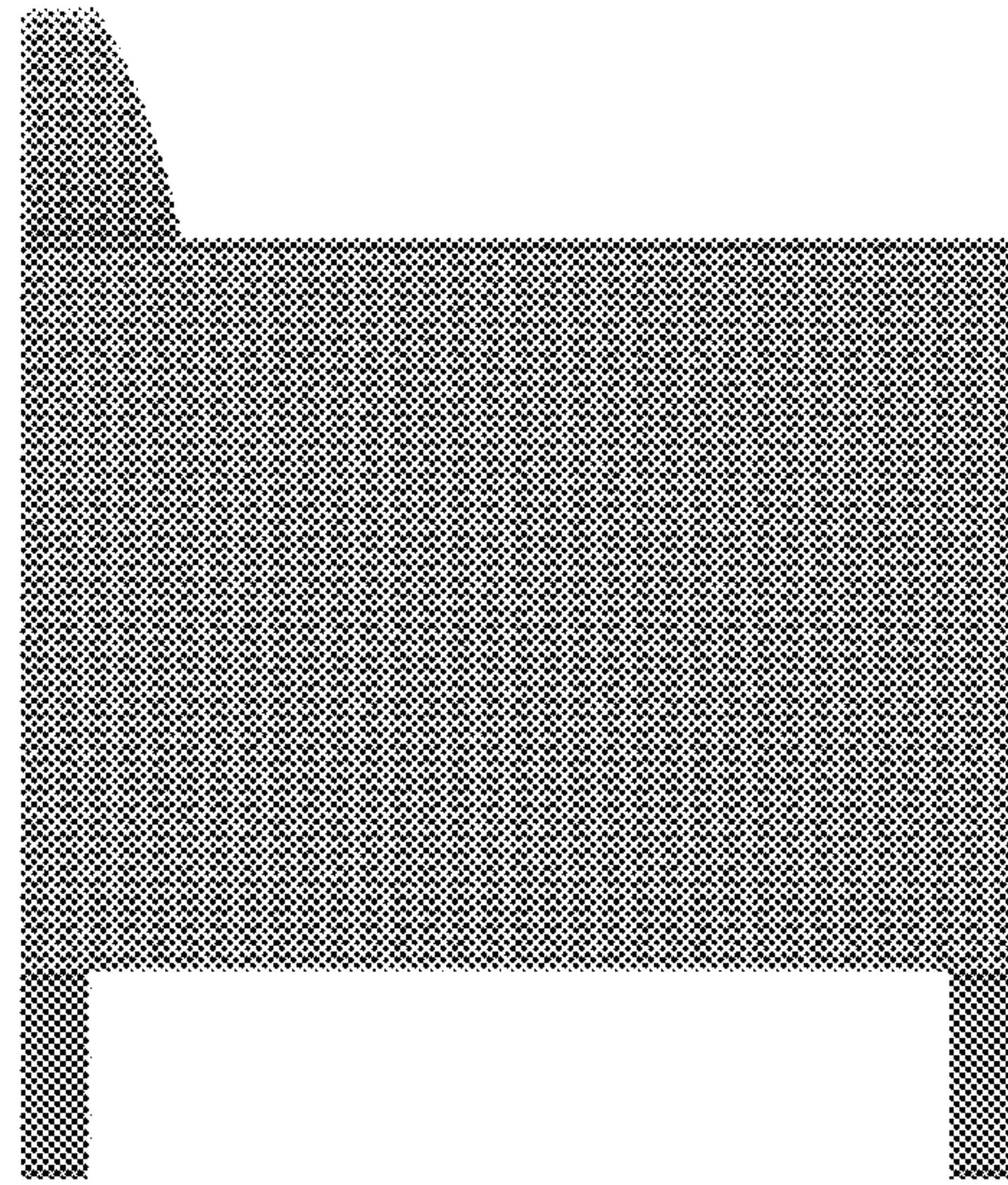

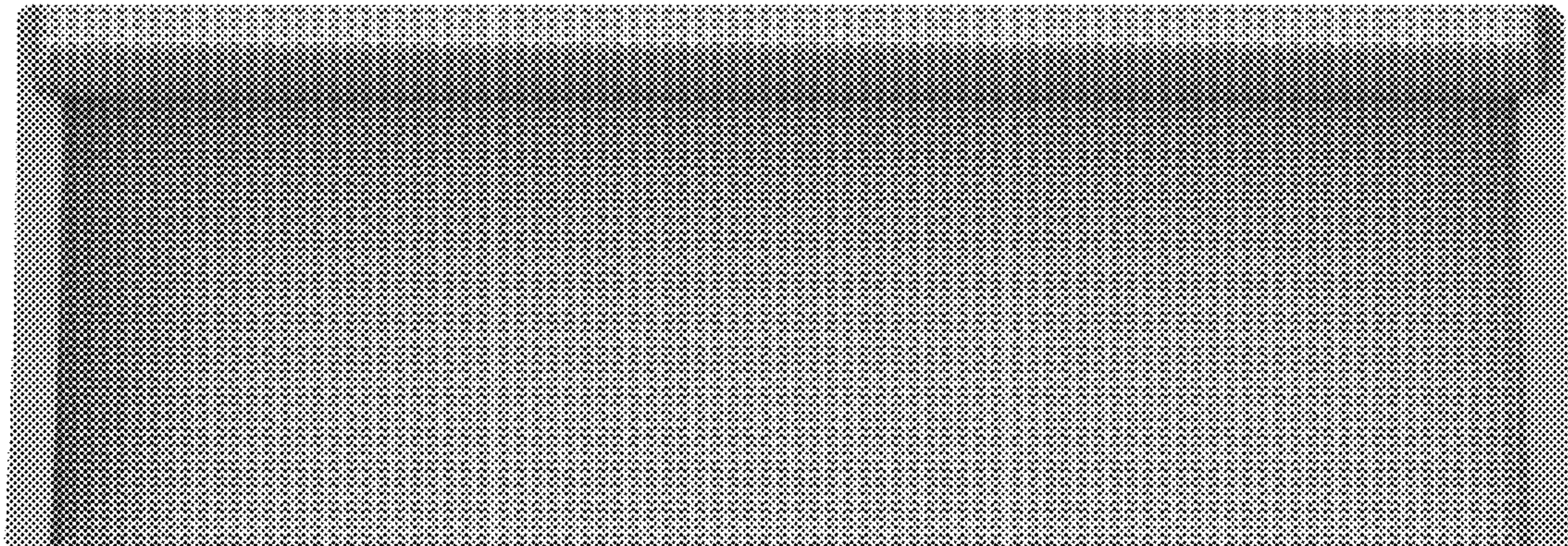
