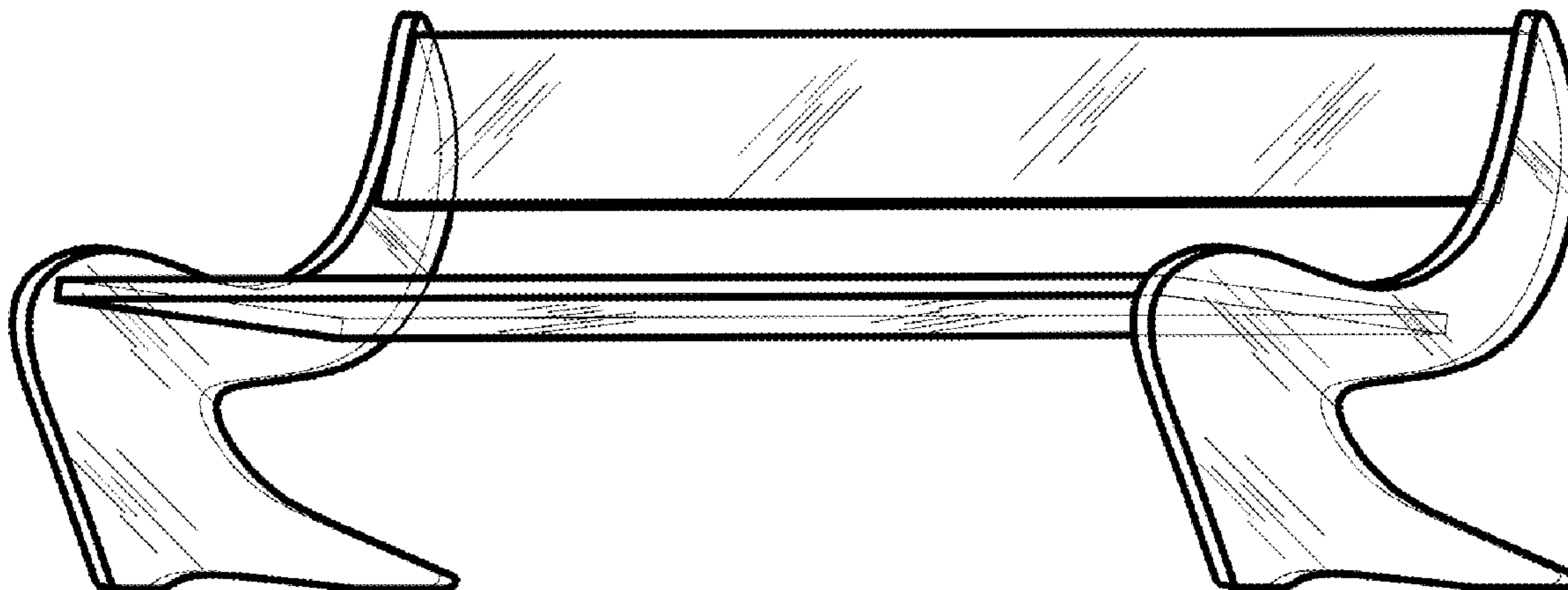
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a left side elevational view of a bench, showing my new design, the right side elevational view being a mirror image thereof;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a front-left side perspective view thereof;  
FIG. 5 is a front-right side perspective view thereof;  
FIG. 6 is a back elevational view thereof; and,

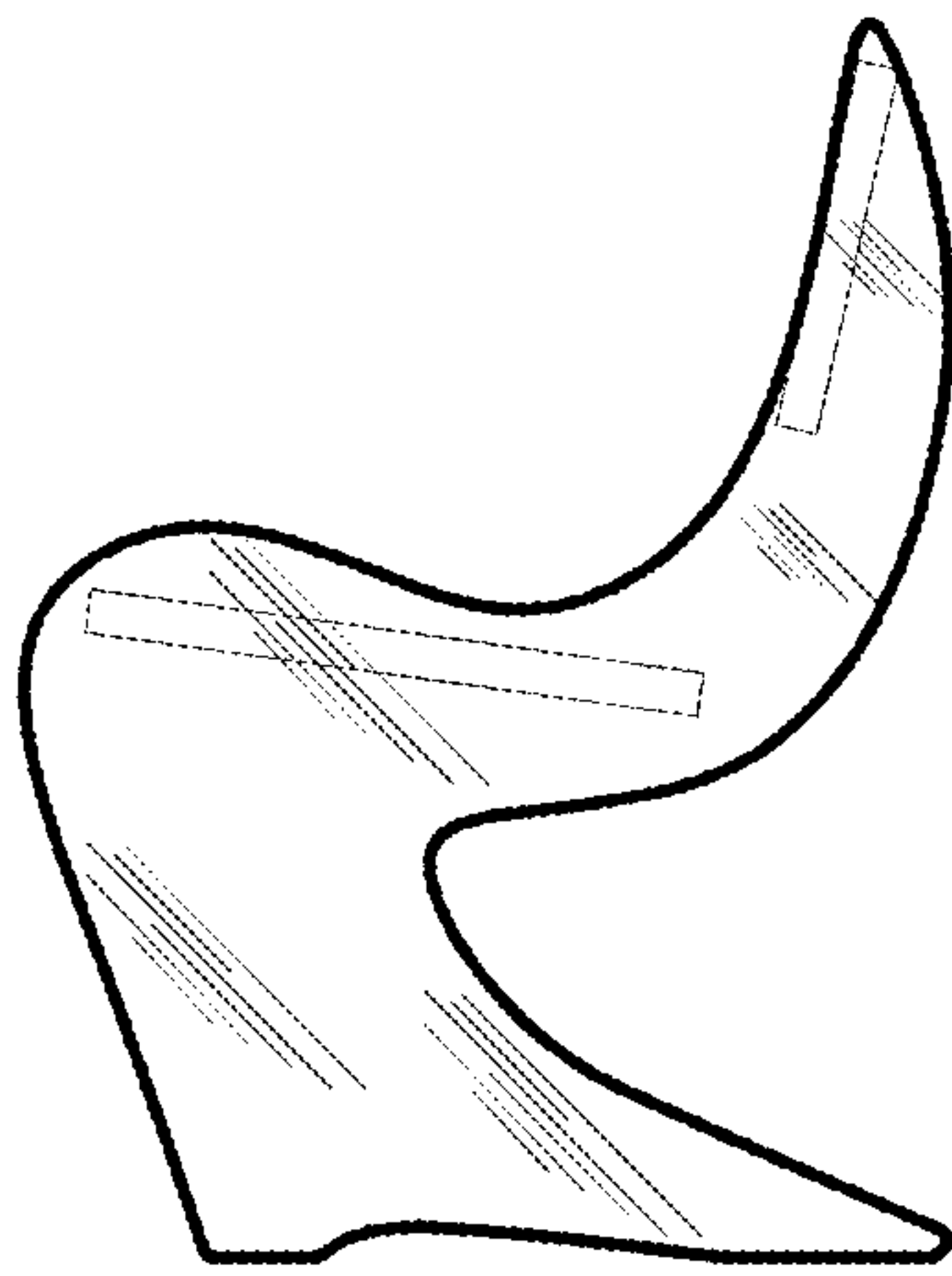

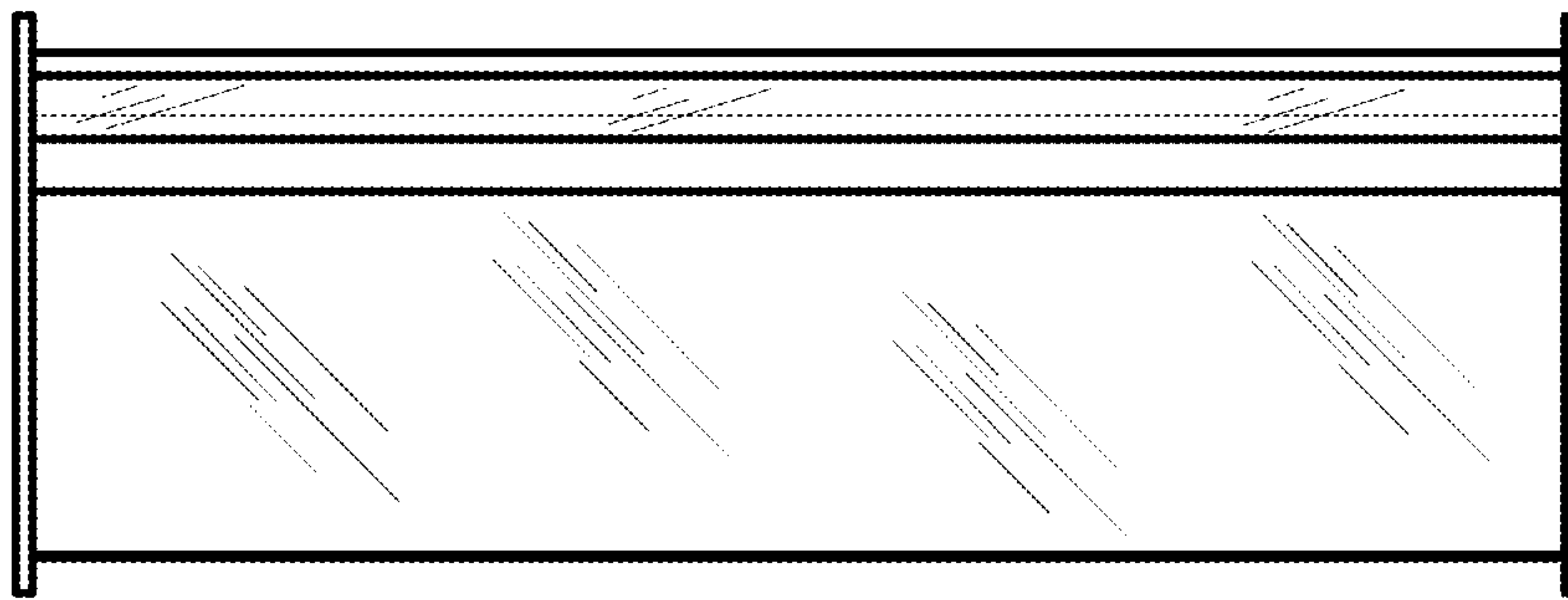

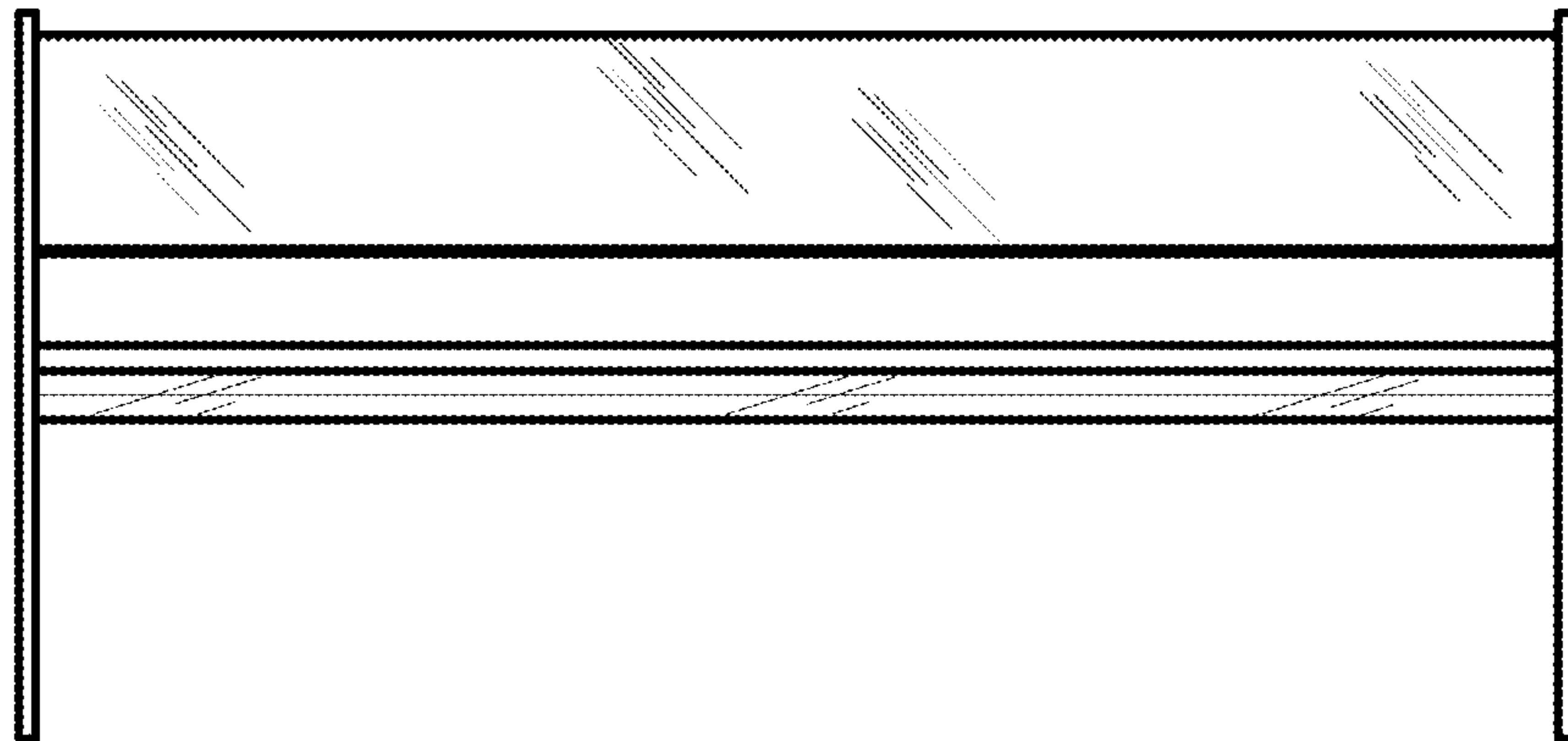

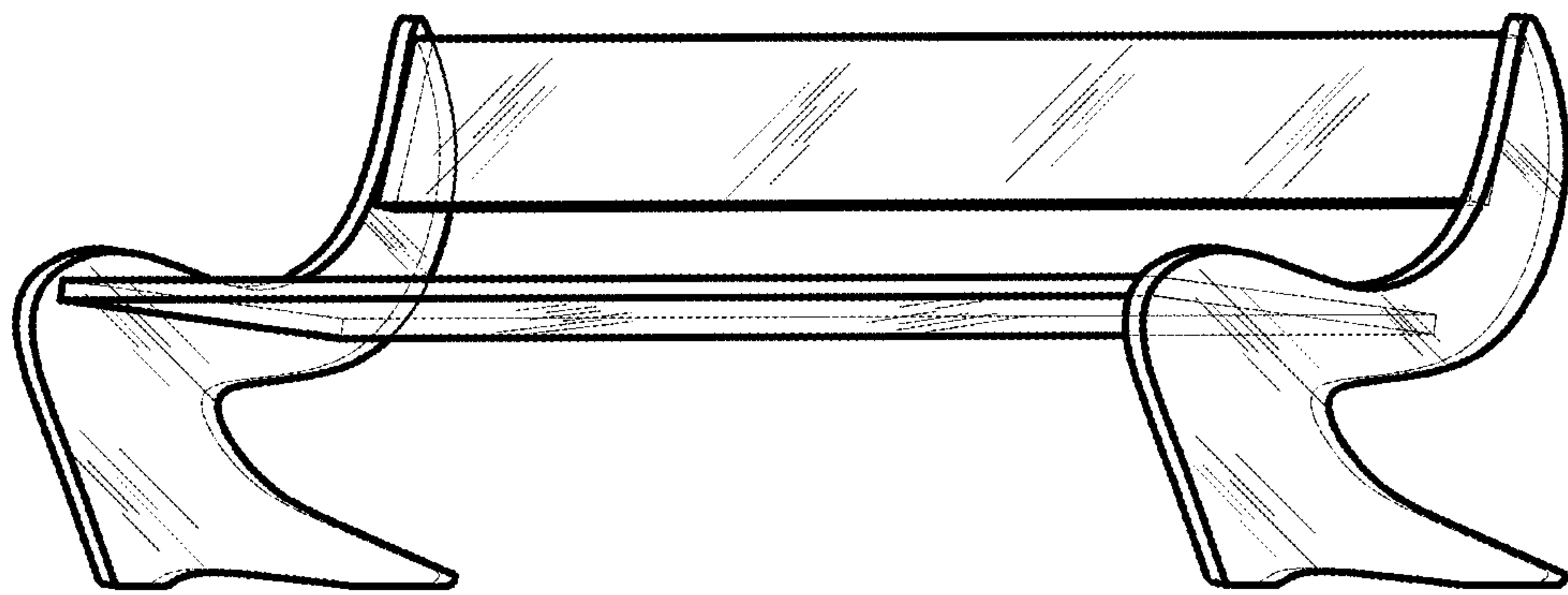

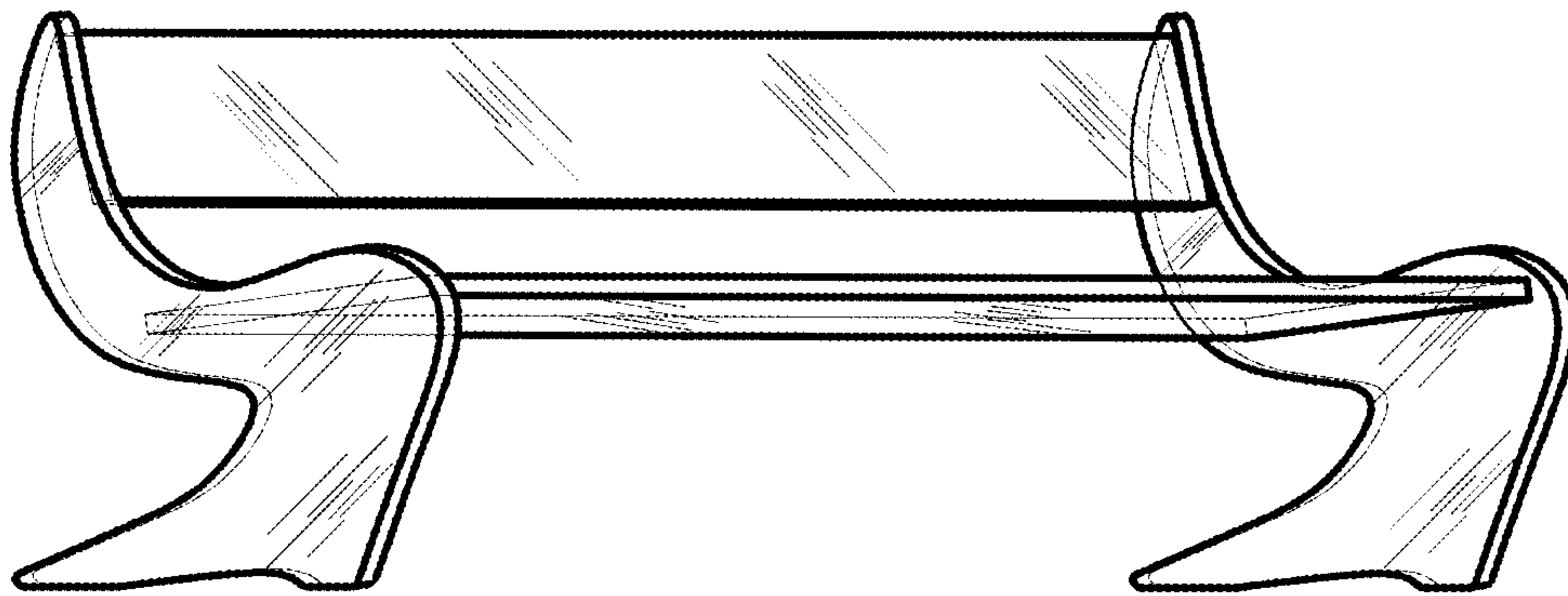

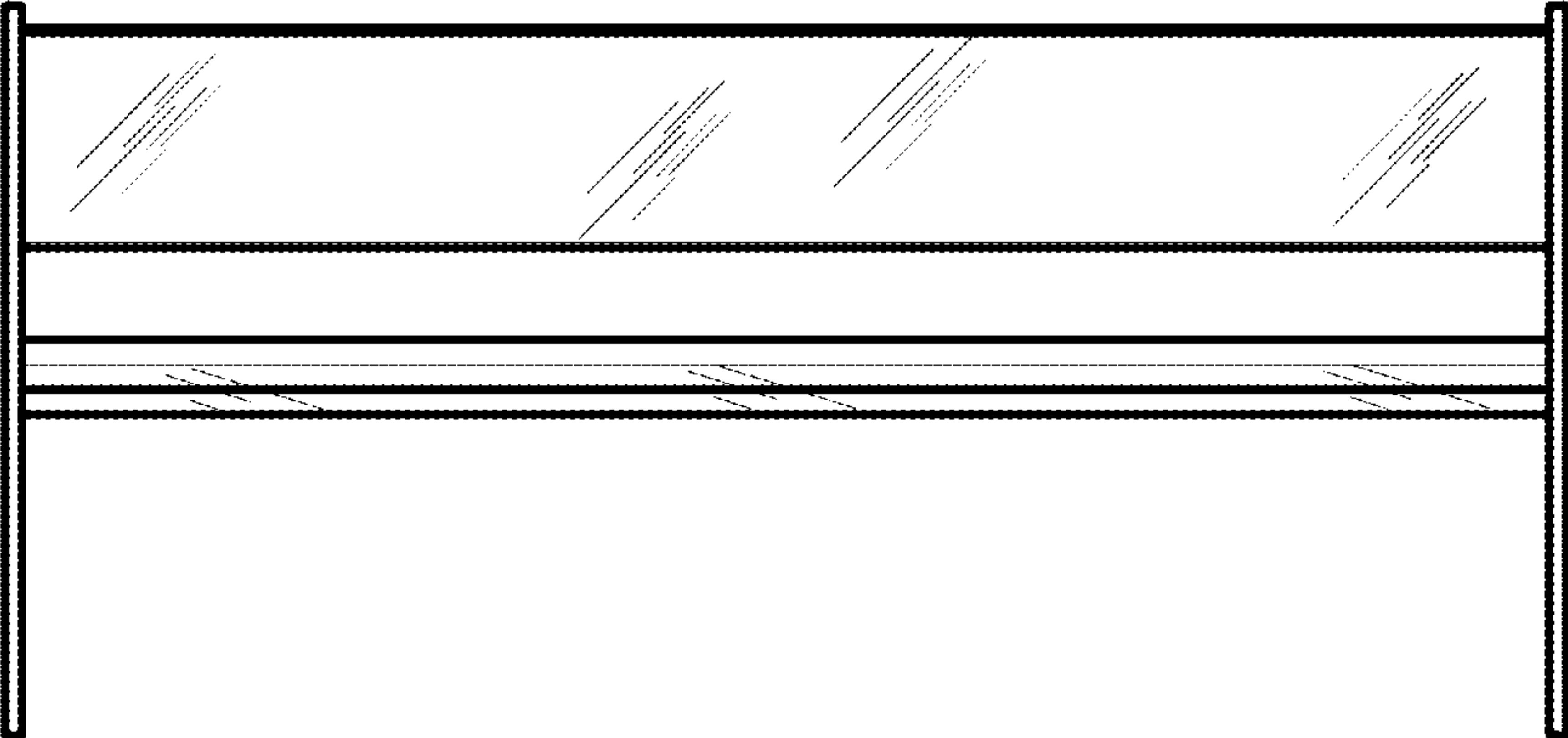

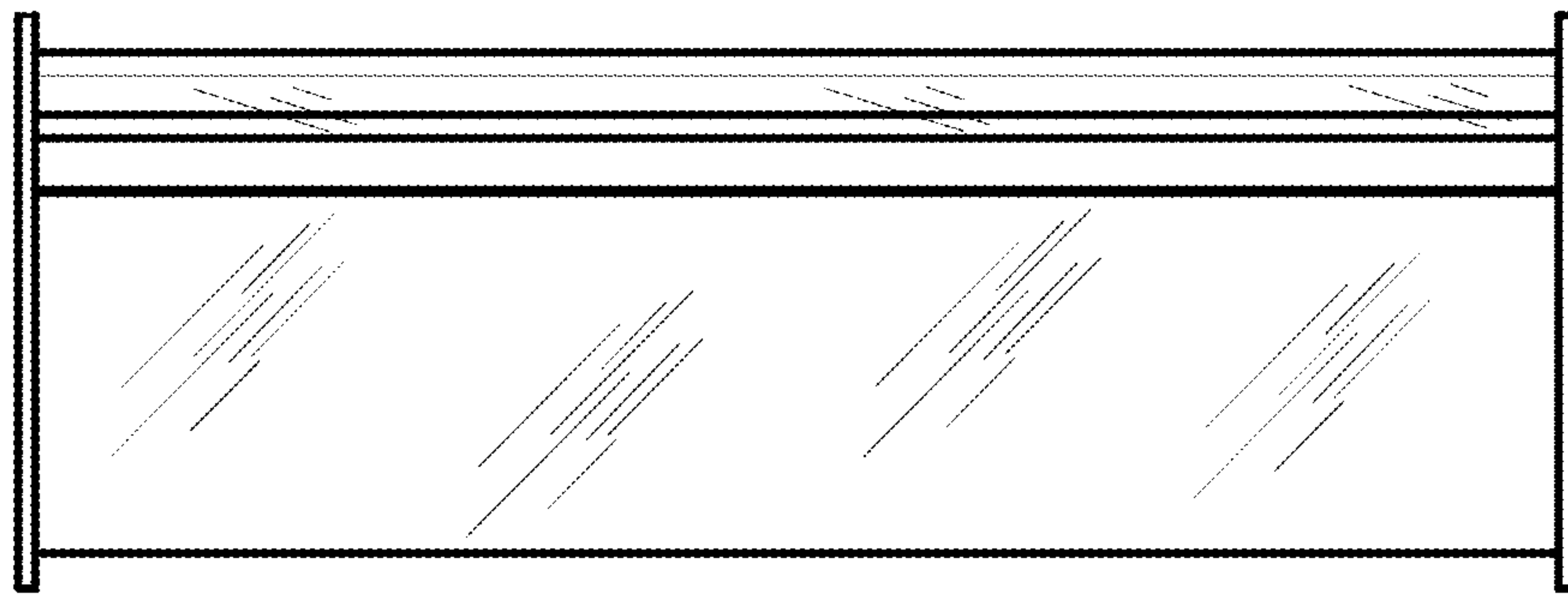
