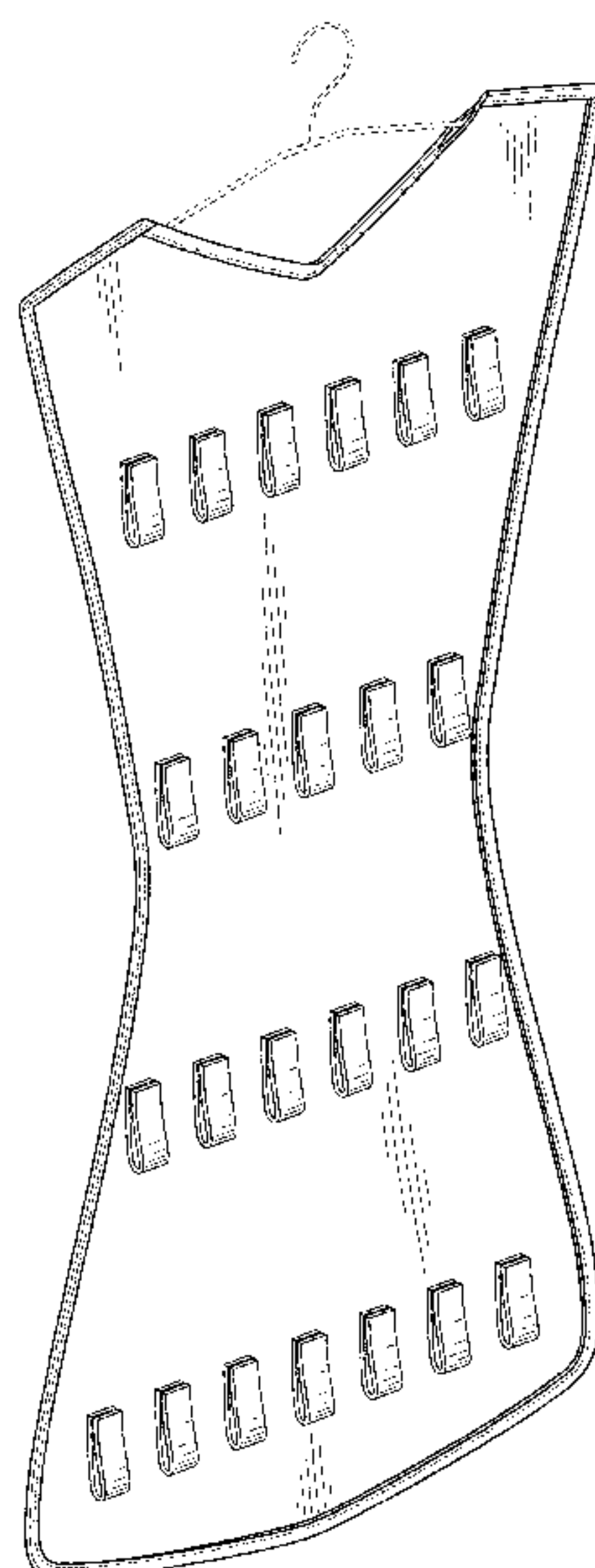
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front right perspective view showing the new design;
FIG. 2 is a front elevation view of FIG. 1;
FIG. 3 is a back elevation view of FIG. 1;
FIG. 4 is a left side view of FIG. 1;
FIG. 5 is a right side view of FIG. 1;
FIG. 6 is a top plan view of FIG. 1;
FIG. 7 is a bottom plan view of FIG. 1; and,
FIG. 8 is a back left perspective view of FIG. 1.

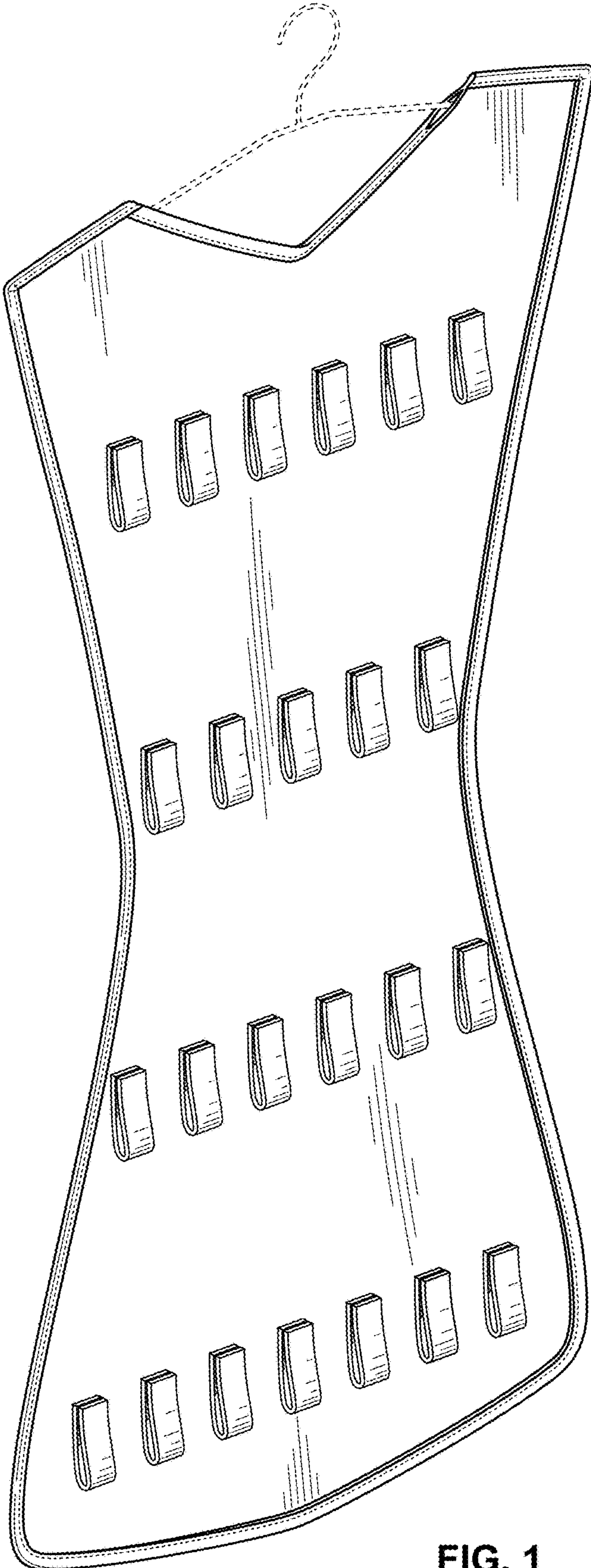

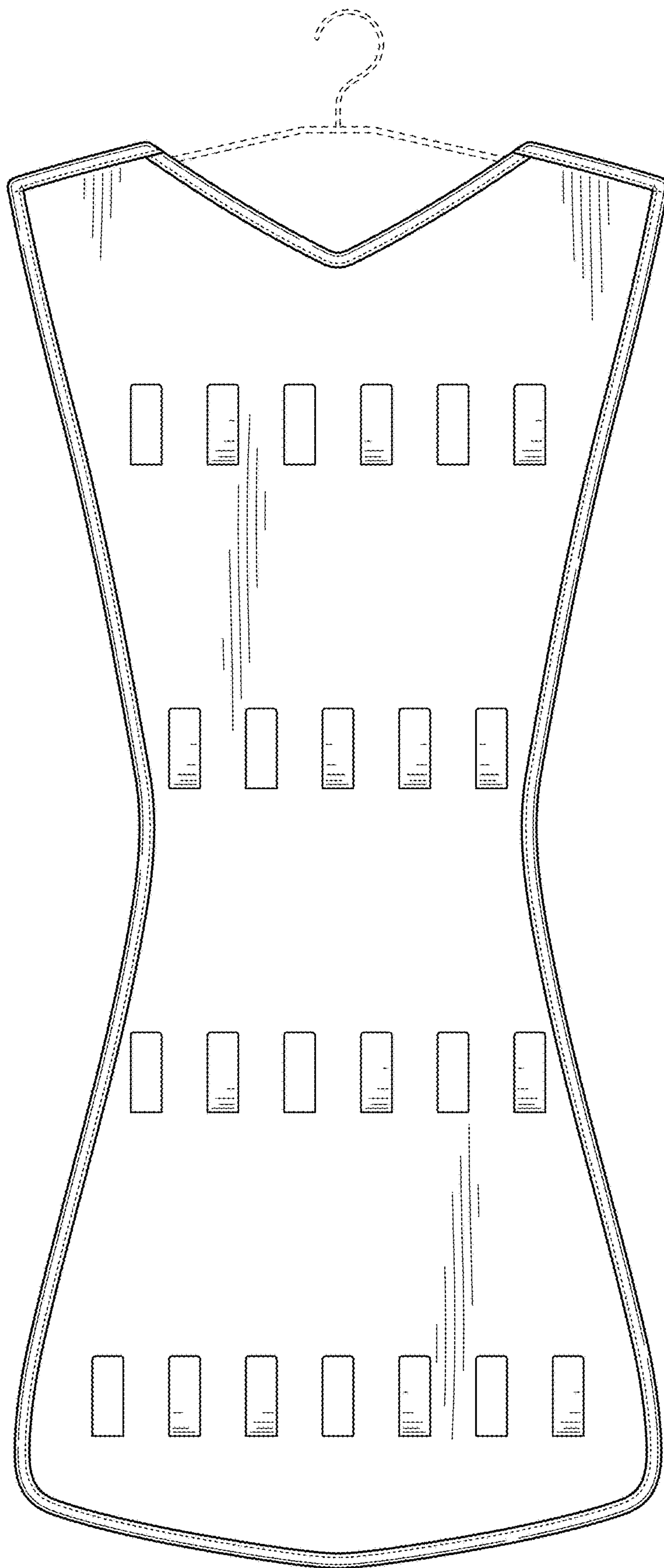

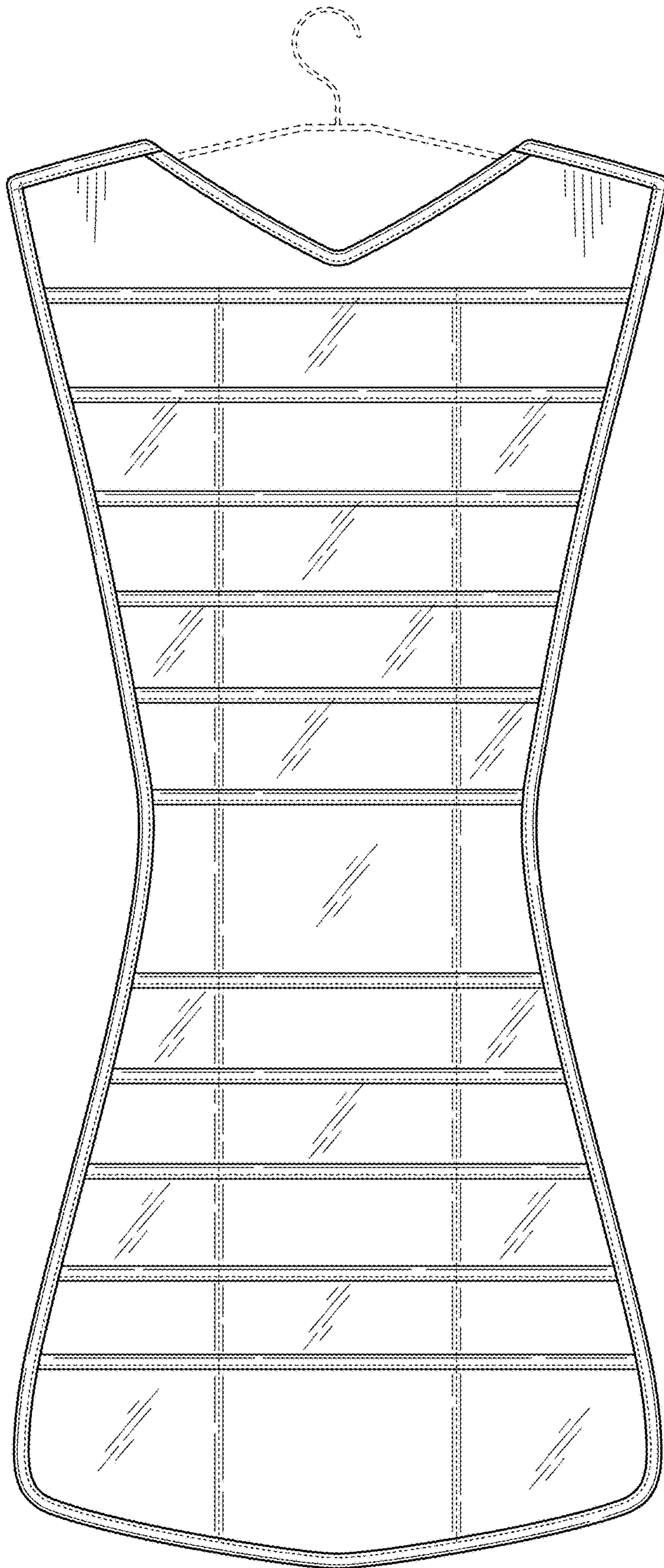

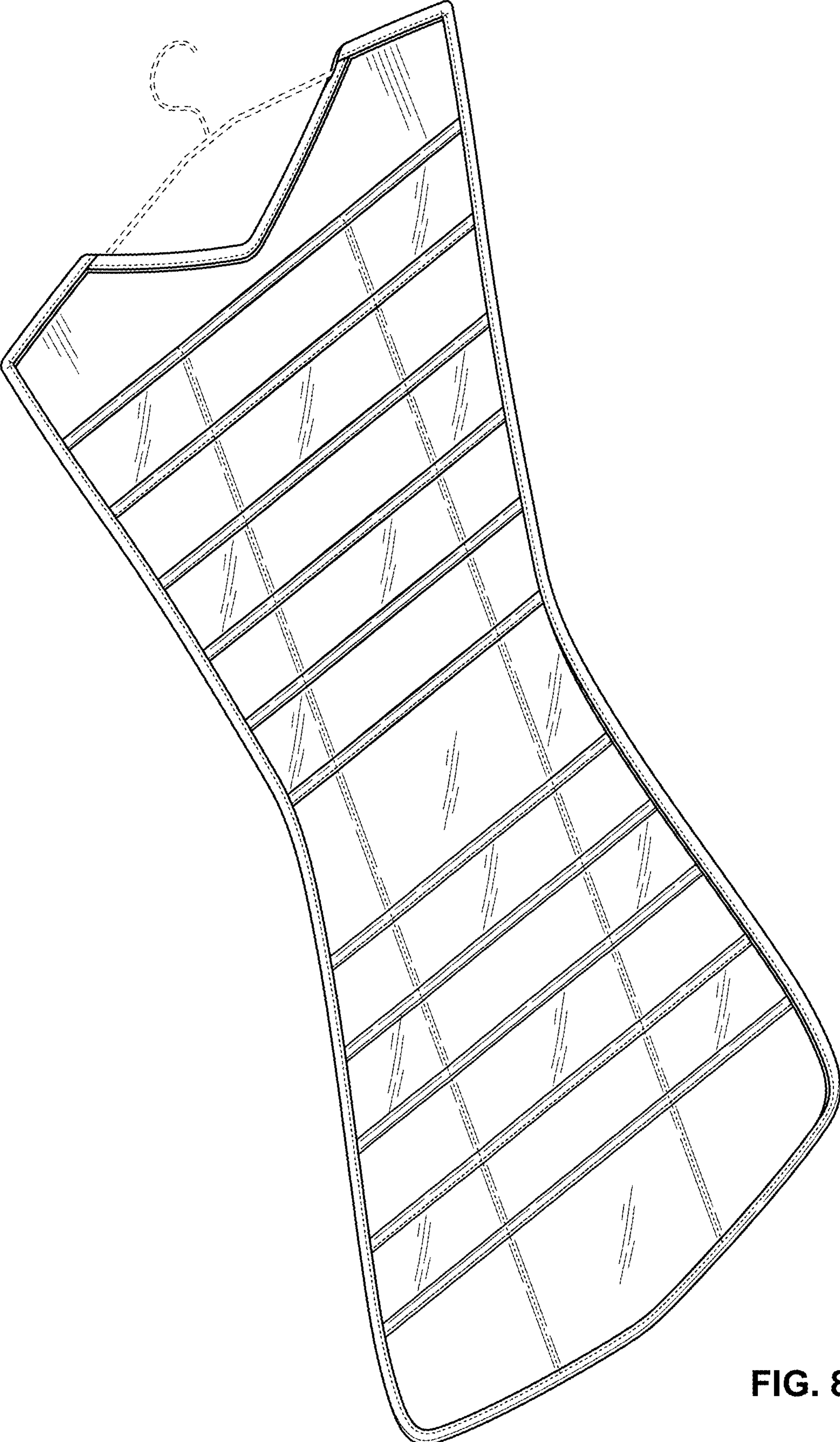
