FIG. 1 is a front perspective view of a vanity with wrap-around drawer fronts.

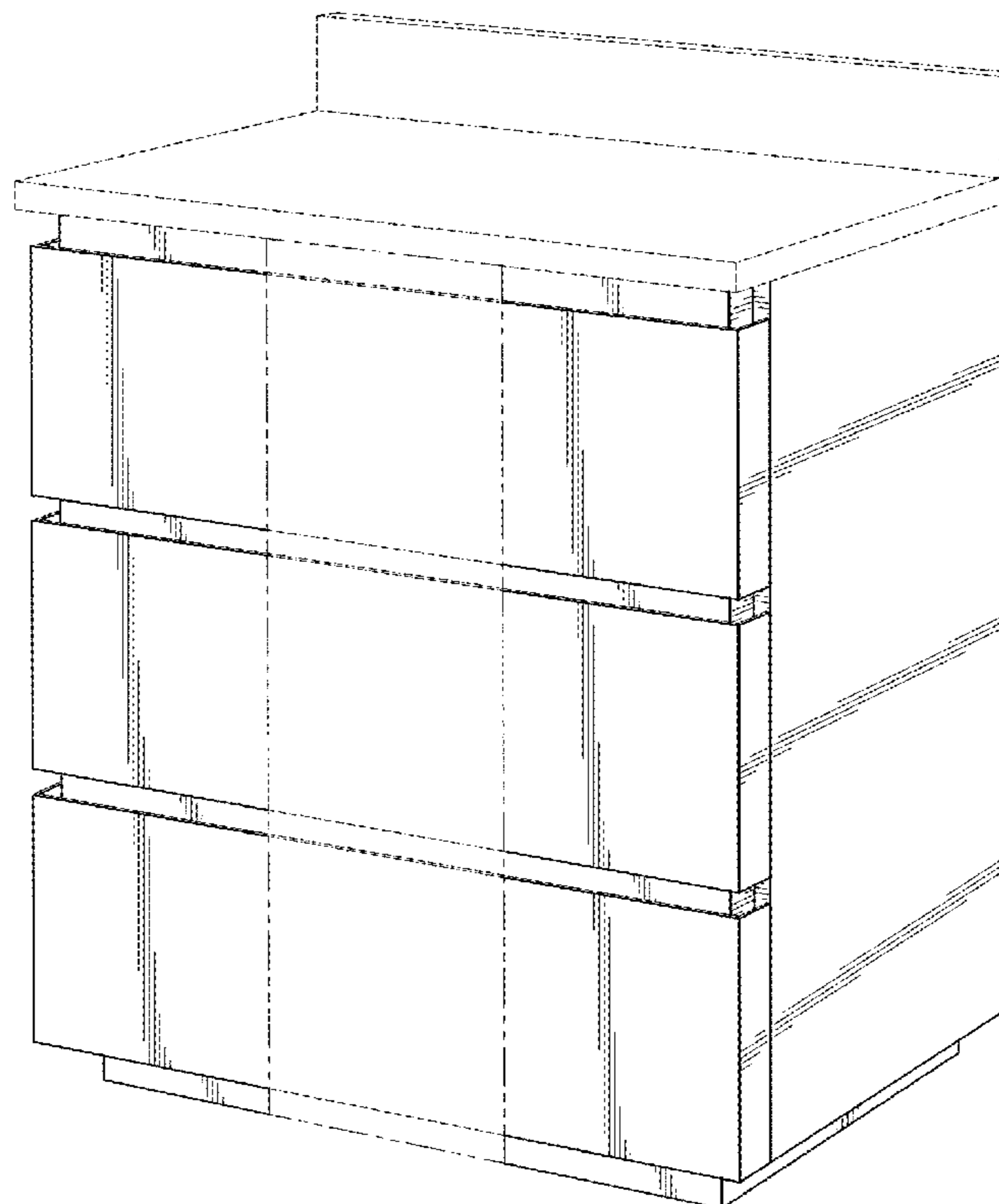
FIG. 2 is a front view thereof

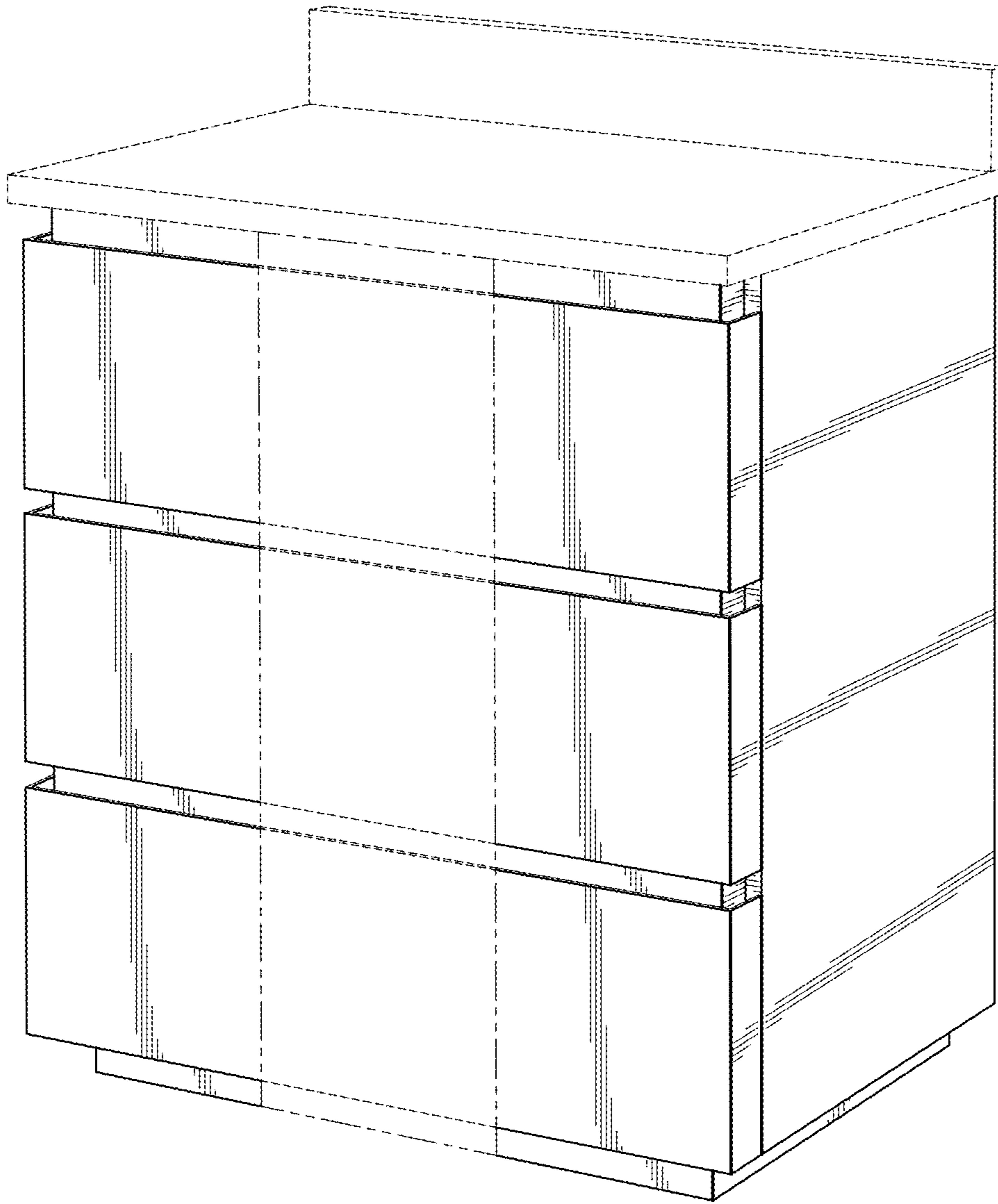

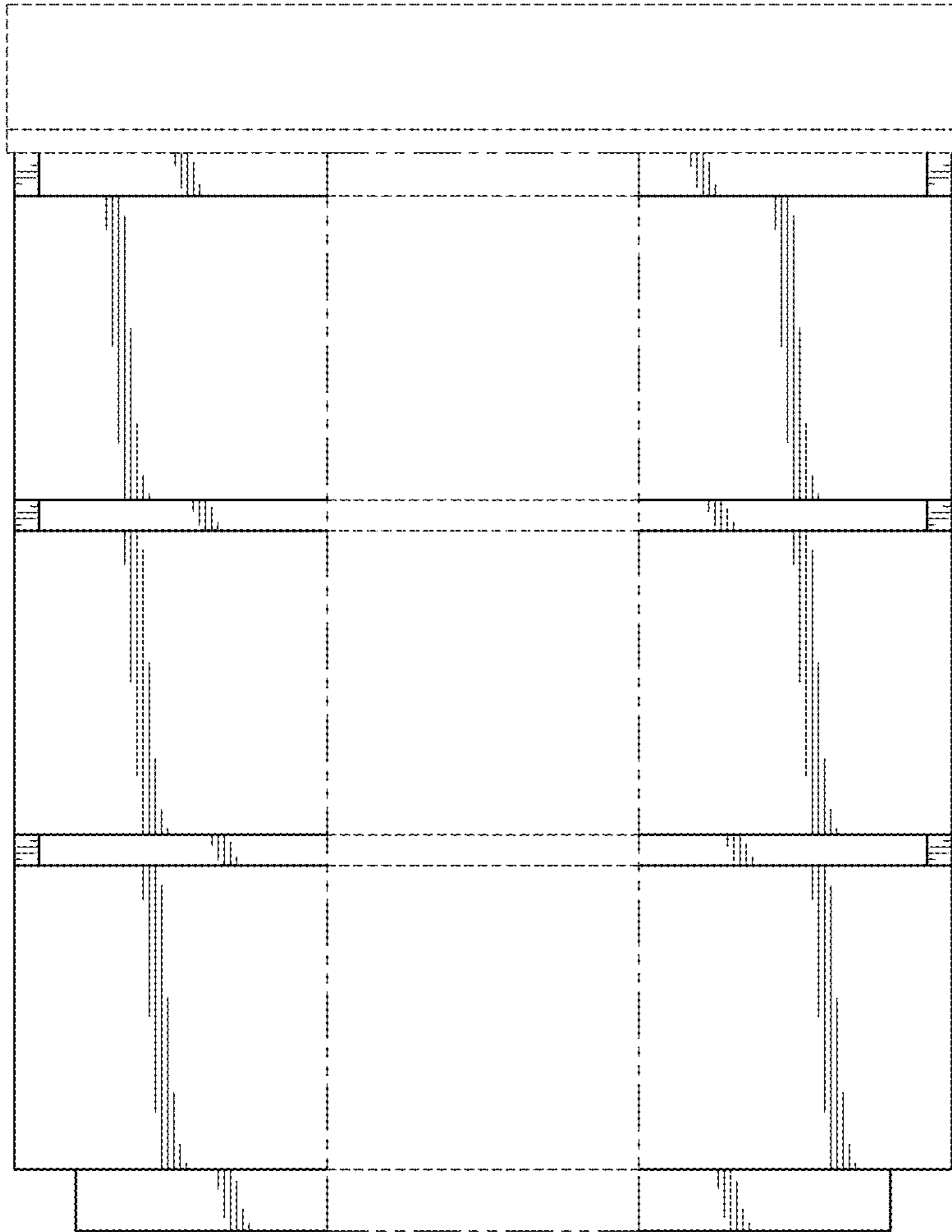

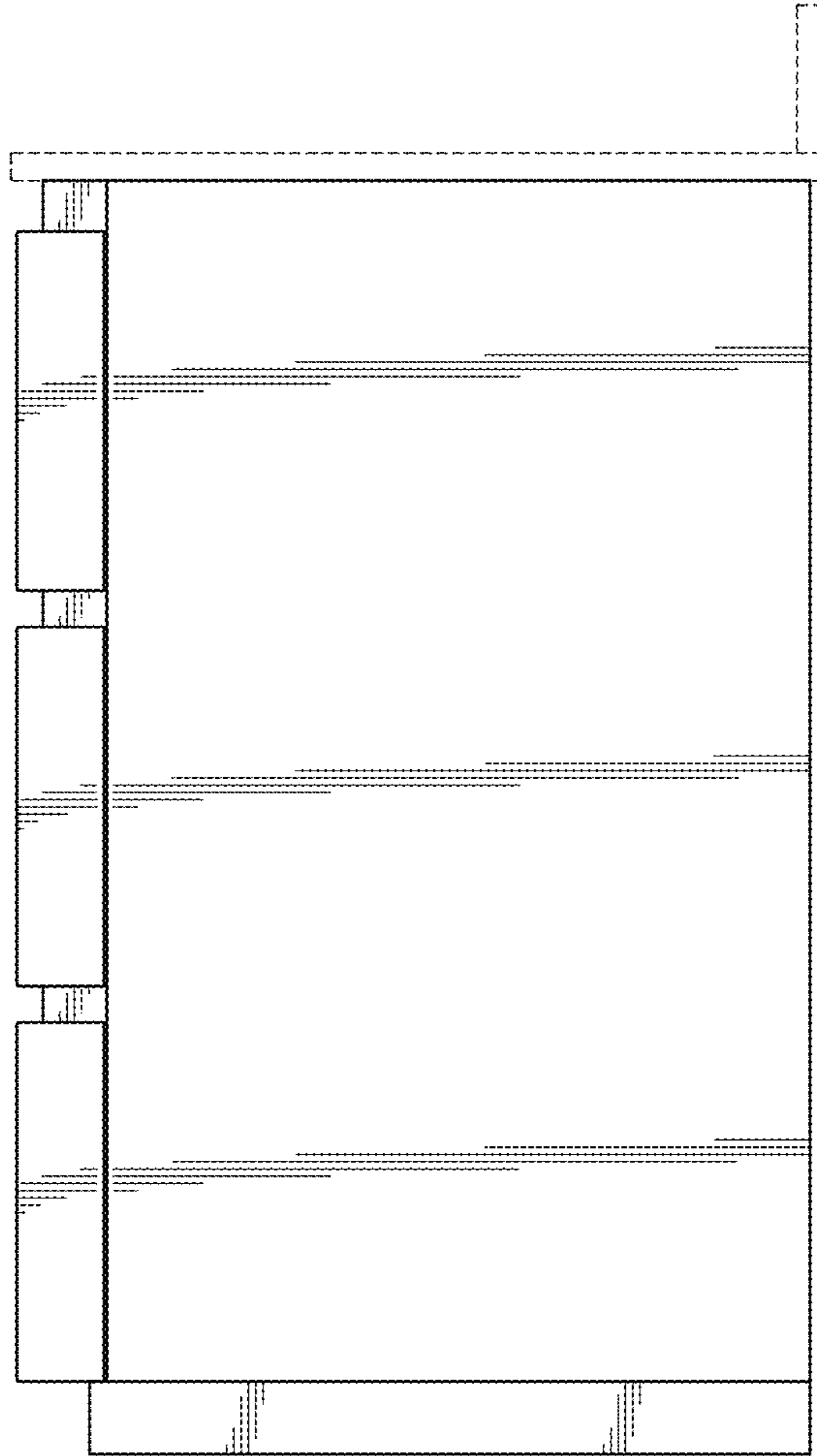
