(57) **CLAIM**

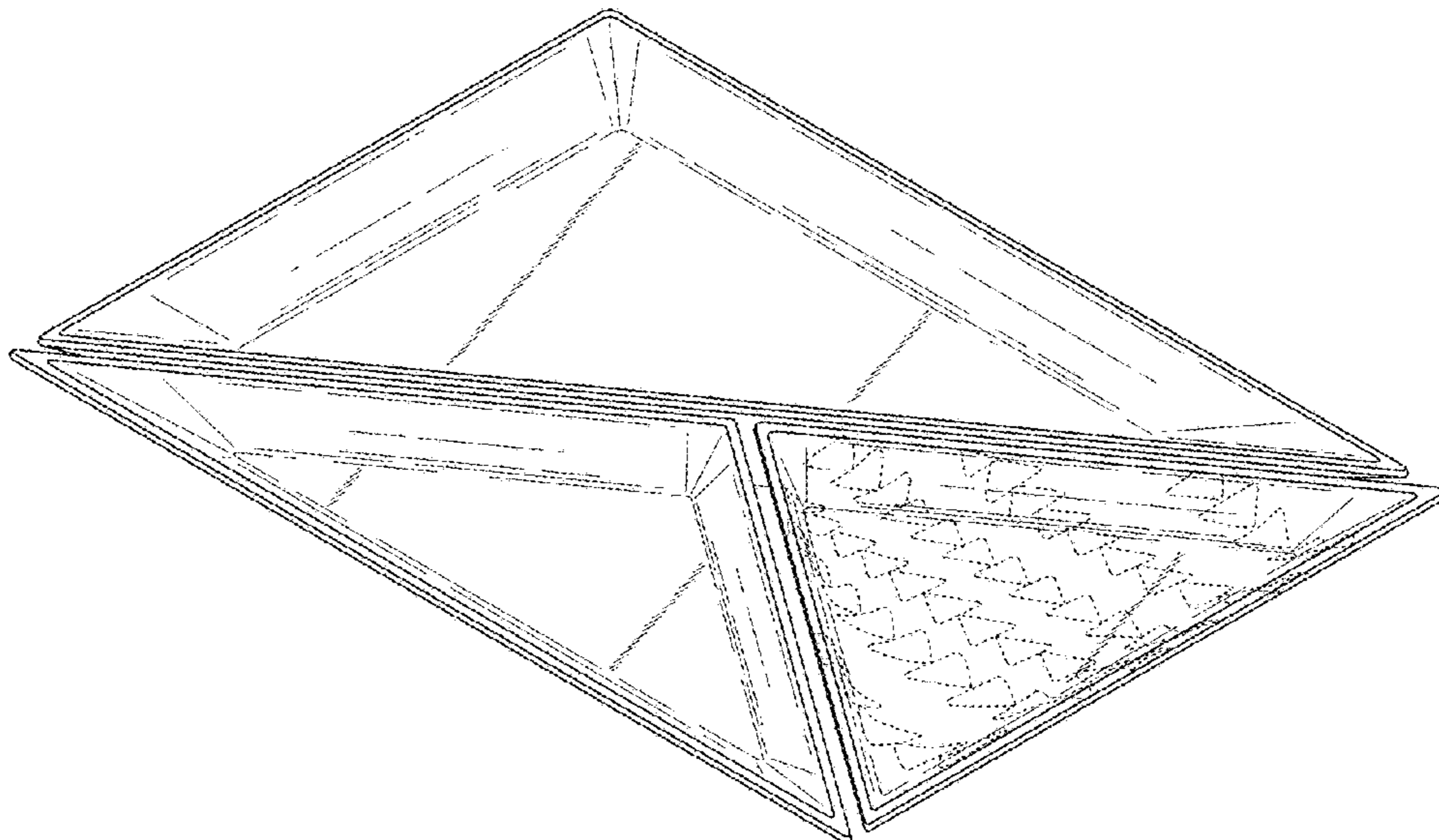
The ornamental design for a set of trays, as shown and described.

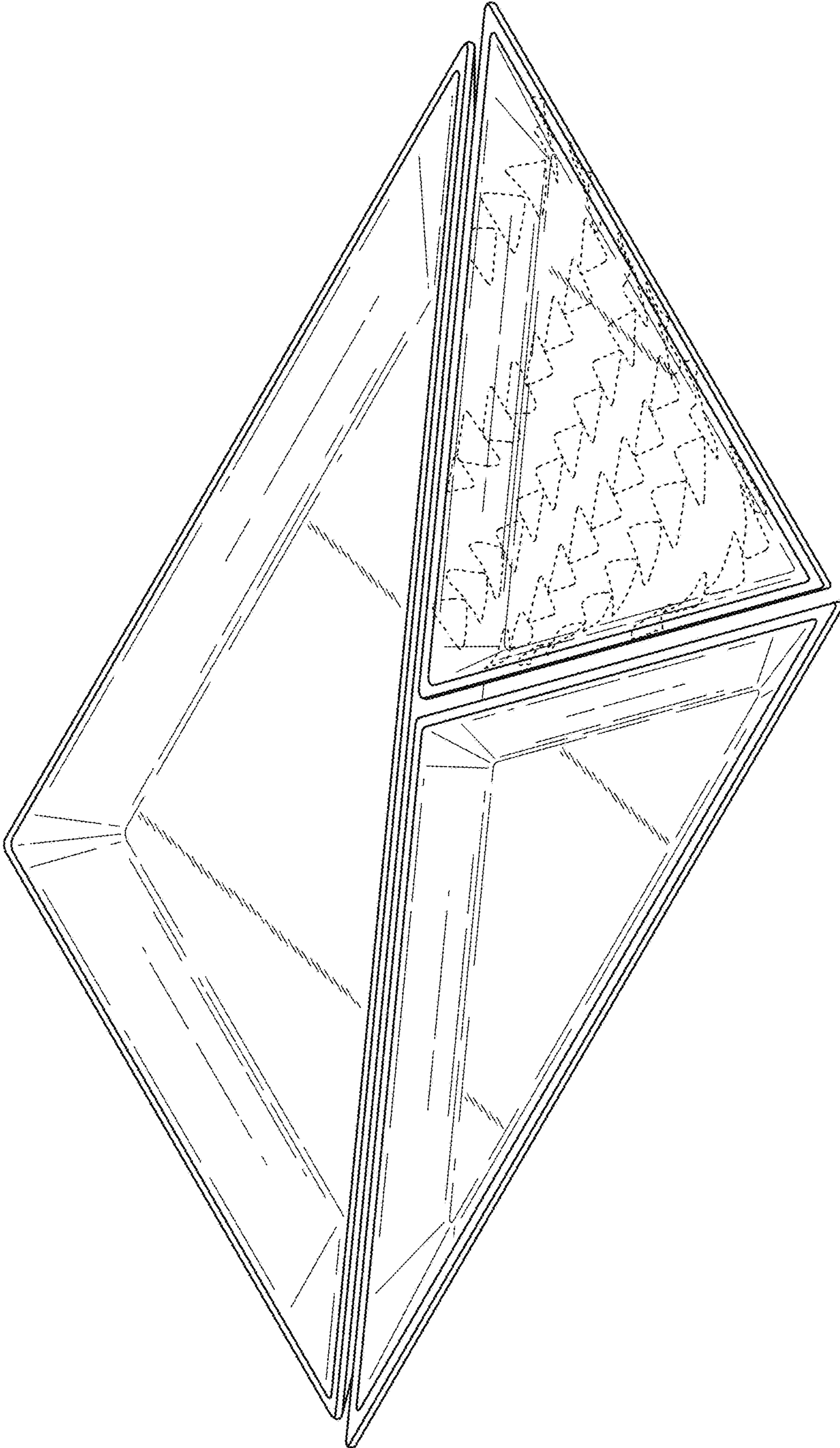

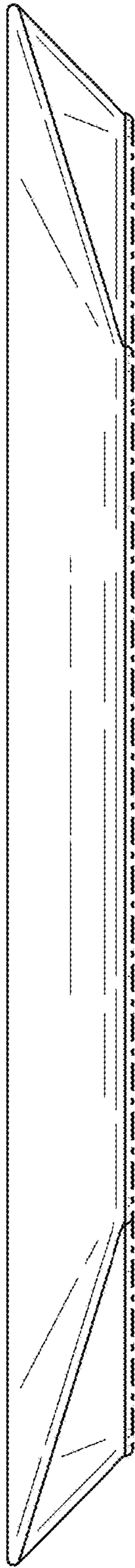

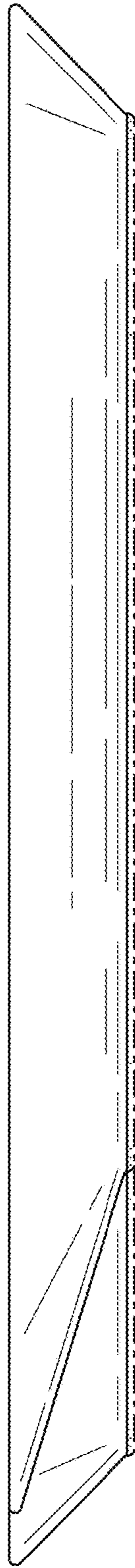

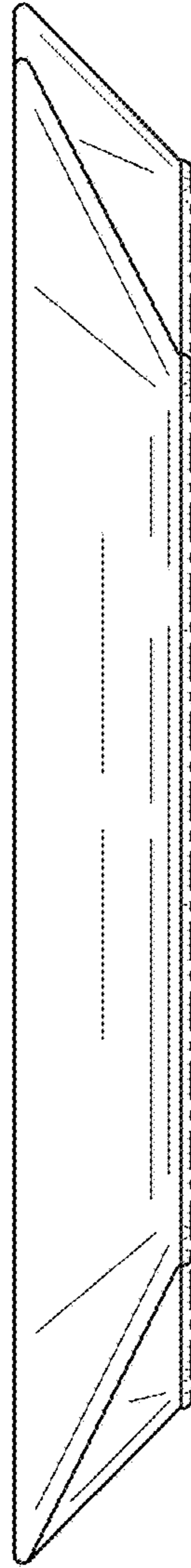

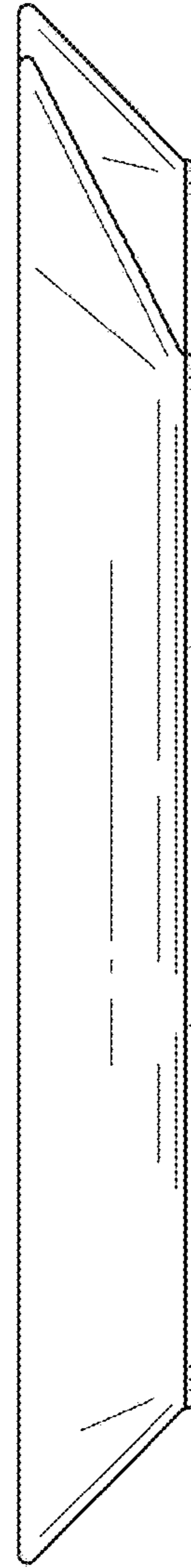

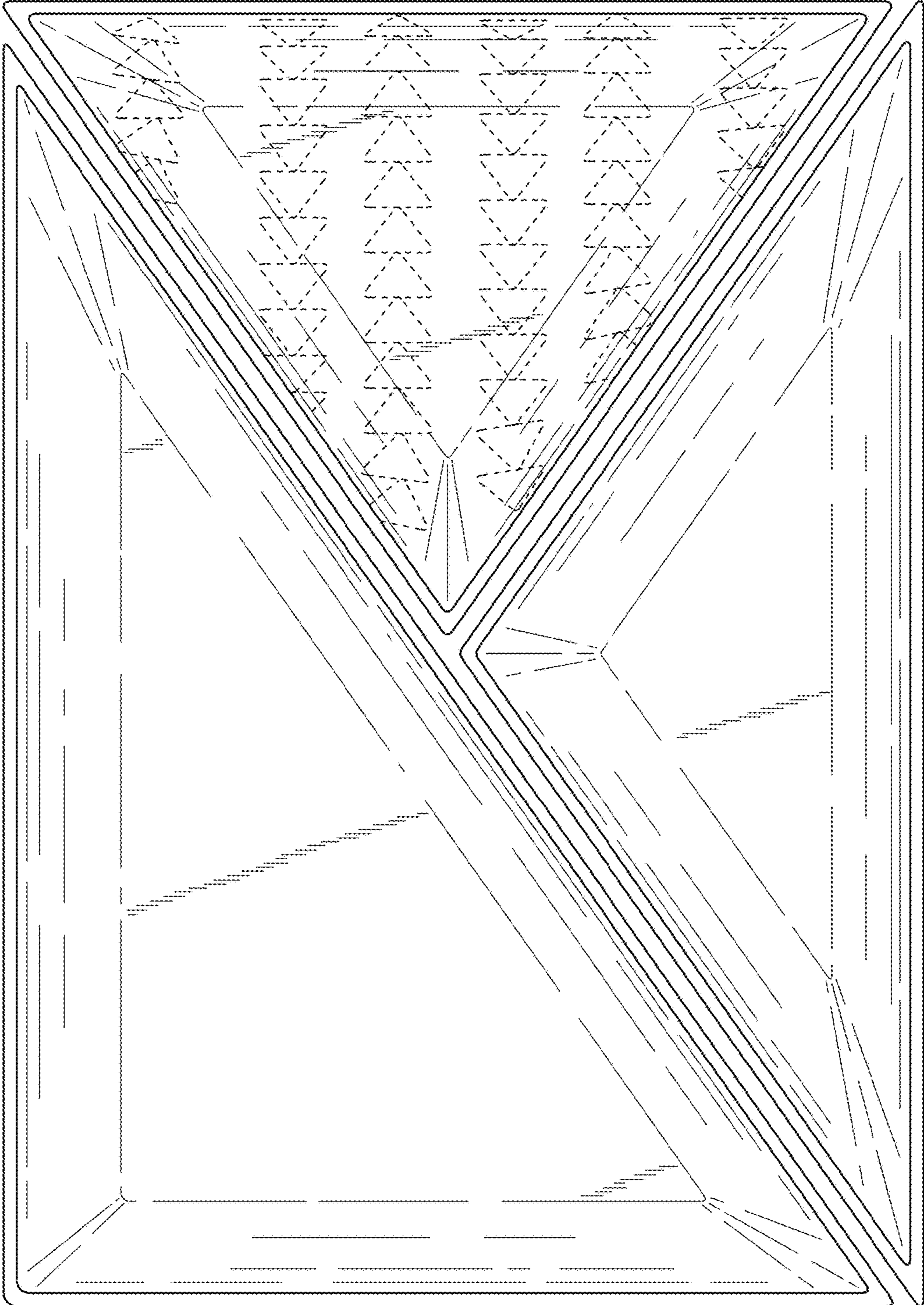

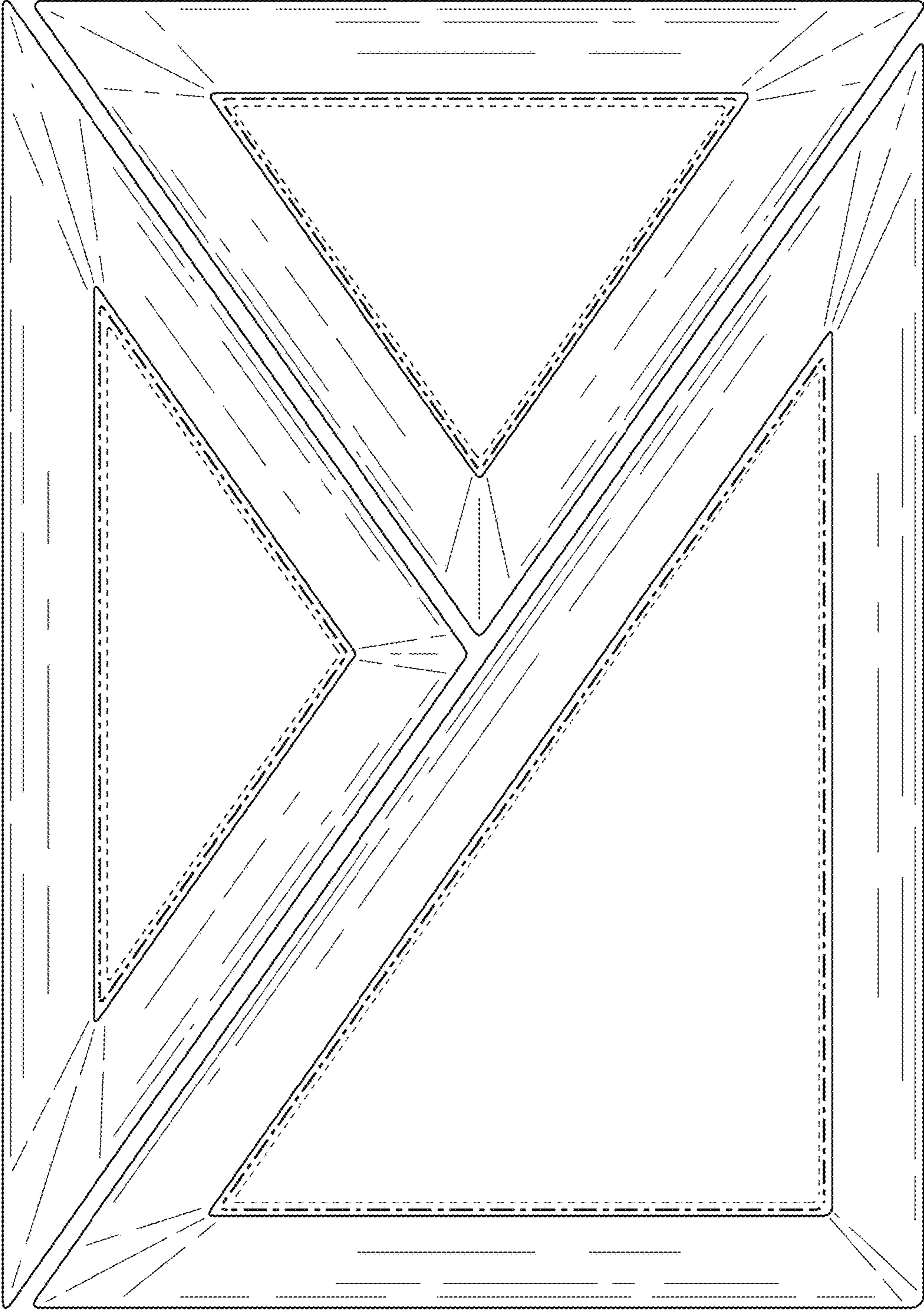
