container;

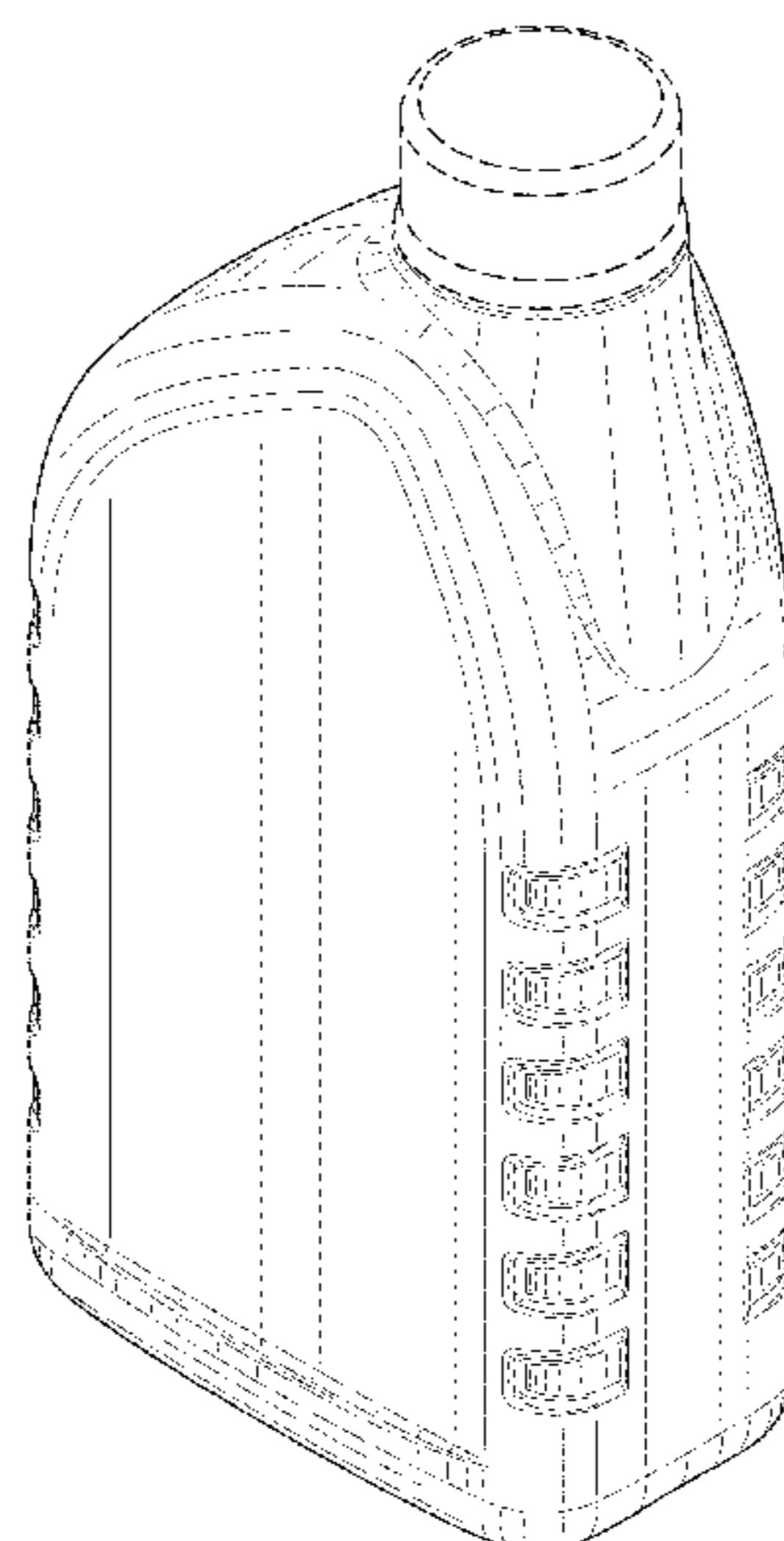
FIG. 6 is a top view of the ornamental design for the

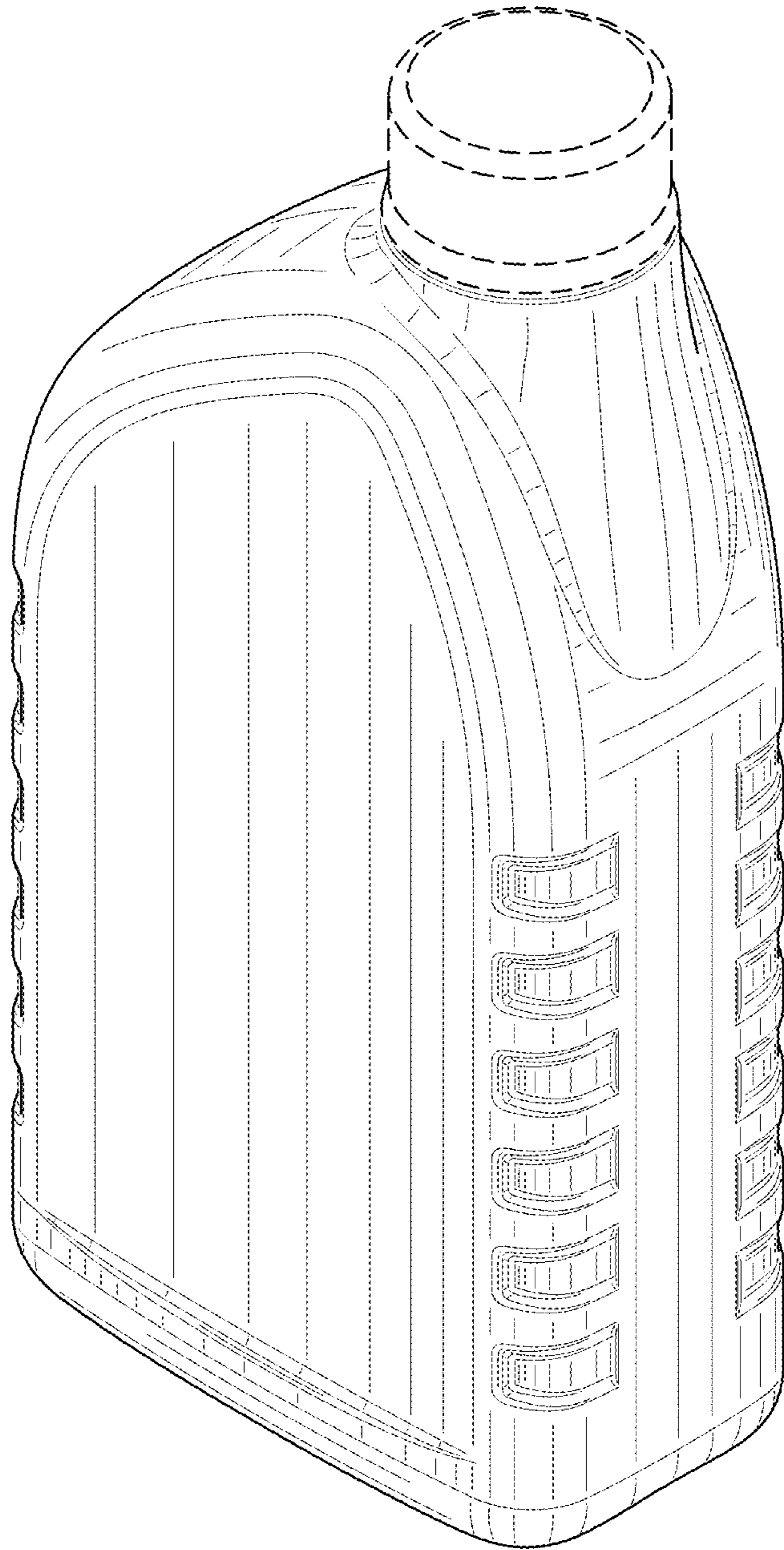

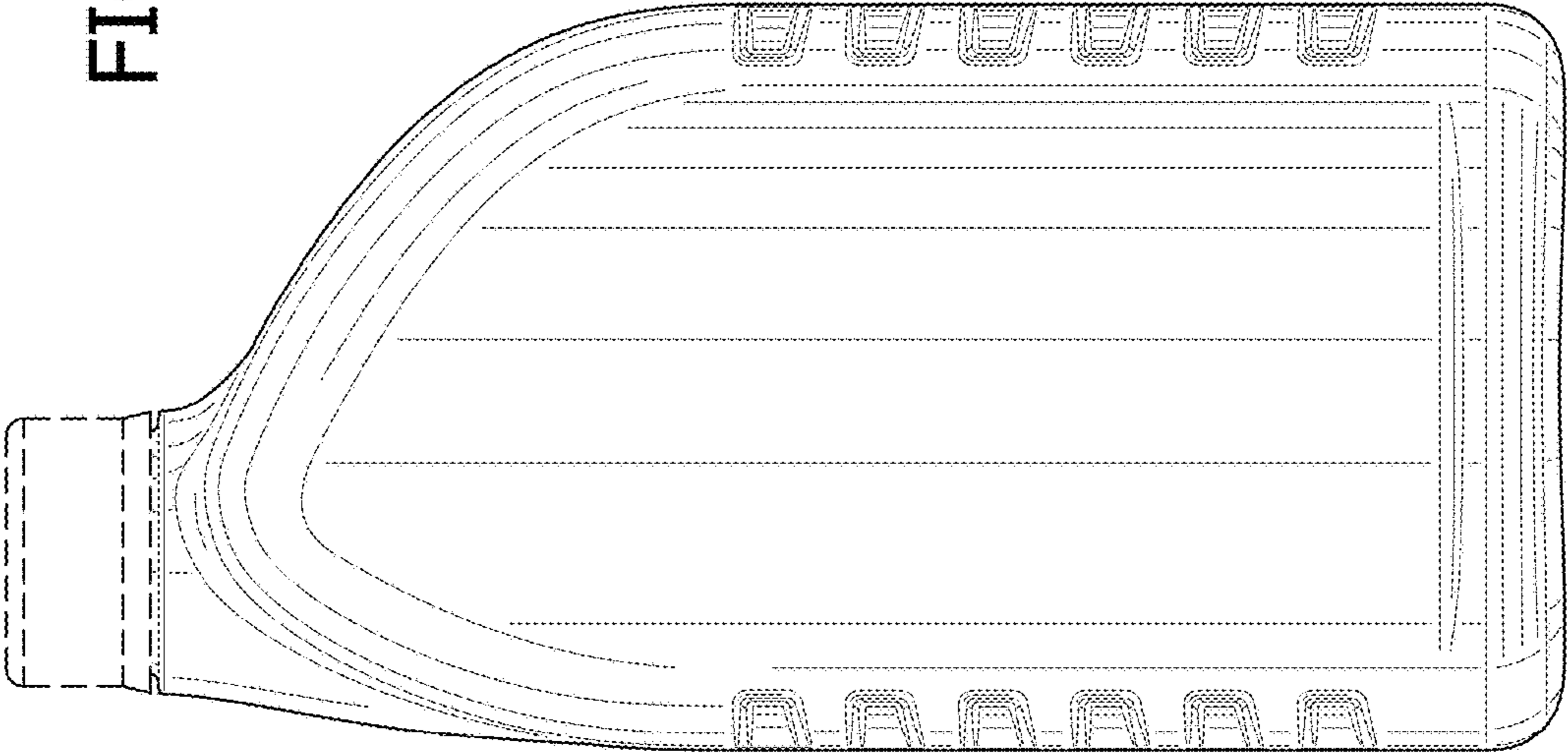
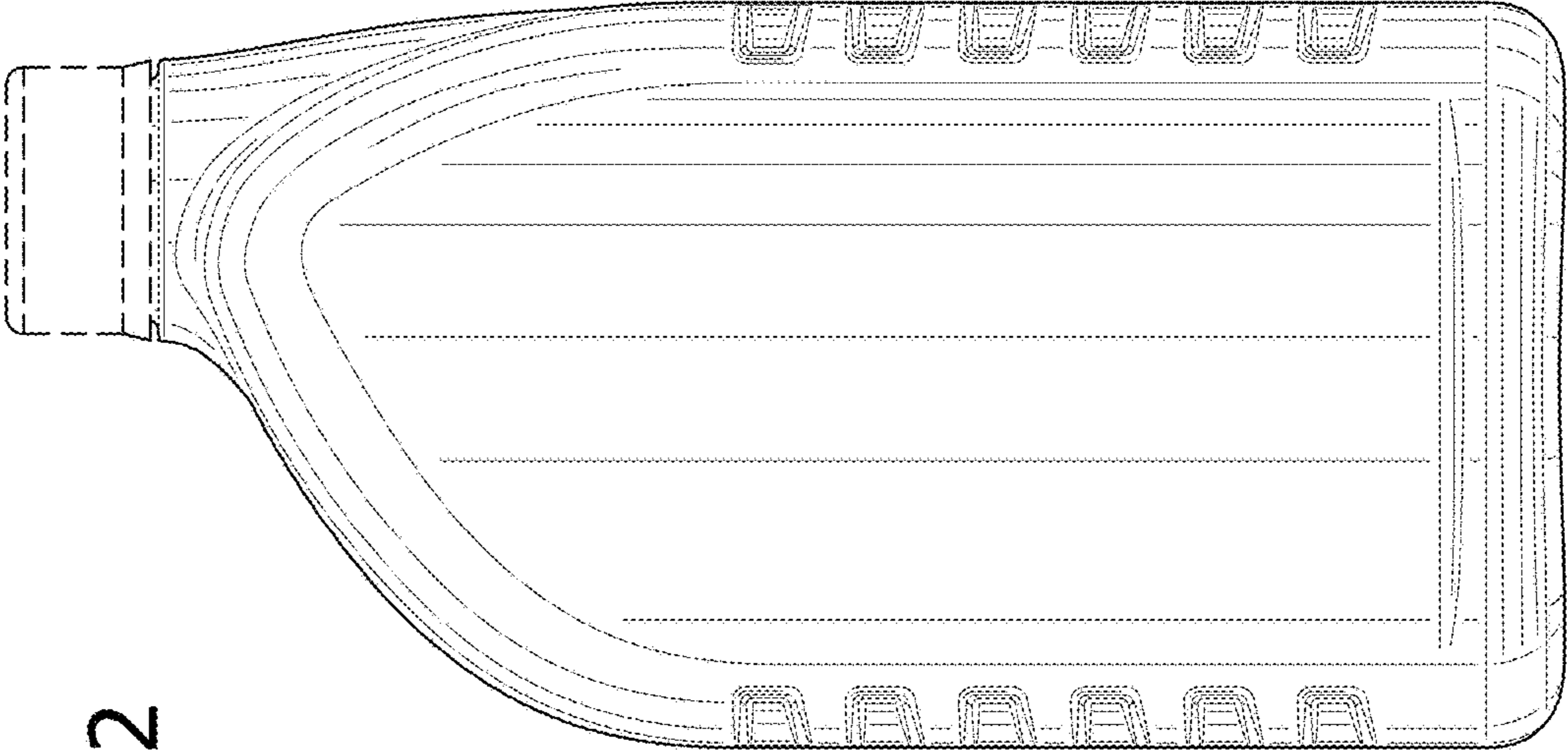

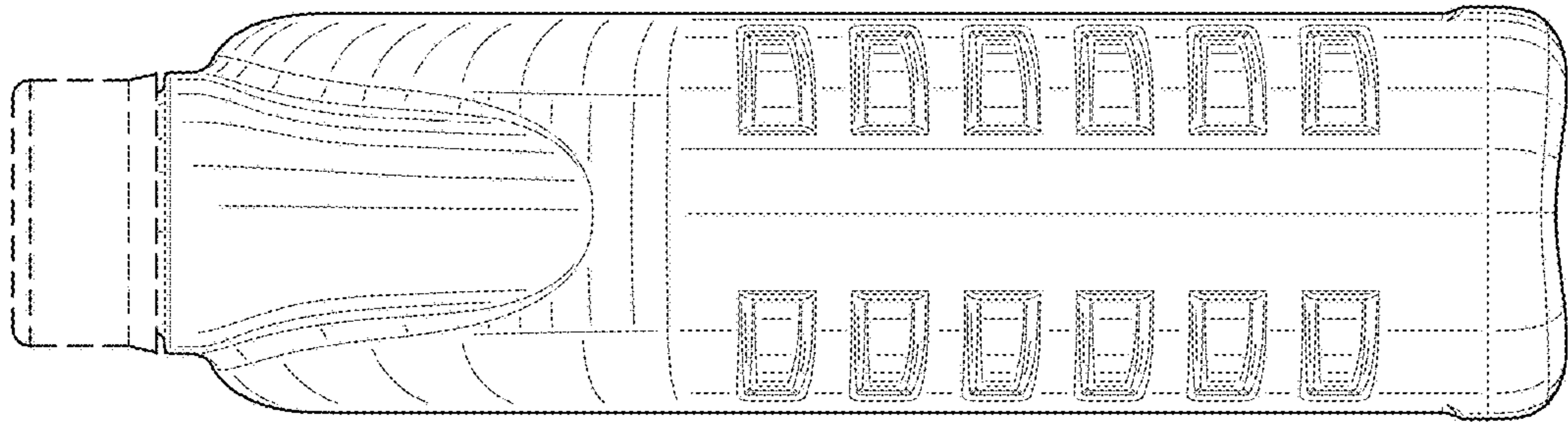

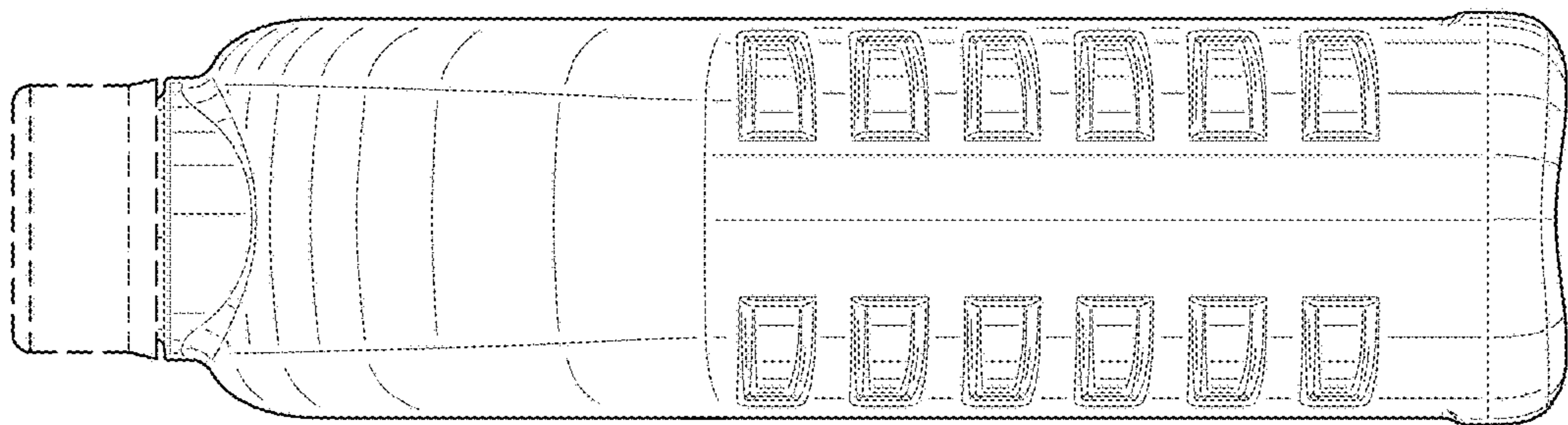

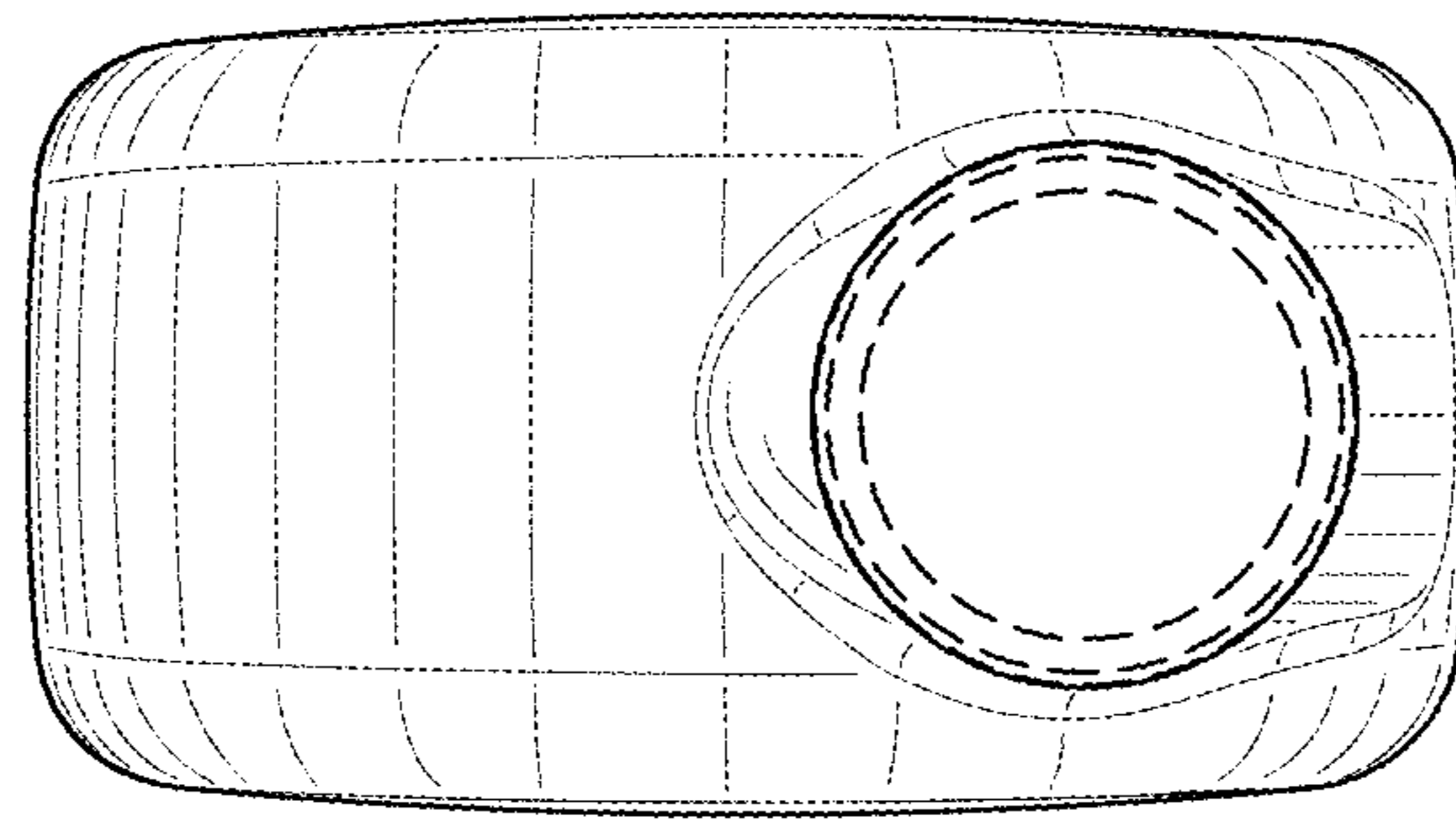

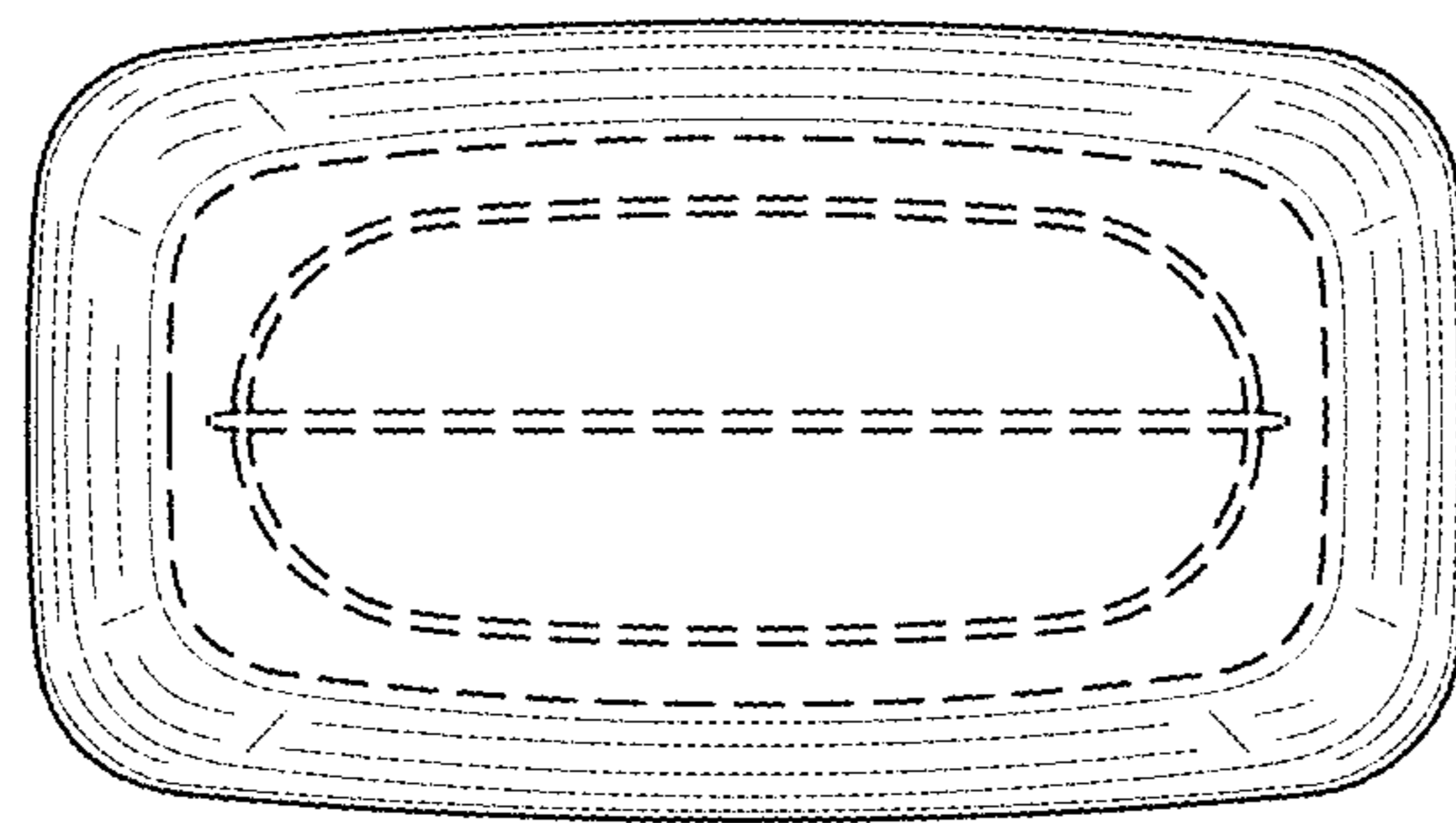

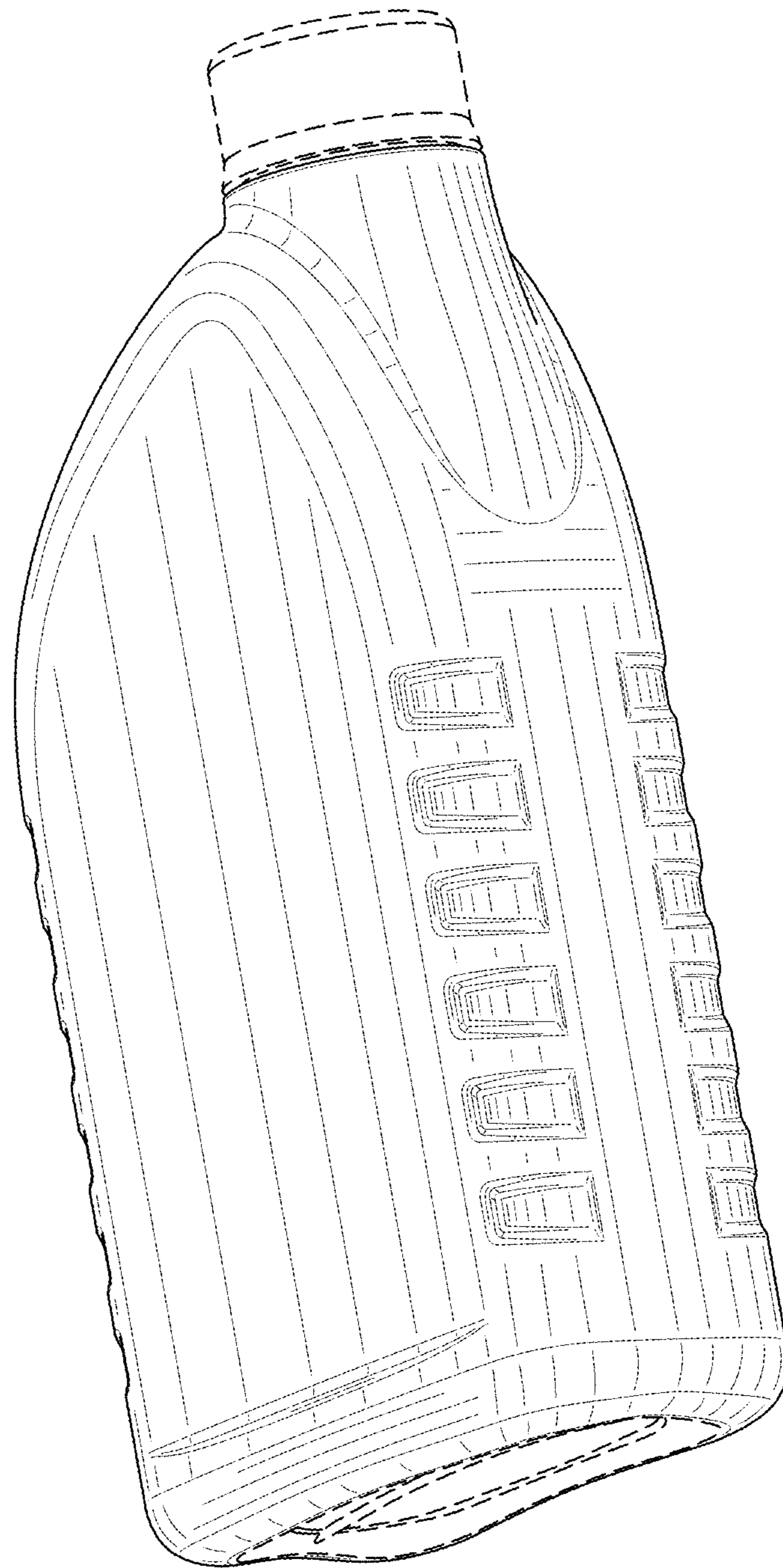
