FIG. 7 is a front, bottom, and left side perspective view thereof.

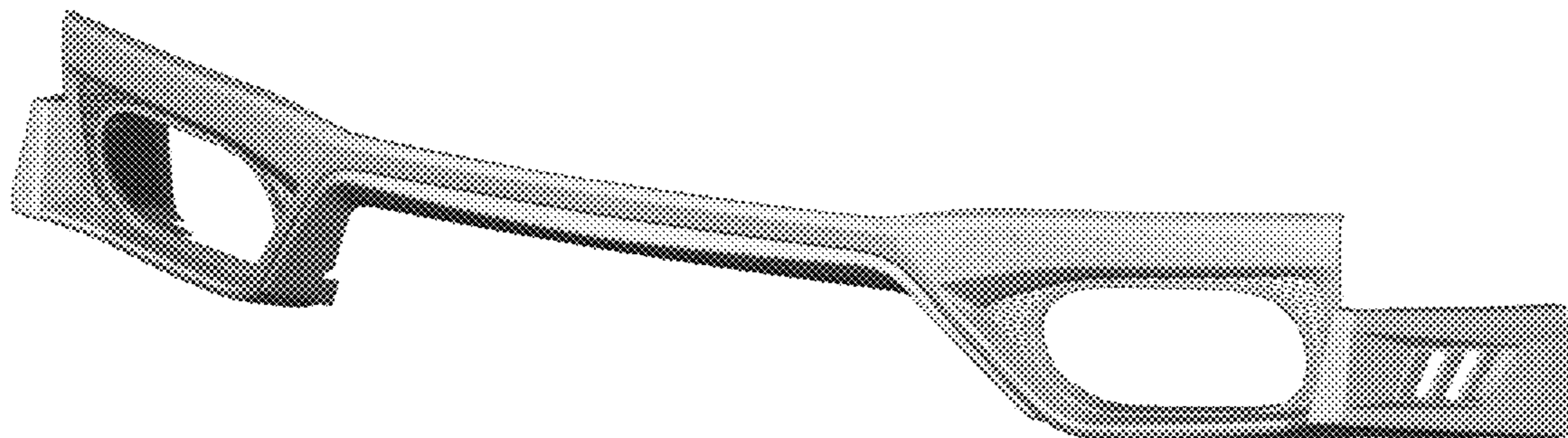

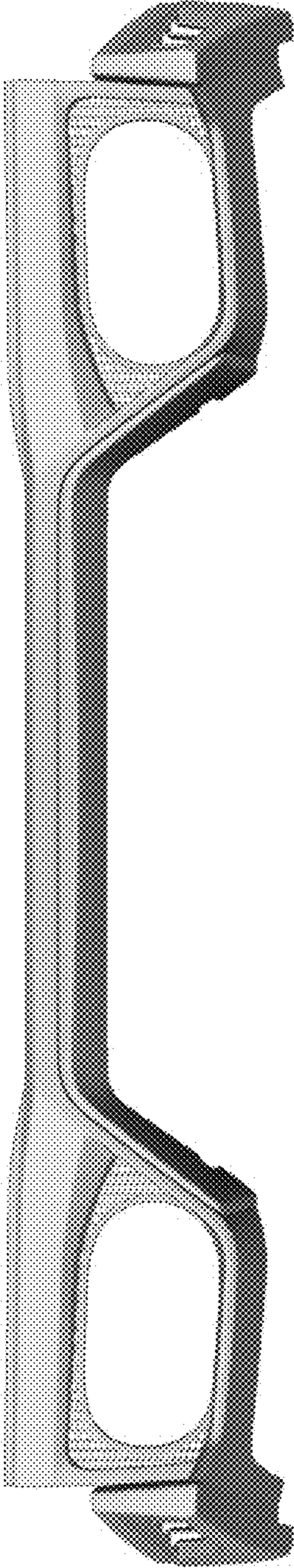

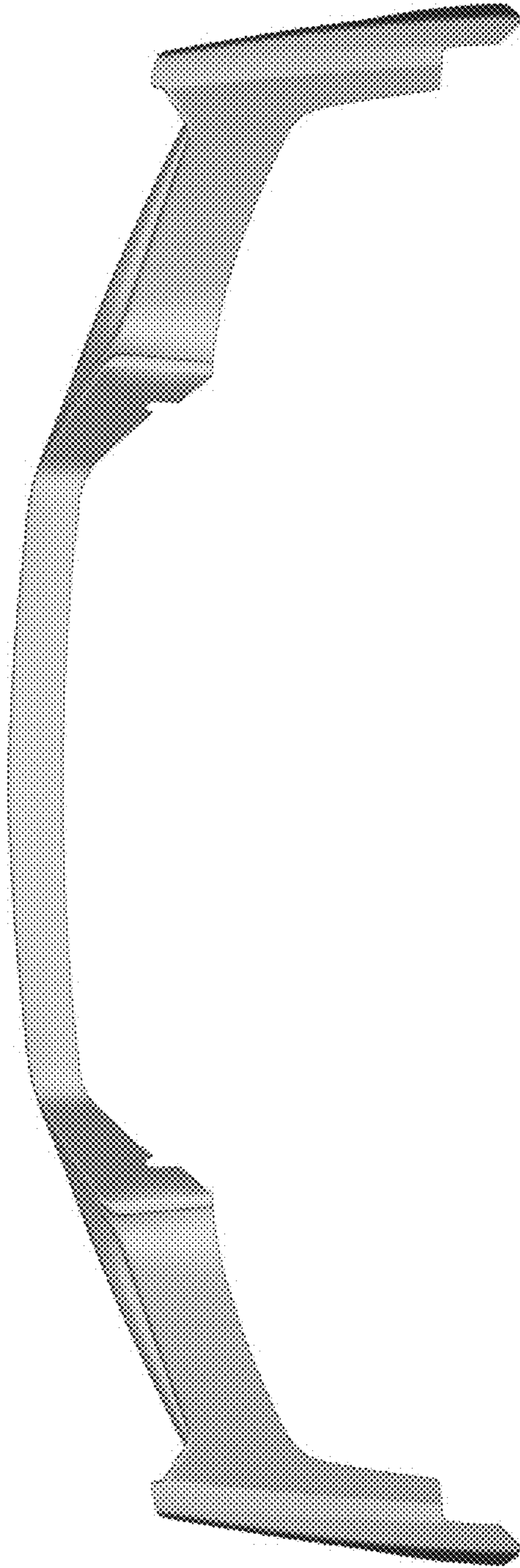

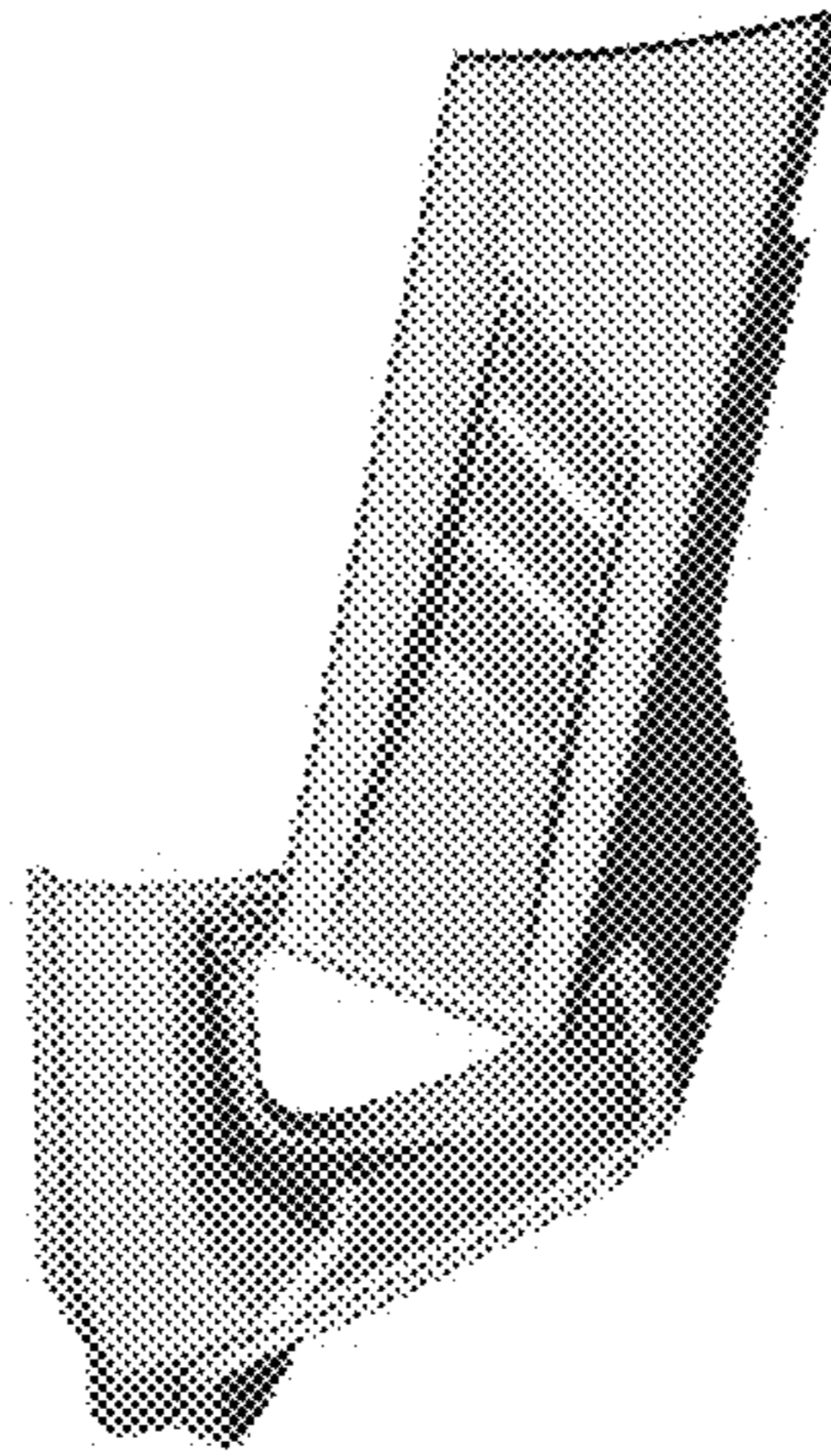

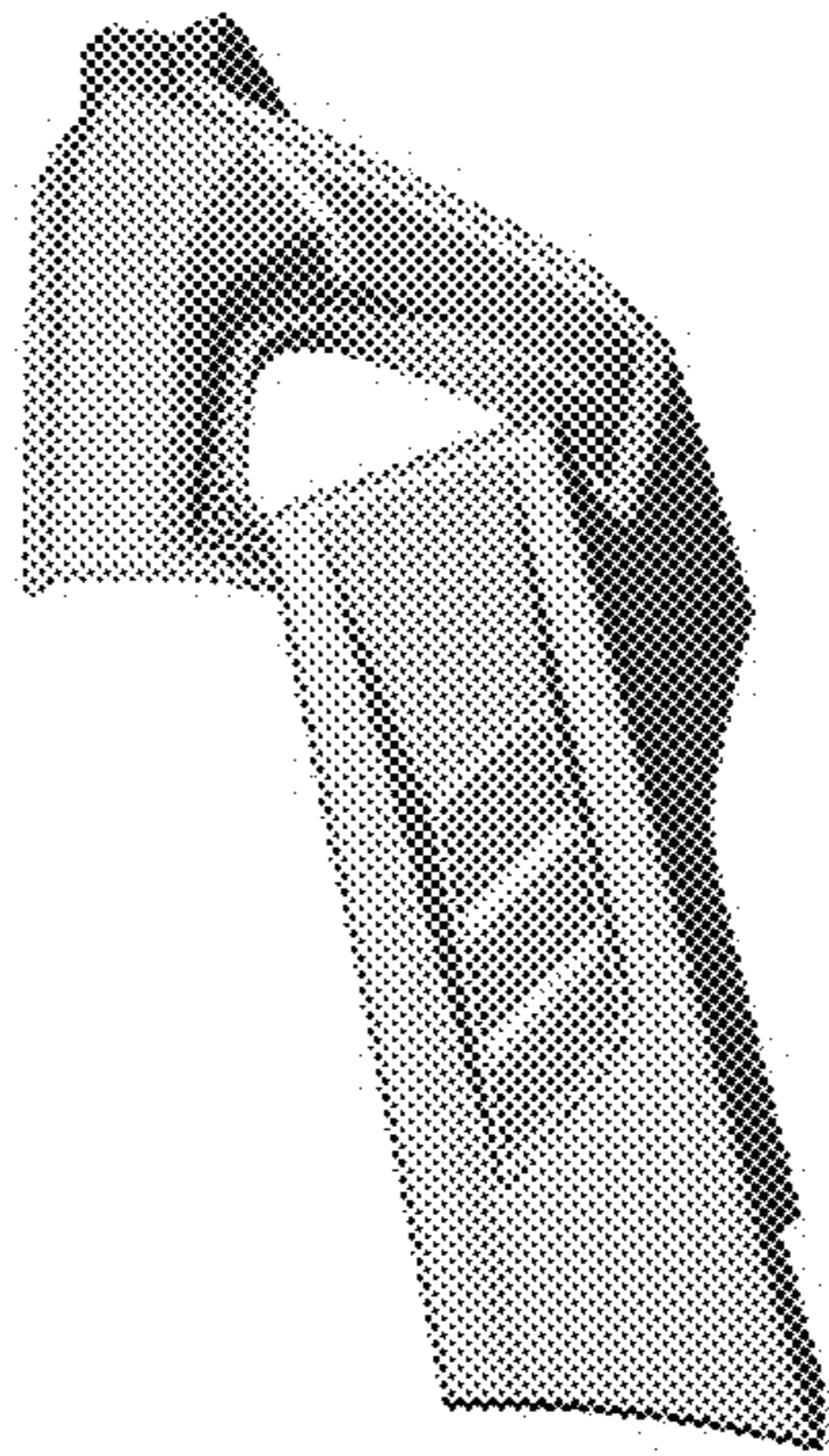

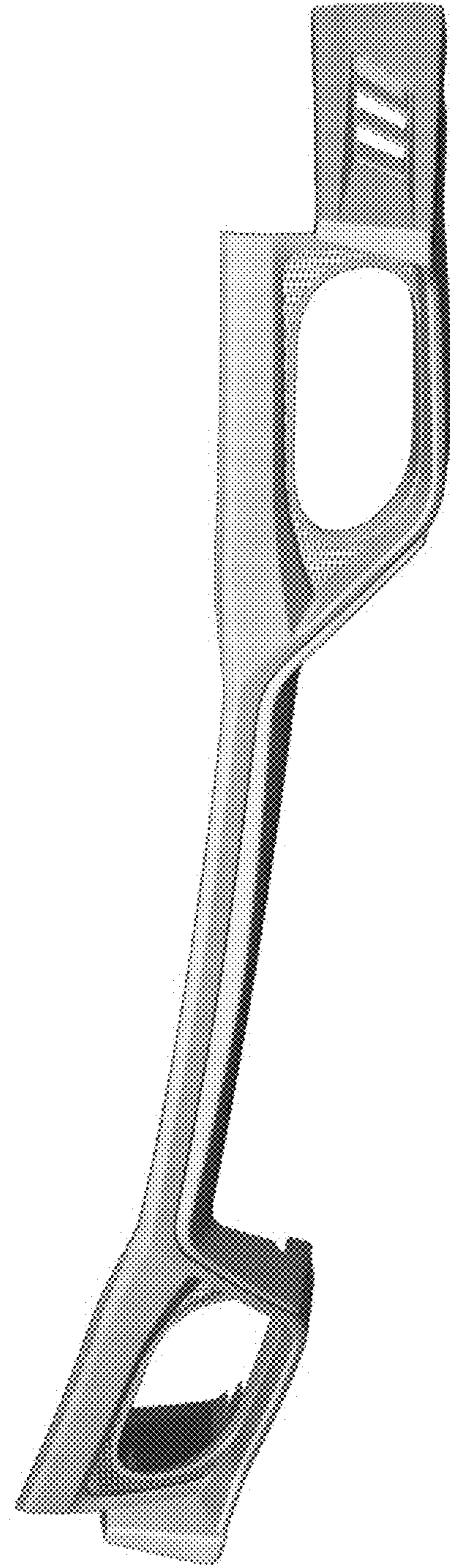

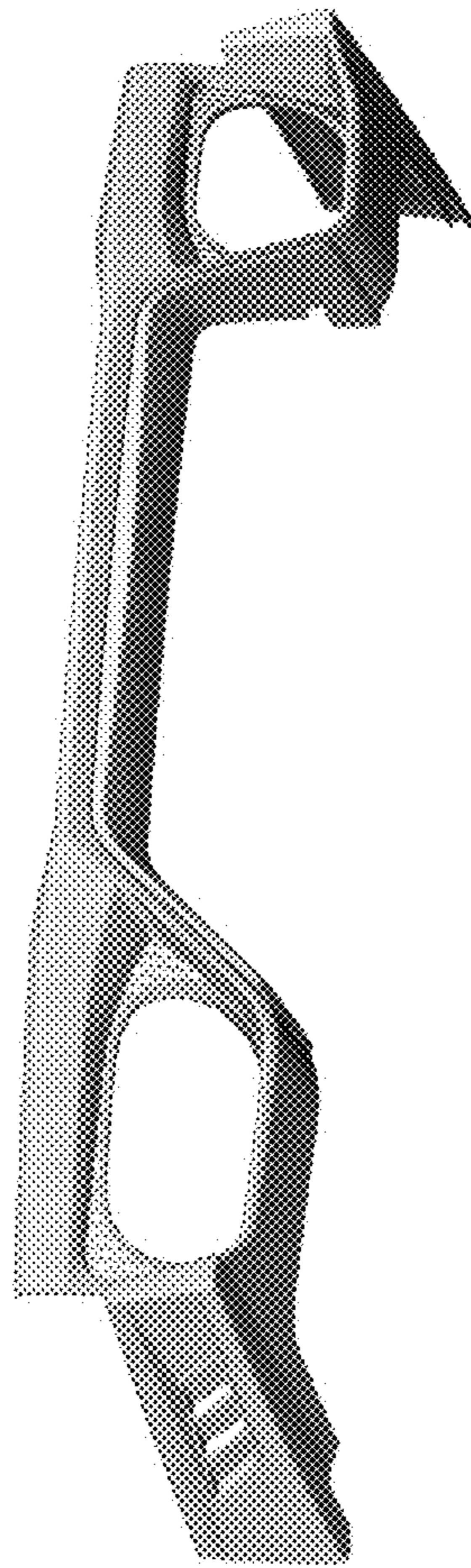
