FIG. 6 is a bottom plan view of the present invention shown in FIG. 1.

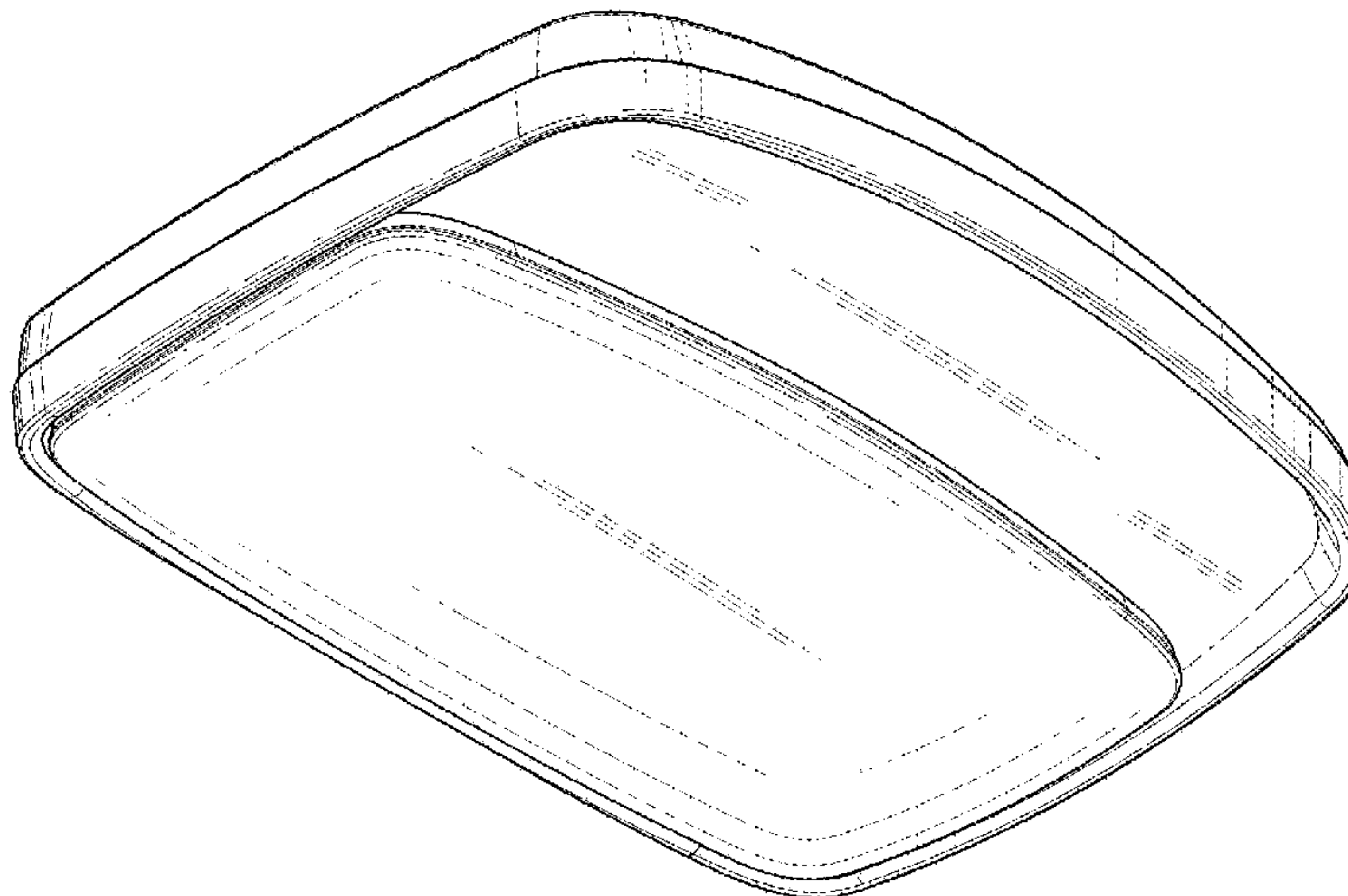

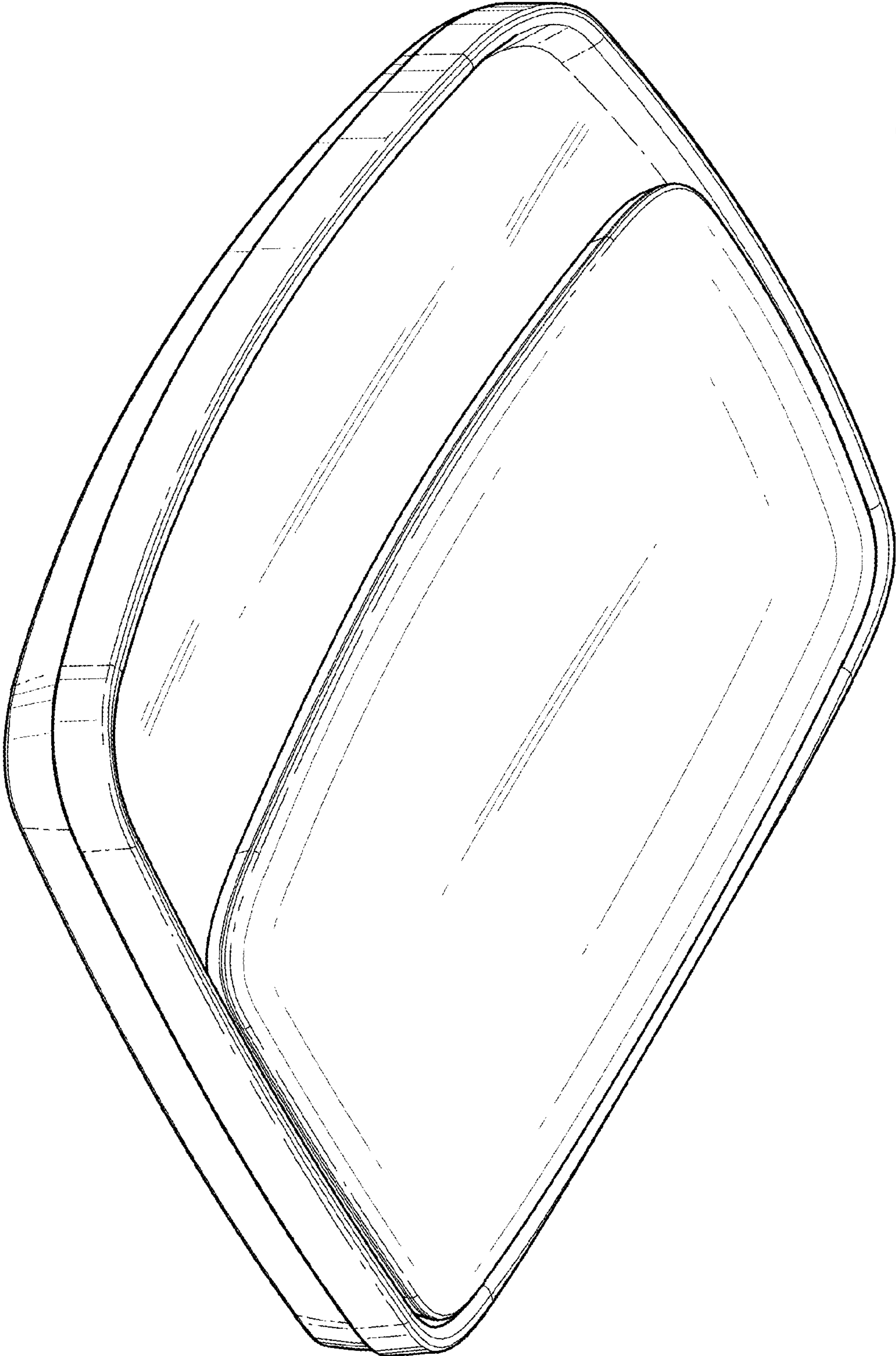

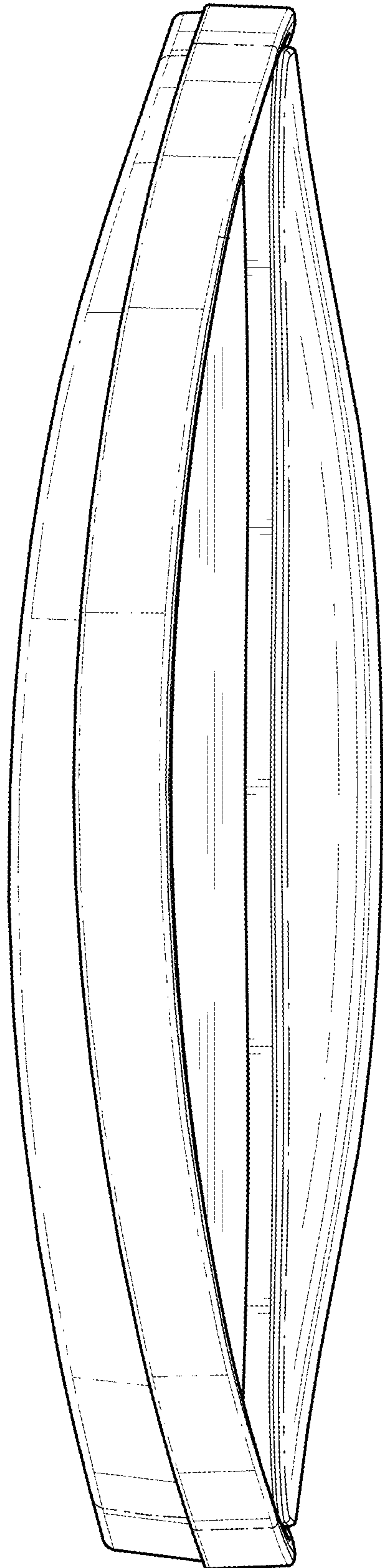

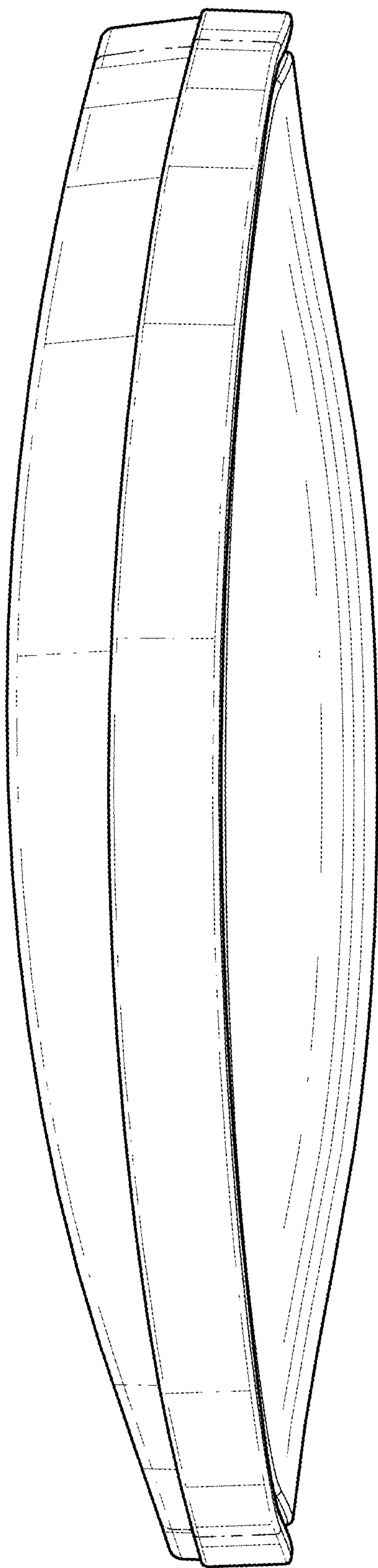

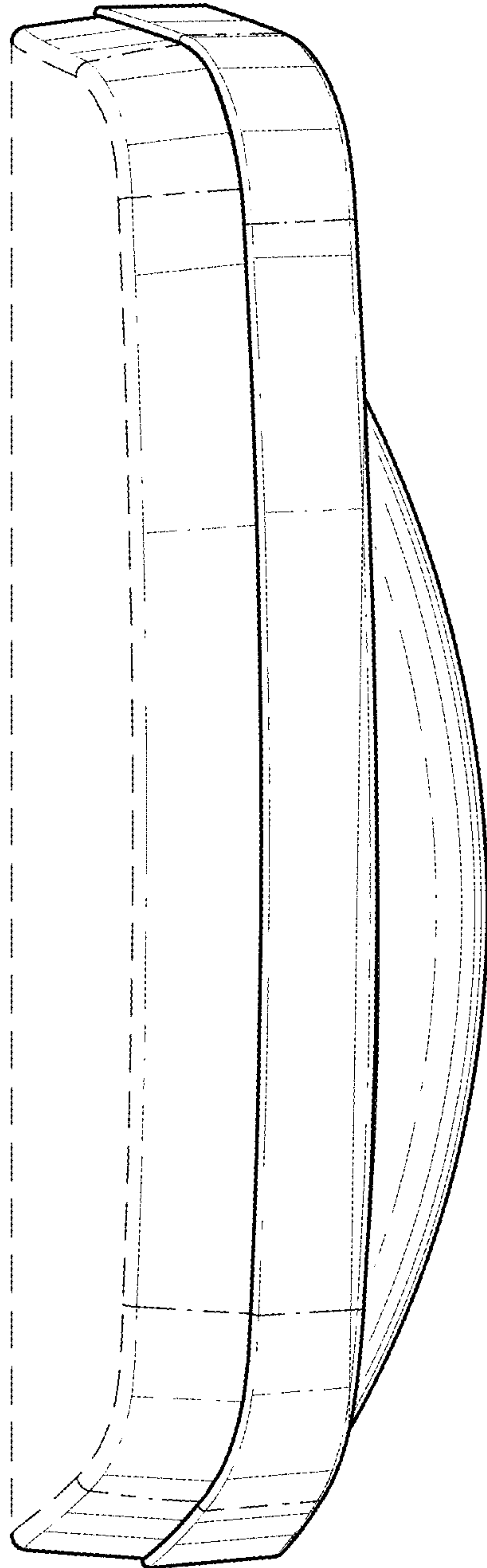

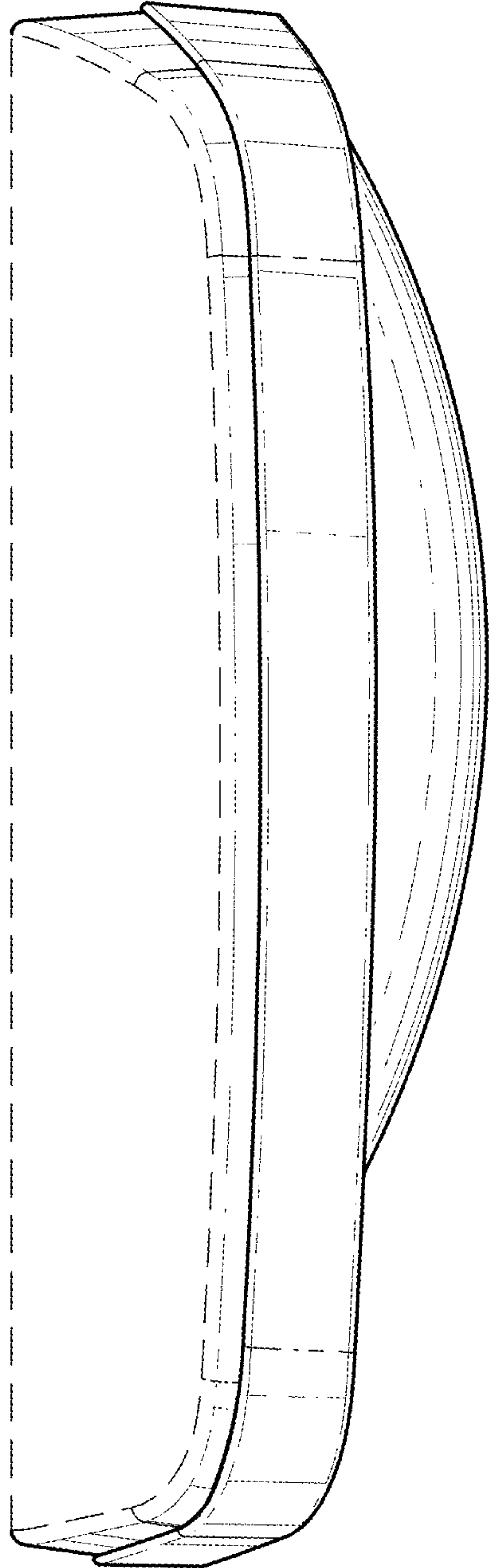

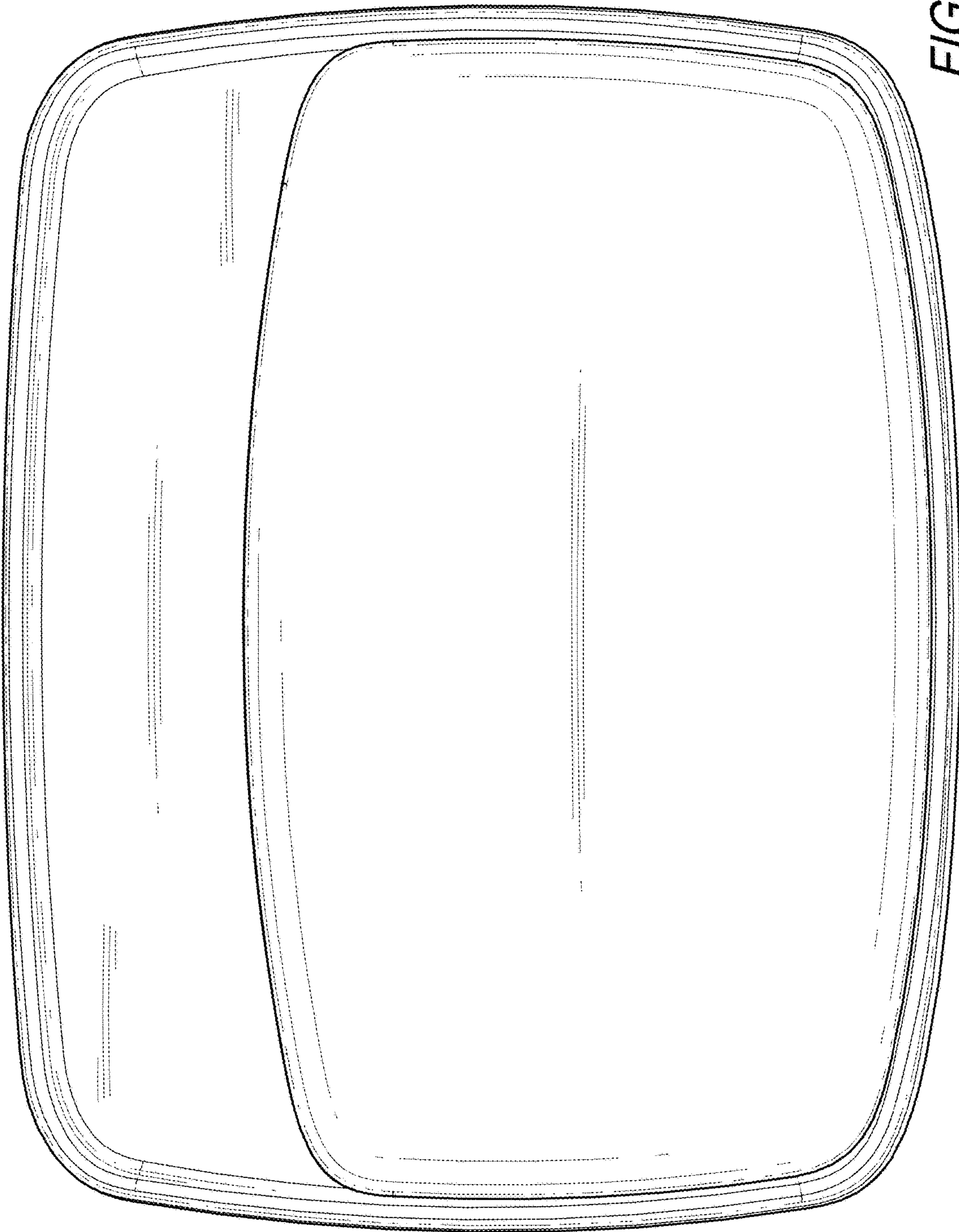
