The ornamental design for an electronic device, as shown and described.

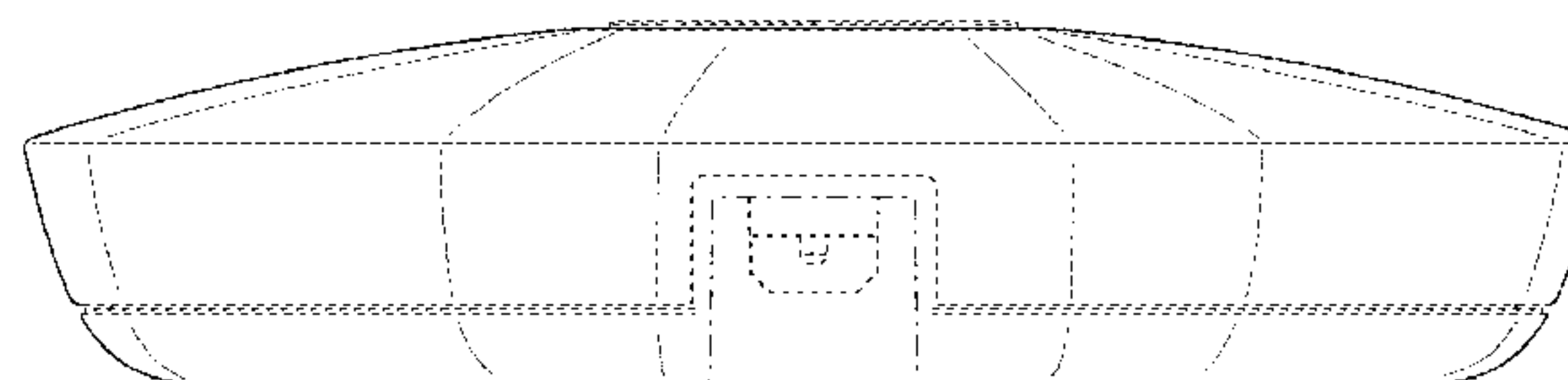
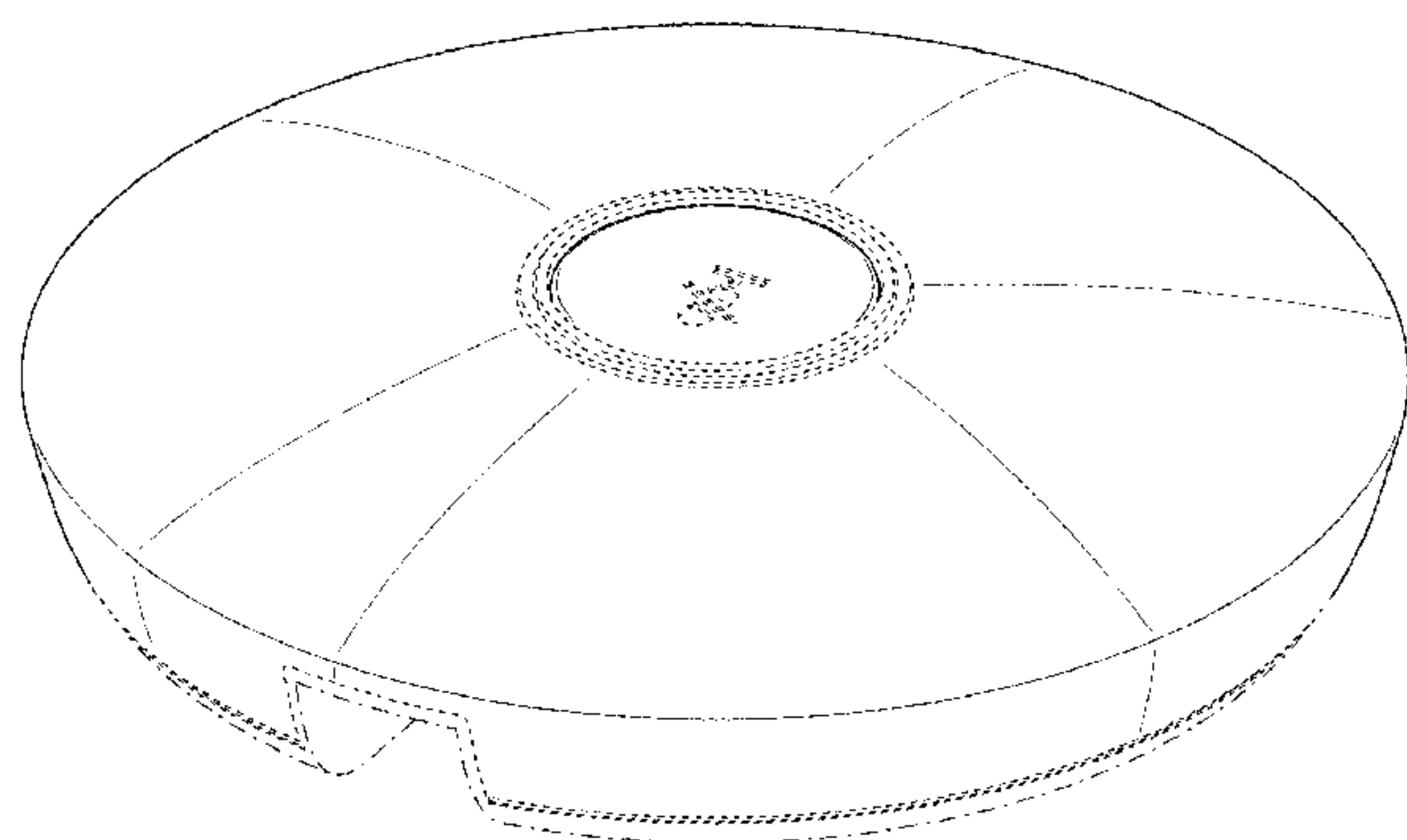
**DESCRIPTION**

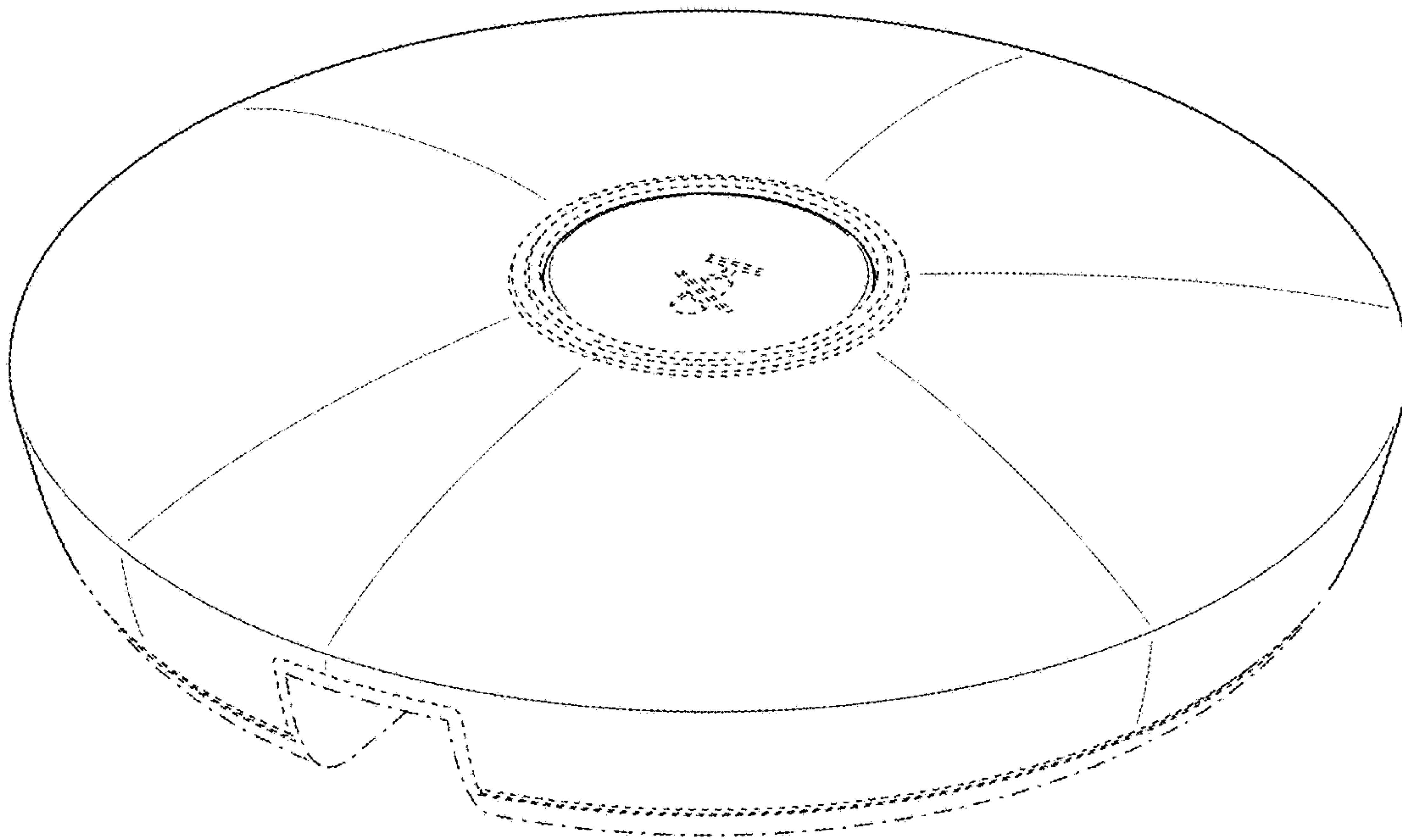

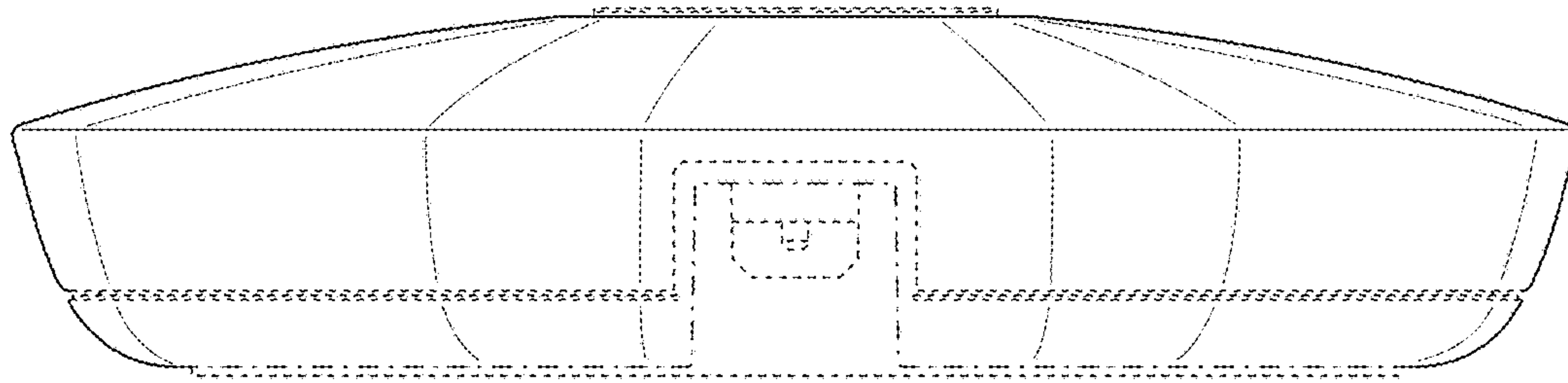

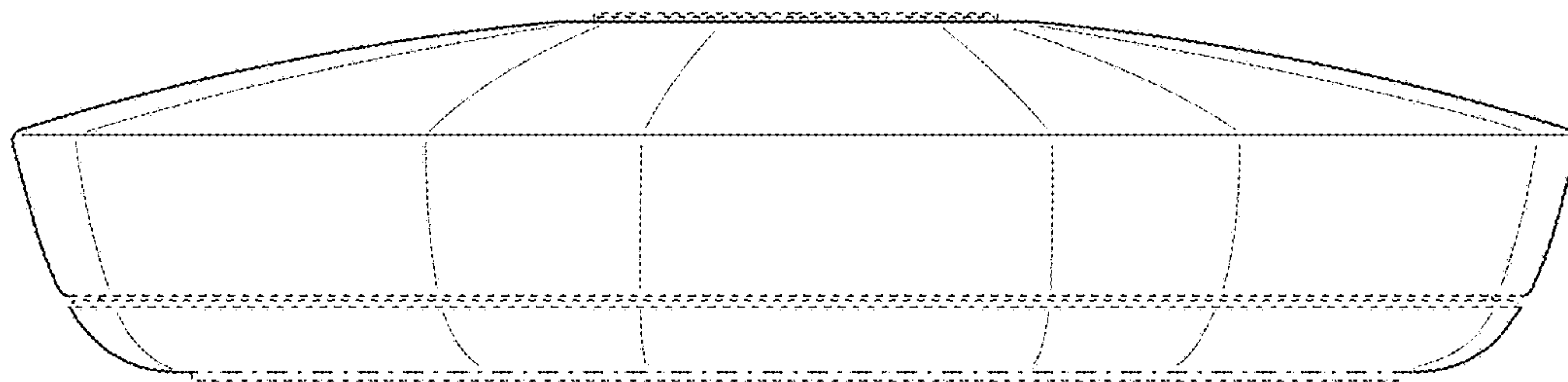

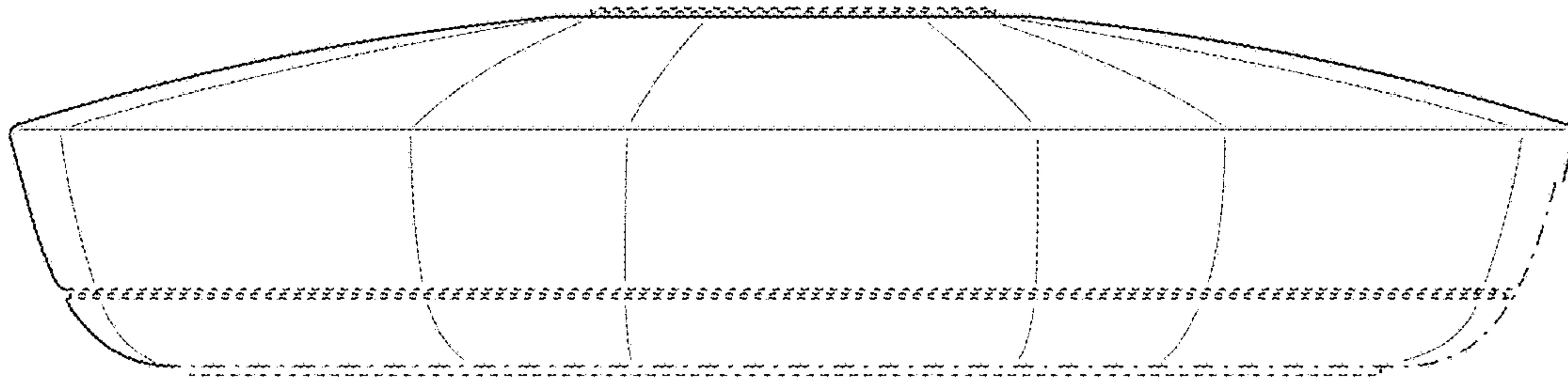

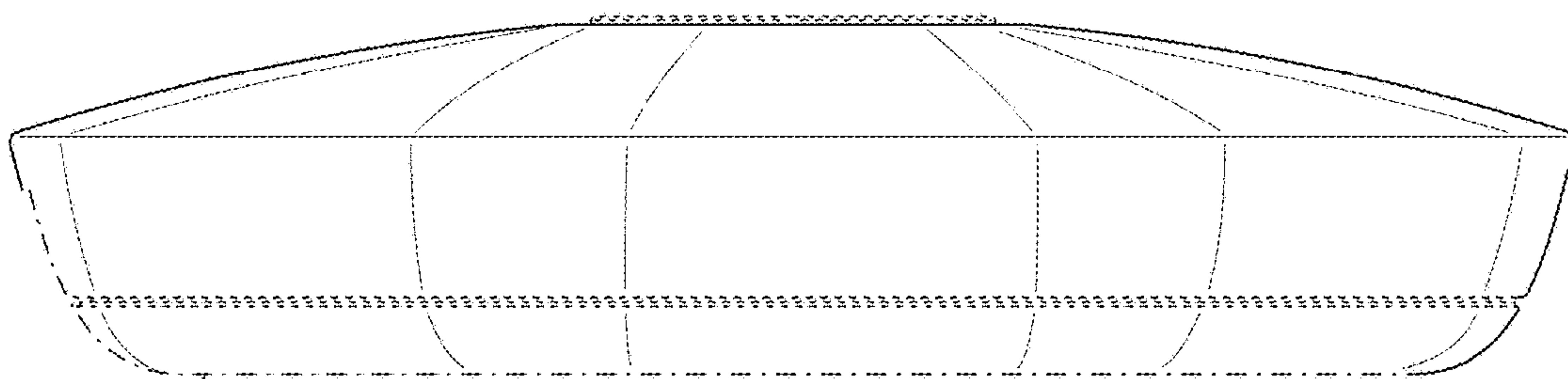

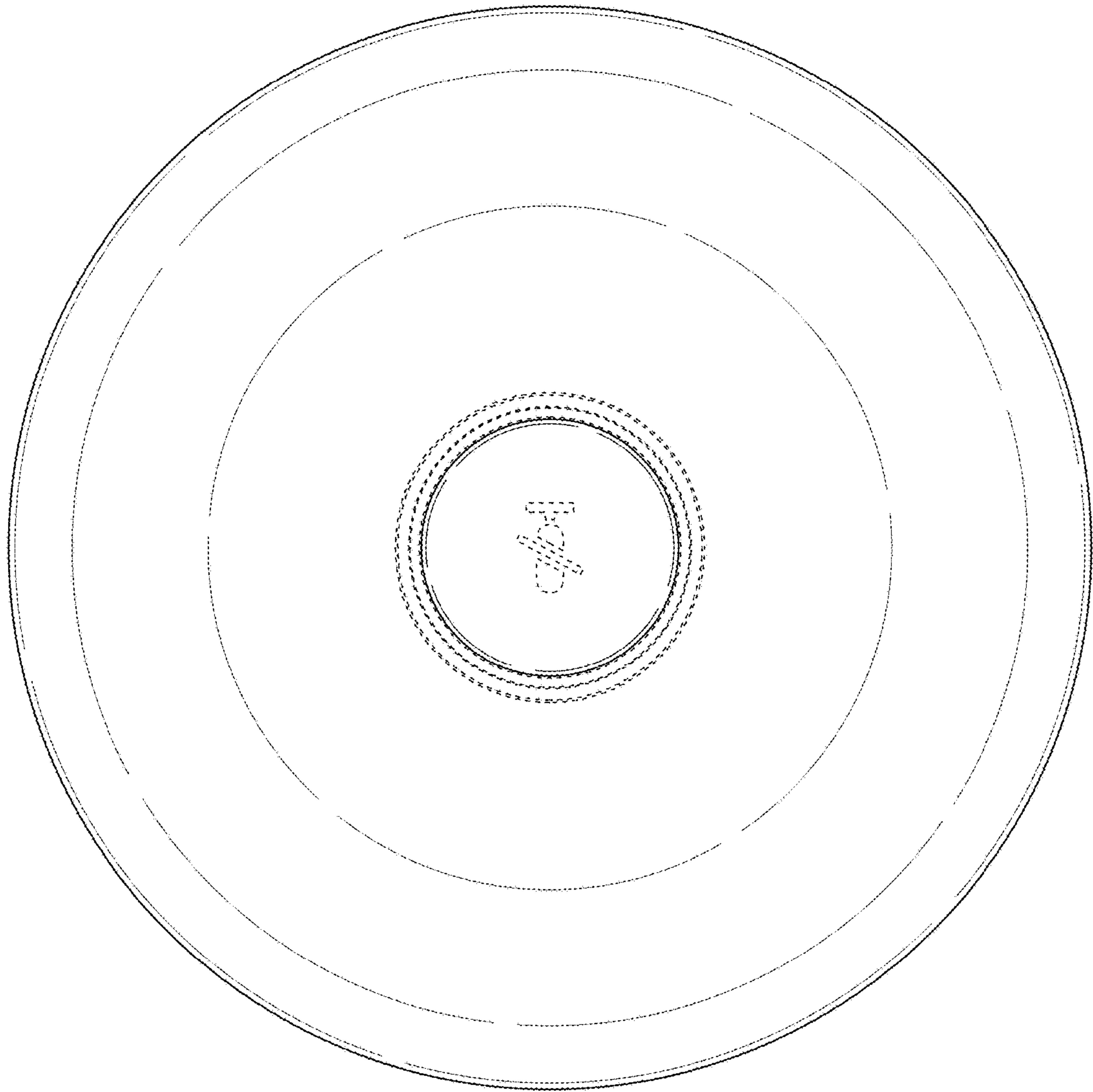

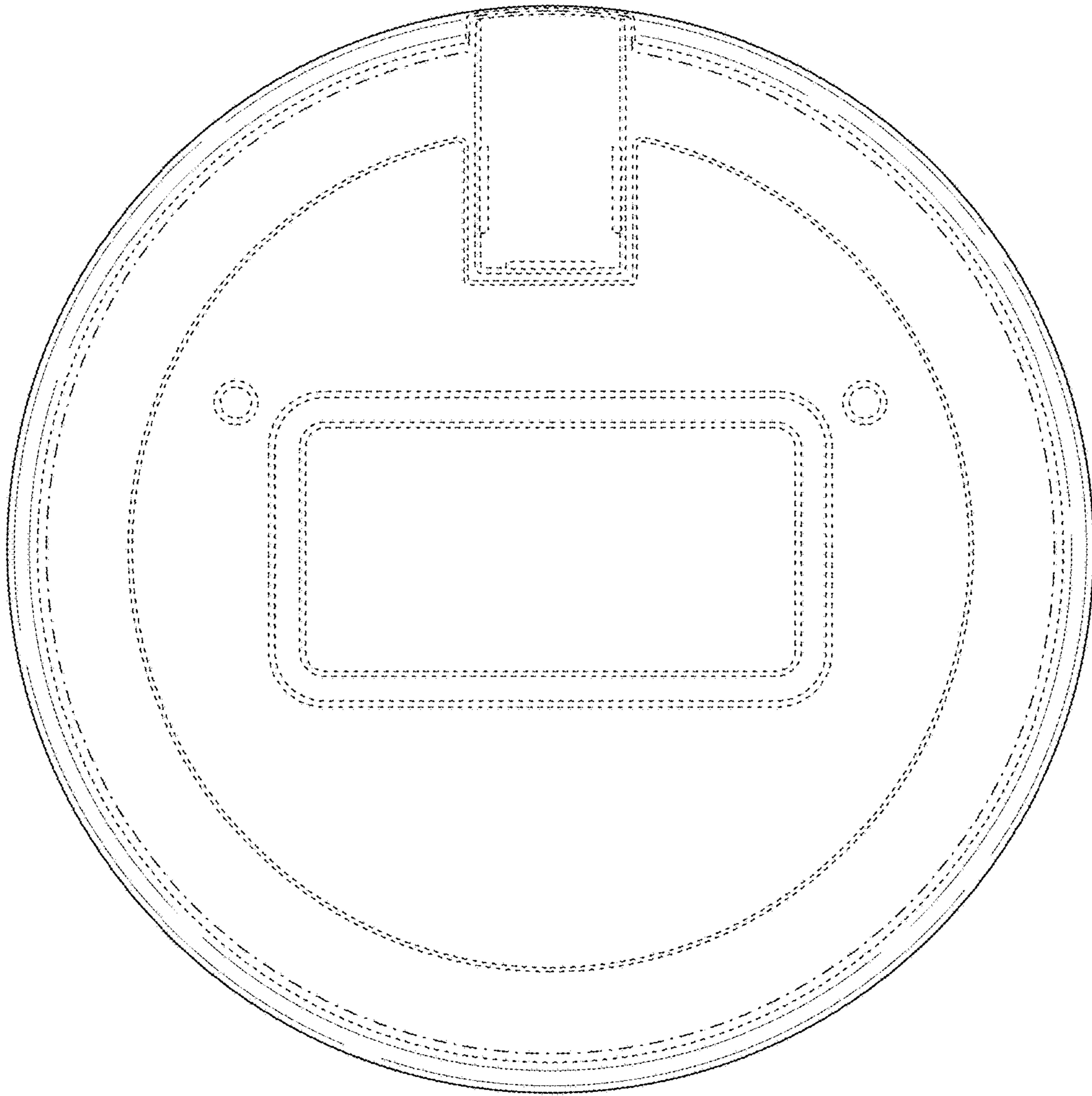
