FIG. 4 is a left view of the case for phone;

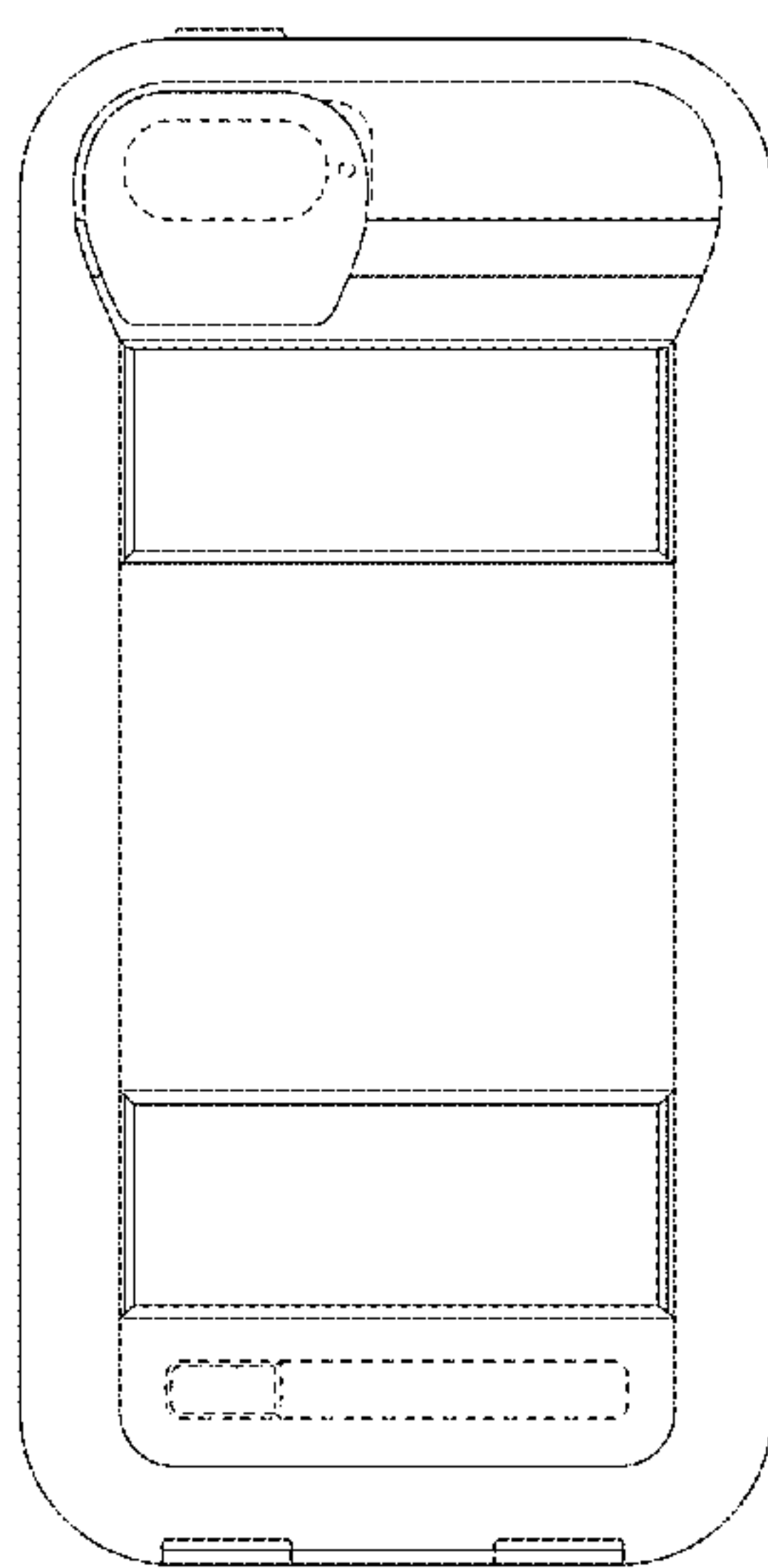
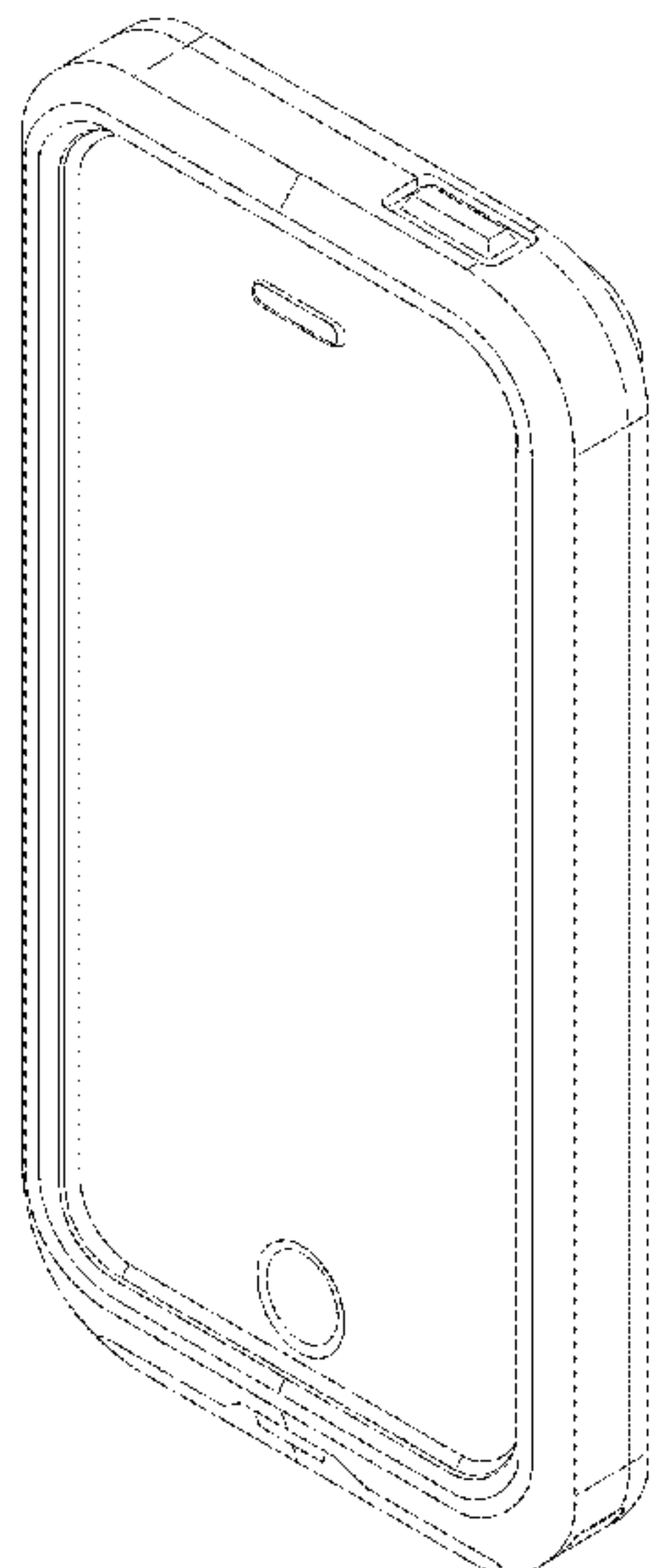
FIG. 5 is a right view of the case for phone;

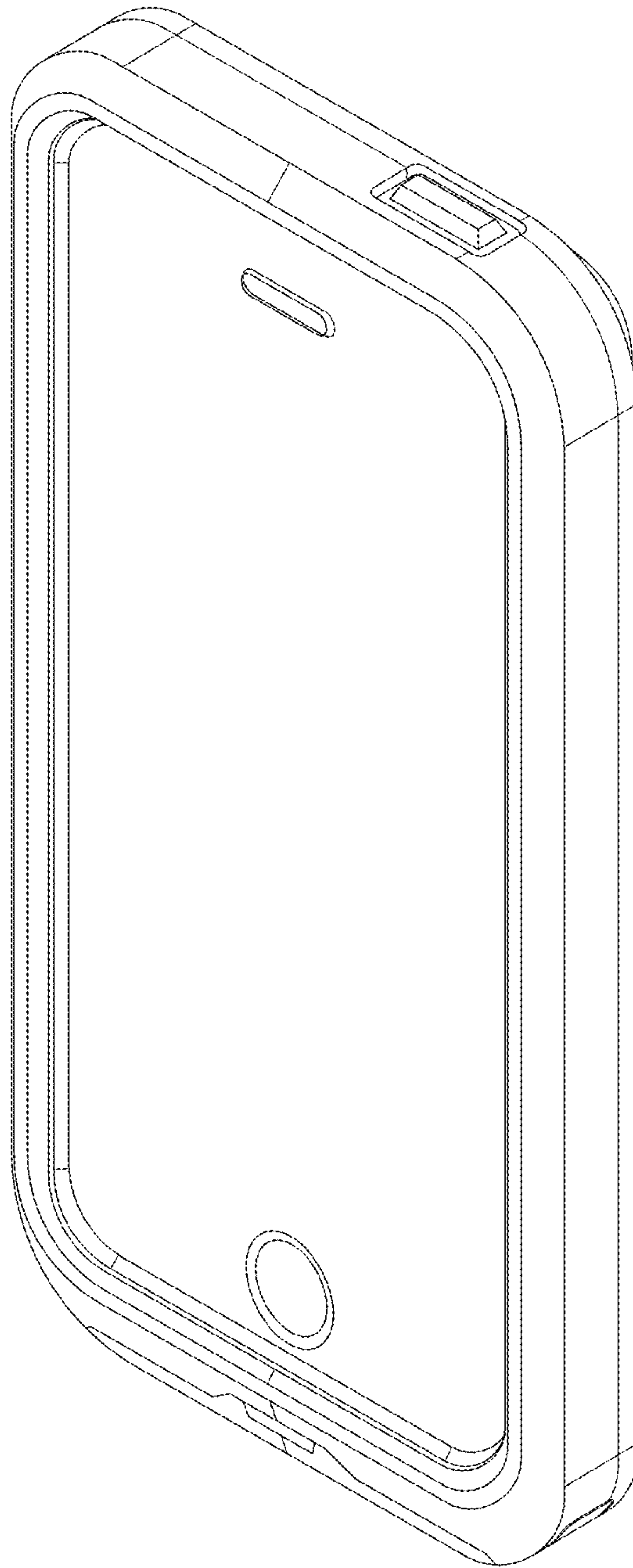

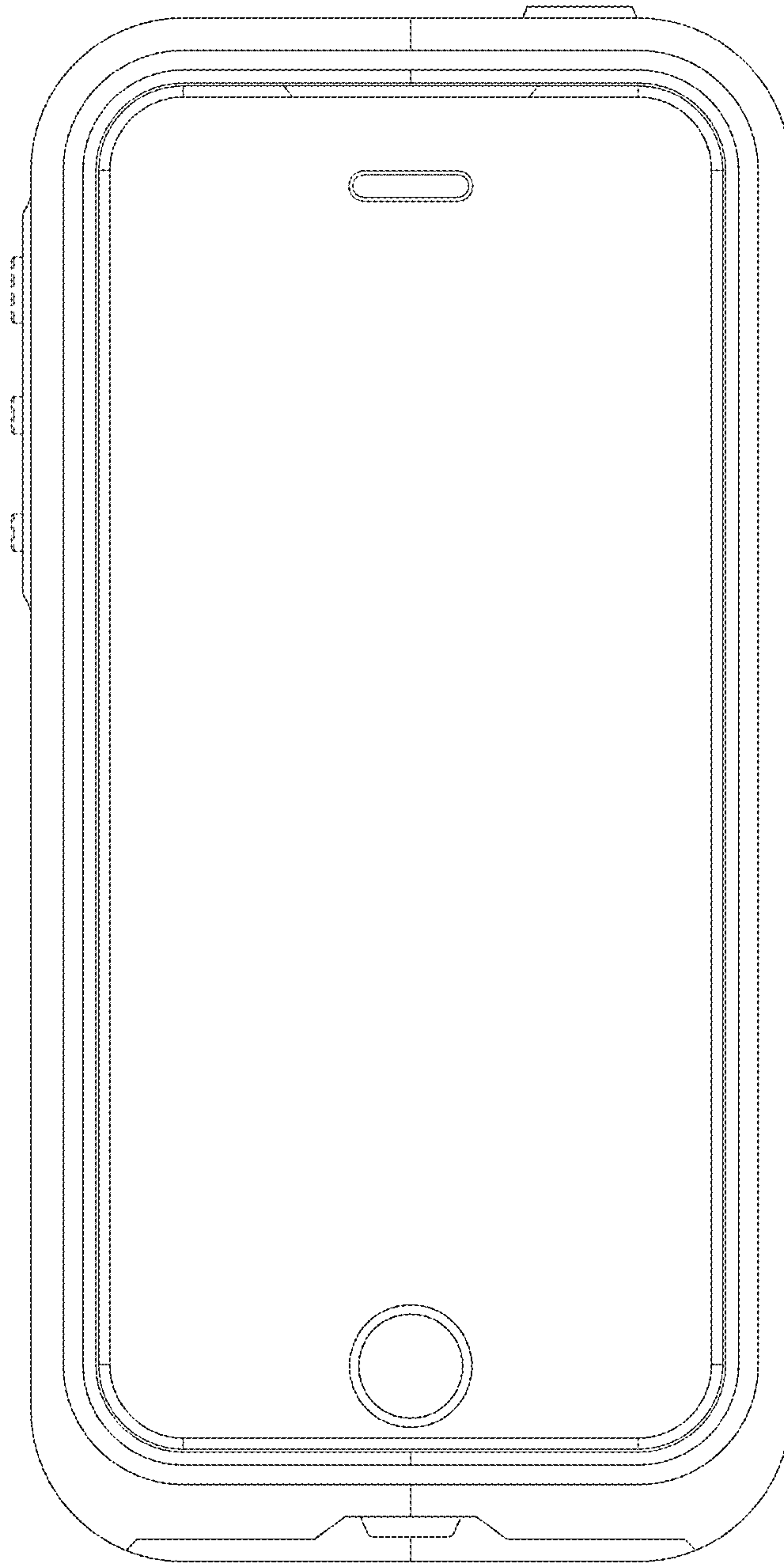

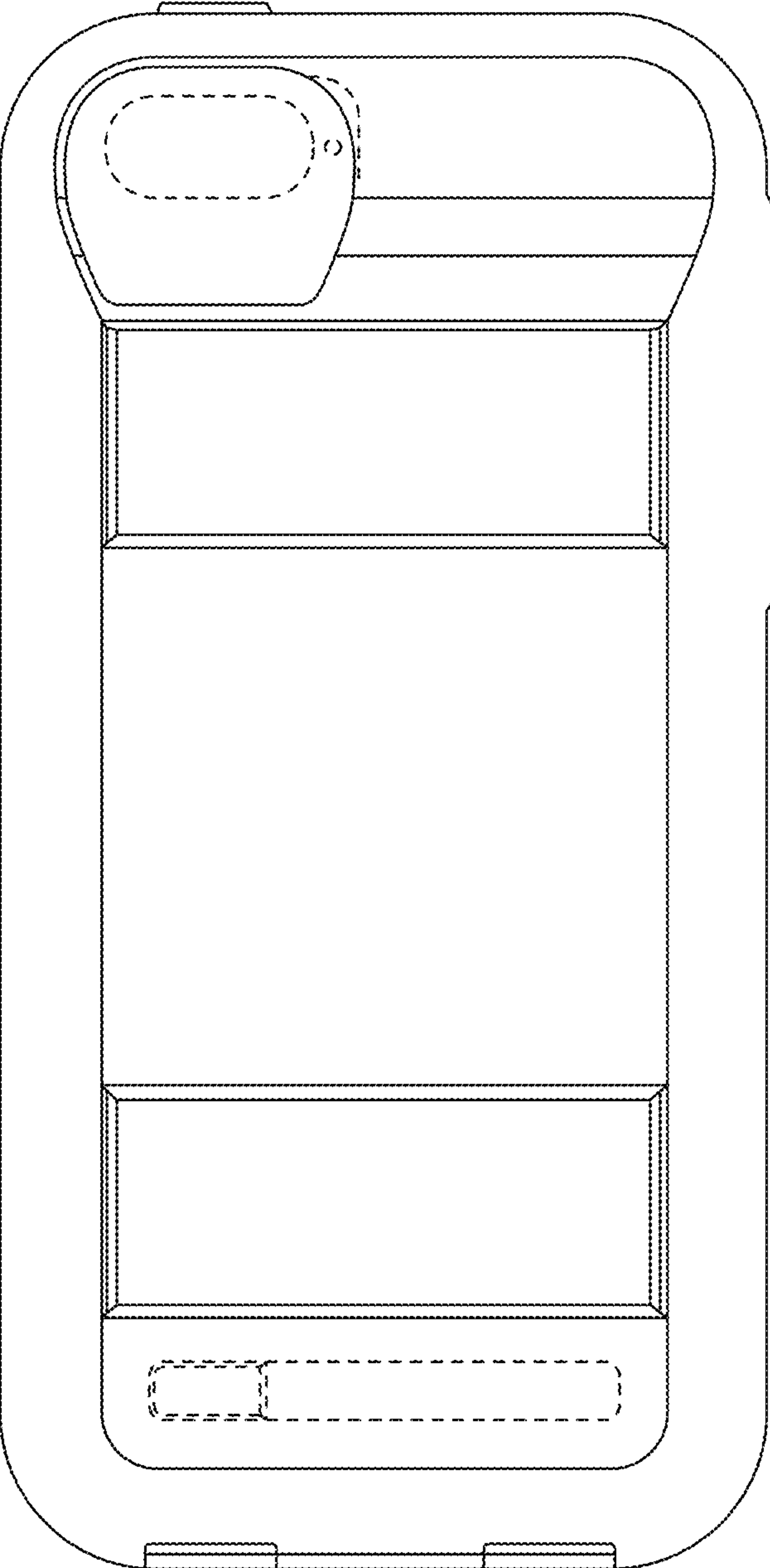

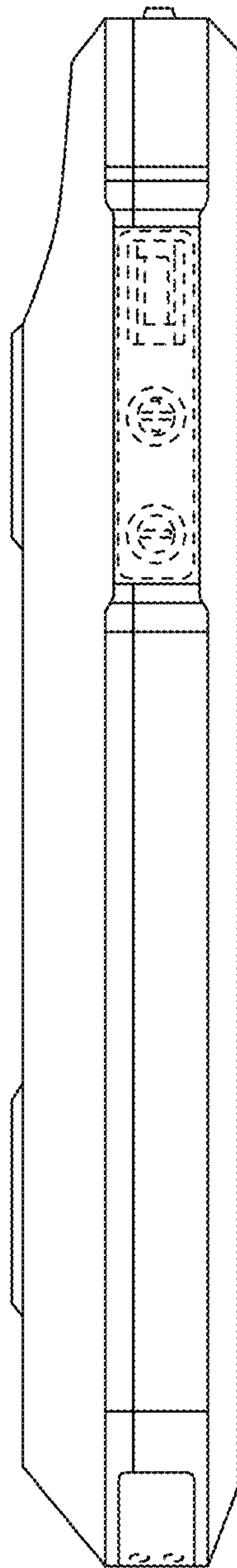

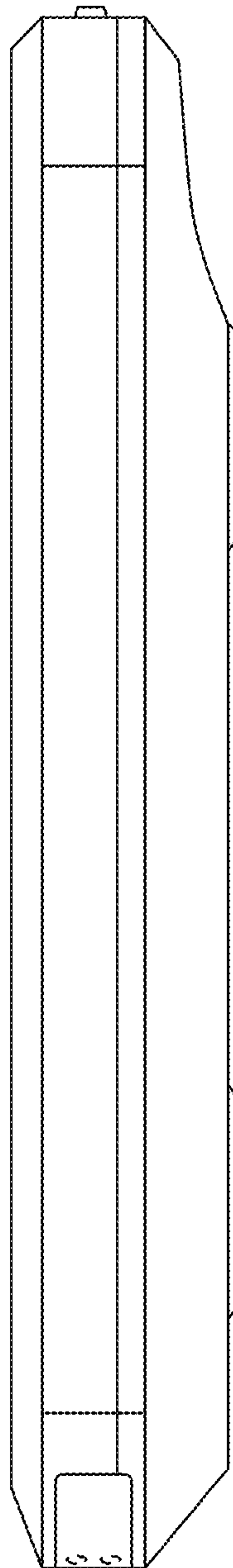

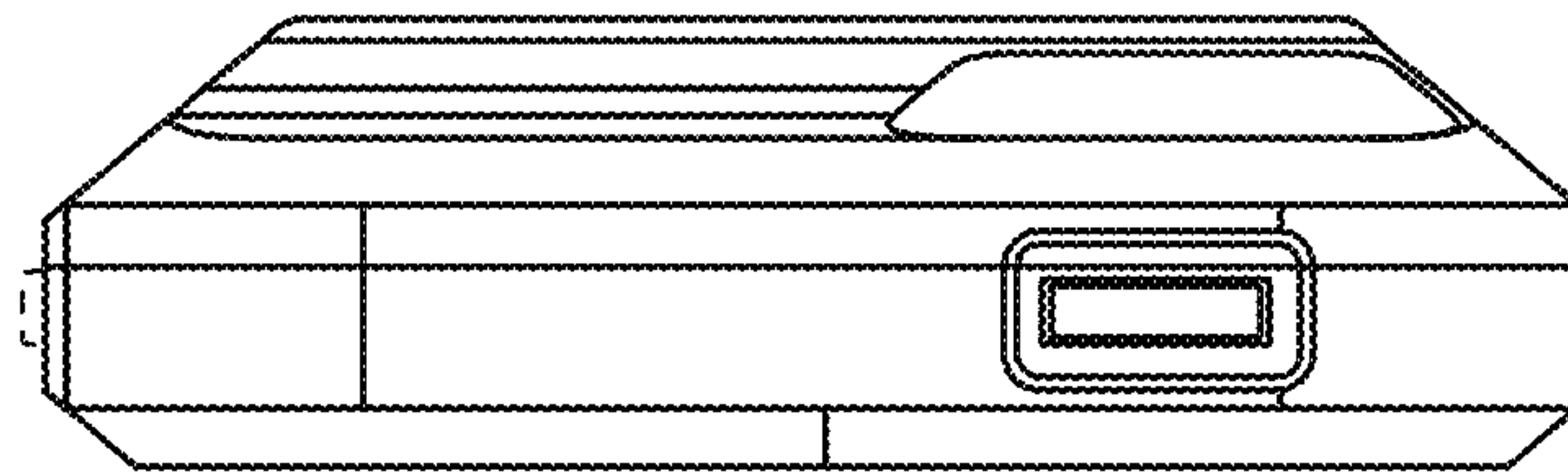
