(57) **CLAIM**

The ornamental design for a cellular phone with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image in a sequence for a cellular phone with animated graphical user interface showing our new design;

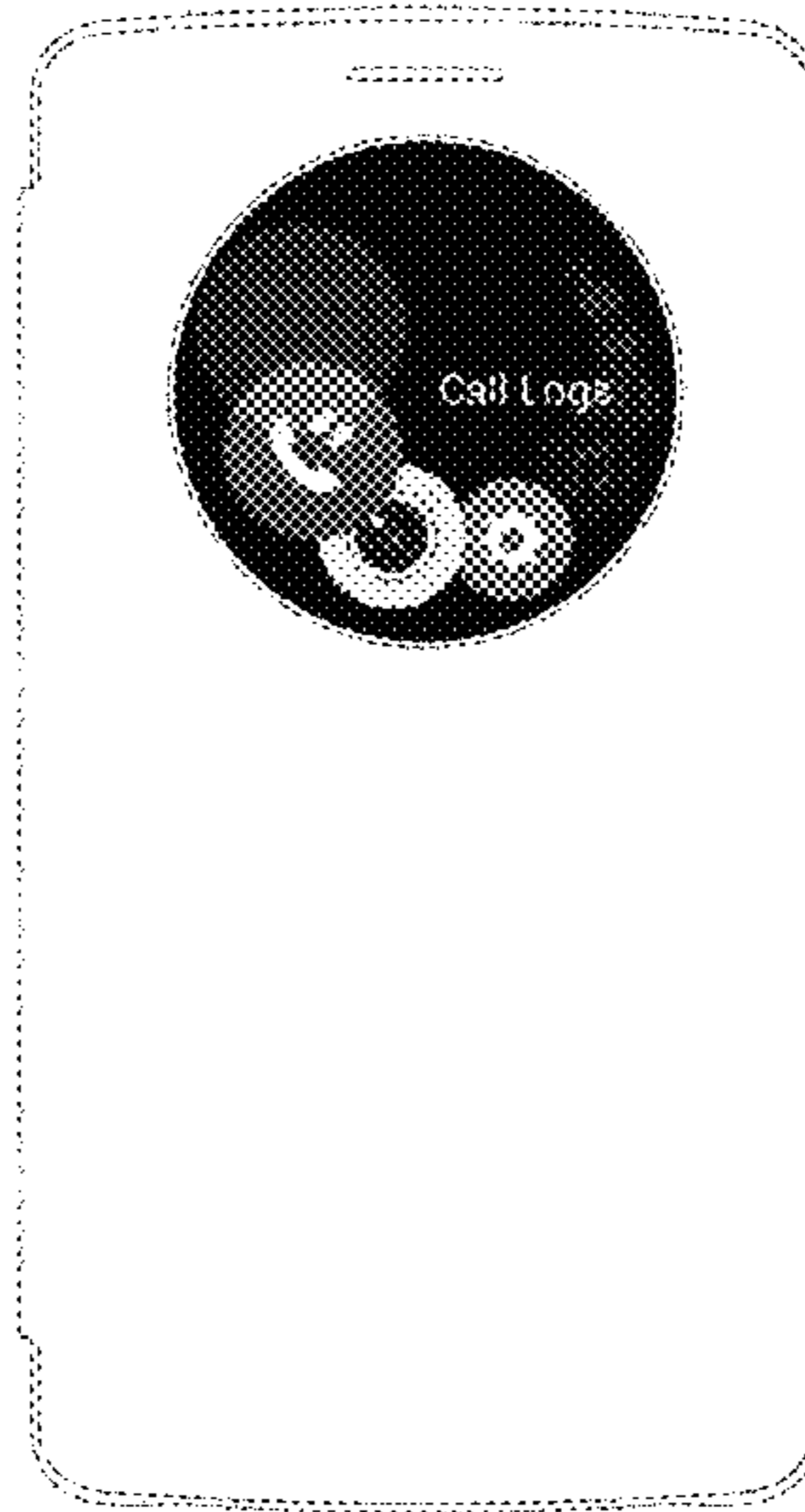
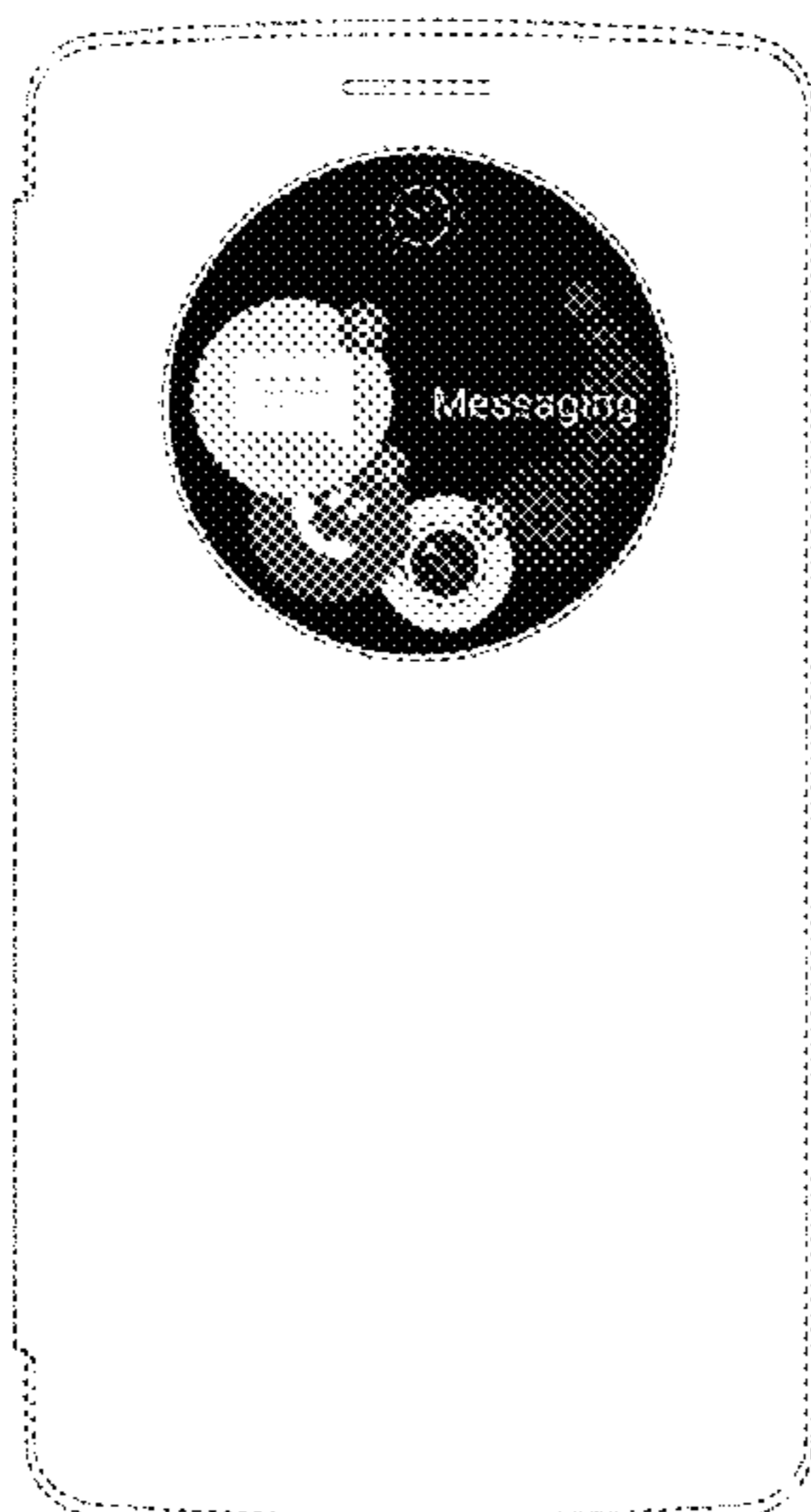
FIG. 2 is a front view of the second image thereof; and,

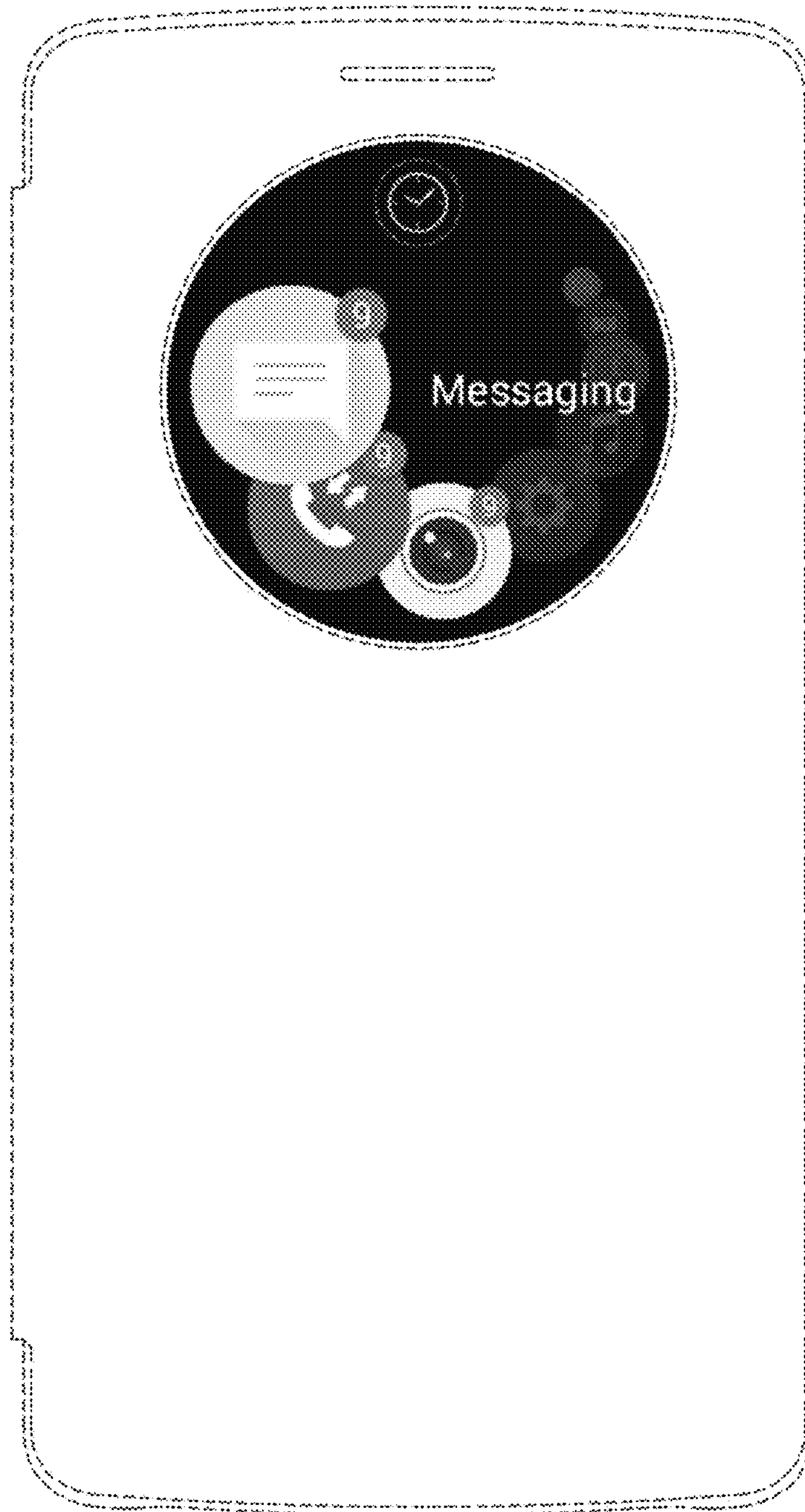

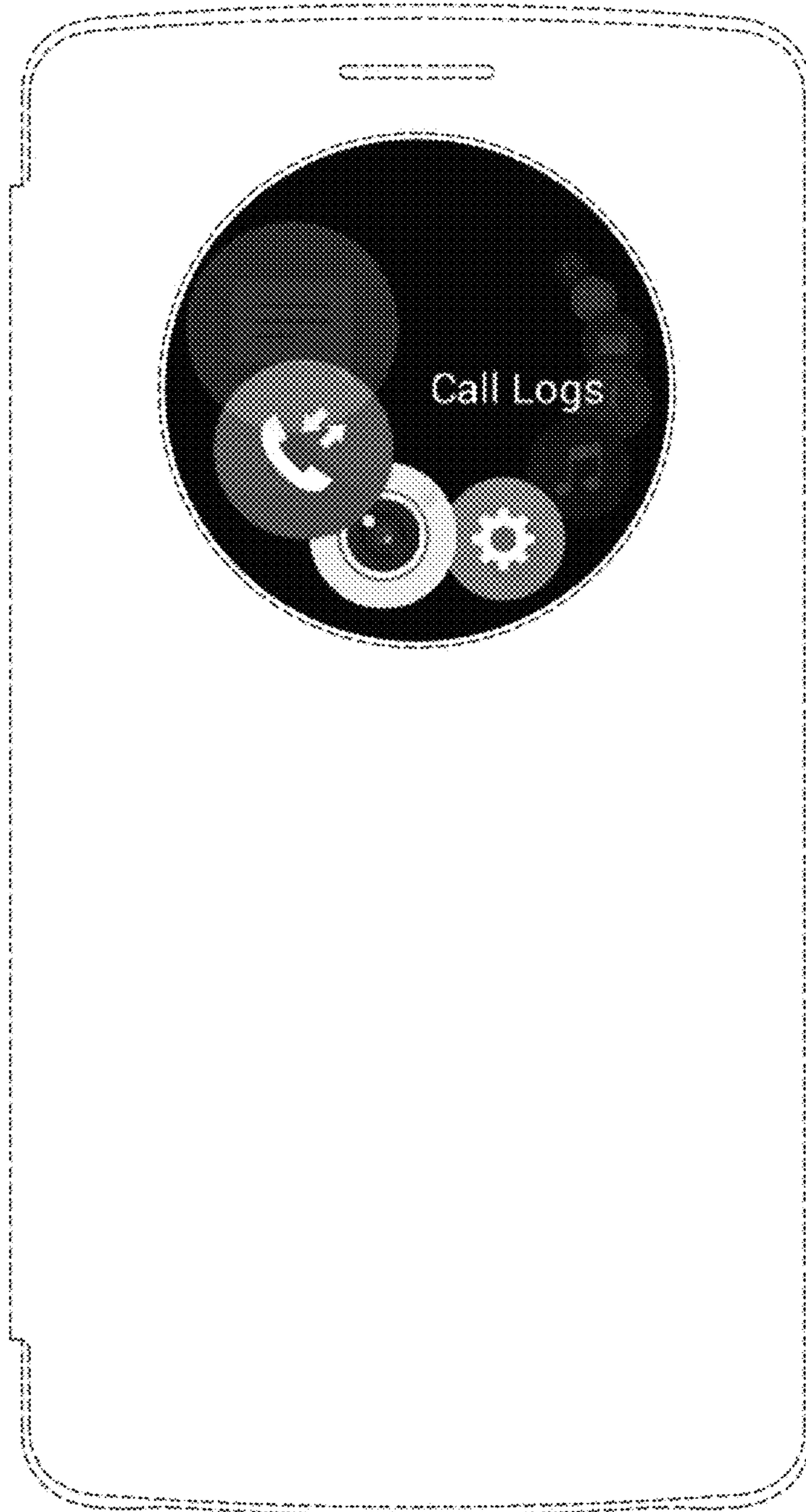
