FIG. 4 is a first side view of the pivot plunger of FIG. 1.

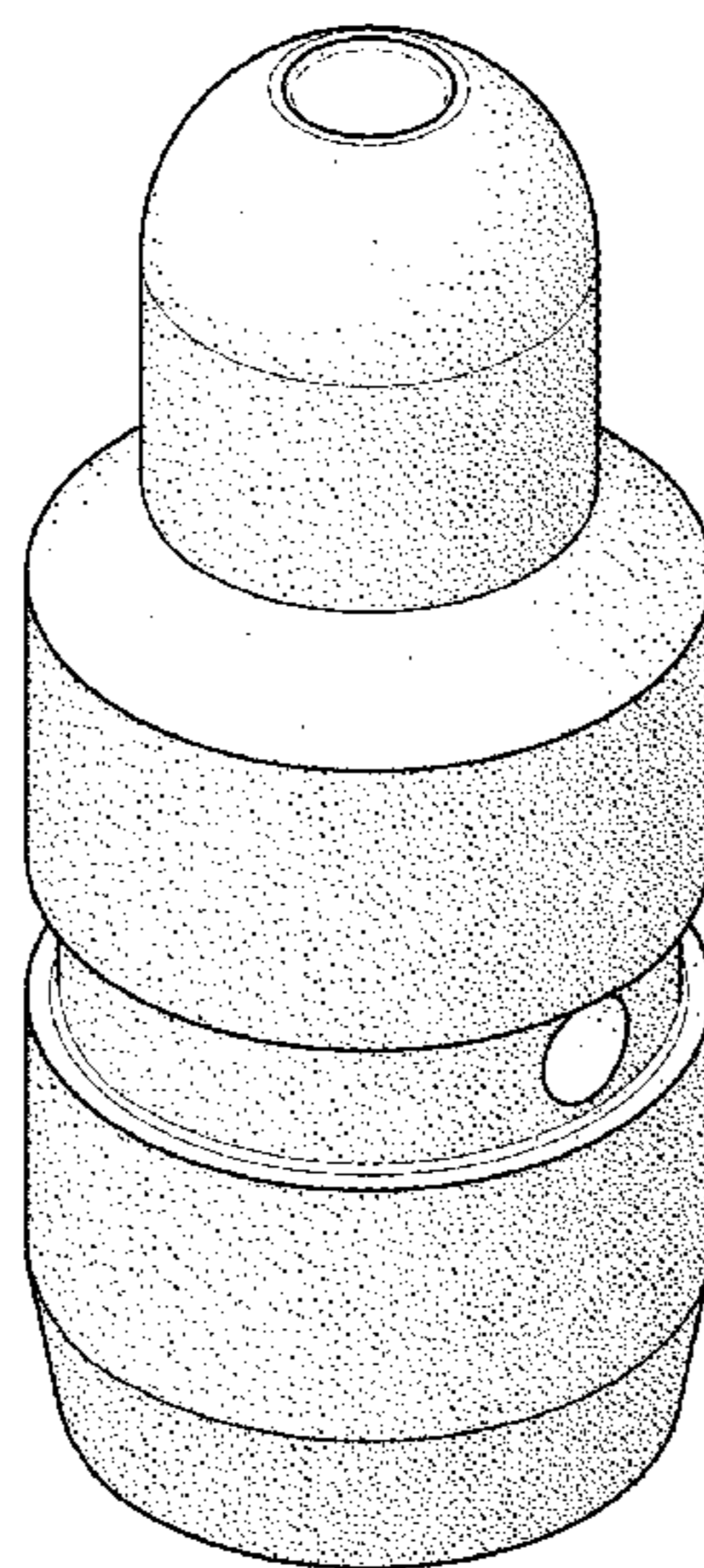
FIG. 5 is a second view of the pivot plunger of FIG. 1.

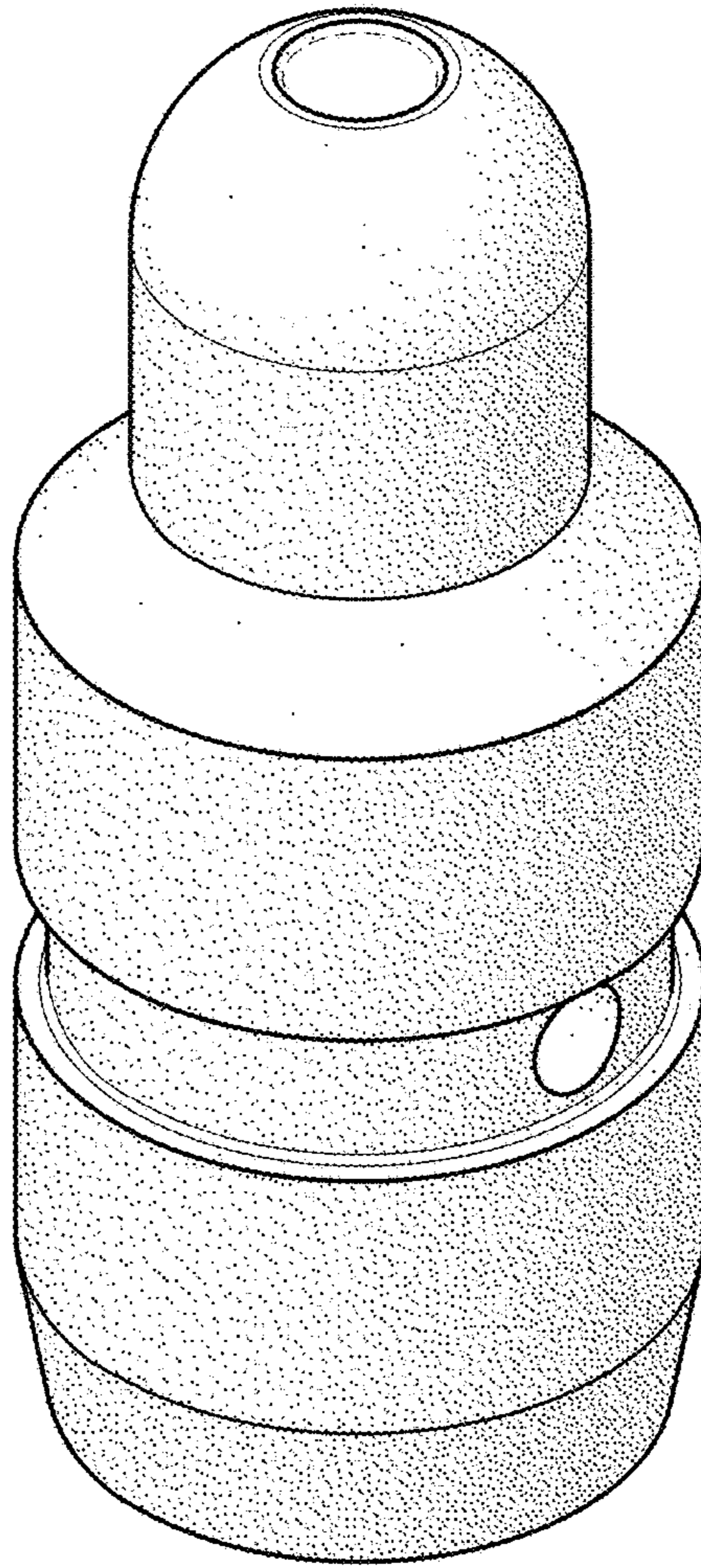

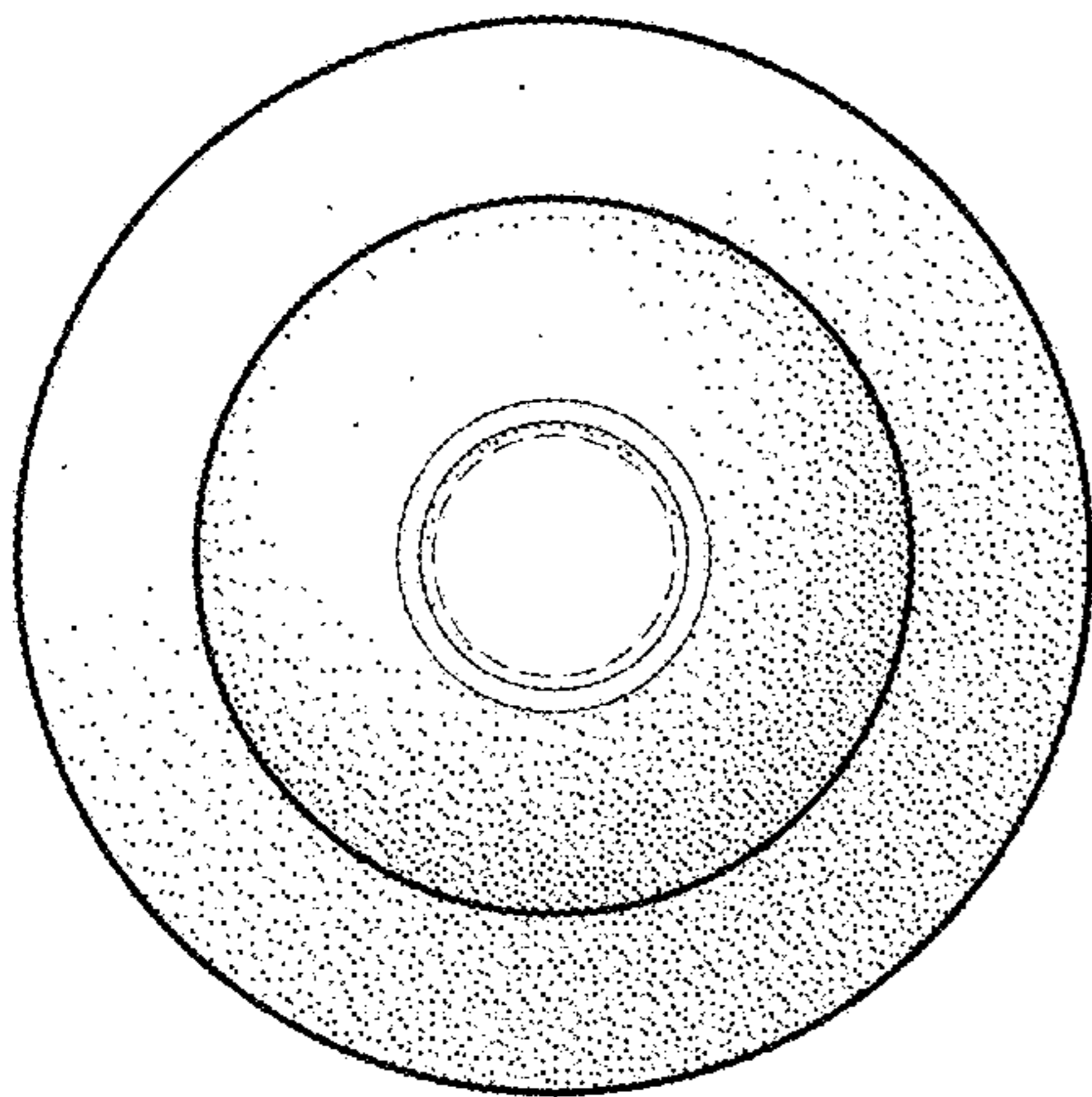

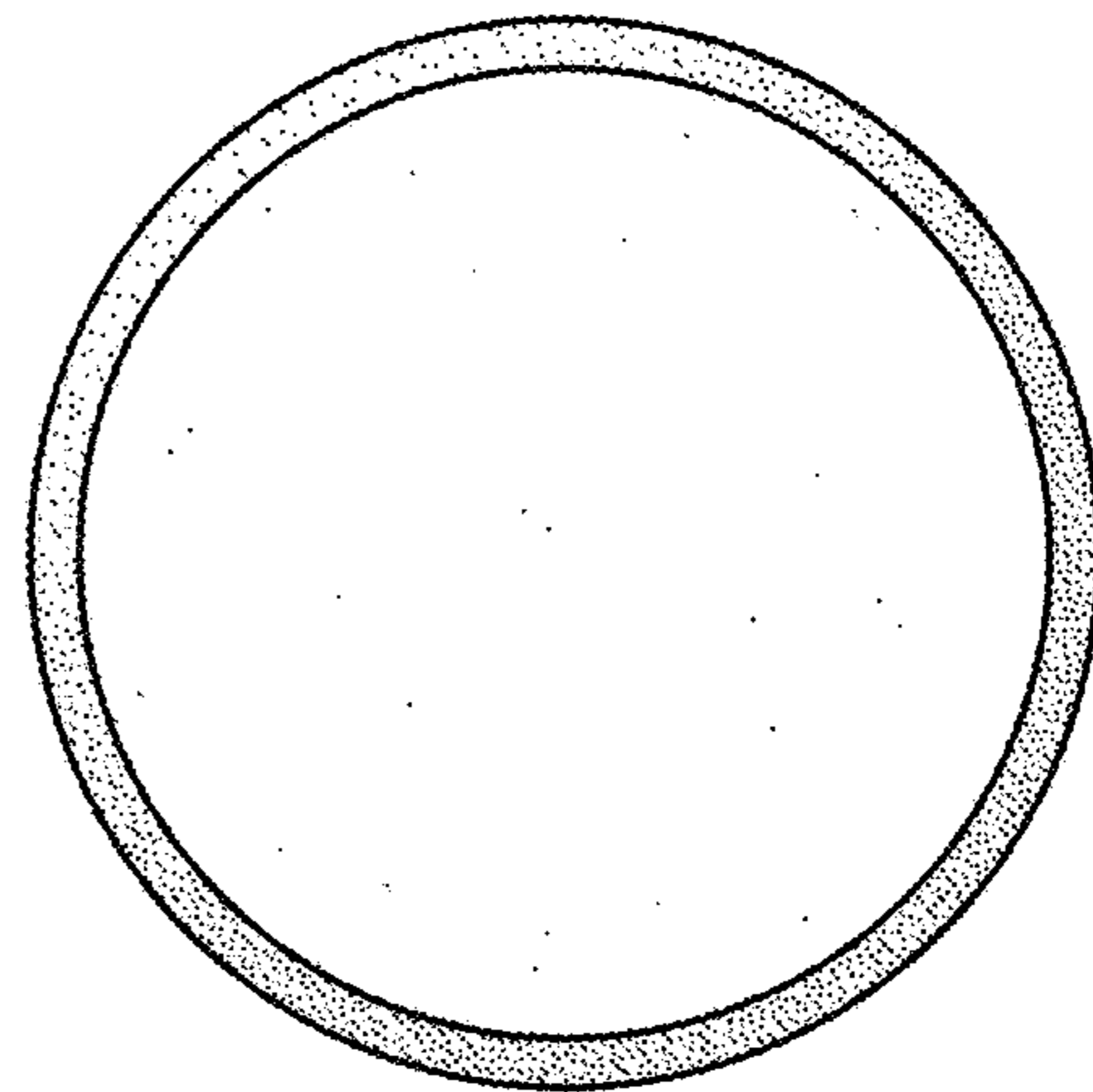

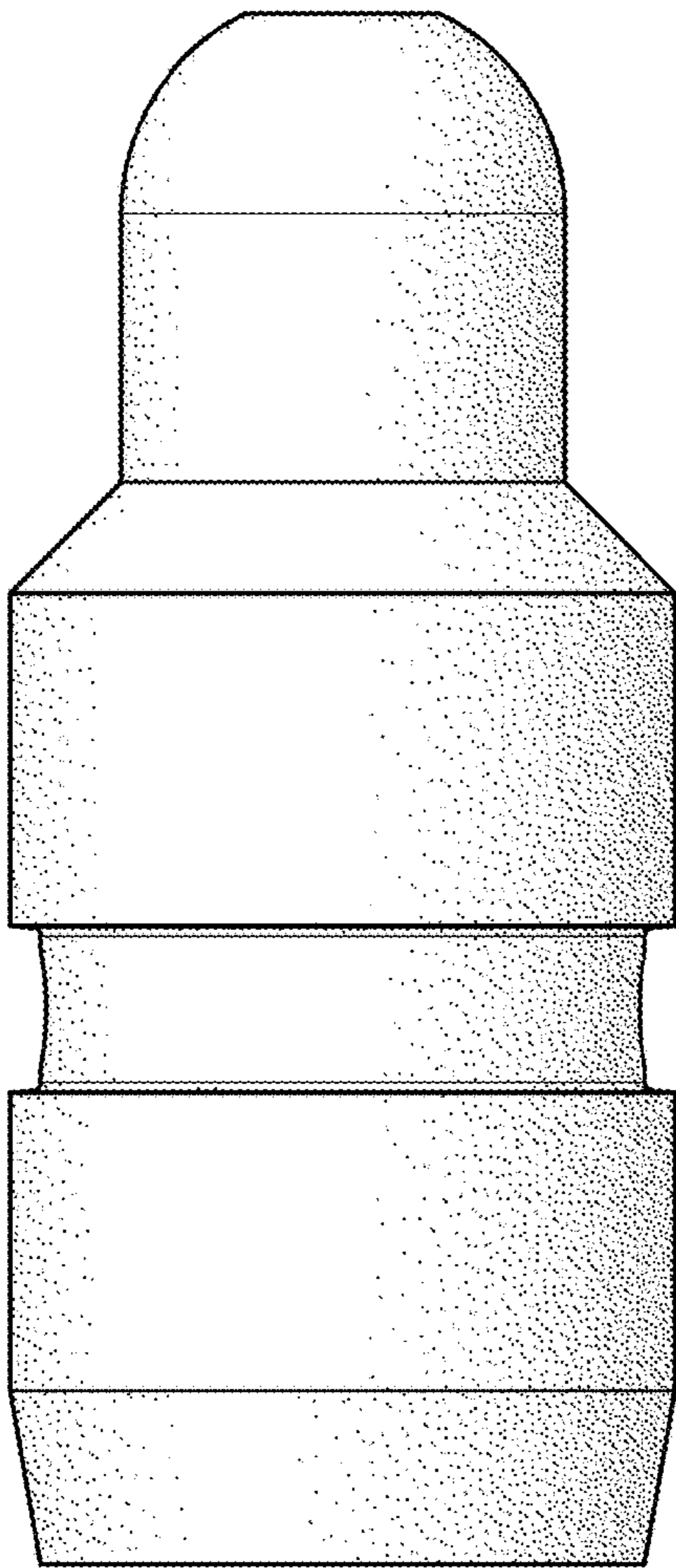

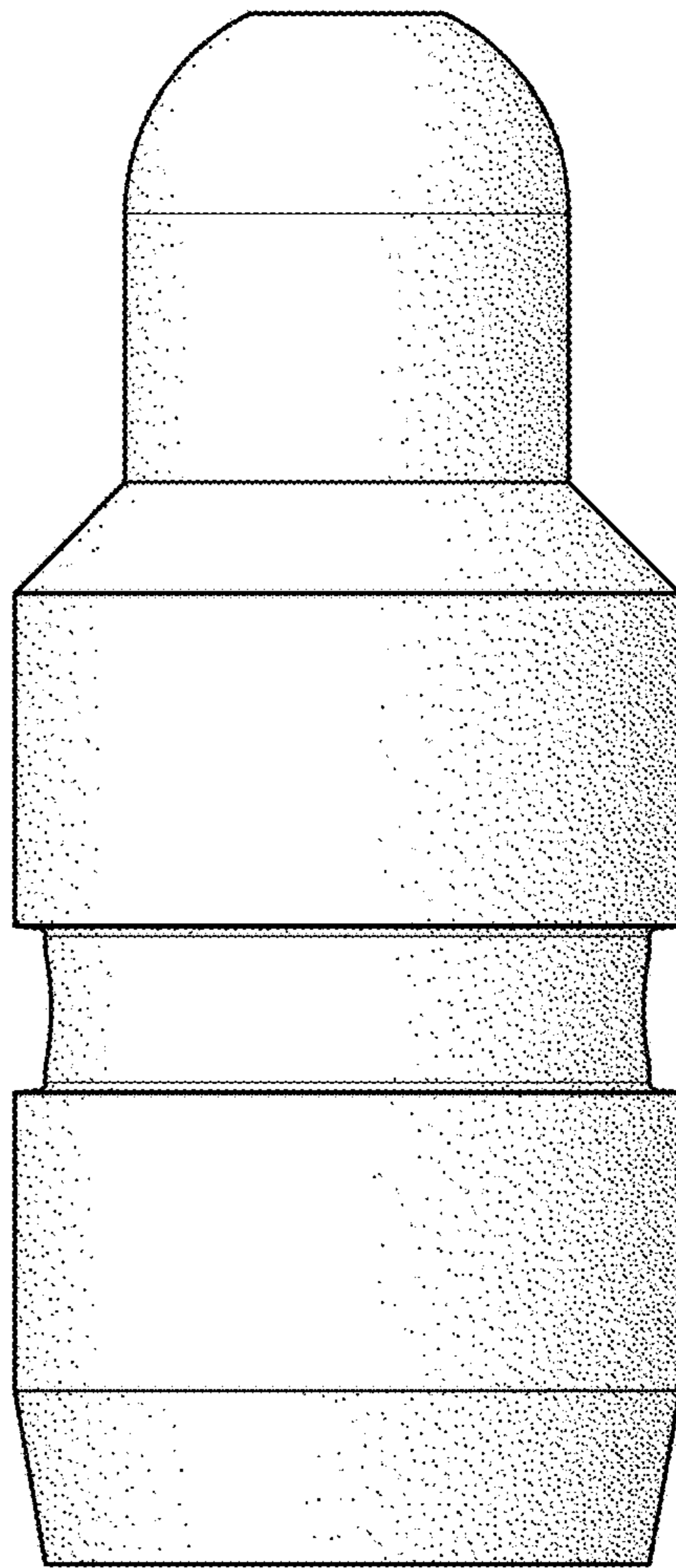

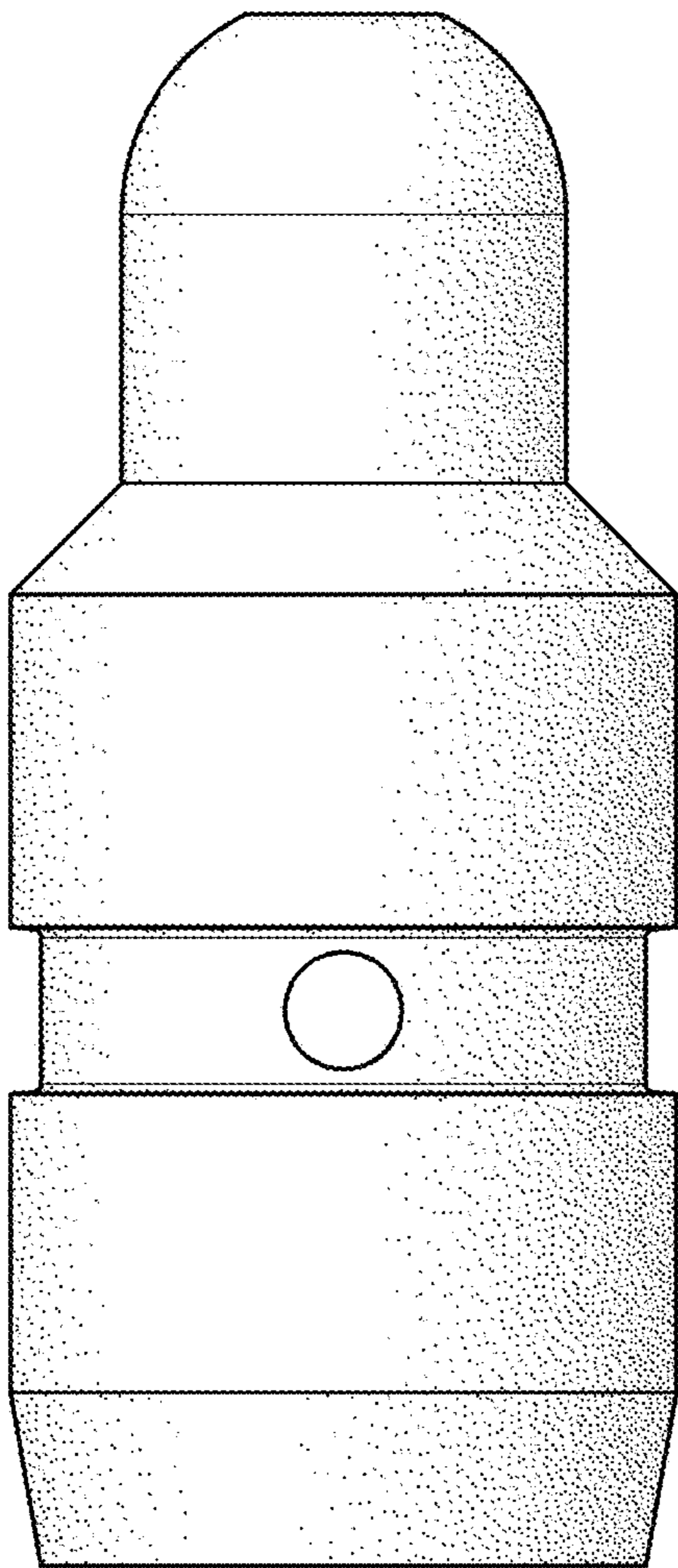

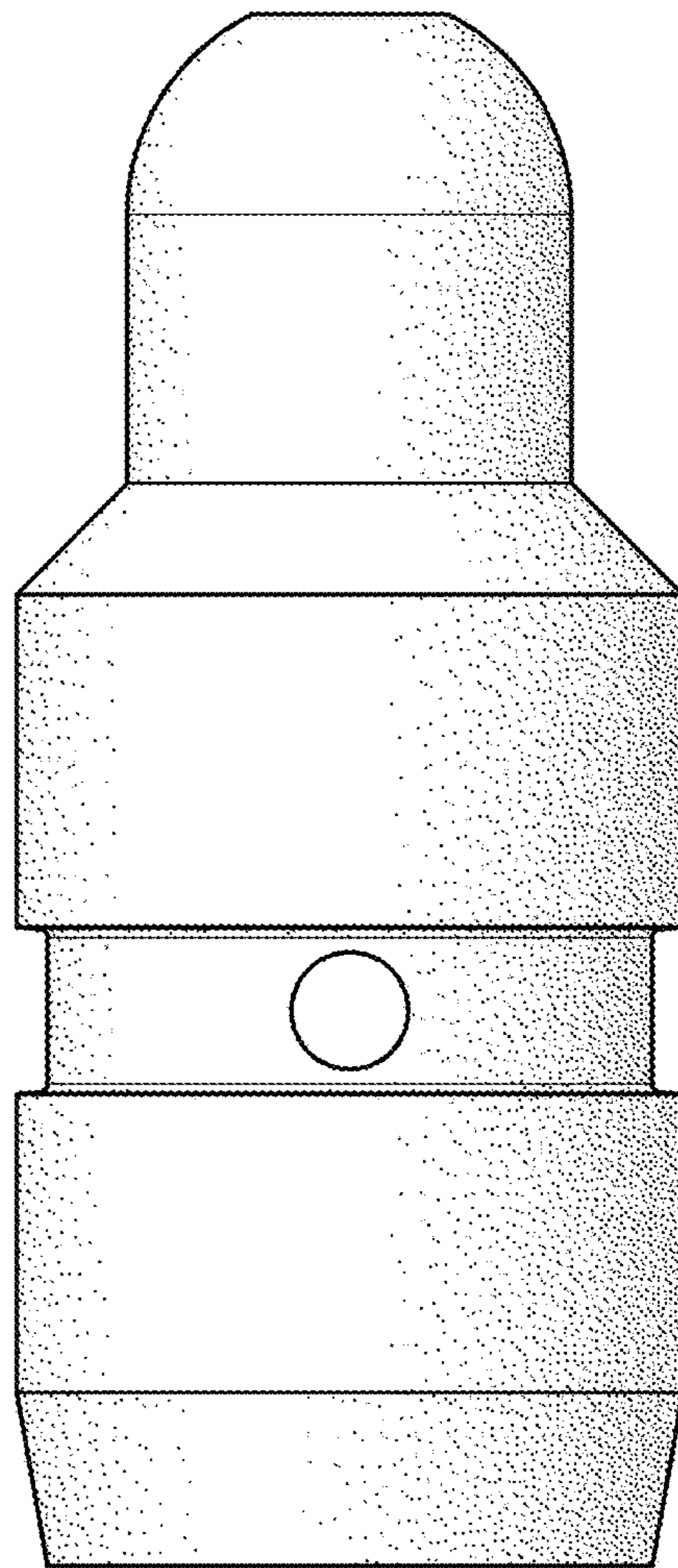
