DESCRIPTION

FIG. 1 is a front perspective view of a printer showing our new design;

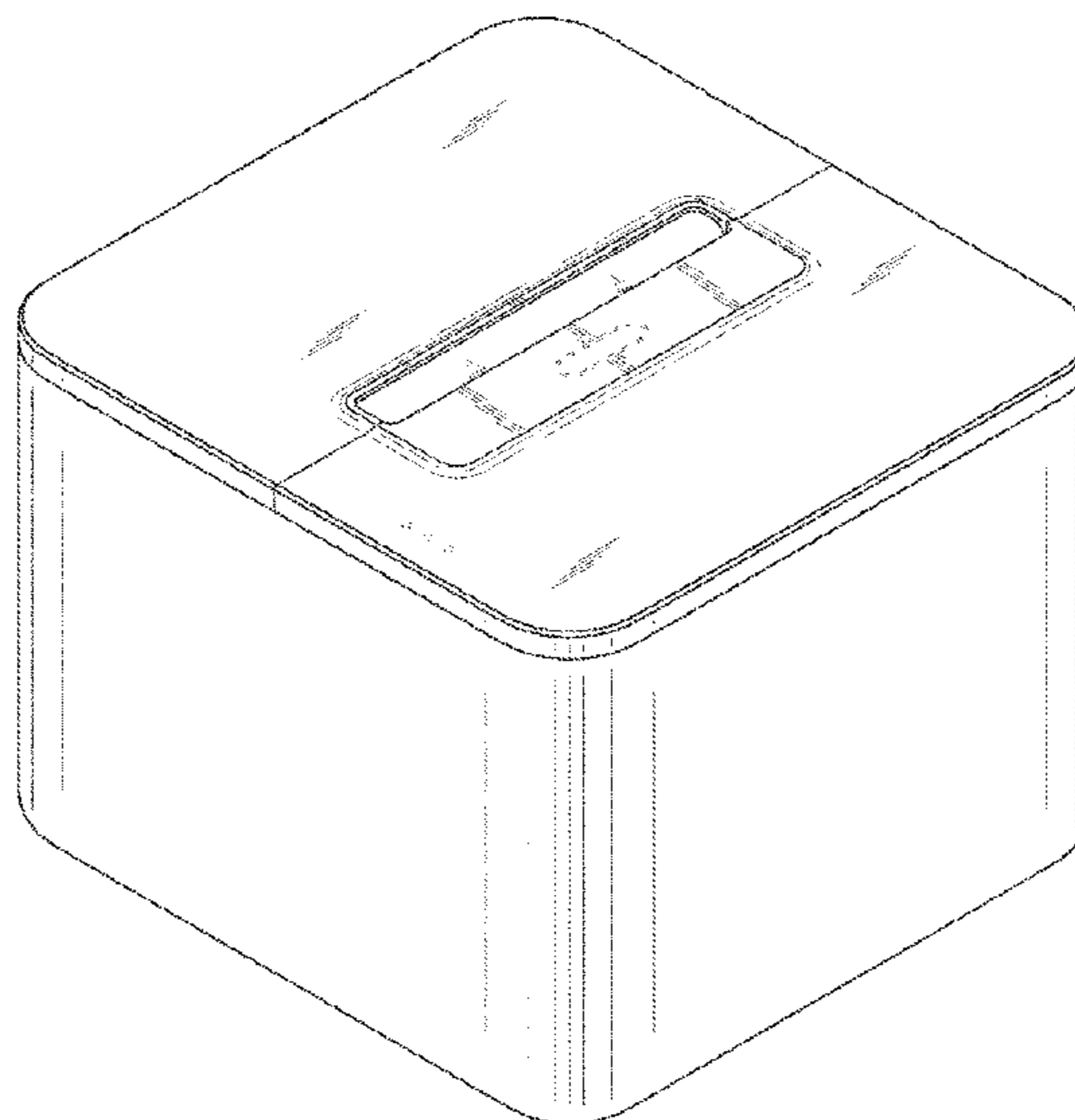

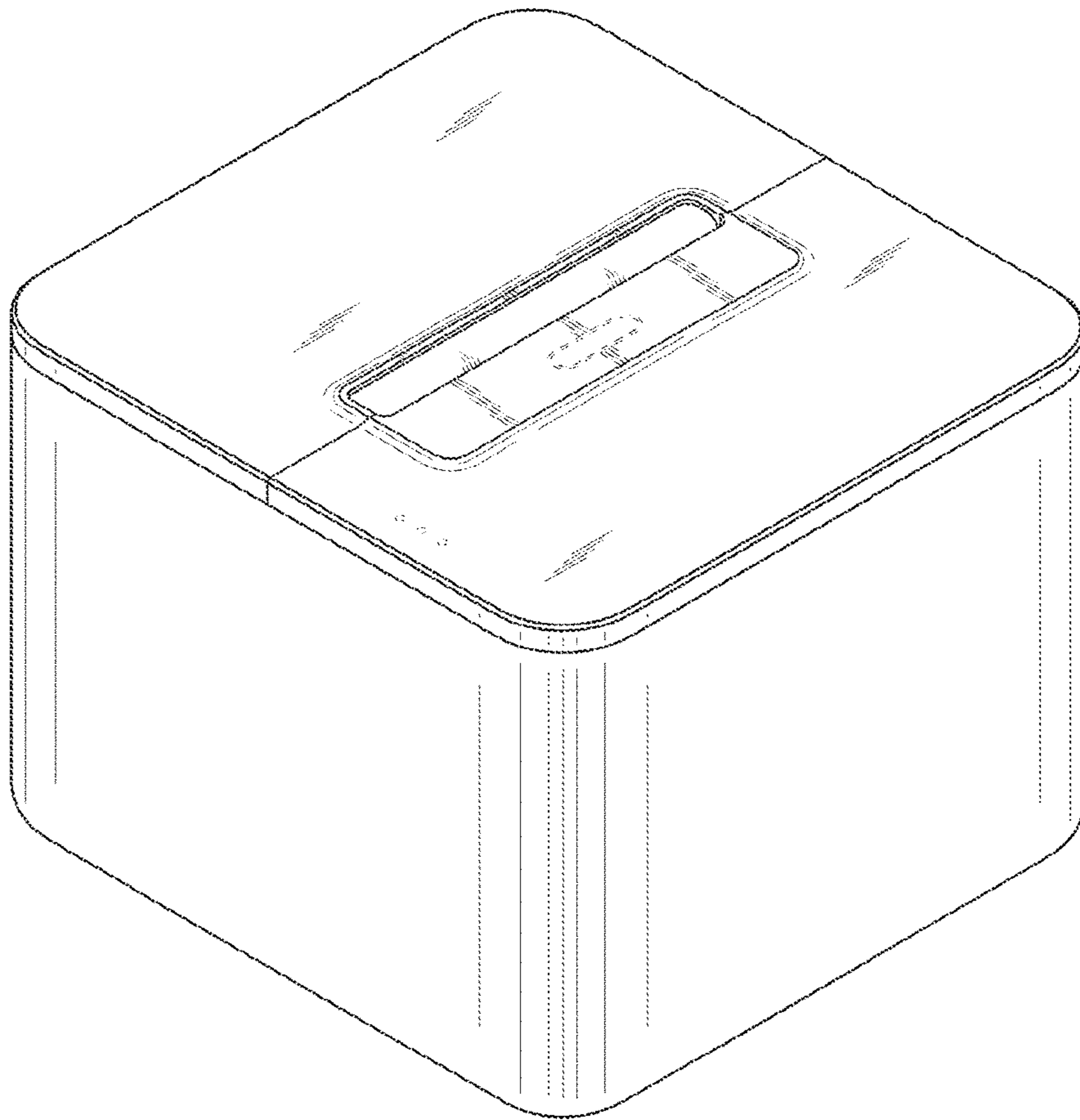

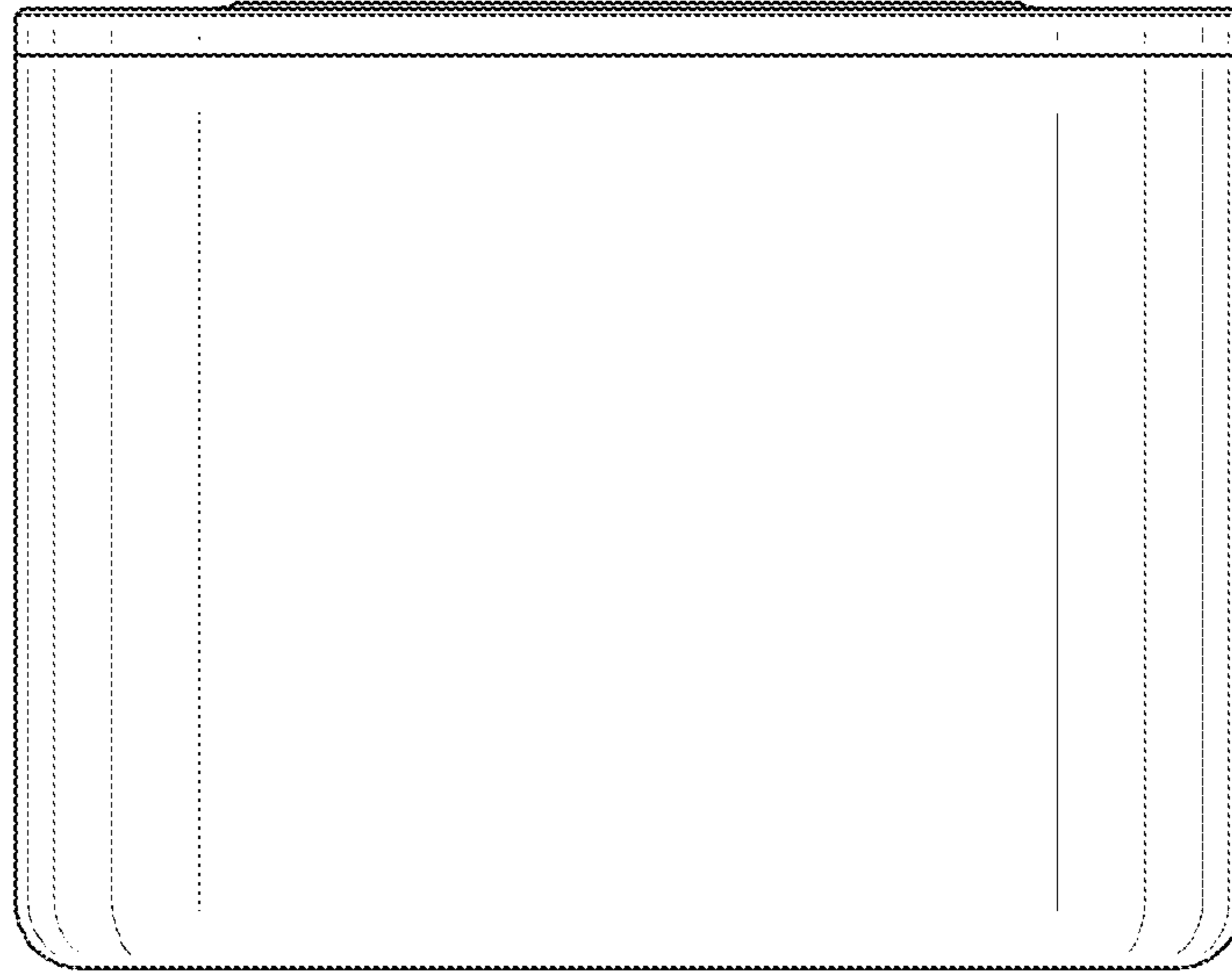

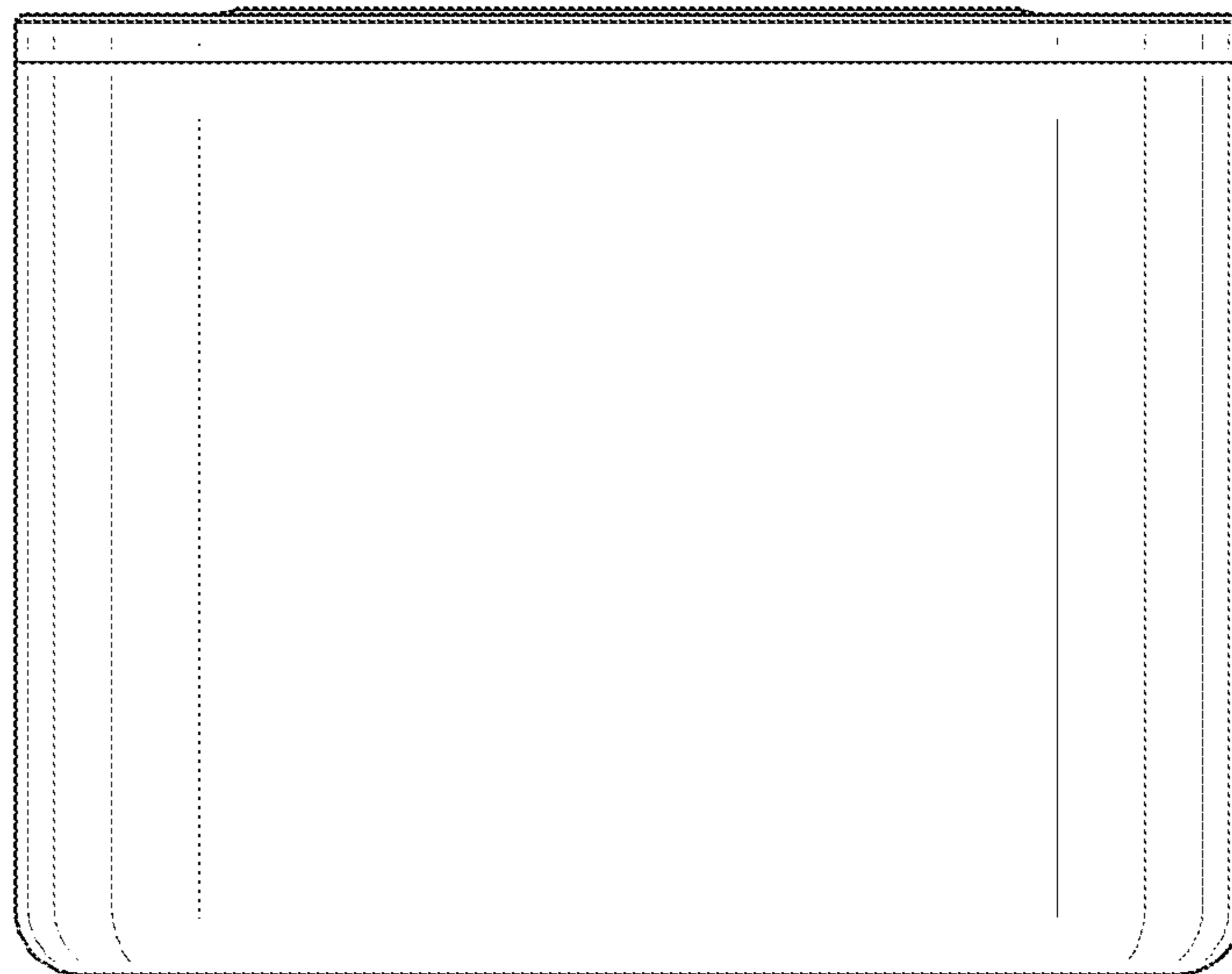

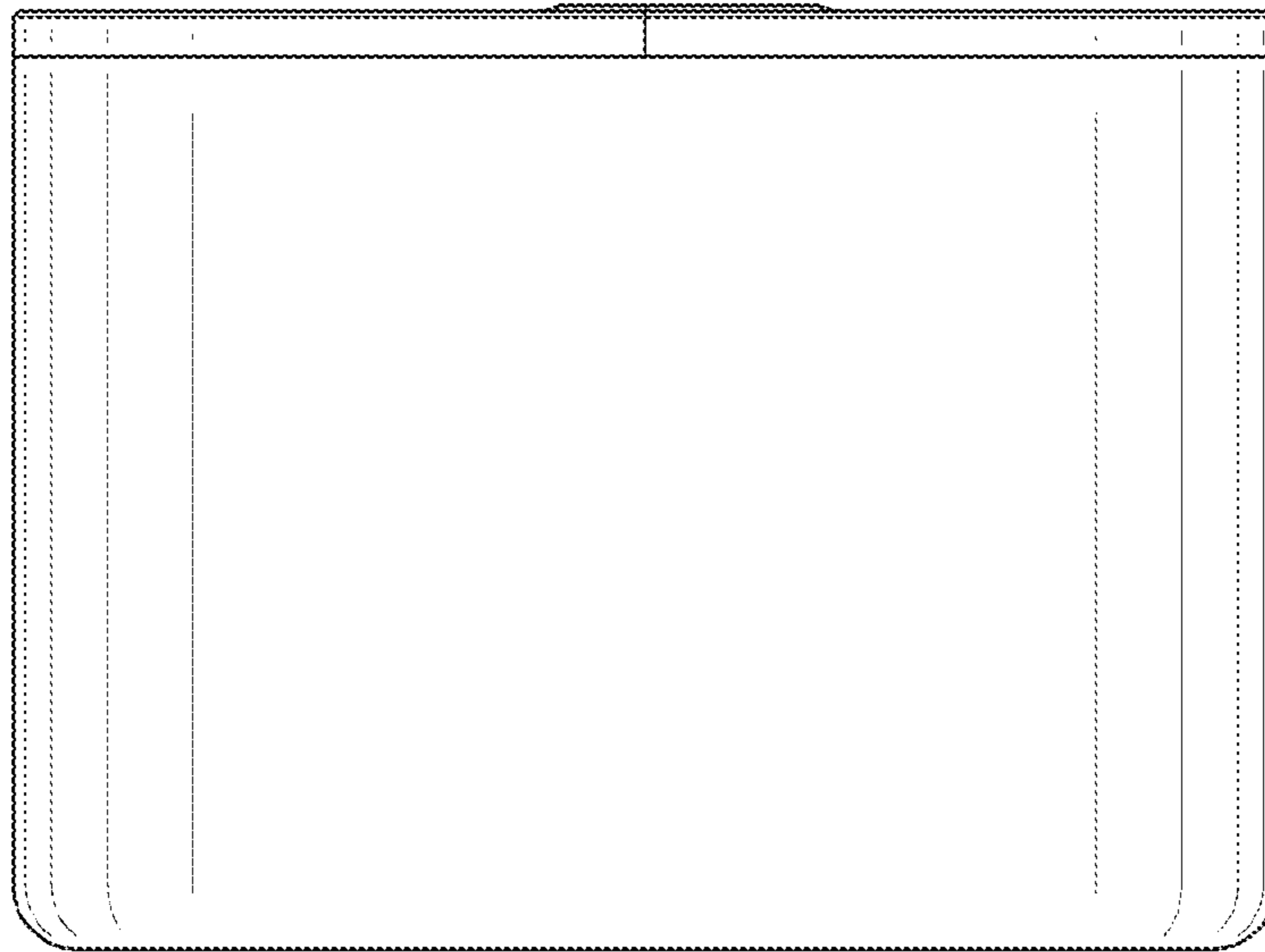

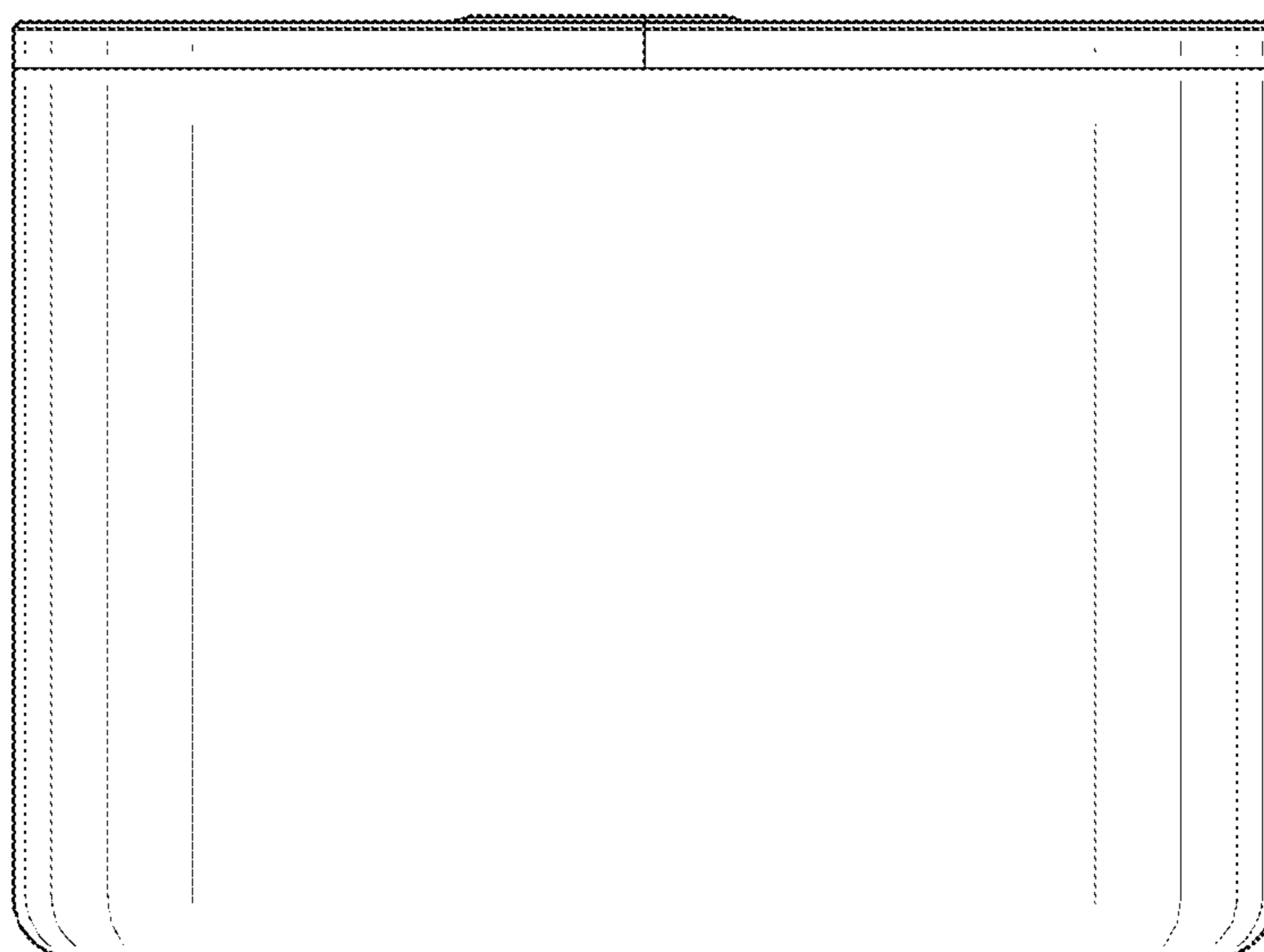
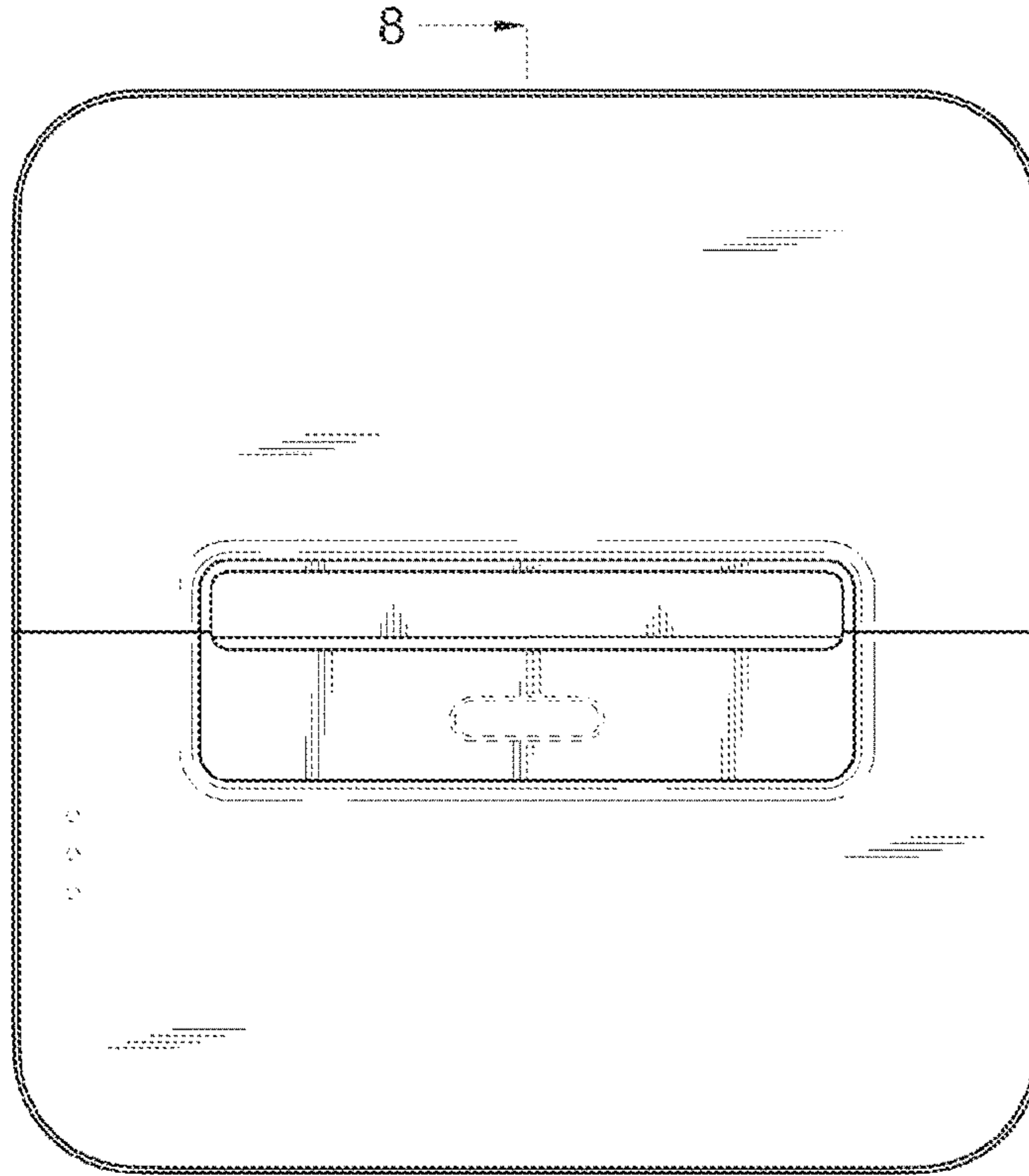

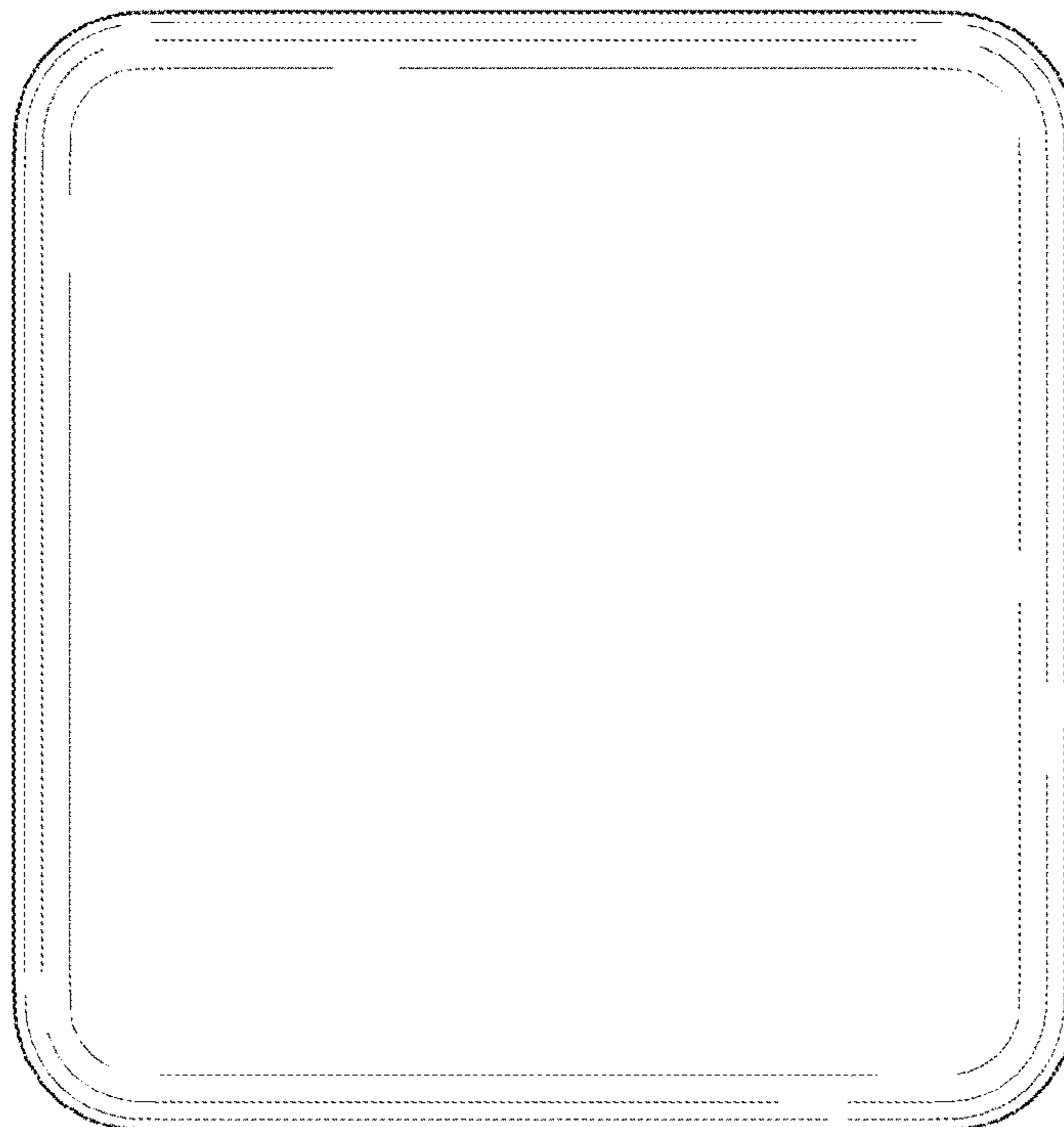
