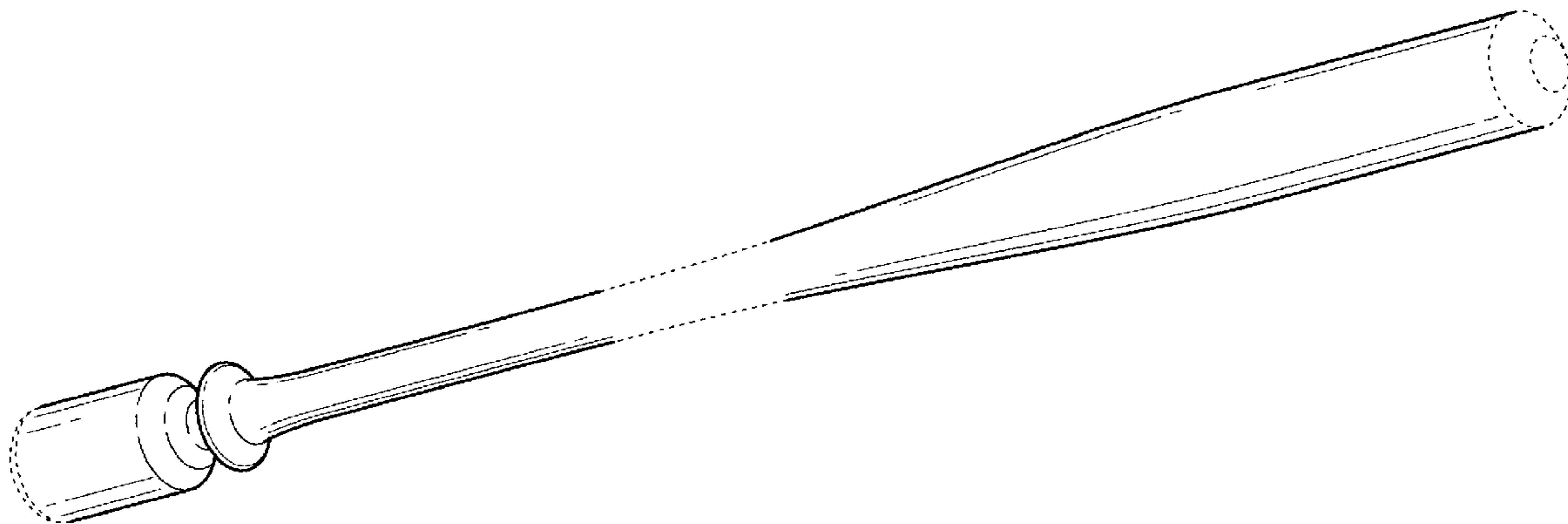
(57) **CLAIM**

The ornamental design for a baseball bat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a baseball bat in accordance with my new design;
FIG. 2 is an elevational view thereof;

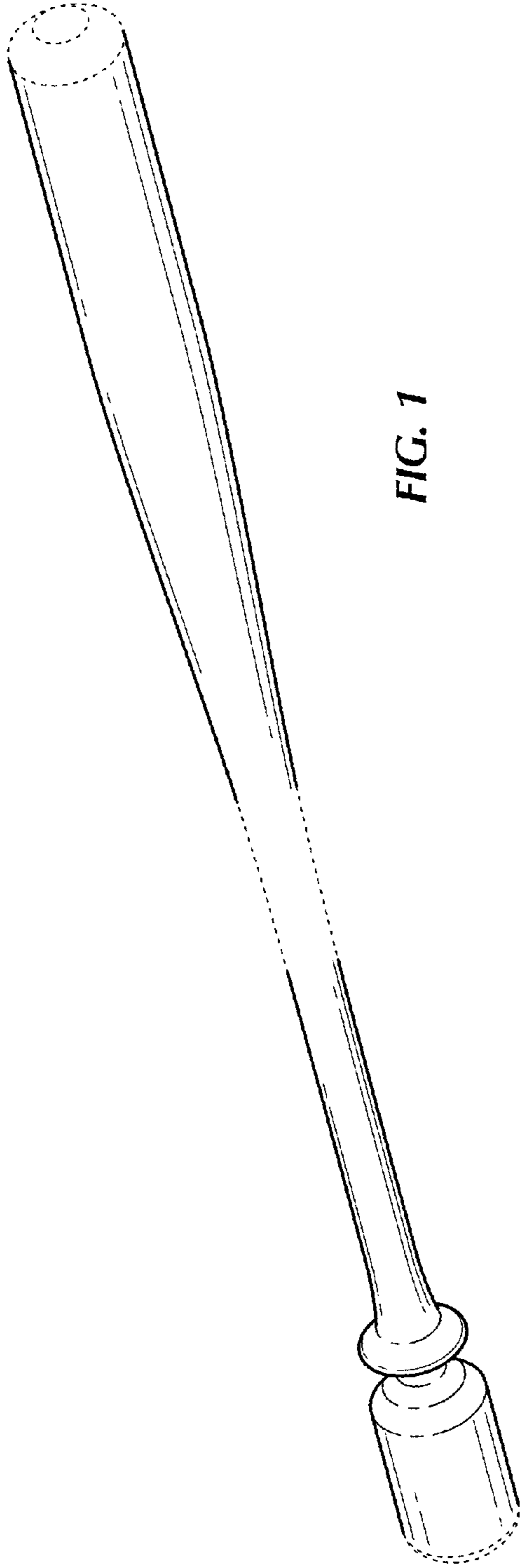

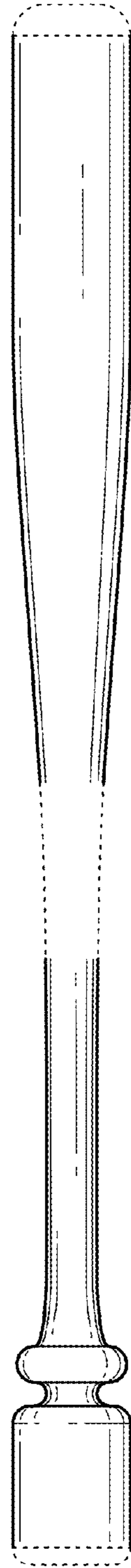

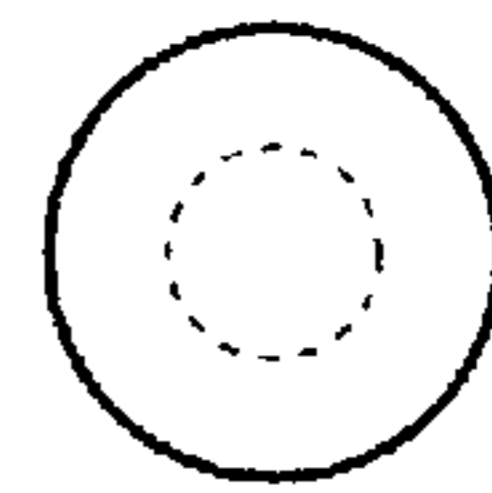

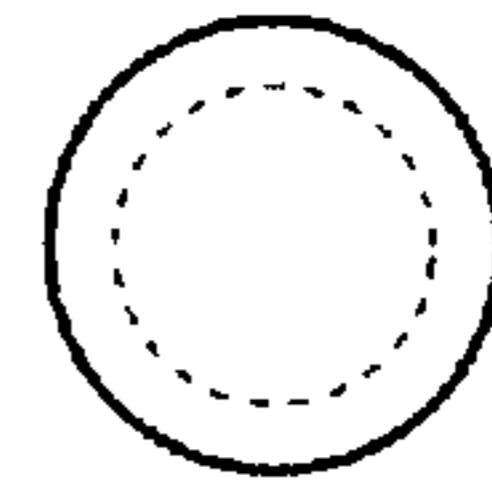
