(57) **CLAIM**

We claim the ornamental design for a water fountain spray head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a water fountain spray head, with a single water diverter.

FIG. 20 is another side elevation view thereof, rotated 45 degrees.

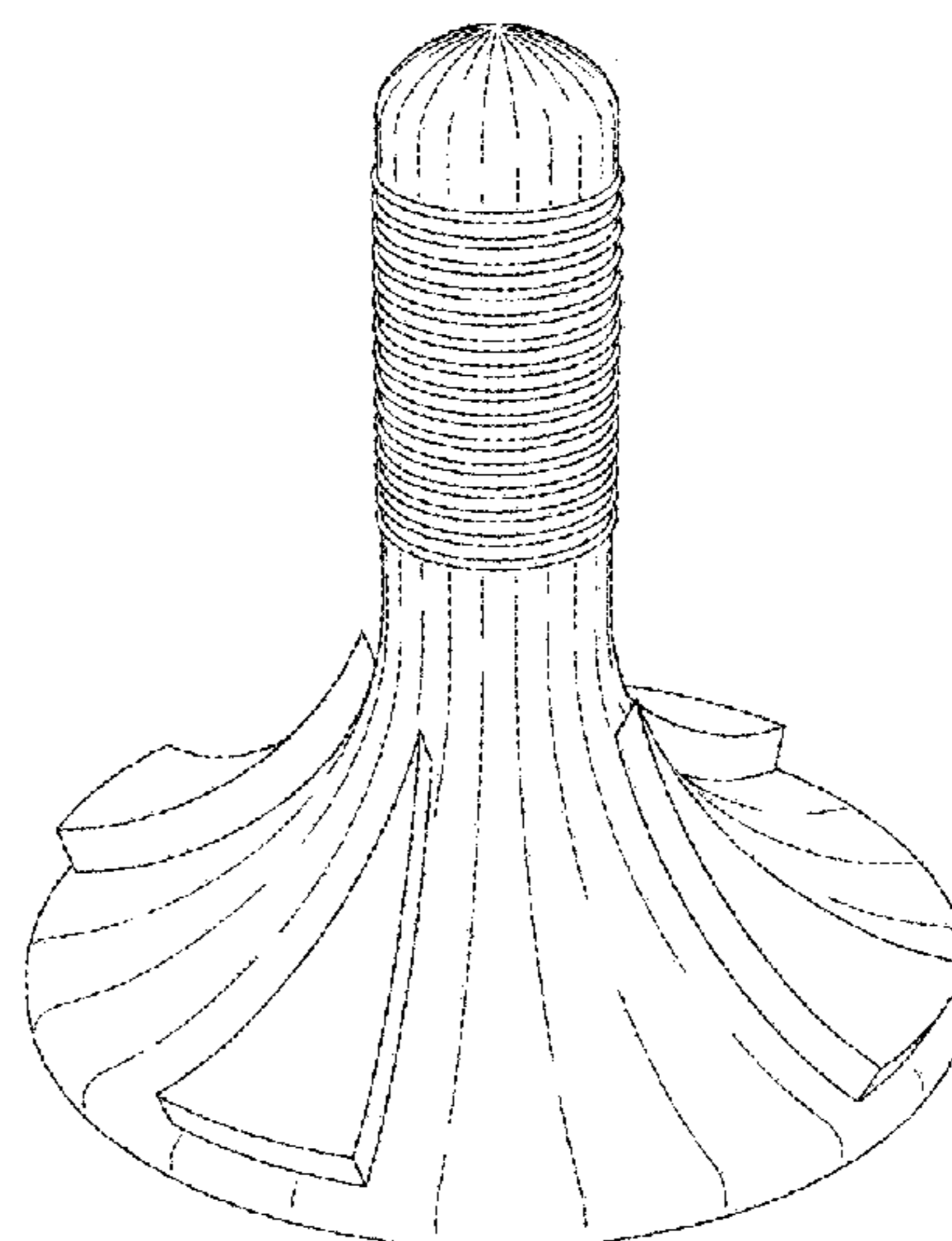
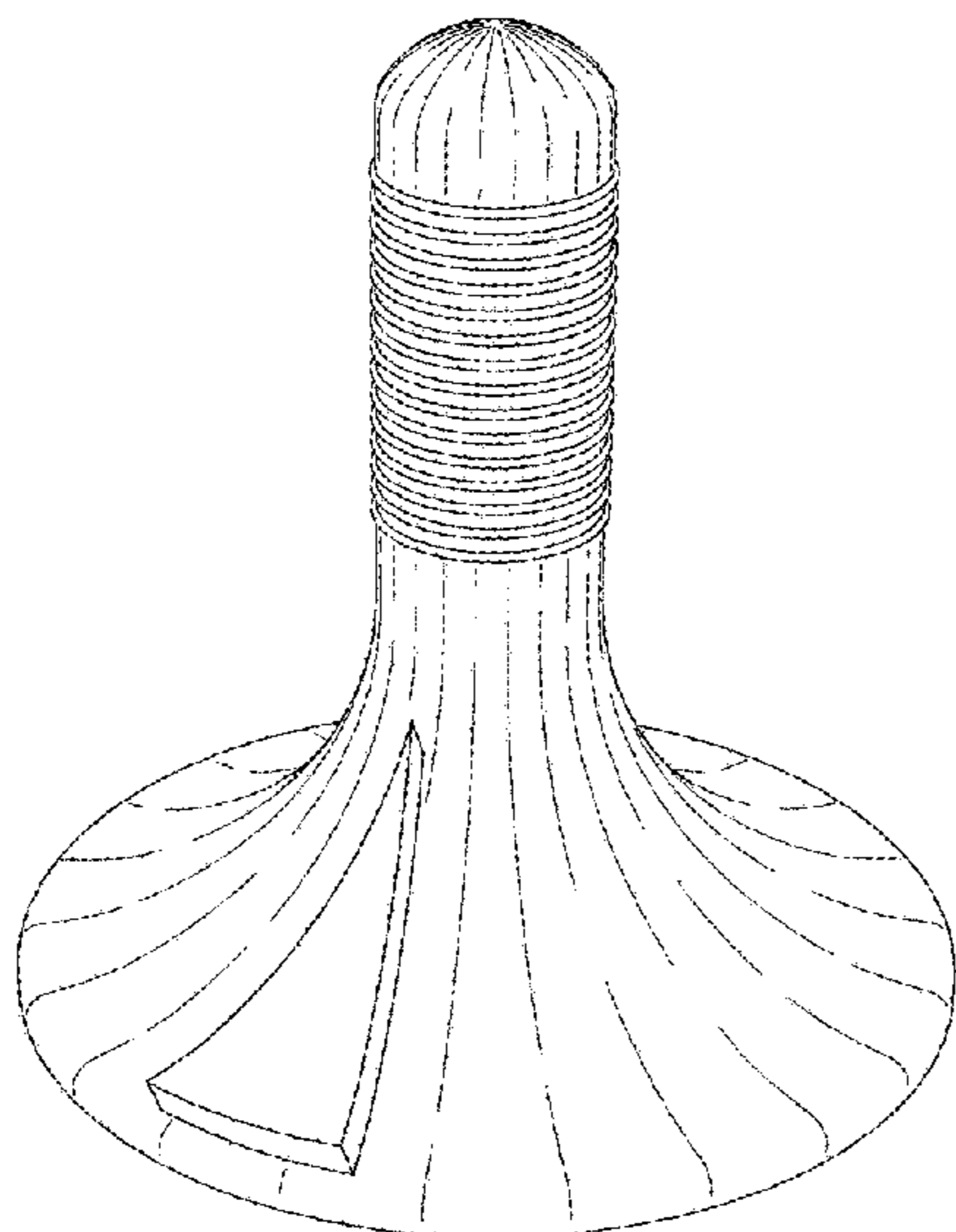
FIG. 21 is a perspective view of a water fountain spray head, with nine water diverters.

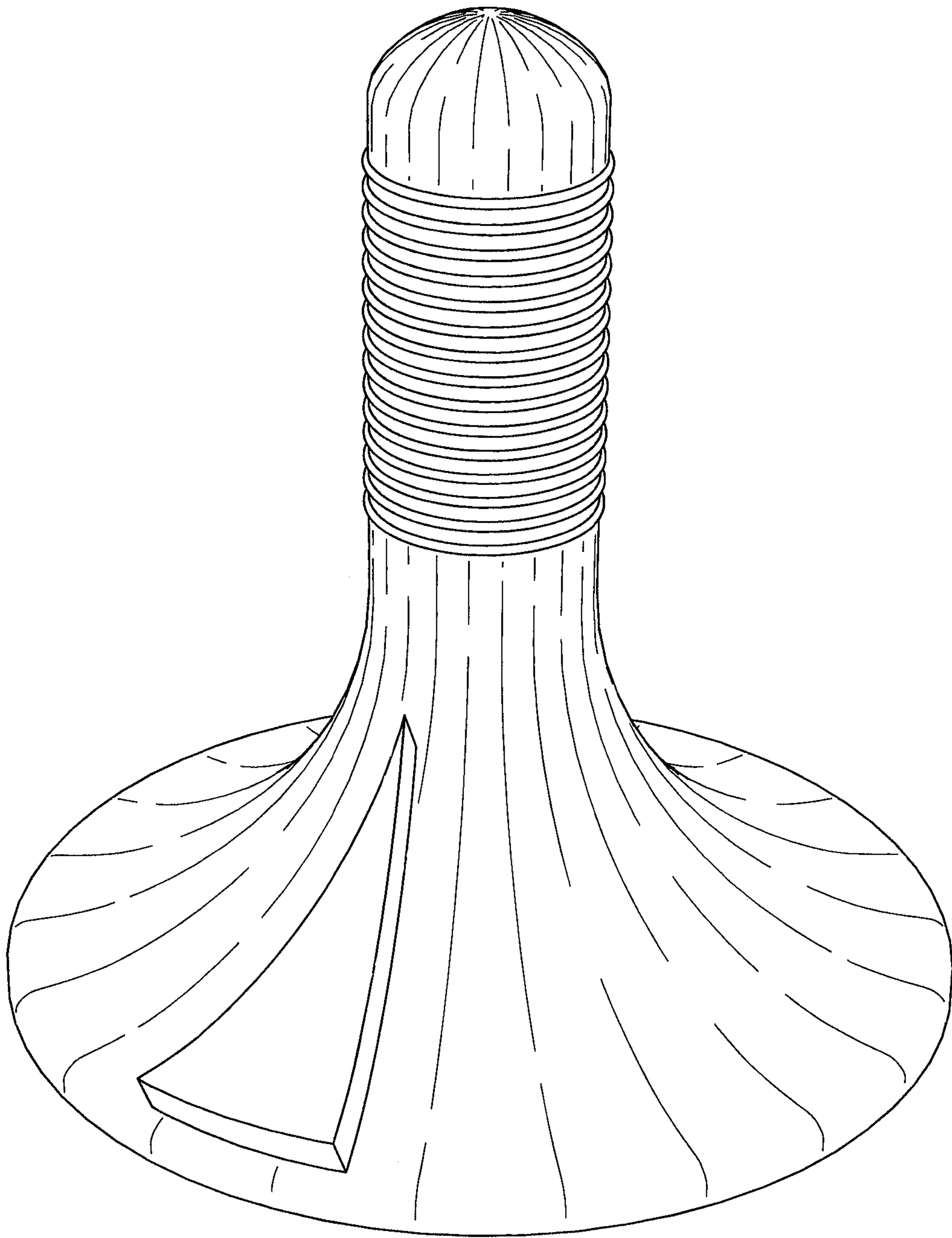

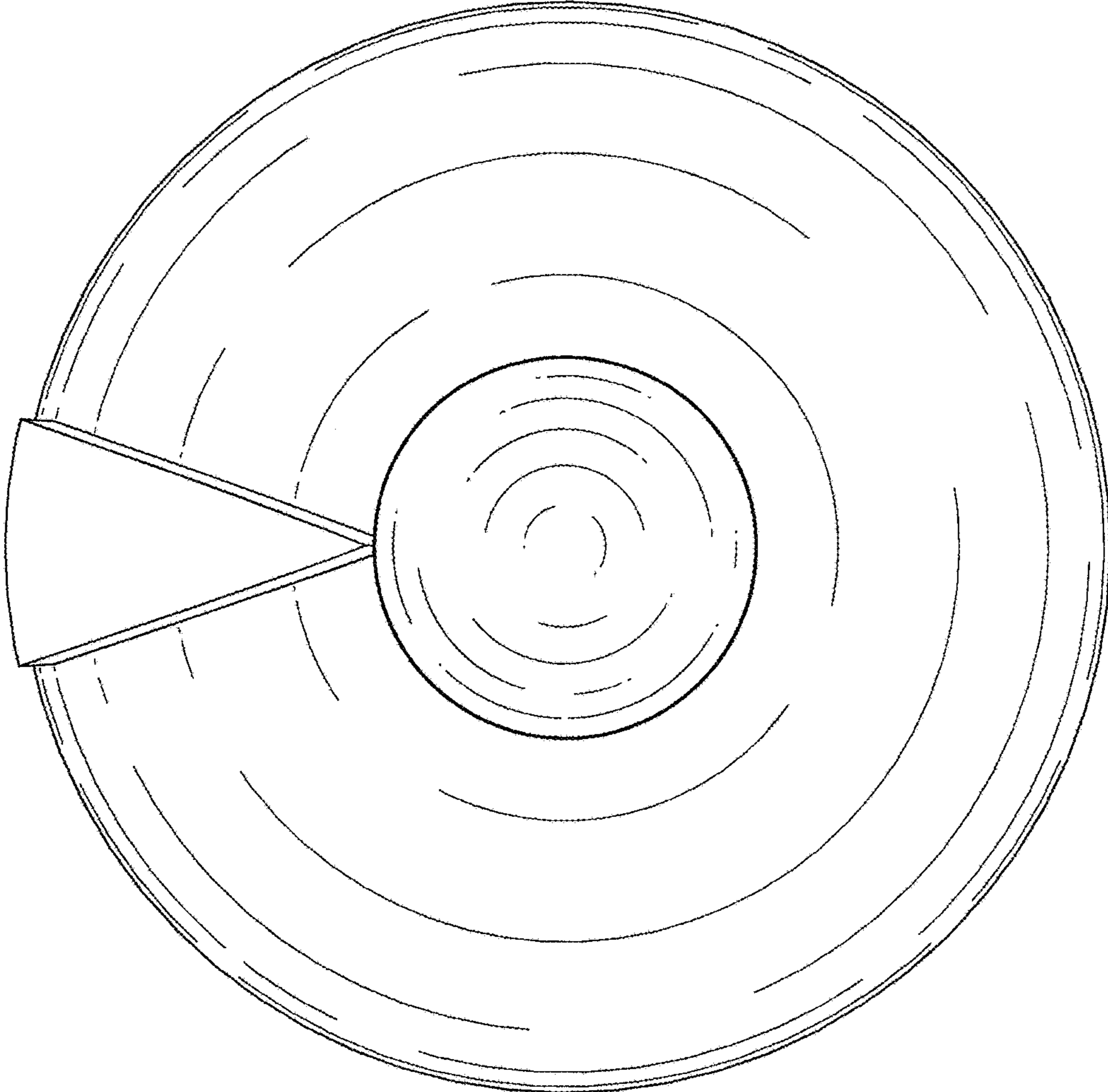

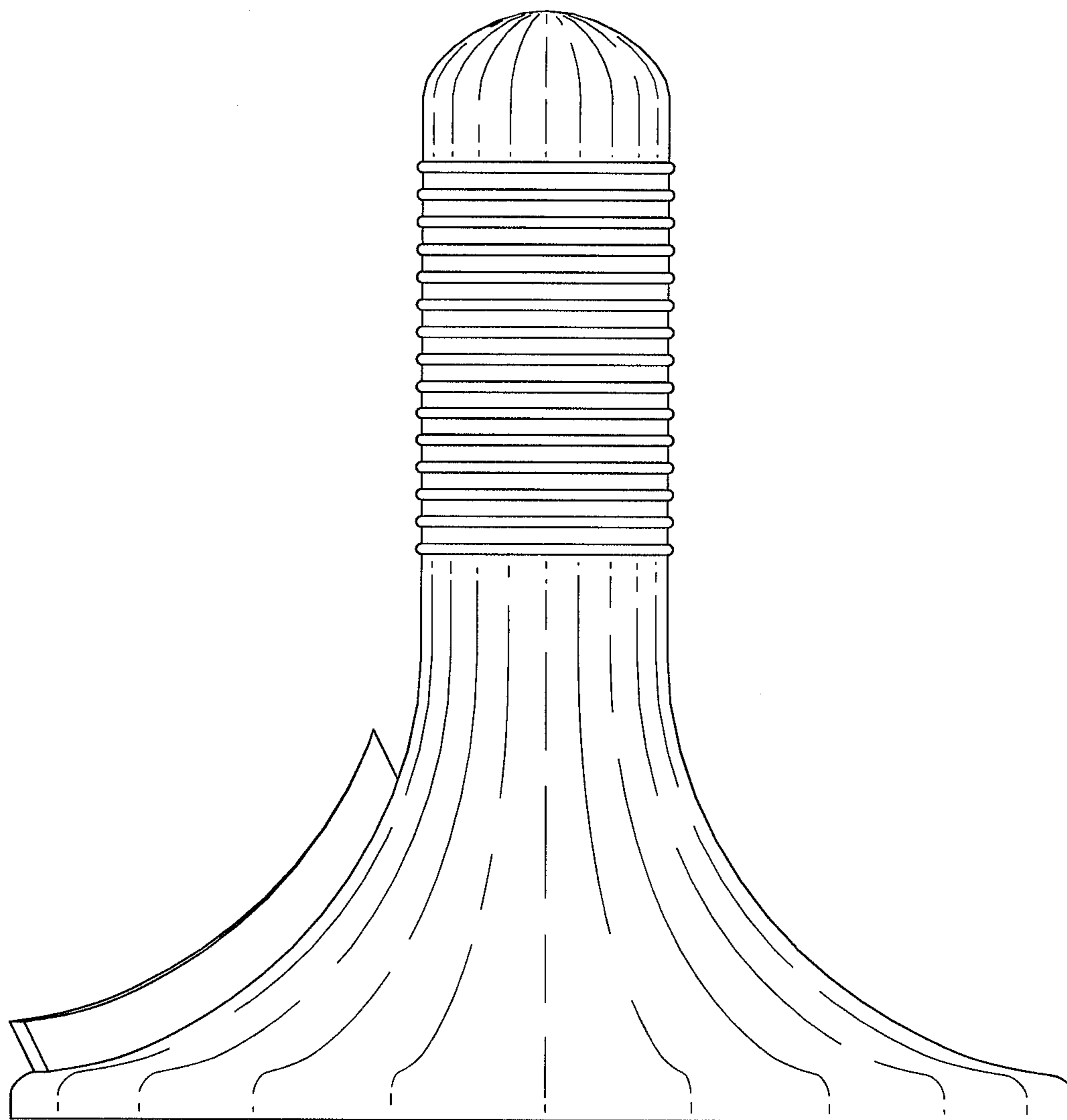

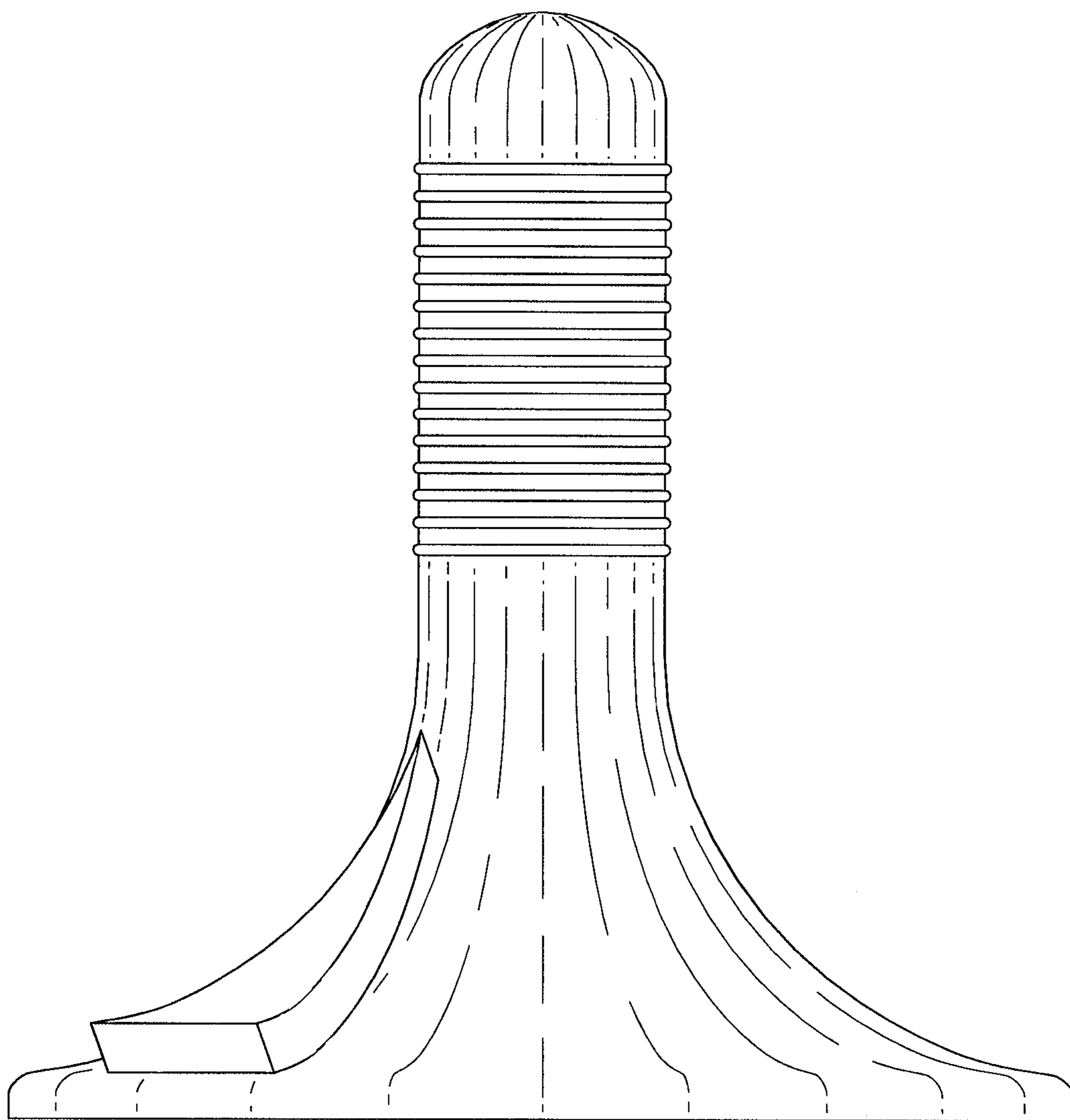

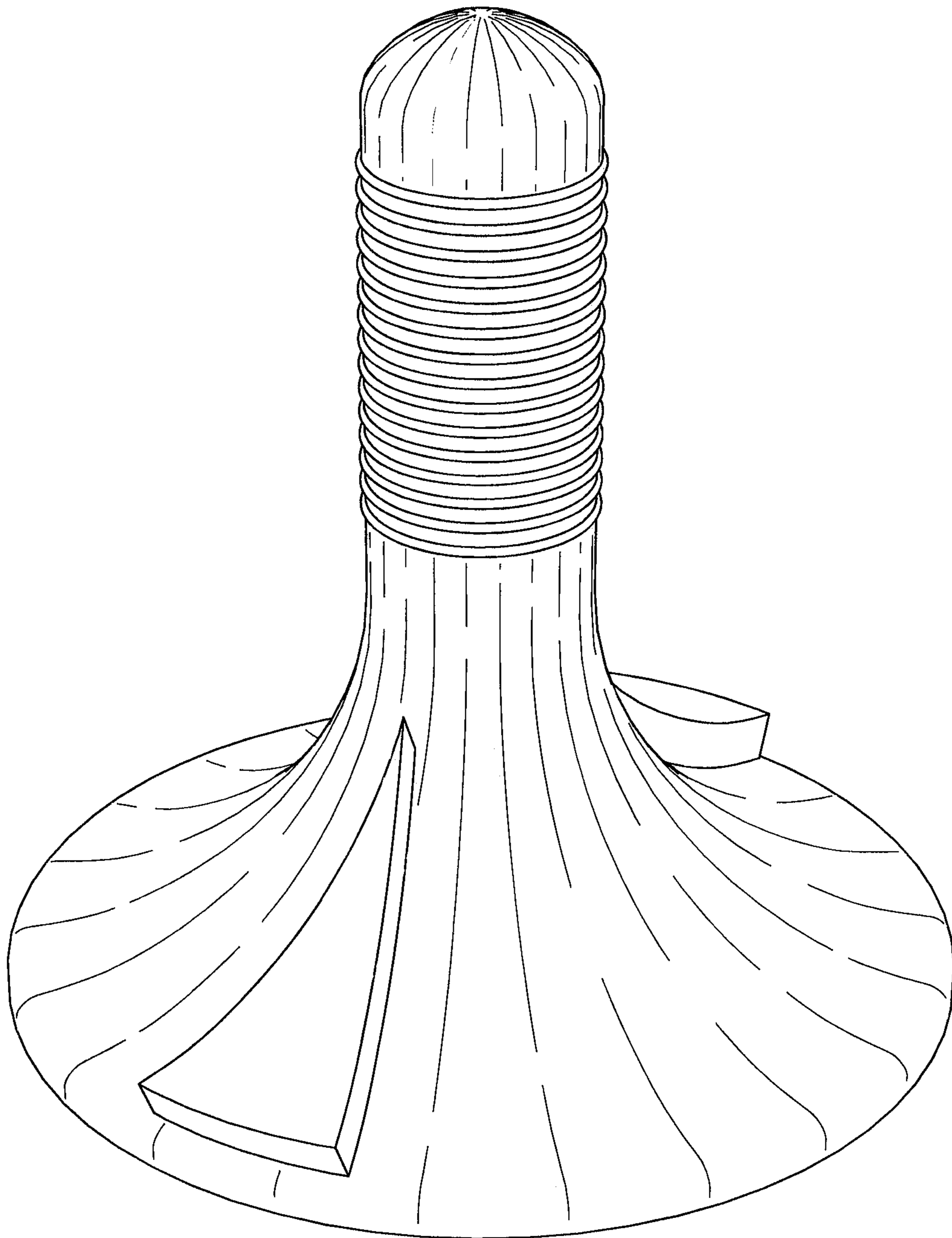

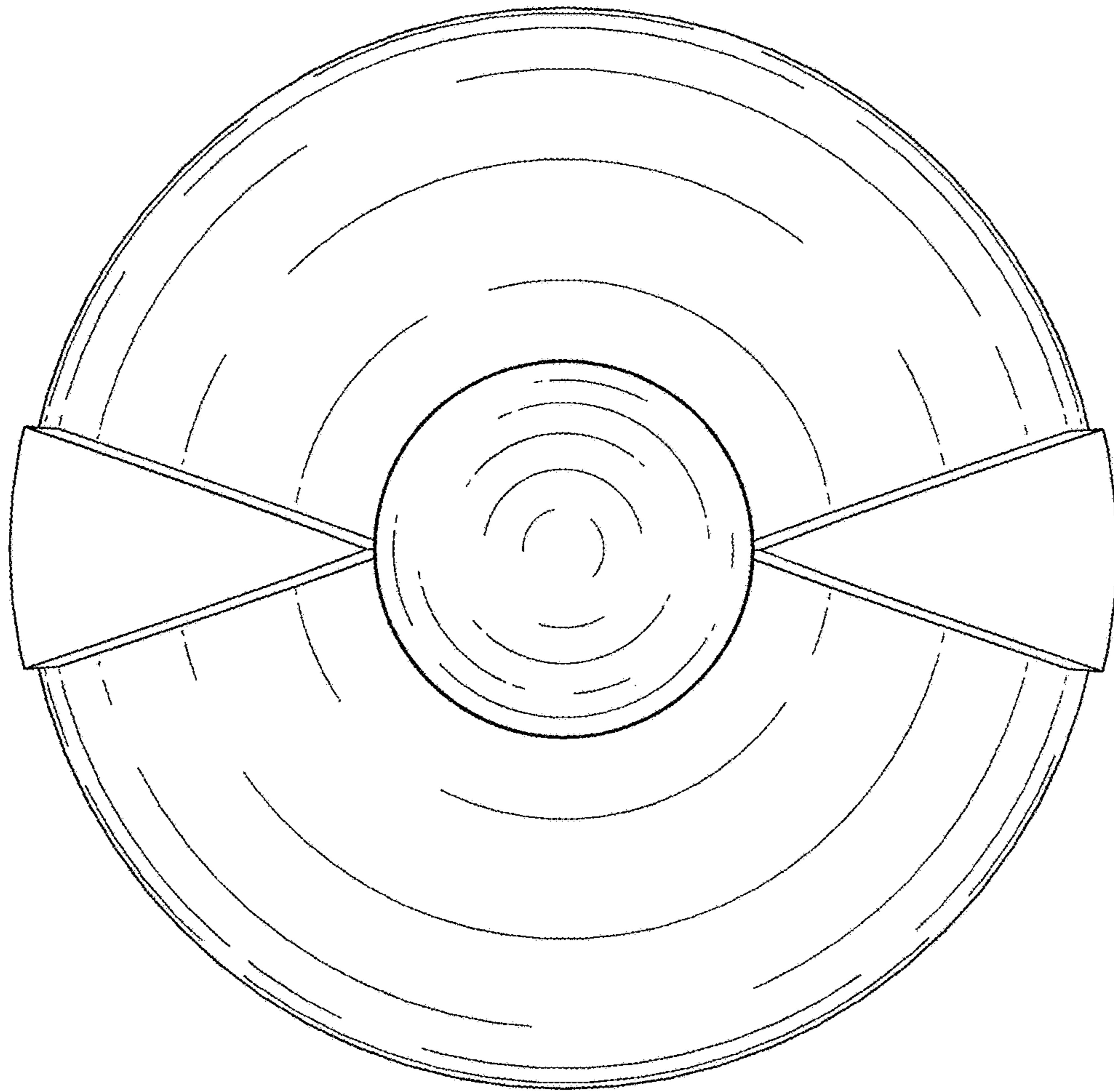

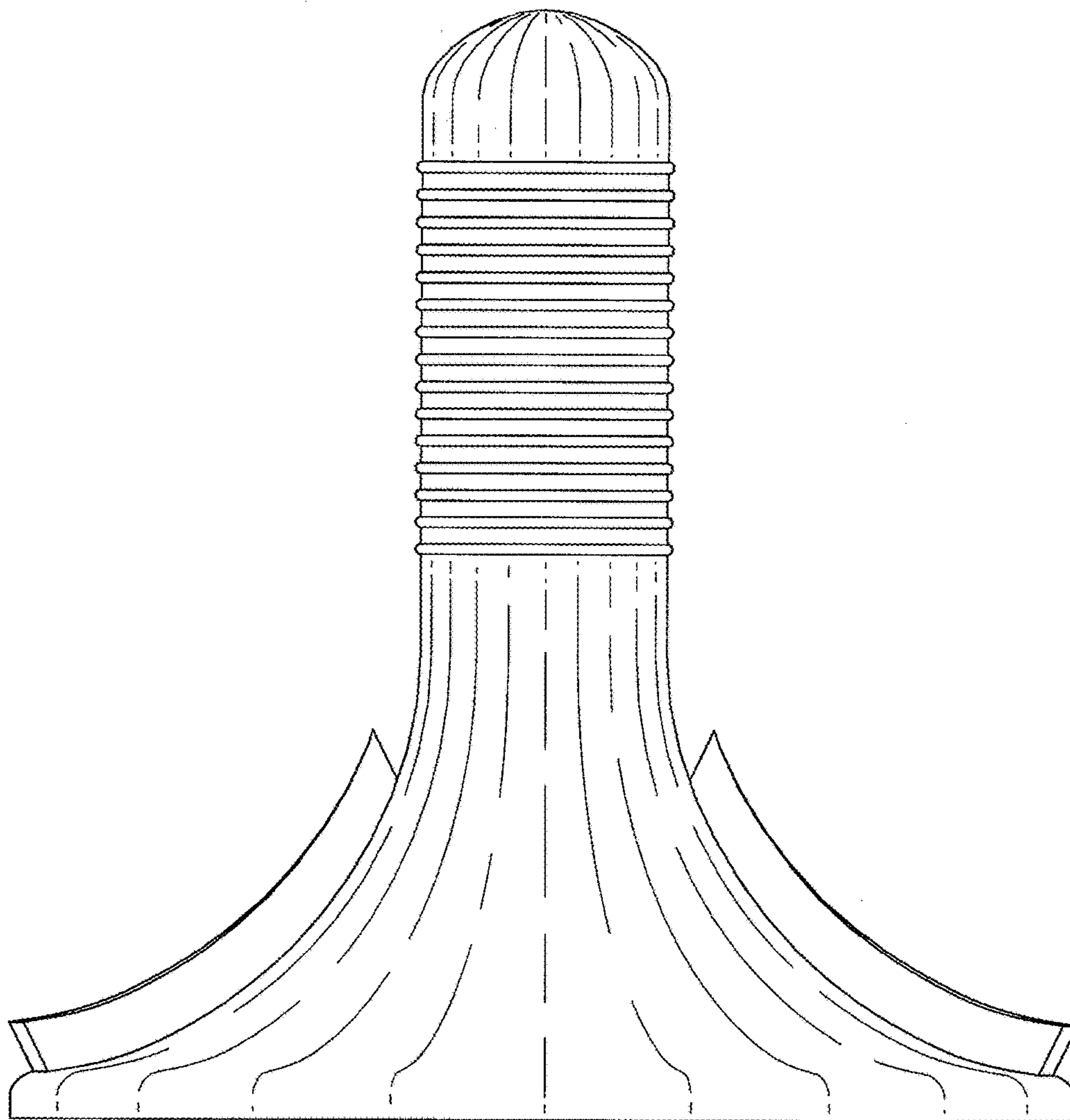

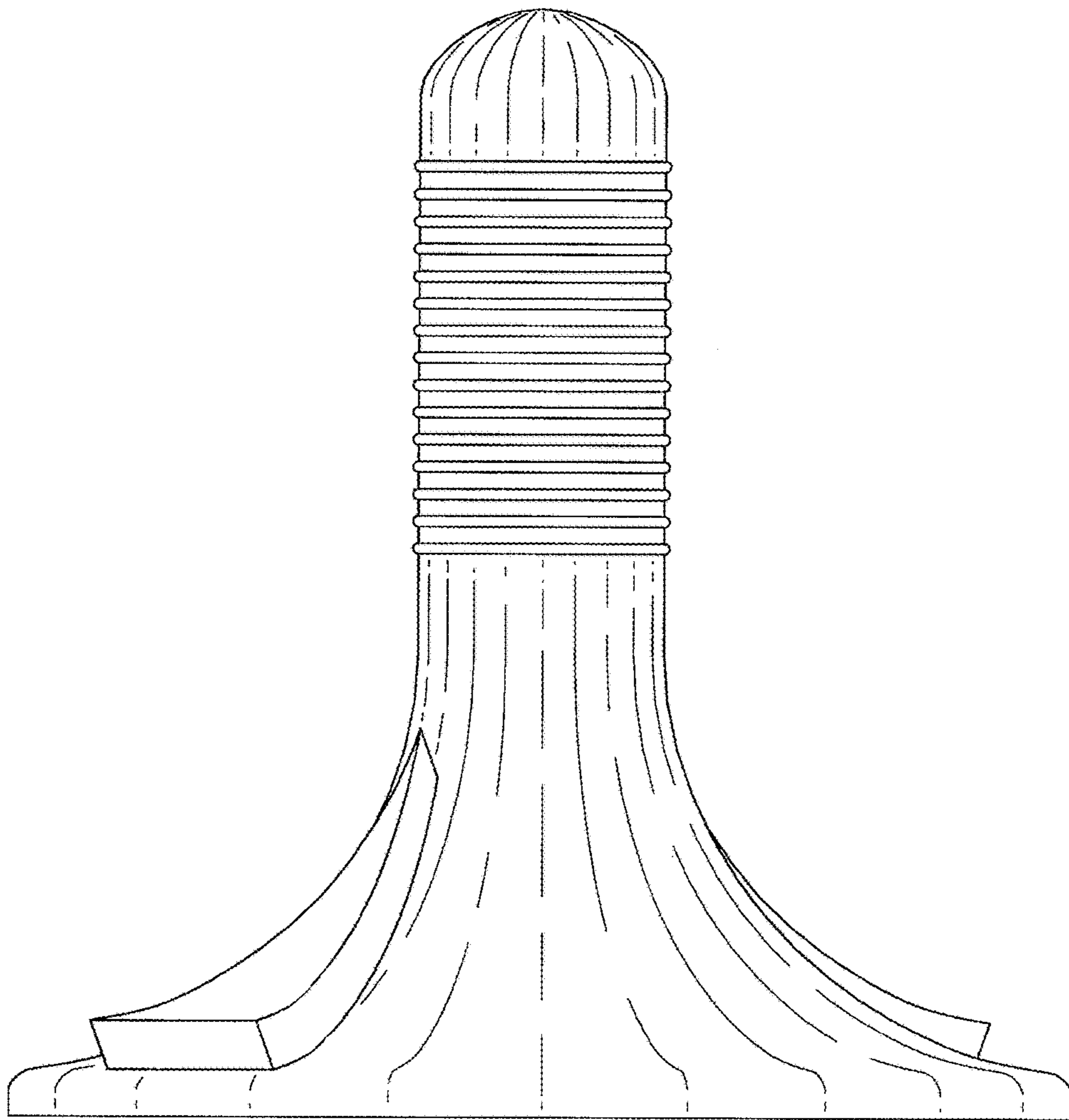

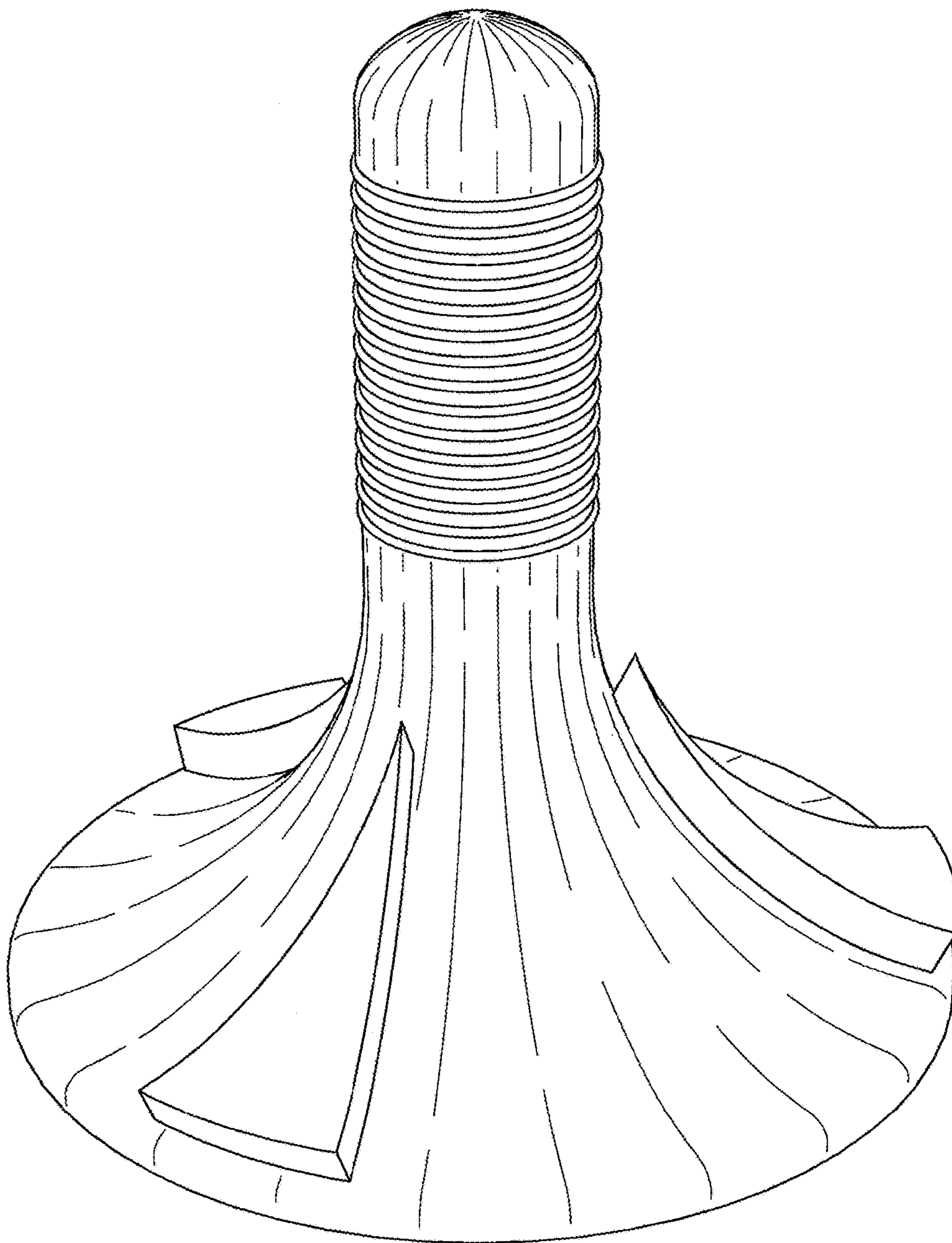

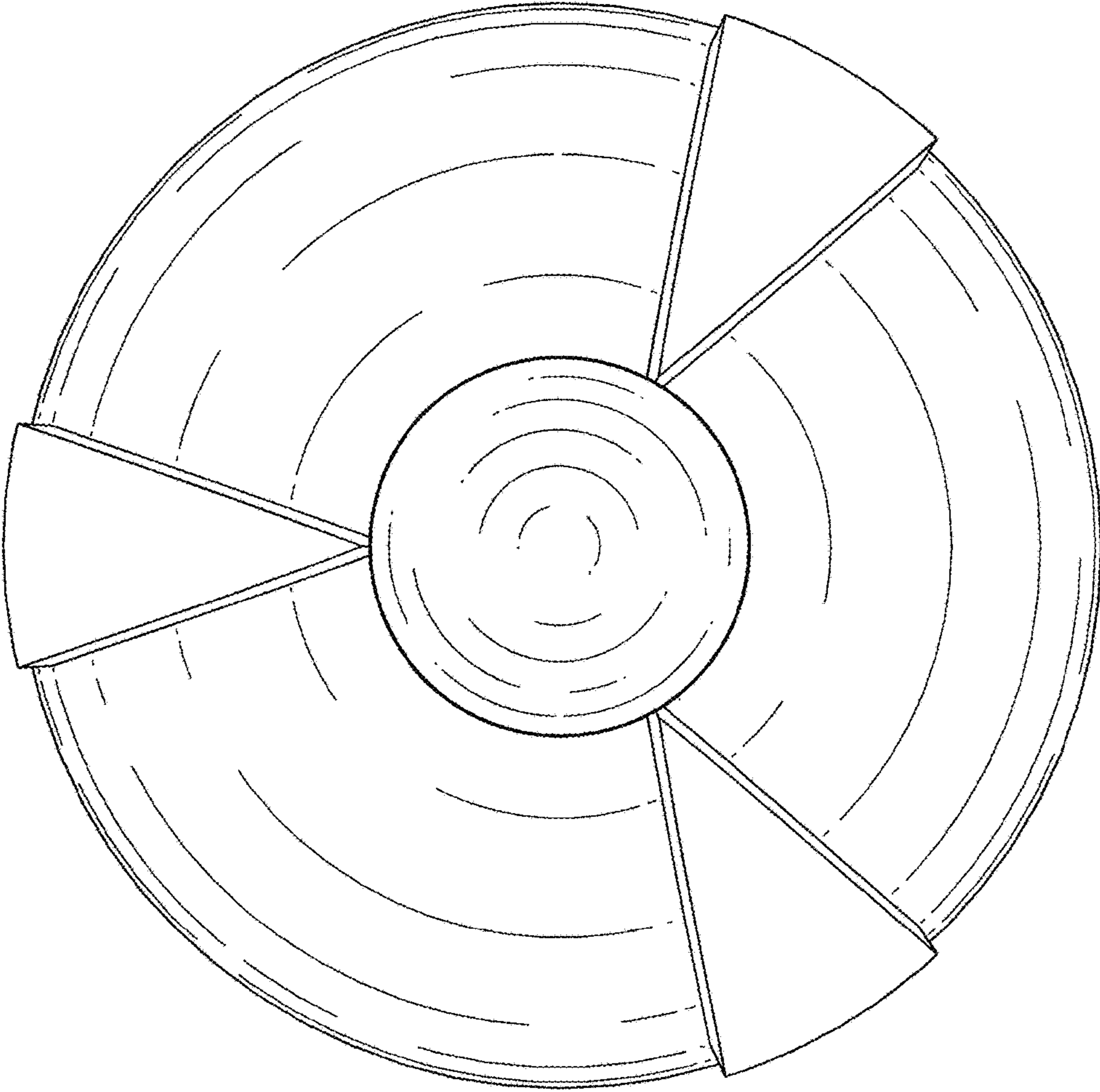

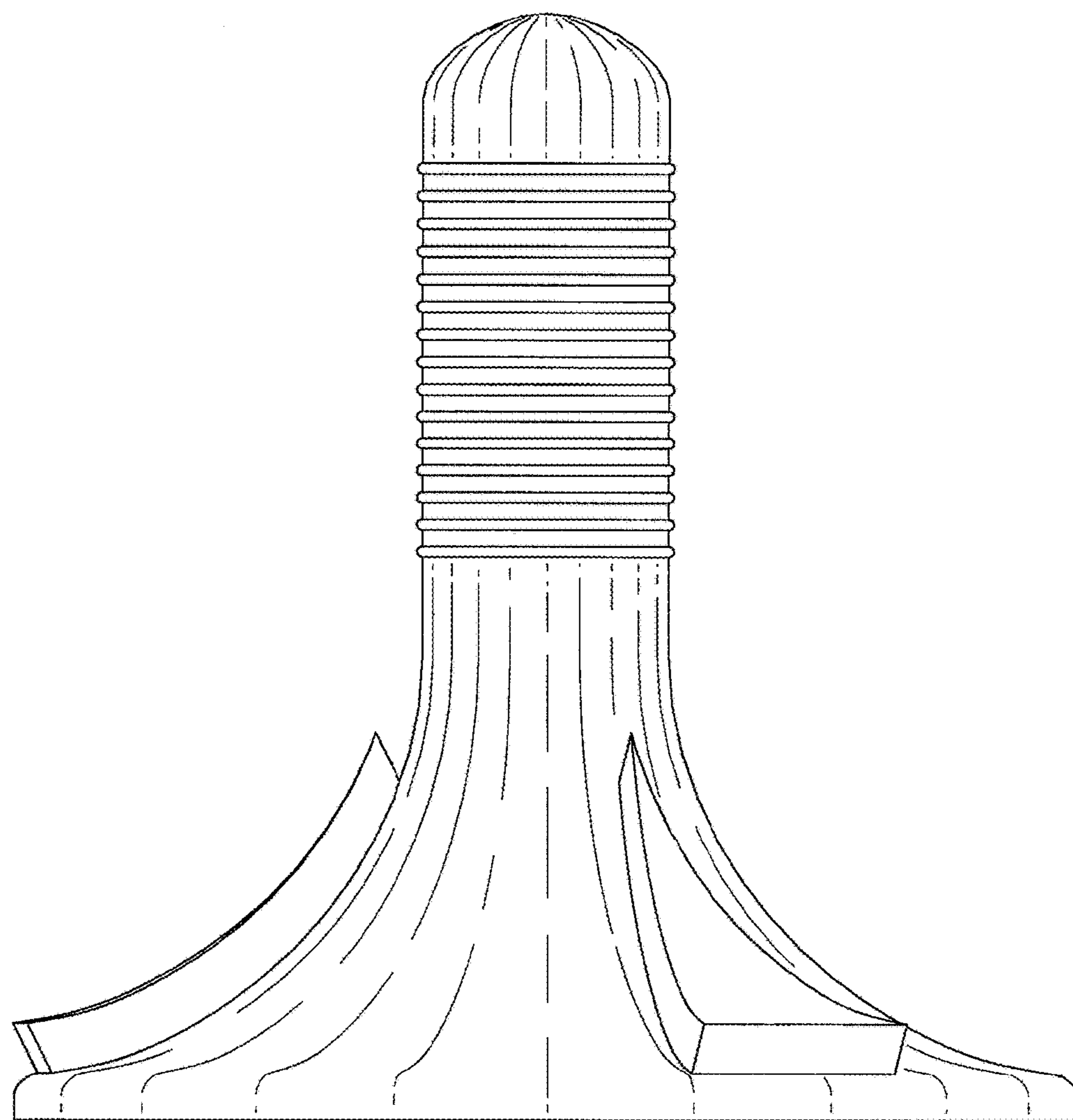

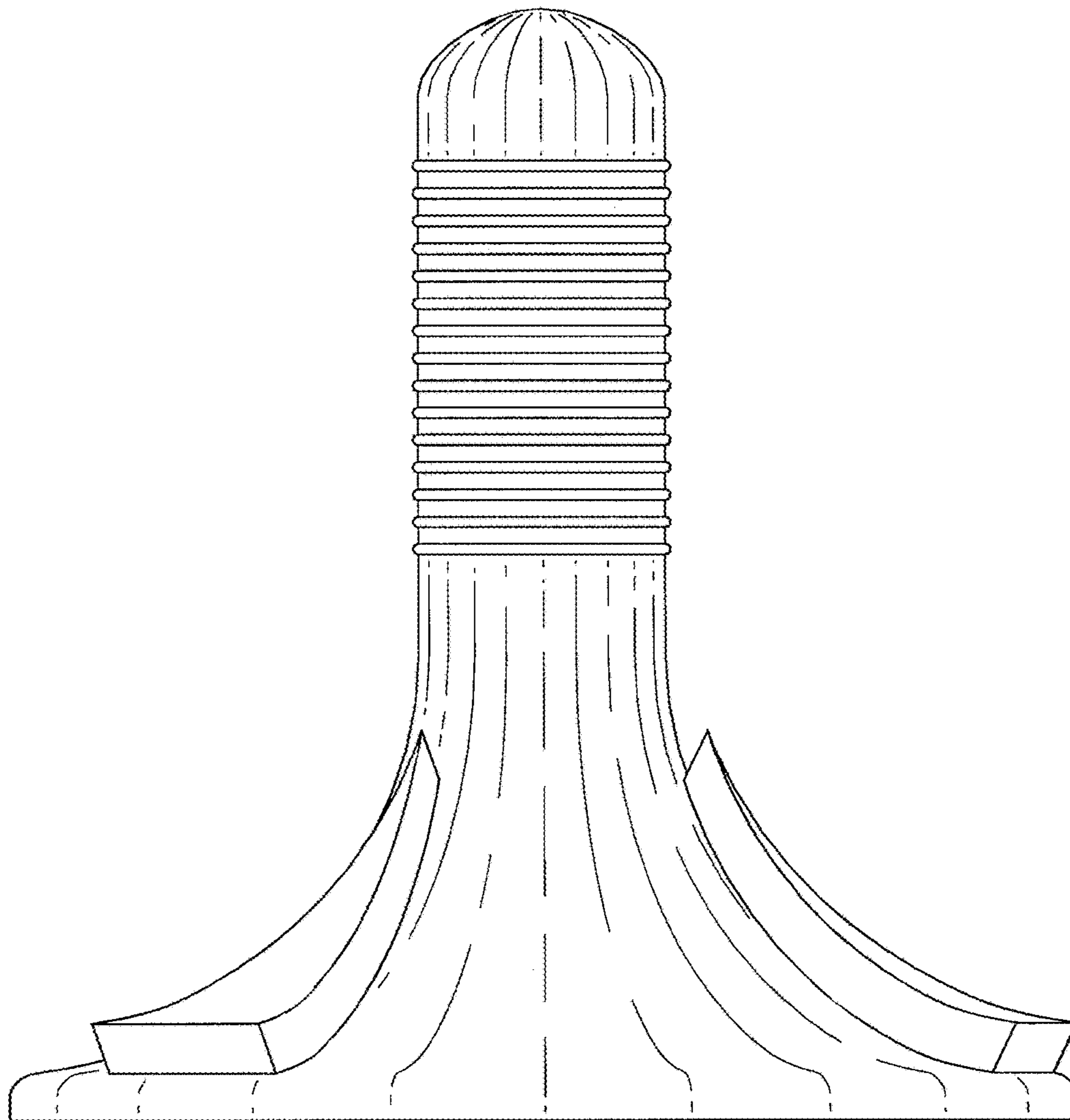

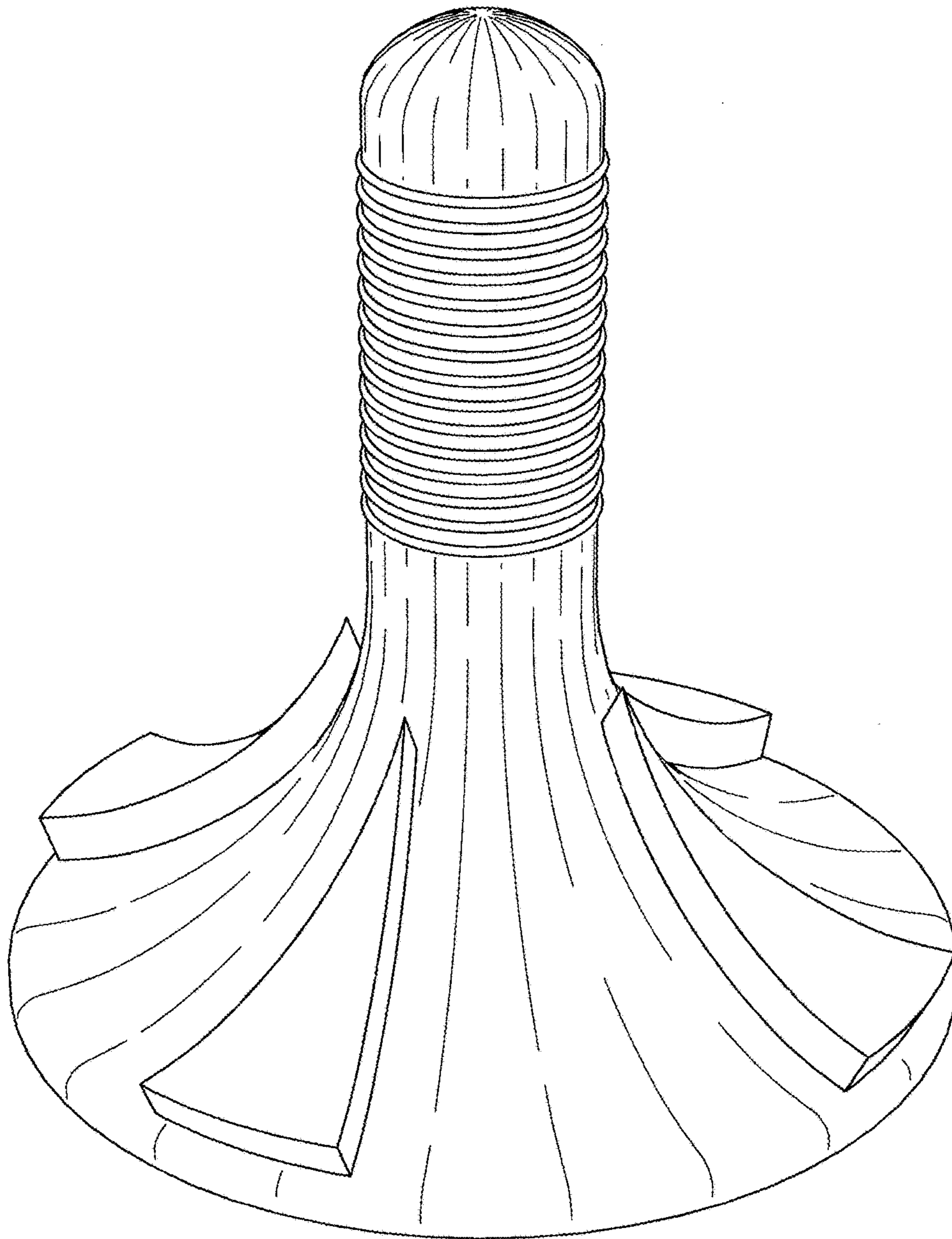

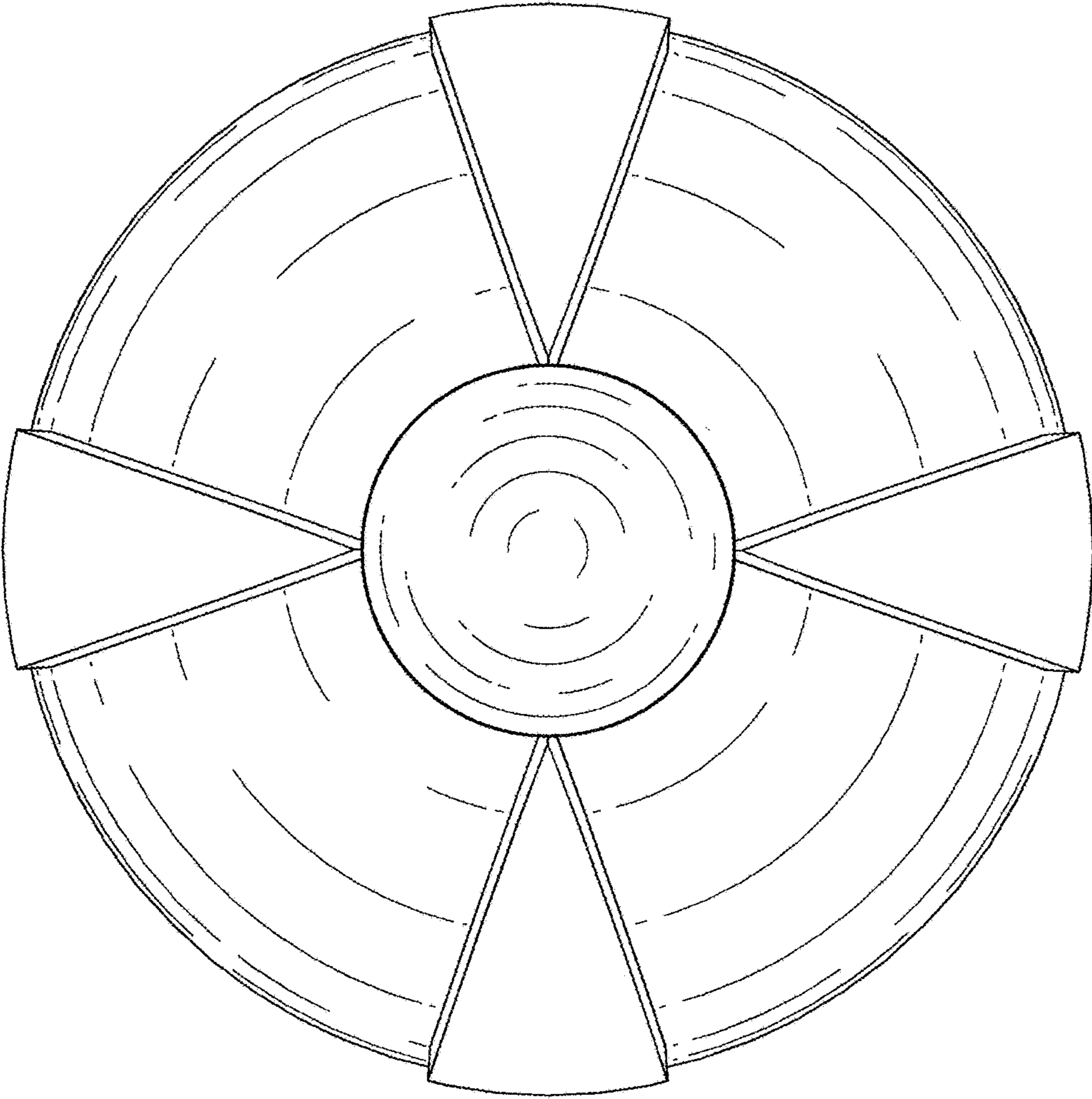

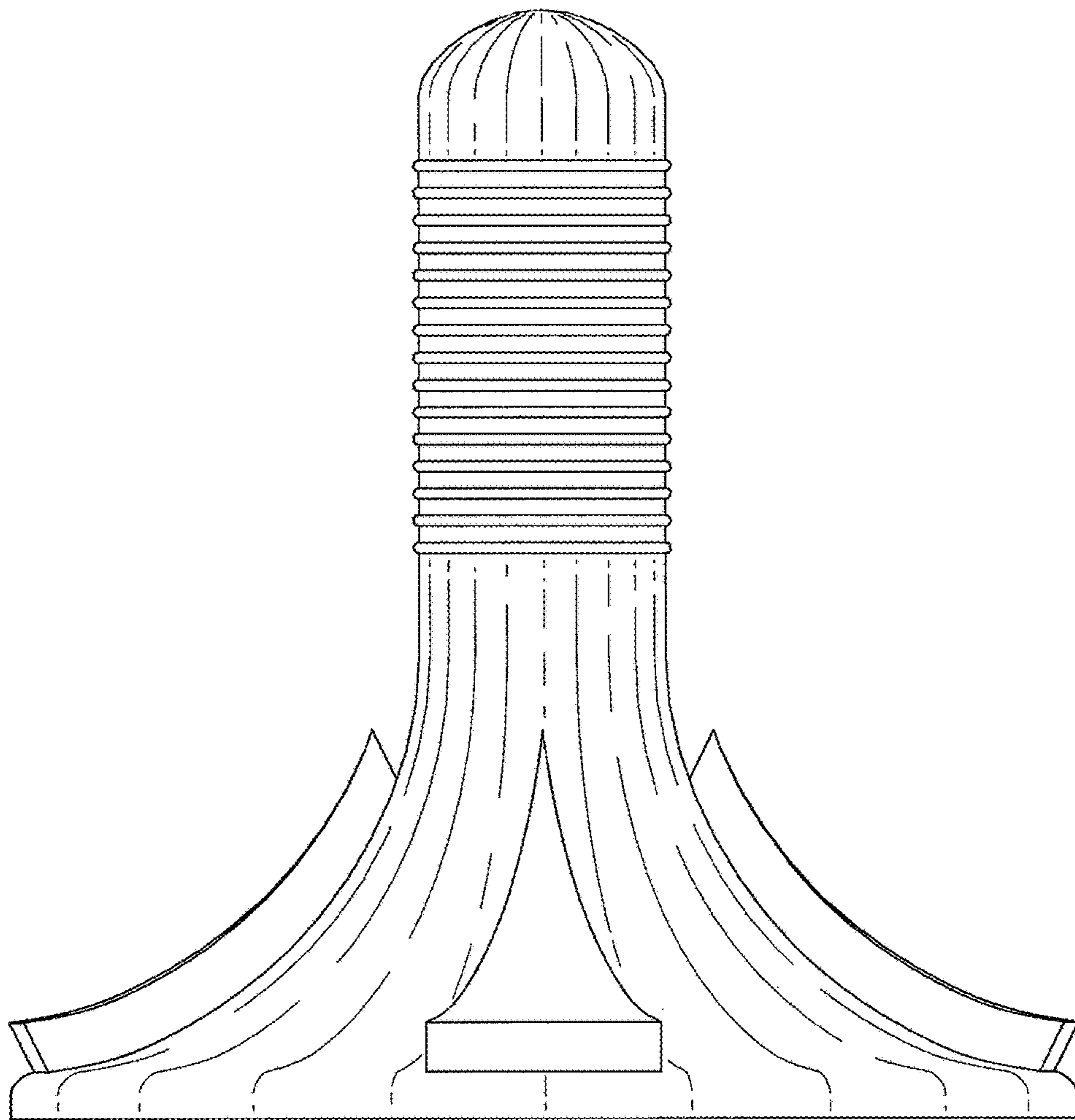

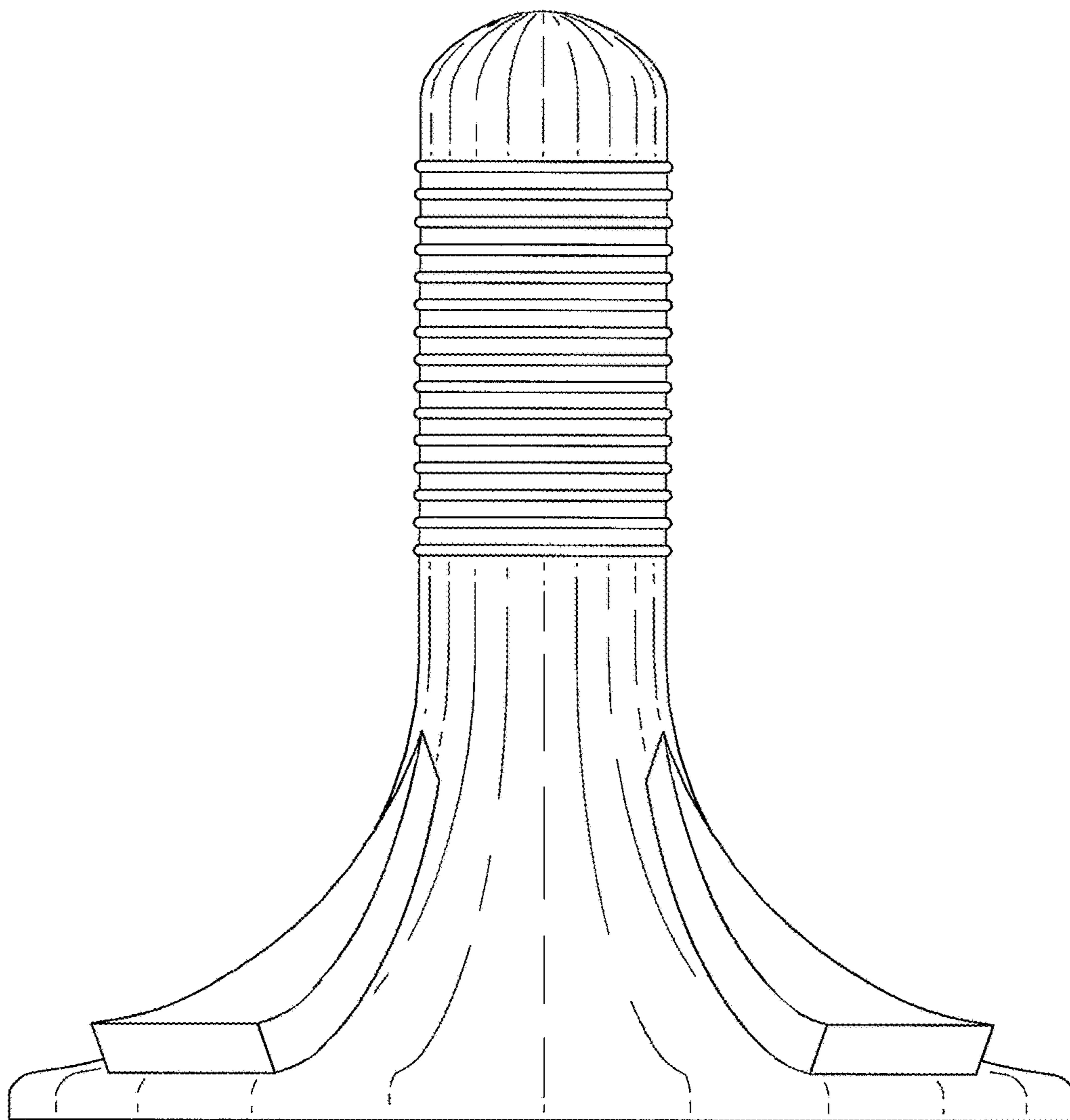

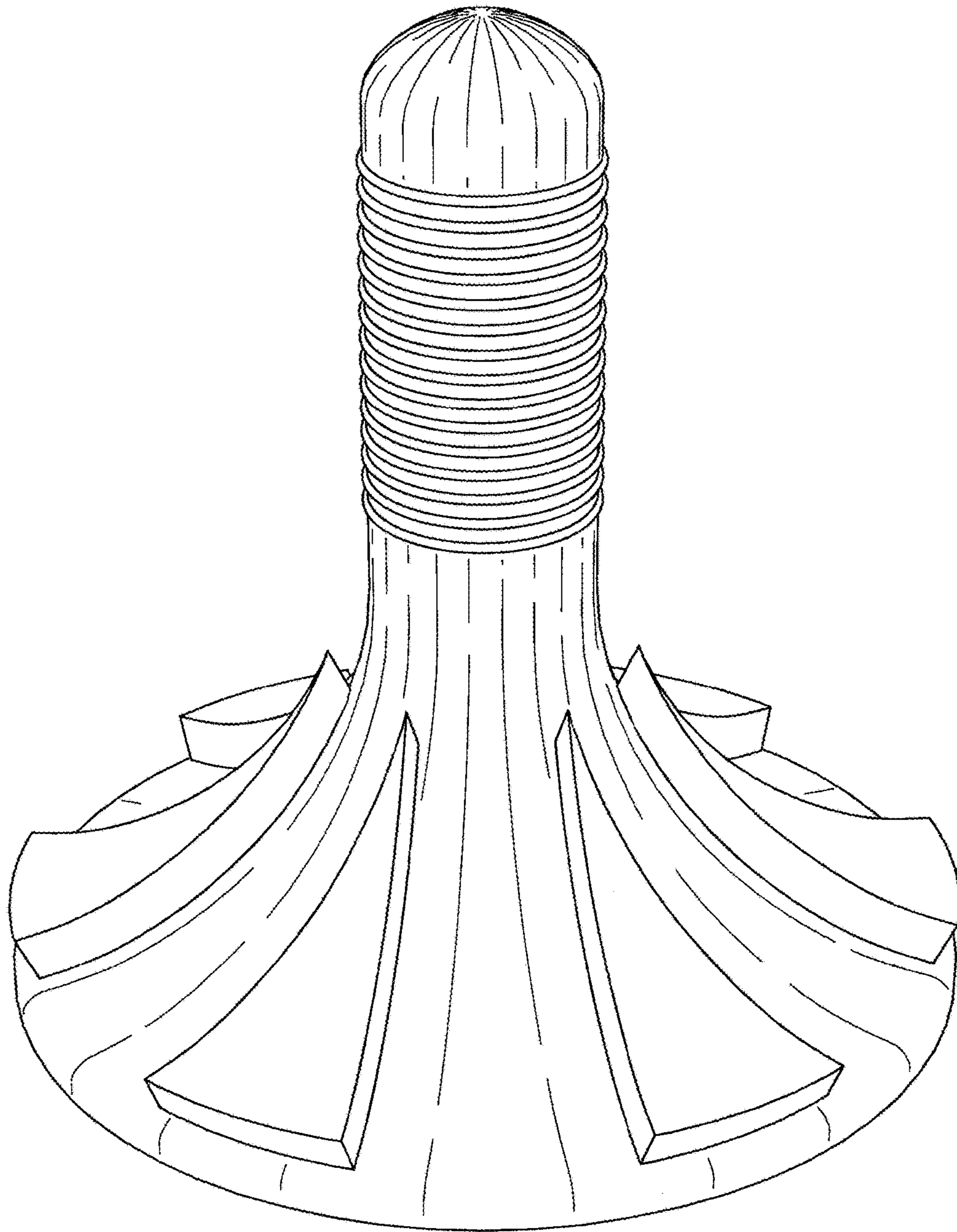

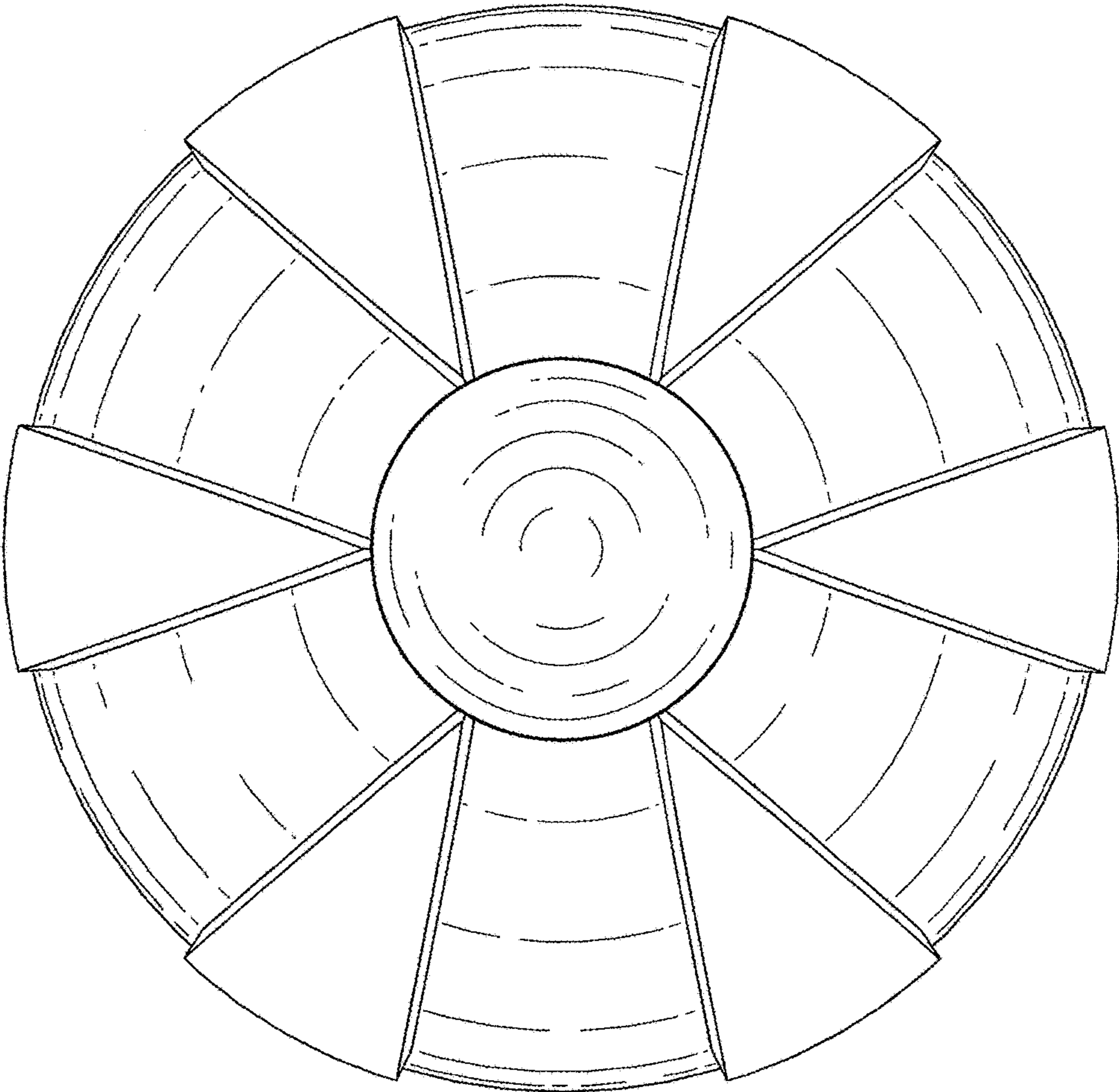

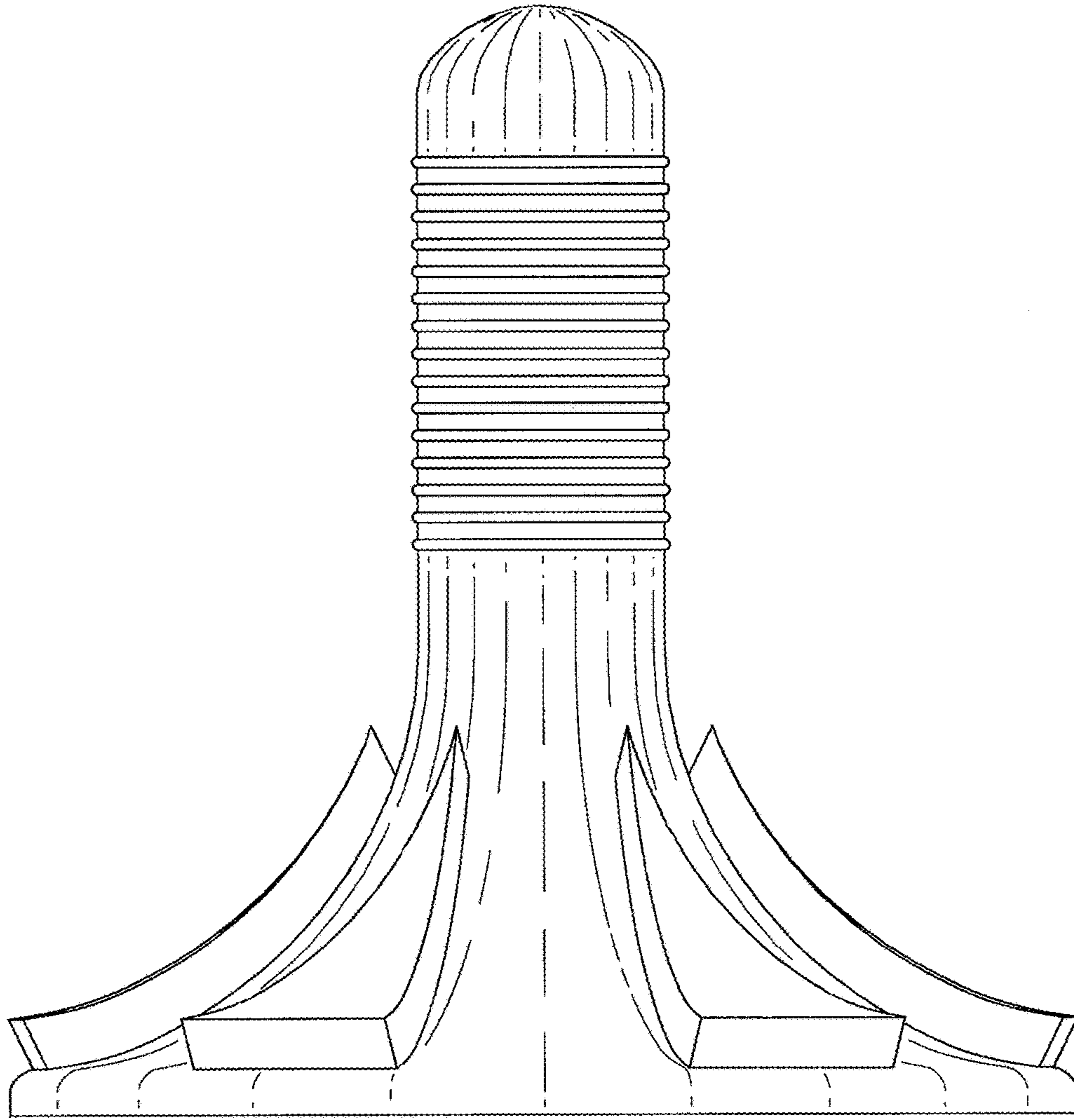

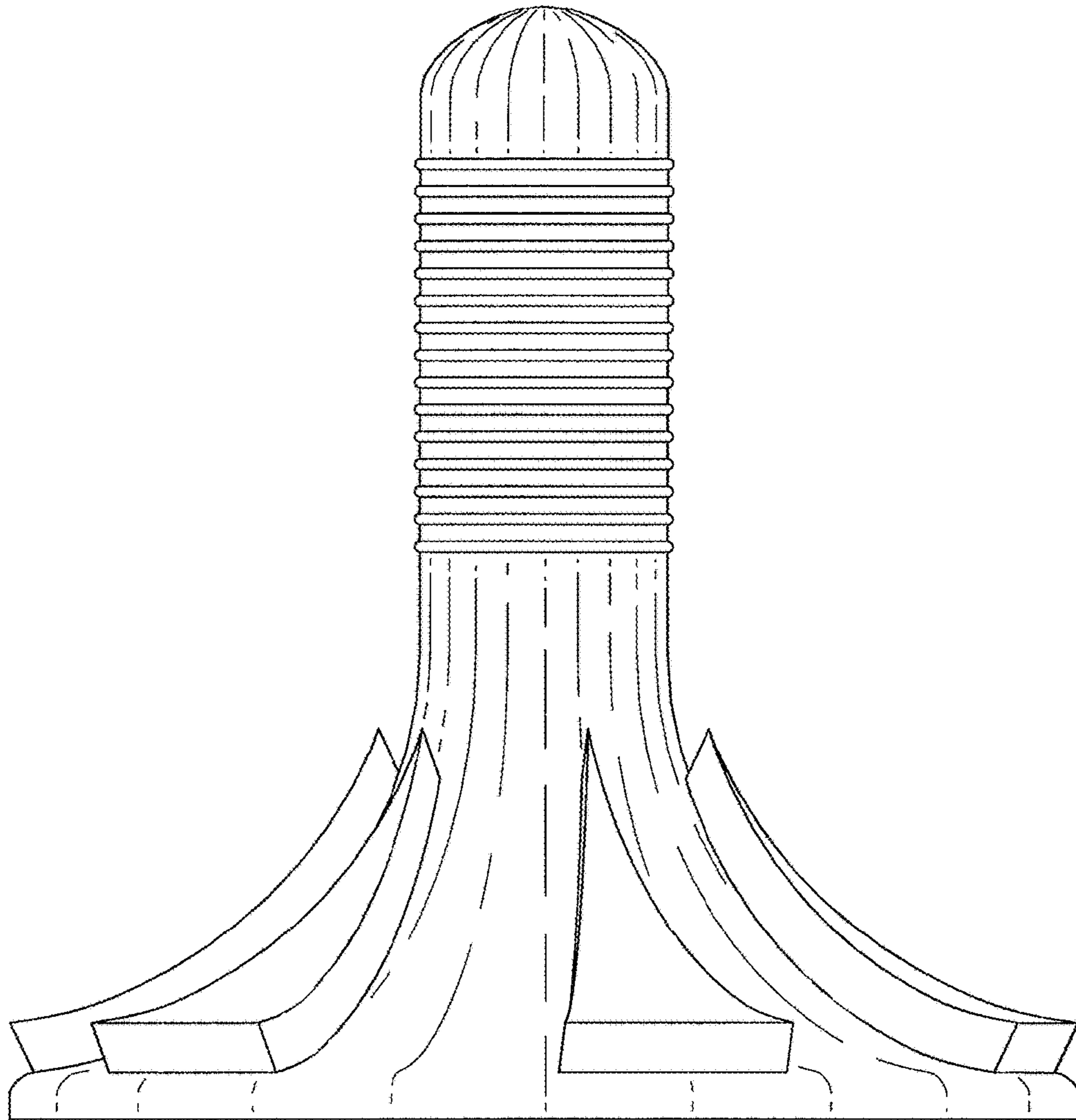

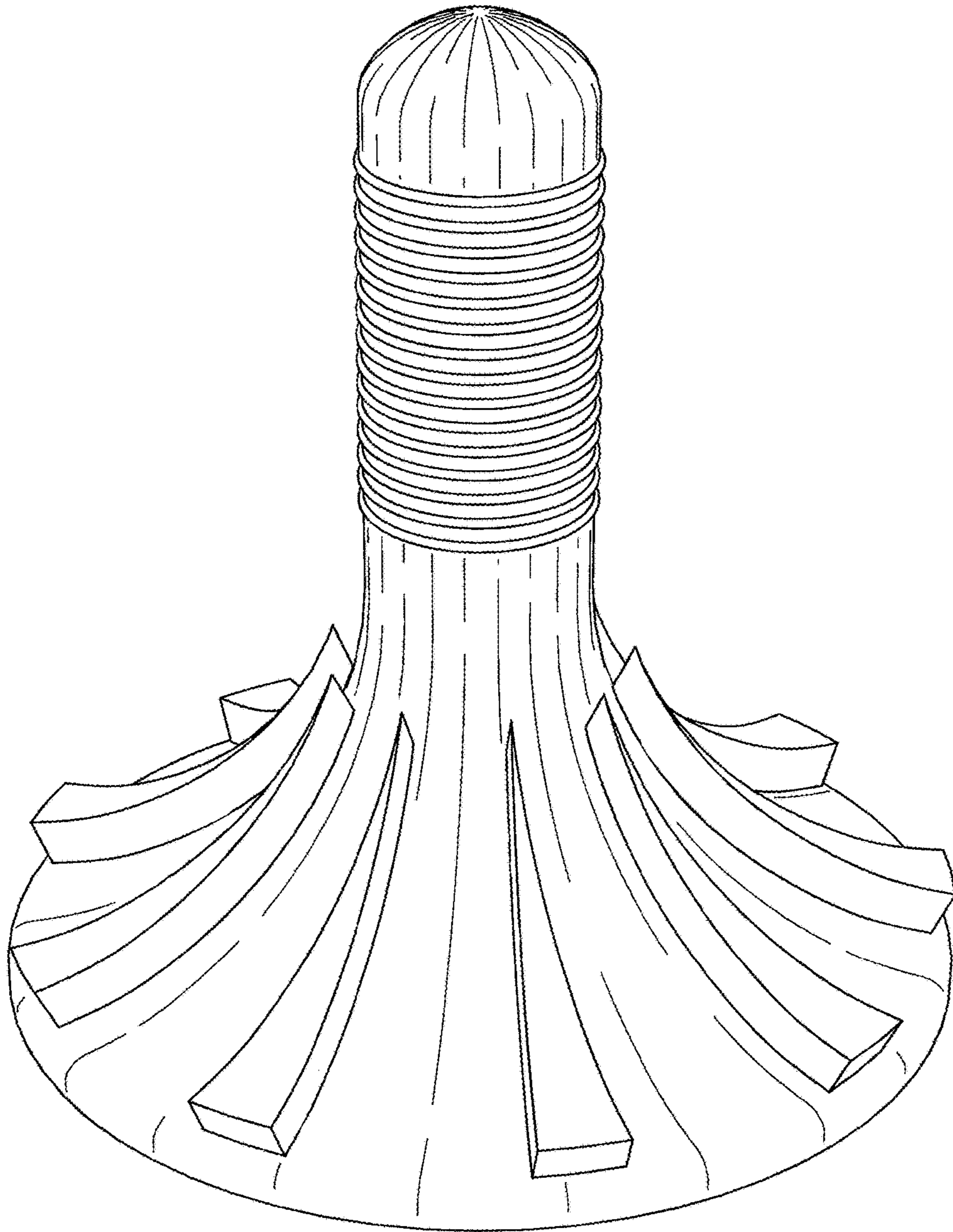

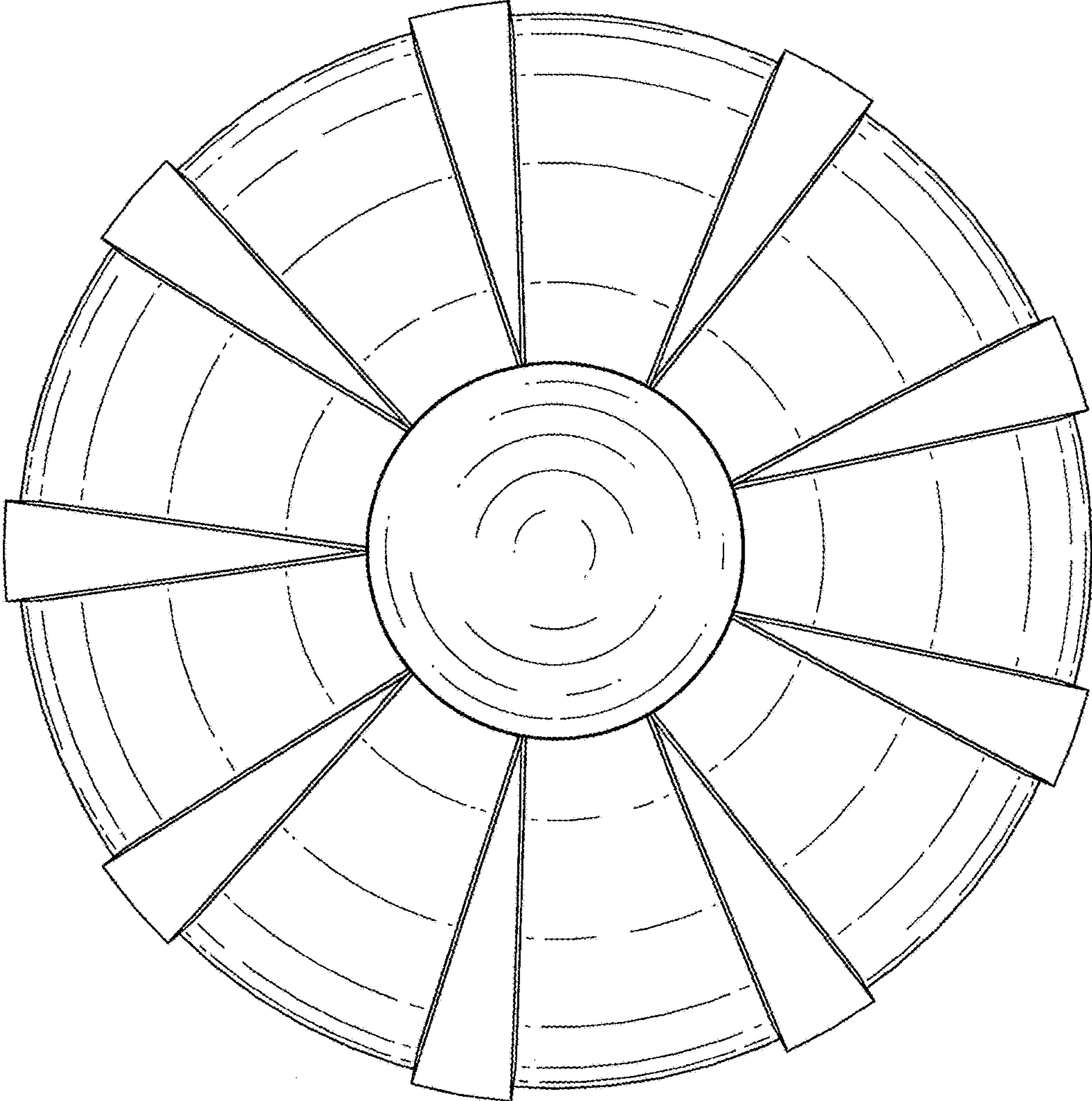

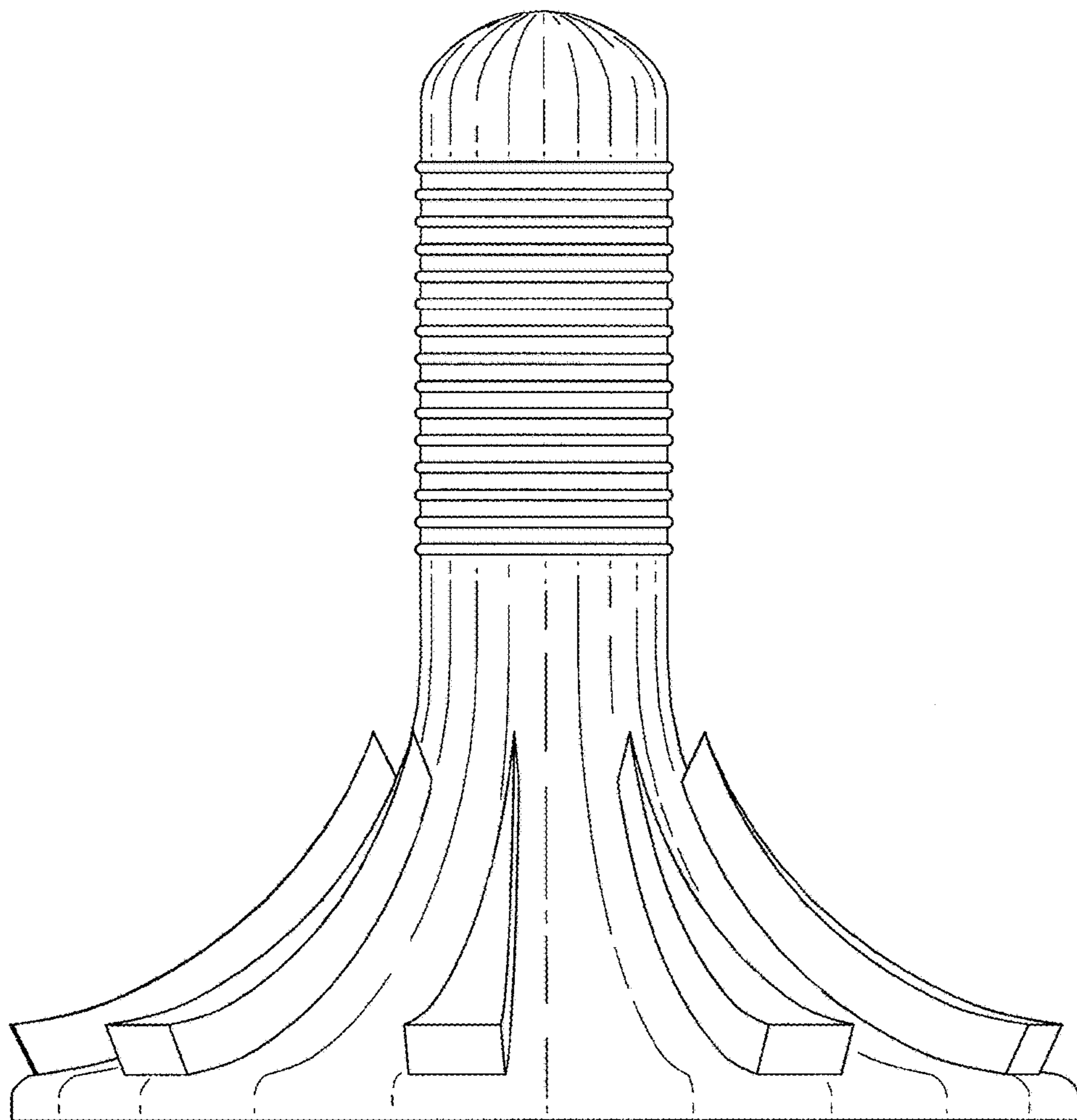

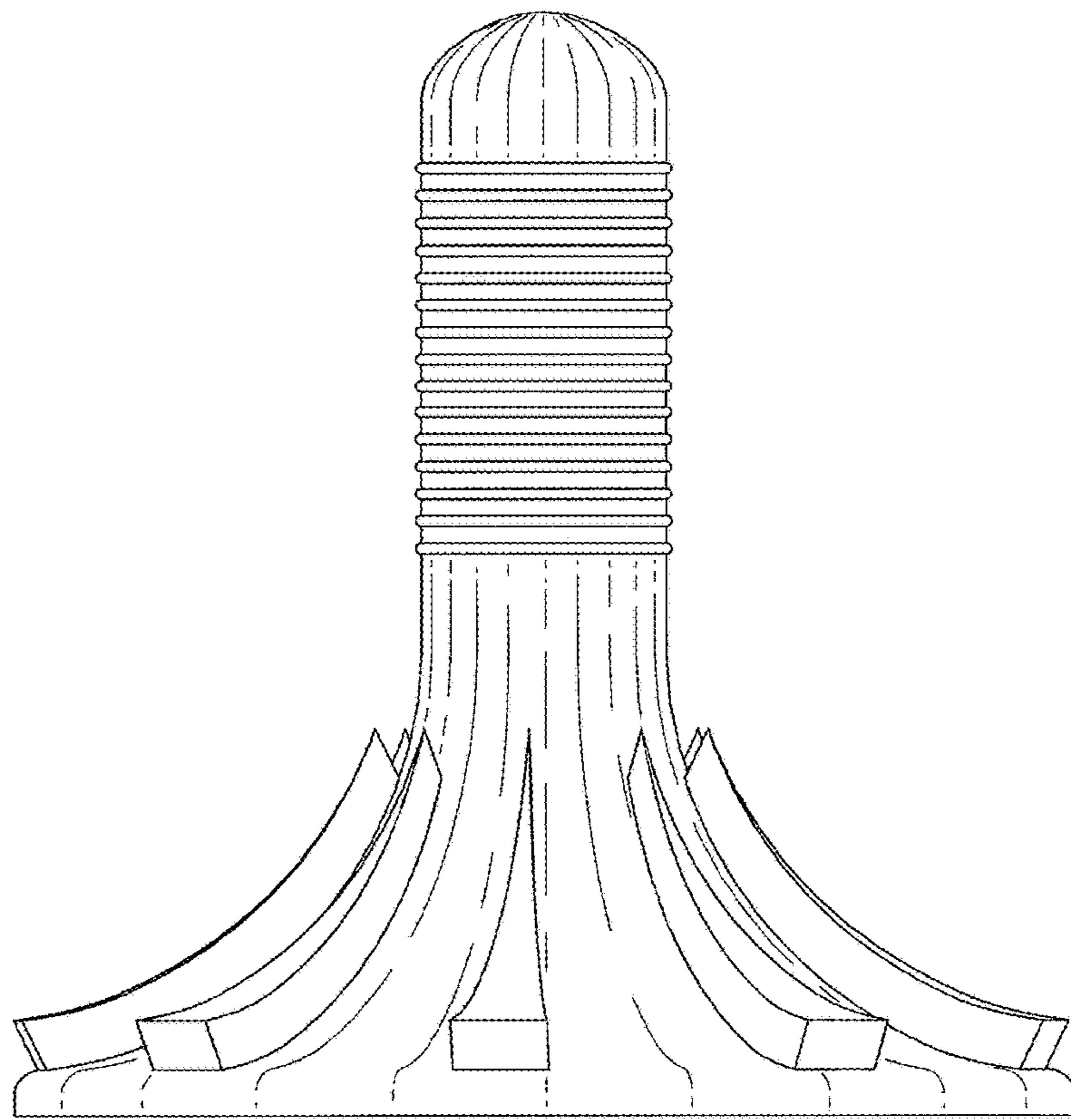
