(57) **CLAIM**

The ornamental design for a sealing ring for a pipe coupling, as shown.

**DESCRIPTION**

FIG. 1 is a front perspective view of a sealing for a pipe coupling showing my new design;  
FIG. 2 is a side view of the sealing ring;  
FIG. 3 is a top plan view of the sealing ring;  
FIG. 4 is a side view of the sealing ring; and,  
FIG. 5 is a cross-sectional view of the sealing ring taken along lines 5-5 from FIG. 3.

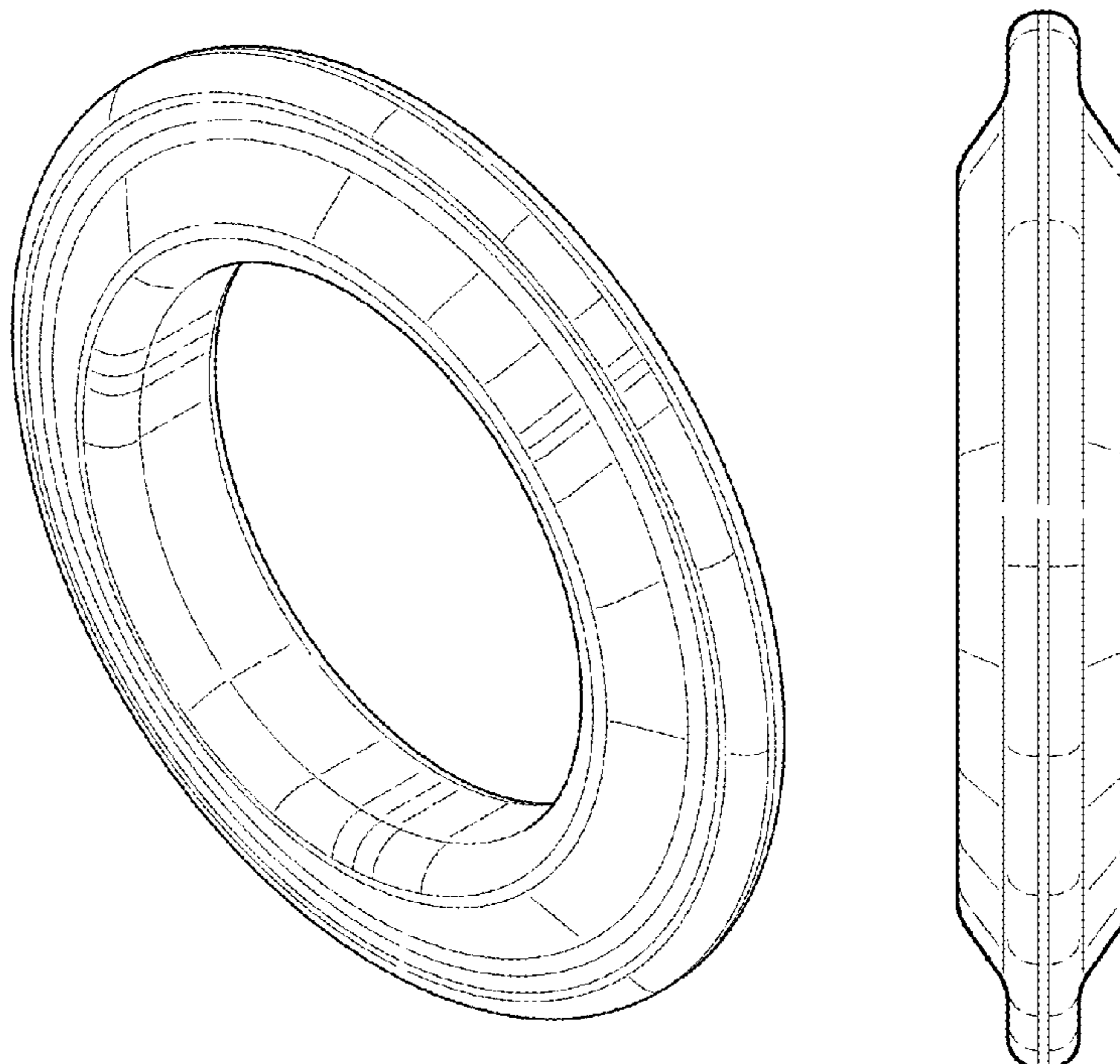

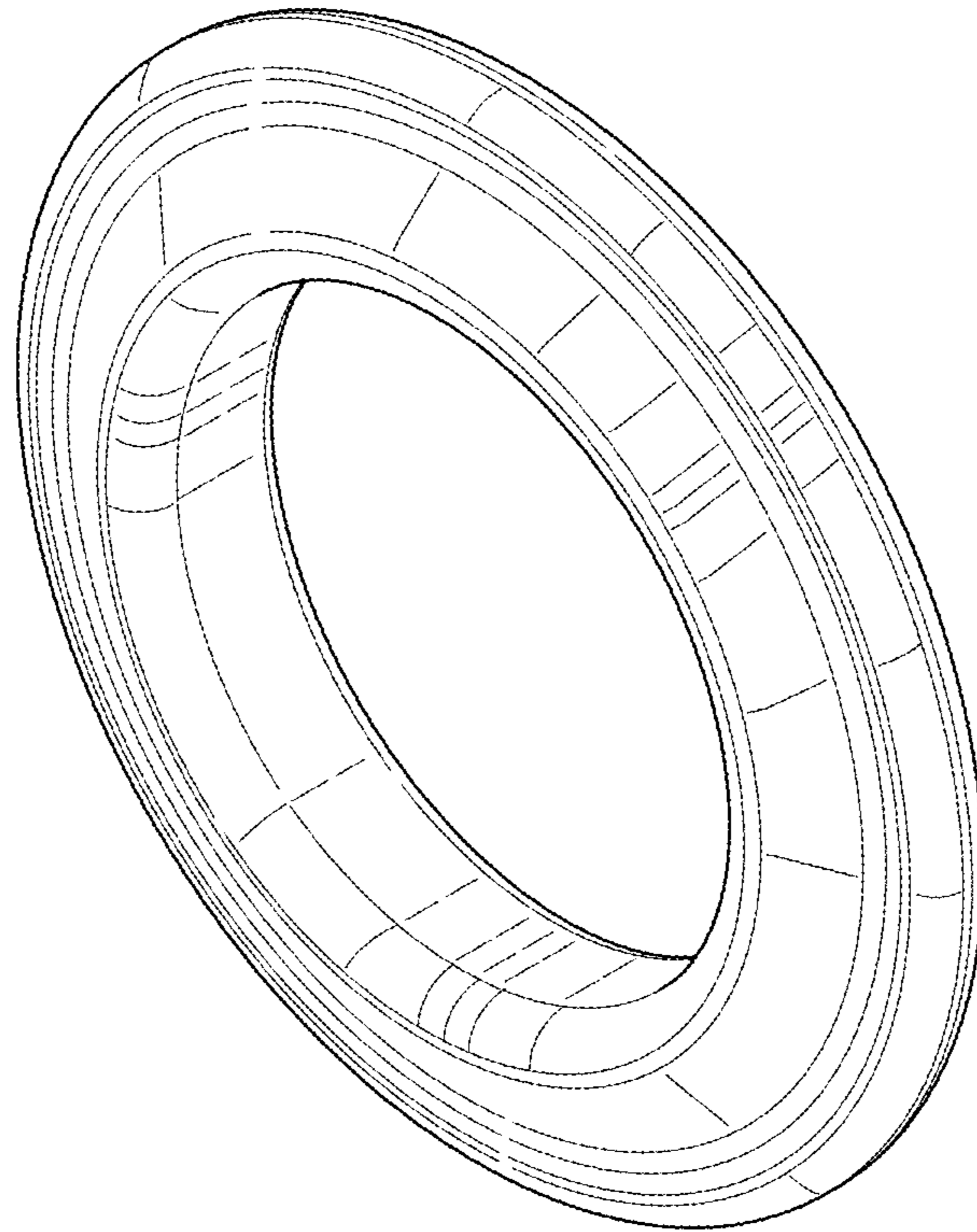

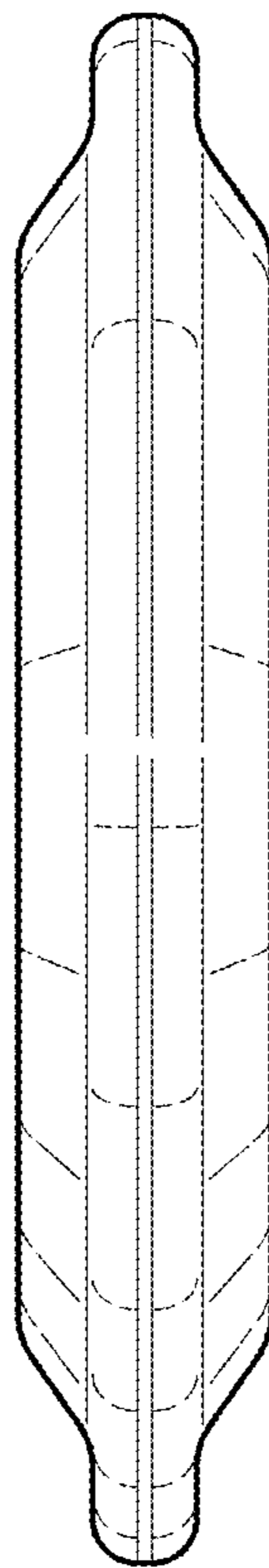

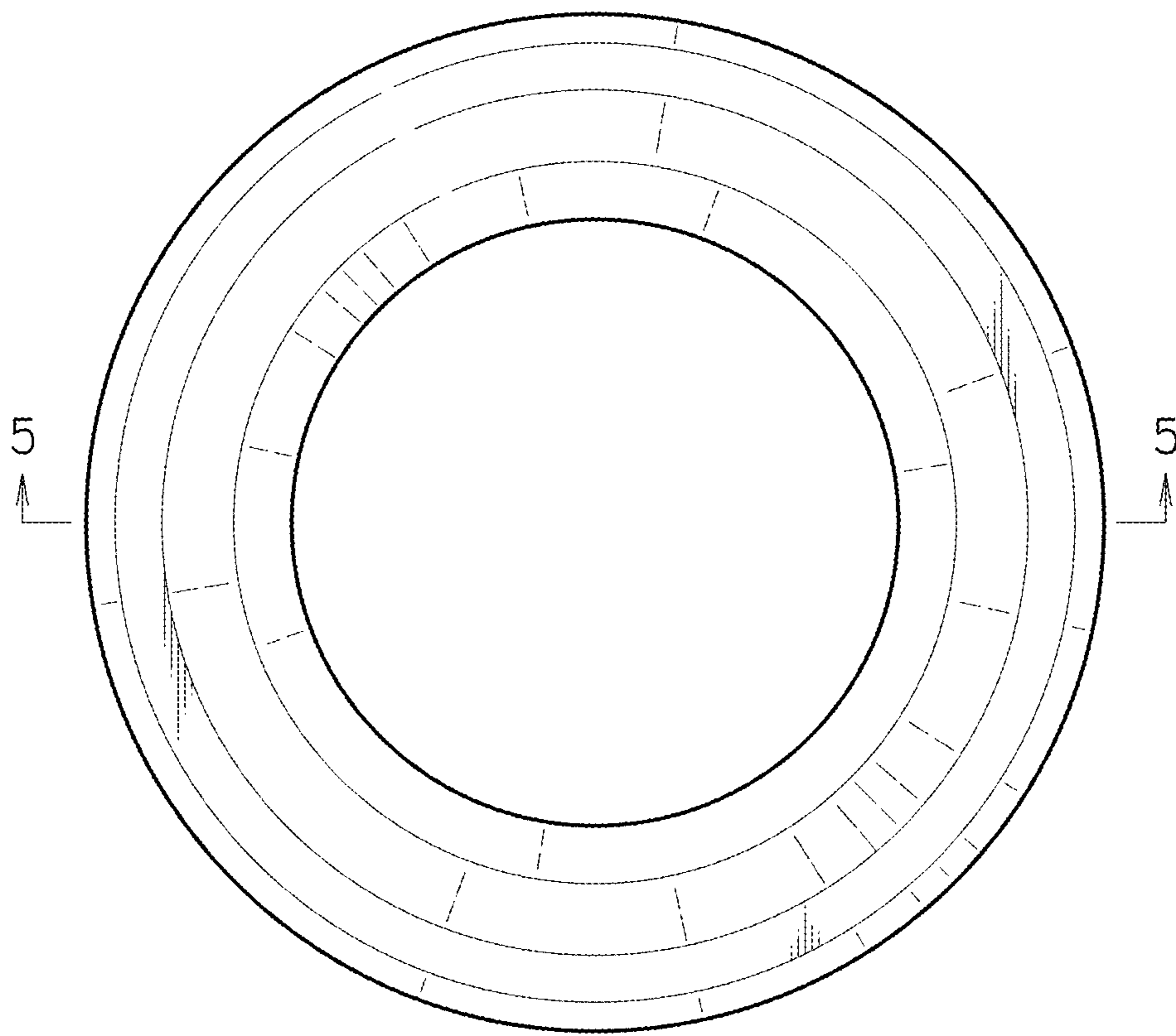

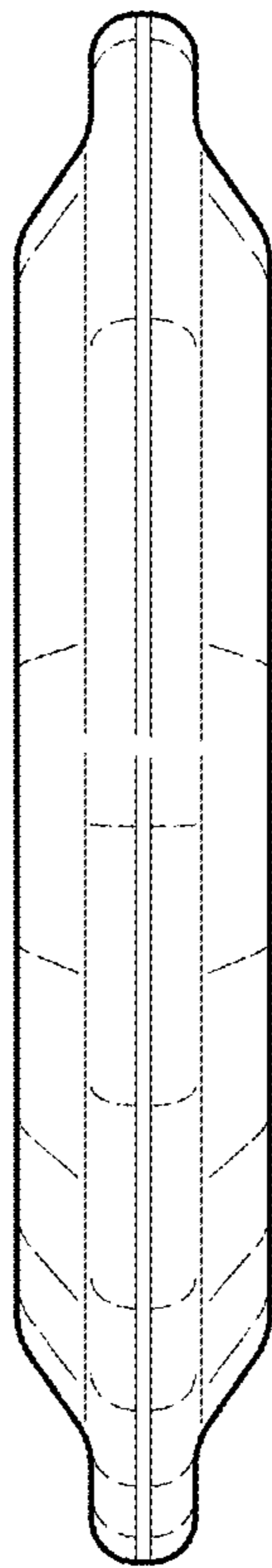
