(57) **CLAIM**

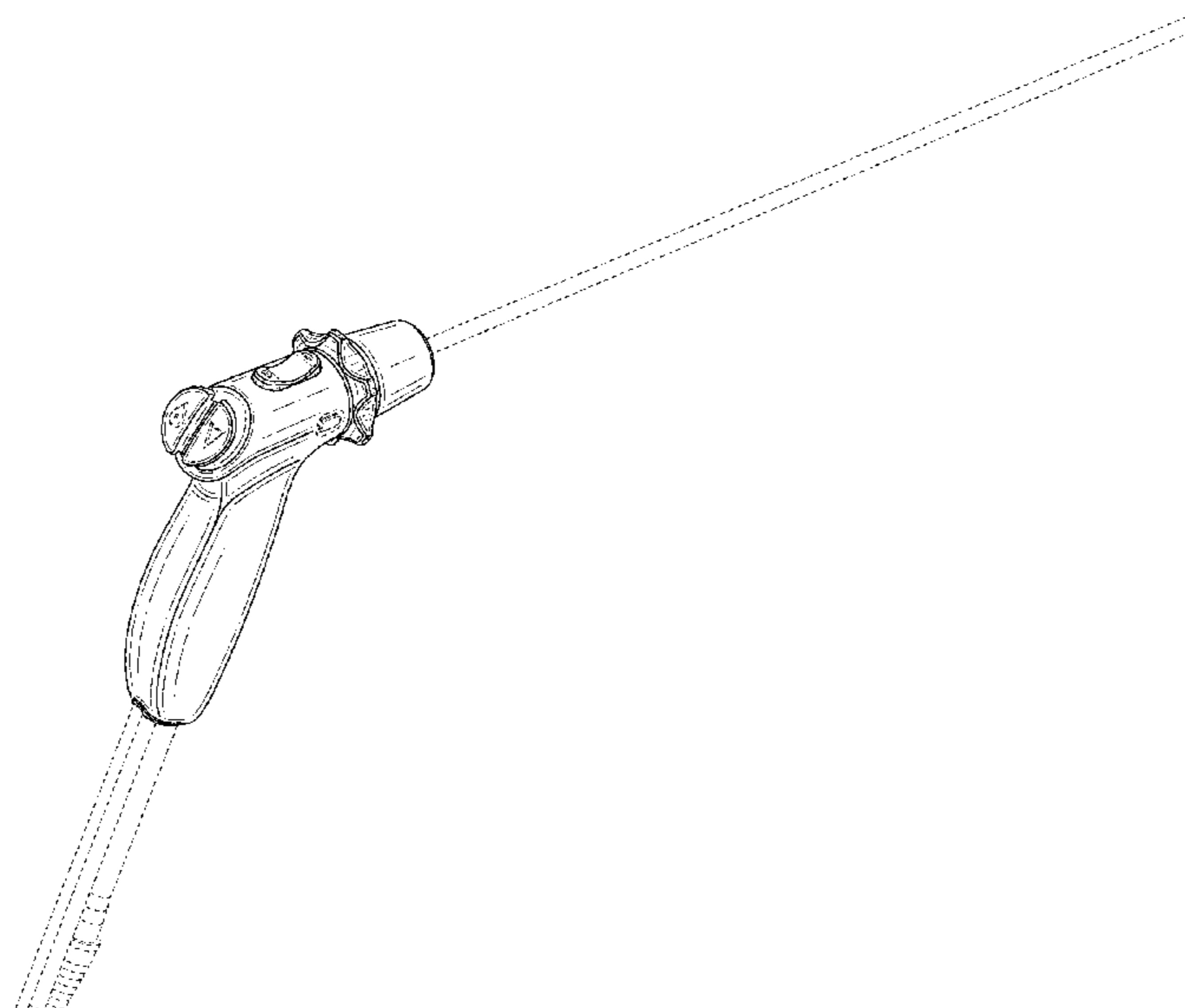
The ornamental design for a handle for laparoscopic surgery instruments, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle for laparoscopic surgery instruments;

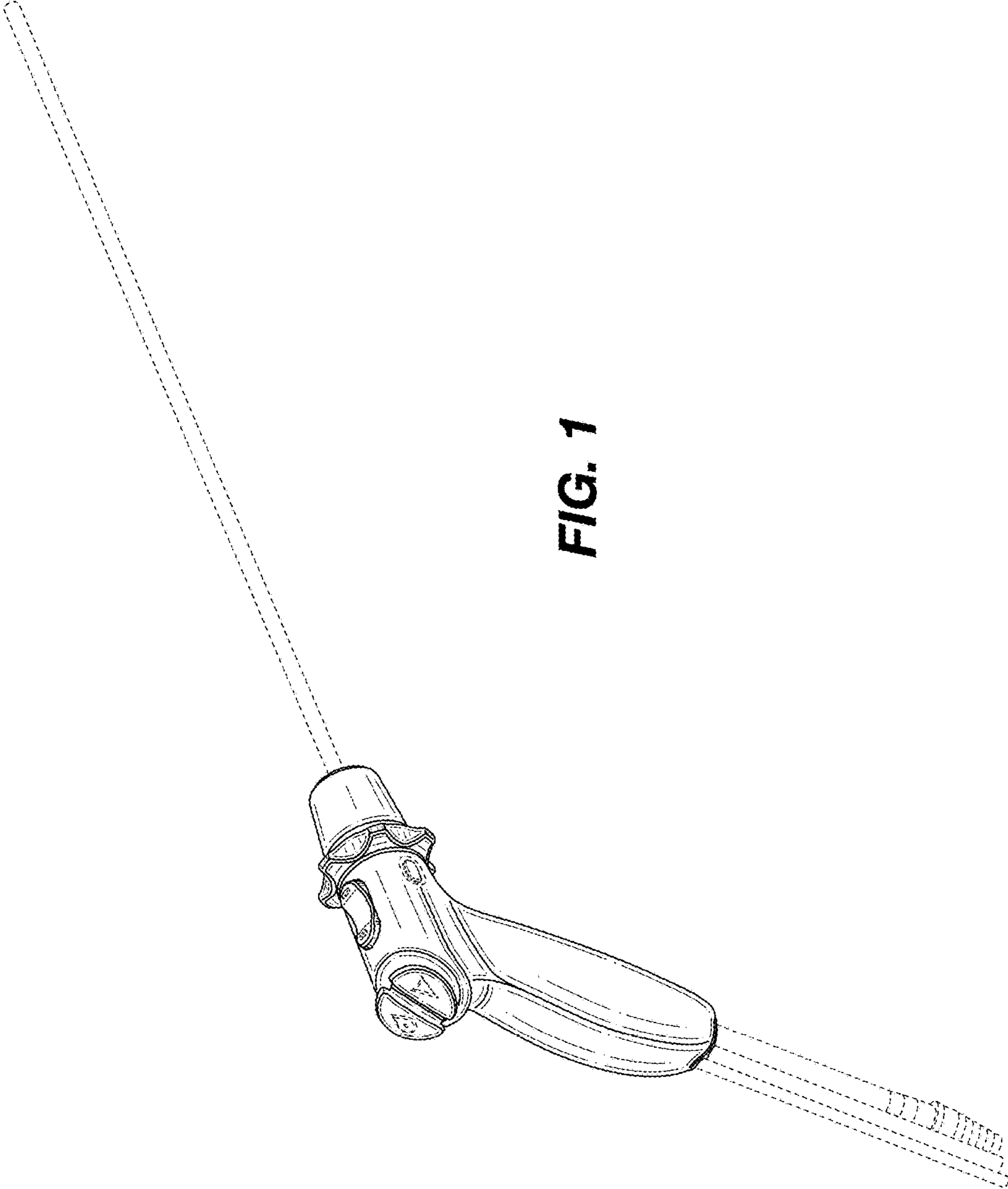

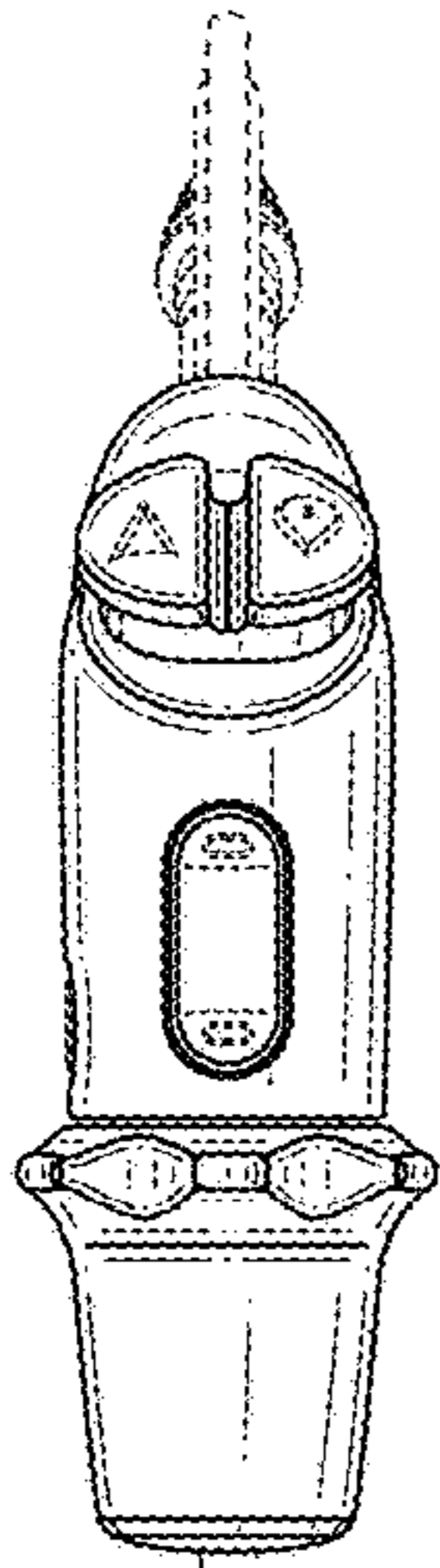

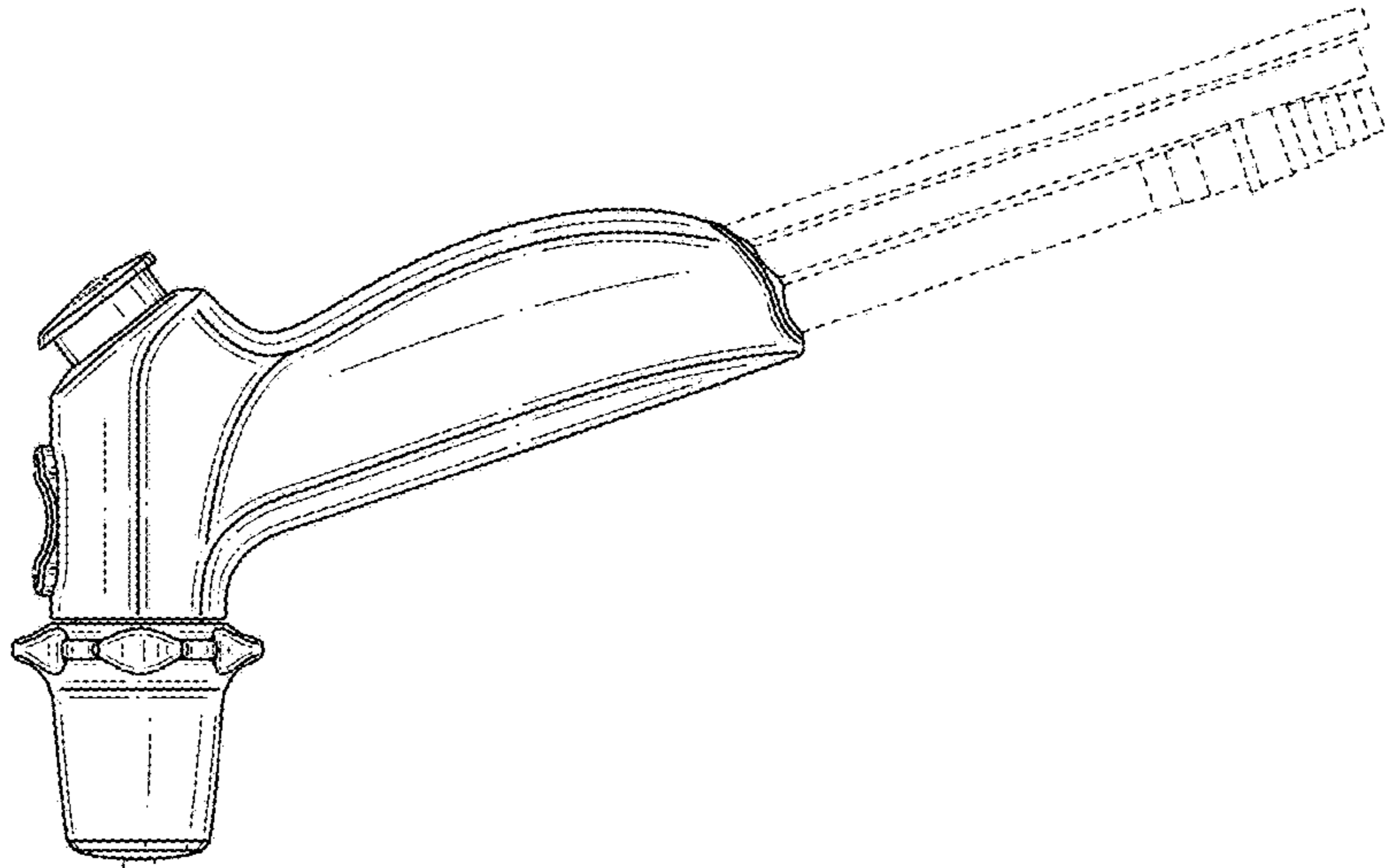

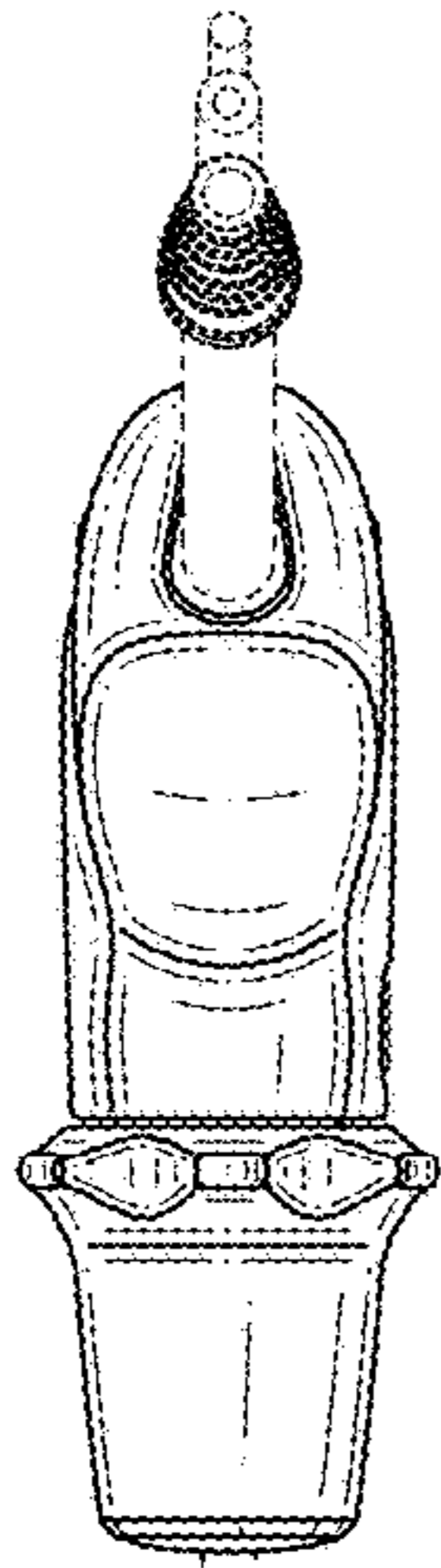

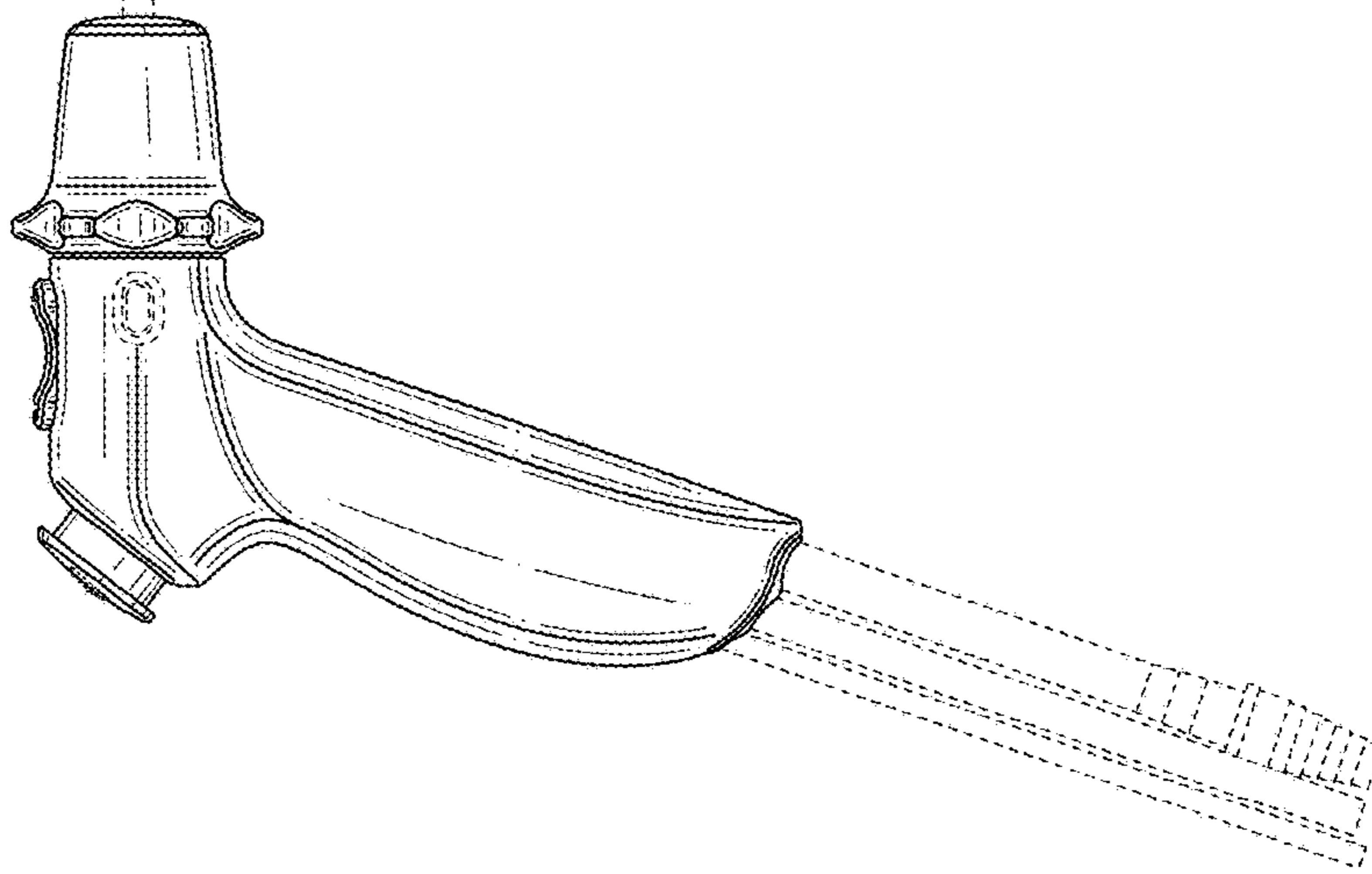

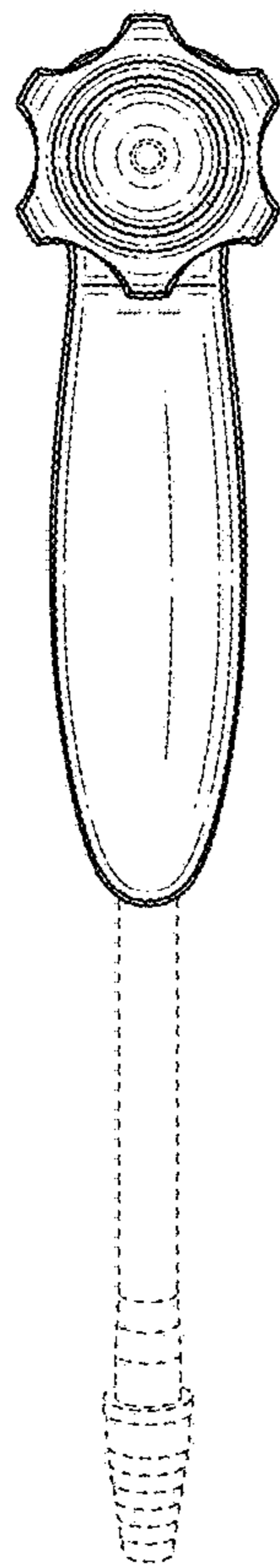

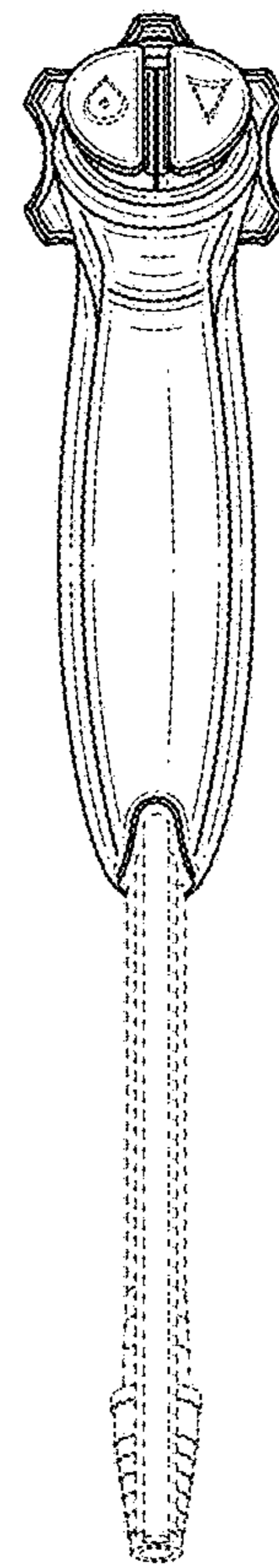
