**DESCRIPTION**

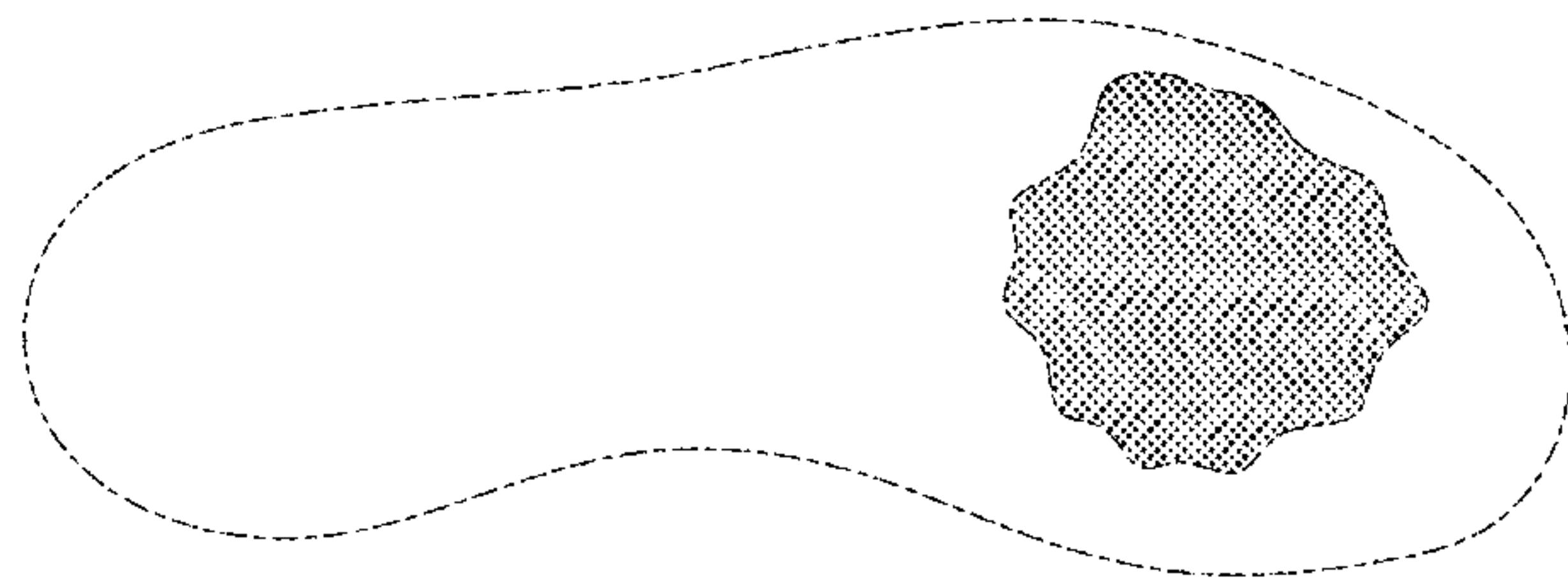
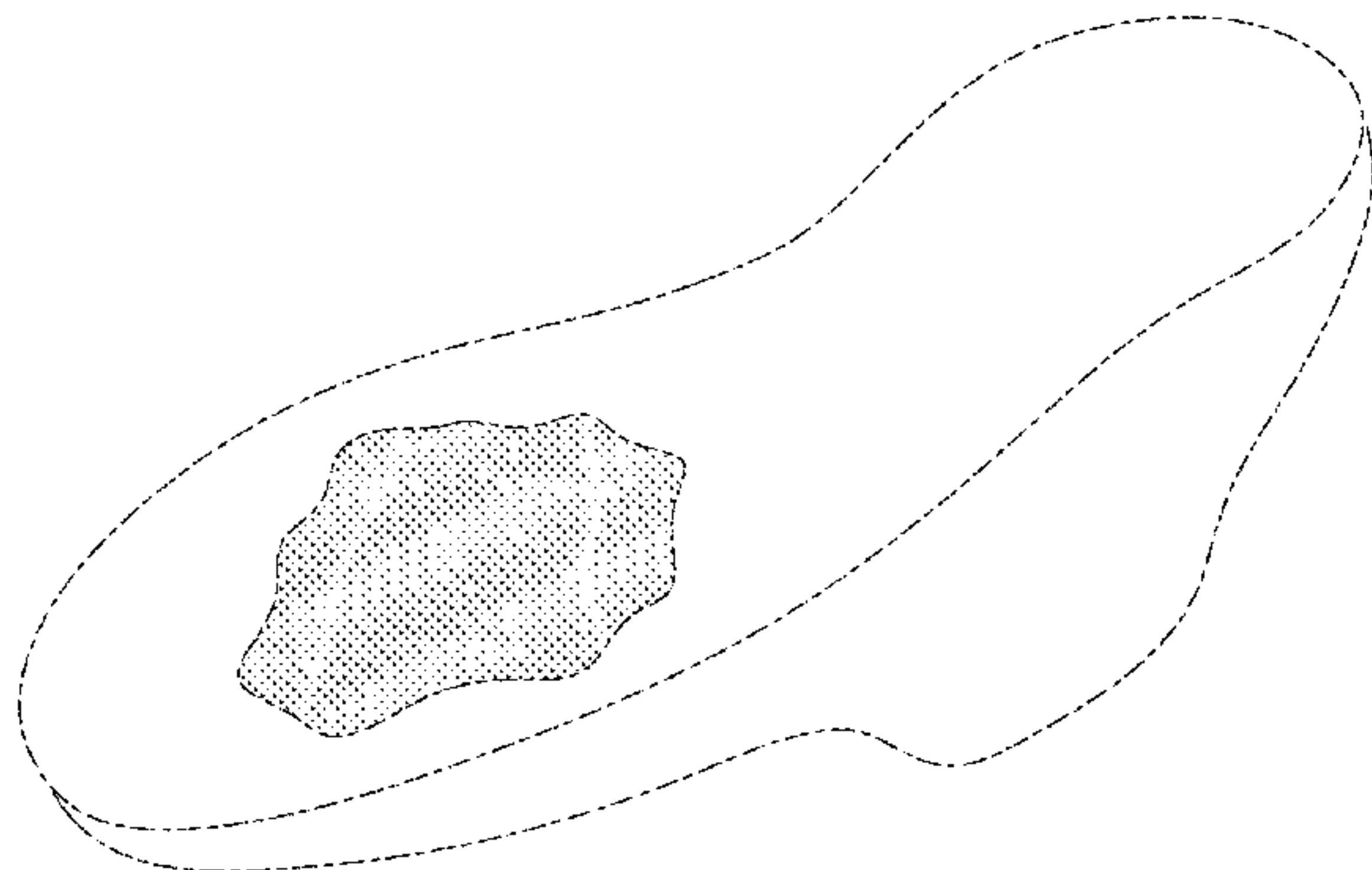
FIG. 1 is a photographic front perspective view of a shoe outsole showing my new design;

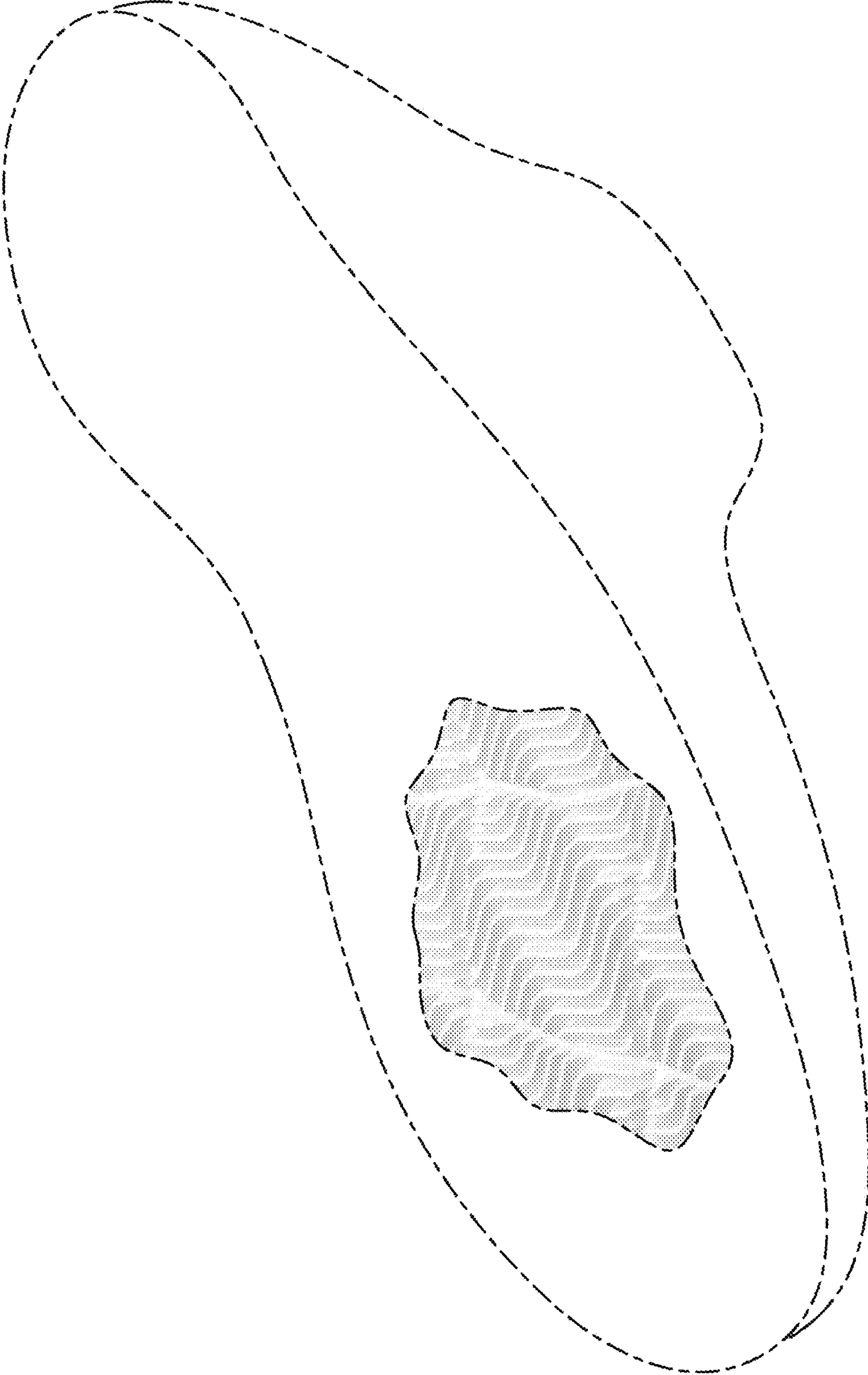

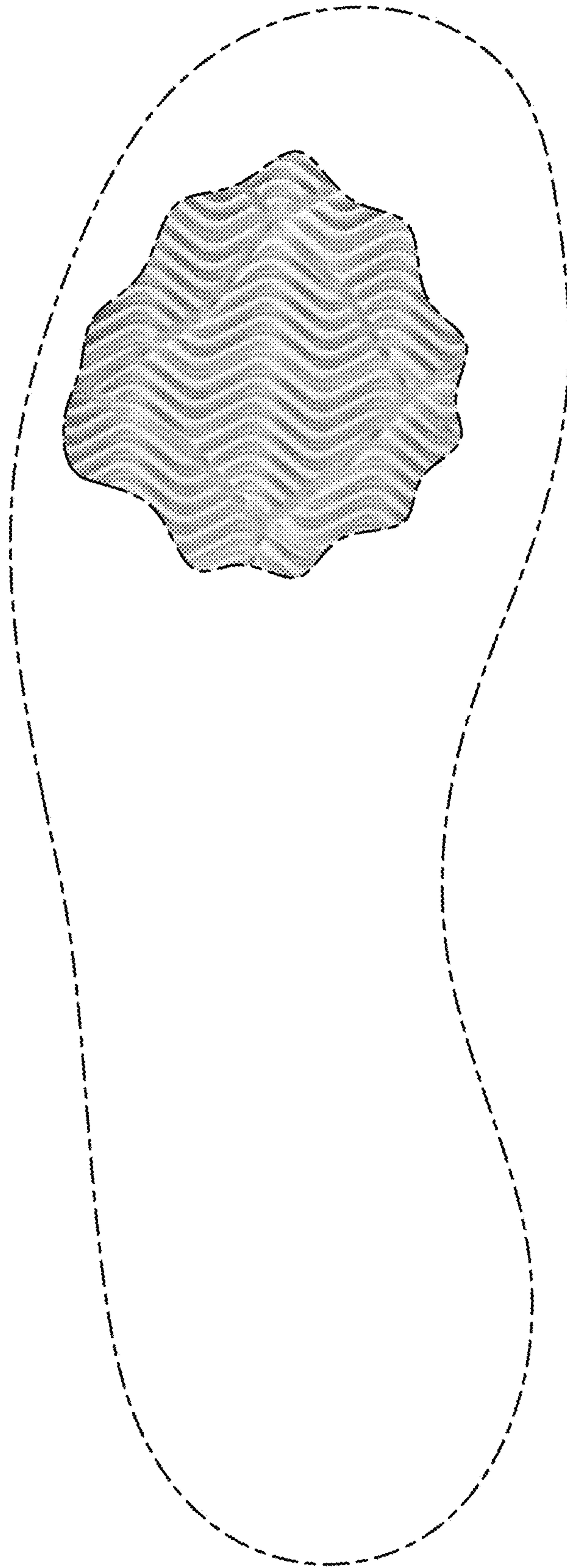

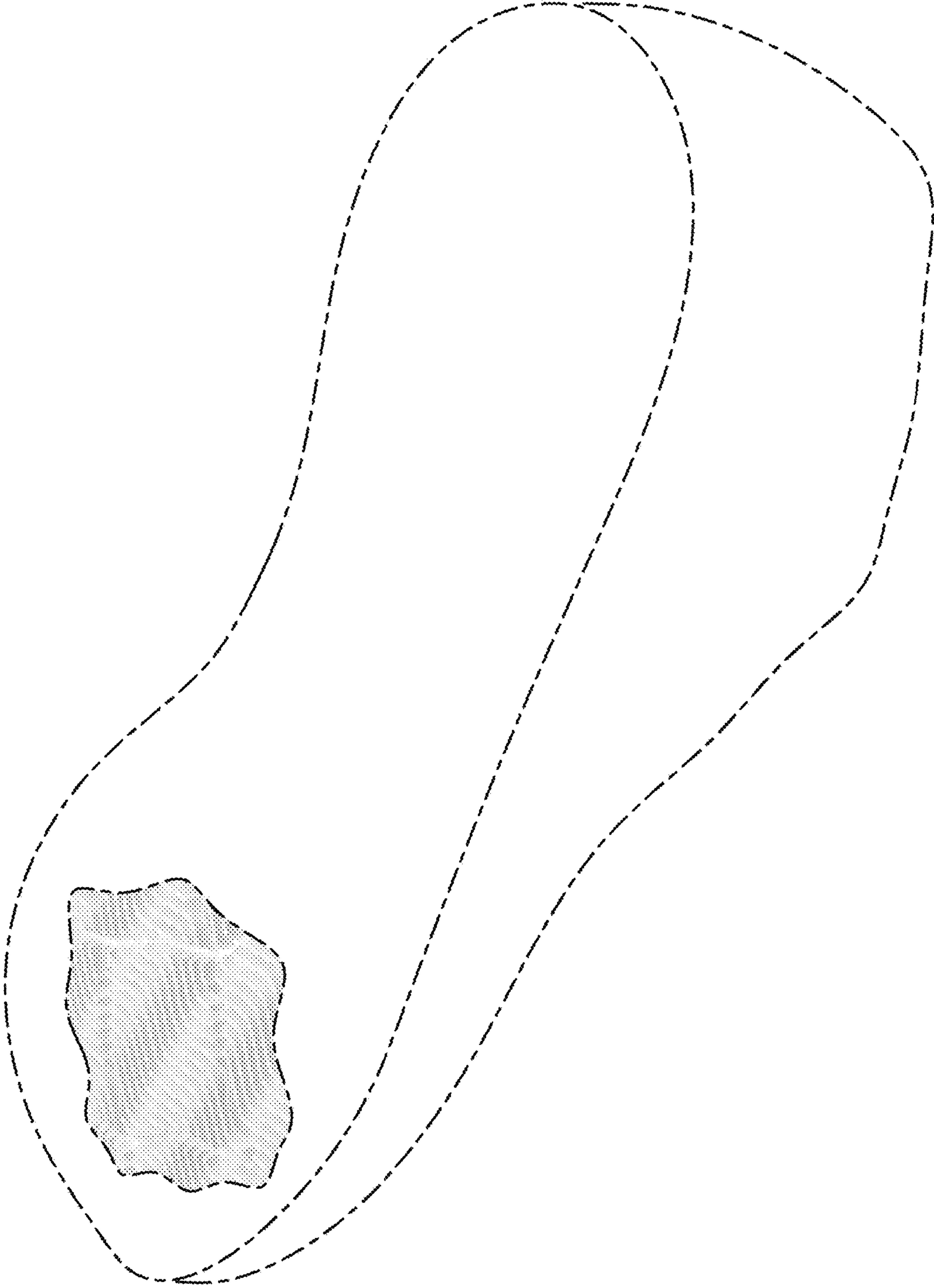
