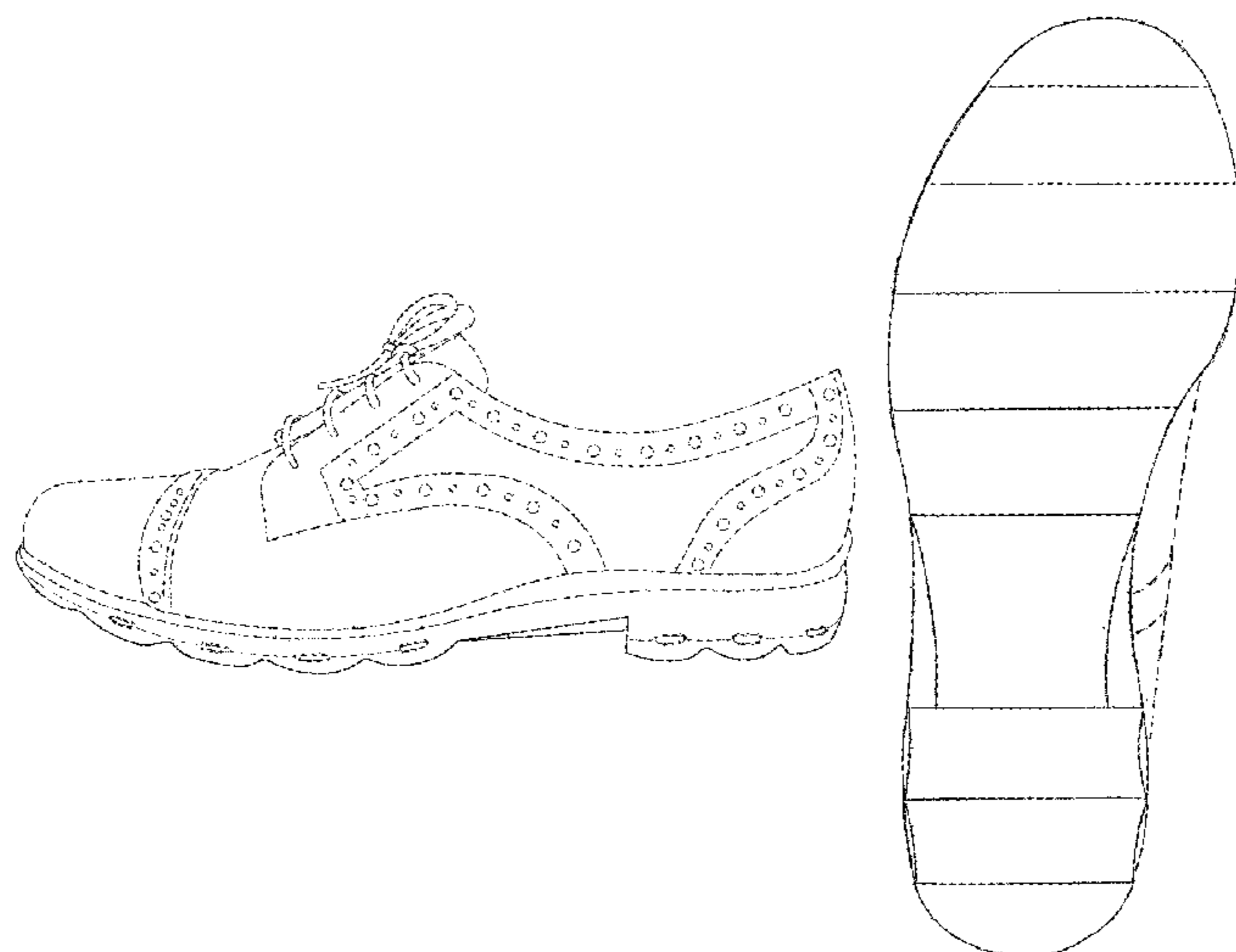
(57) **CLAIM**

The ornamental design for a sole for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevation of a sole for footwear; FIG. 2 is a right side elevation of the sole of FIG. 1; FIG. 3 is a top plan of the sole of FIG. 1; FIG. 4 is a bottom plan of the sole of FIG. 1; FIG. 5 is a front elevation of the sole of FIG. 1; and, FIG. 6 is a rear elevation of the sole of FIG. 1. The broken lines in the drawings indicate environmental structures that form no part of the claimed design.

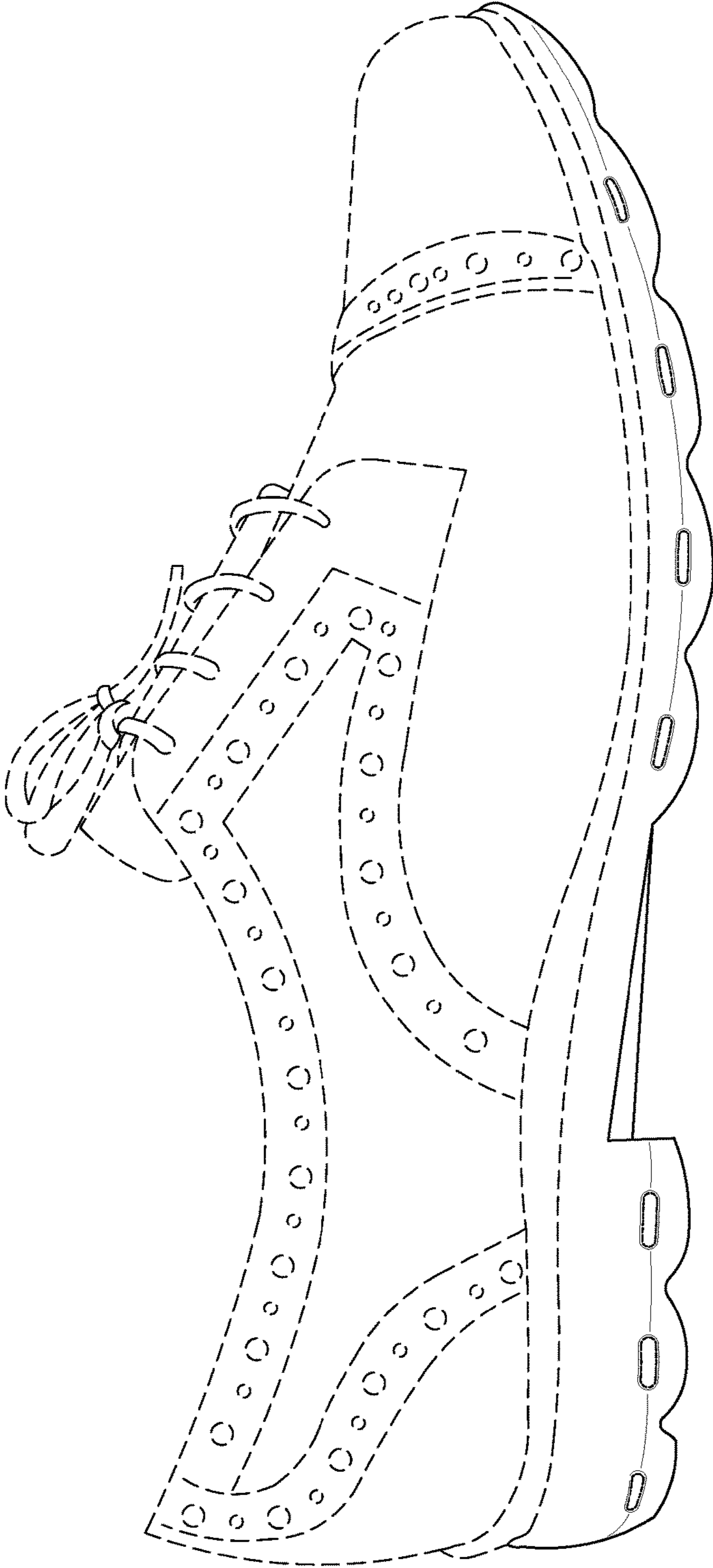

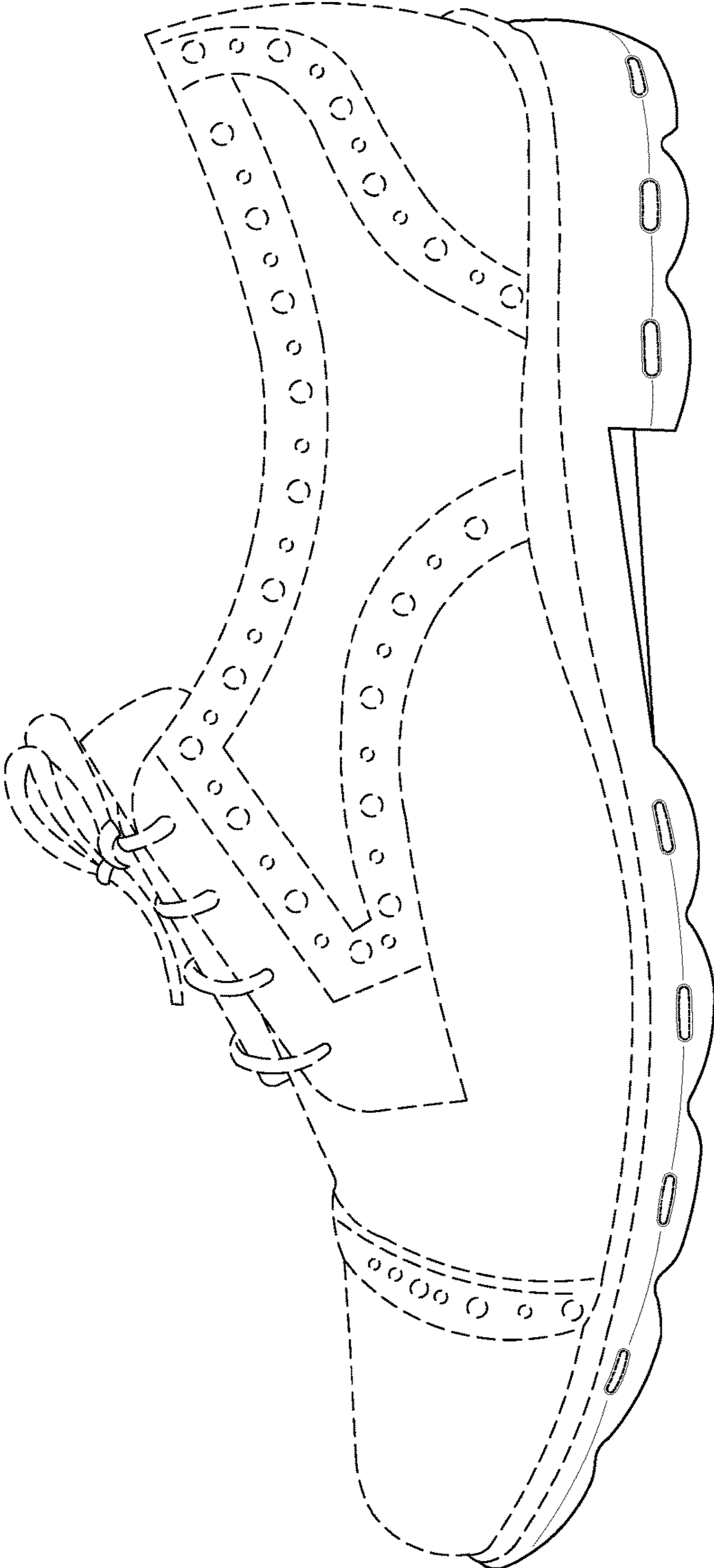

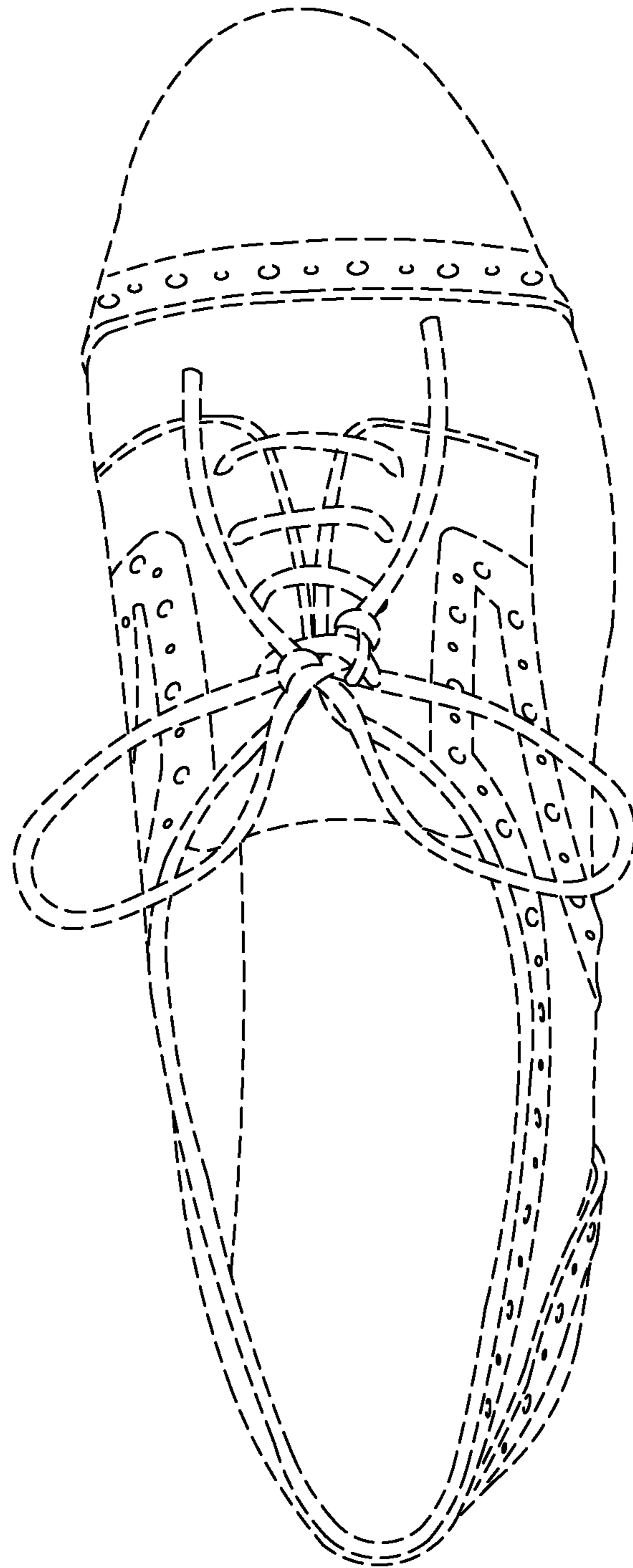

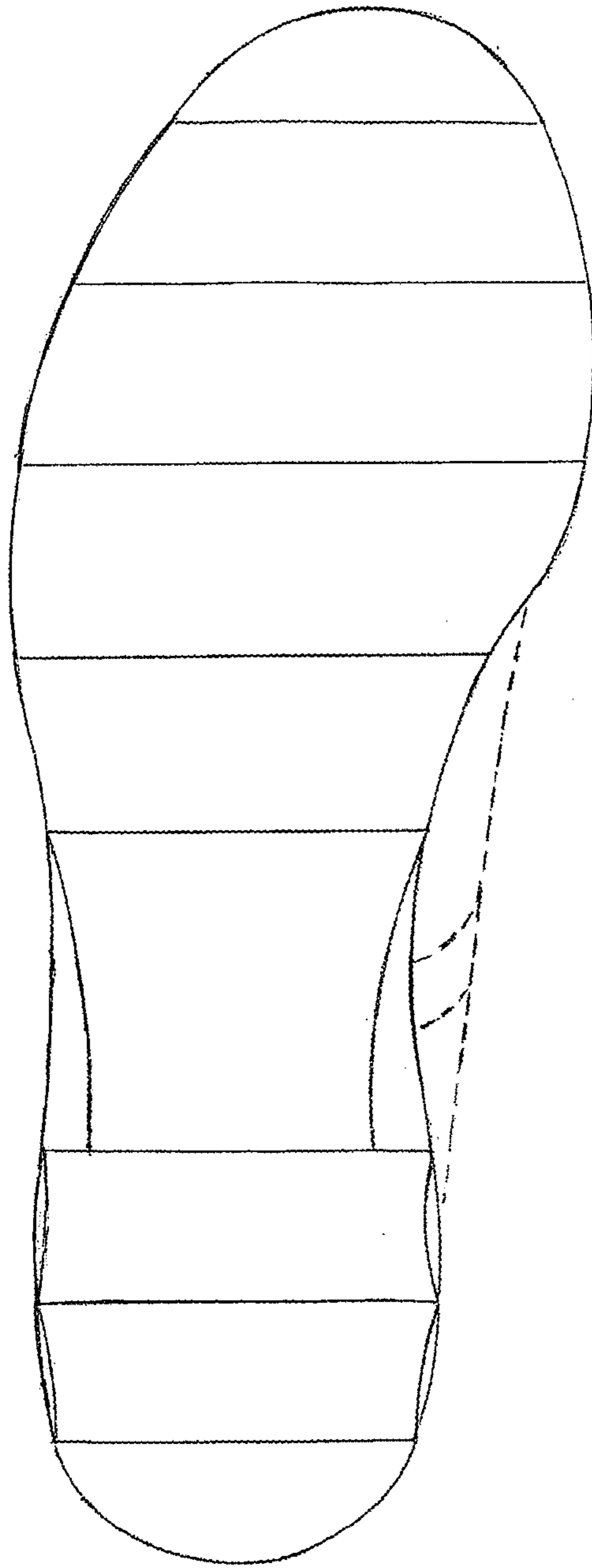

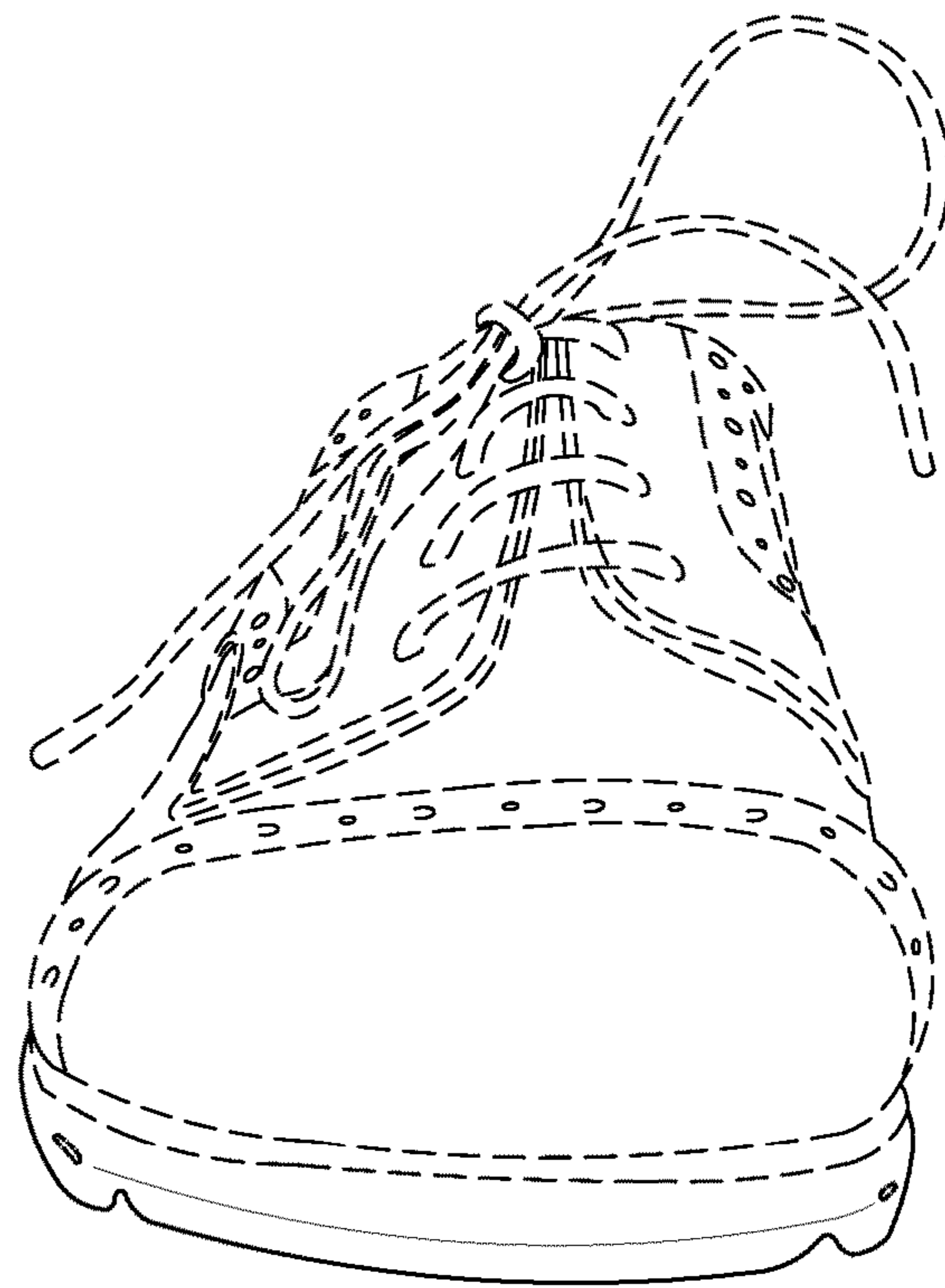
