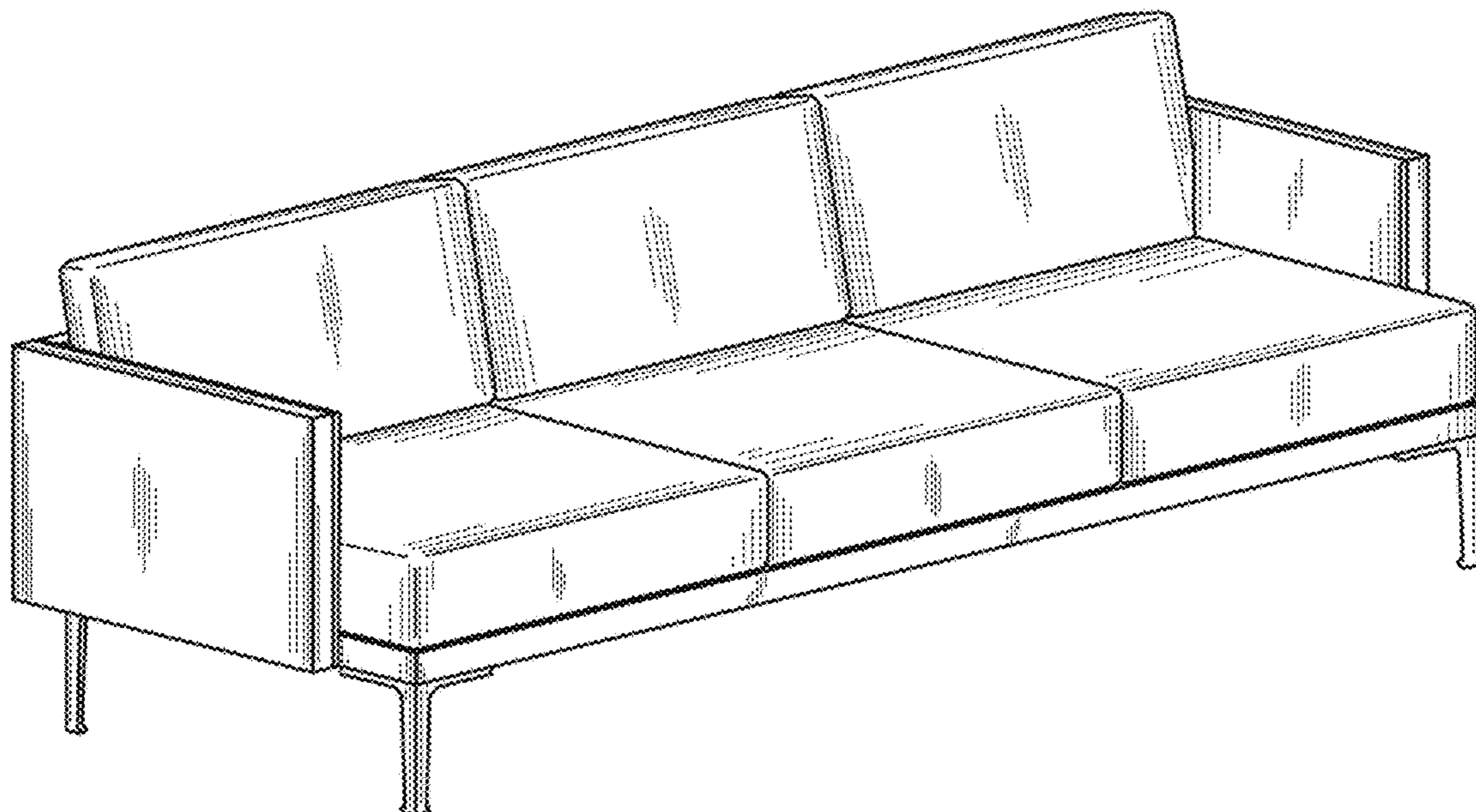

The ornamental design for a sofa, as shown and described.

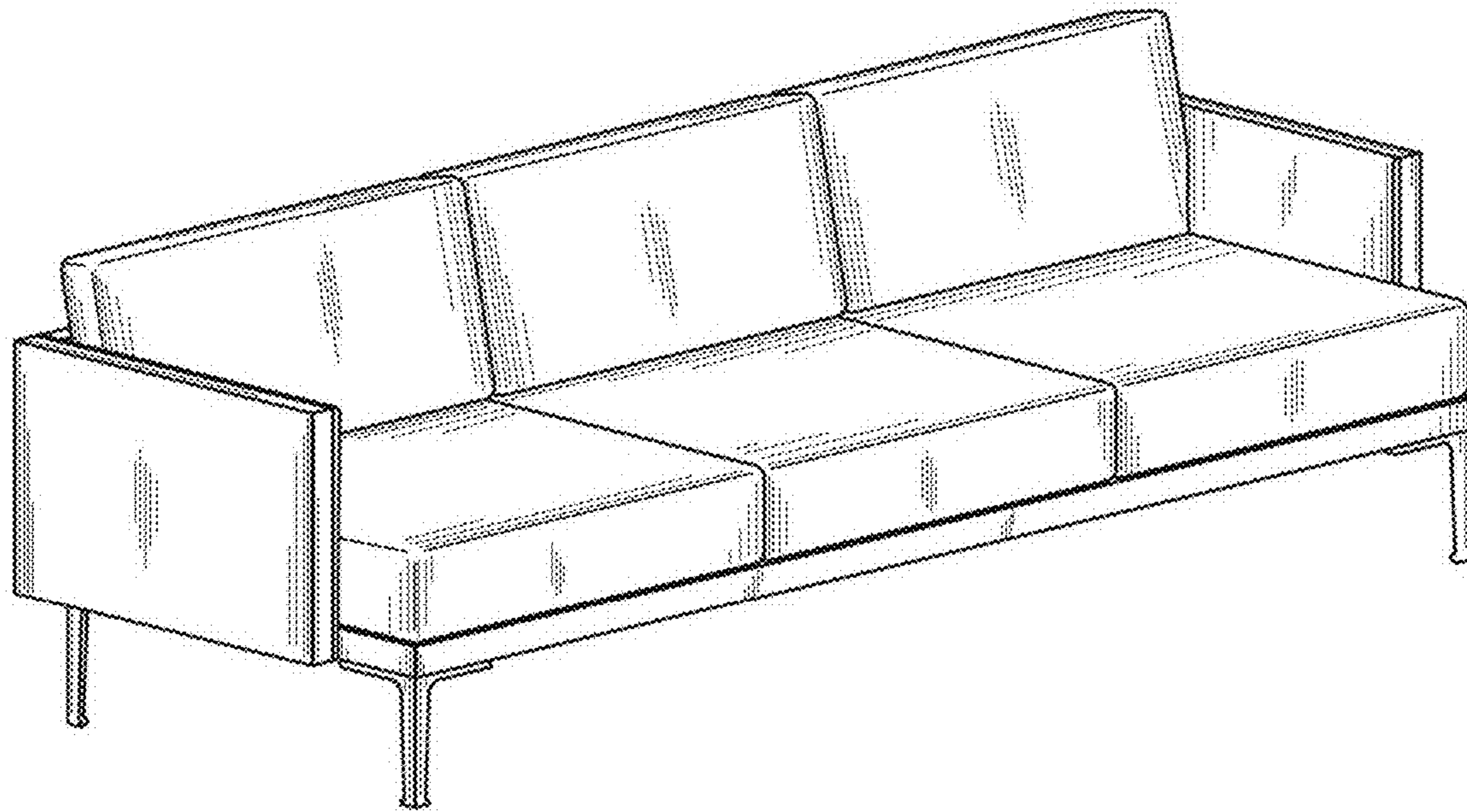
DESCRIPTION

- 1.7 is a bottom view.

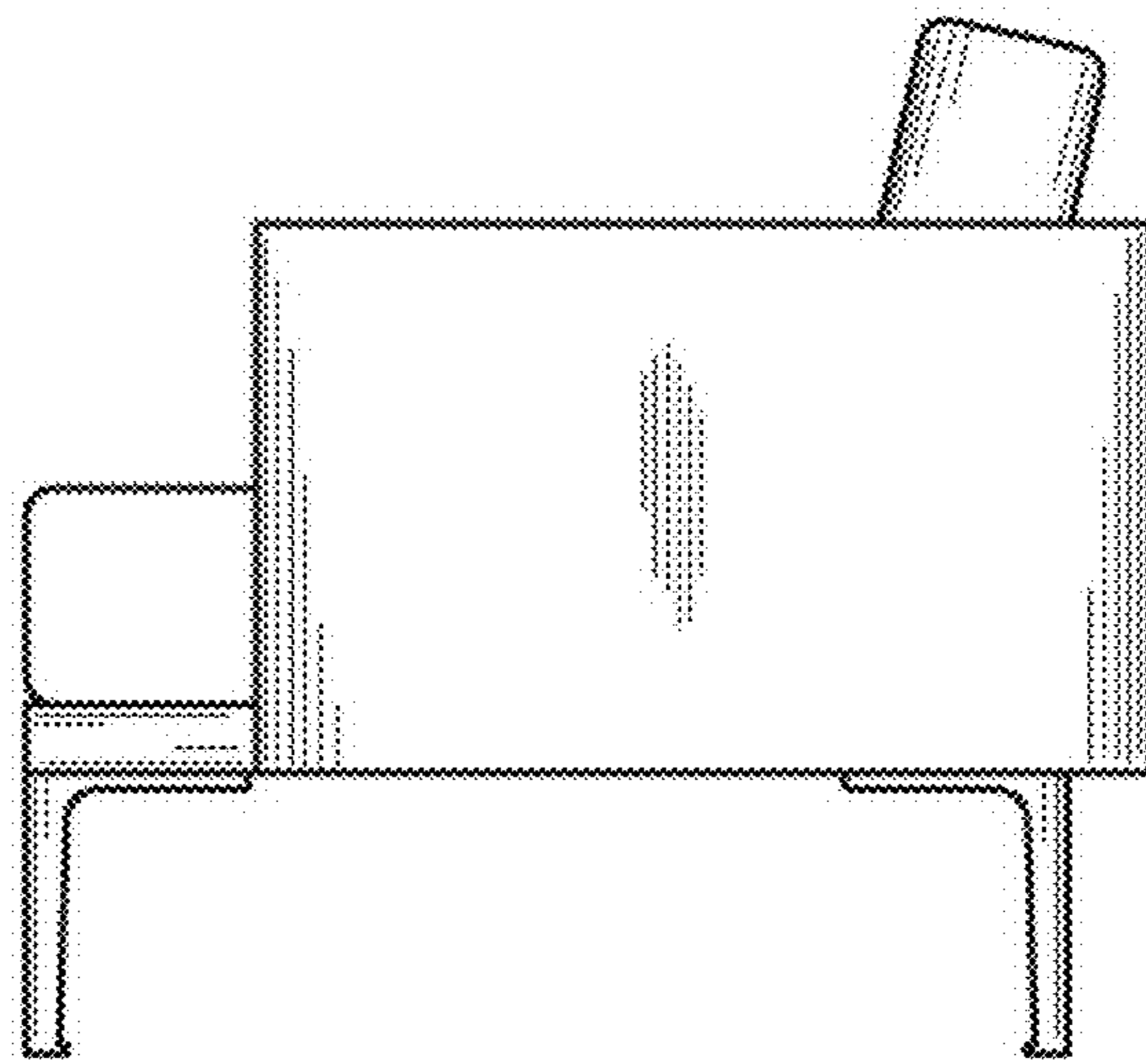

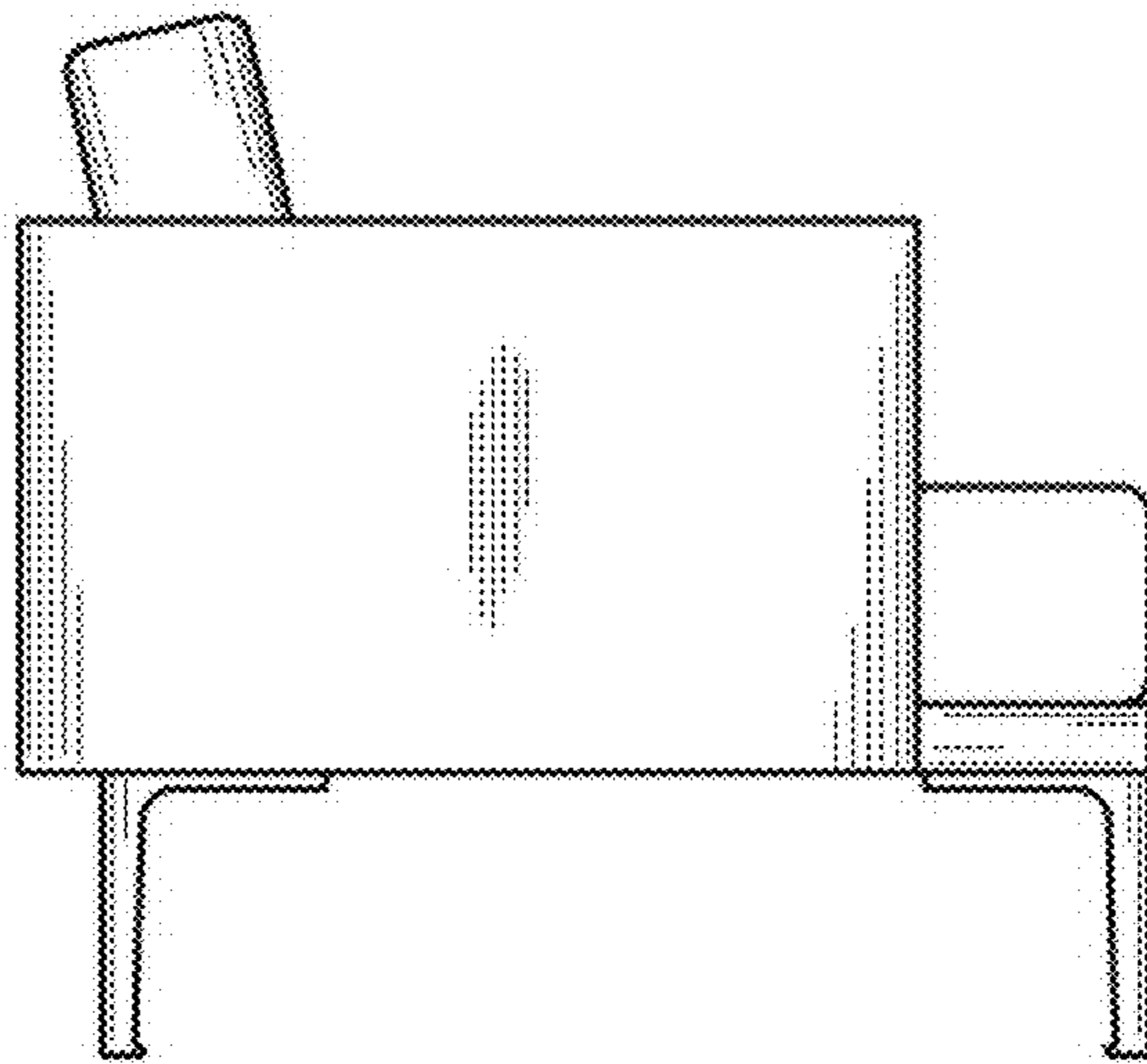

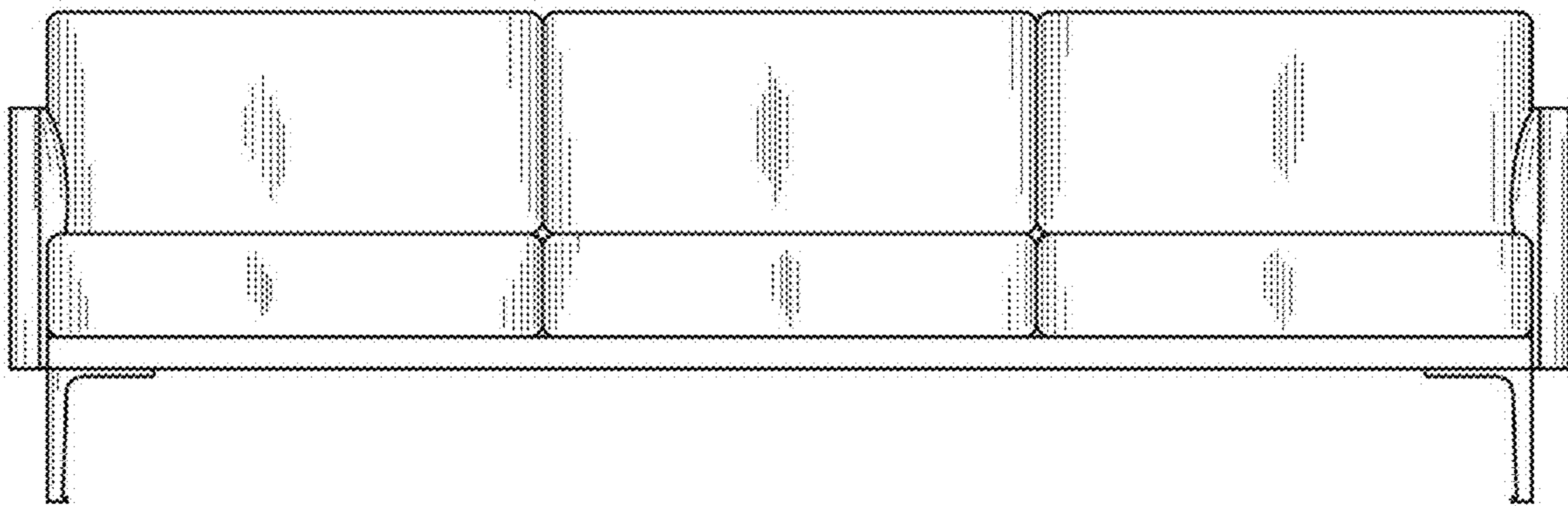

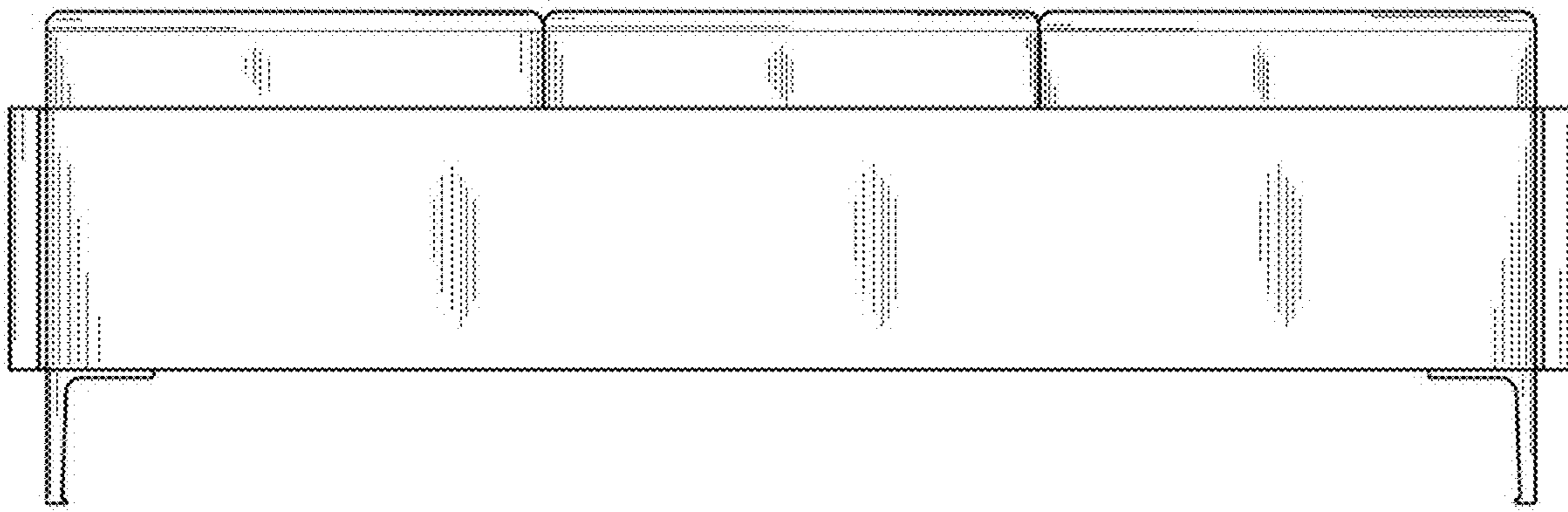

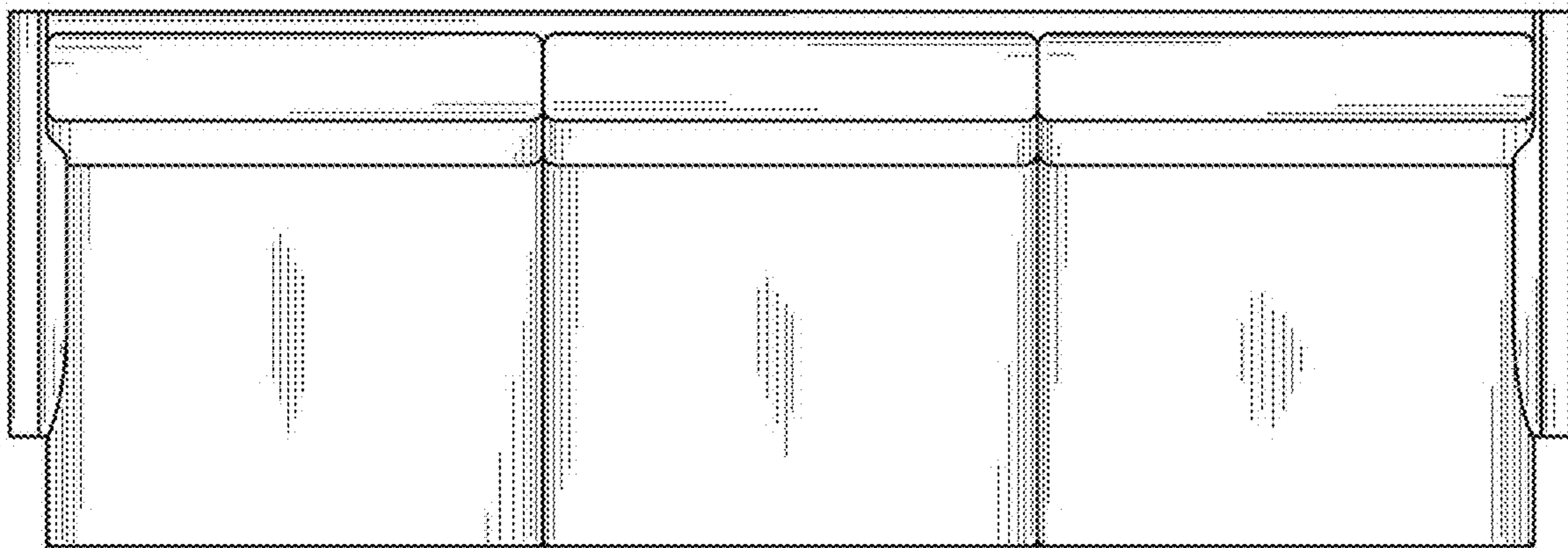
