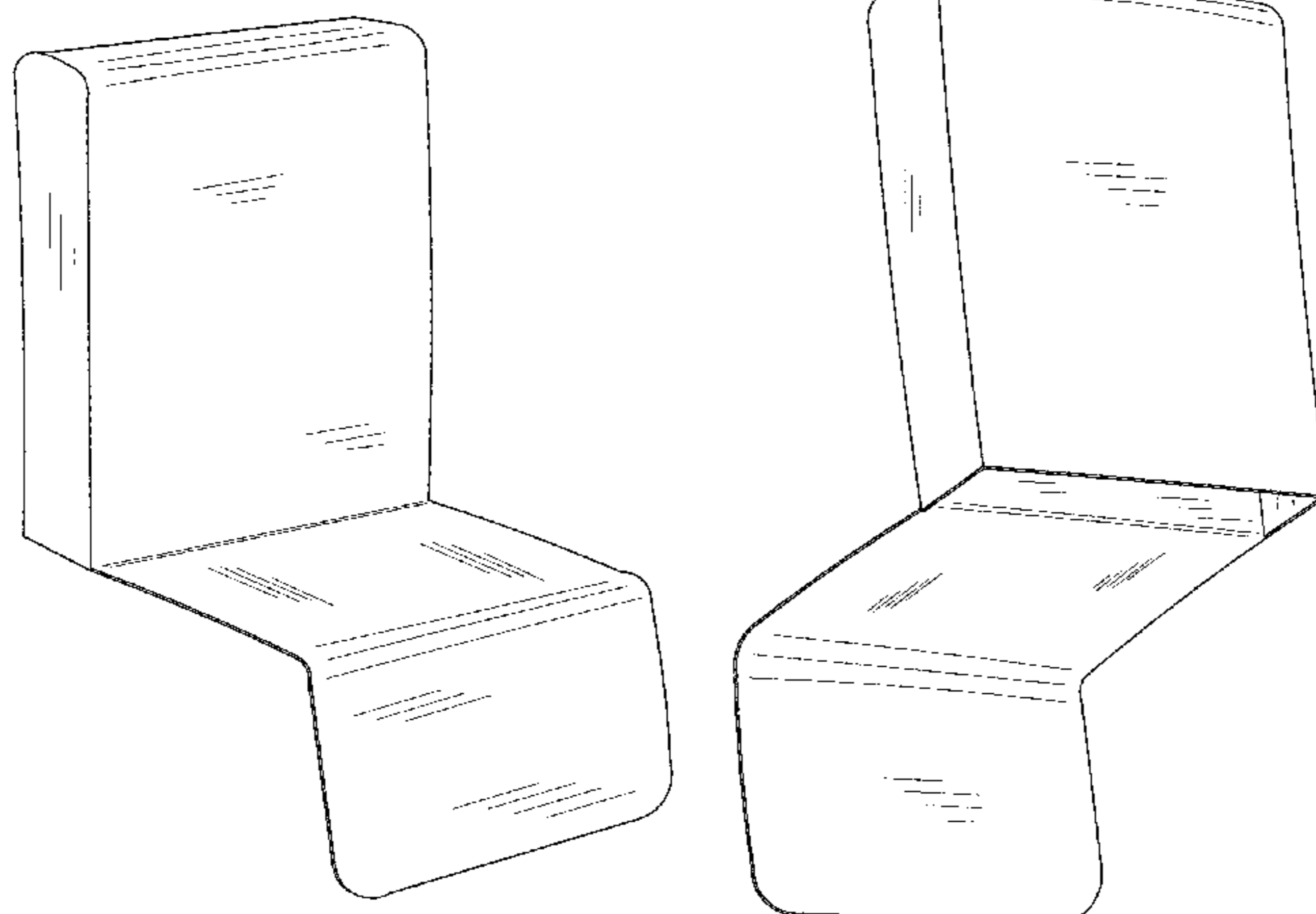


FIG. 7 is a bottom rear side perspective view of the protective chair cover.

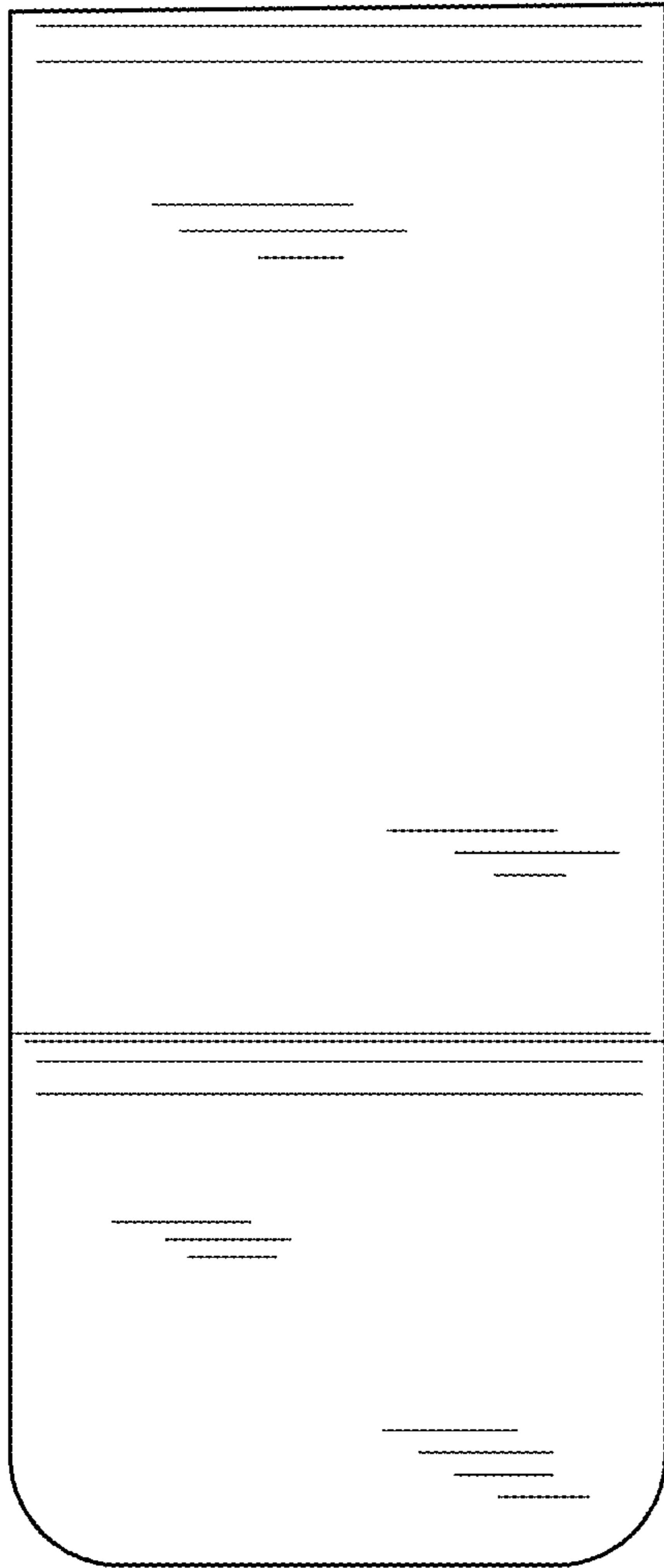

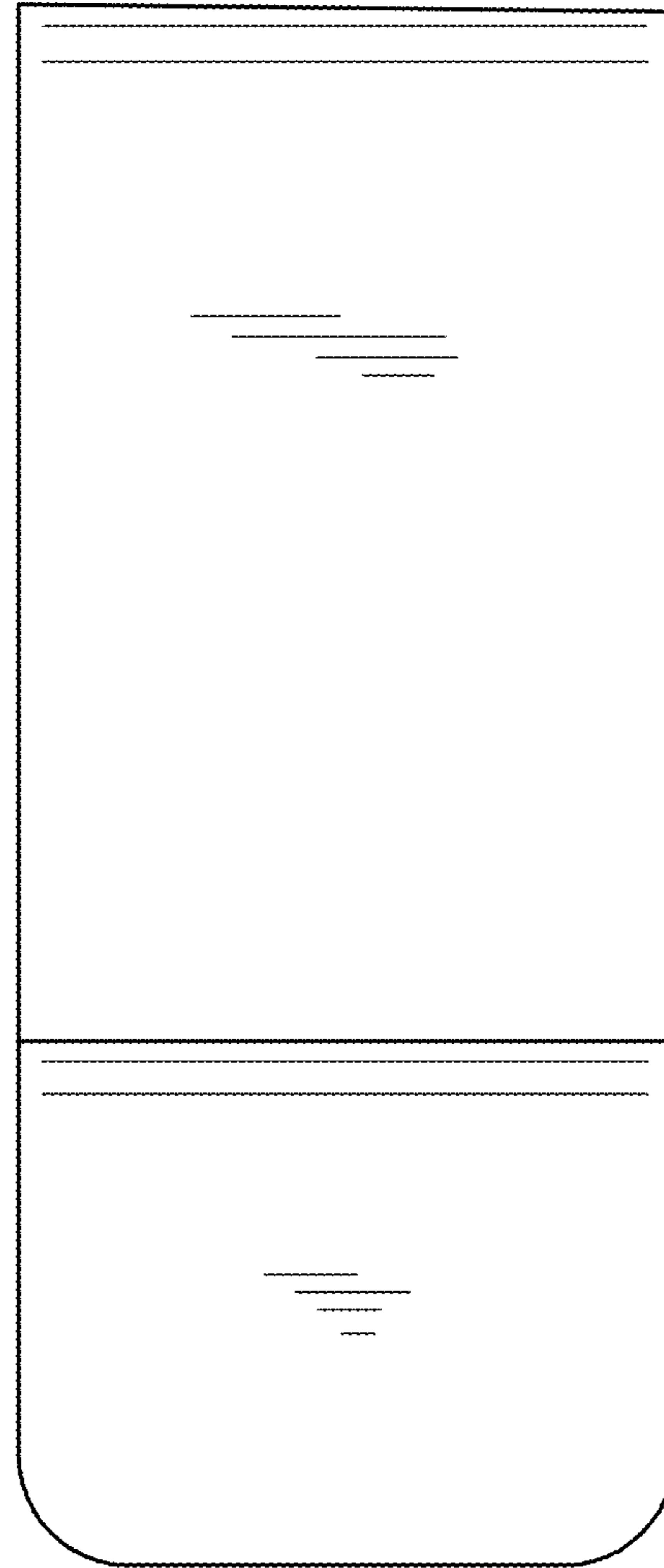

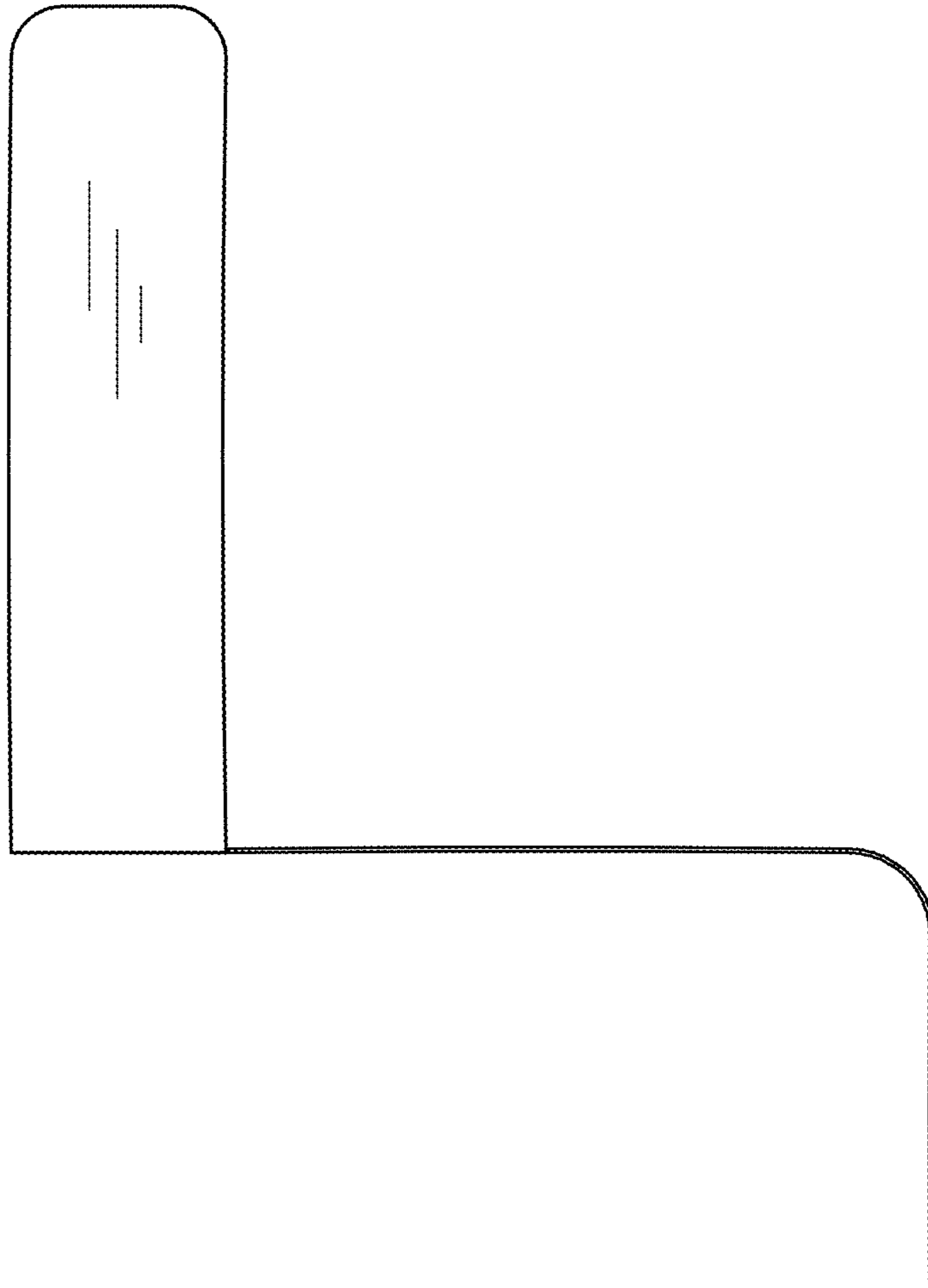

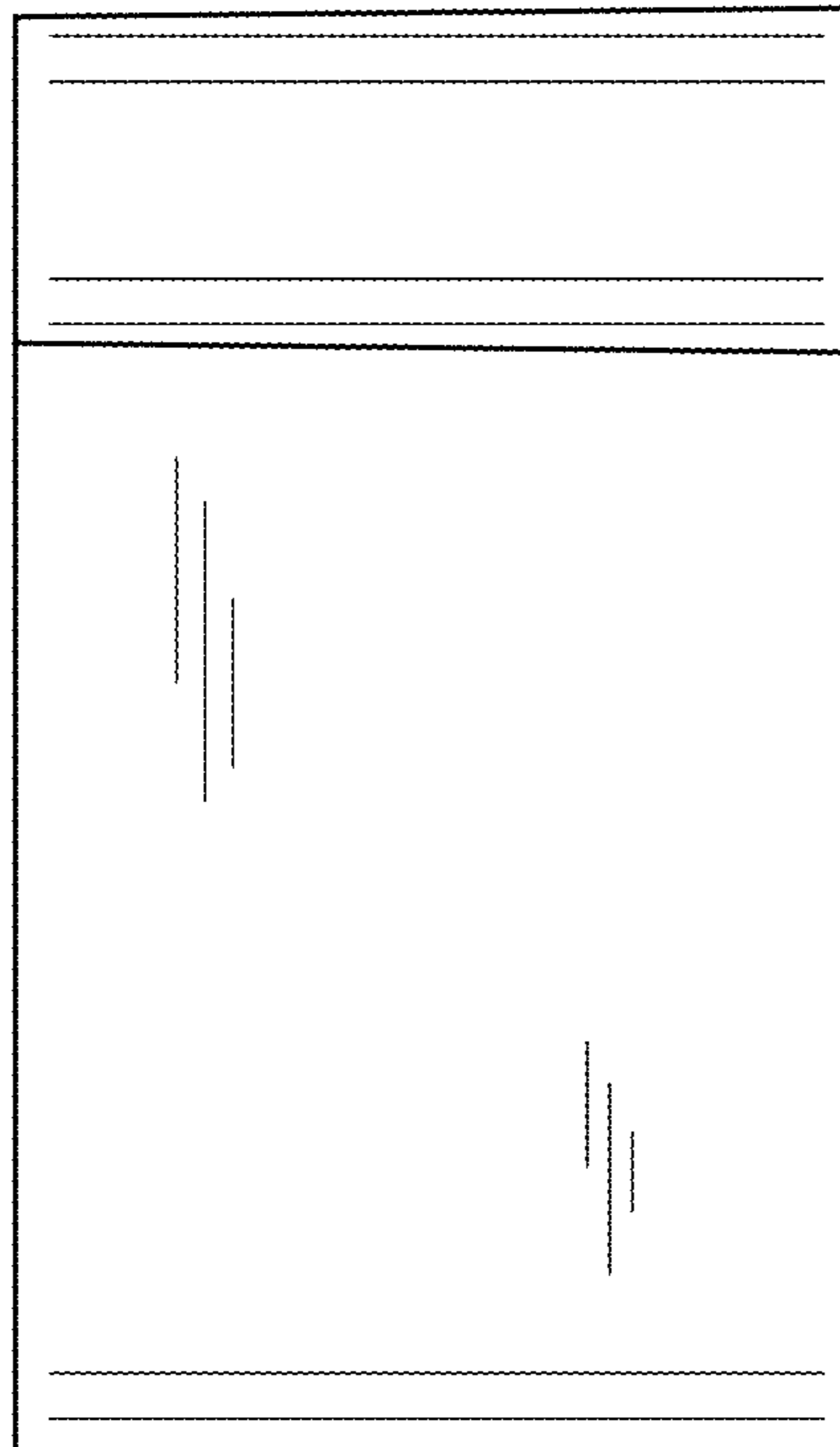

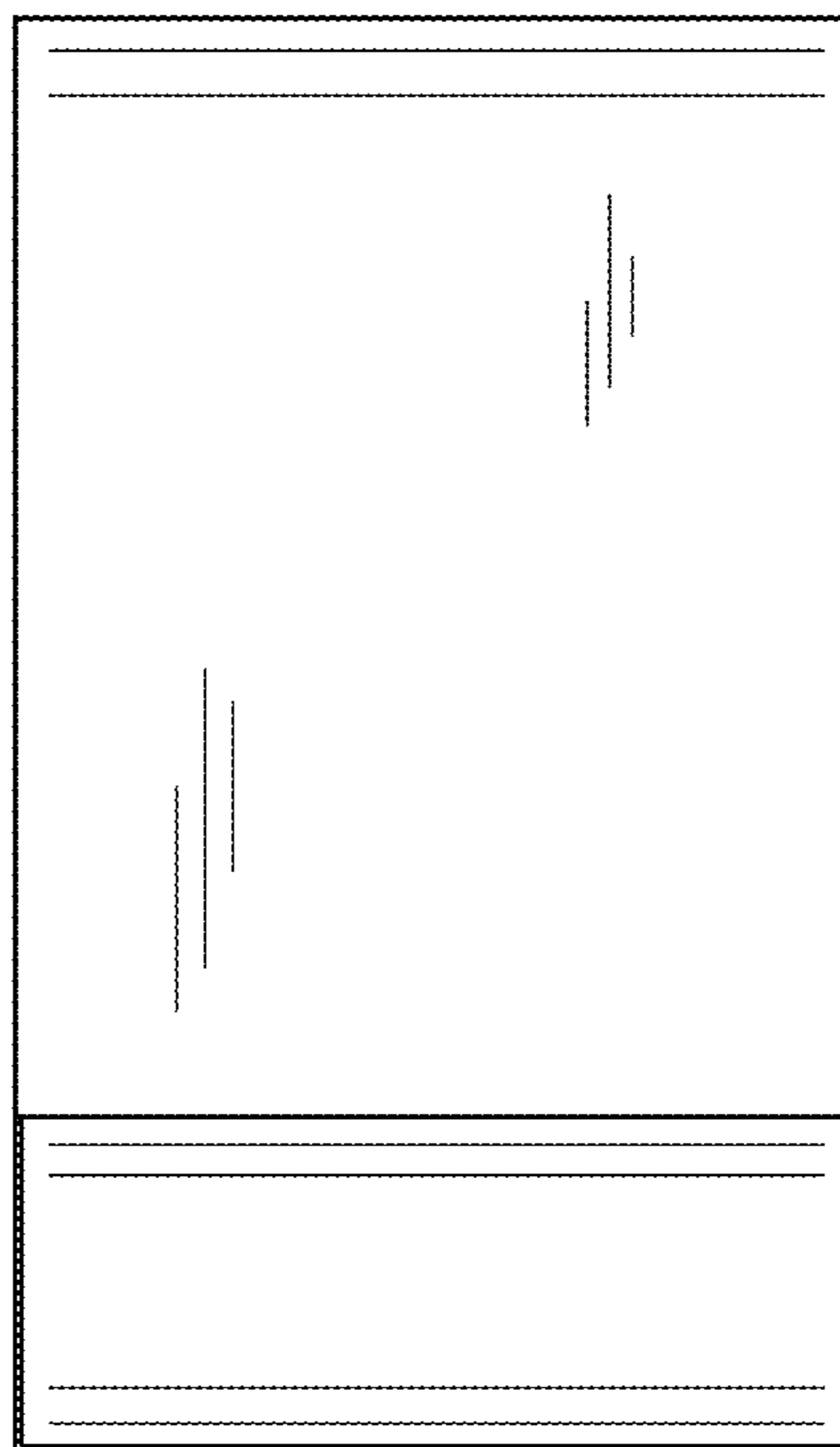

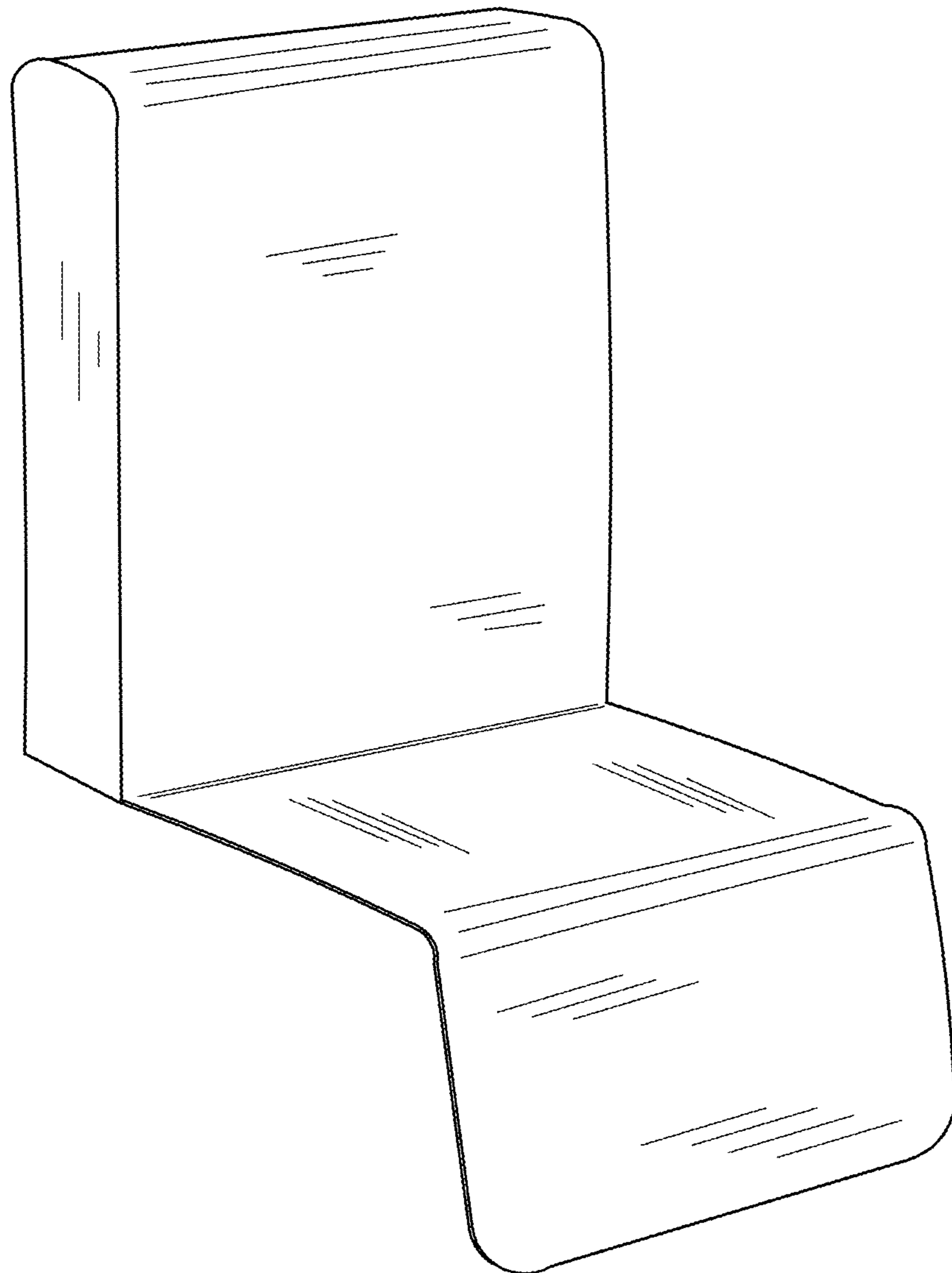

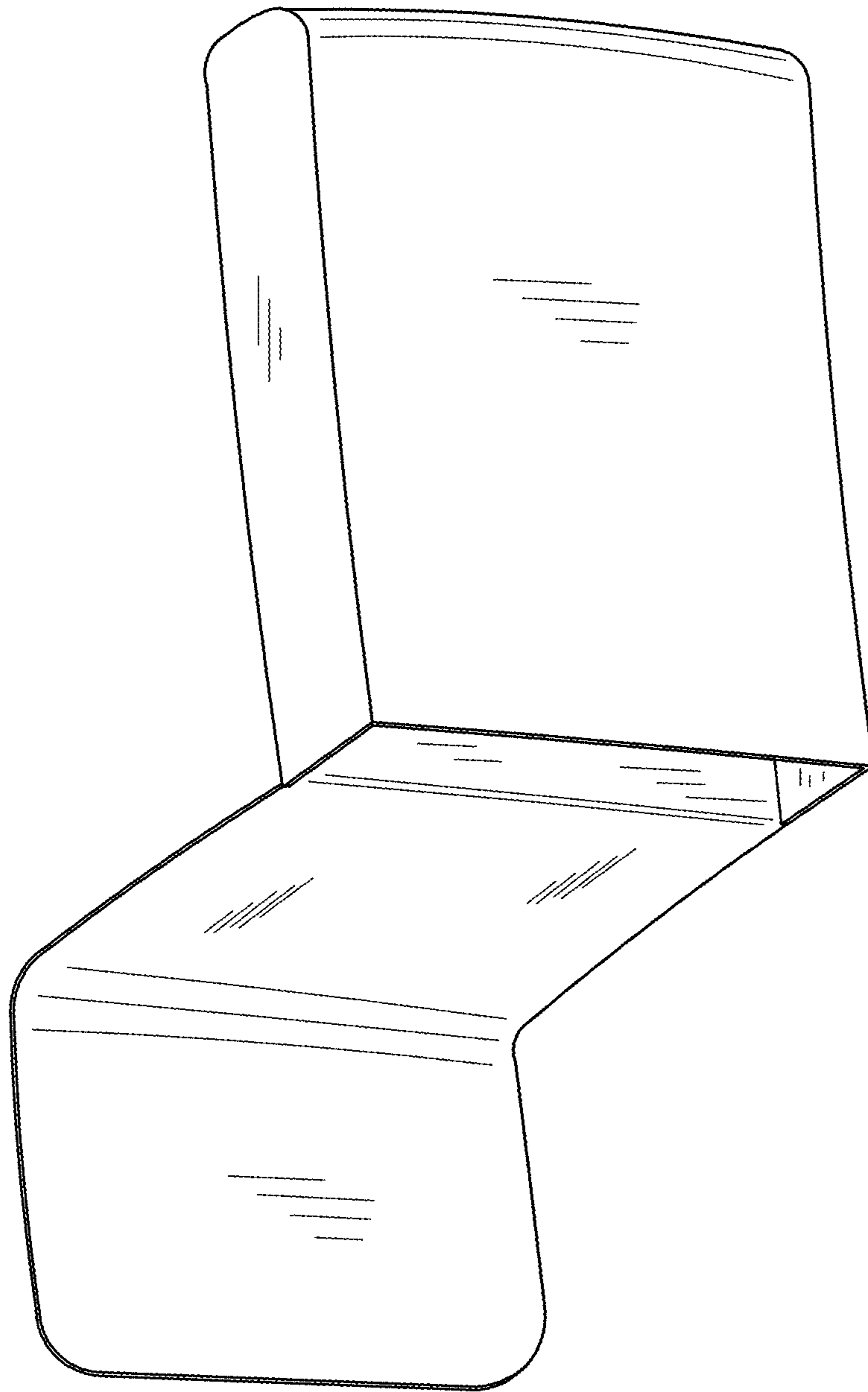
