The ornamental design for a grilling utensil, as shown and described.

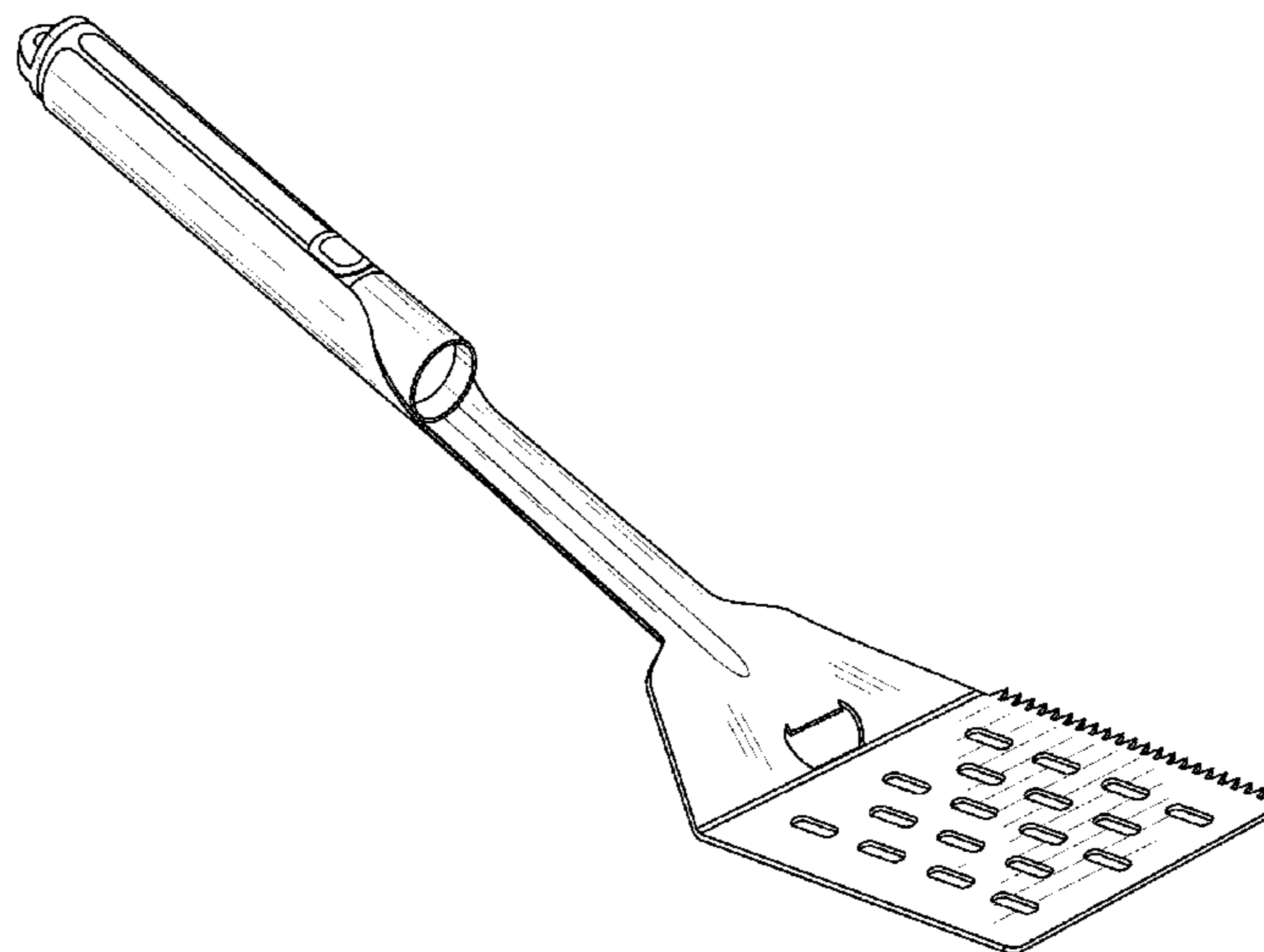
DESCRIPTION

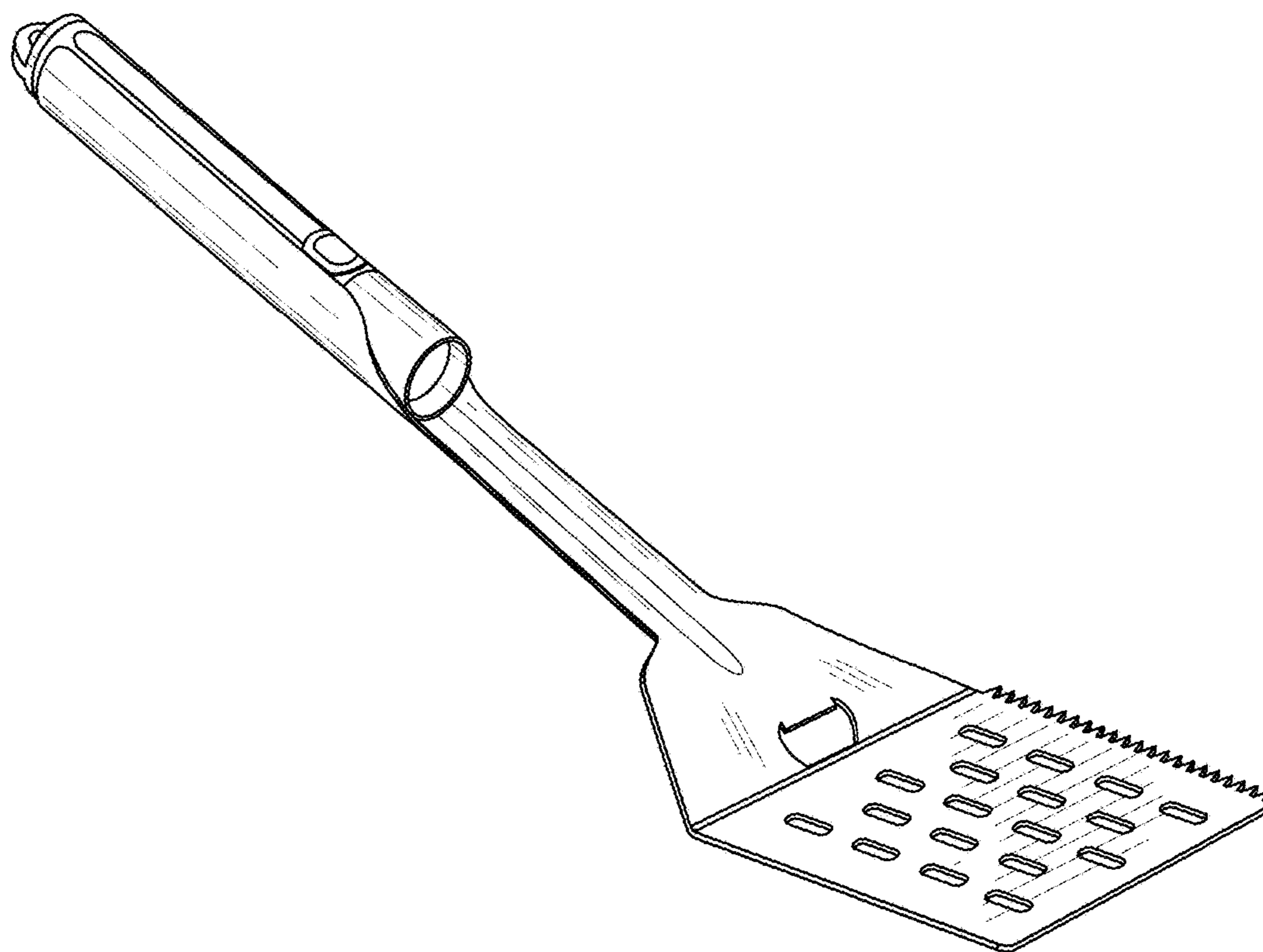

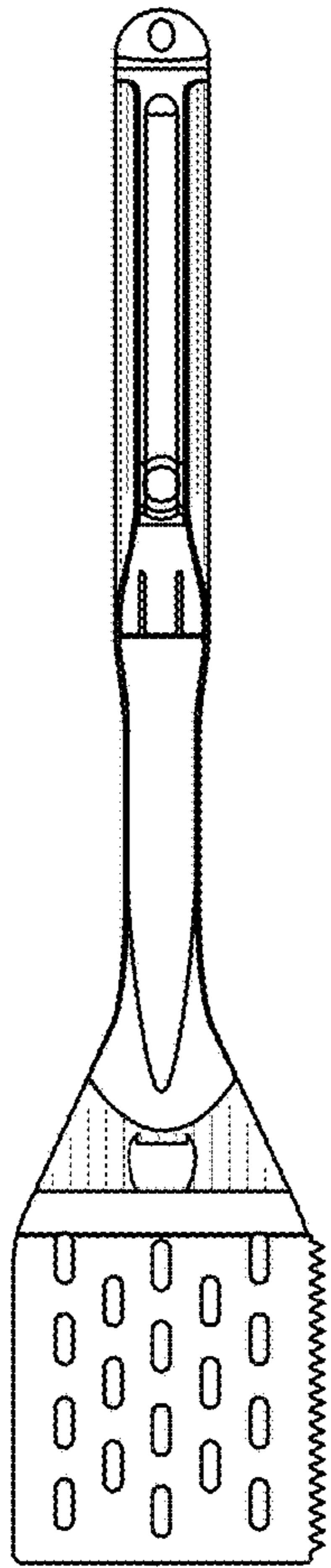

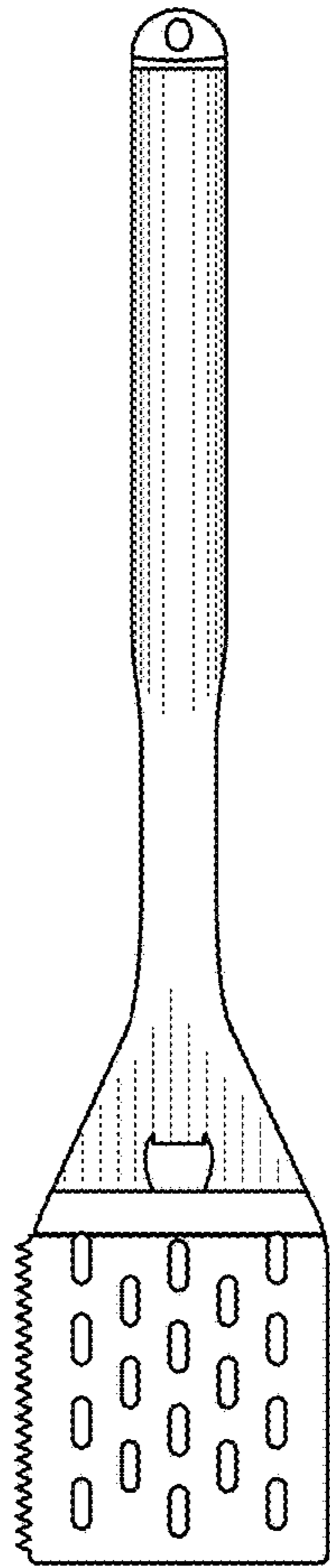

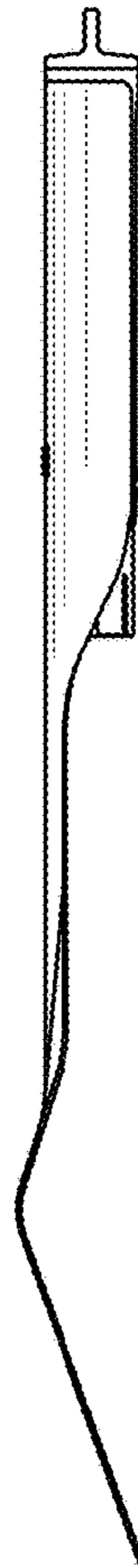

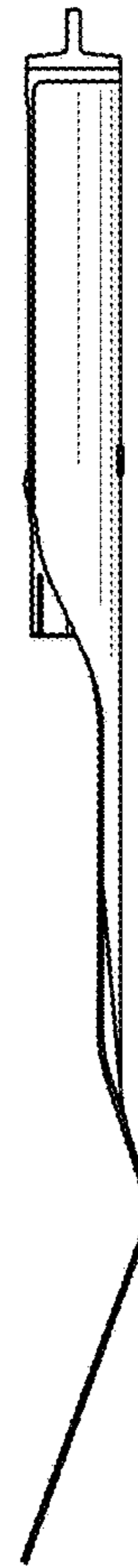

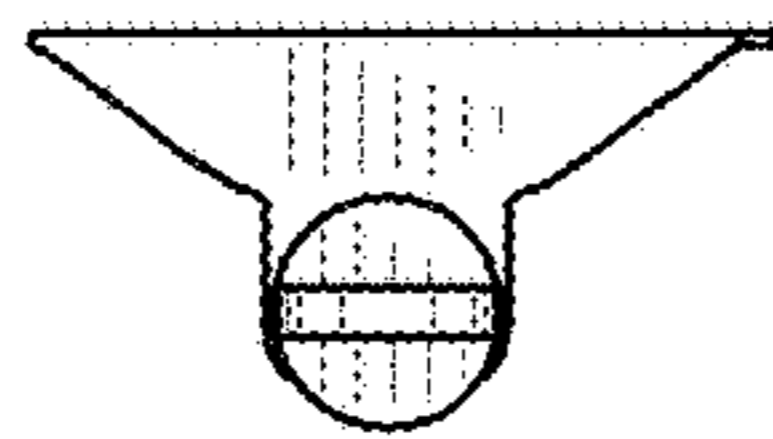

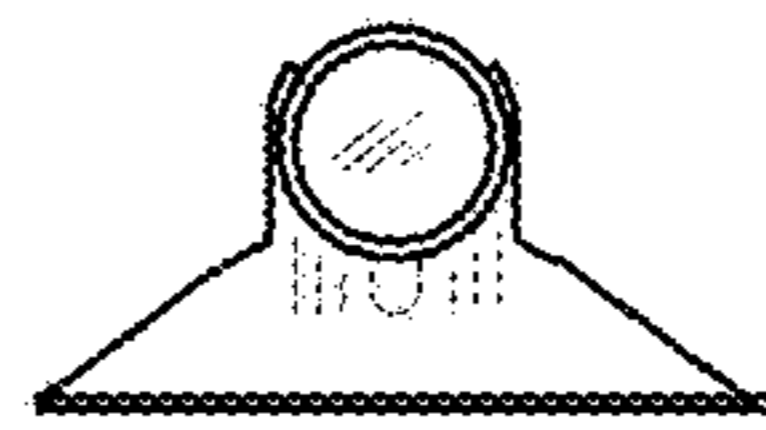
