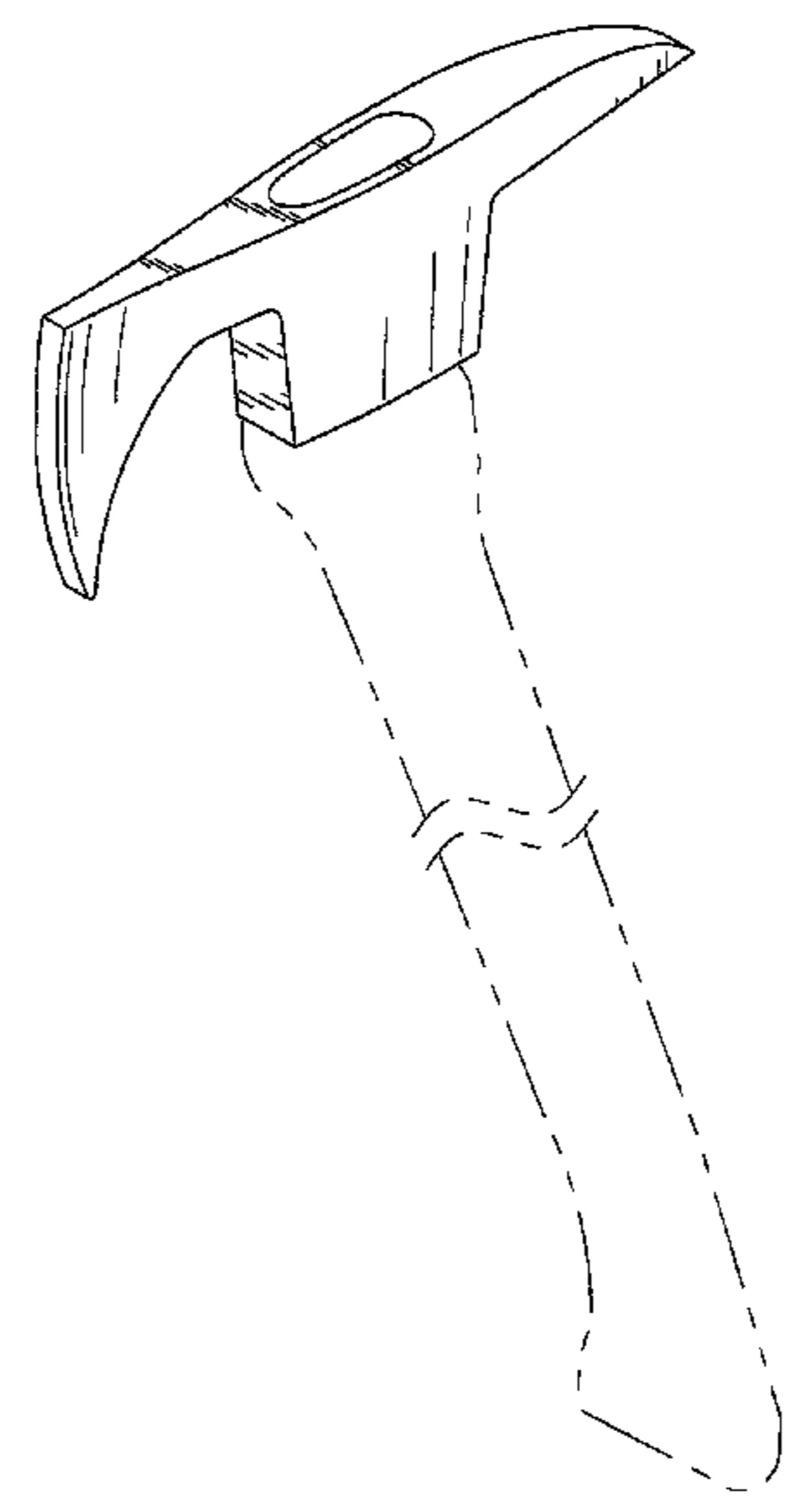
(57) **CLAIM**

The ornamental design for a firefighter's carry ax, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a firefighter's carry ax.
FIG. 2 is a rear view of a firefighter's carry ax.
FIG. 3 is a top view of a firefighter's carry ax.
FIG. 4 is a bottom view of a firefighter's carry ax.
FIG. 5 is a right side view of a firefighter's carry ax.
FIG. 6 is a left side view of a firefighter's carry ax; and,
FIG. 7 is a perspective view of the firefighter's carry ax with phantom lines indicating a handle used in conjunction with the firefighter's carry ax.

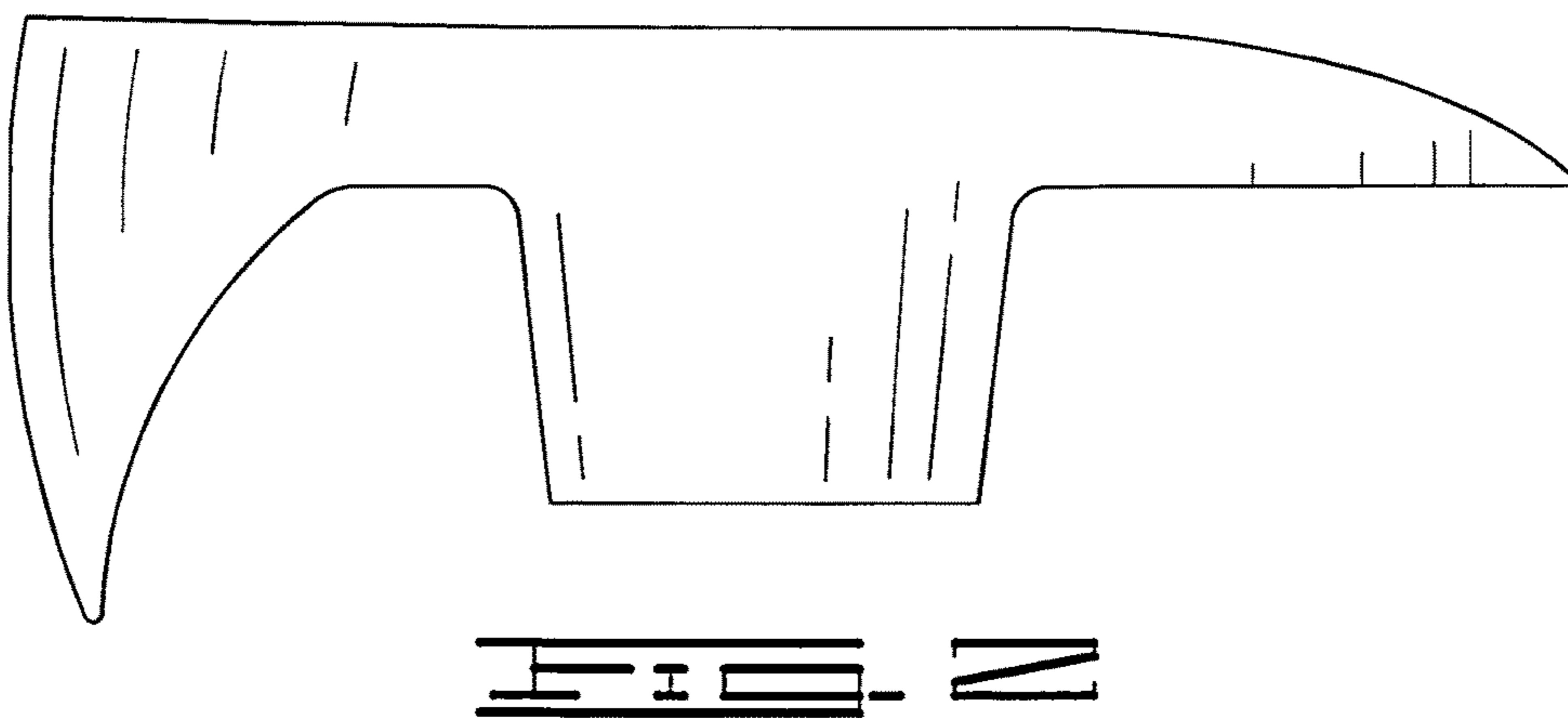
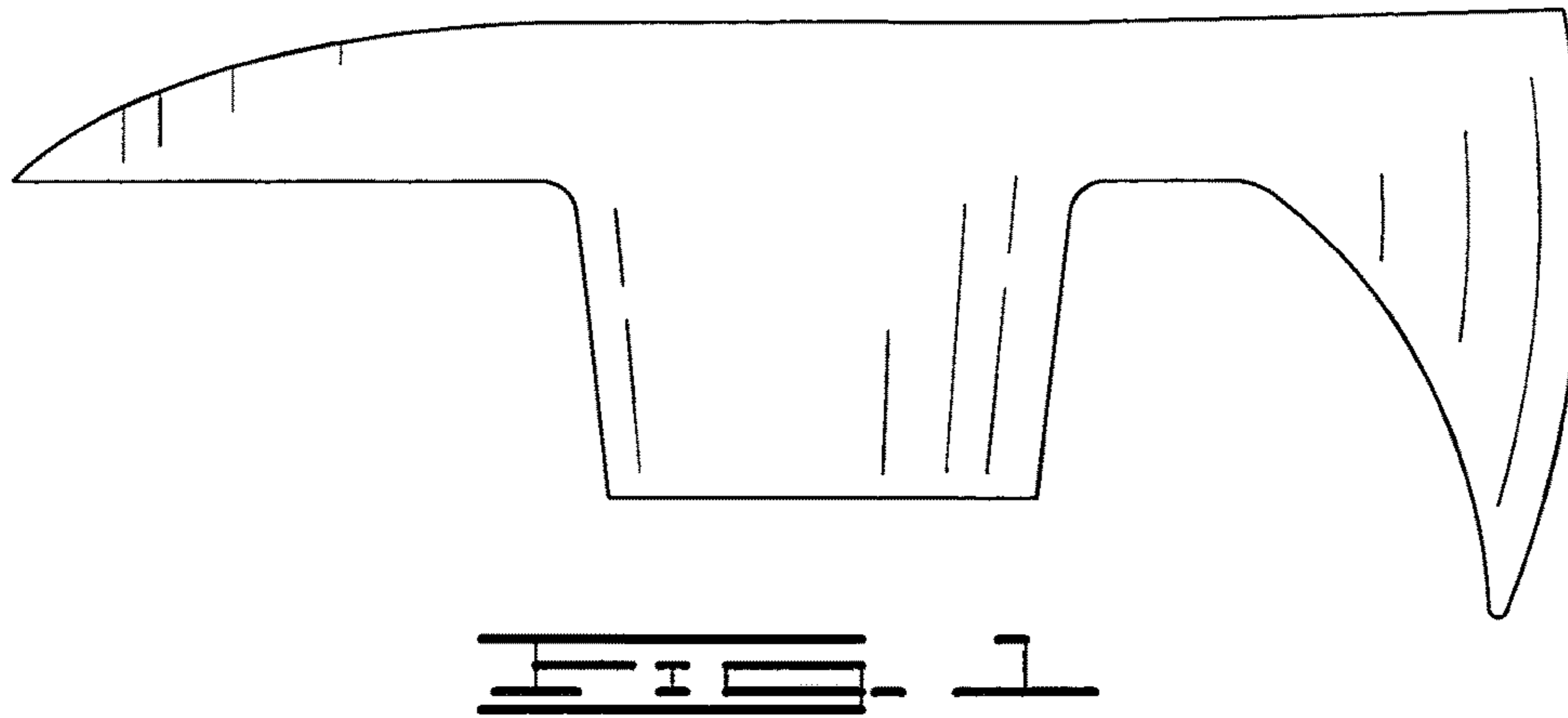

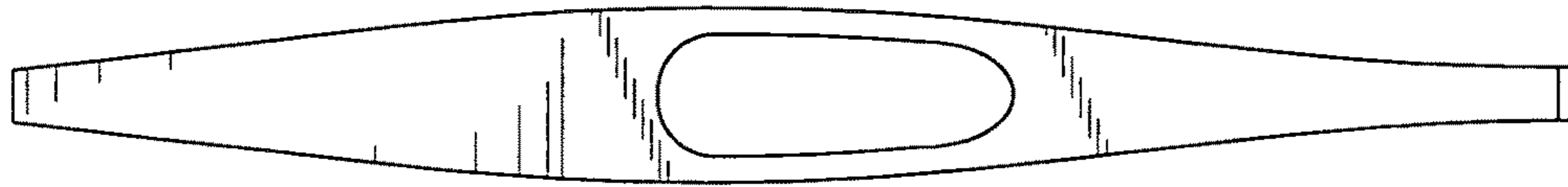

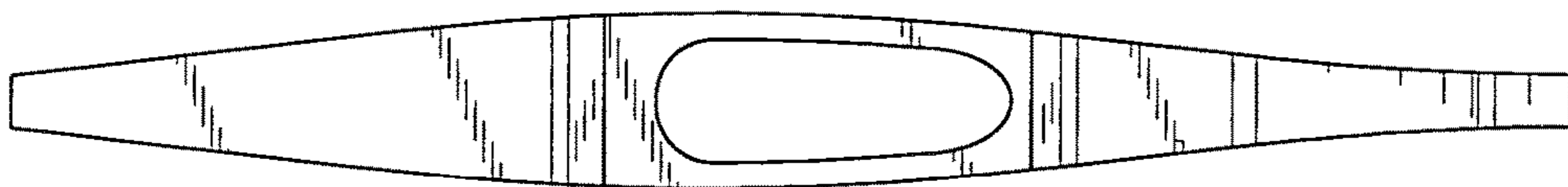

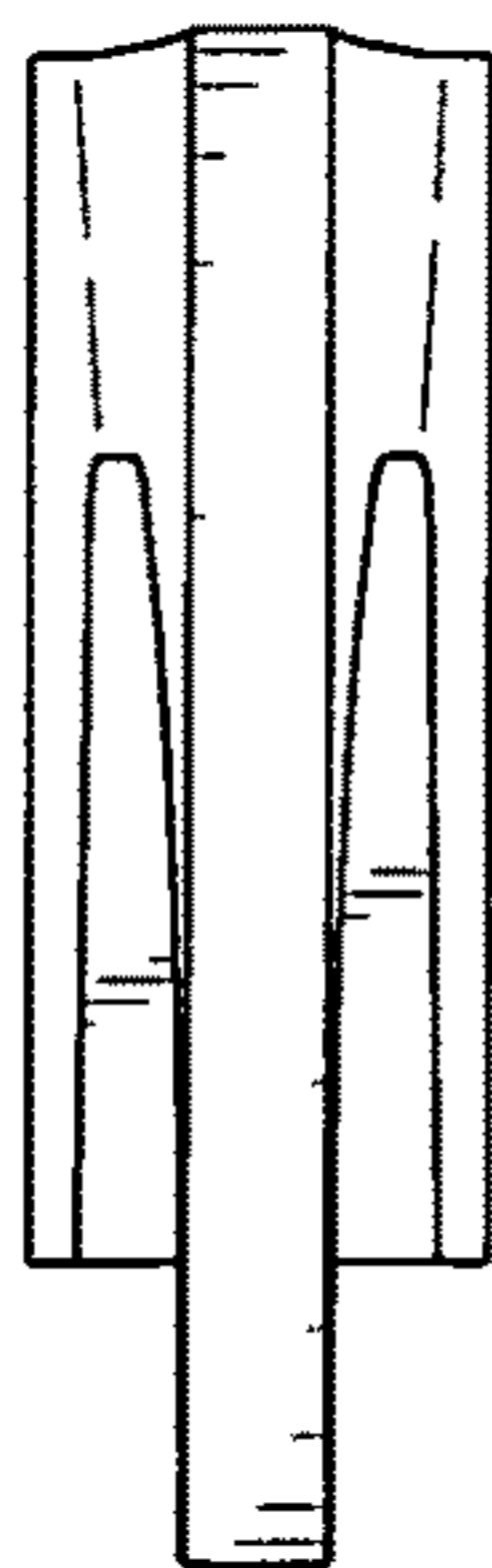

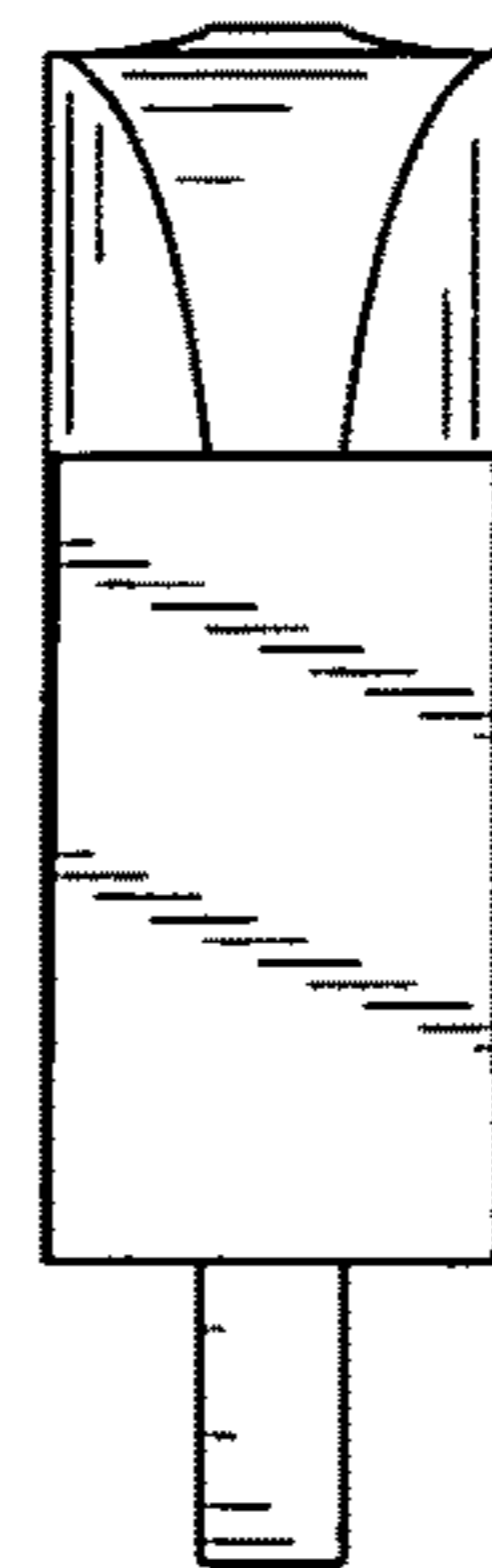
