The ornamental design for a strap for a watch-shaped toy, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a strap for a watch-shaped toy;

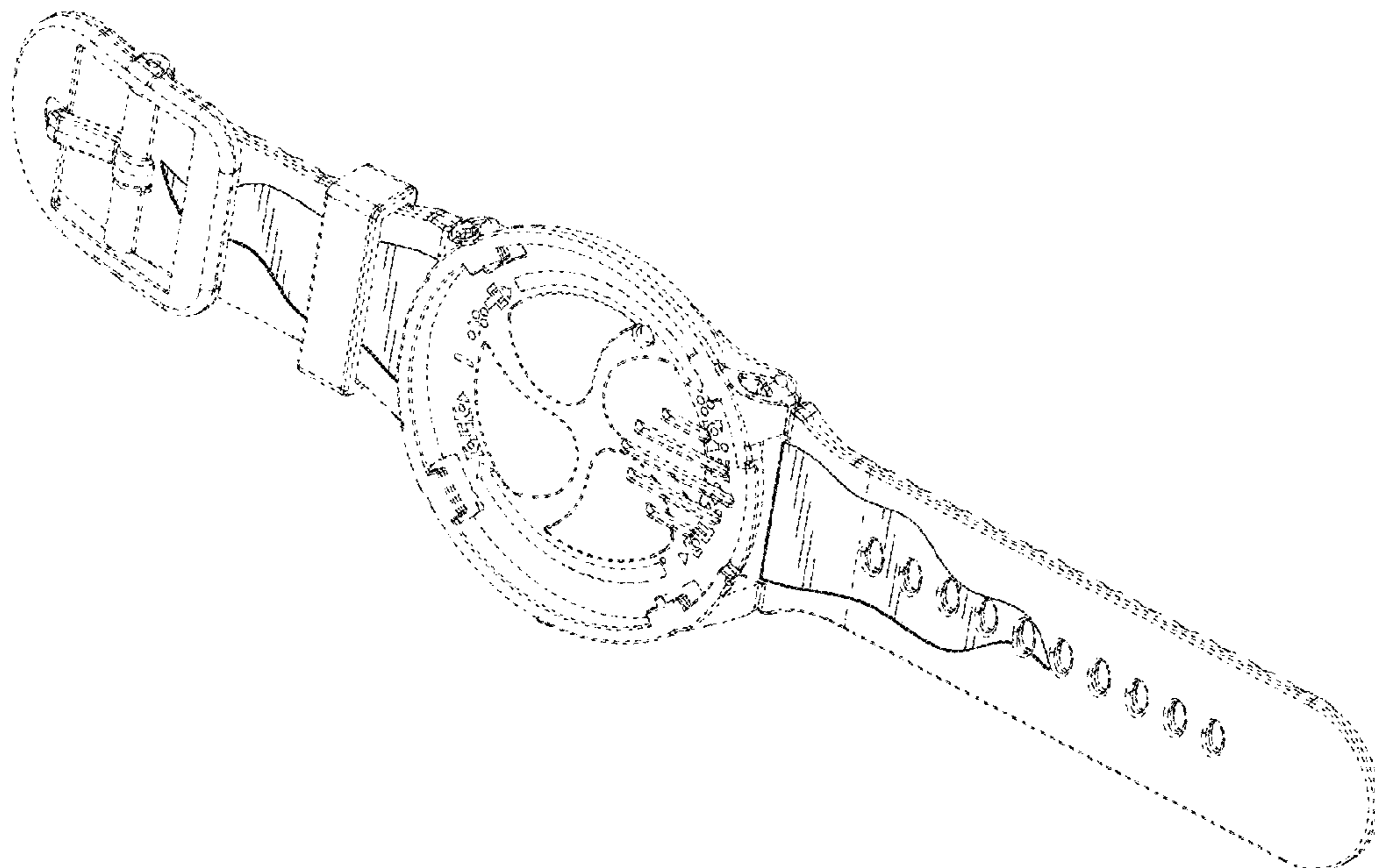
FIG. 2 is a front view thereof;

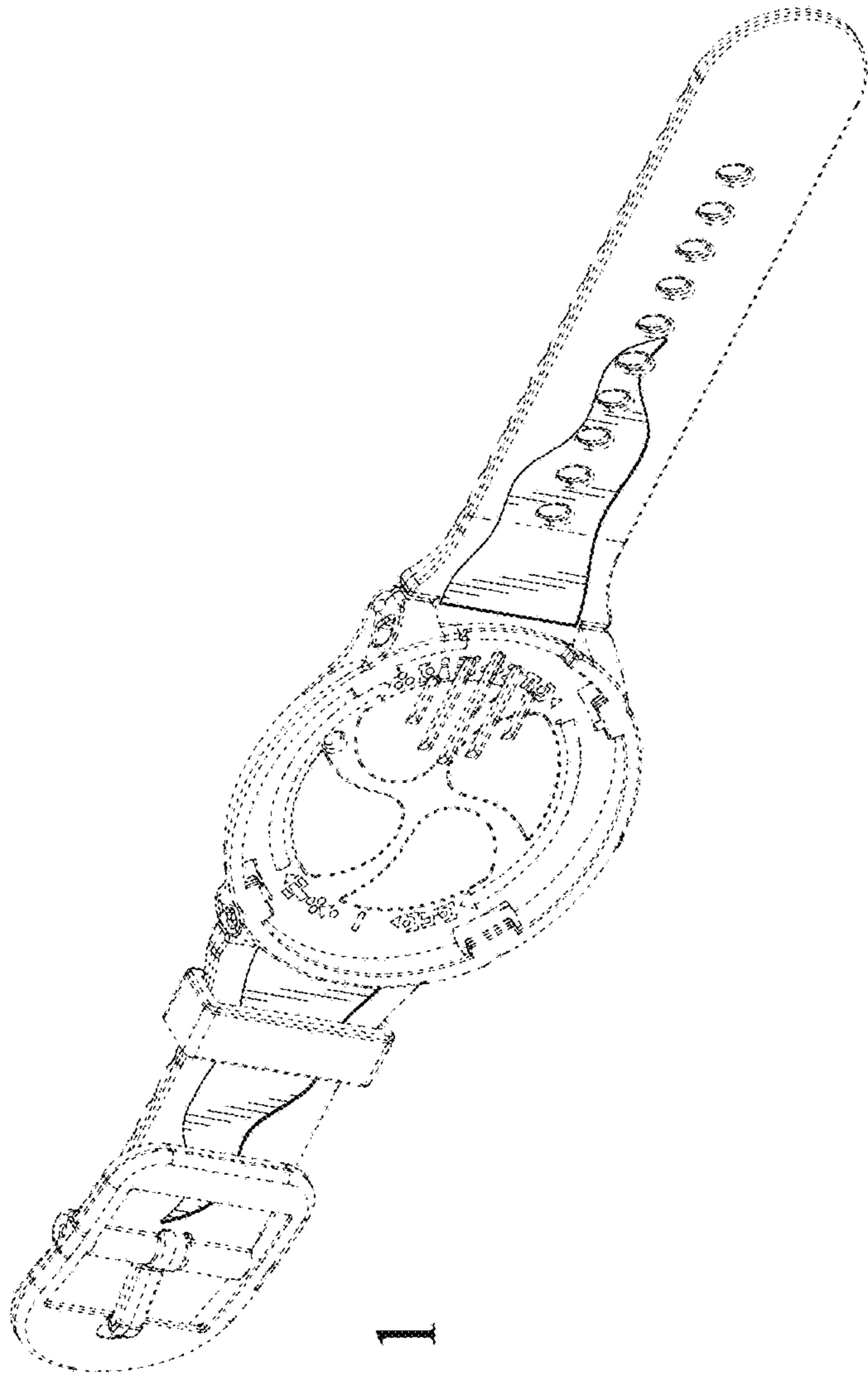

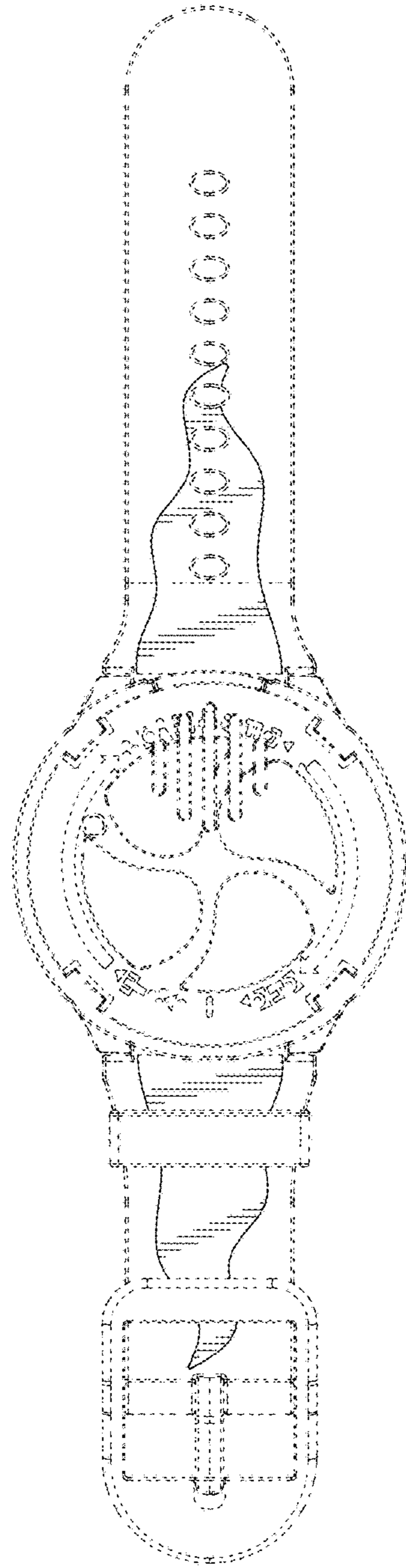

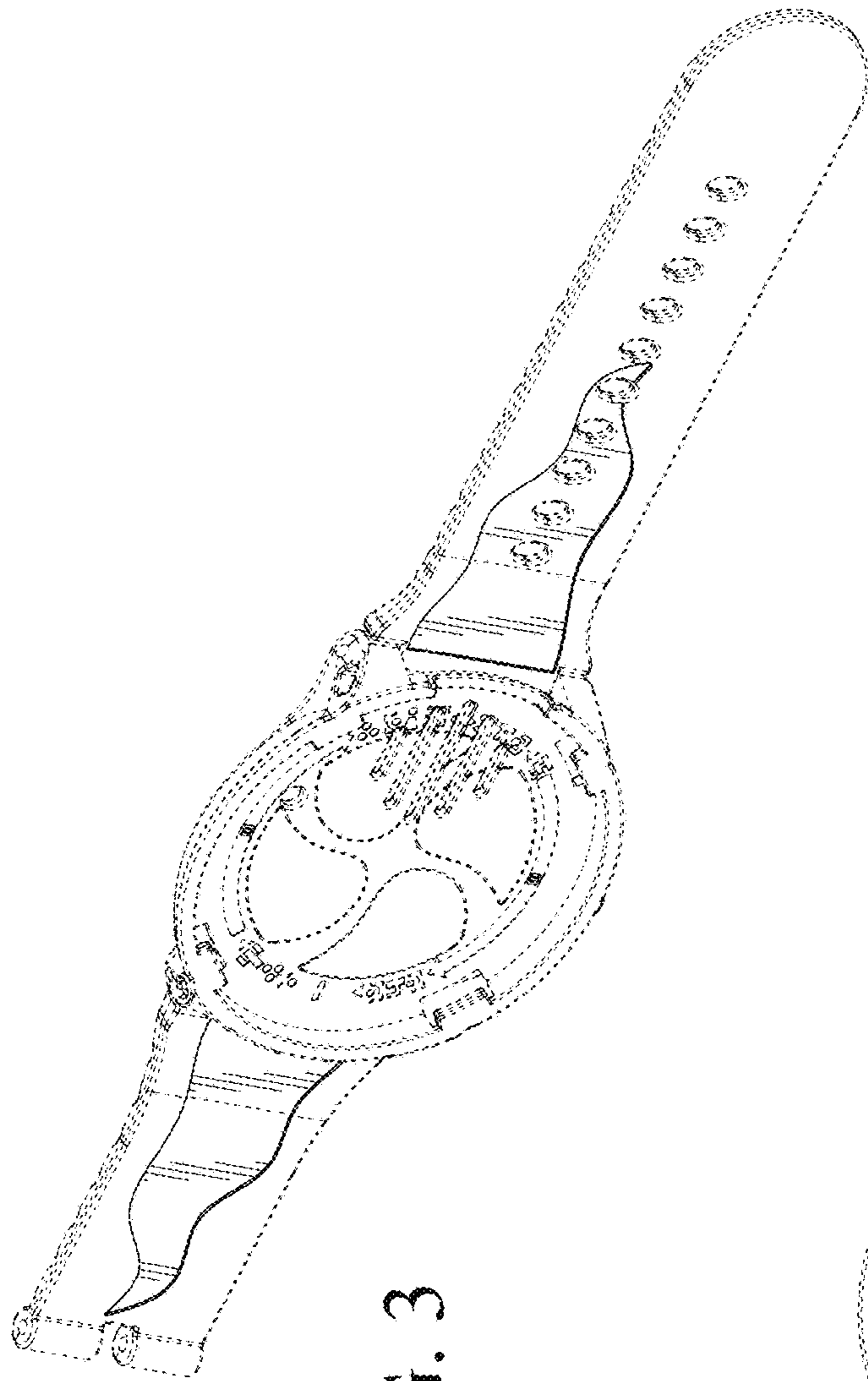

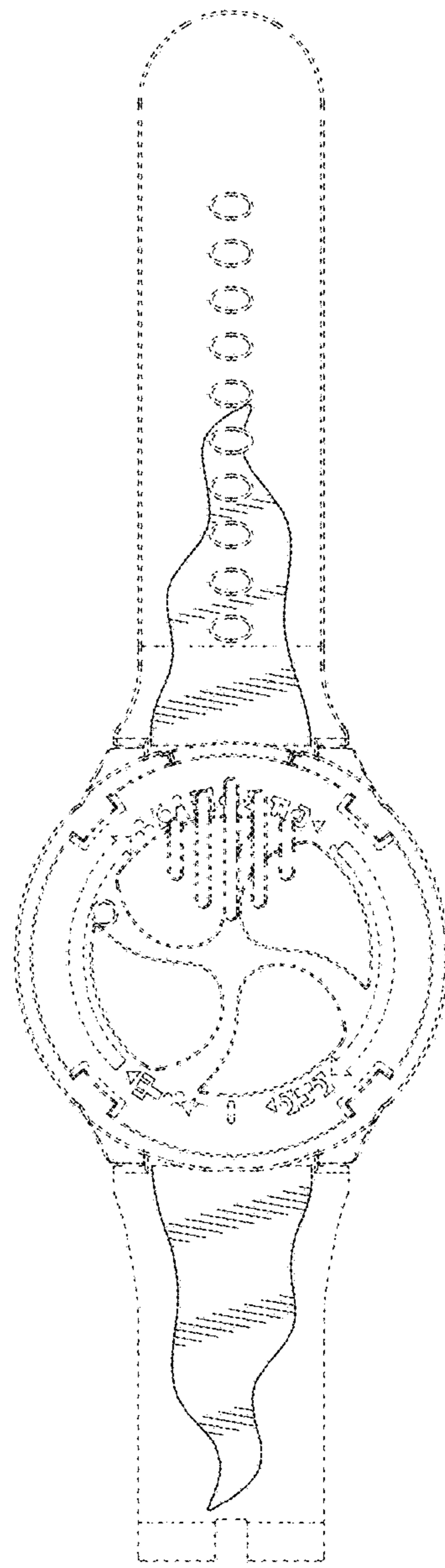
