(57) **CLAIM**

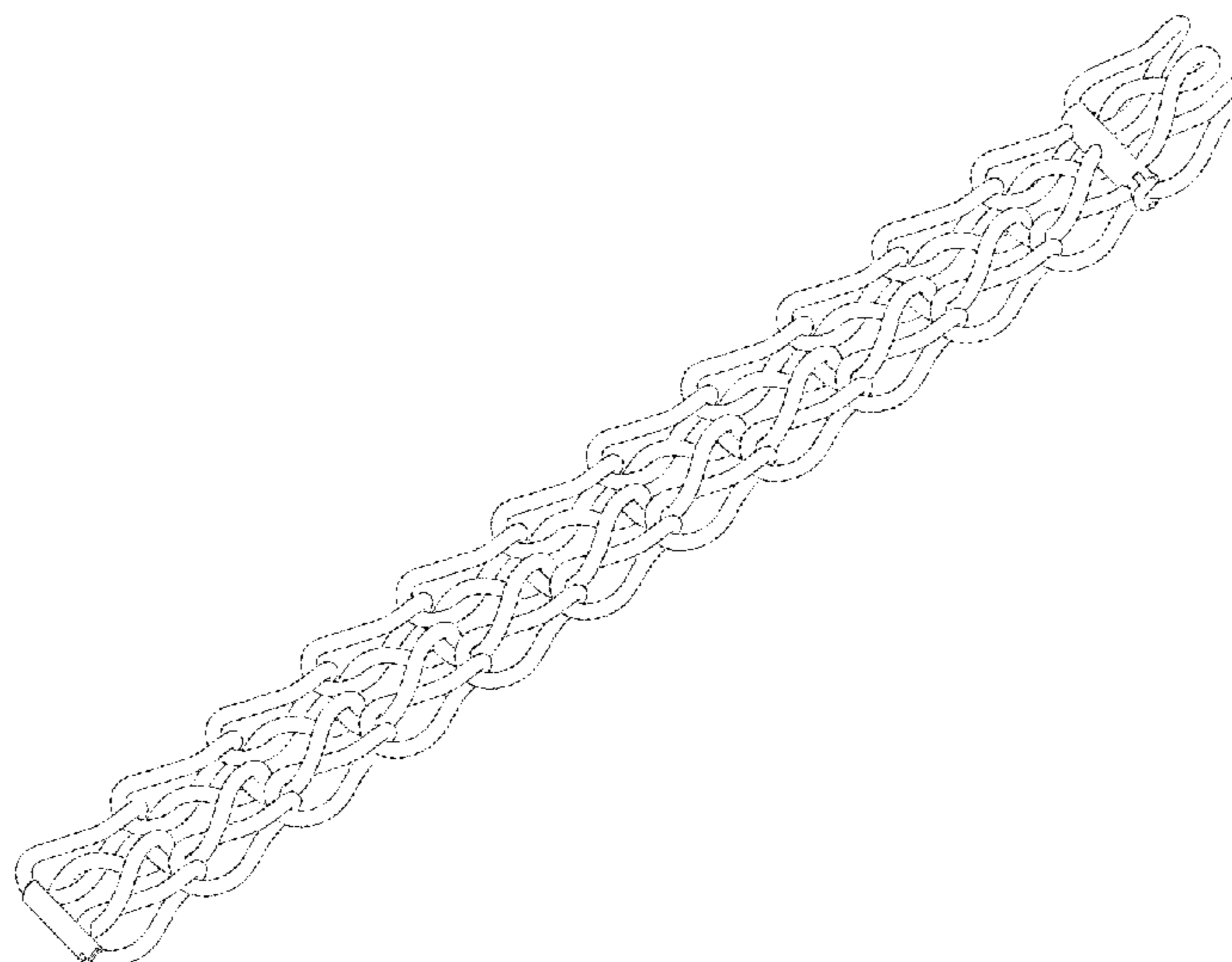
The ornamental design for a bracelet, as shown and described.

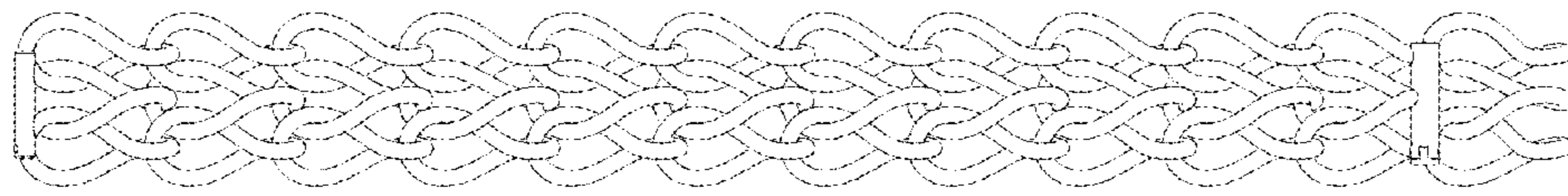

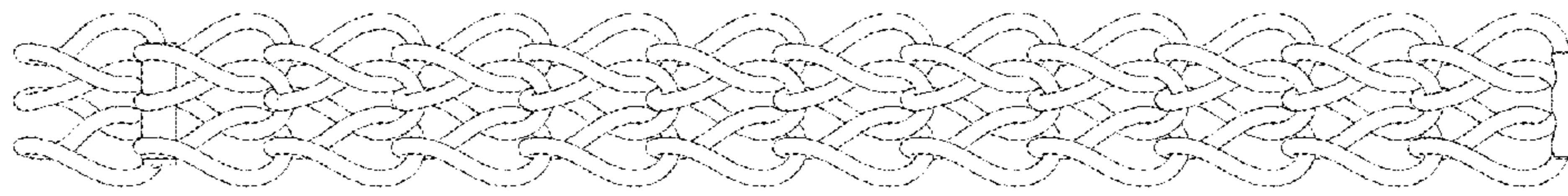

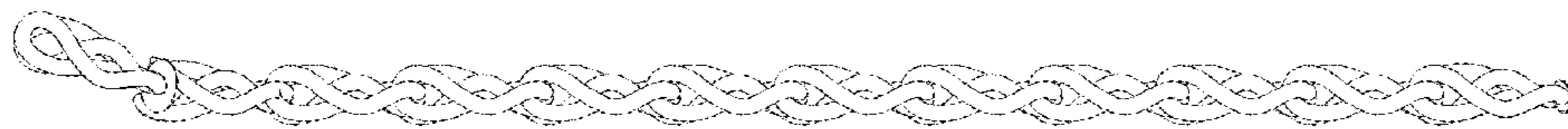

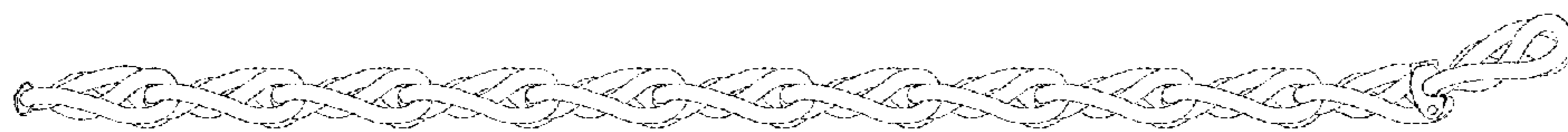

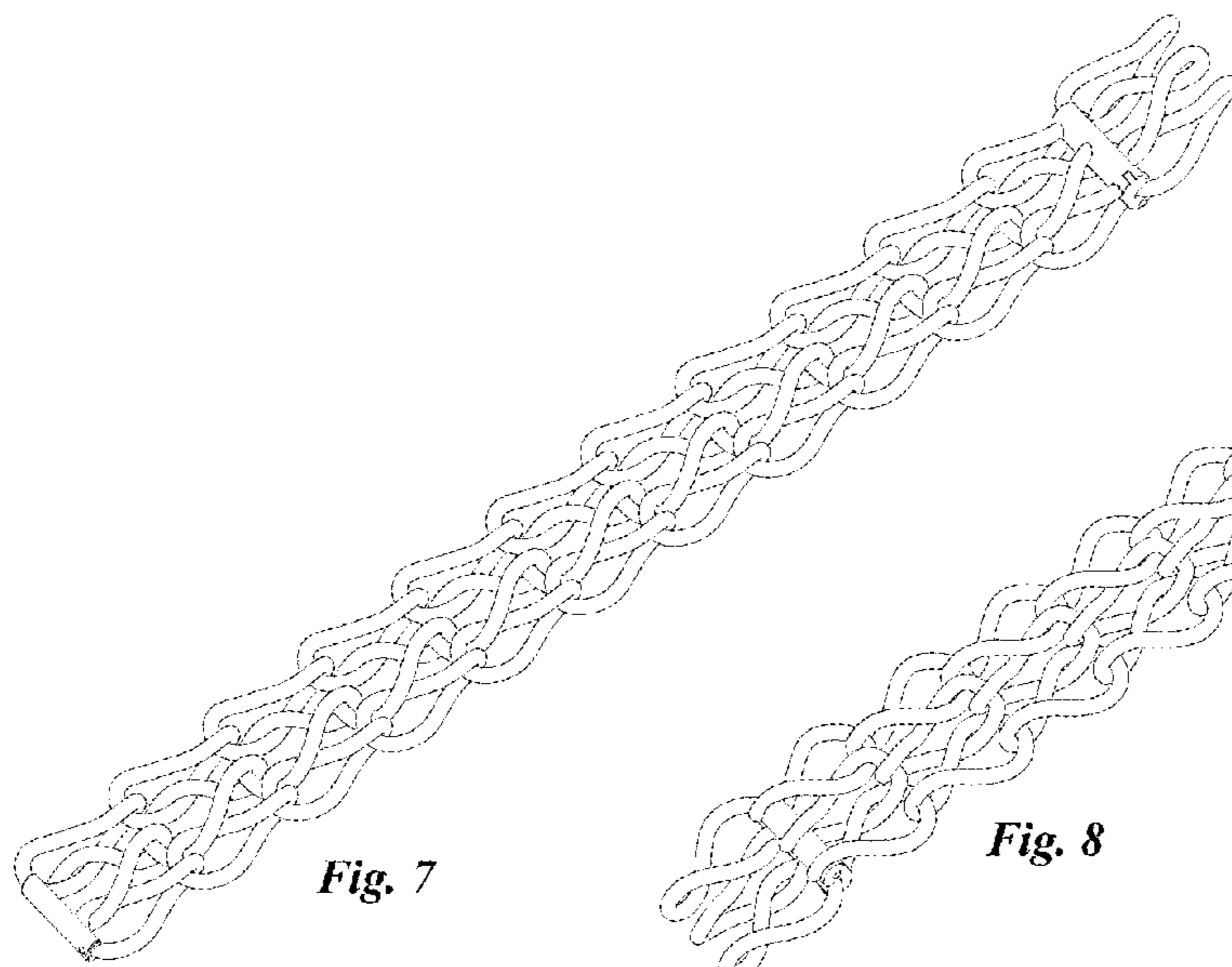

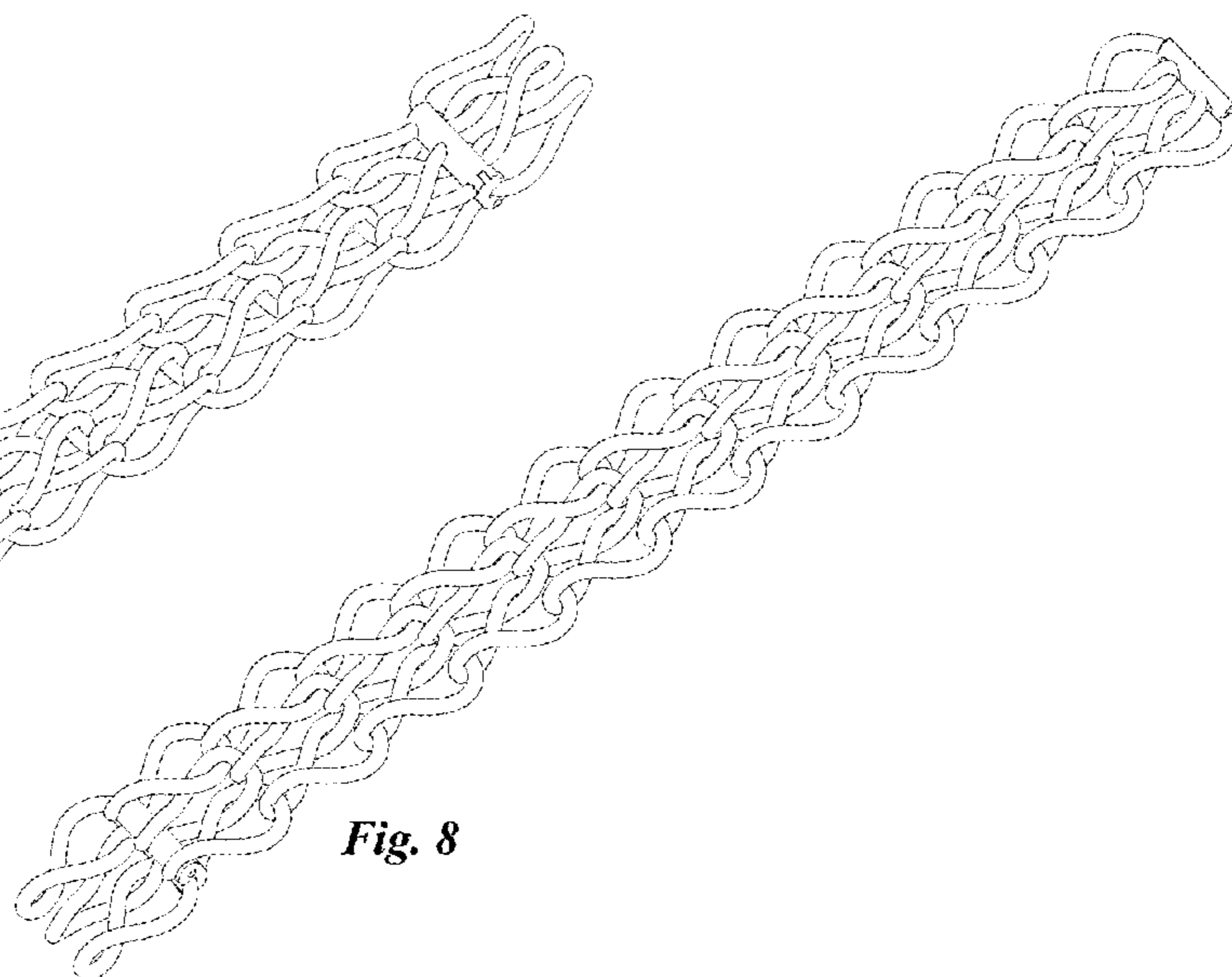
