The ornamental design for a license plate frame with football motif, as shown and described.

FIG. 8 is right side elevation view thereof.

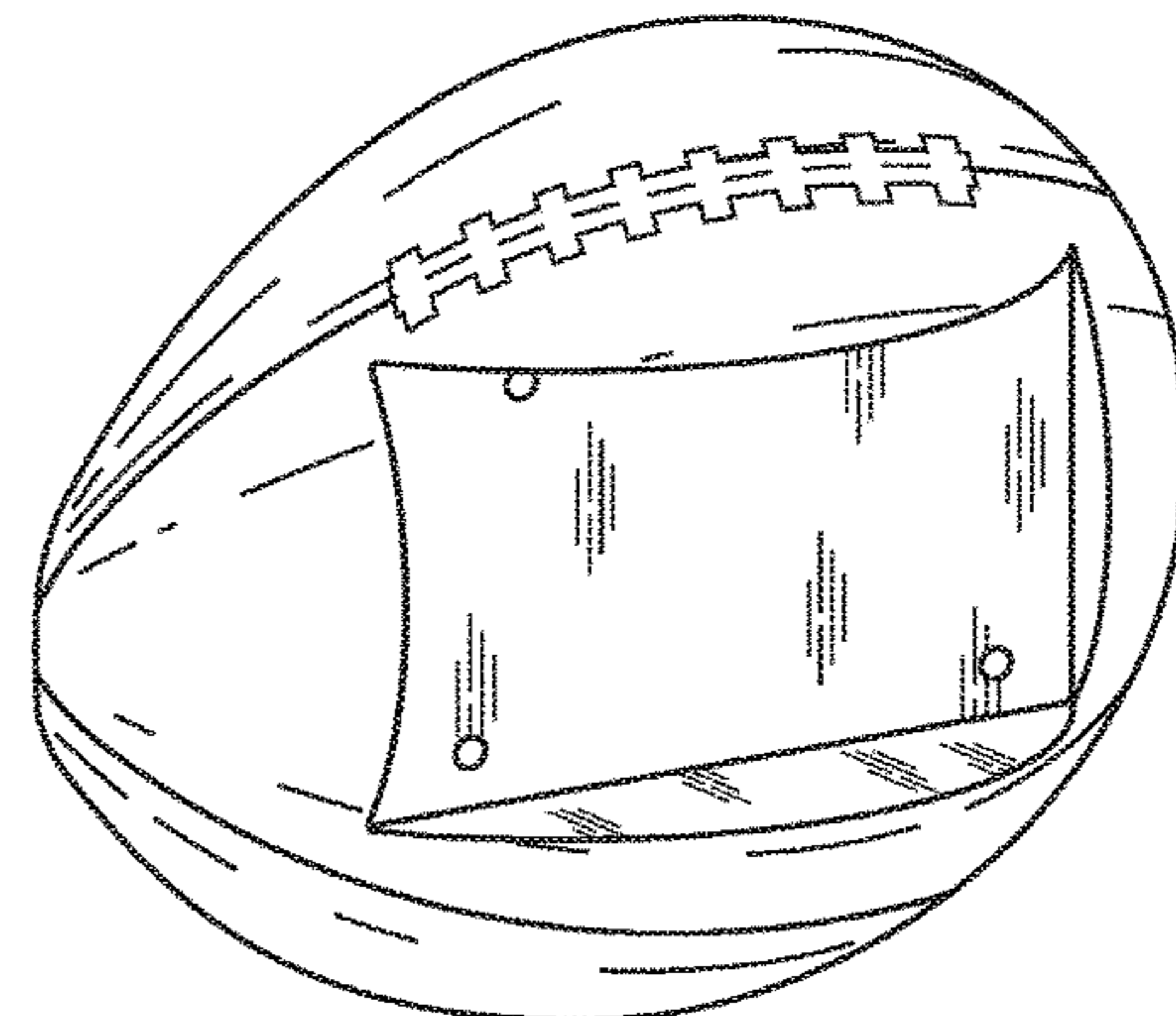
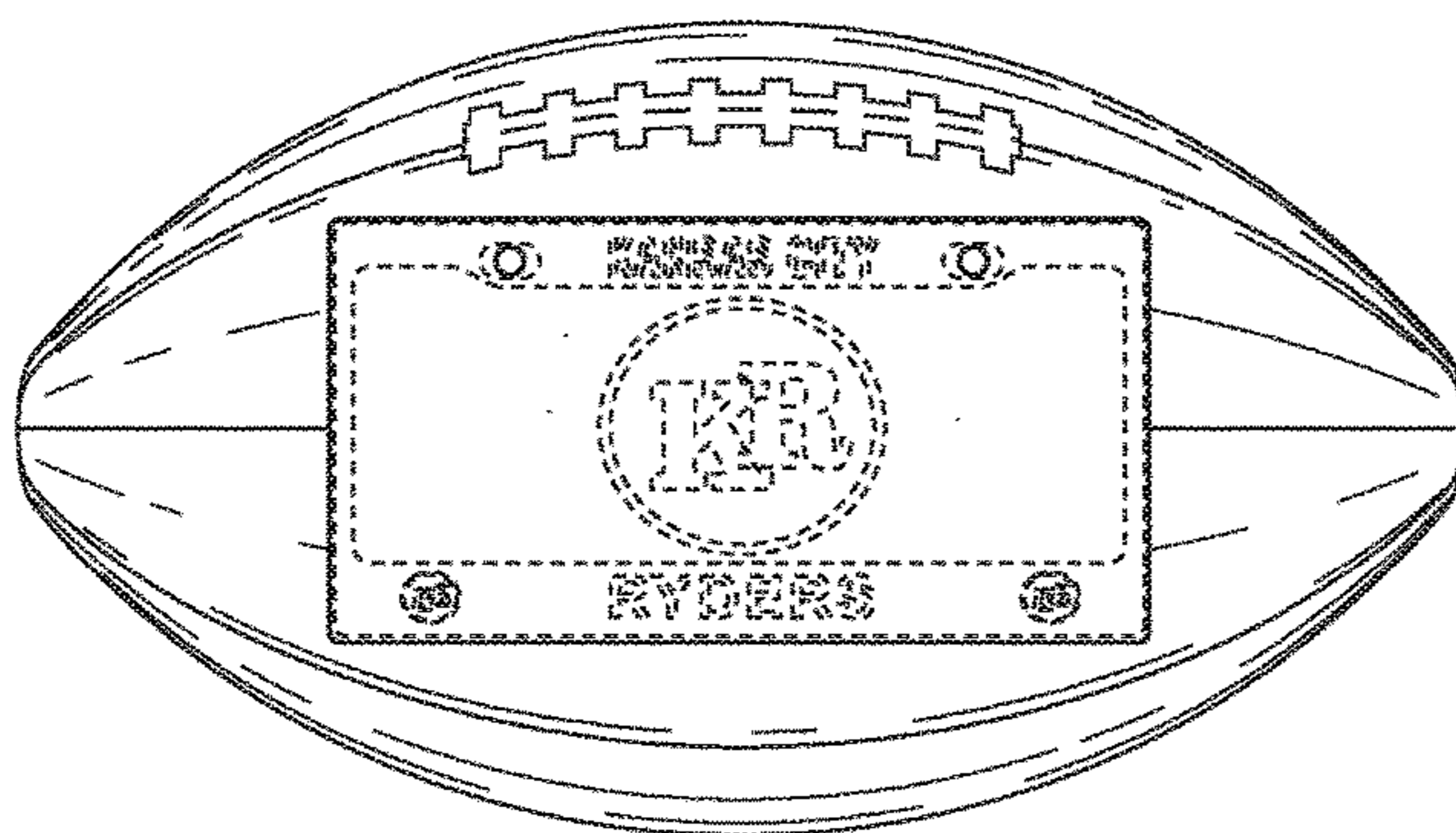
FIG. 9 is a top view thereof; and,

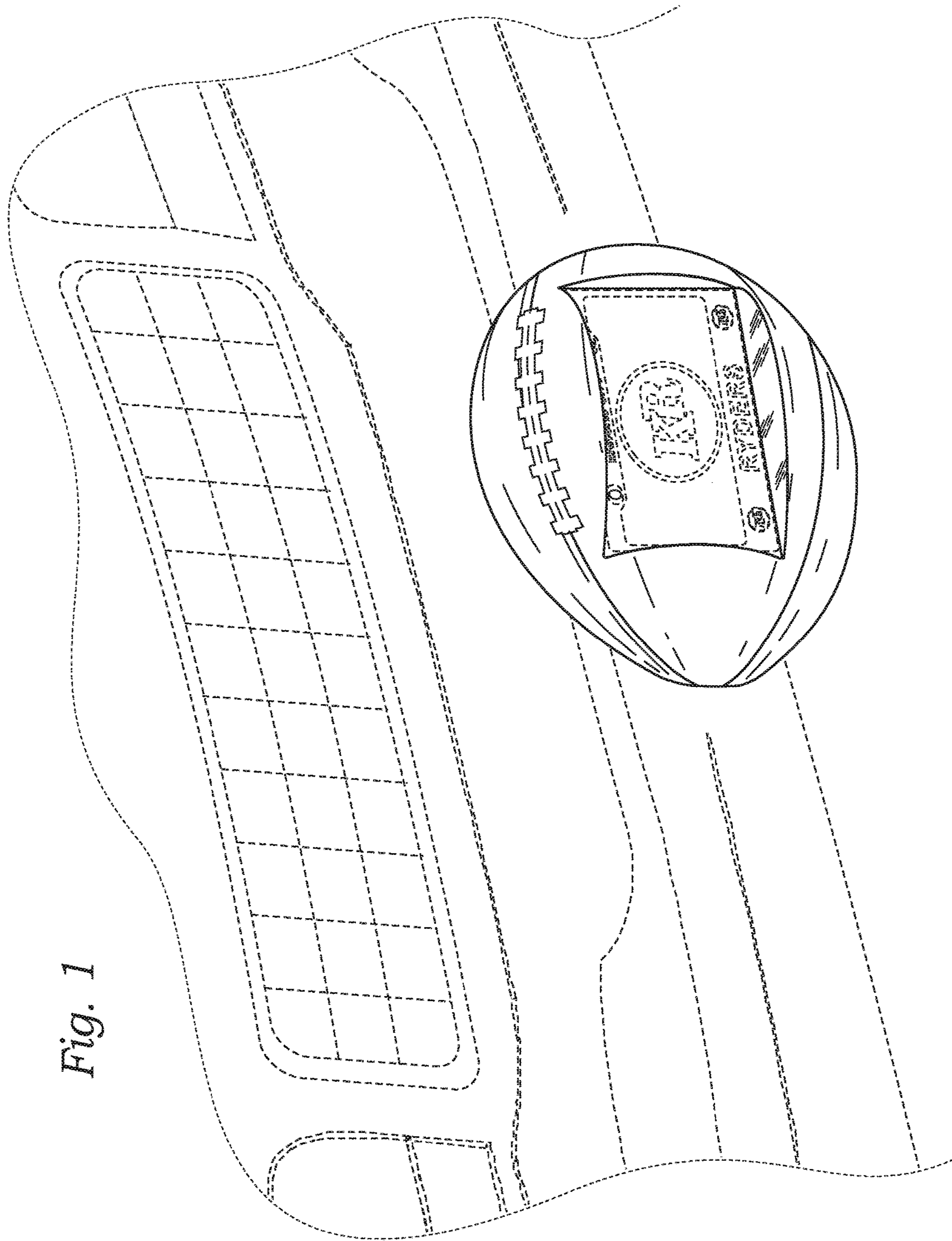
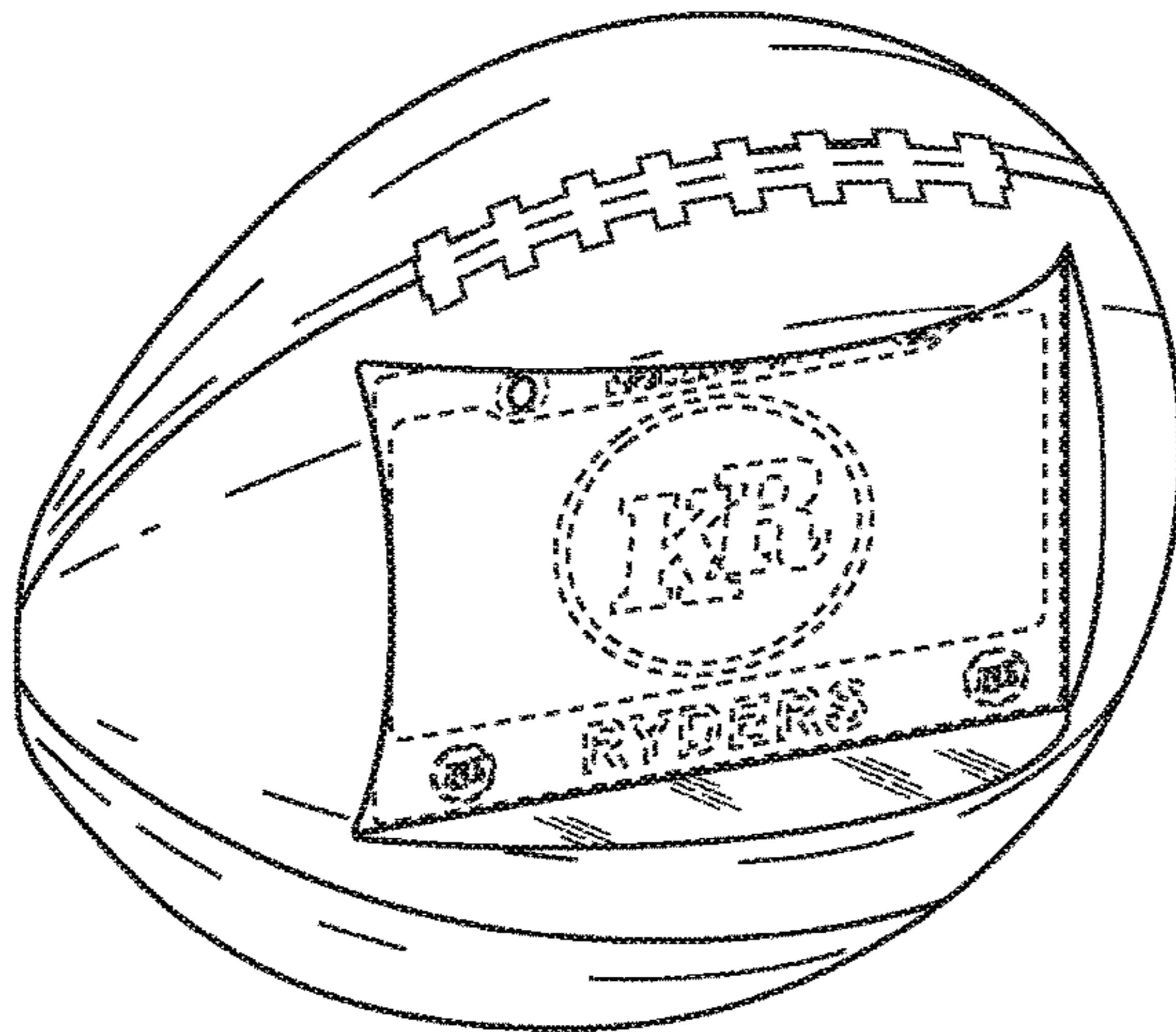


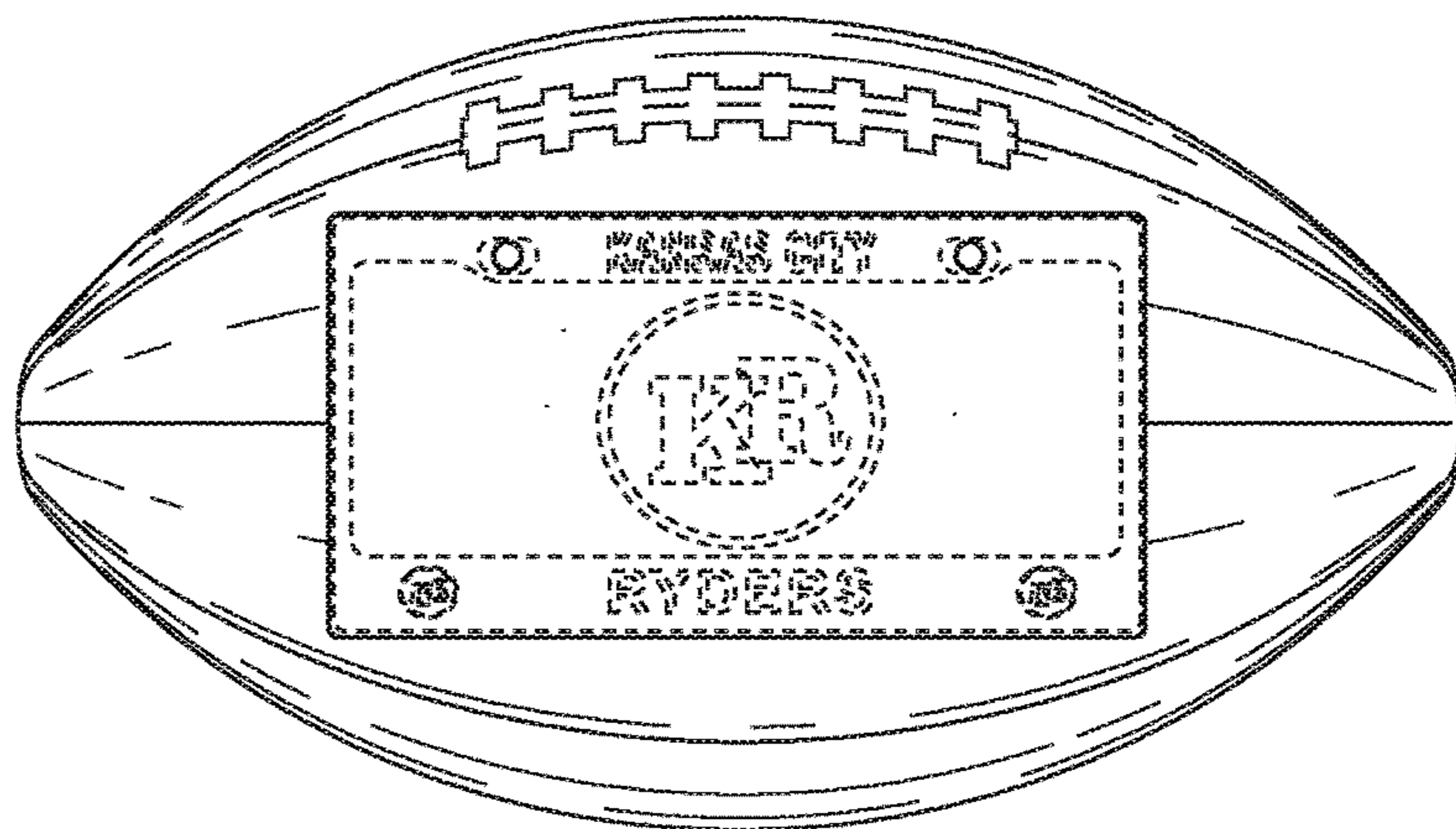

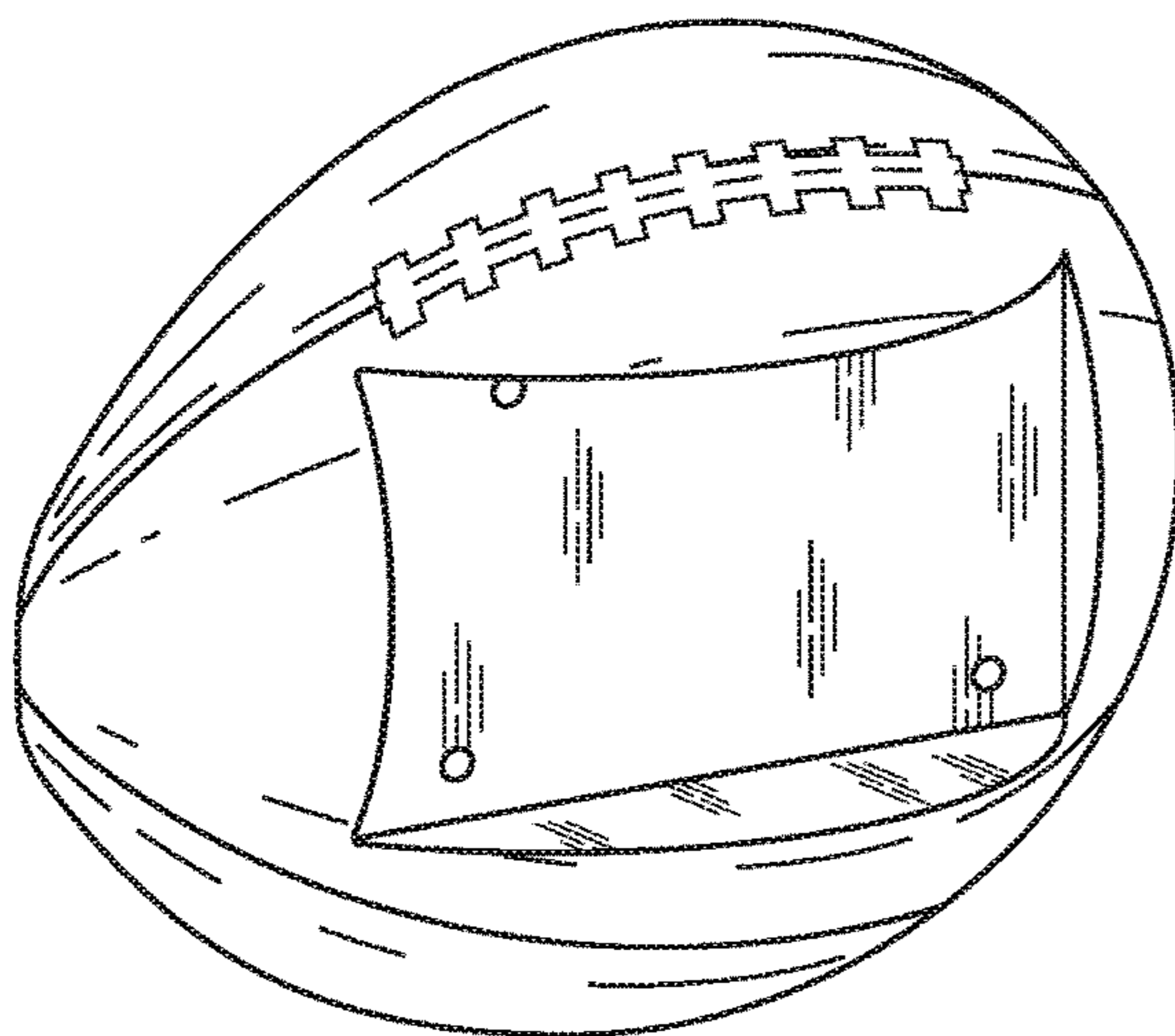

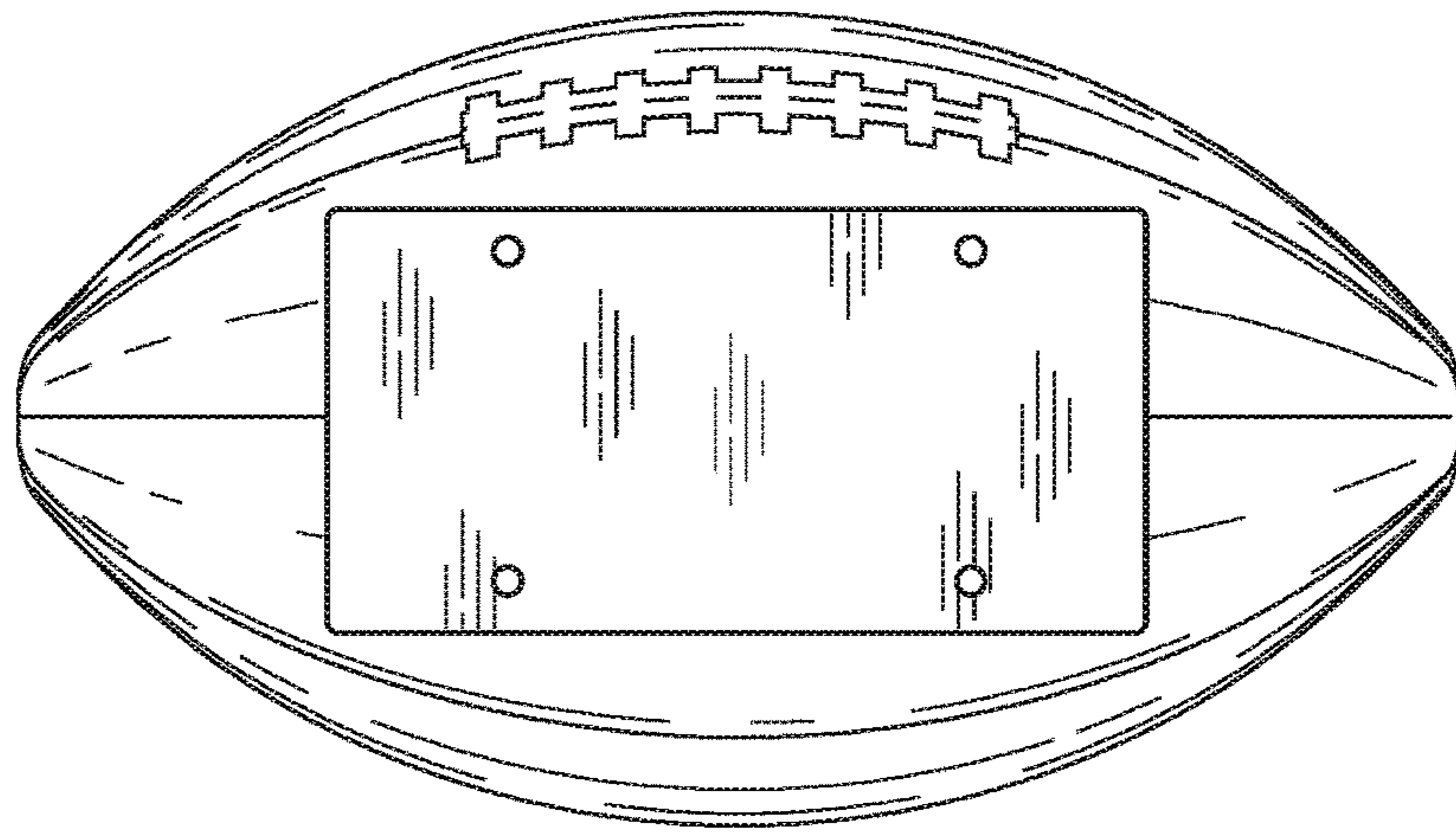

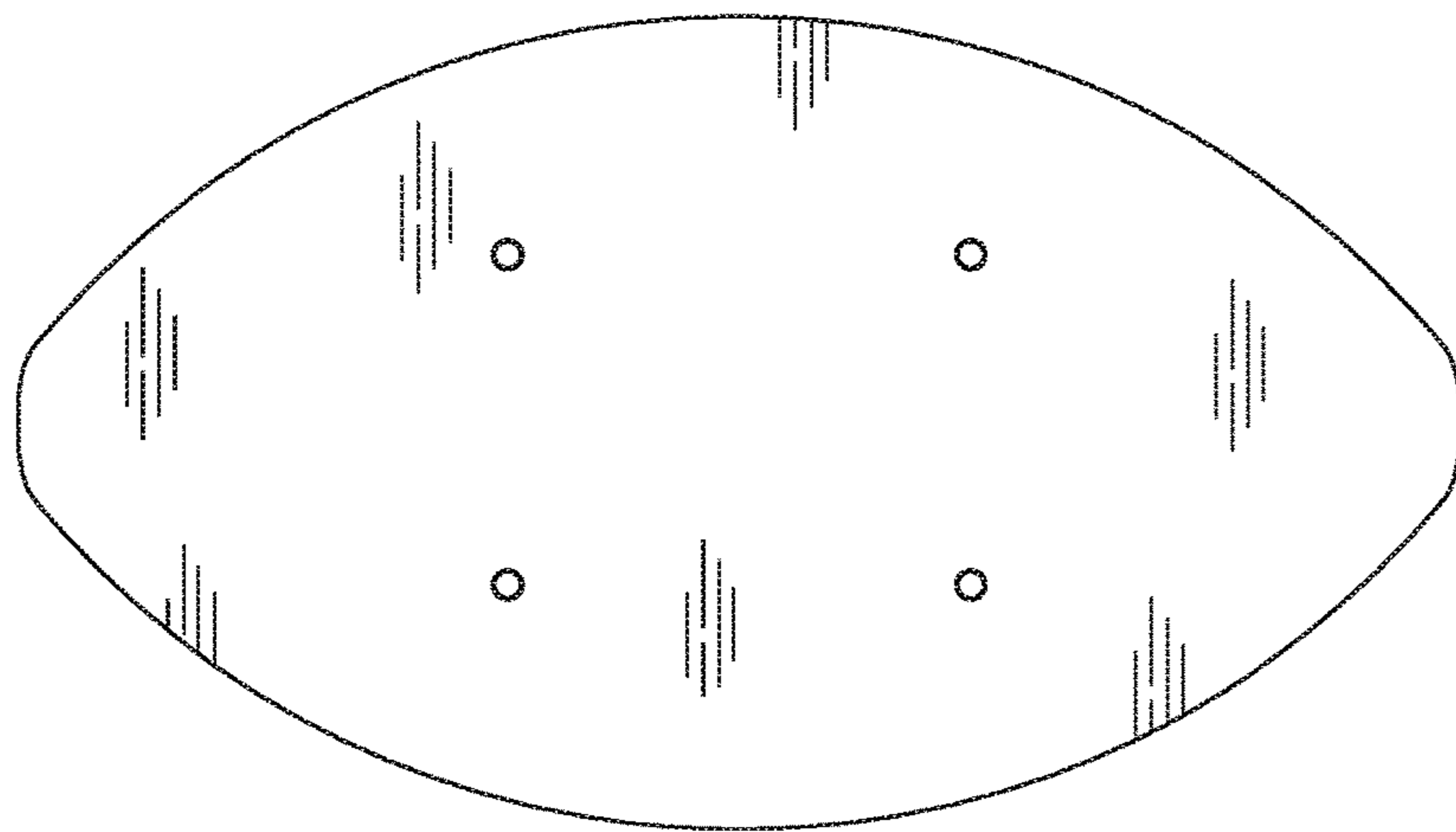

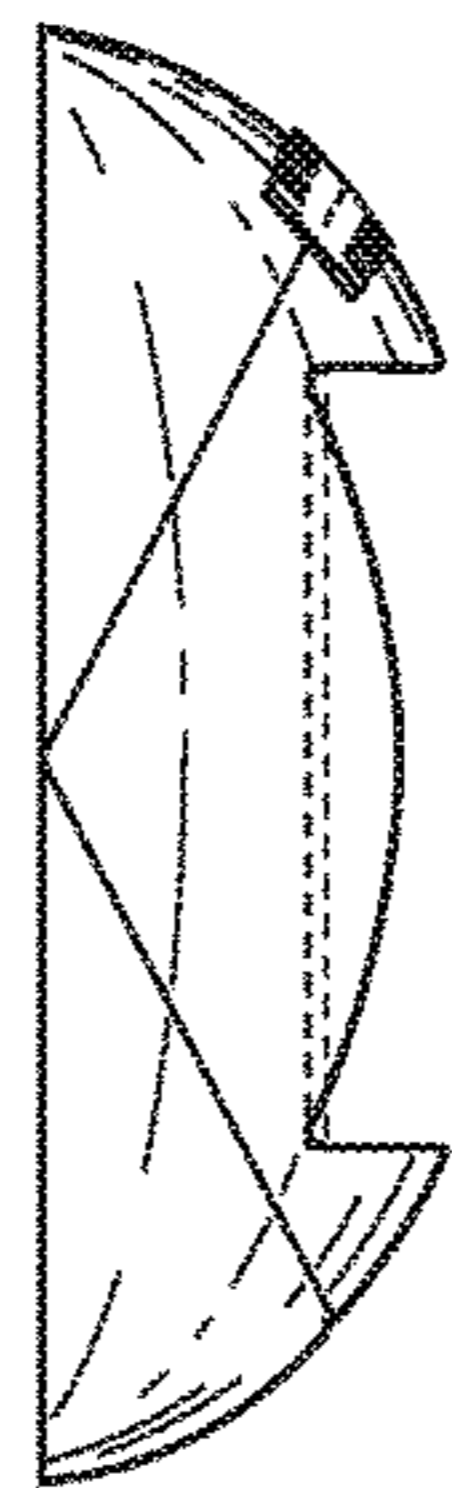

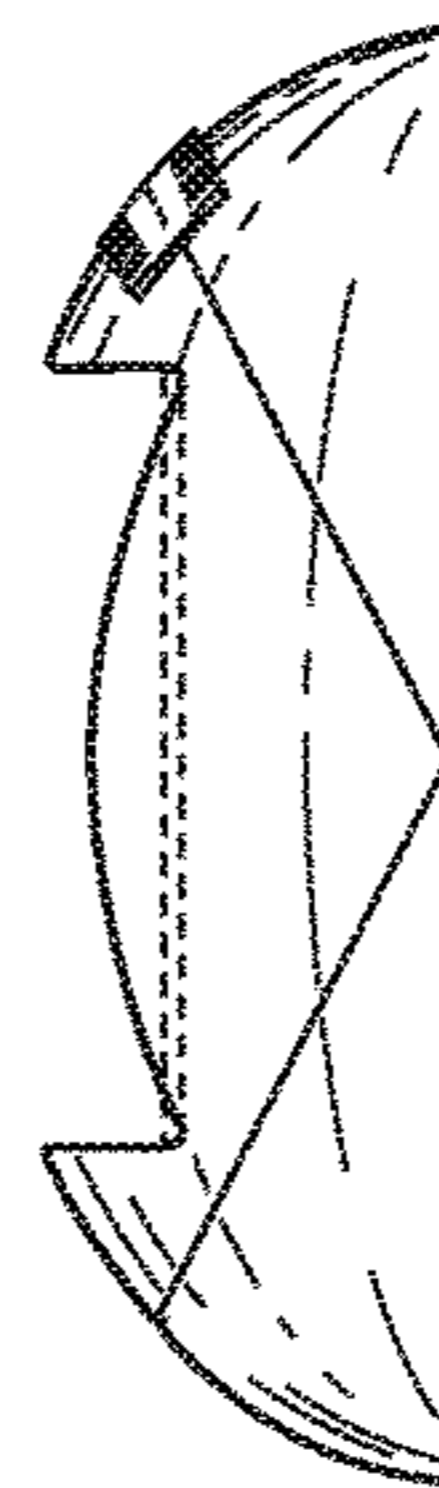
