(57) **CLAIM**

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire showing the claimed design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top plan view thereof, the bottom plan view being the same;

FIG. 5 is a right side view thereof

FIG. 6 is a left side view thereof;

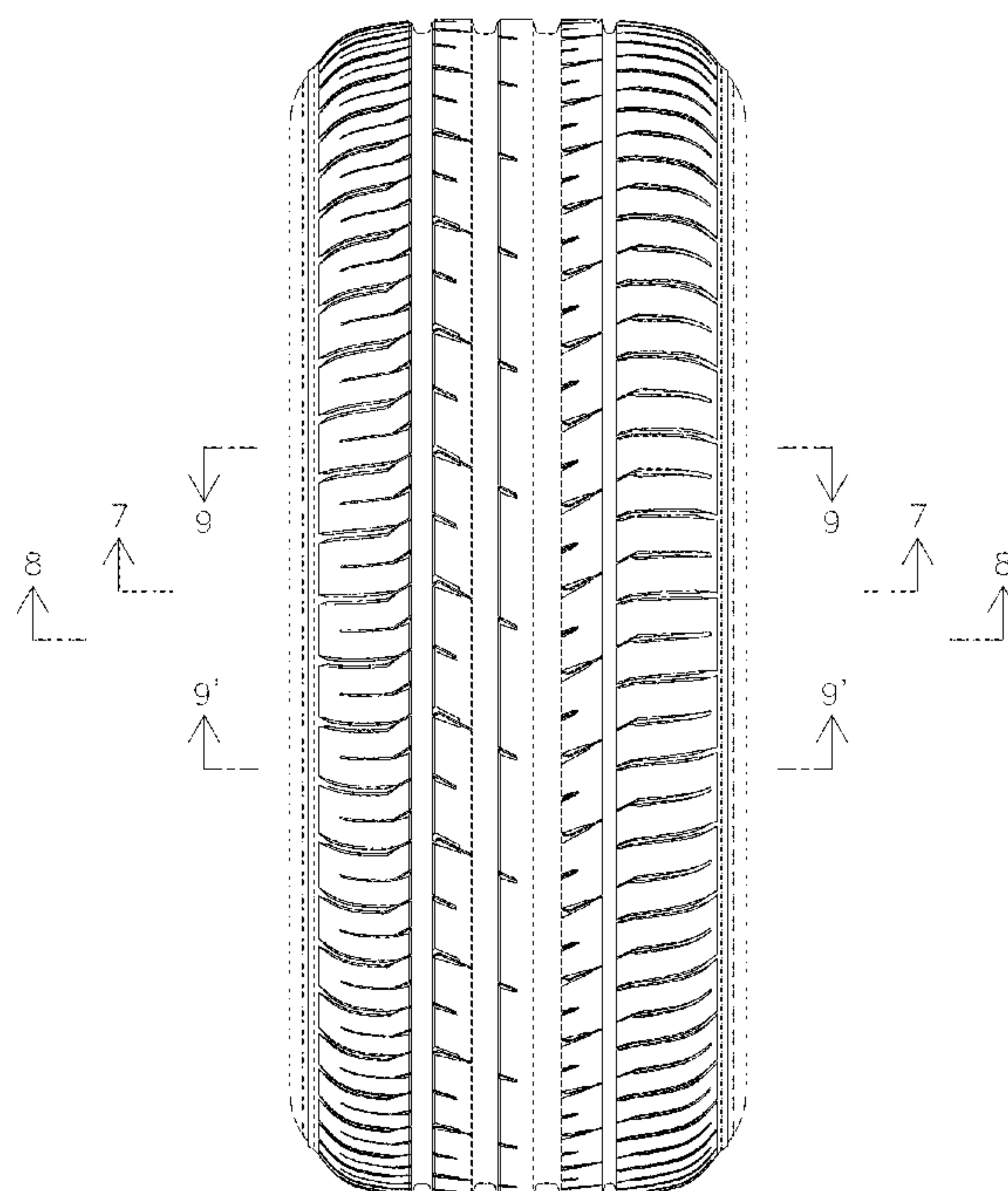
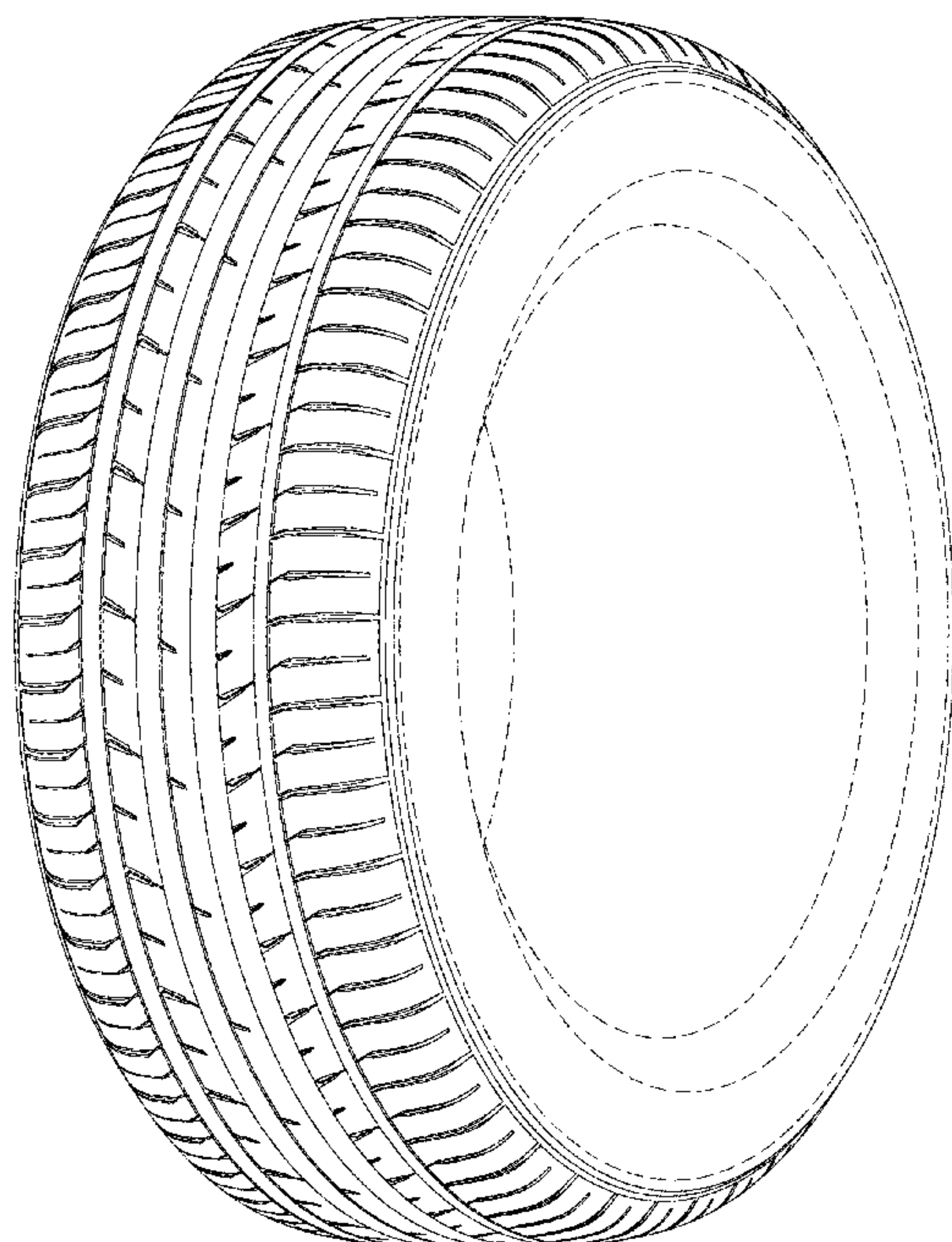
FIG. 7 is an enlarged cross-sectional view taken along line 7-7 in FIG. 2 to line 7'-7' in FIG. 5;

FIG. 9 is an enlarged view of the portion between 9-9 and 9'-9' in FIG. 2.

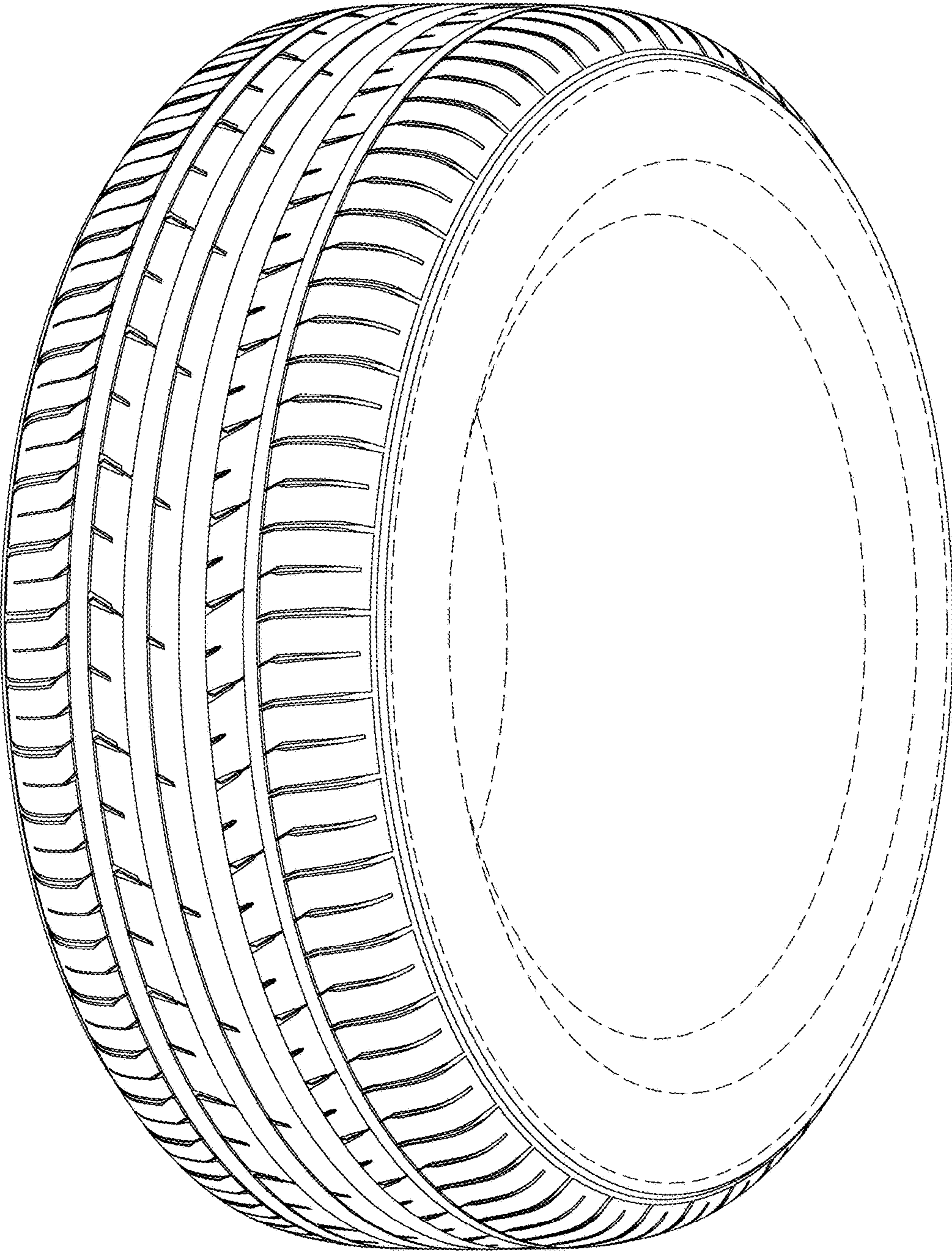

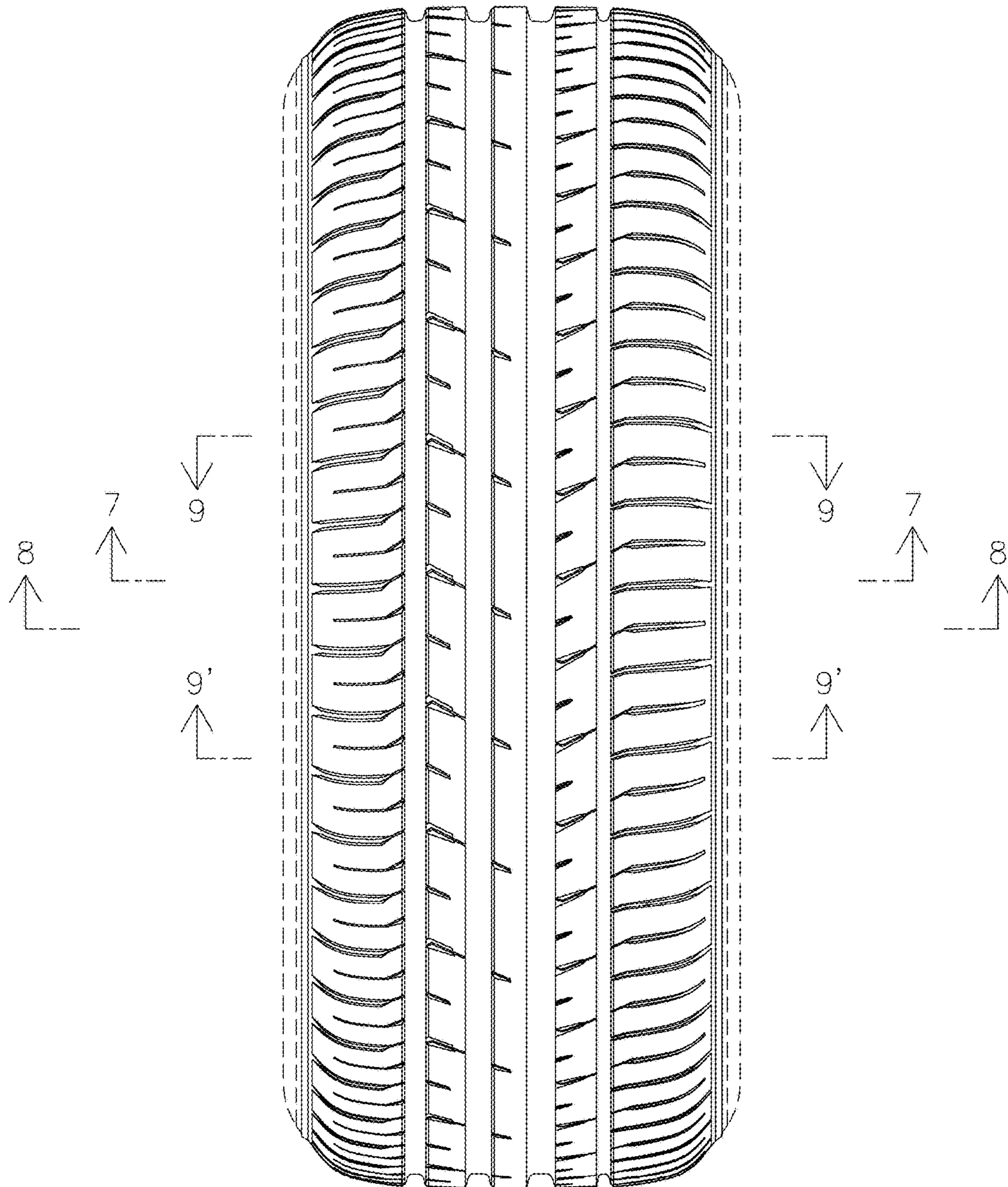

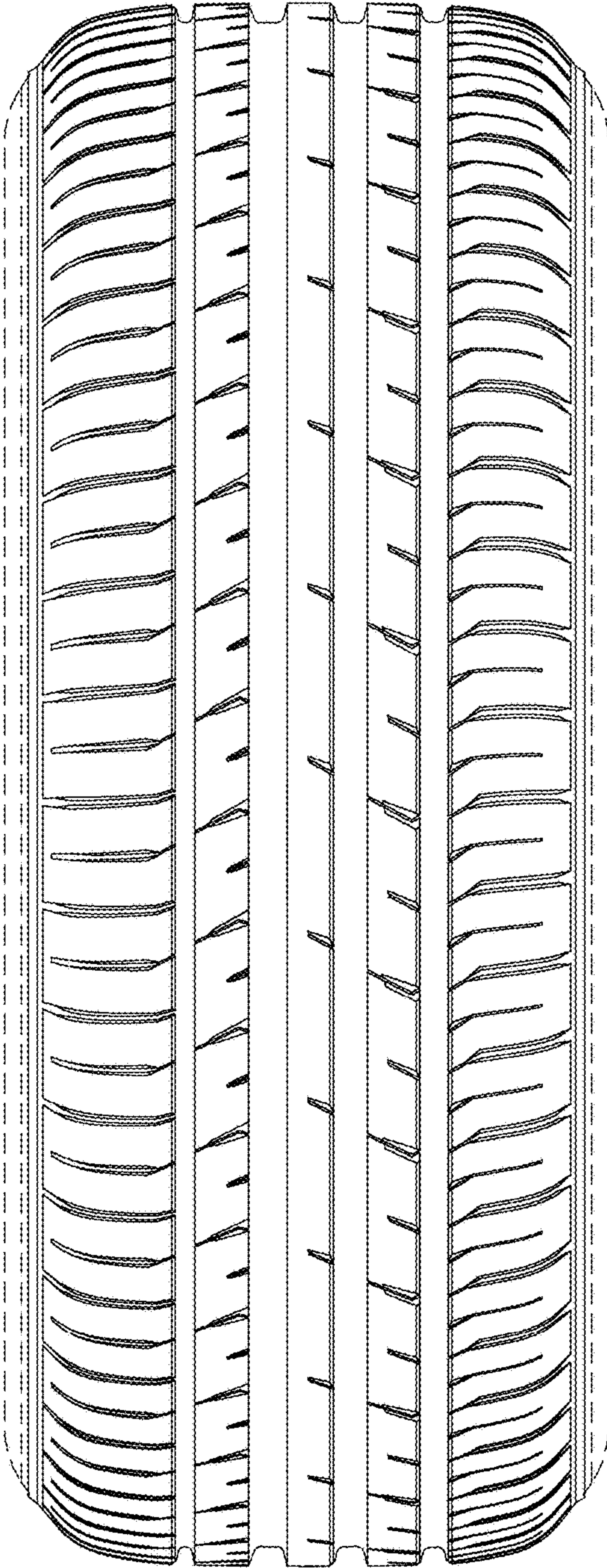

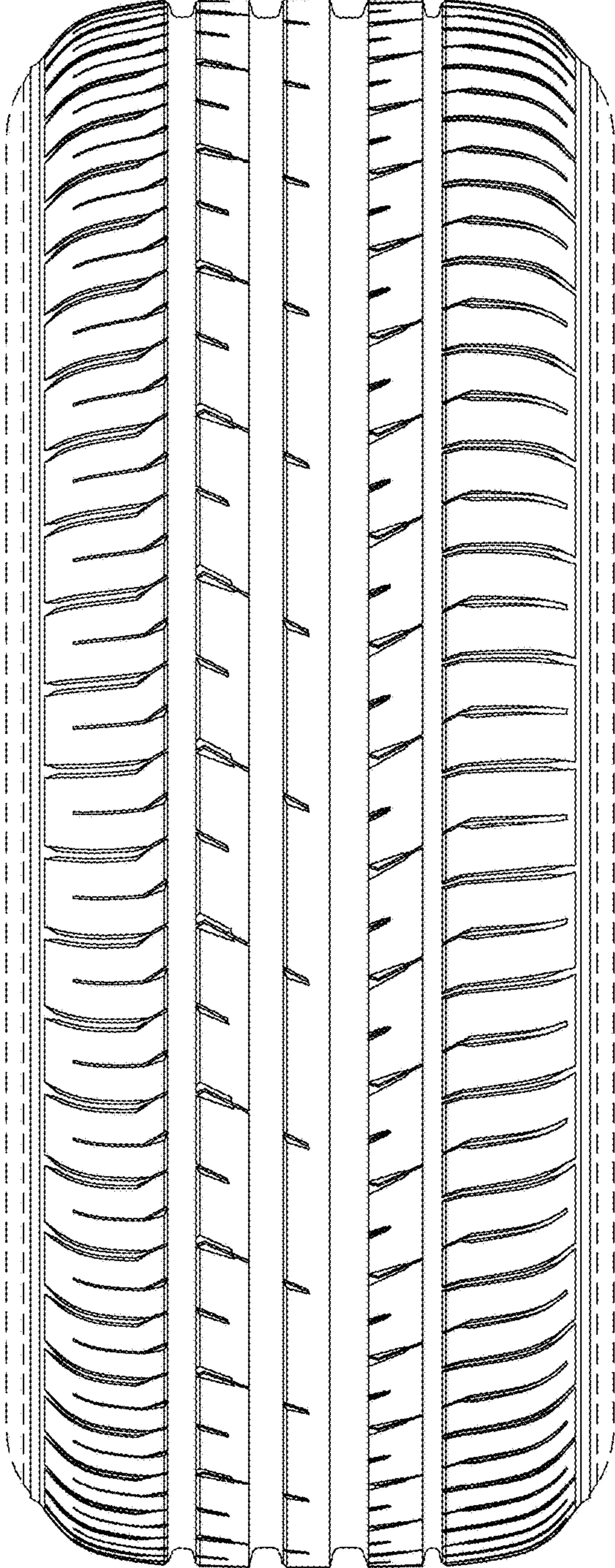

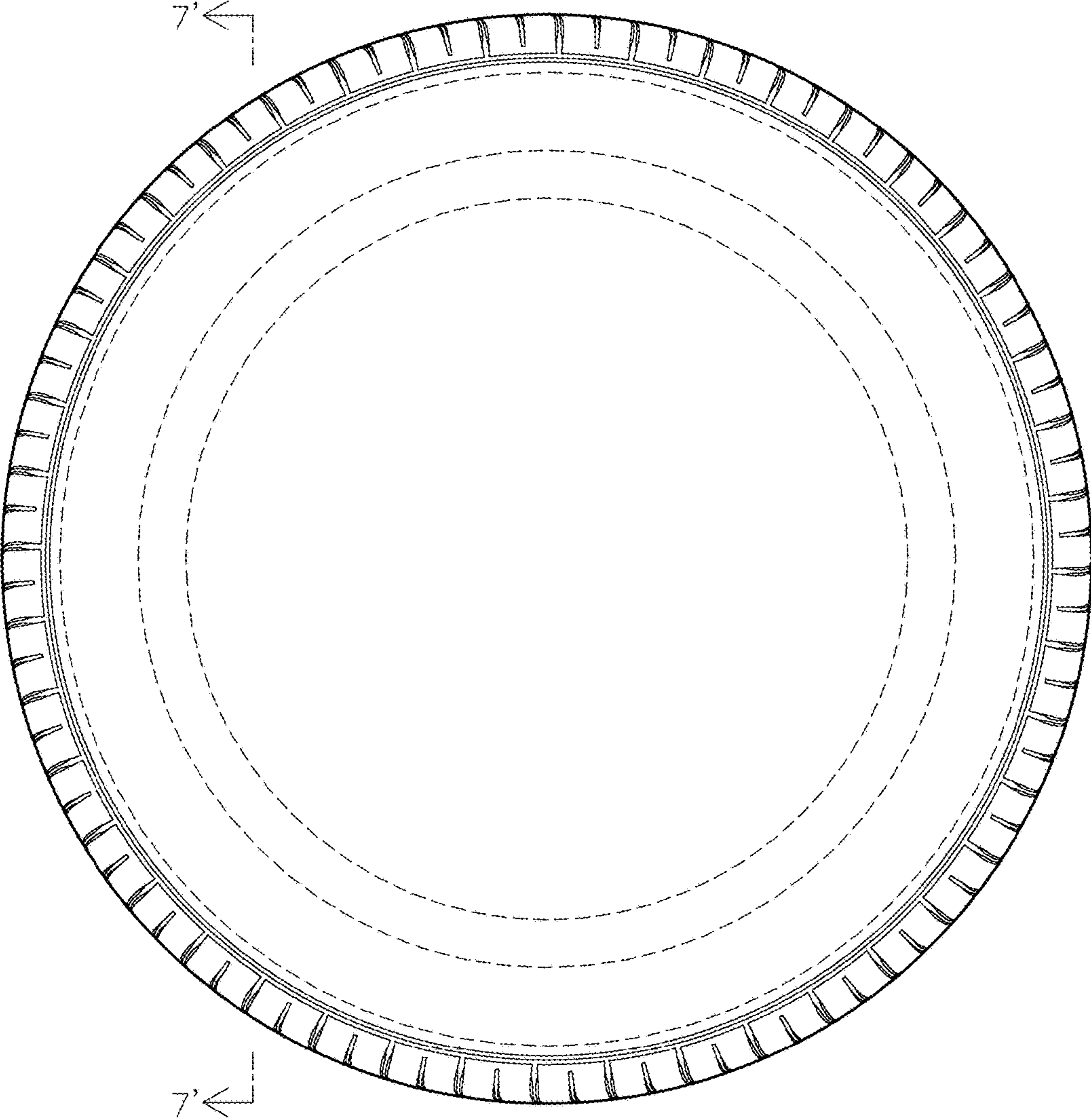

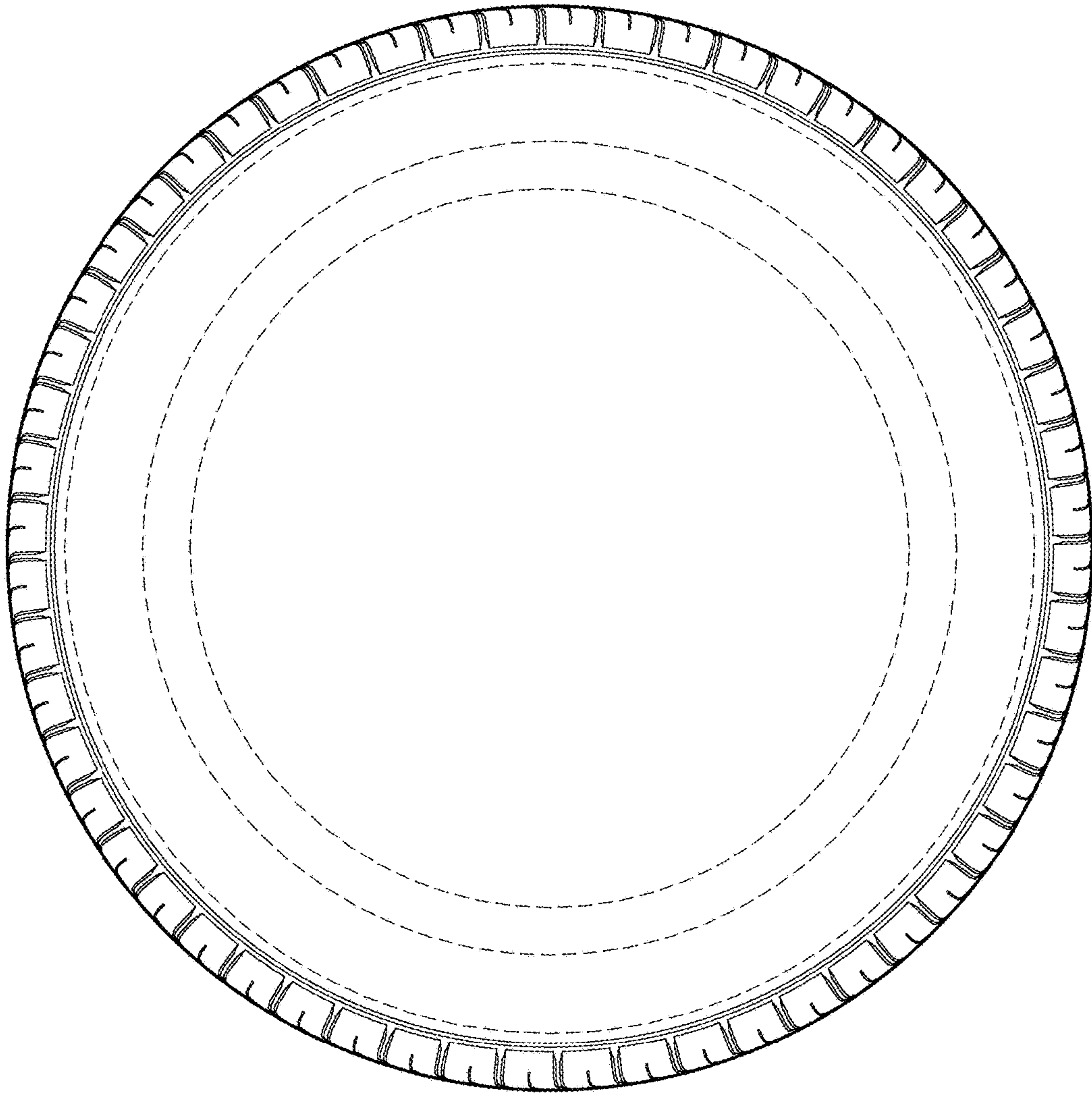

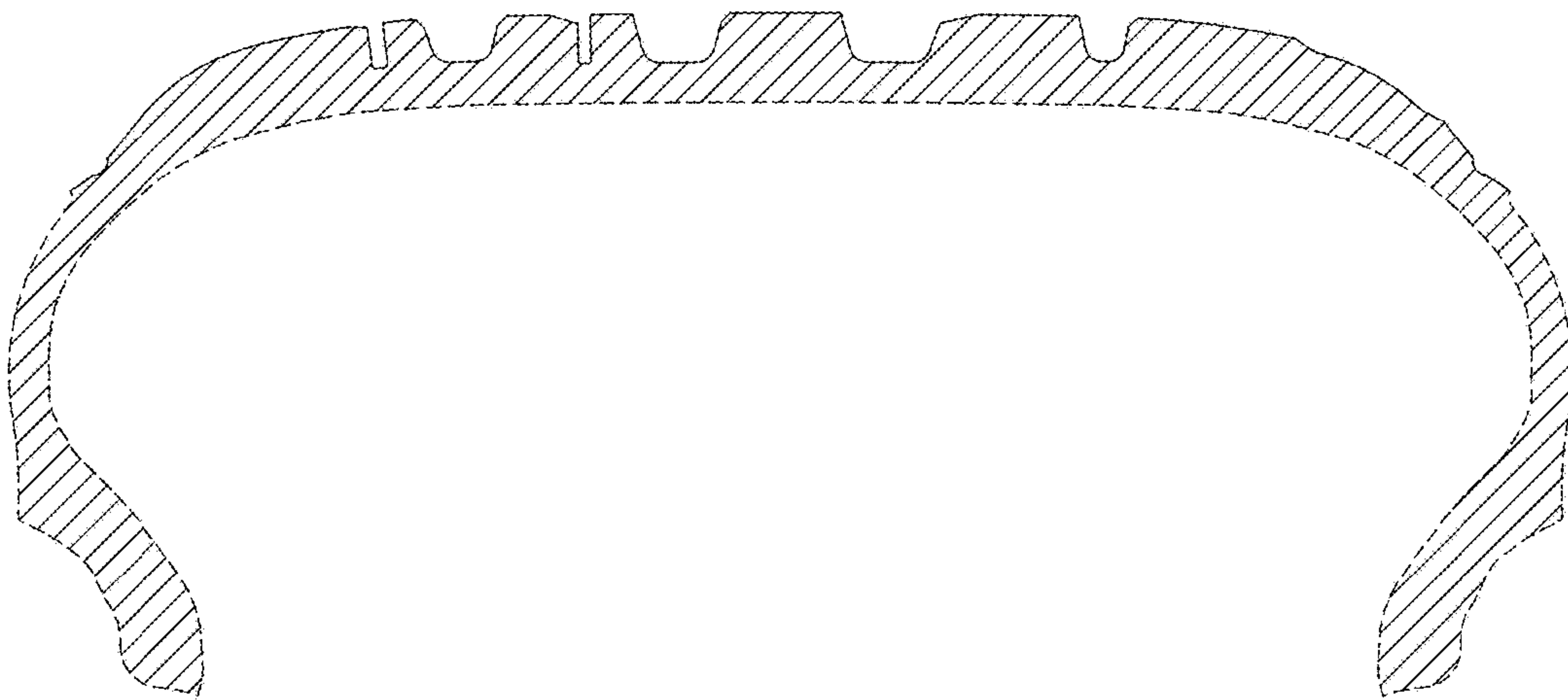

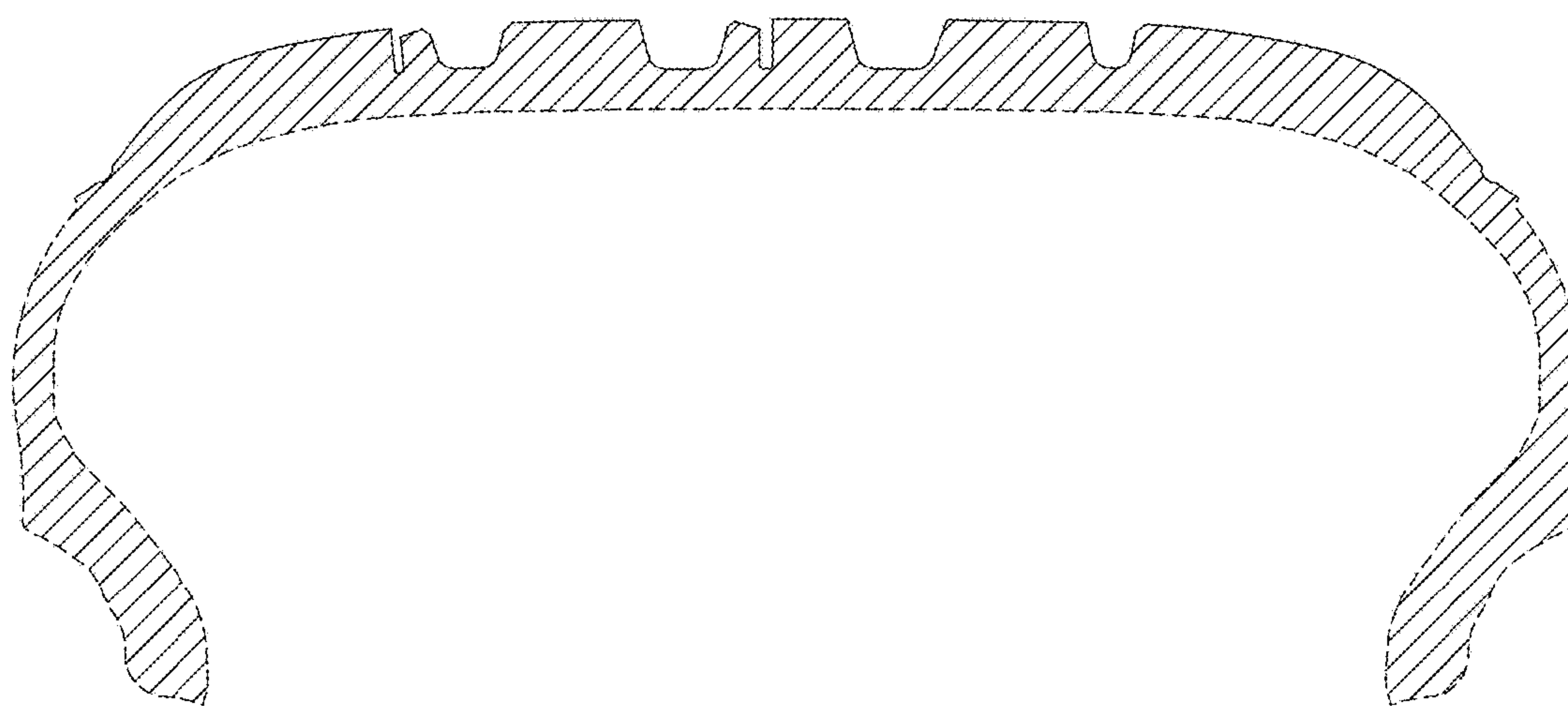

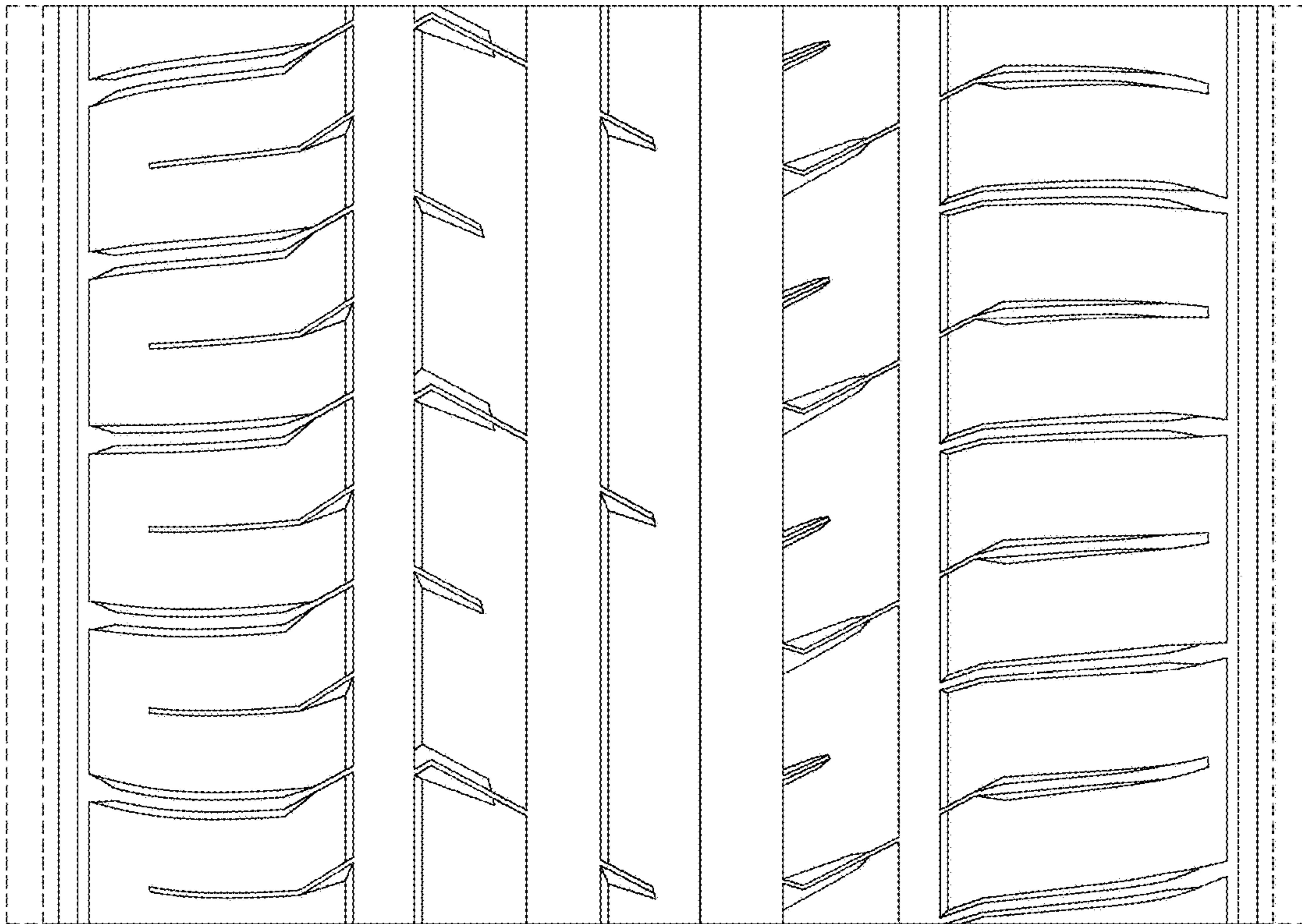
