The ornamental design for a low profile set-top box enclosure, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the low profile set-top box enclosure.

FIG. 2 is a front elevation view of the low profile set-top box enclosure.

FIG. 3 is a left side elevation view of the low profile set-top box enclosure.

FIG. 4 is a right side elevation view of the low profile set-top box enclosure.

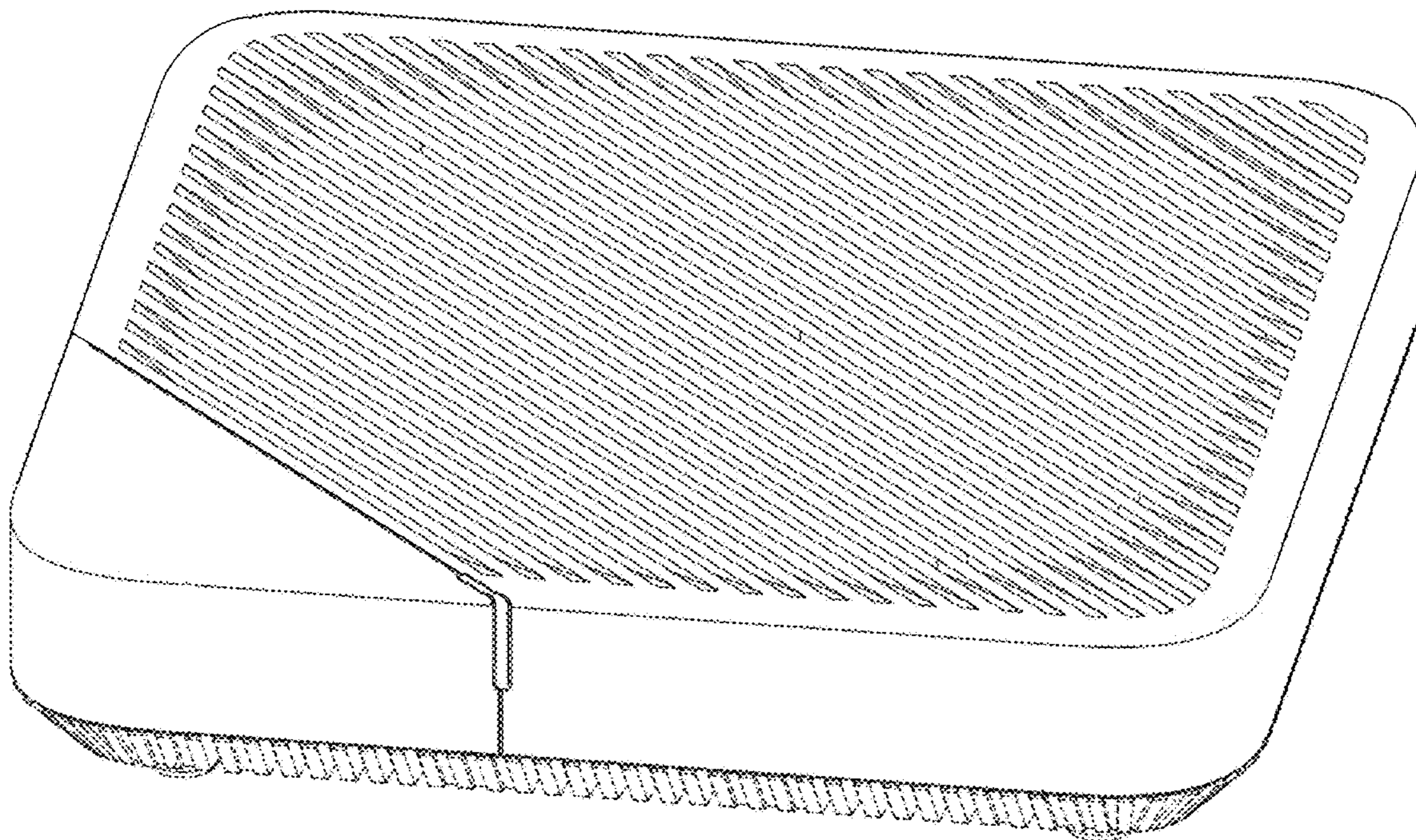
FIG. 5 is a rear elevation view of the low profile set-top box enclosure.

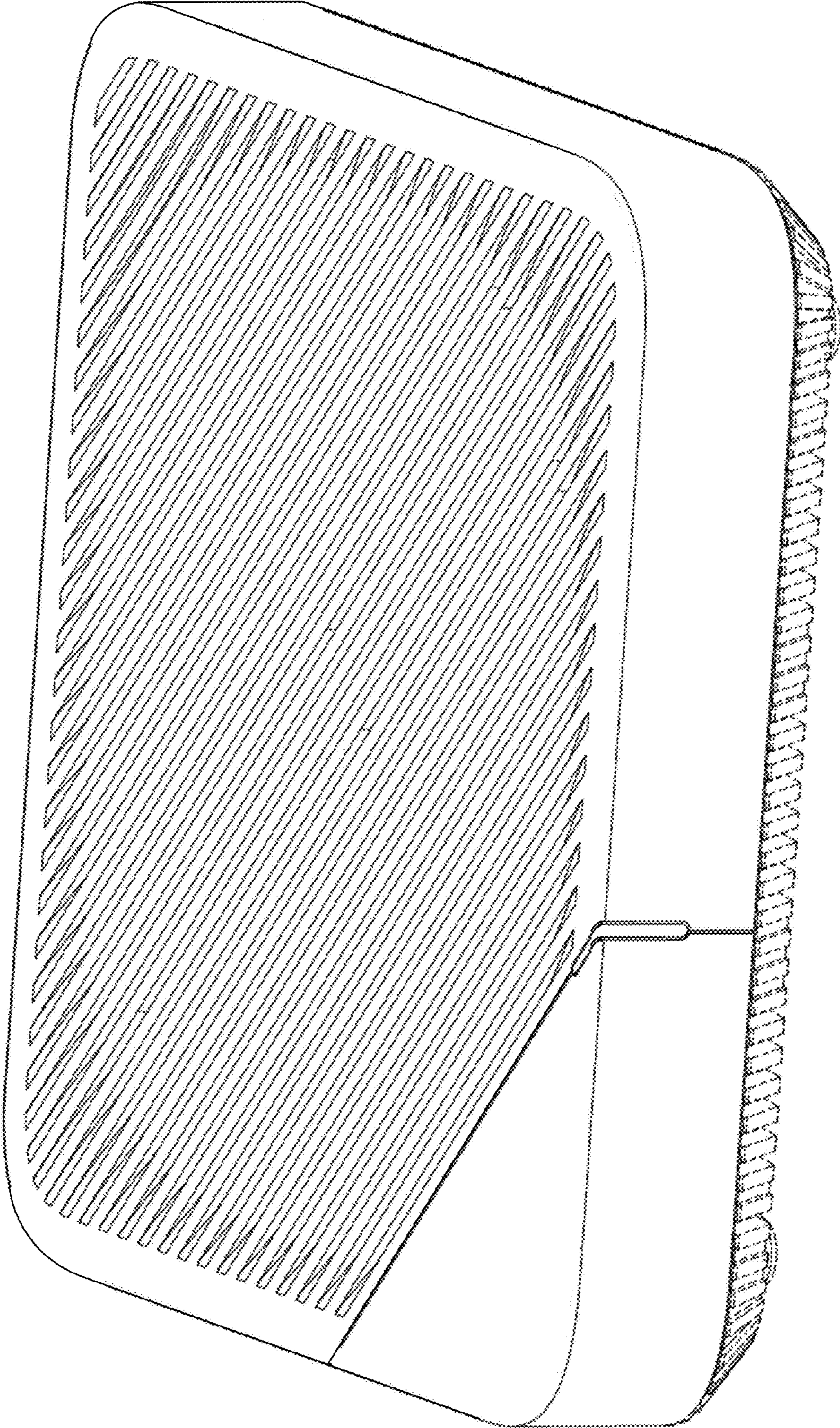

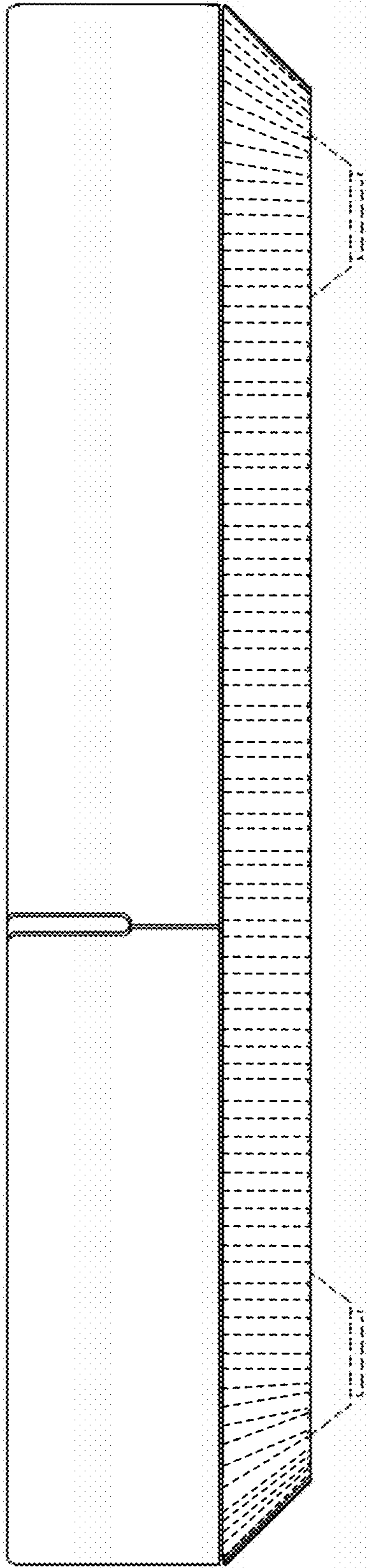

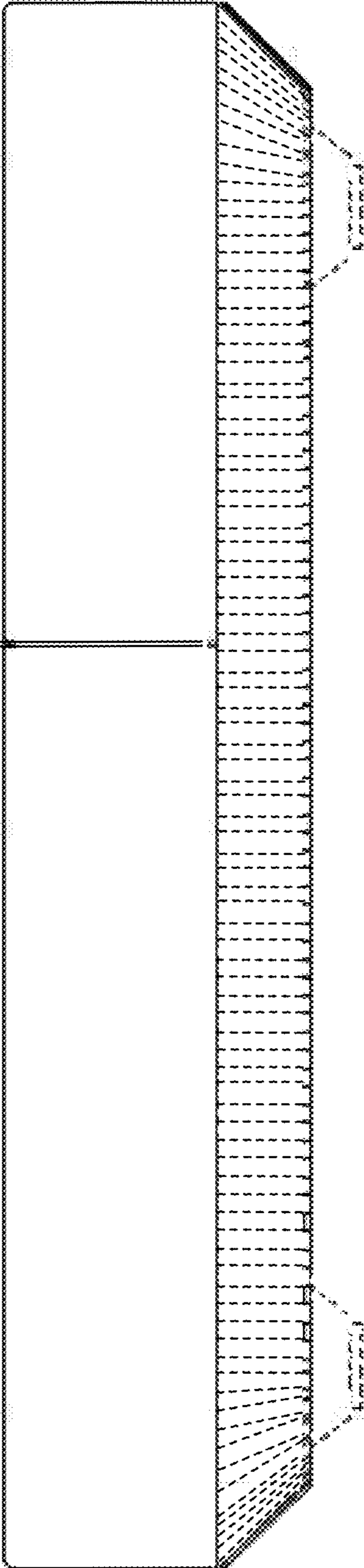

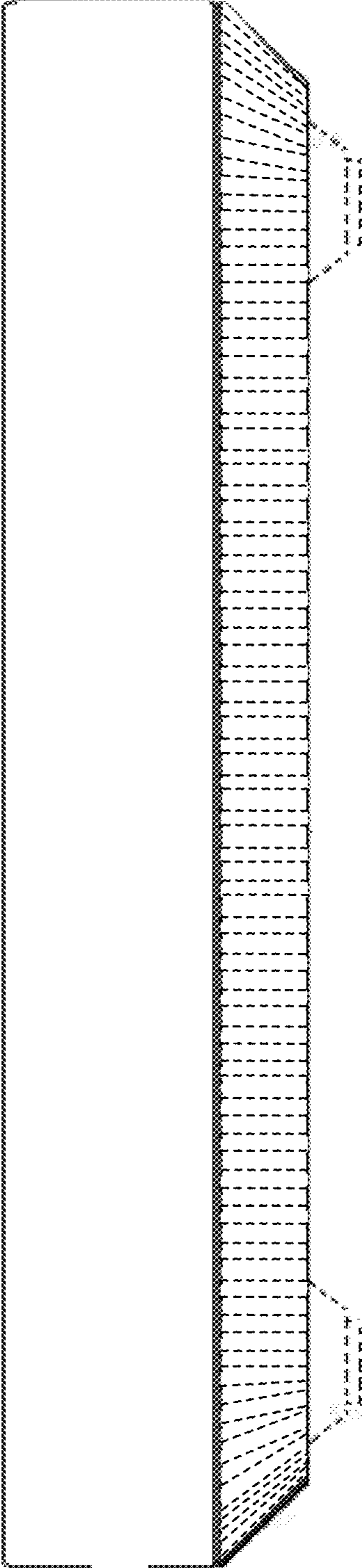

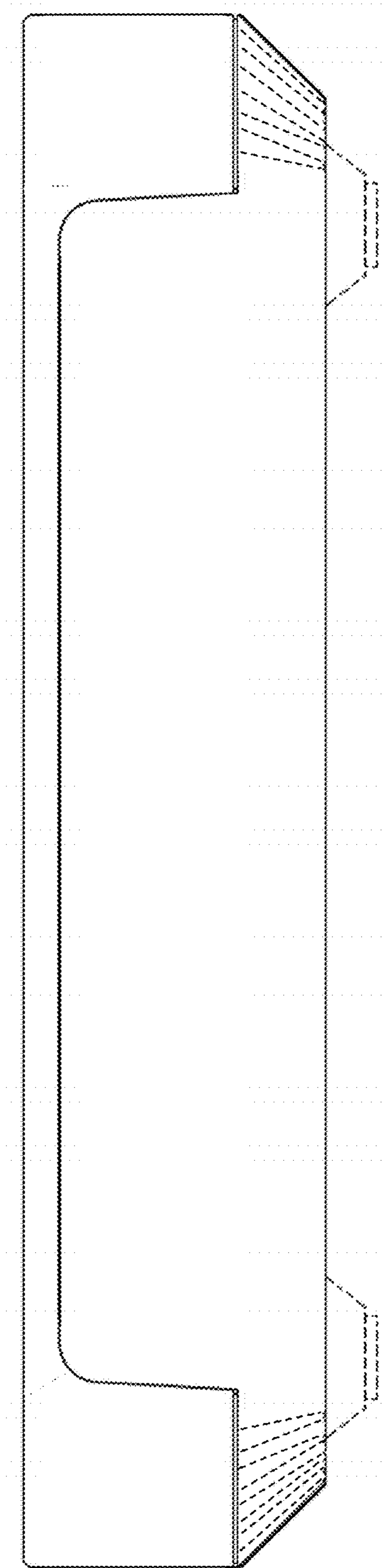

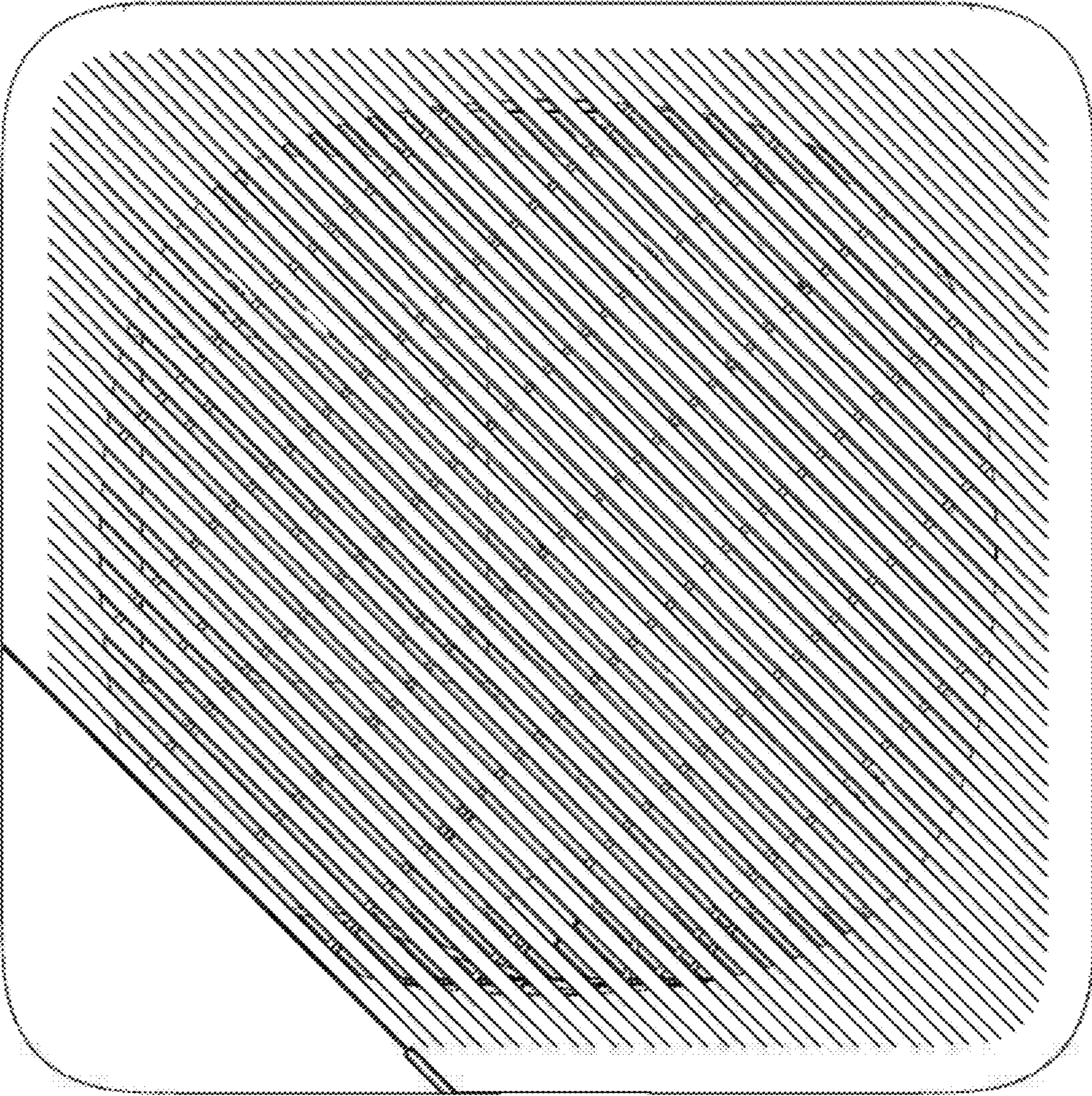

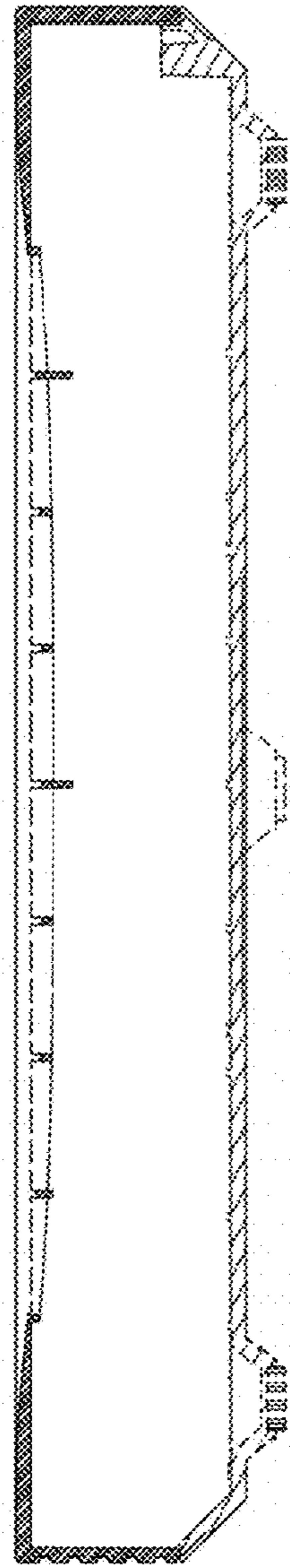
