FIG. 14 is another left side view thereof, showing one earphone body combined with the other earphone body; and,
FIG. 15 is a reference view thereof, showing a state that a woman puts the combined earphones around her neck.
The broken lines in all the drawings depict environment that forms no part of the claimed design.

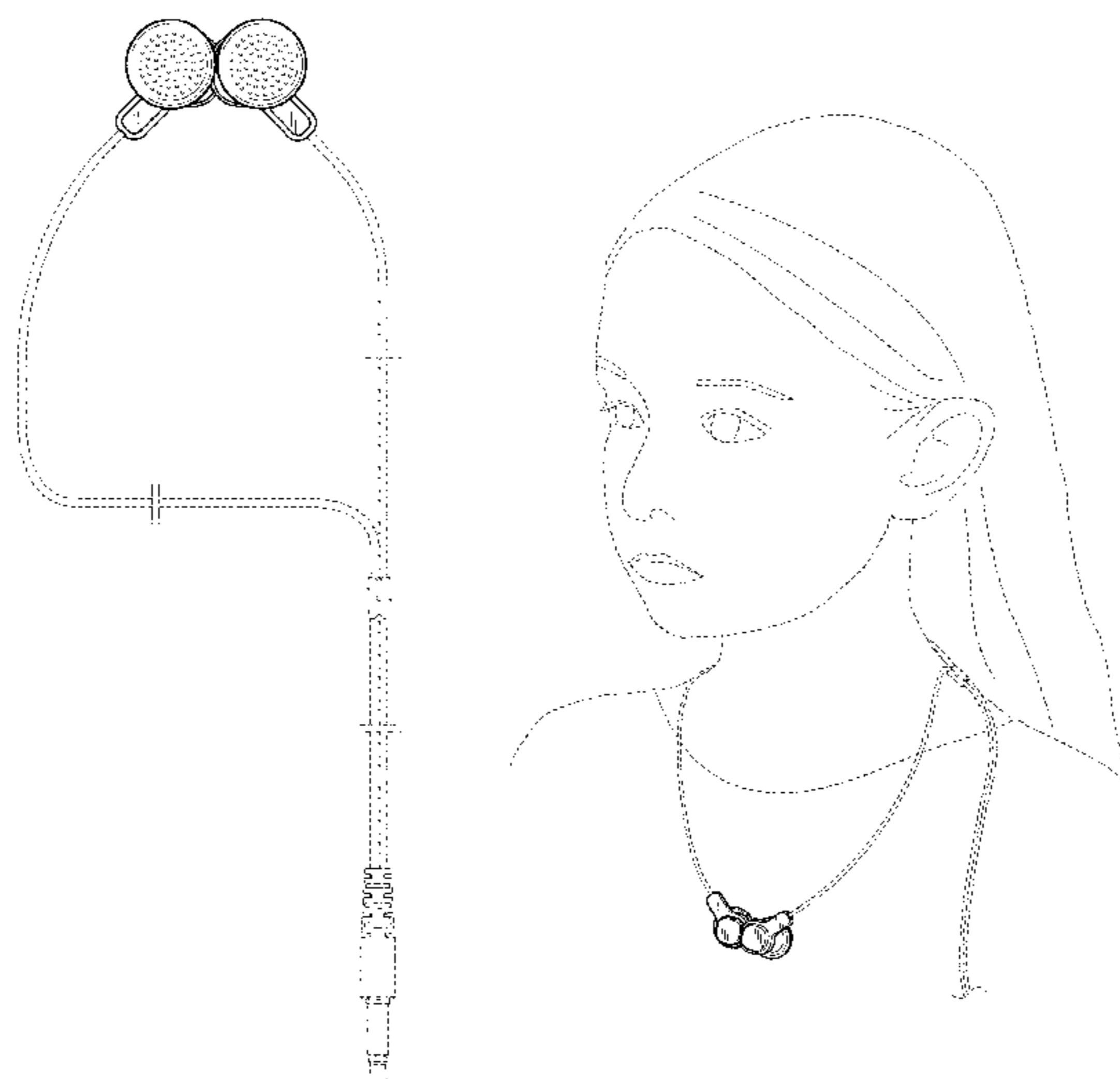

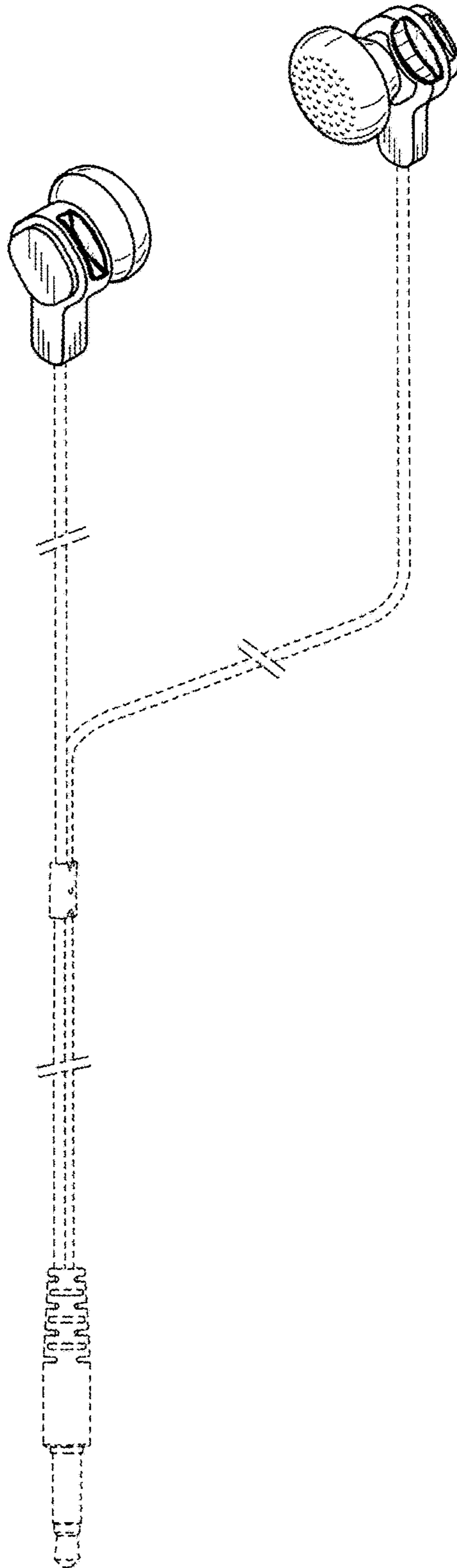

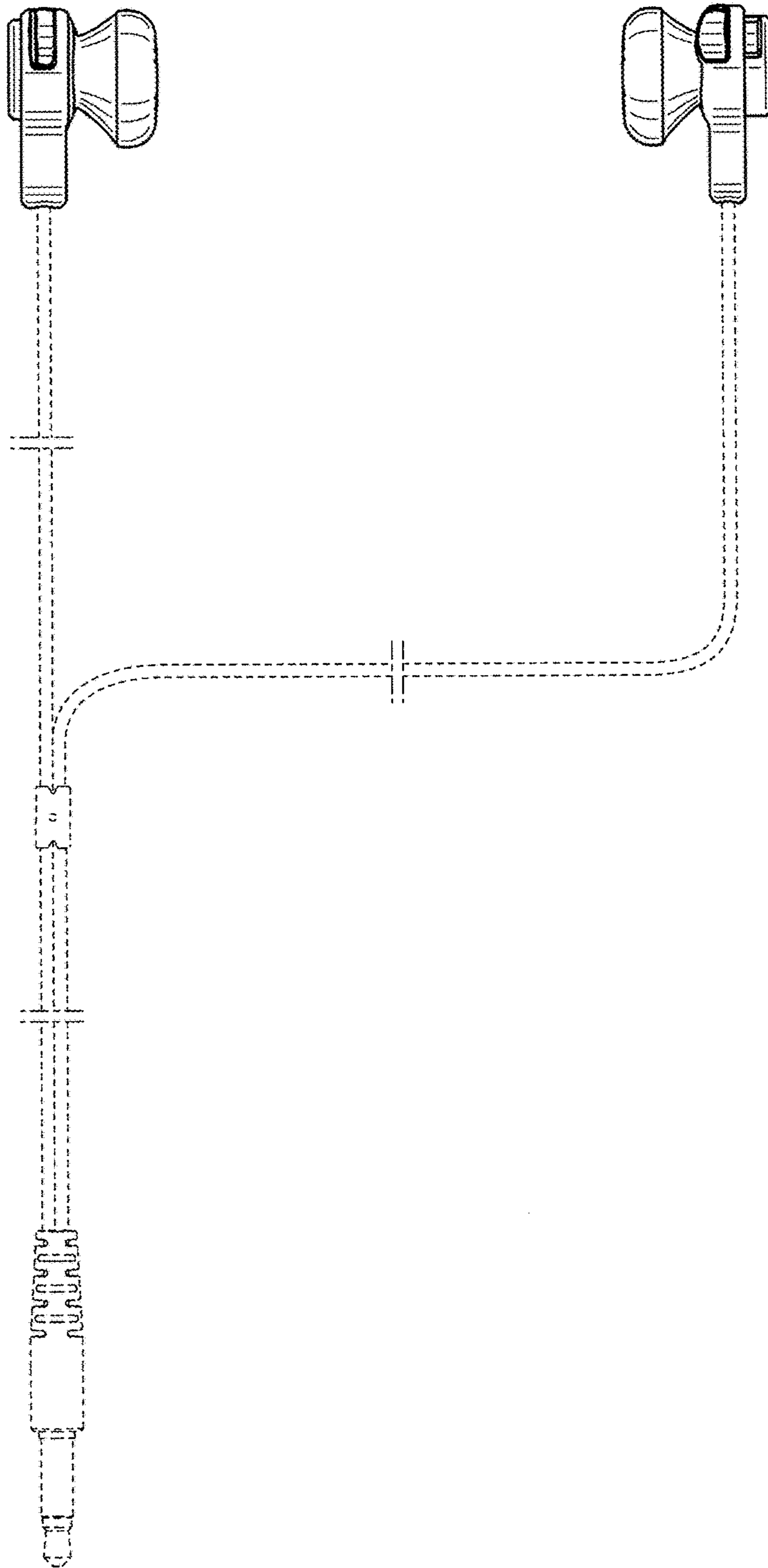

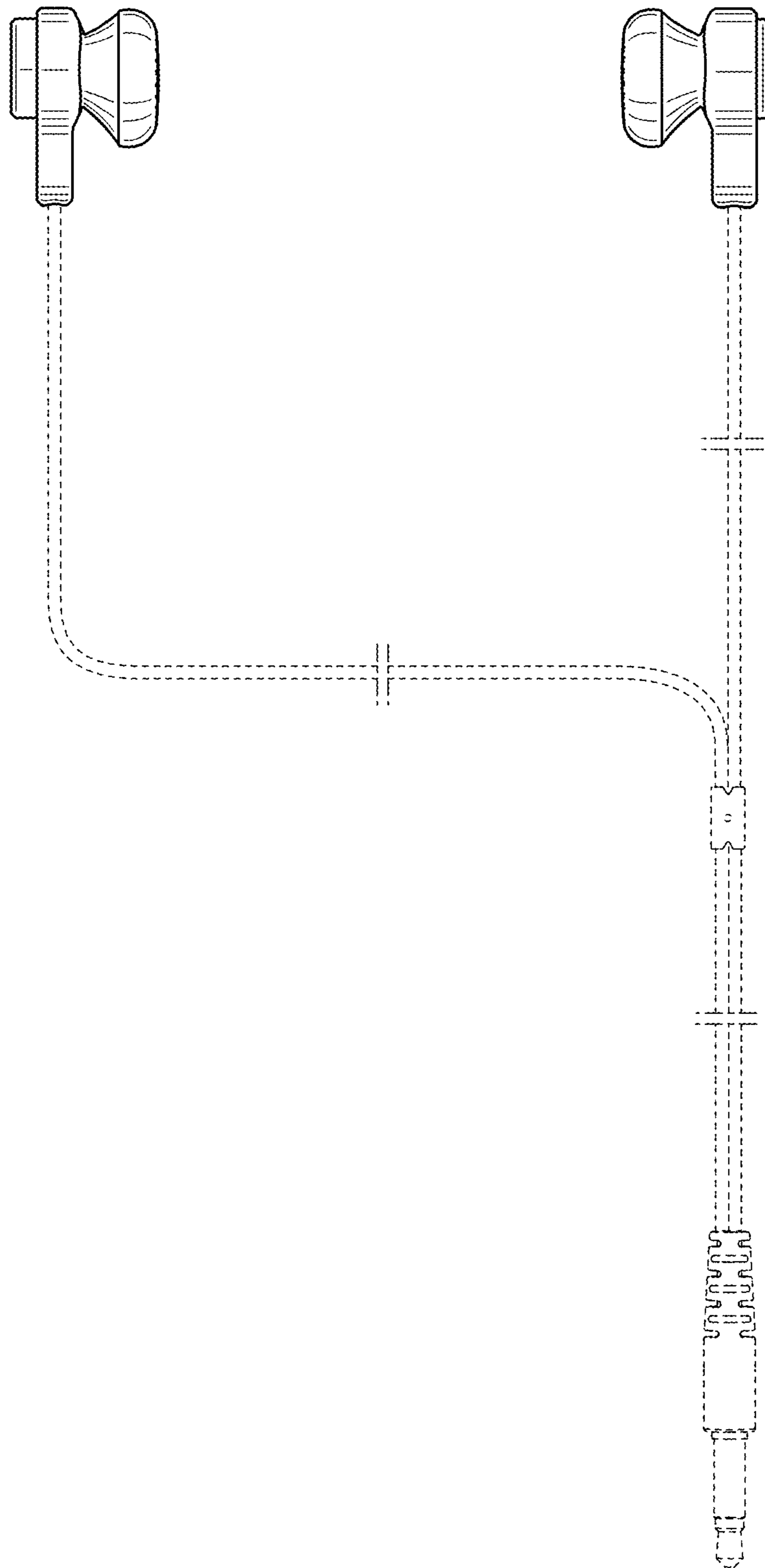

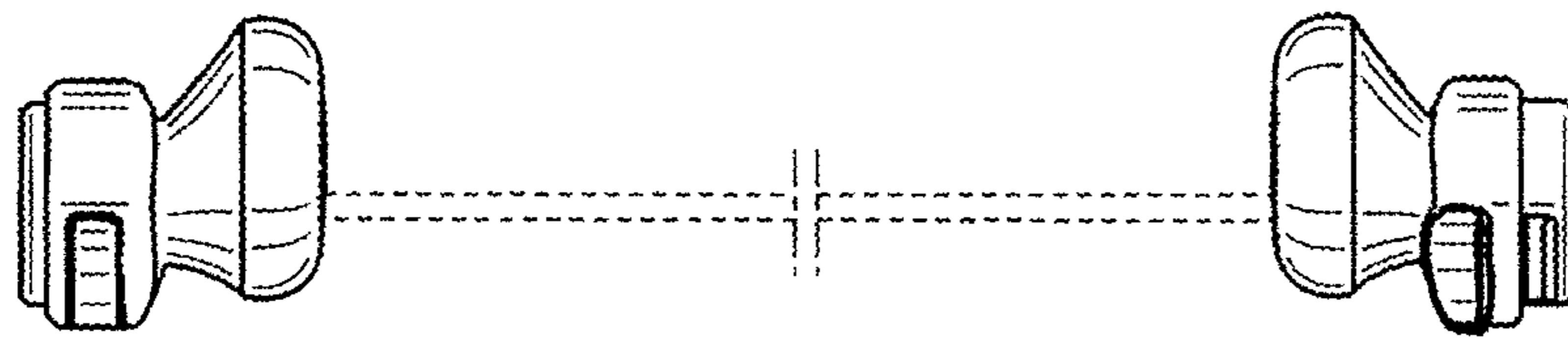

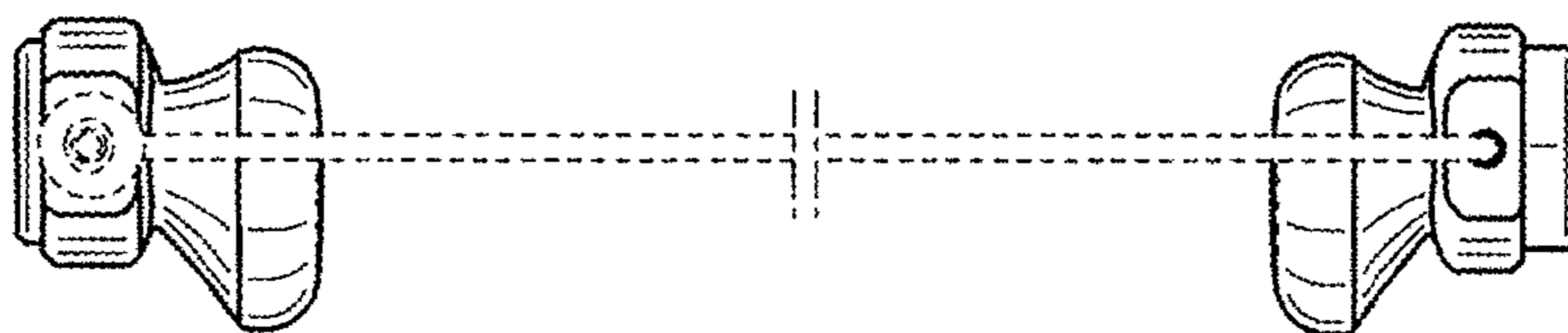

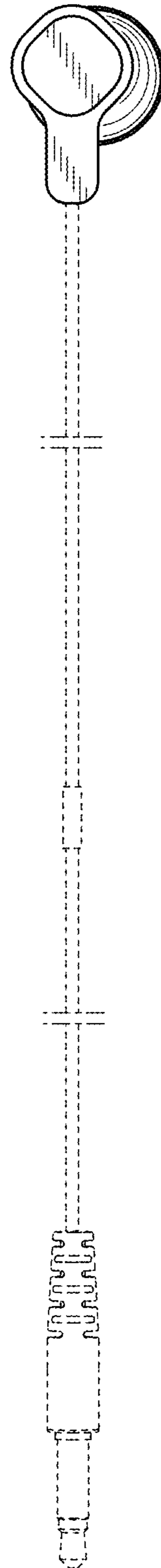

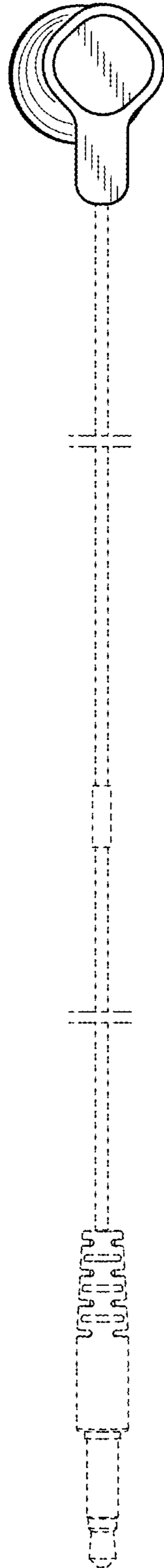

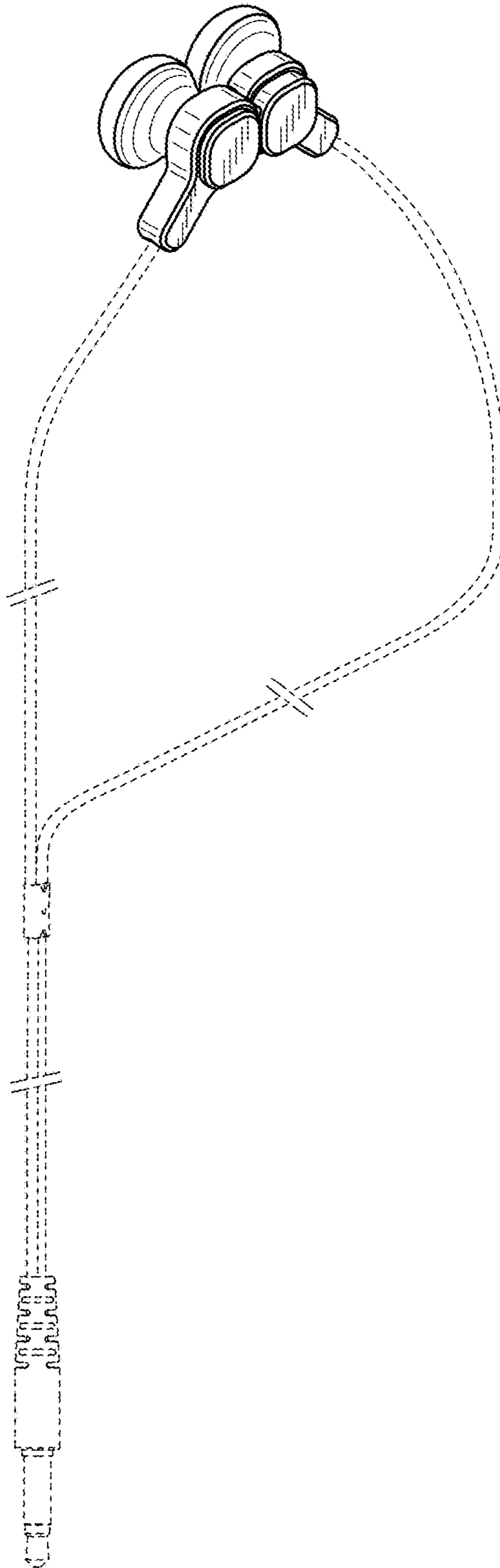

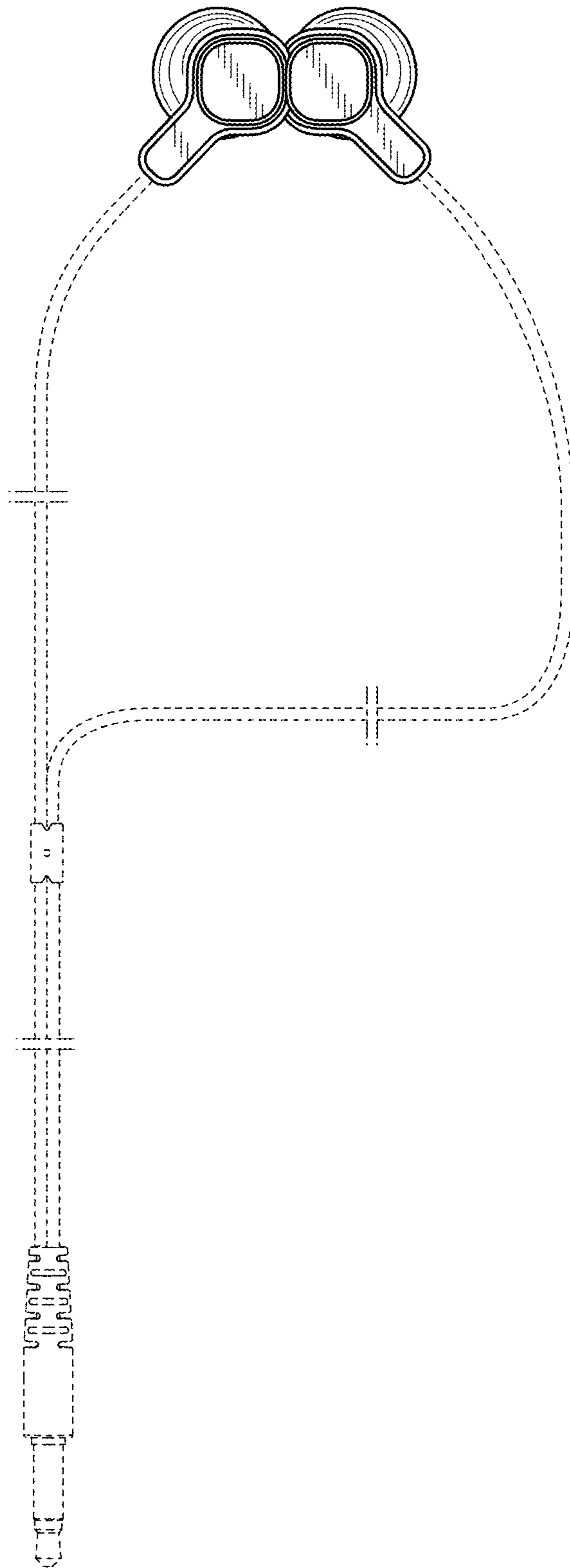

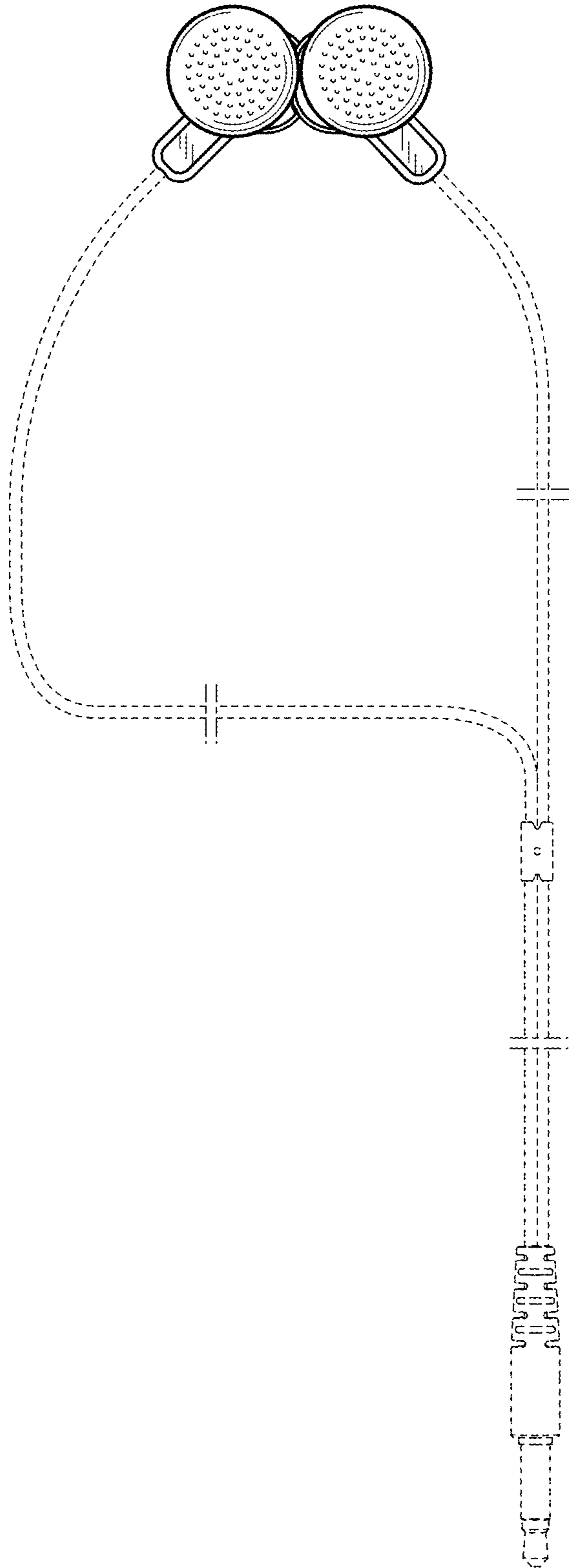

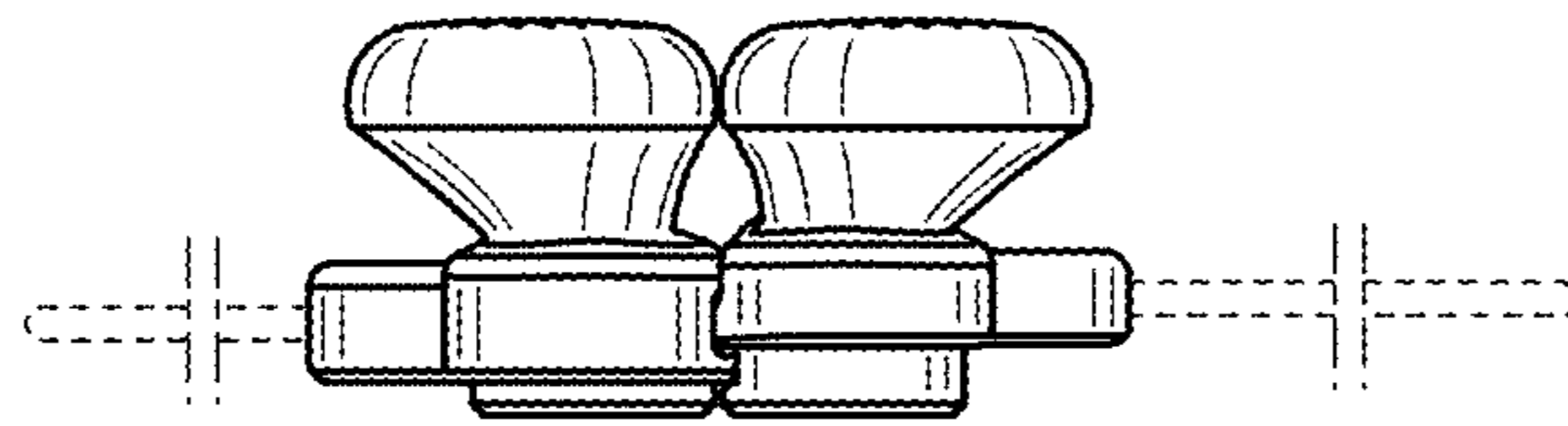

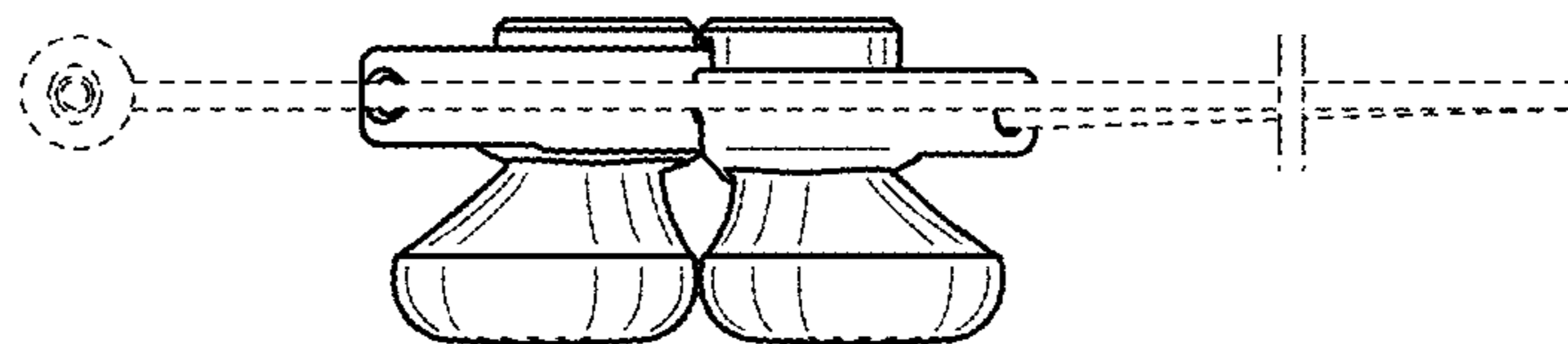

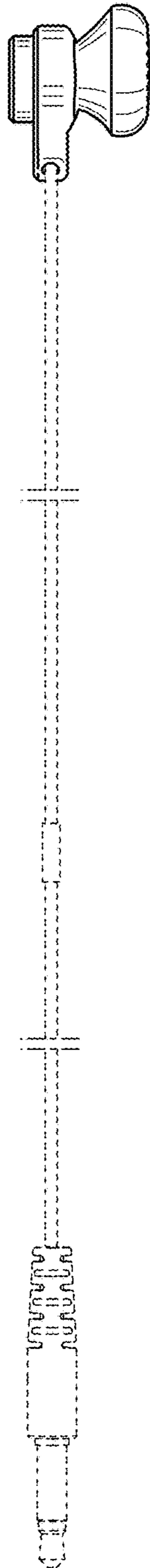

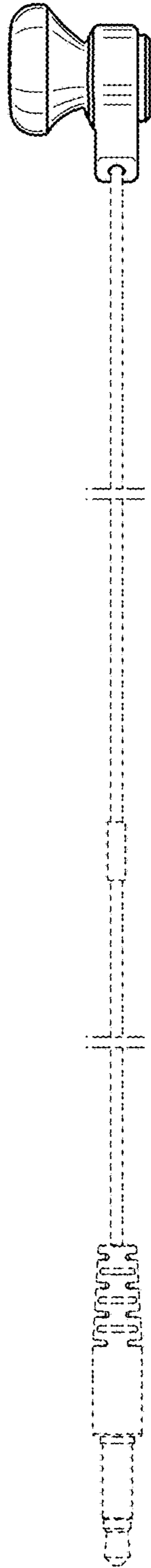
