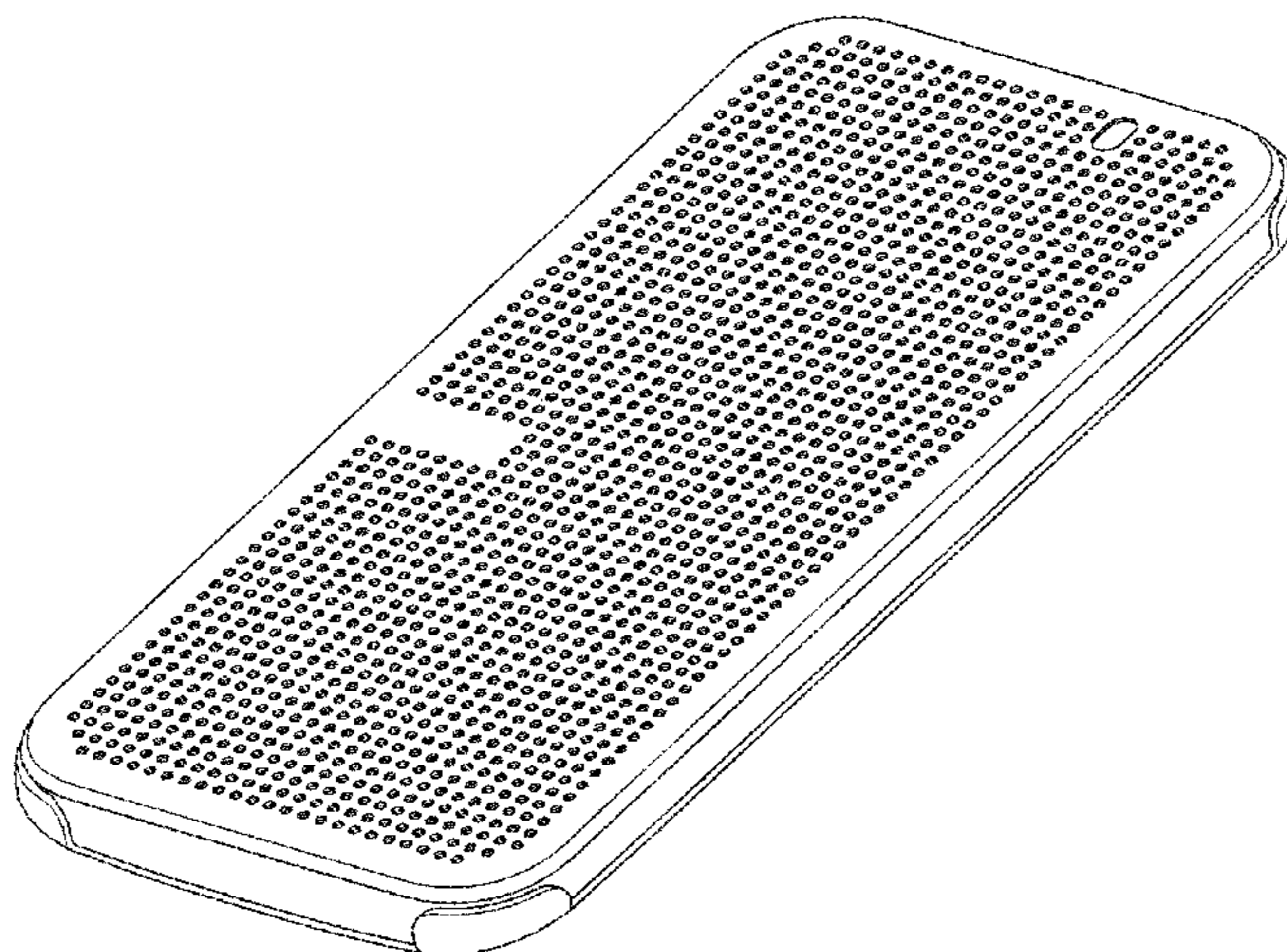
The broken line portions of the case for a portable electronic device in FIGS. 2-3, and 5-6 represent unclaimed portions of the design and form no part thereof.

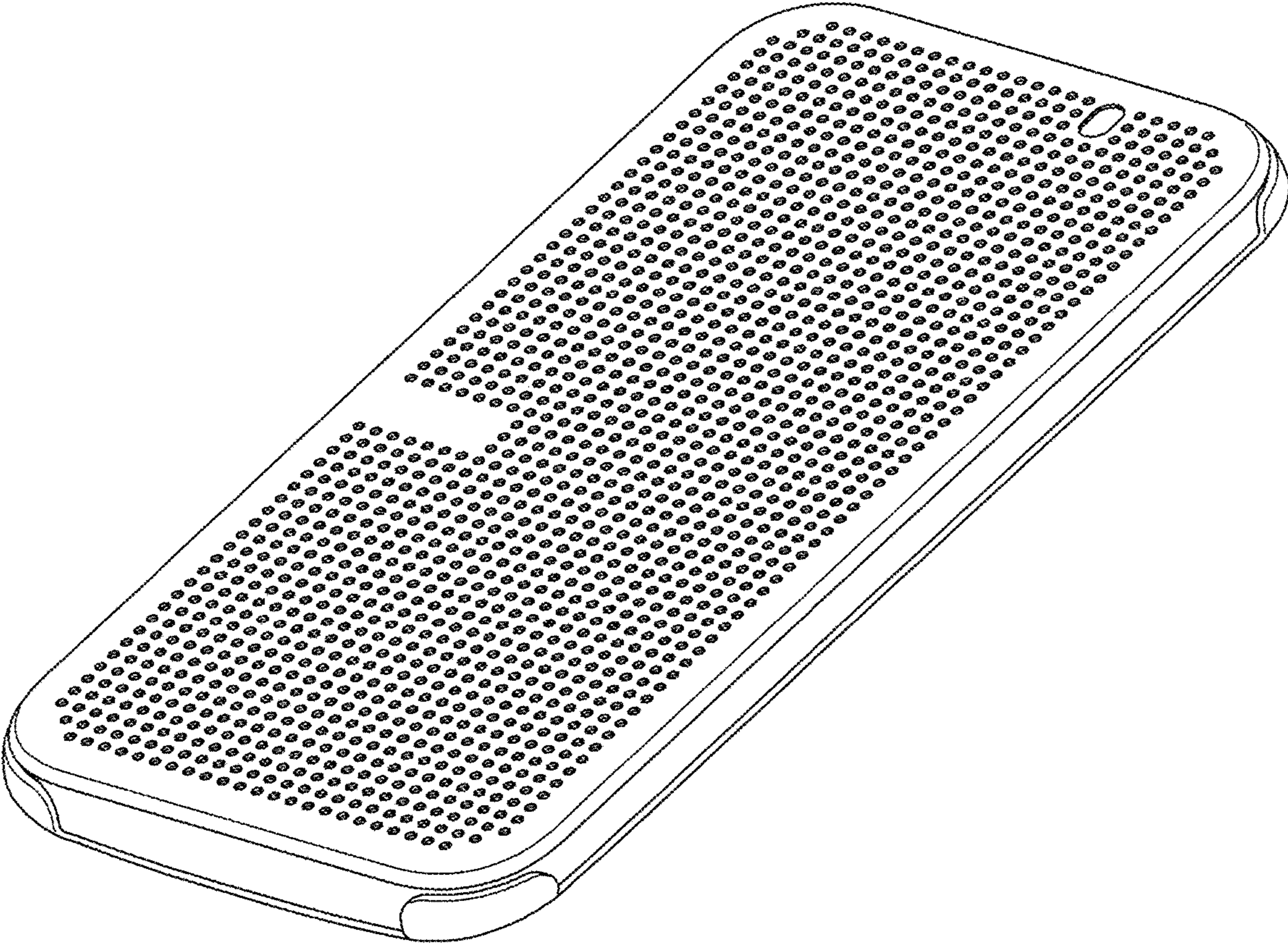

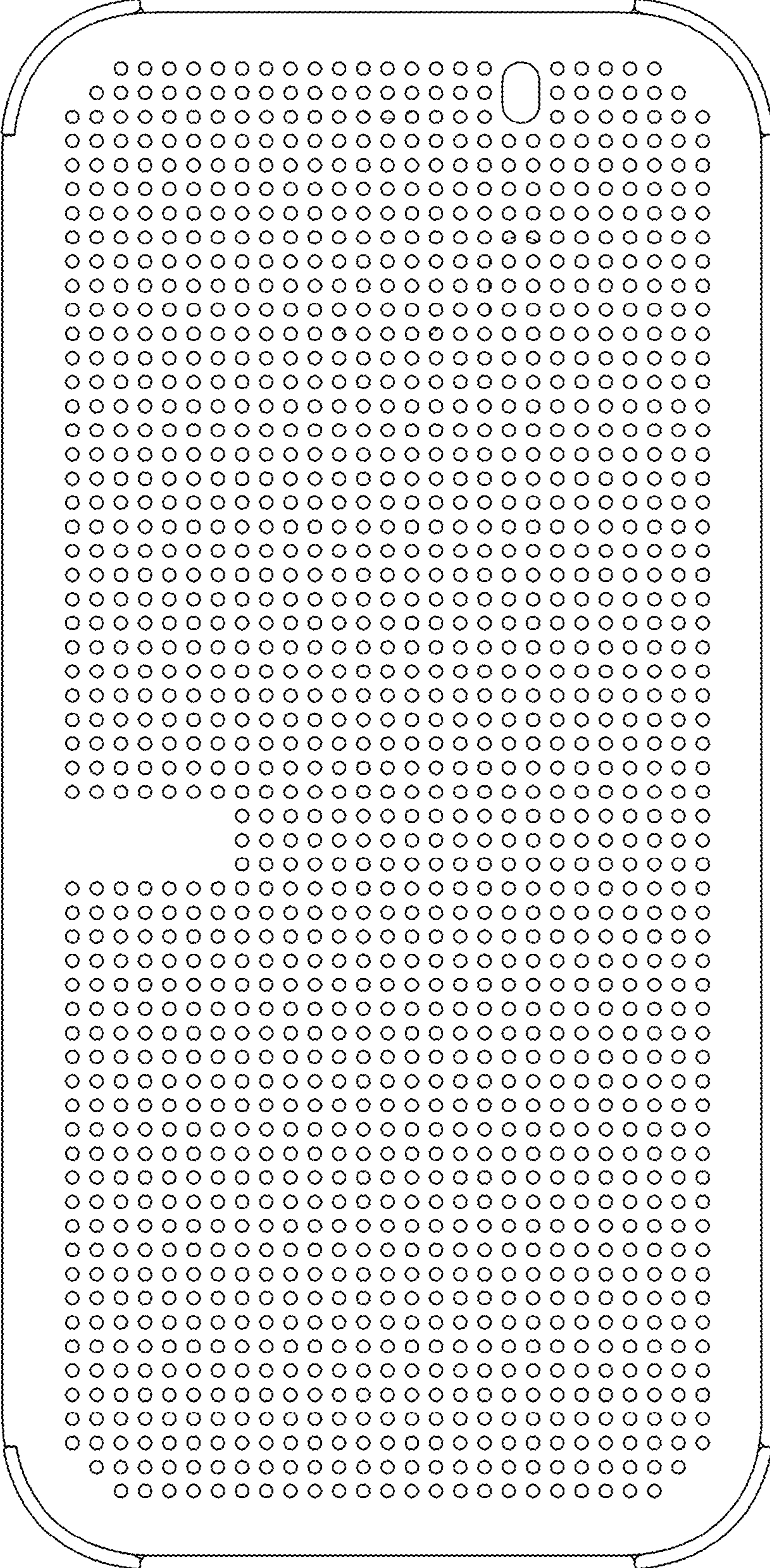

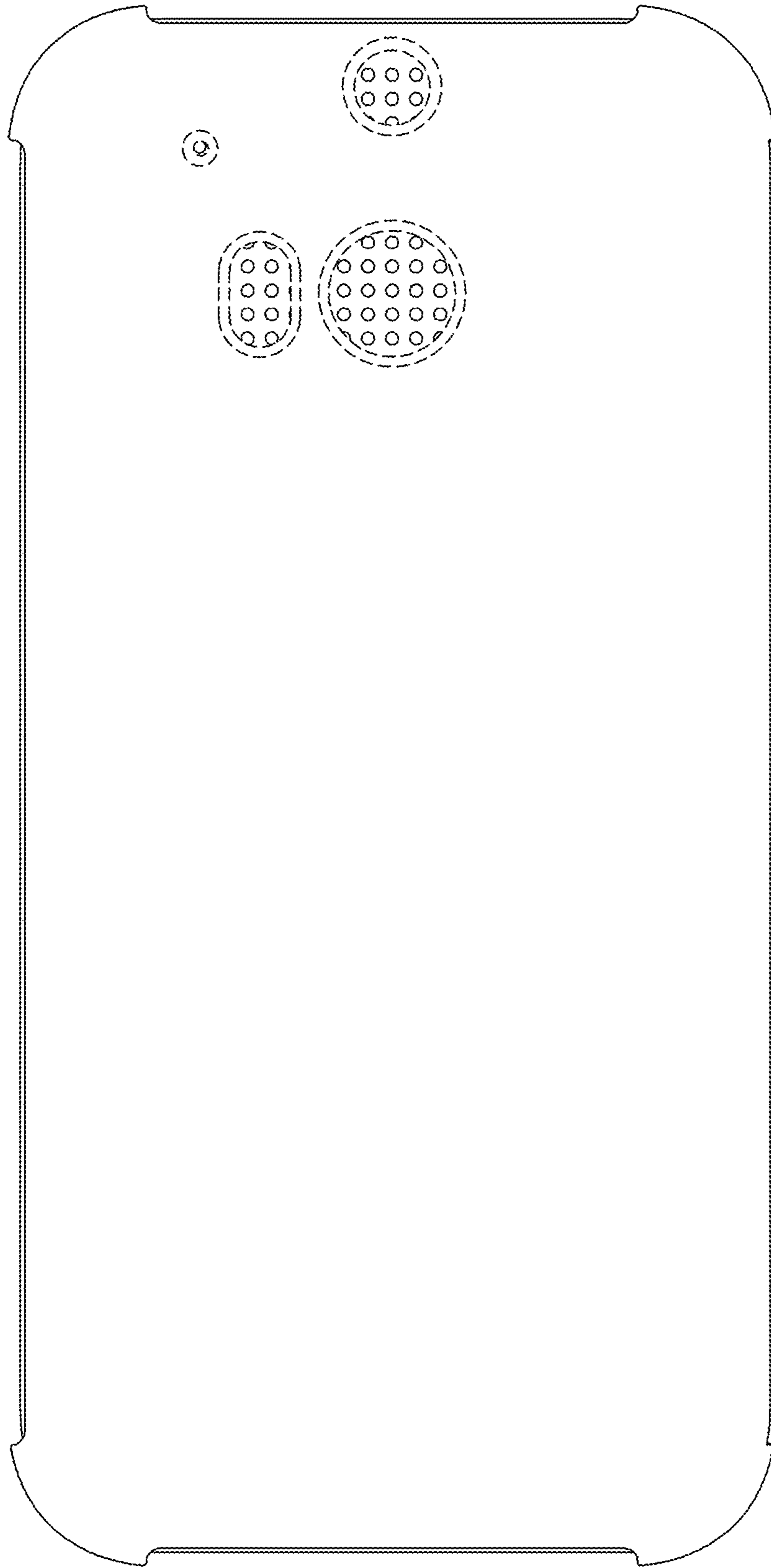

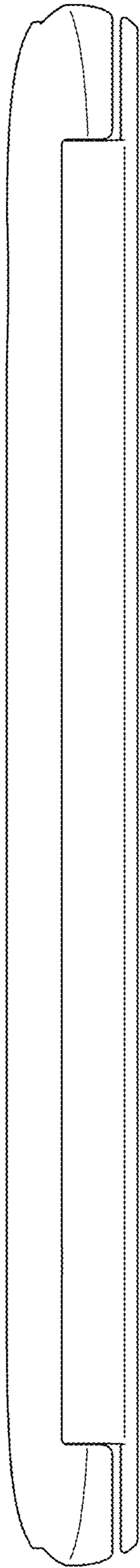

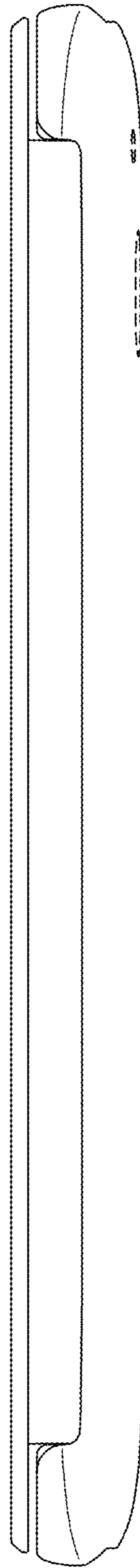

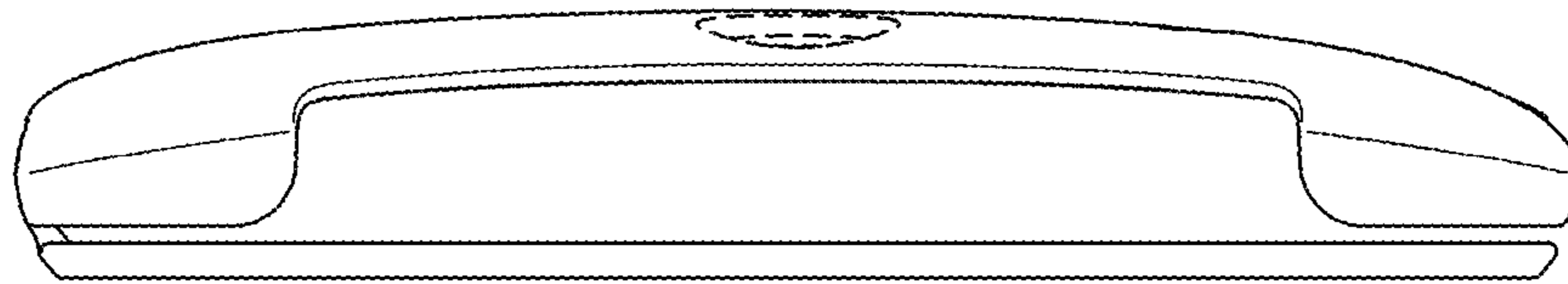

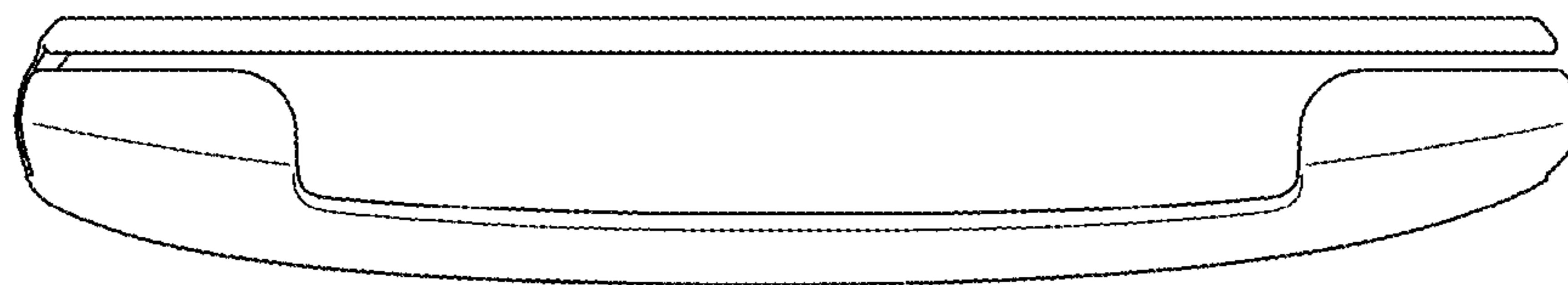
