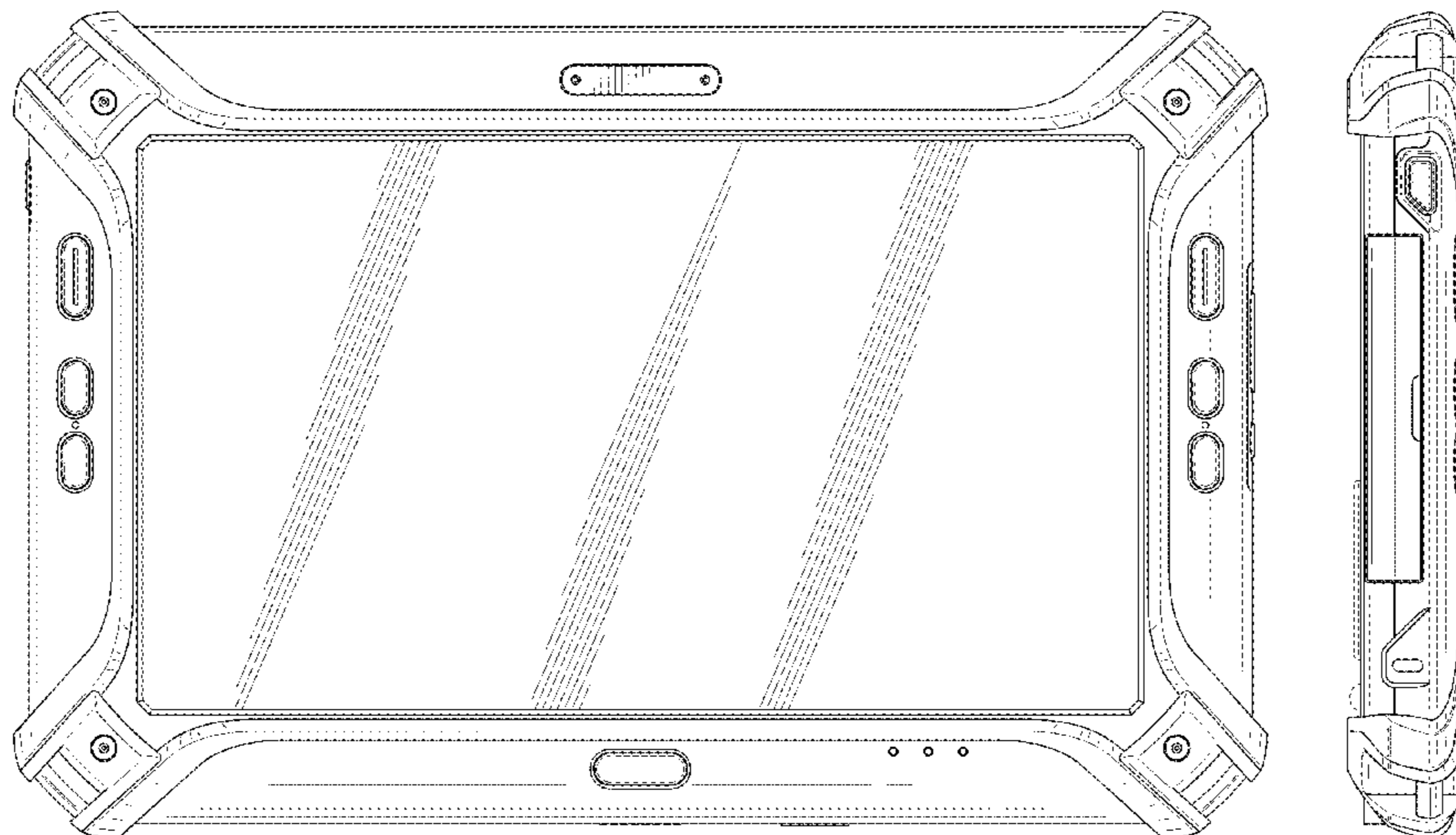
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a tablet computer; FIG. 2 is a front elevation view thereof; FIG. 3 is a back elevation view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a right elevation view thereof; and, FIG. 7 is a left elevation view thereof. 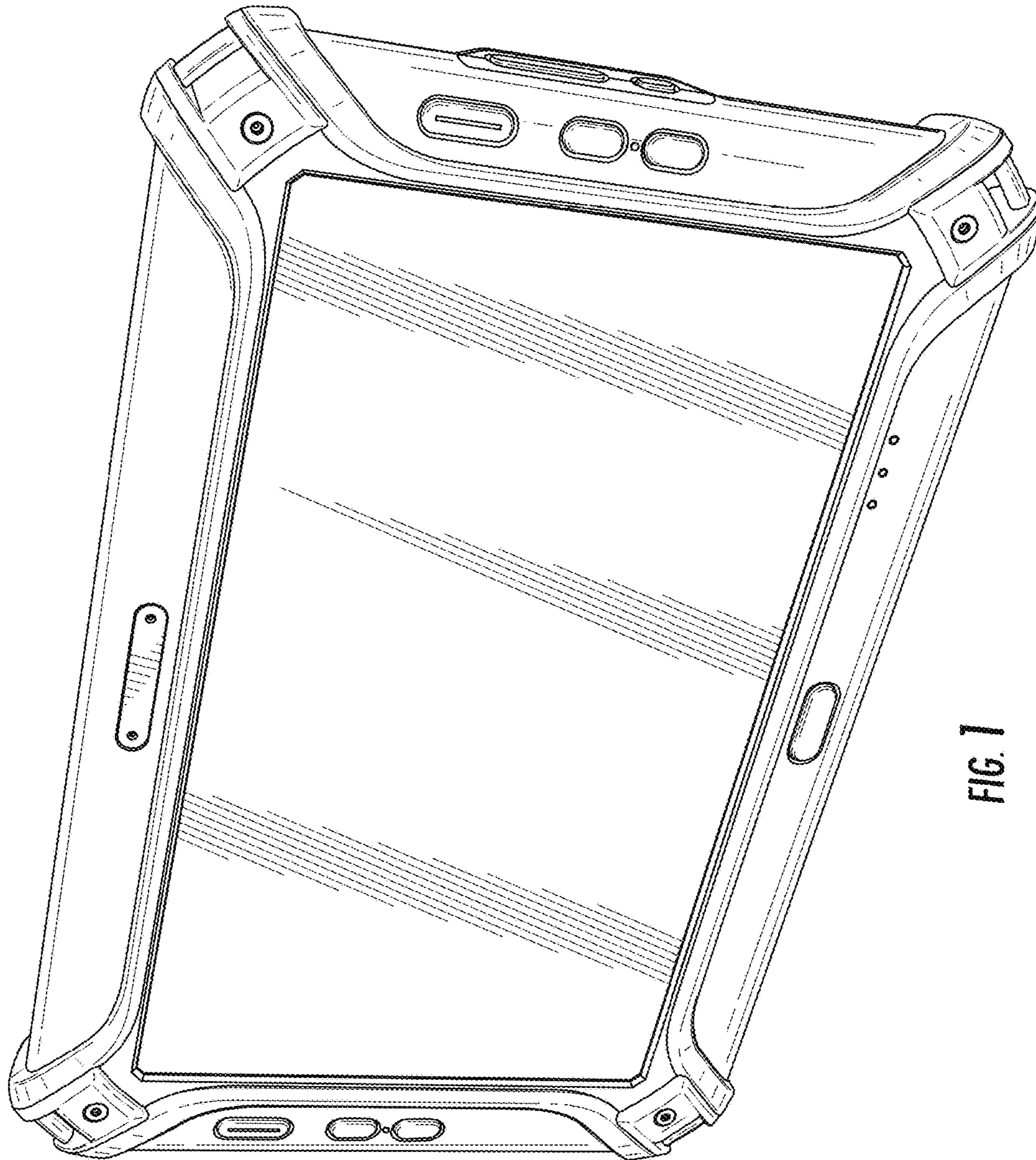
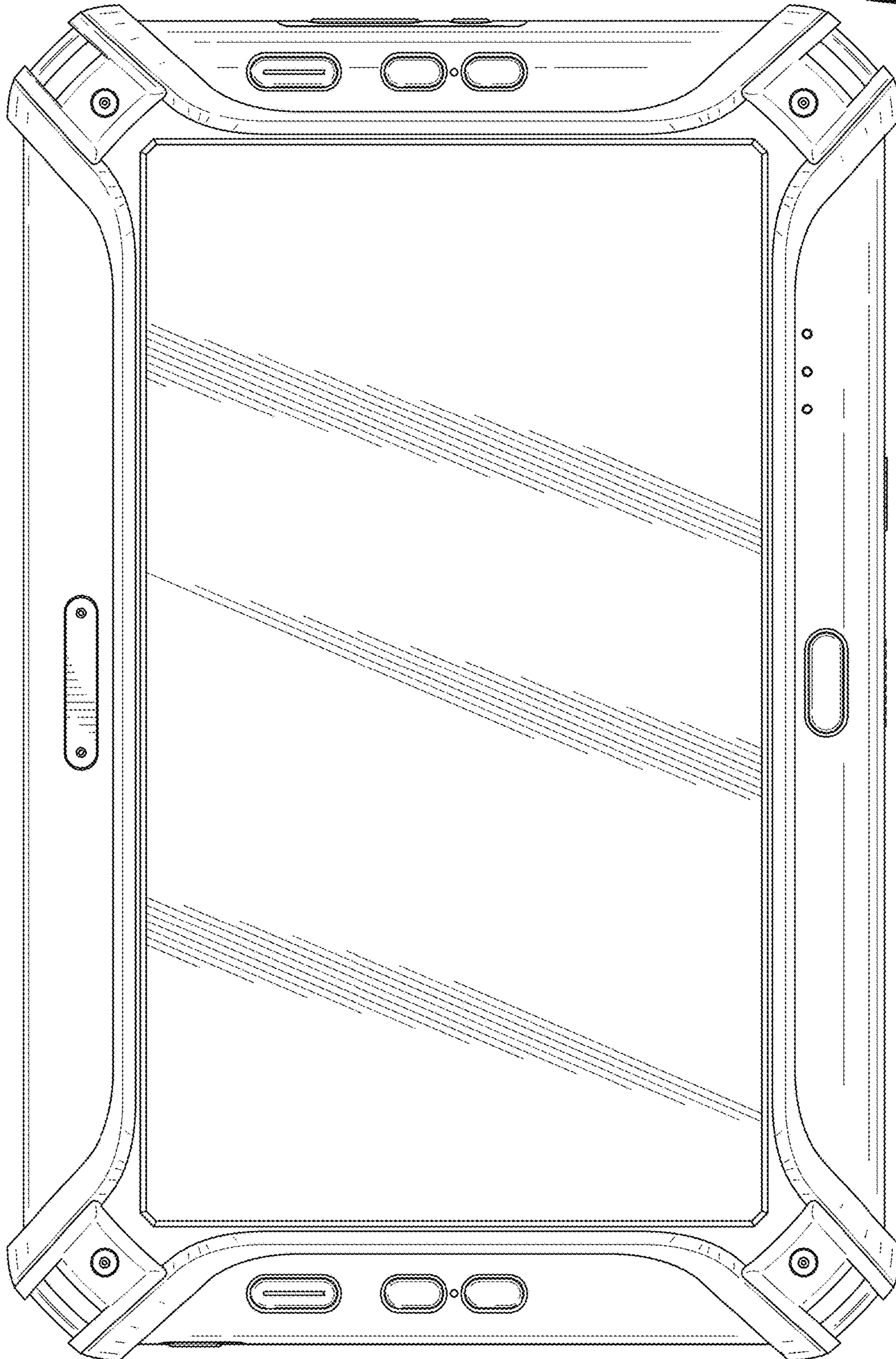
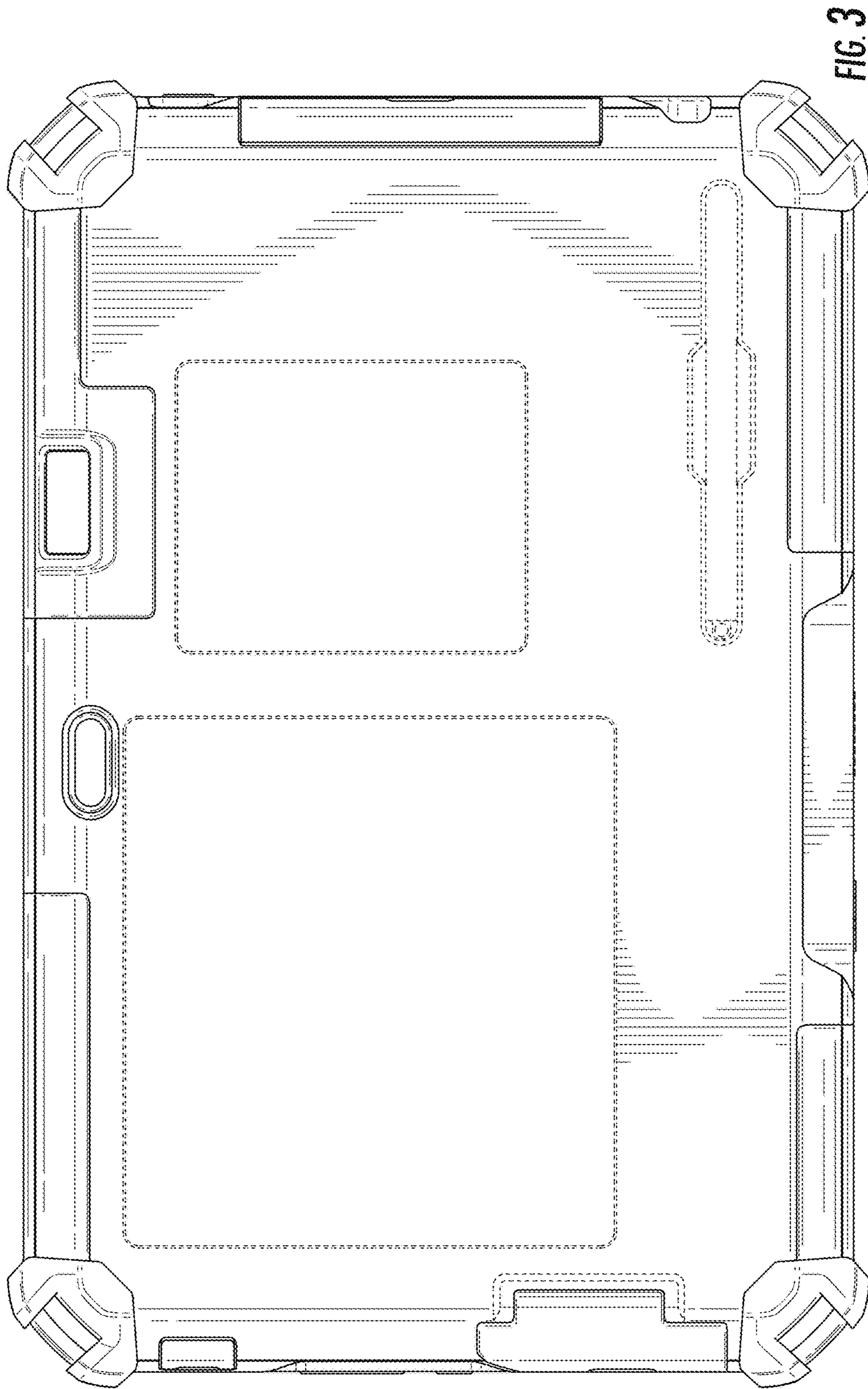

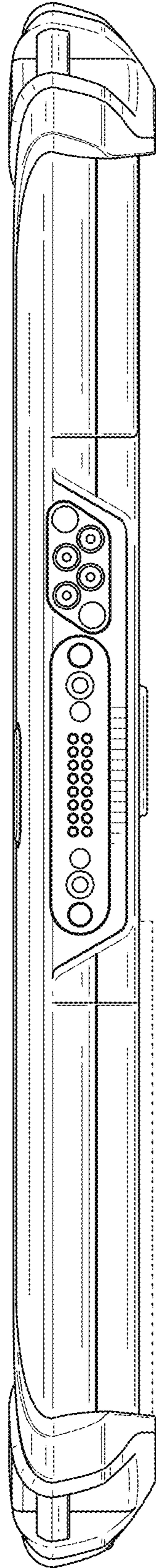

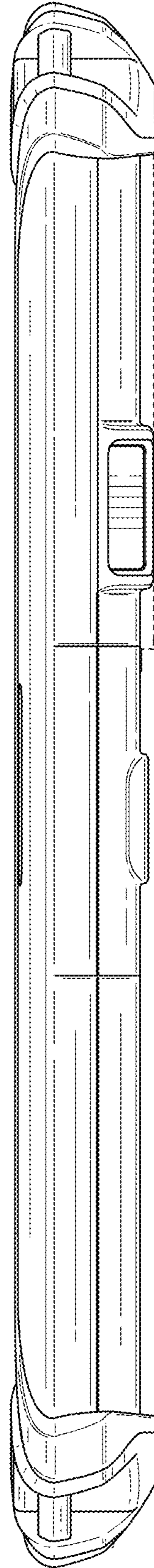

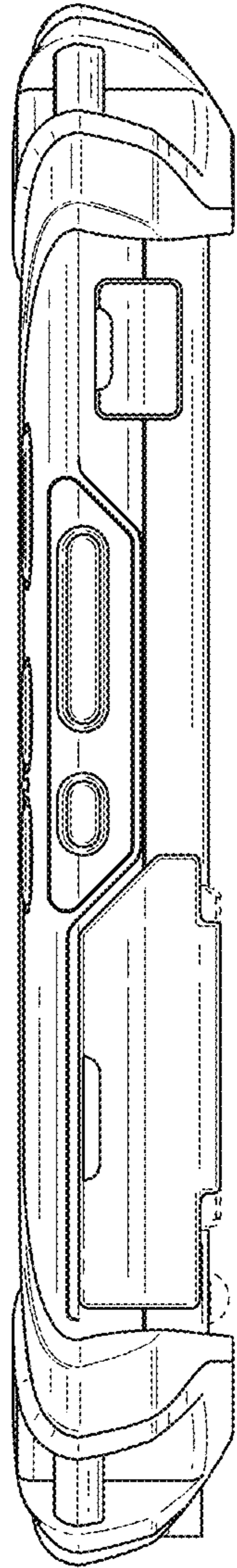

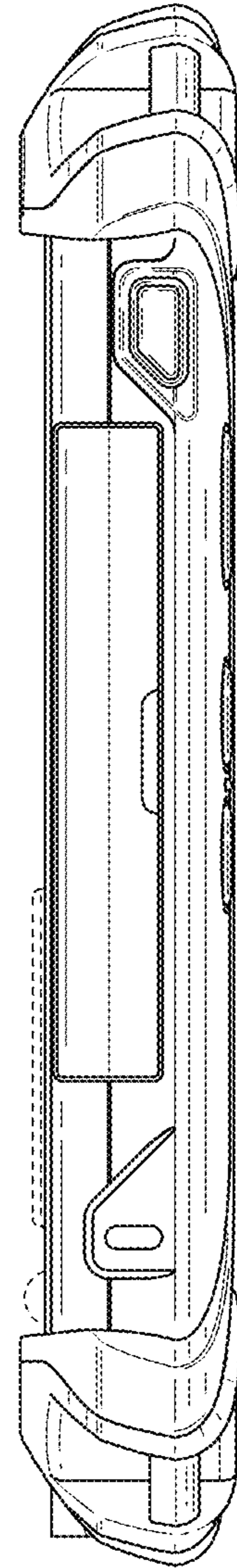
